DESCRIPTION

FIG. 1 is a front, top, and left side isometric view of a computer workstation interior showing our new design;

FIG. 2 is a front, top, and right side isometric view thereof;

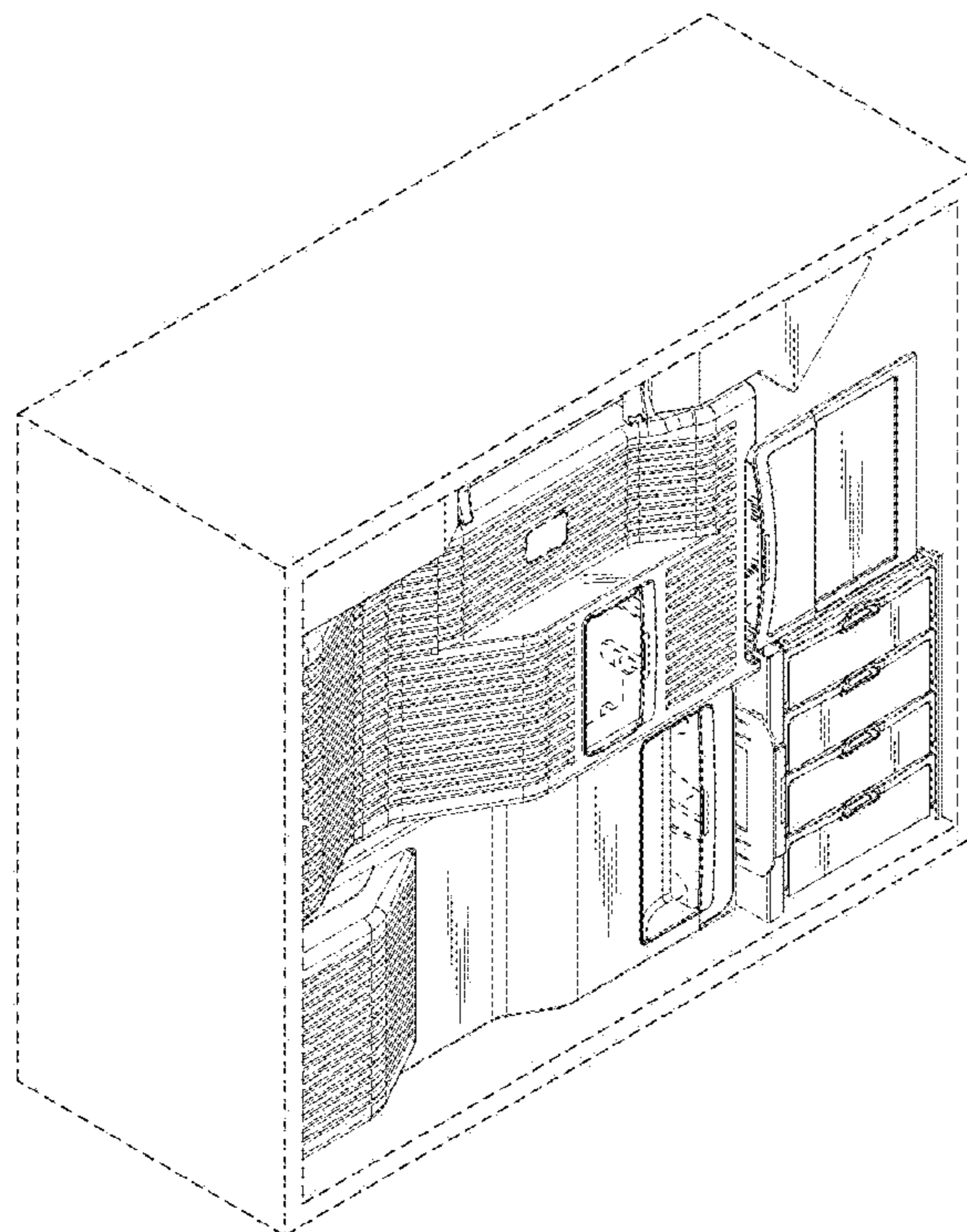
FIG. 3 is a front, bottom, and left side isometric view thereof;

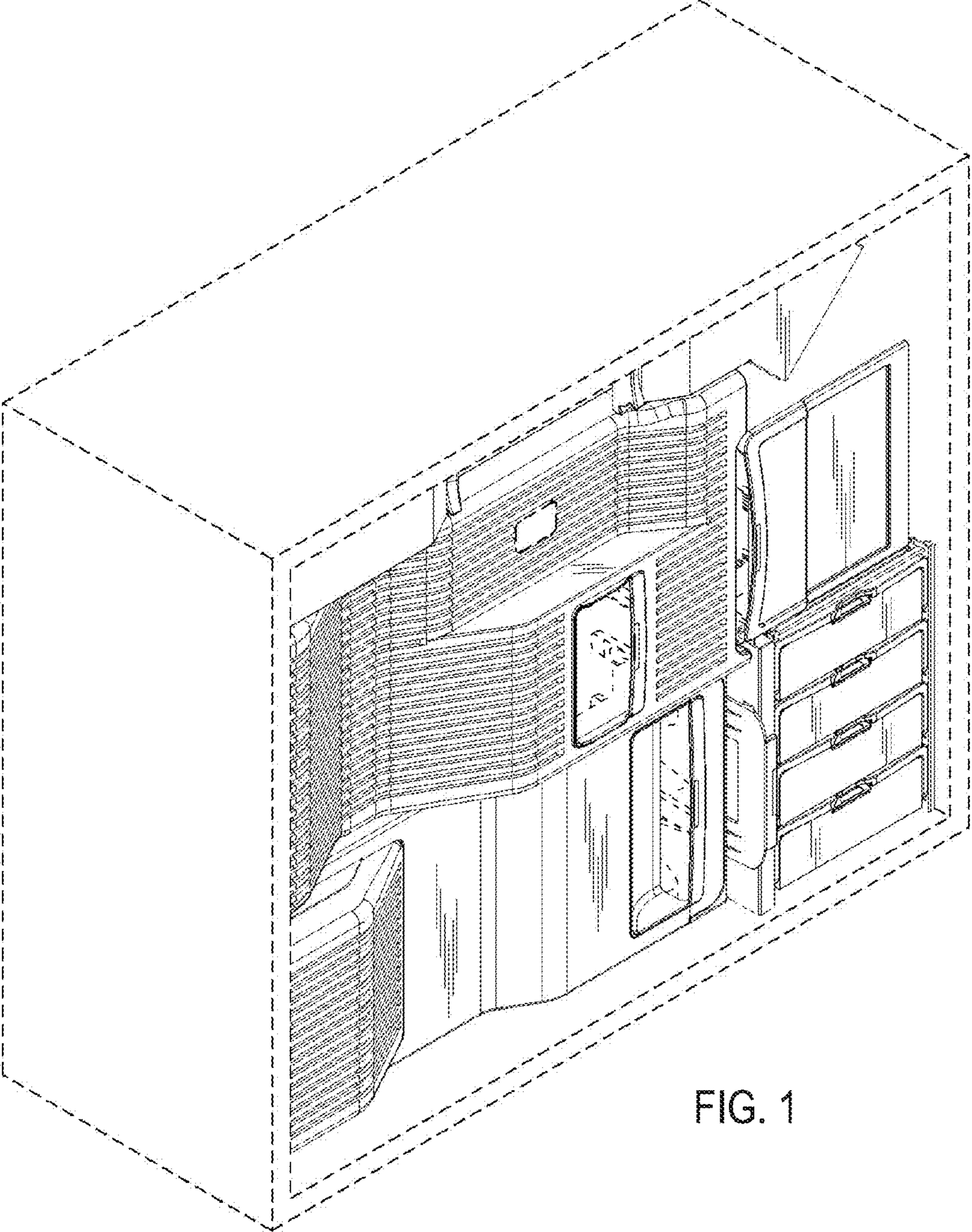

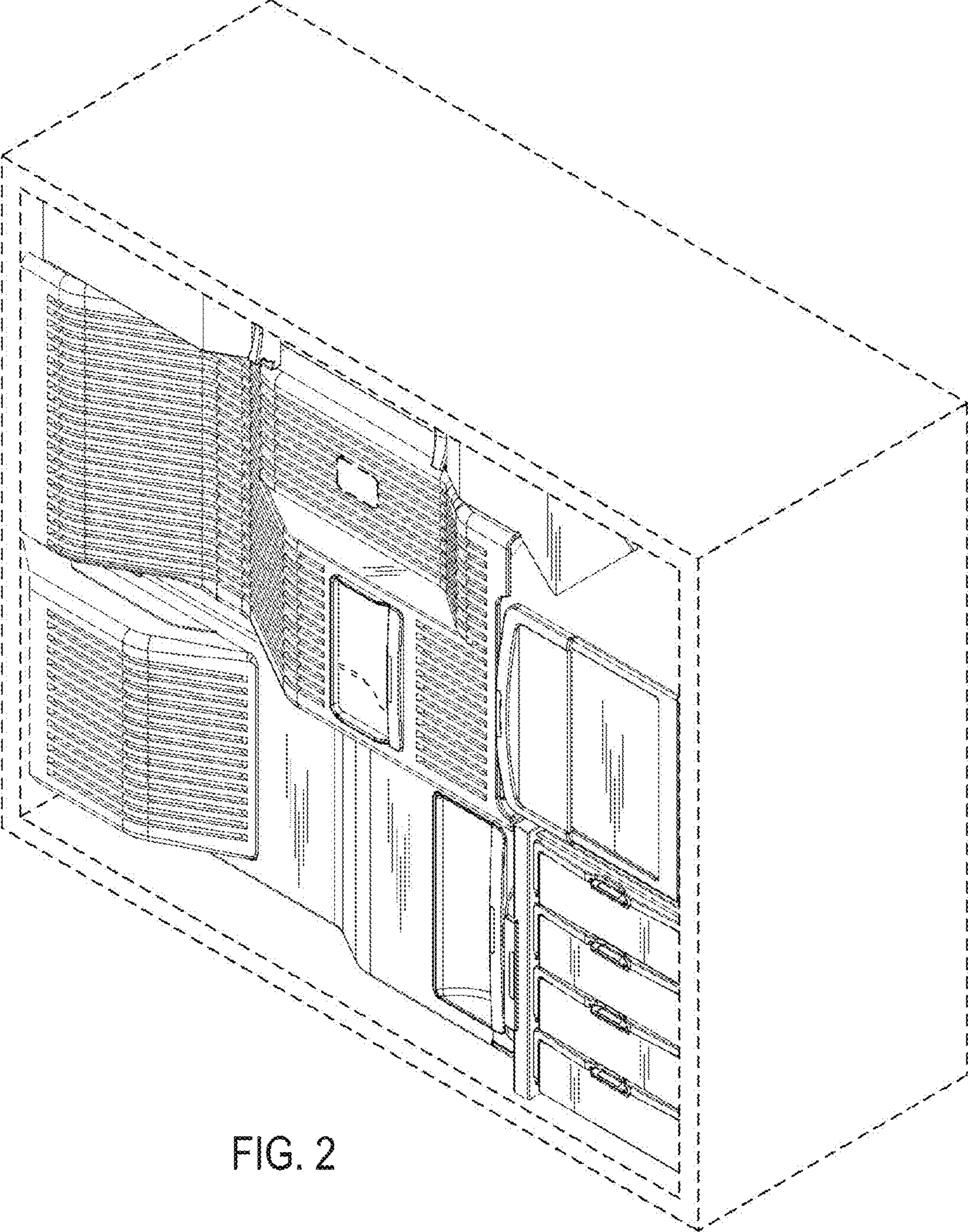

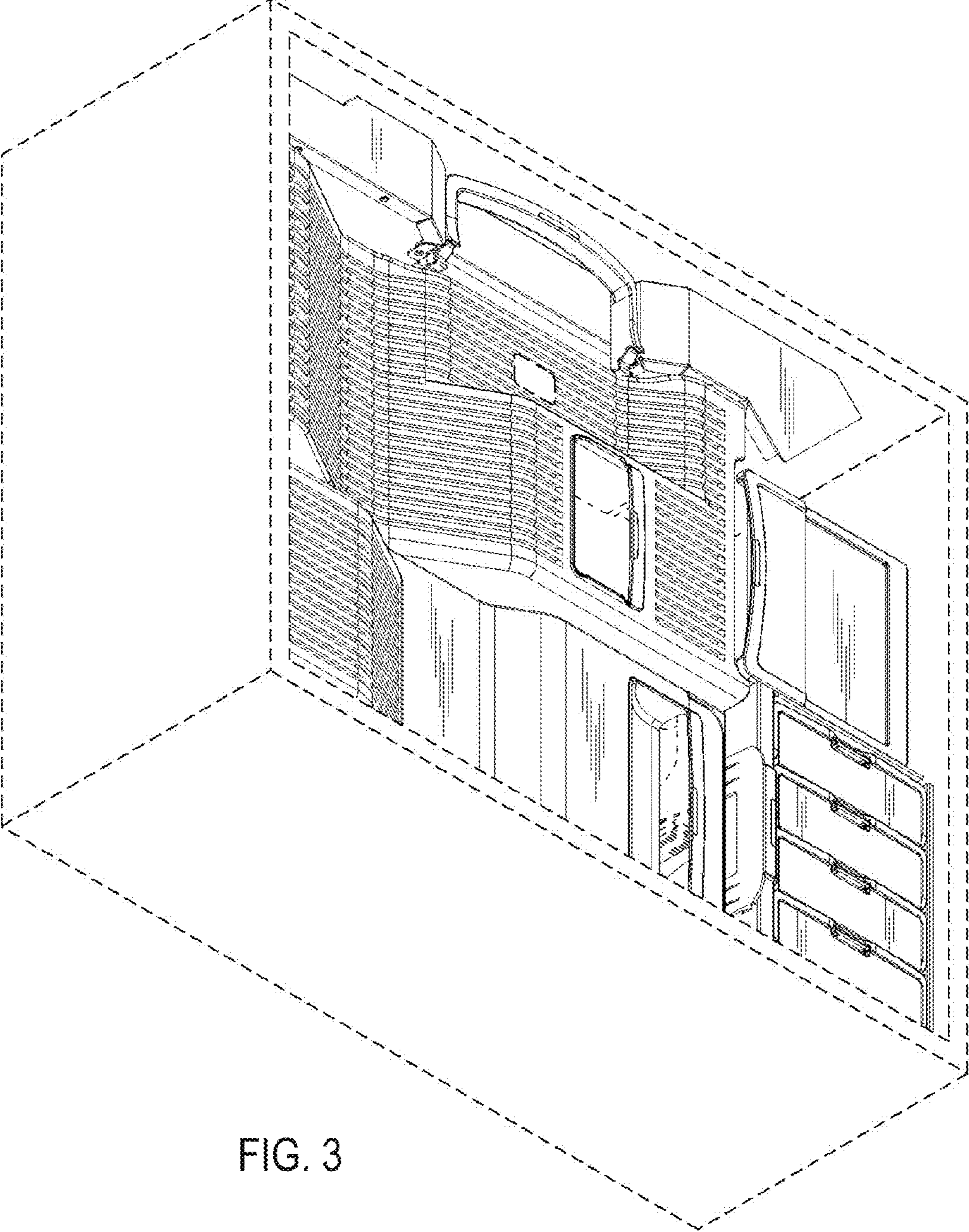

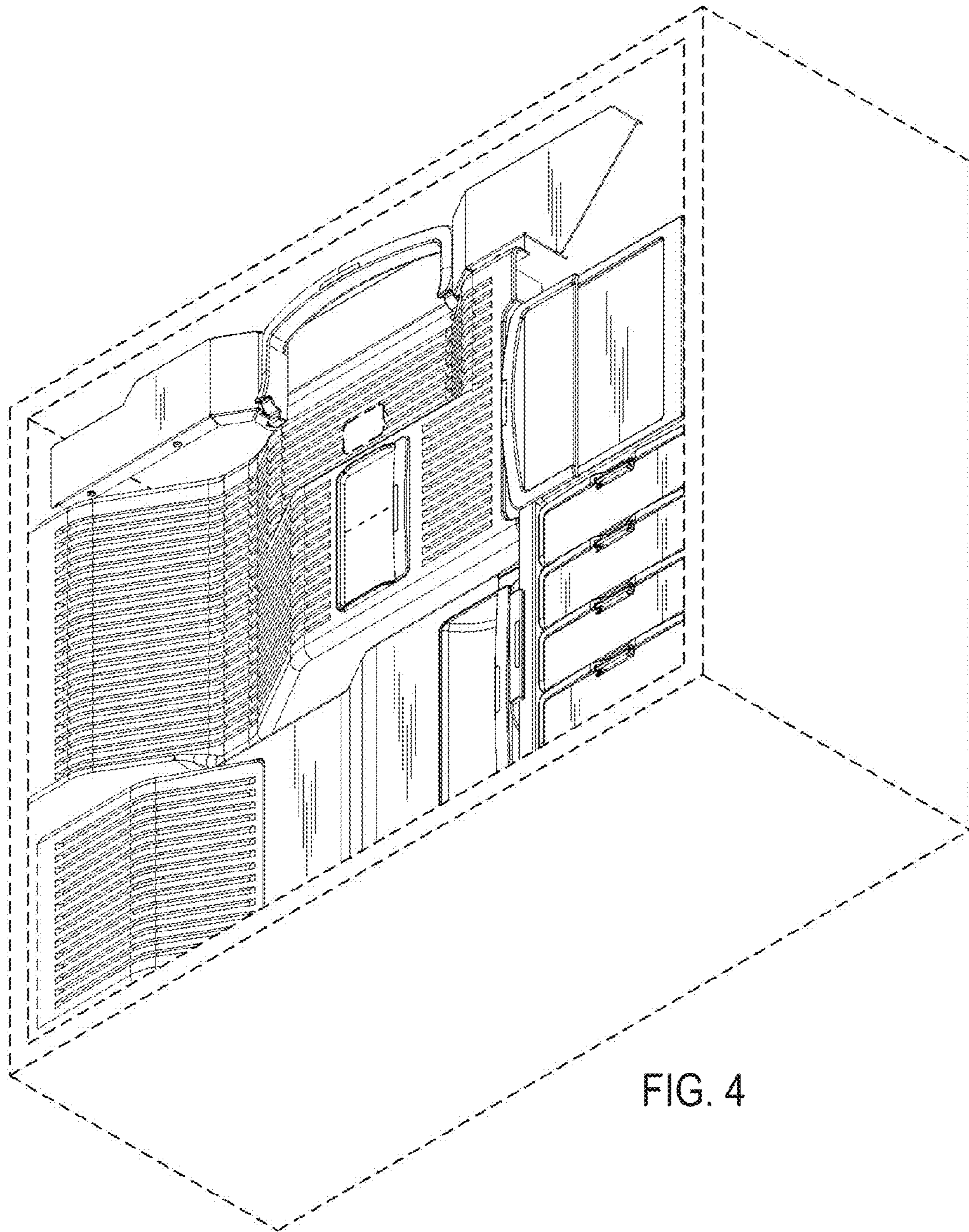

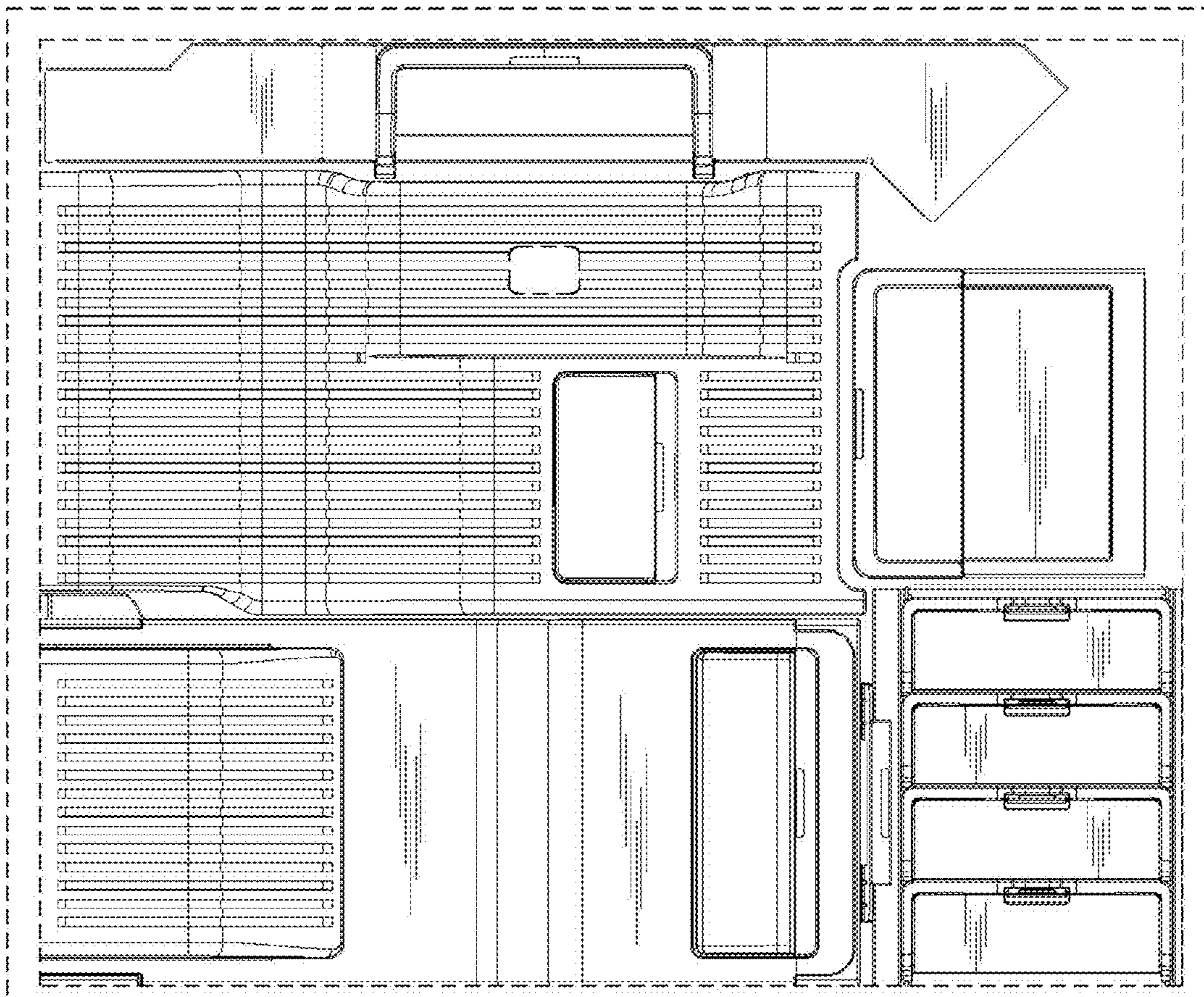
