FIG. 2 is a left elevation view of the vessel for sinus cavity rinse of FIG. 1.

FIG. 4 is a rear elevation view of the vessel for sinus cavity rinse of FIG. 1.

FIG. 5 is a front elevation view of the vessel for sinus cavity rinse of FIG. 1.

FIG. 6 is a top plan view of the vessel for sinus cavity rinse of FIG. 1; and,

FIG. 7 is a bottom plan view of the vessel for sinus cavity rinse of FIG. 1.

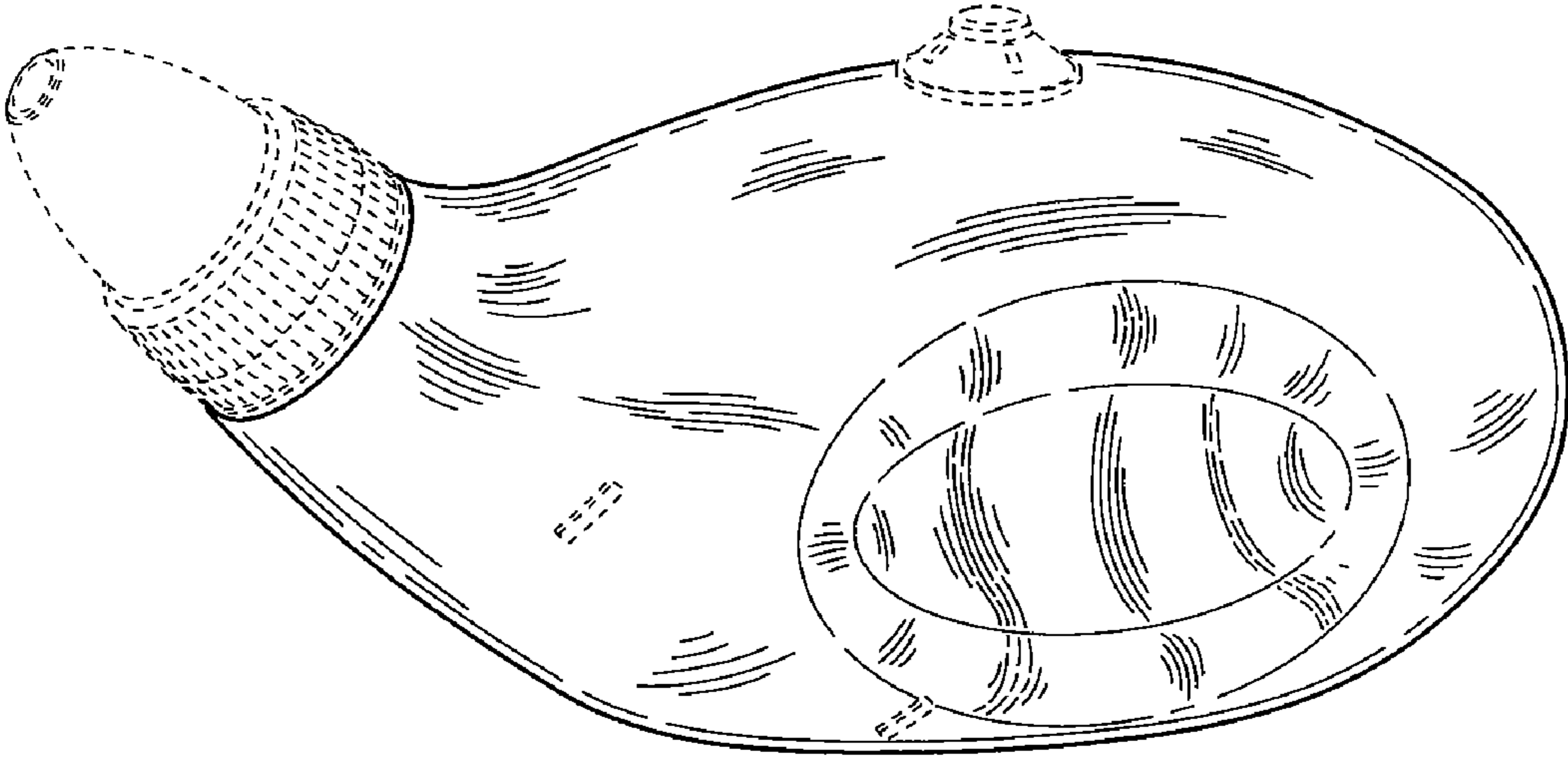

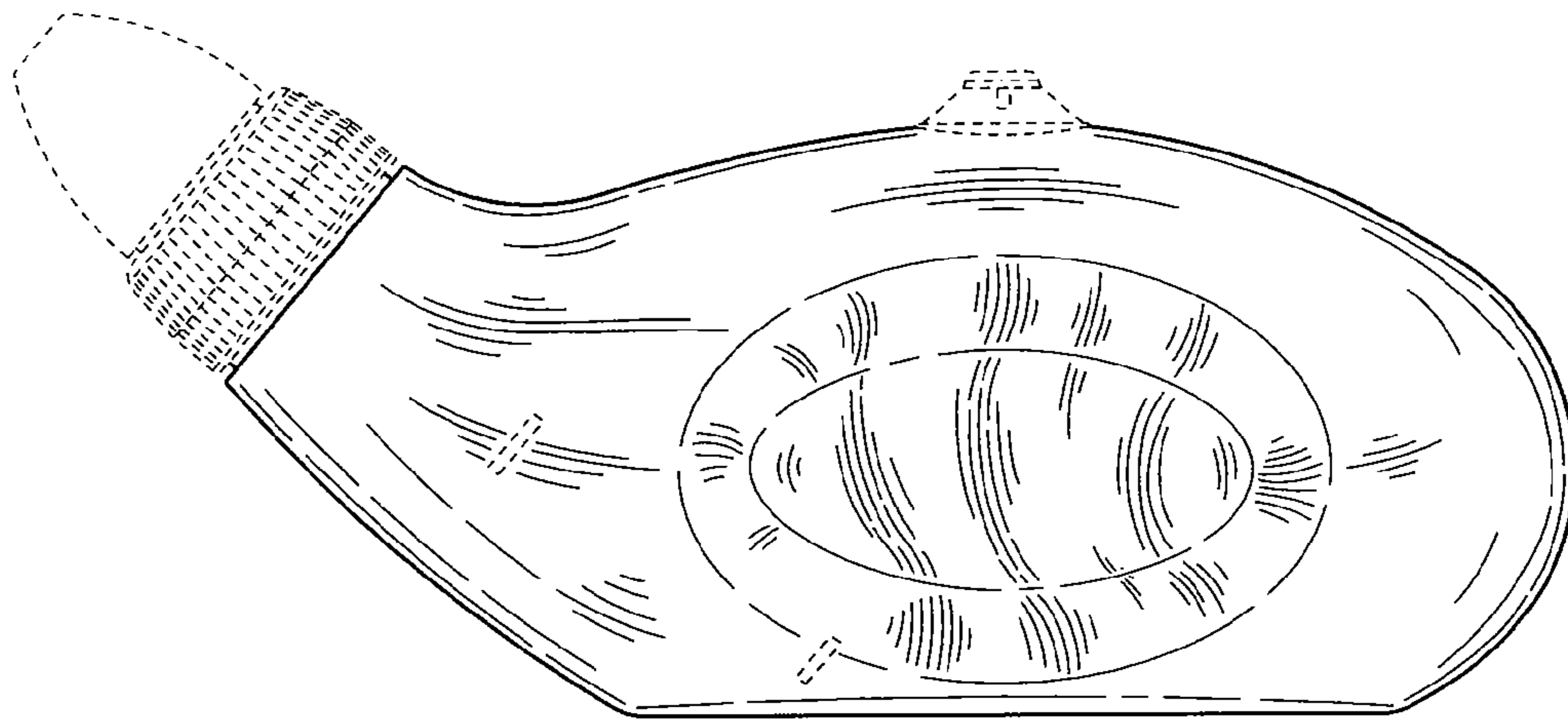

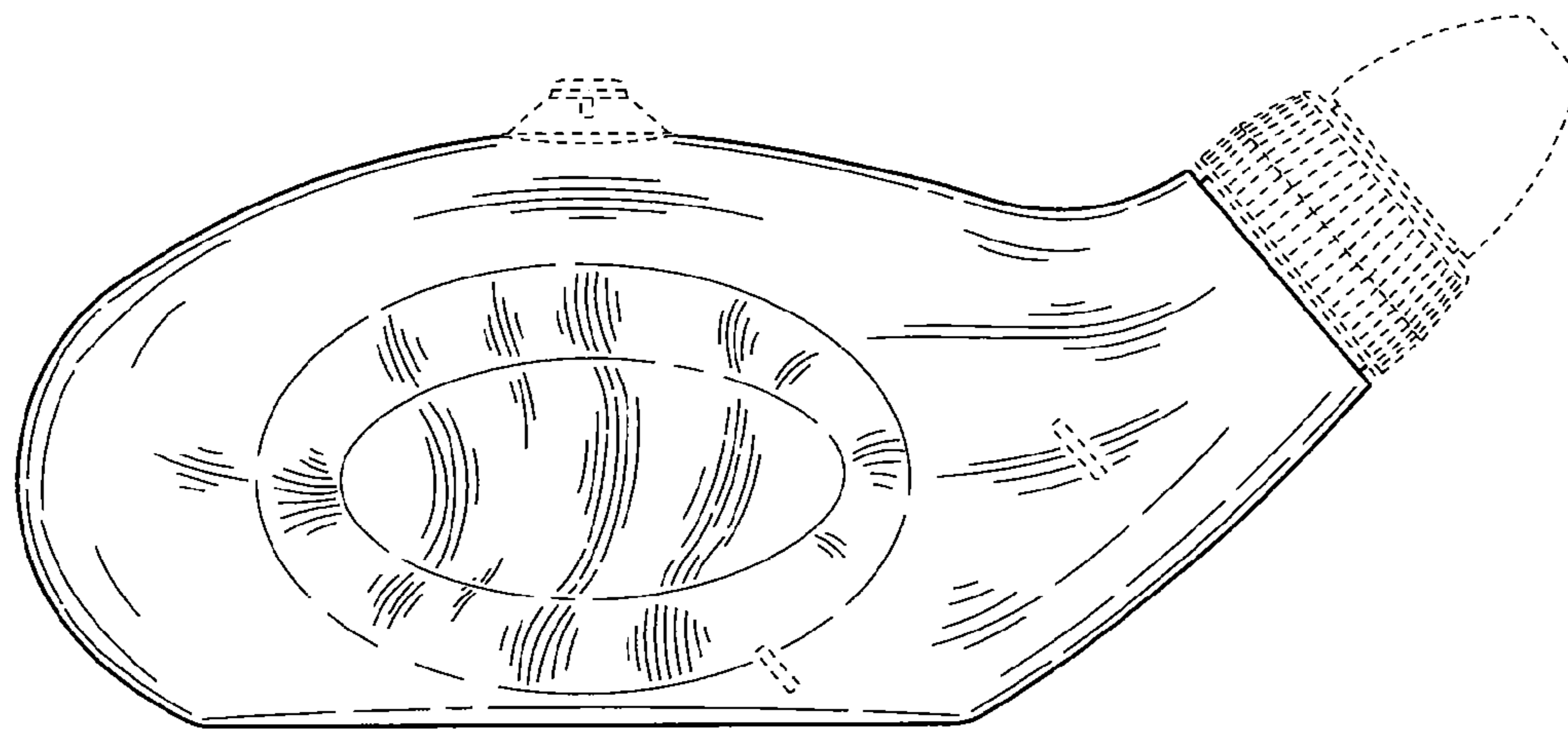

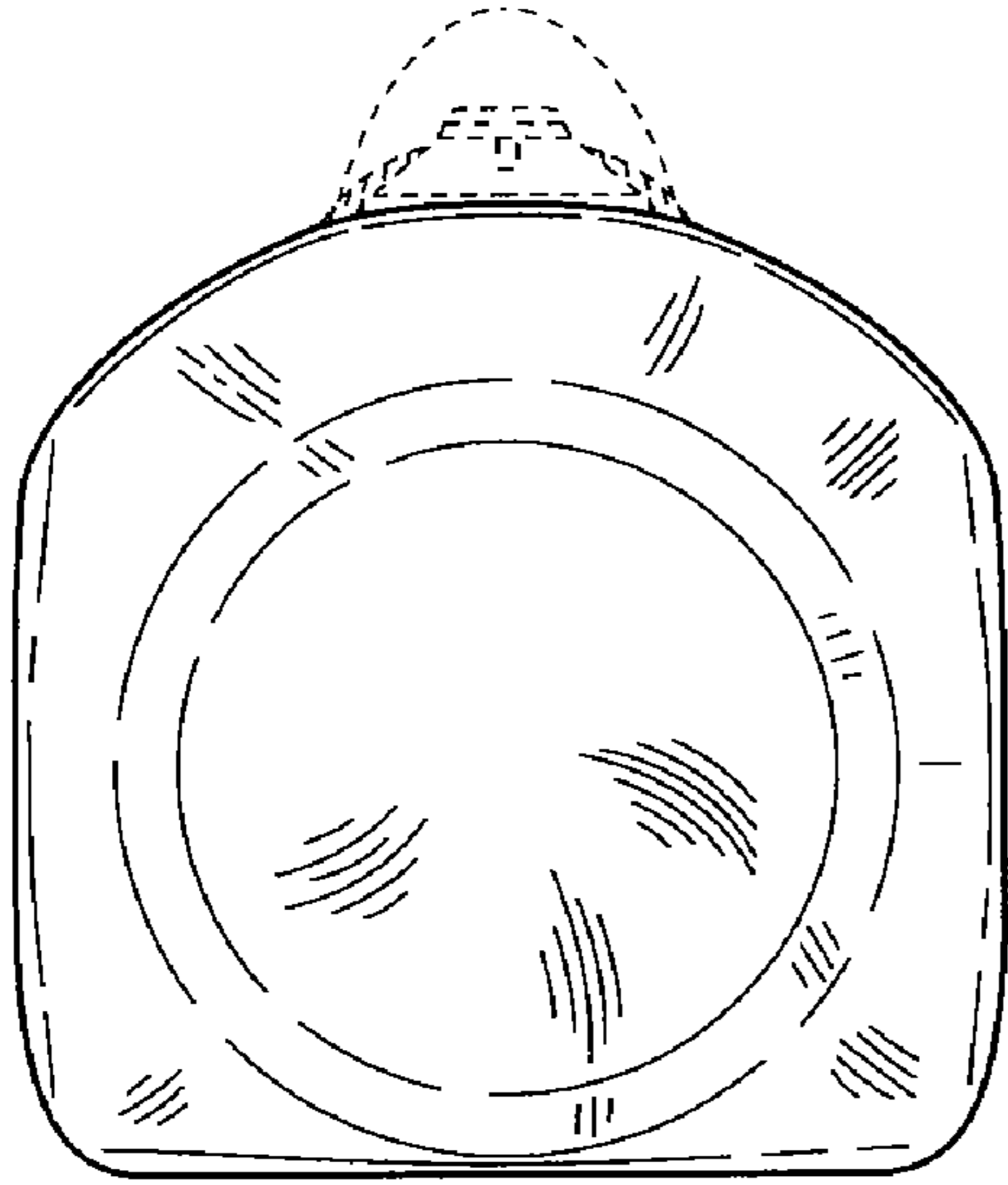

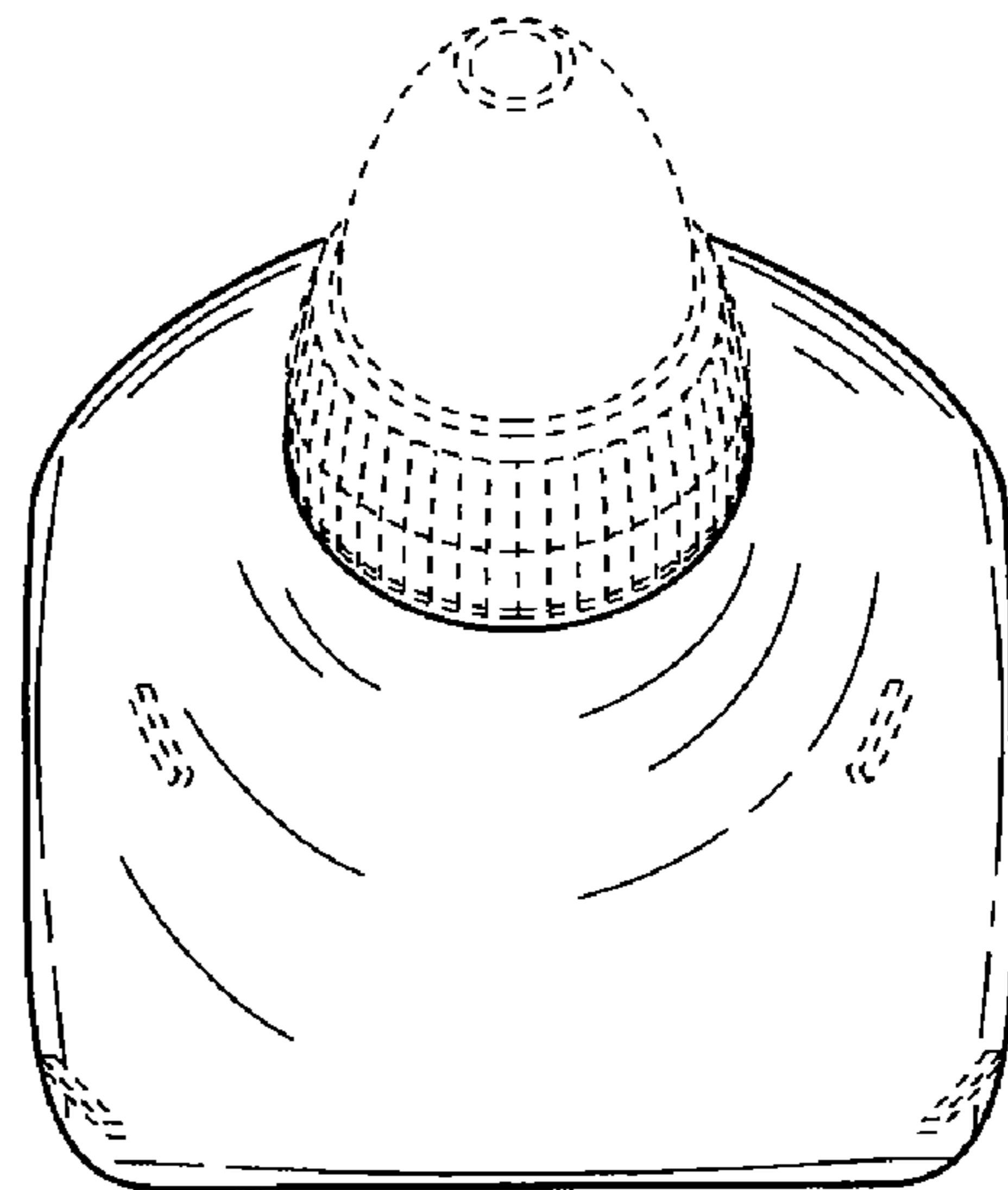

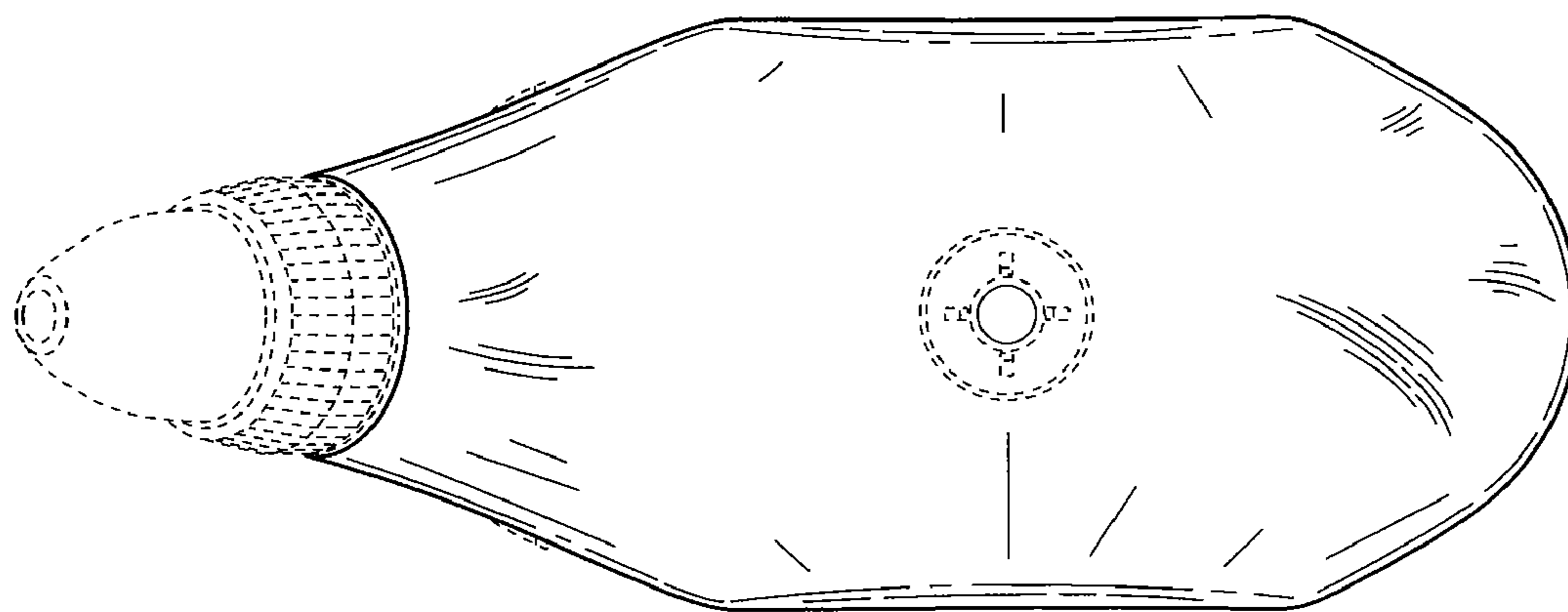

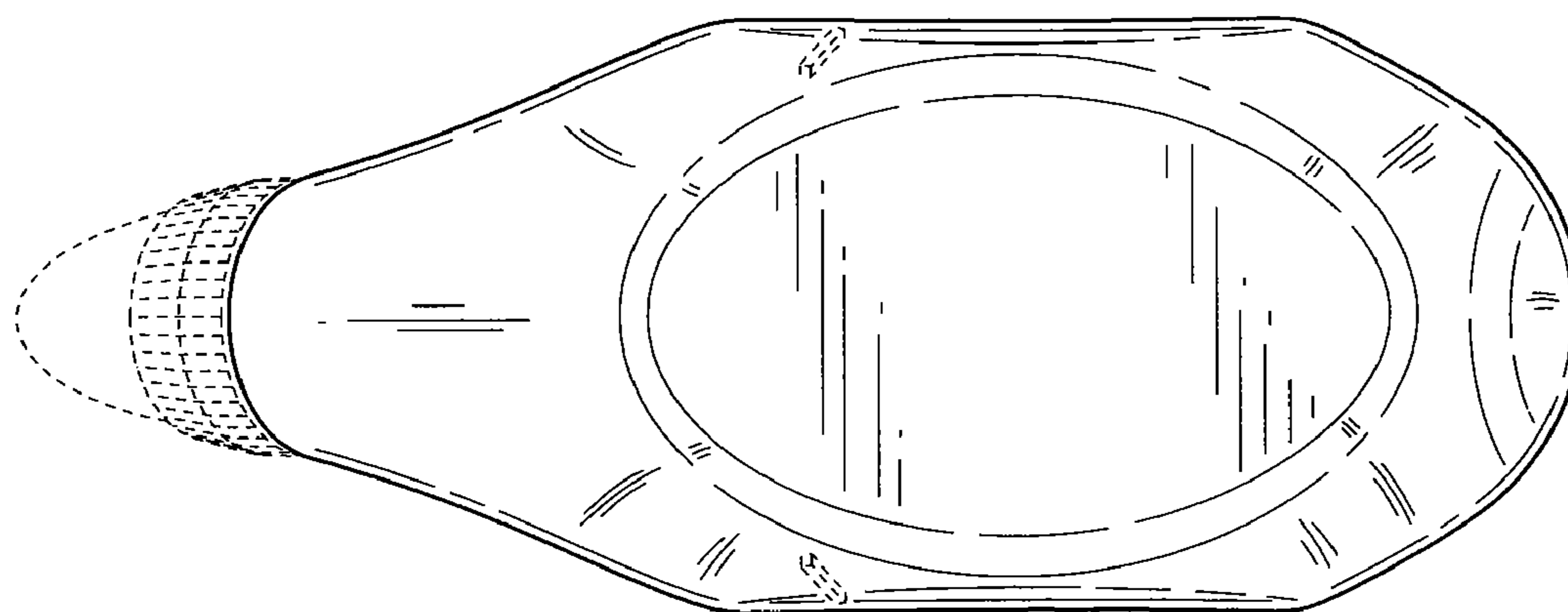
