The ornamental design for a needle for medical purposes, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a needle for medical purposes; FIG. 2 is a front view thereof, the opposite side being an identical image of the side shown herein;

FIG. 3 is a left side view thereof, the opposite side being an identical image of the side shown herein;

FIG. 4 is a top view thereof;

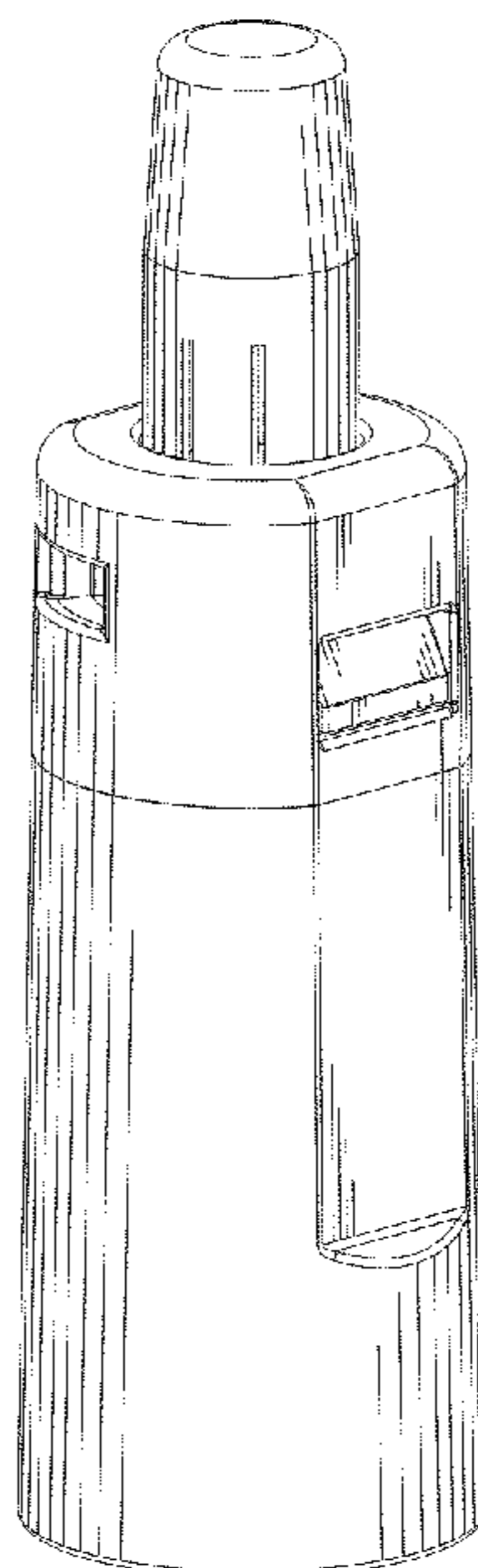
FIG. 5 is a bottom view thereof;

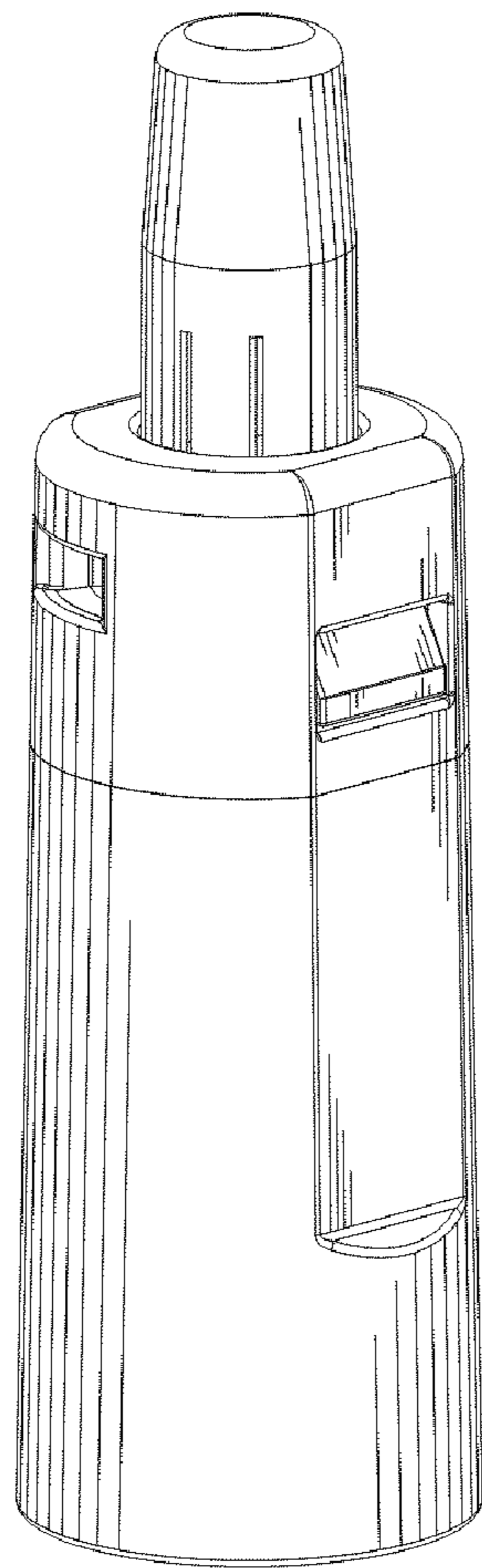

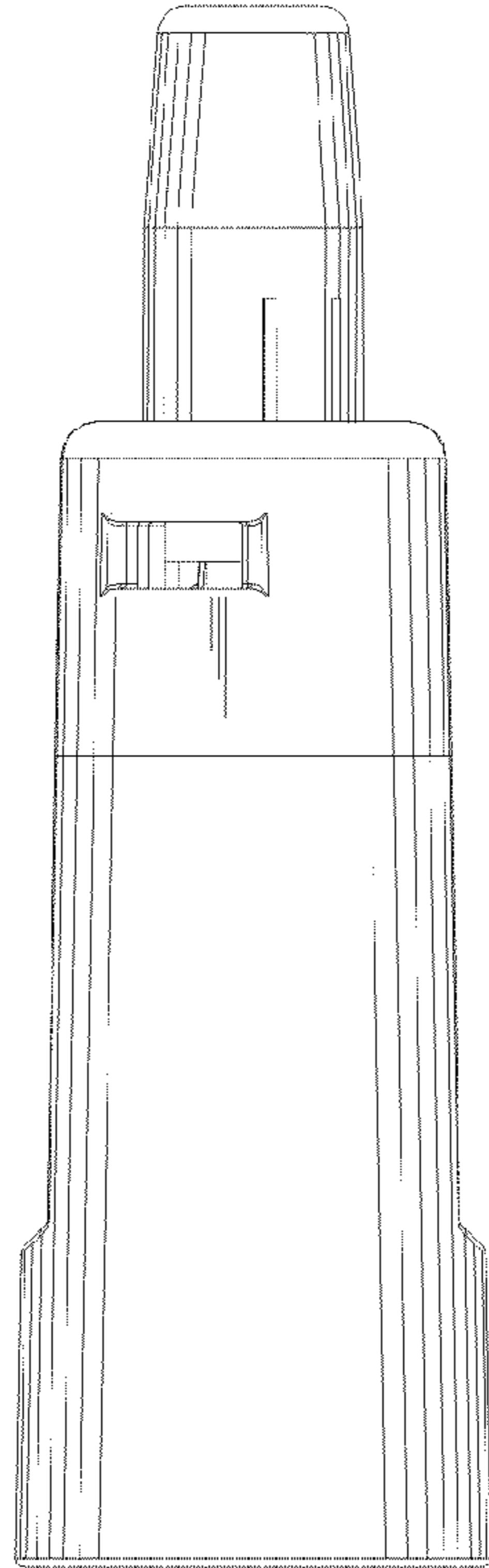

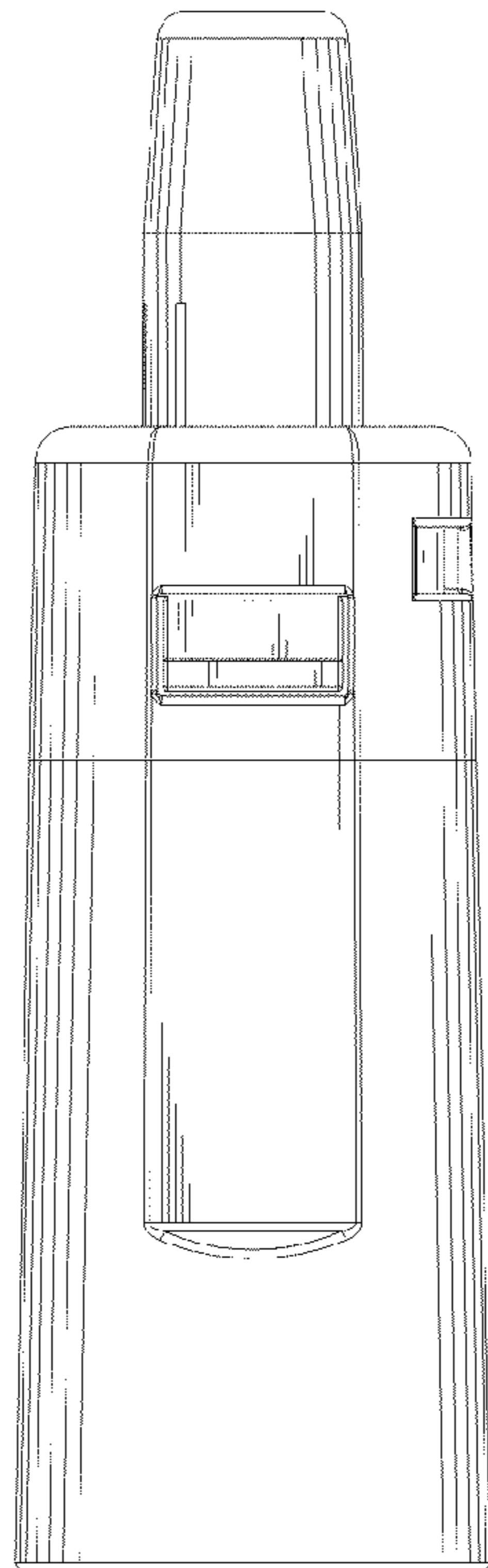

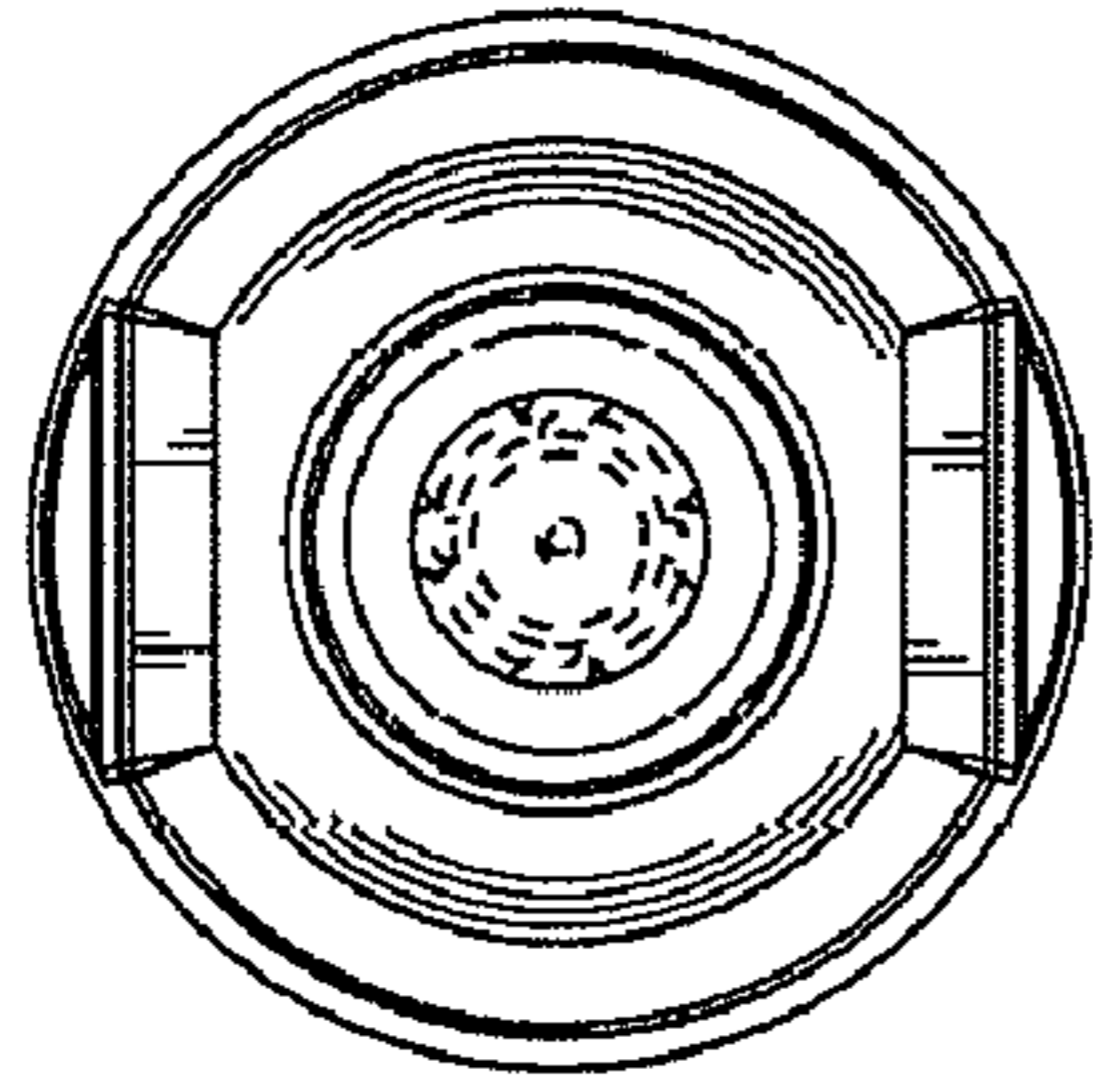

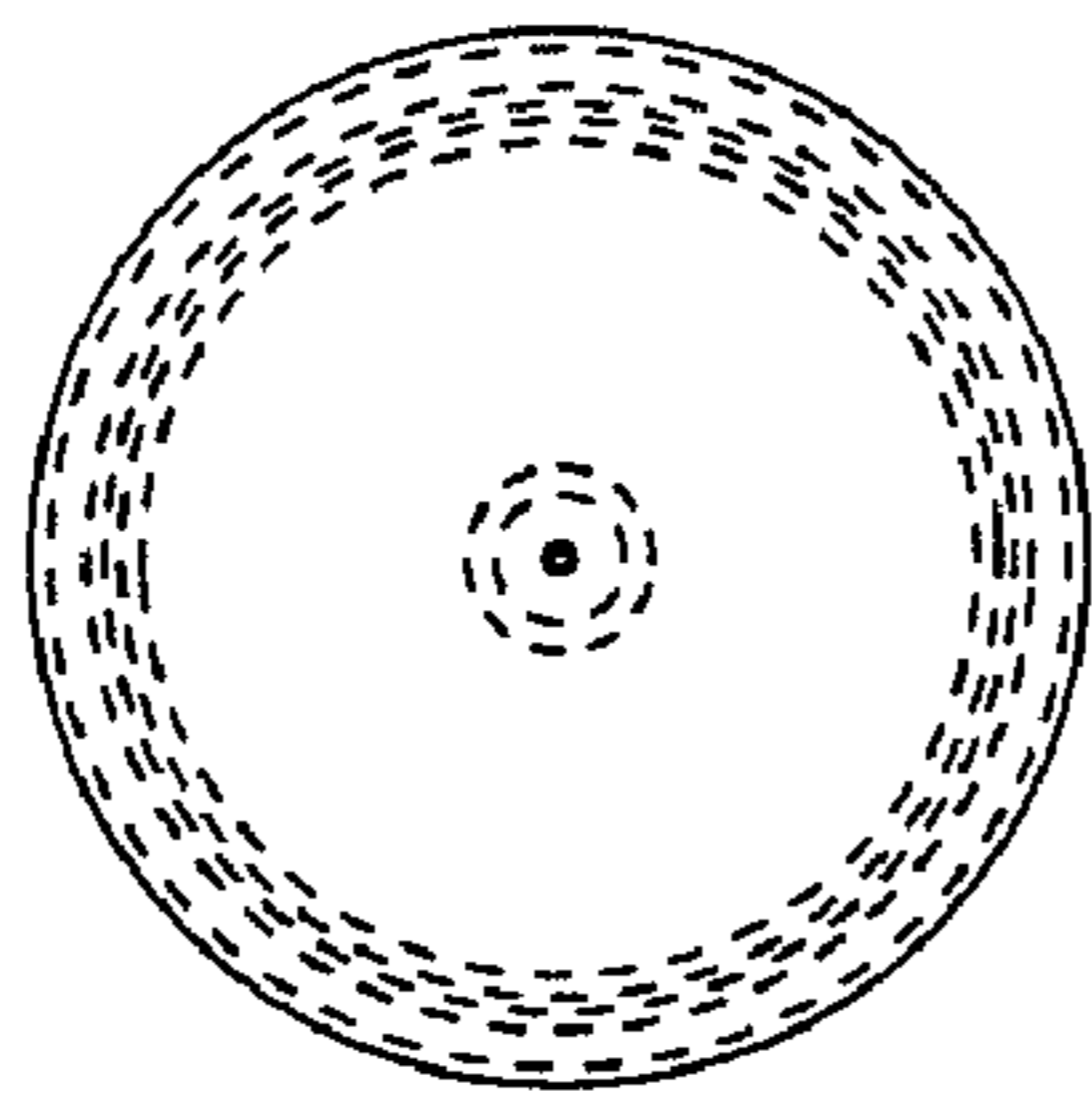

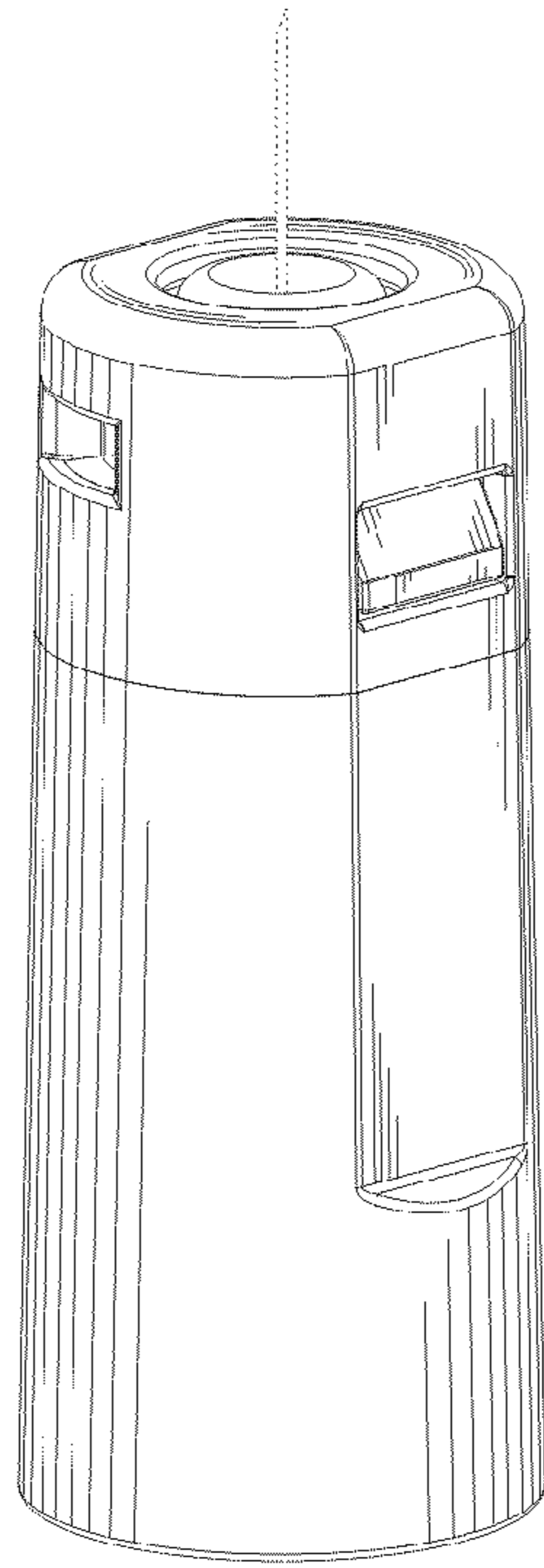

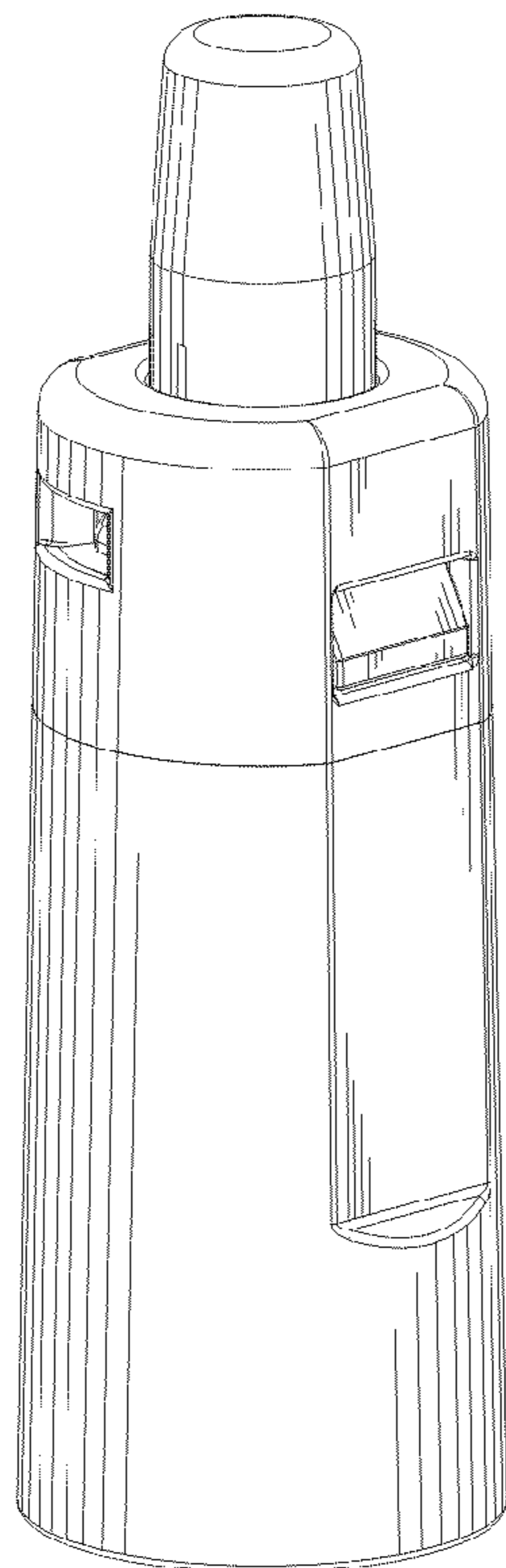
