DESCRIPTION

FIG. 1 is a front perspective view of a spinal implant showing our new design;

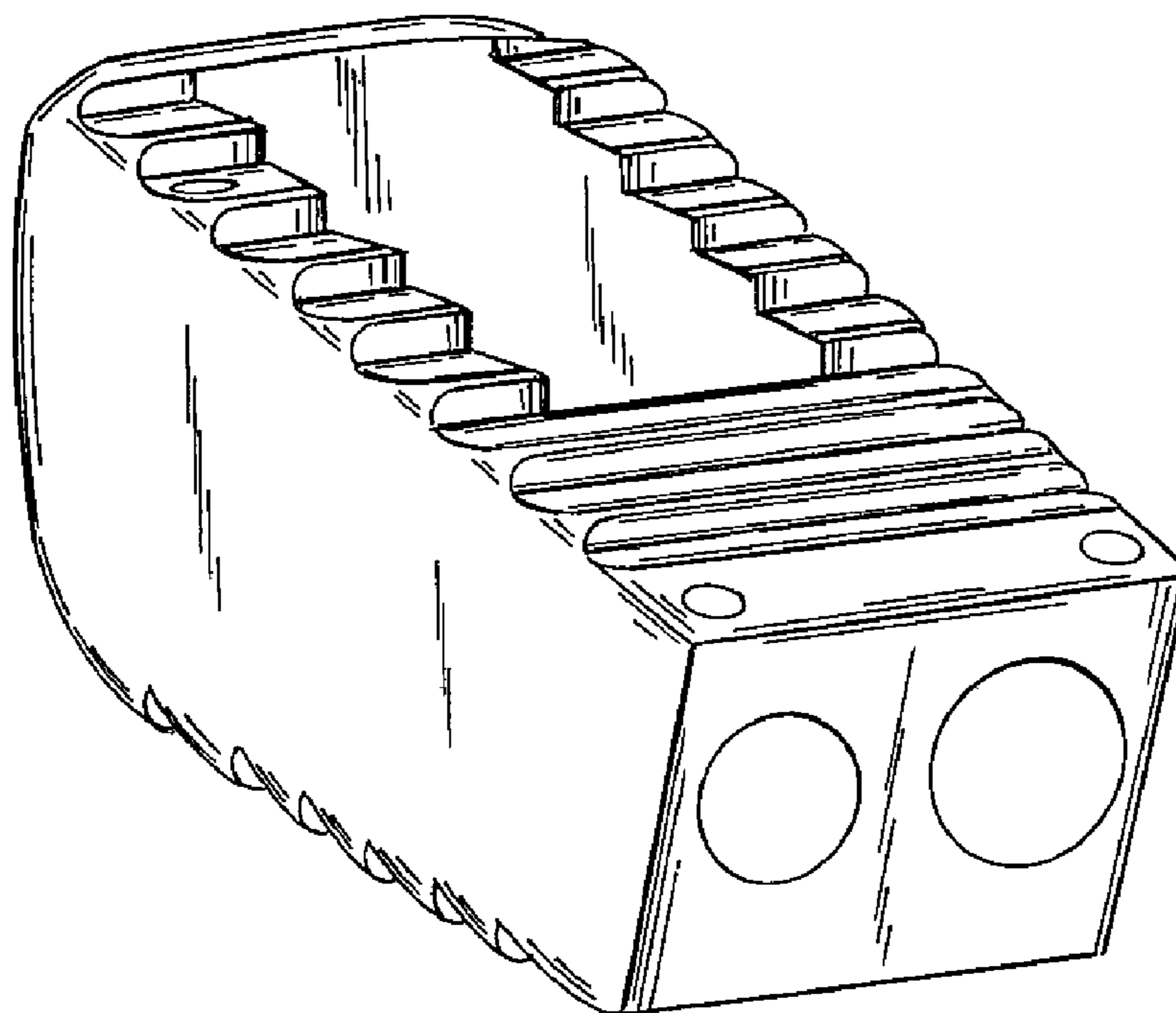
FIG. 2 is a top plan view thereof shown on an enlarged scale, the bottom being identical;

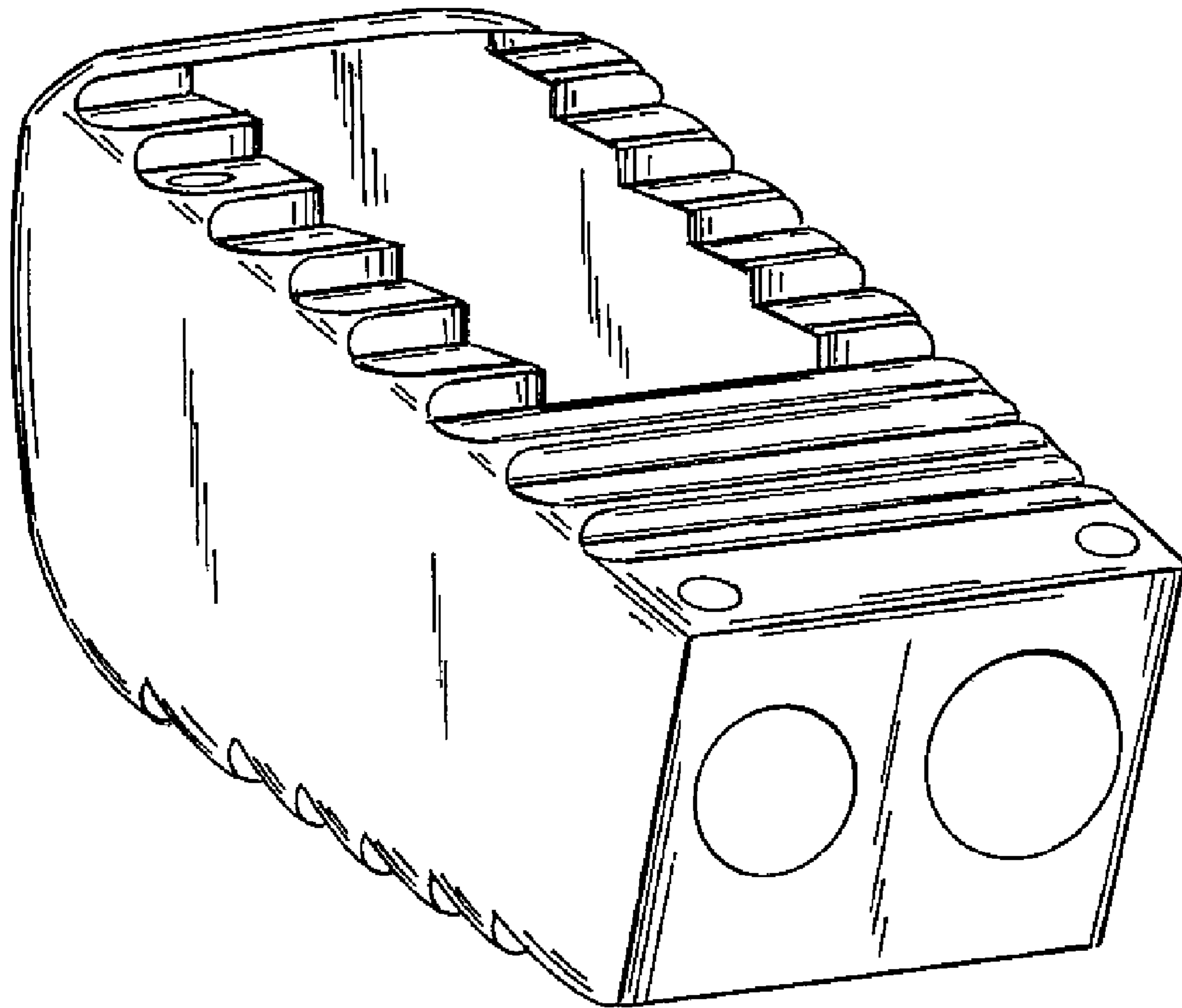

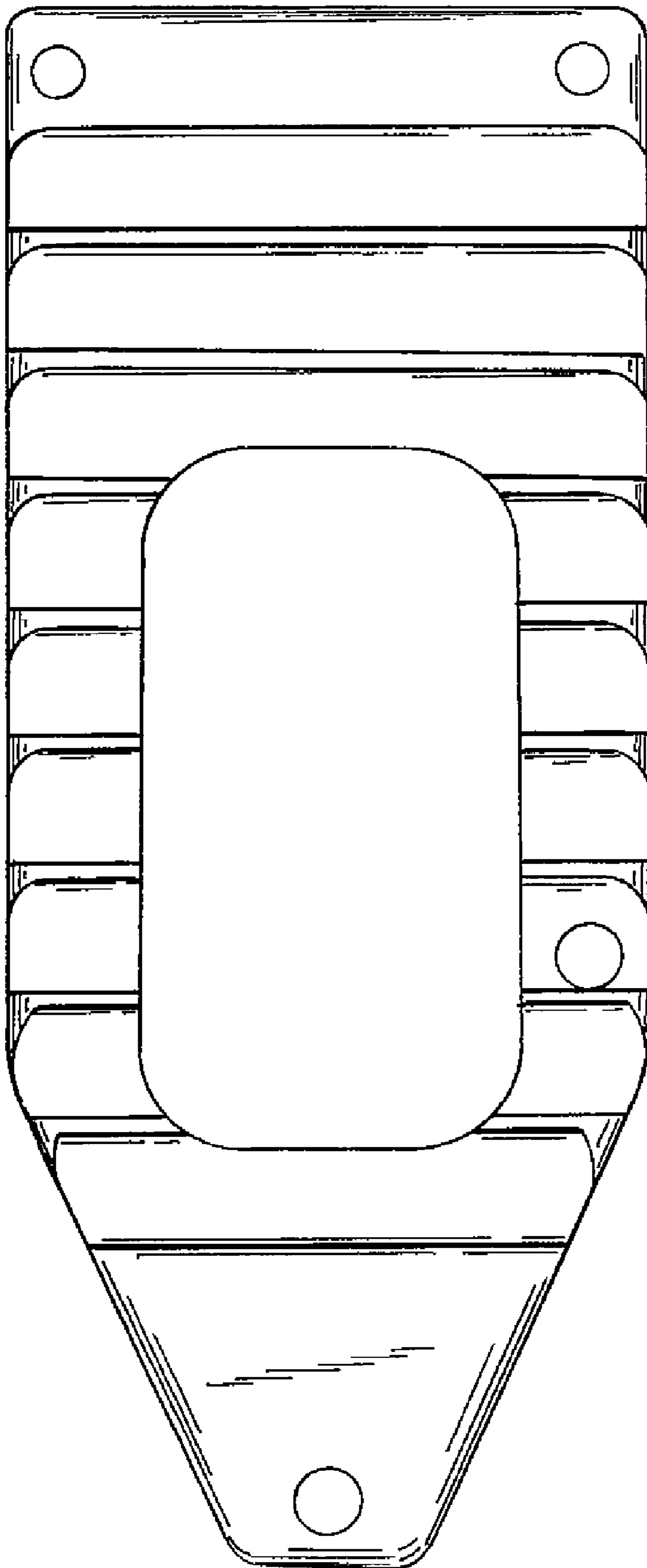

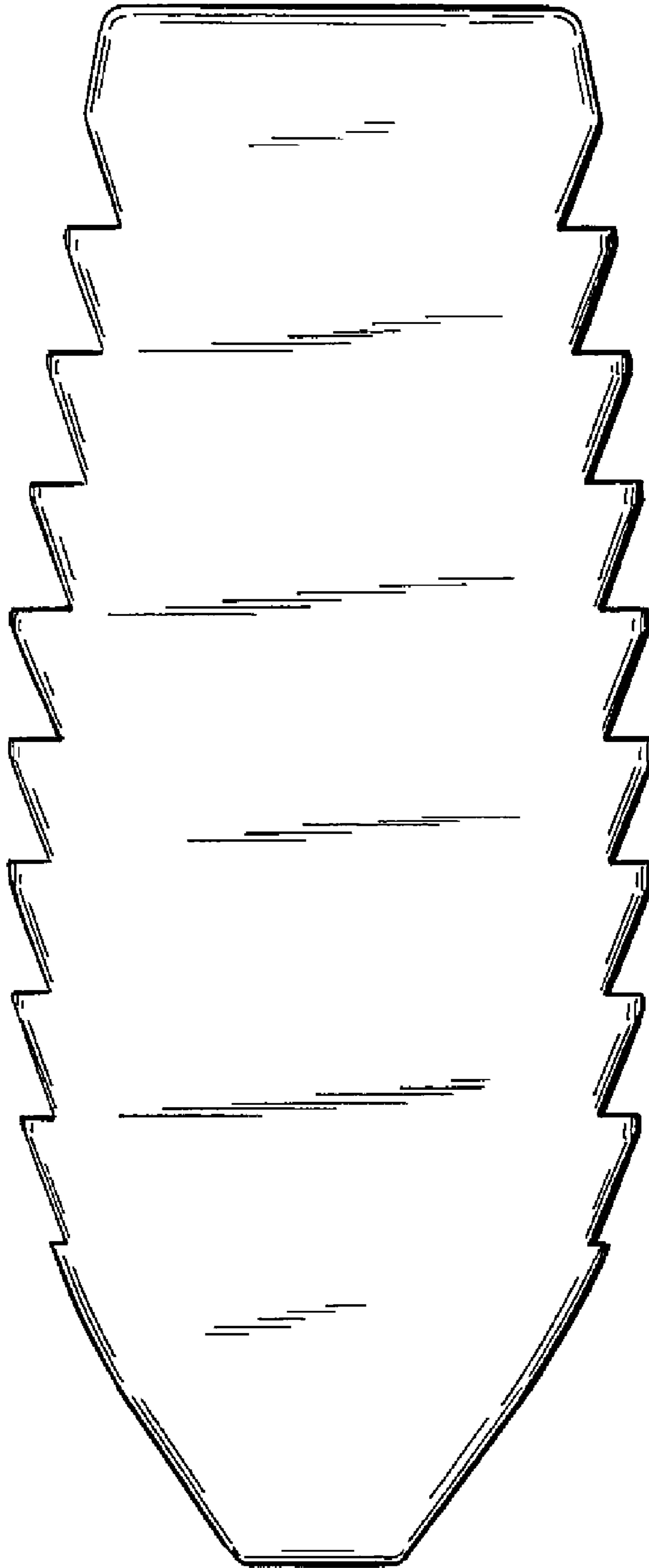

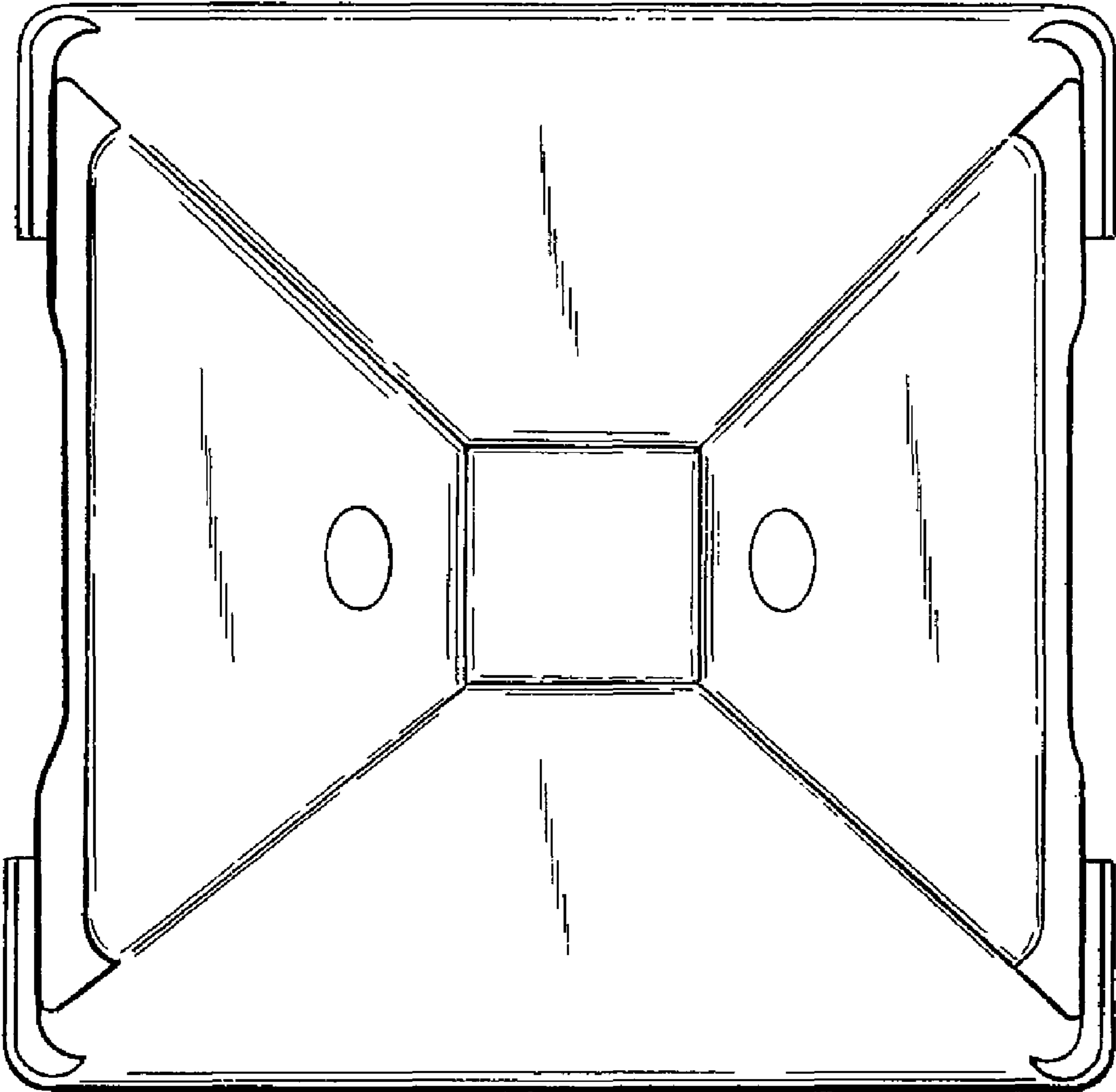

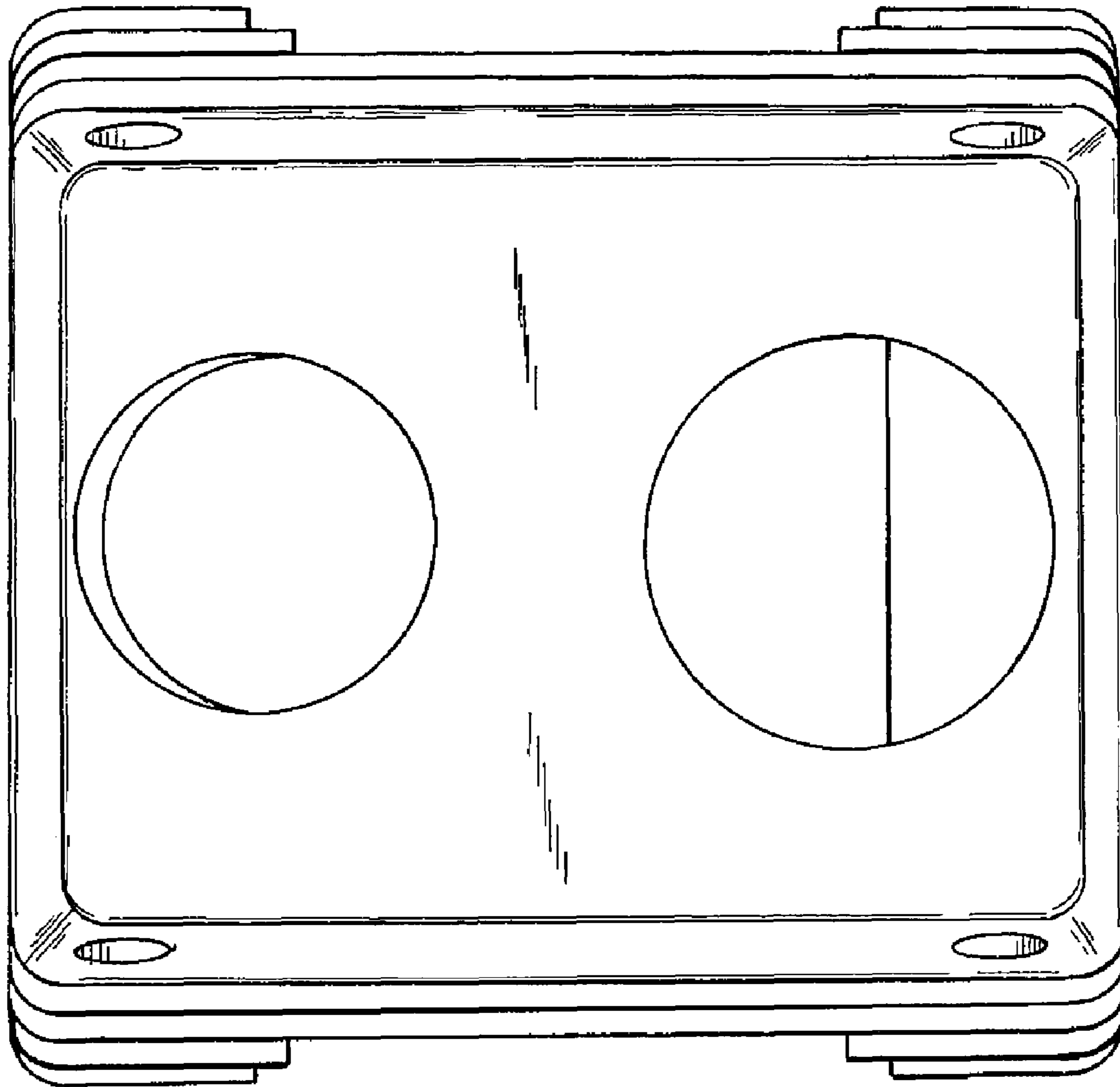
