FIG. 3 is a top plan view thereof;

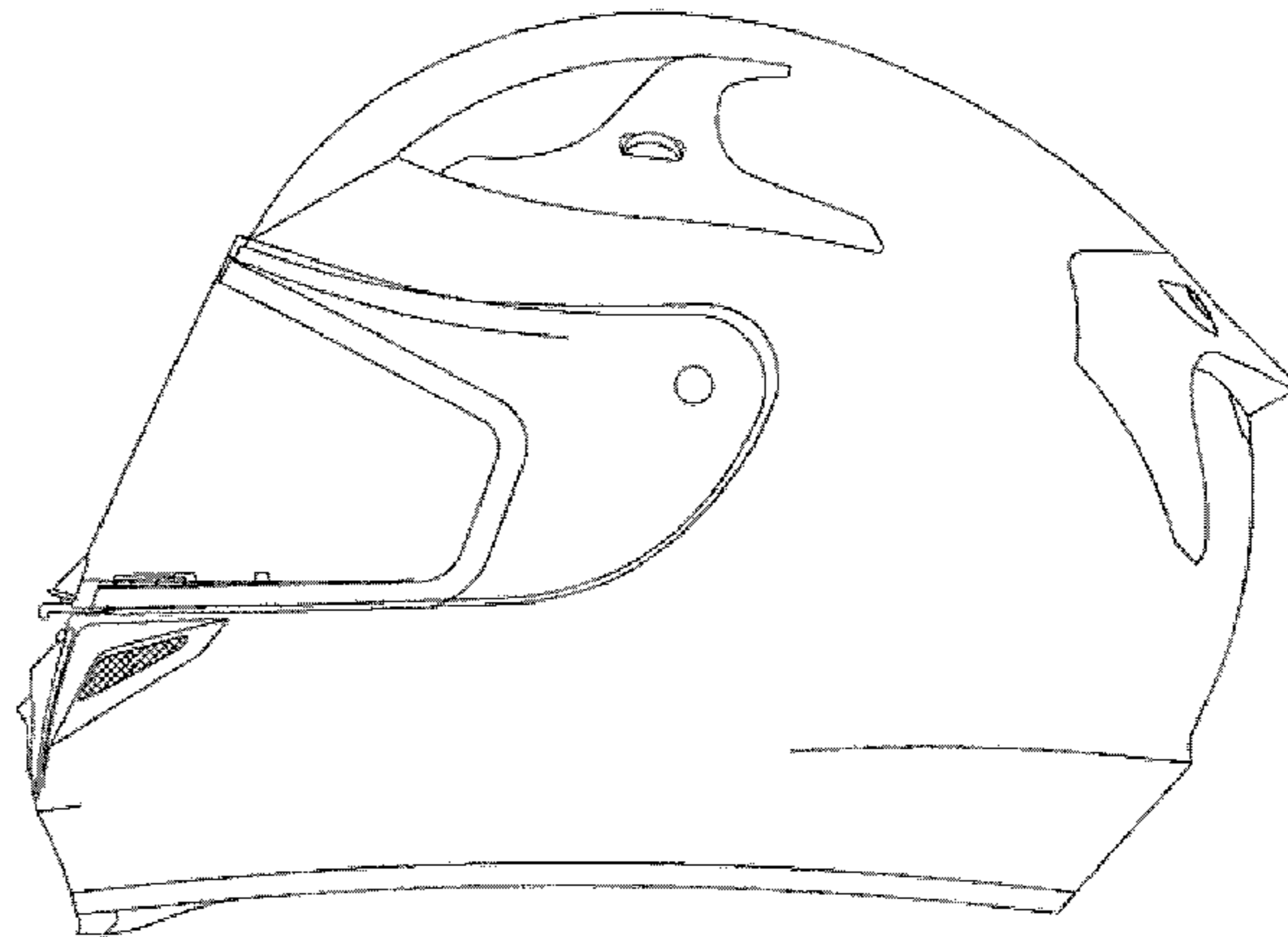
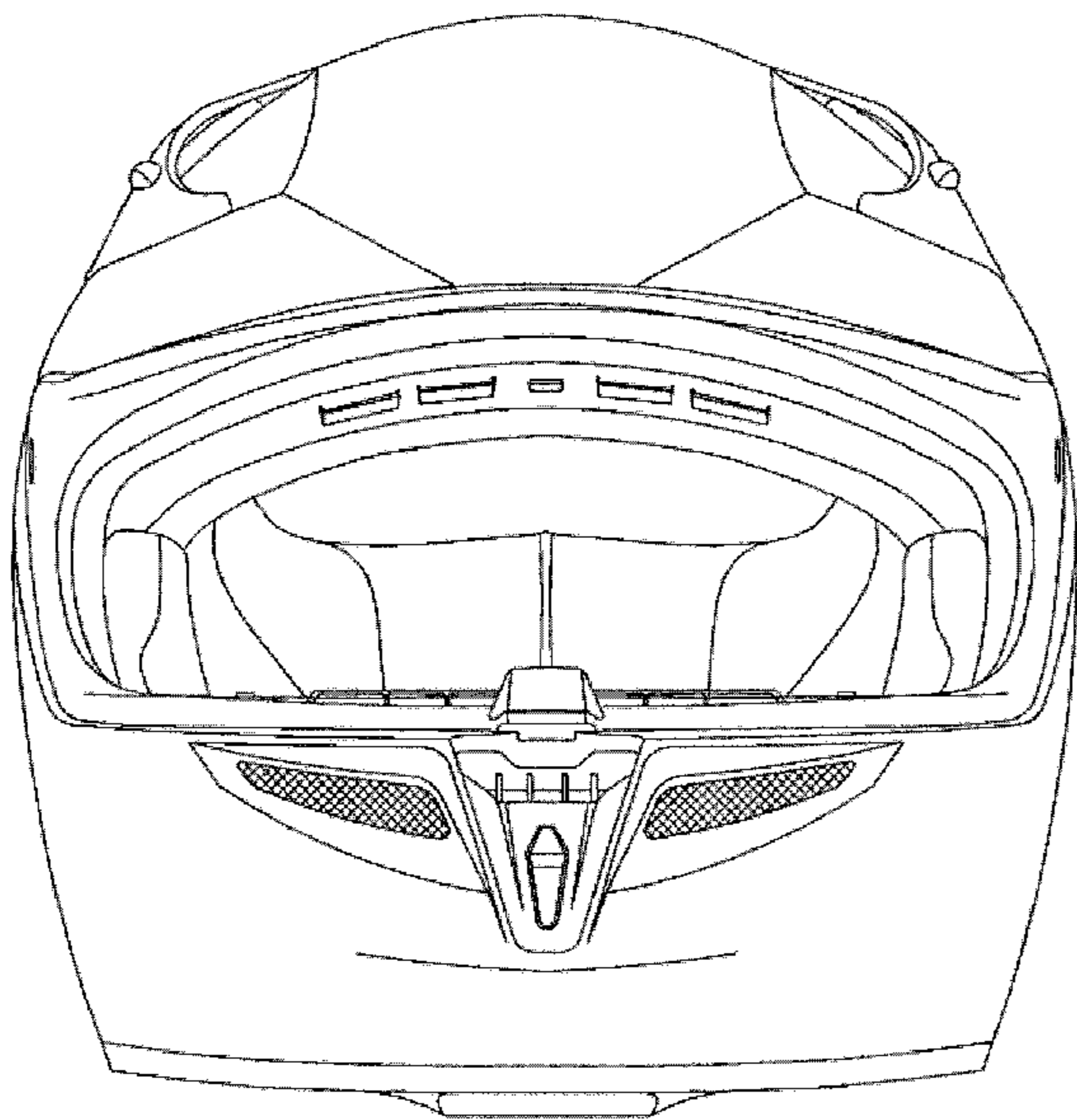
FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevational view thereof;

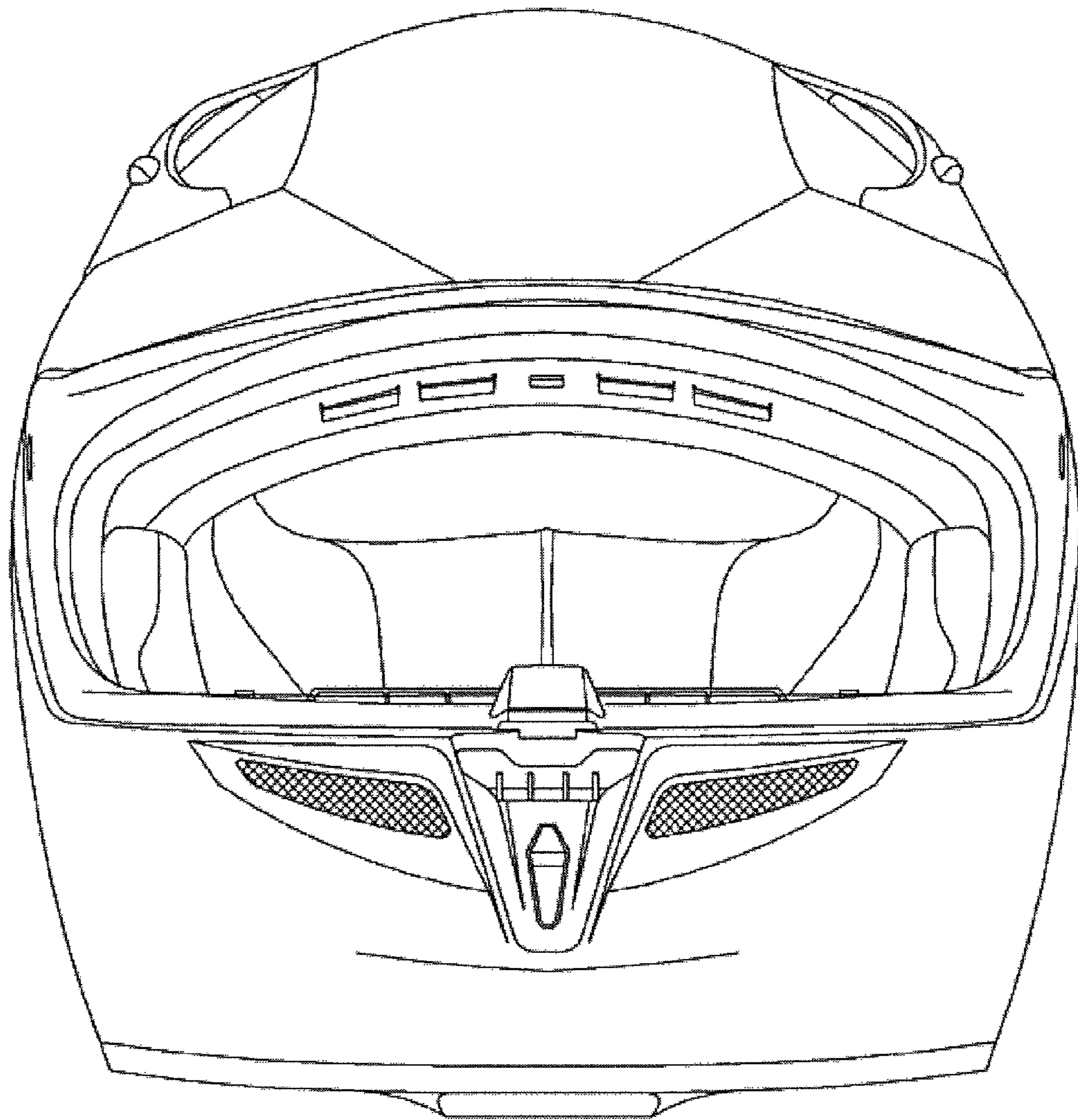
FIG. 6 is a right side elevational view thereof; and,

FIG. 7 is a top, front and right-side perspective view thereof.

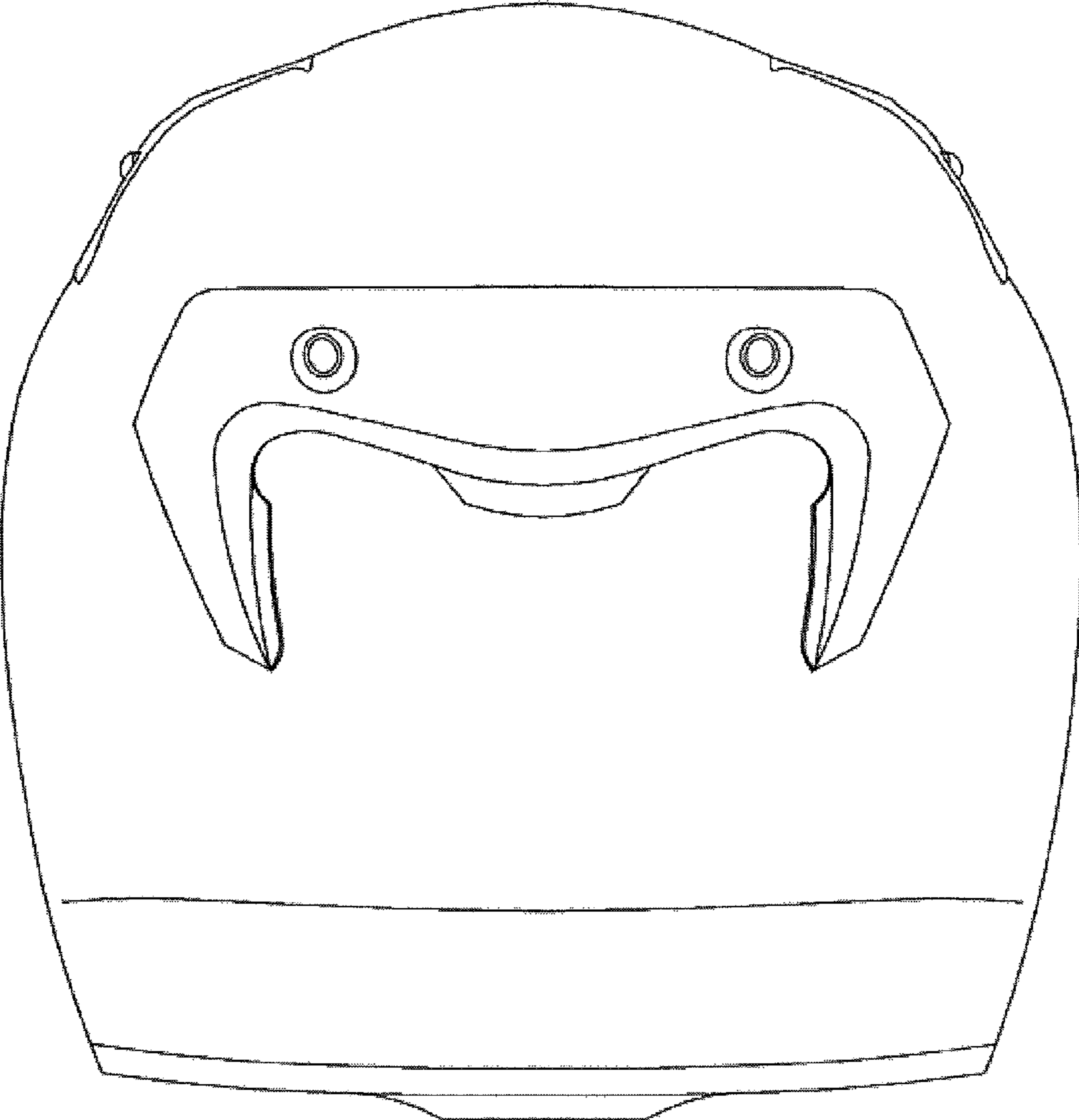

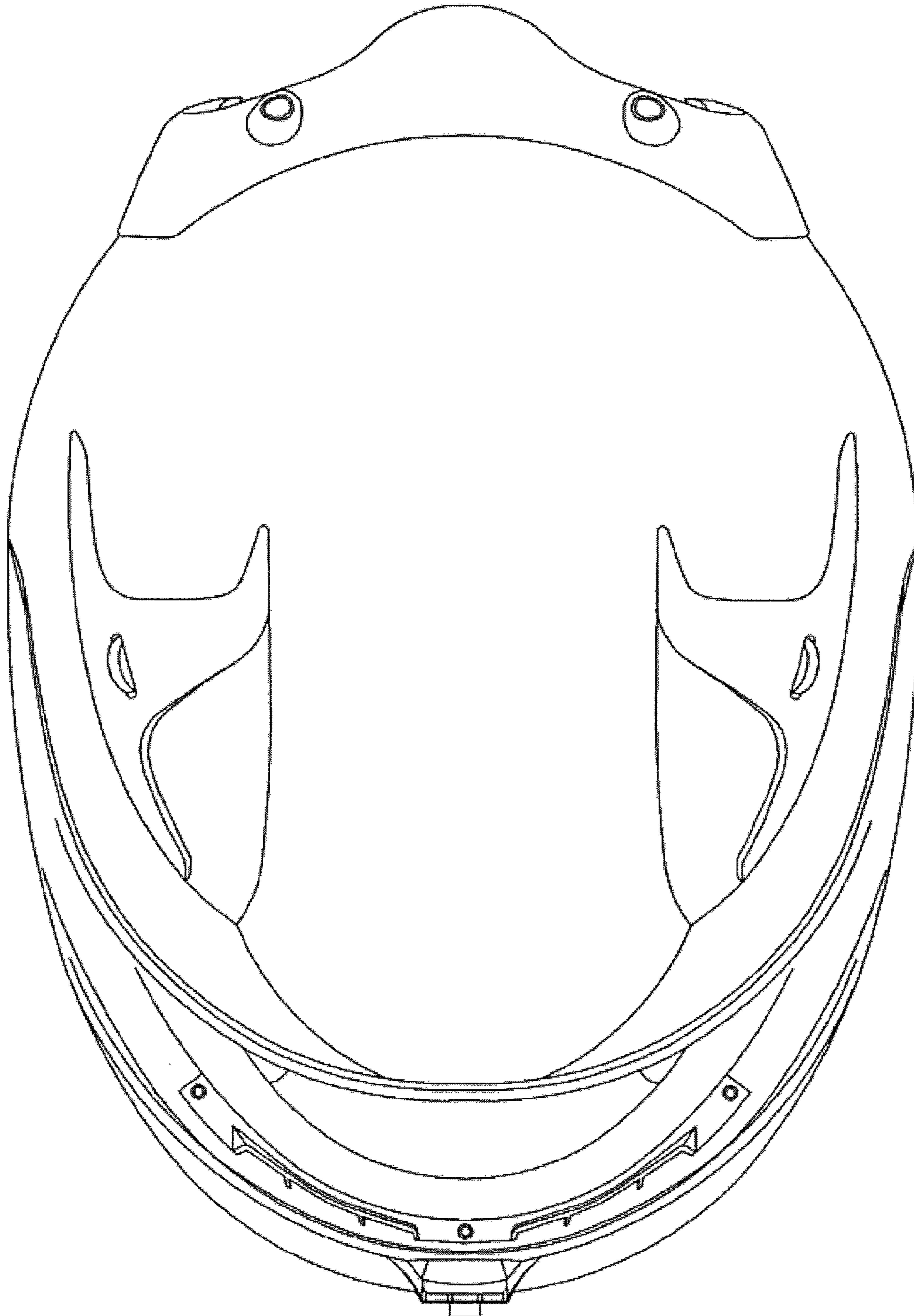

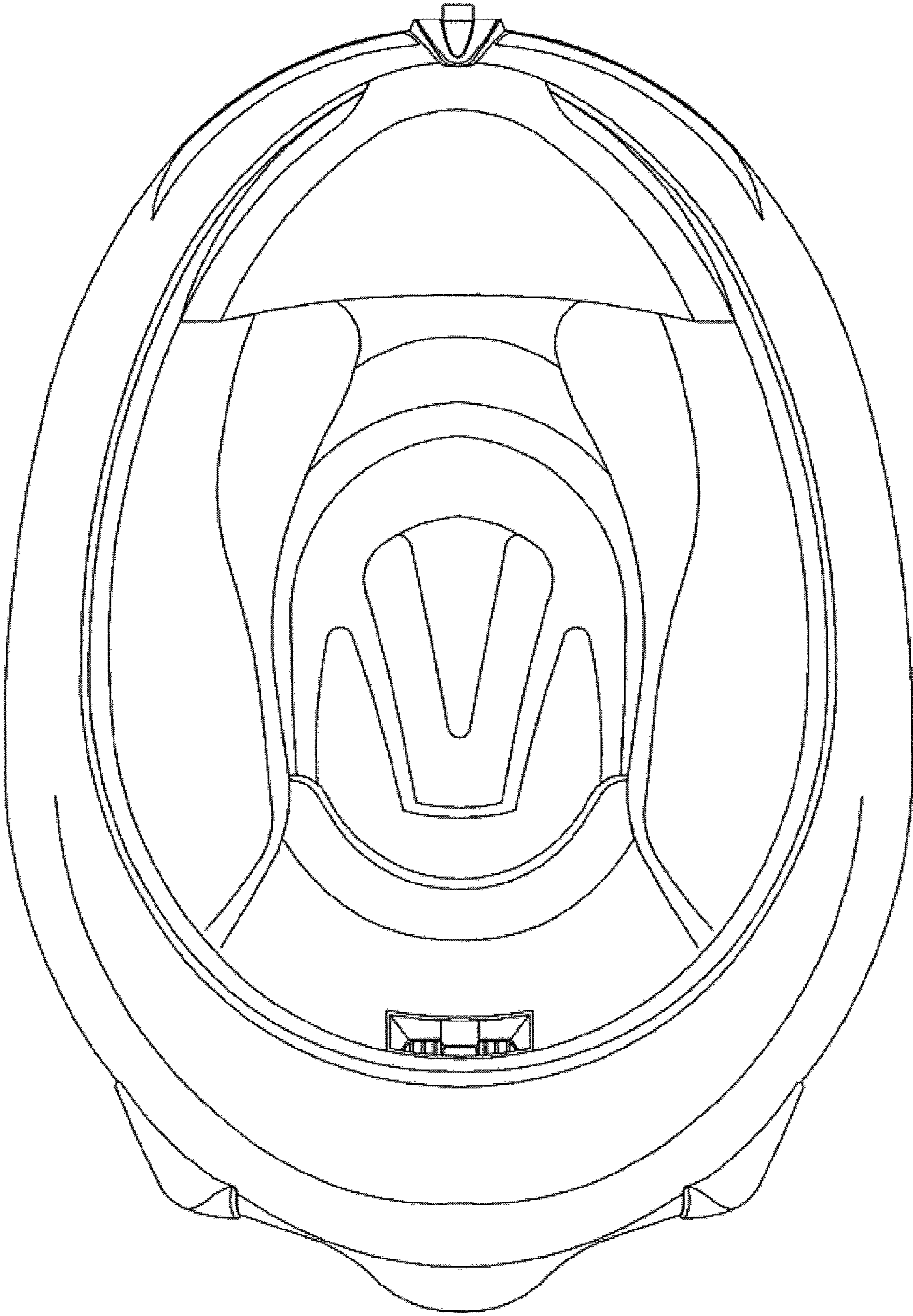

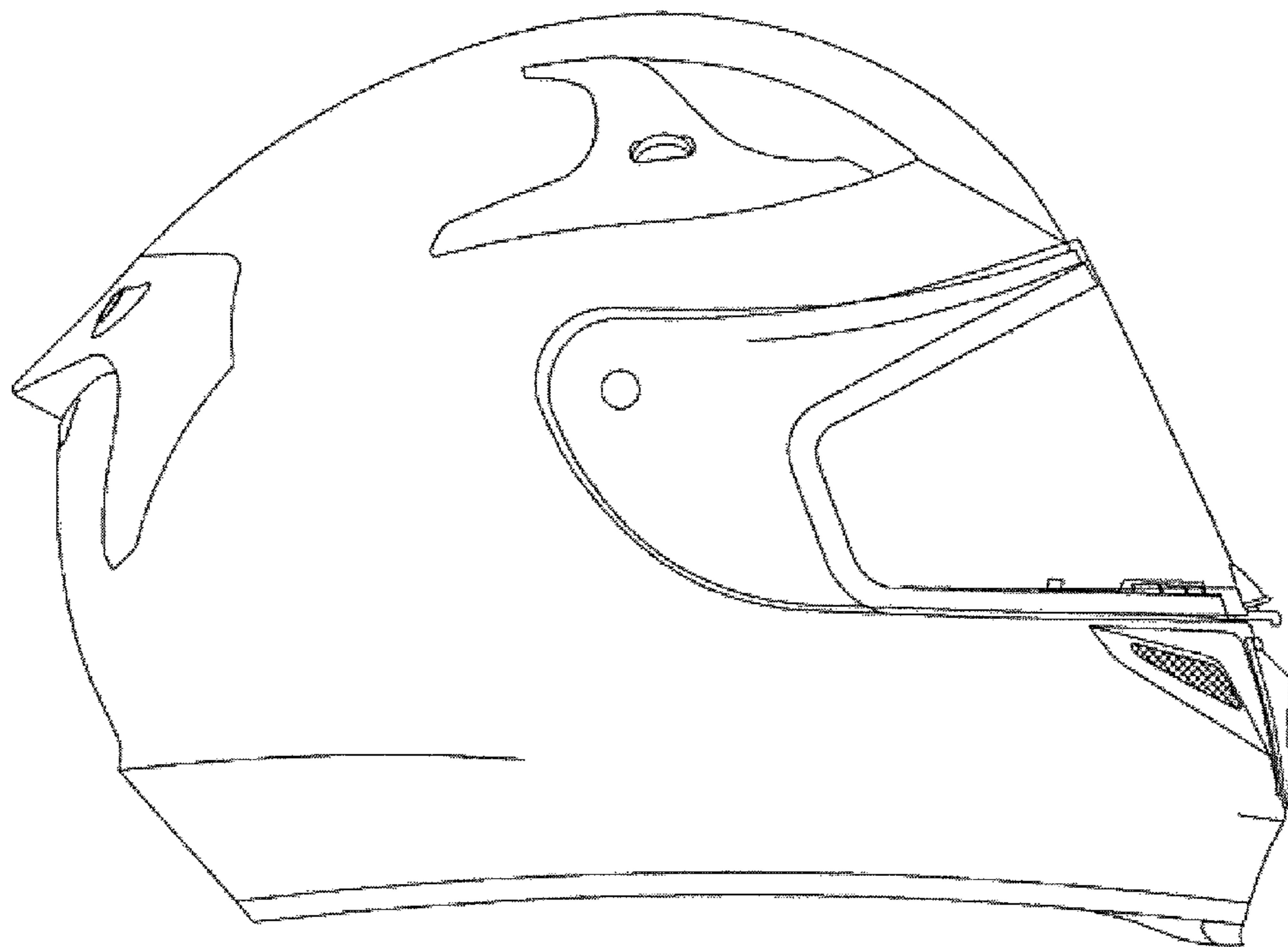

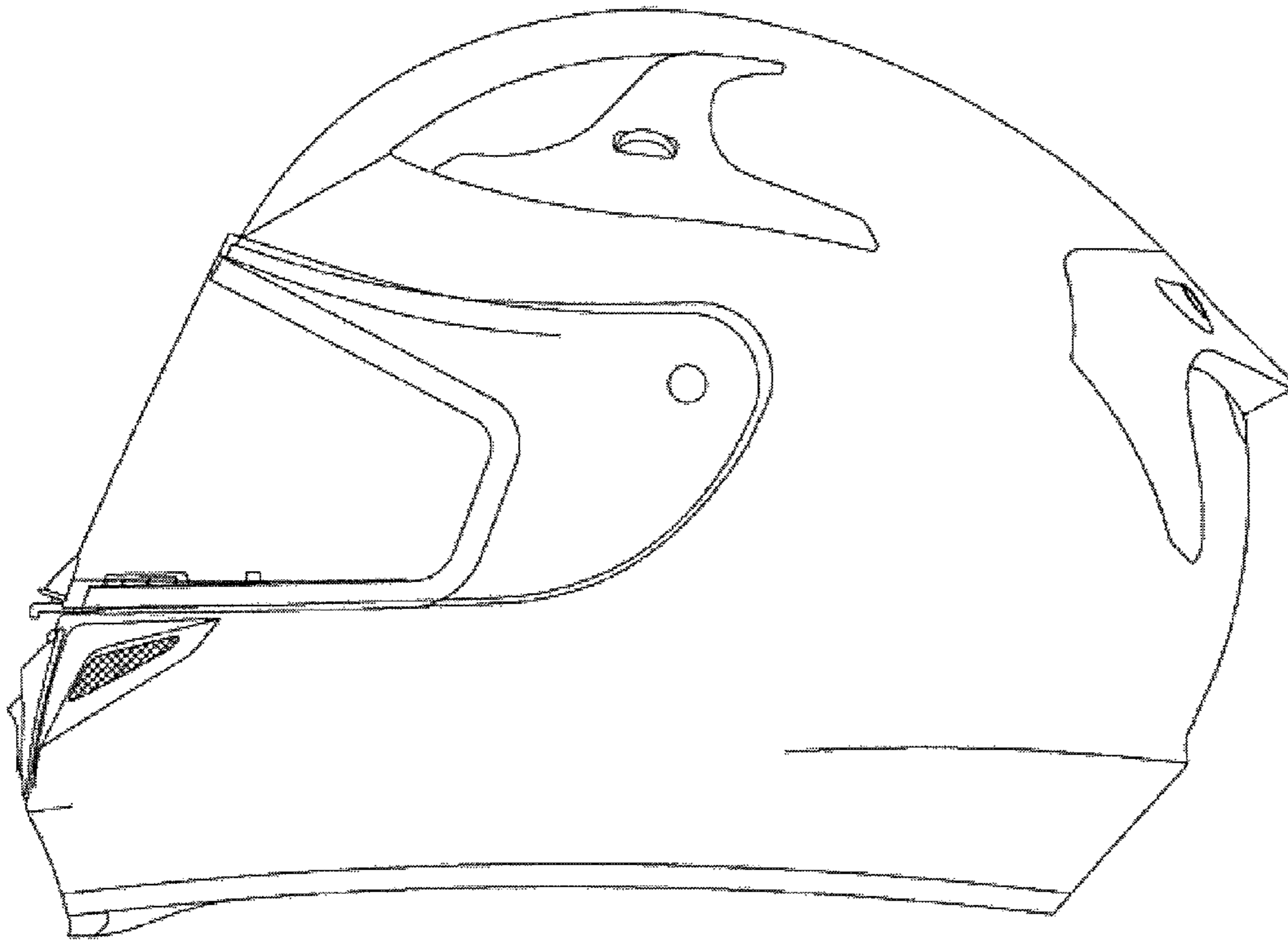
