DESCRIPTION

FIG. 8 is a perspective view of a second embodiment of the pet toy of my design;

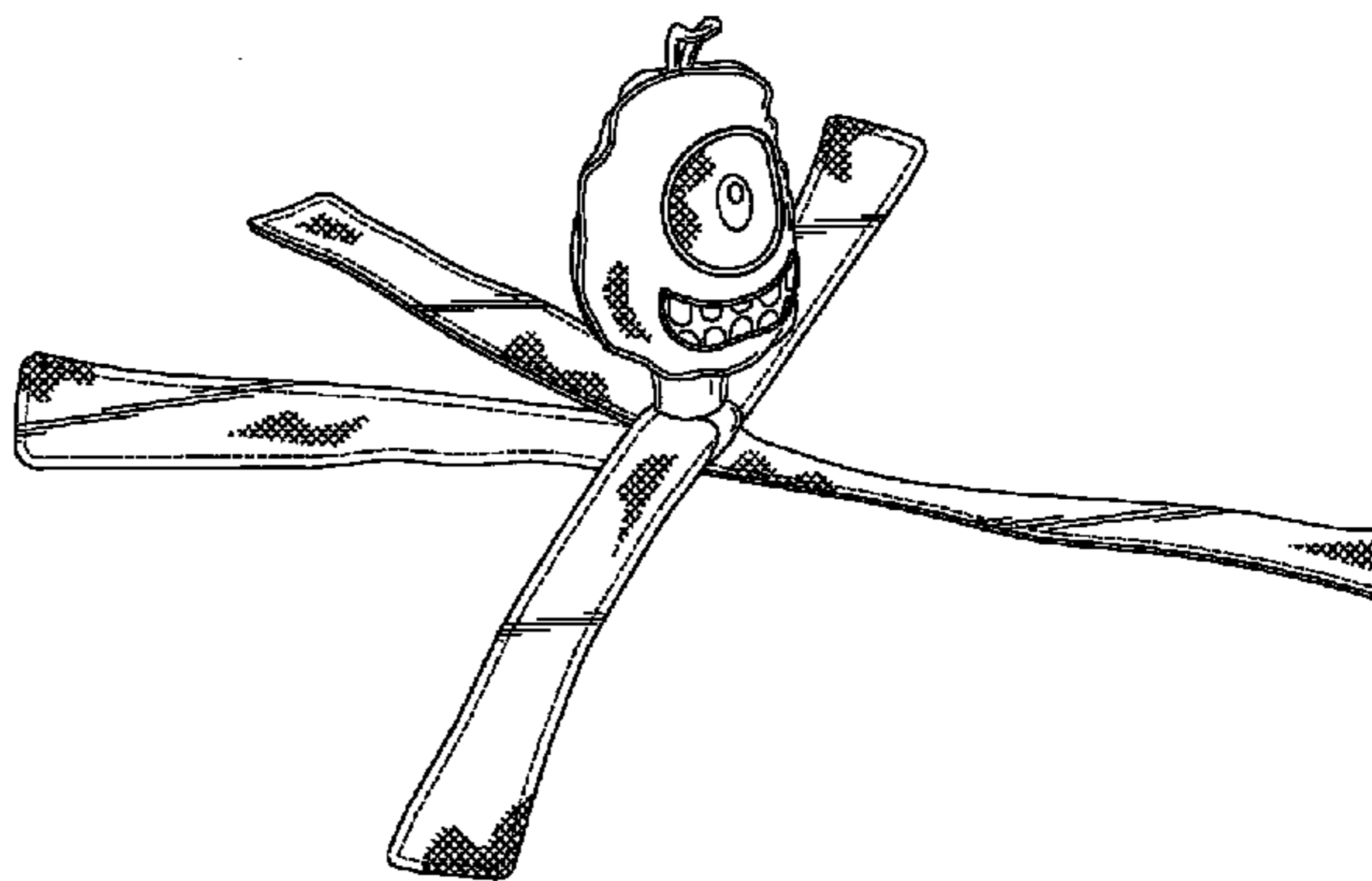
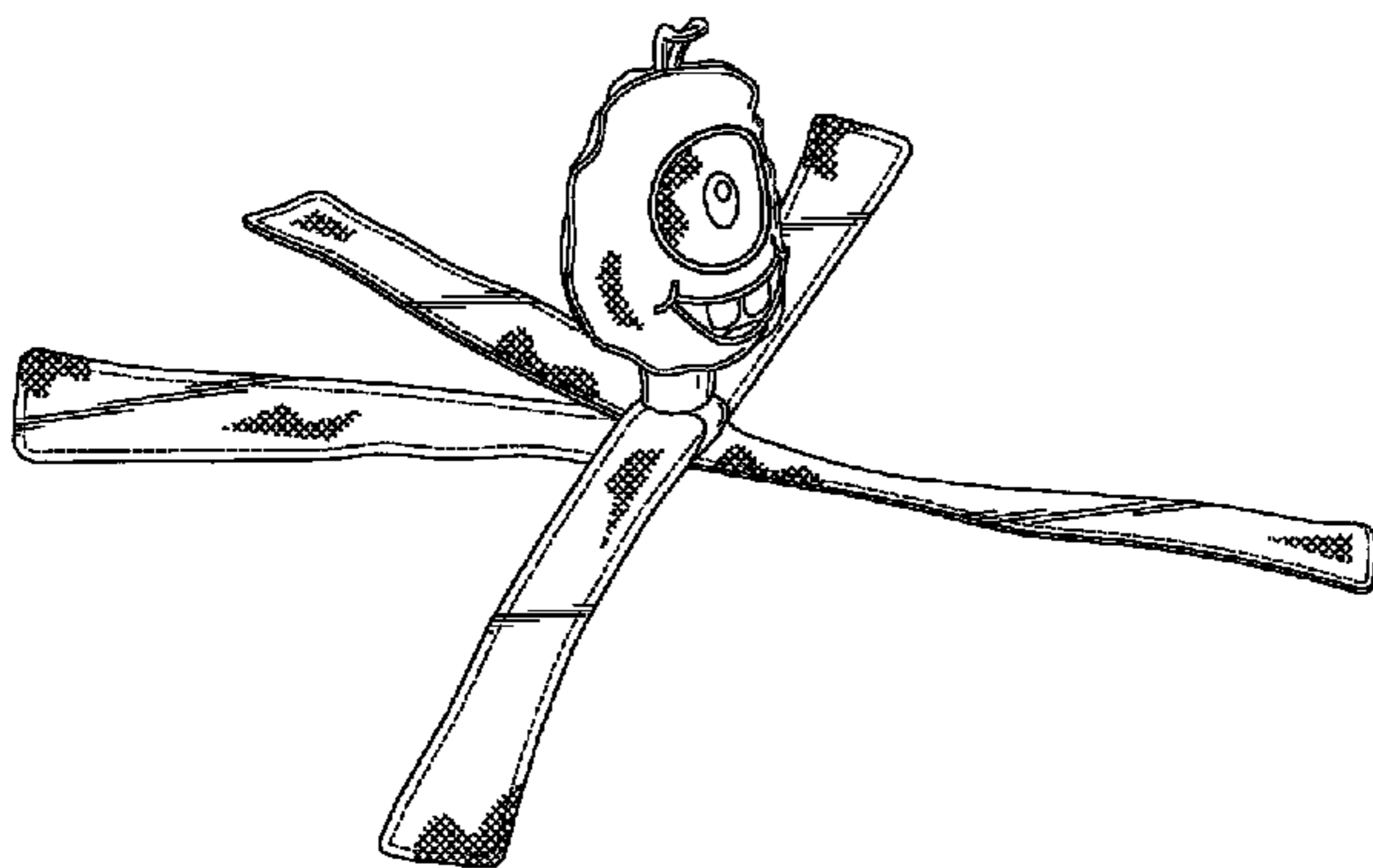
FIG. 9 is a front view of the second embodiment of the pet toy of my design;

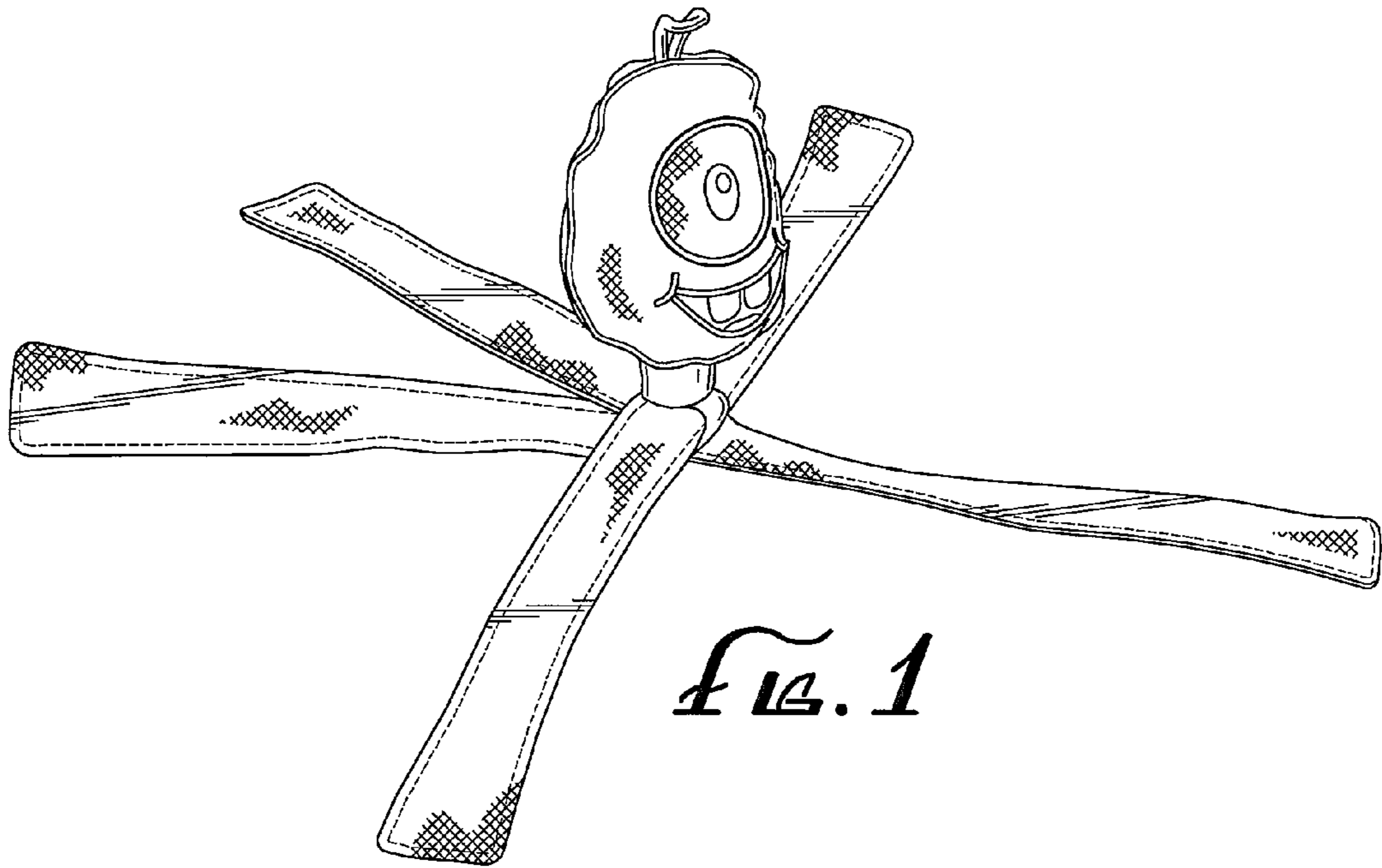

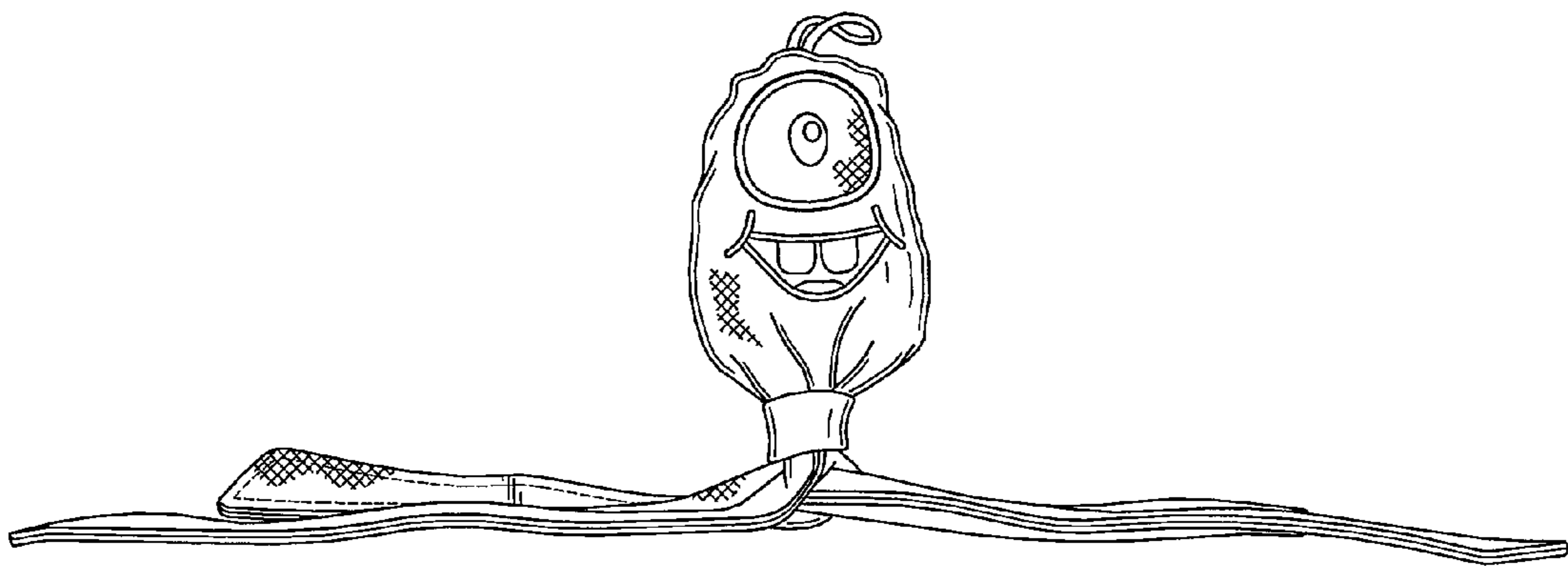
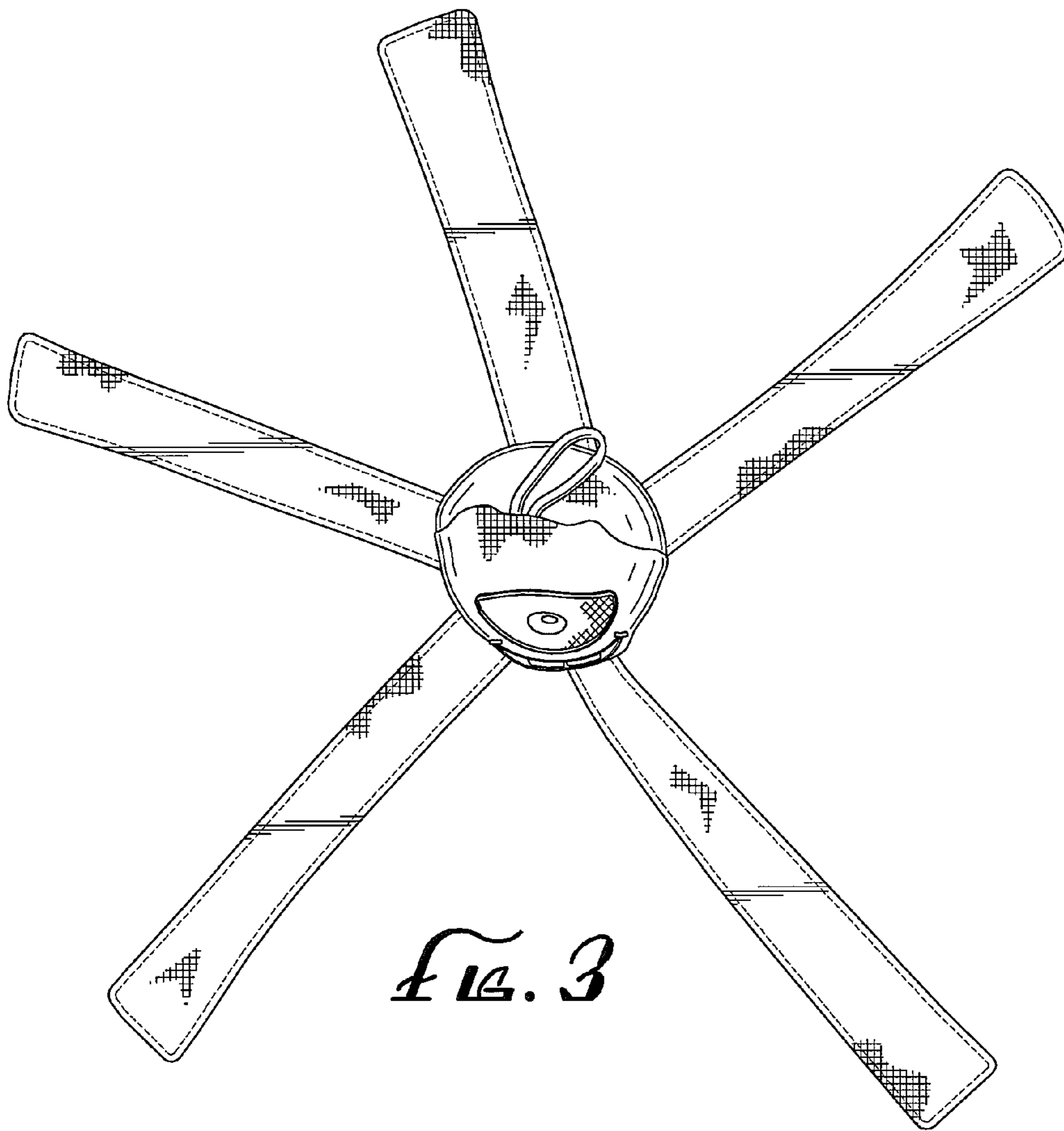

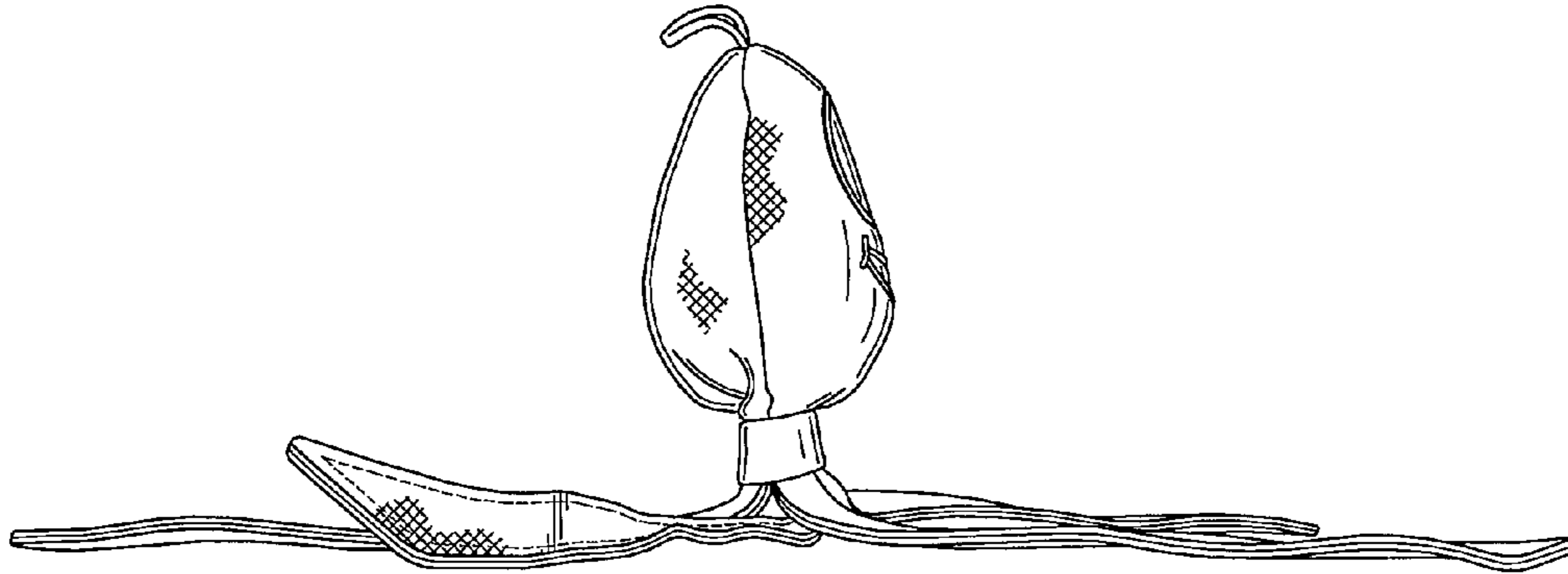

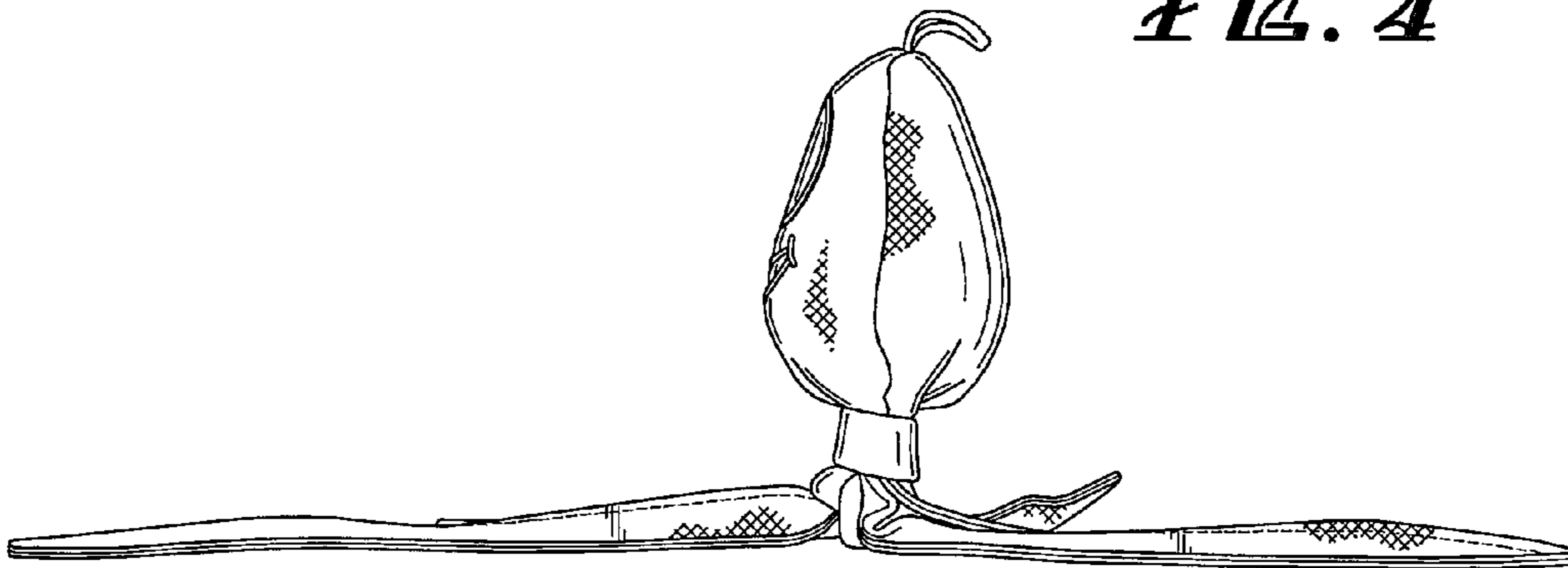

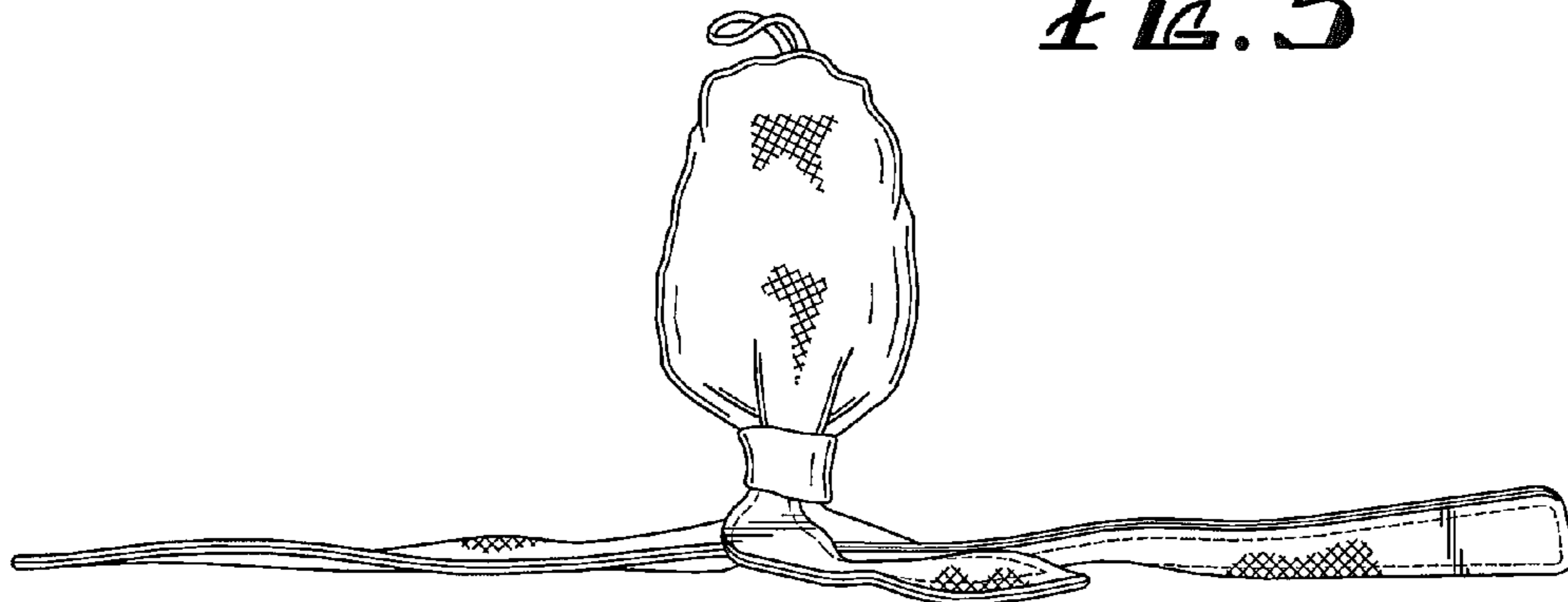
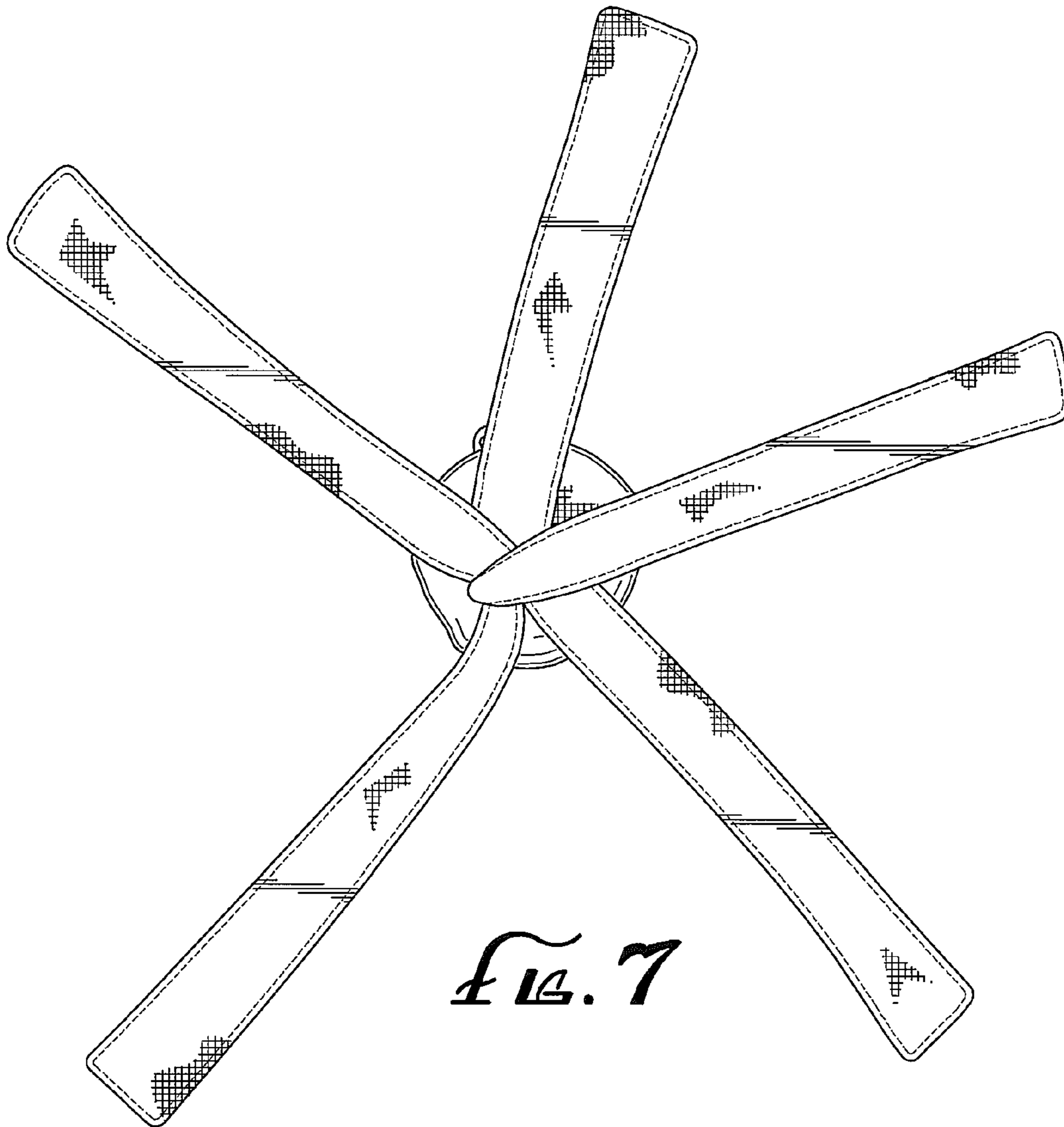

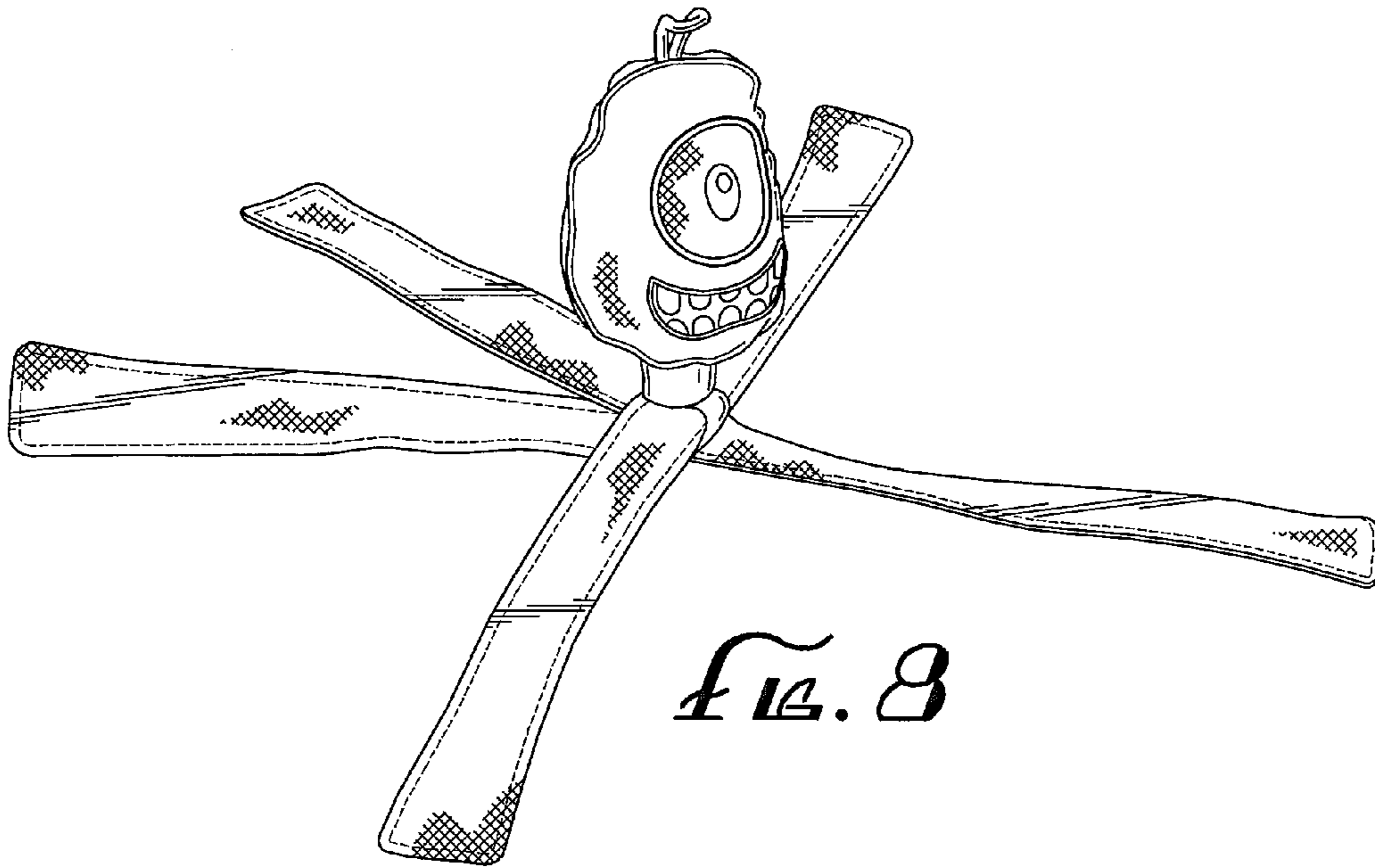

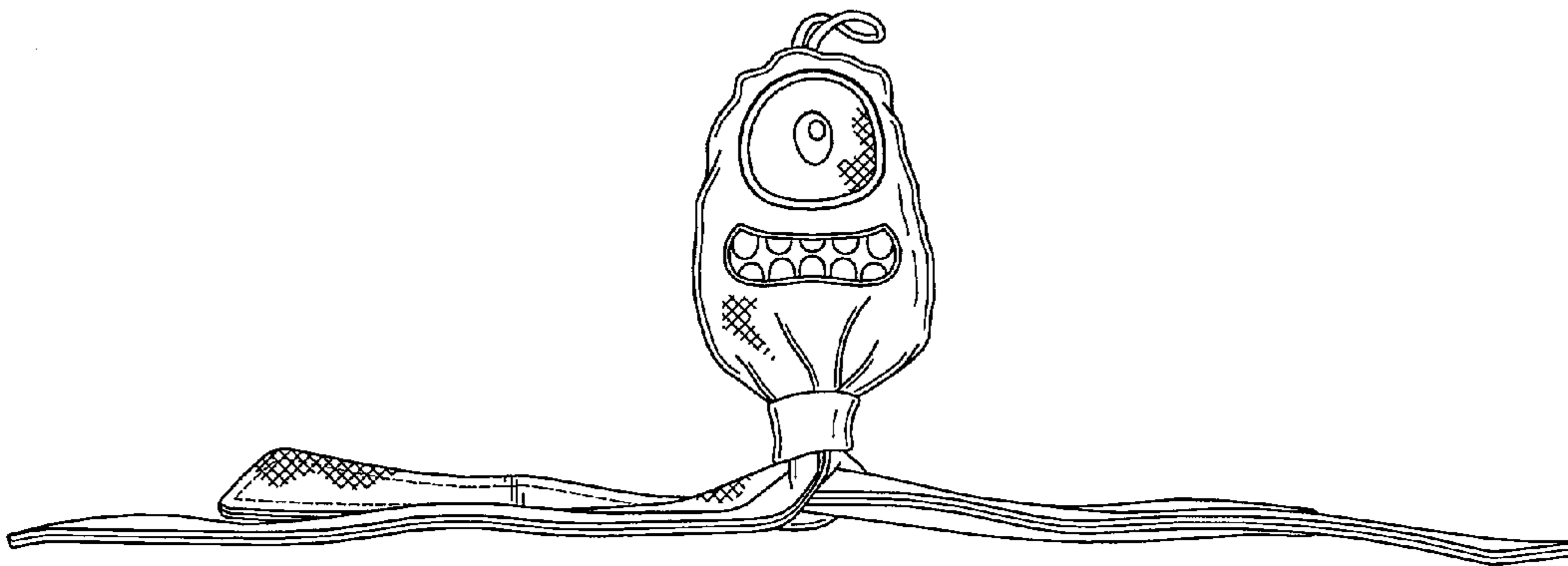
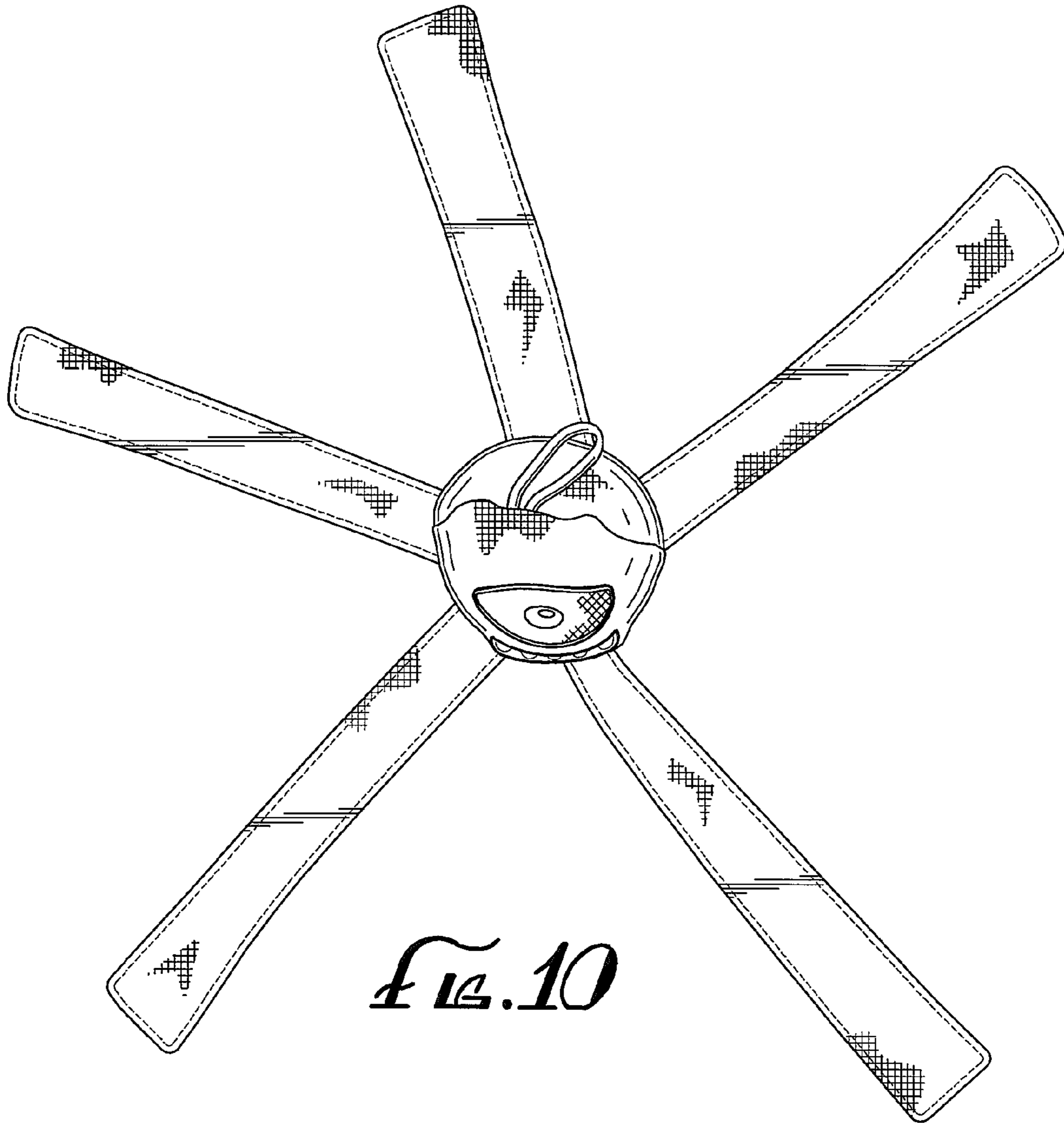

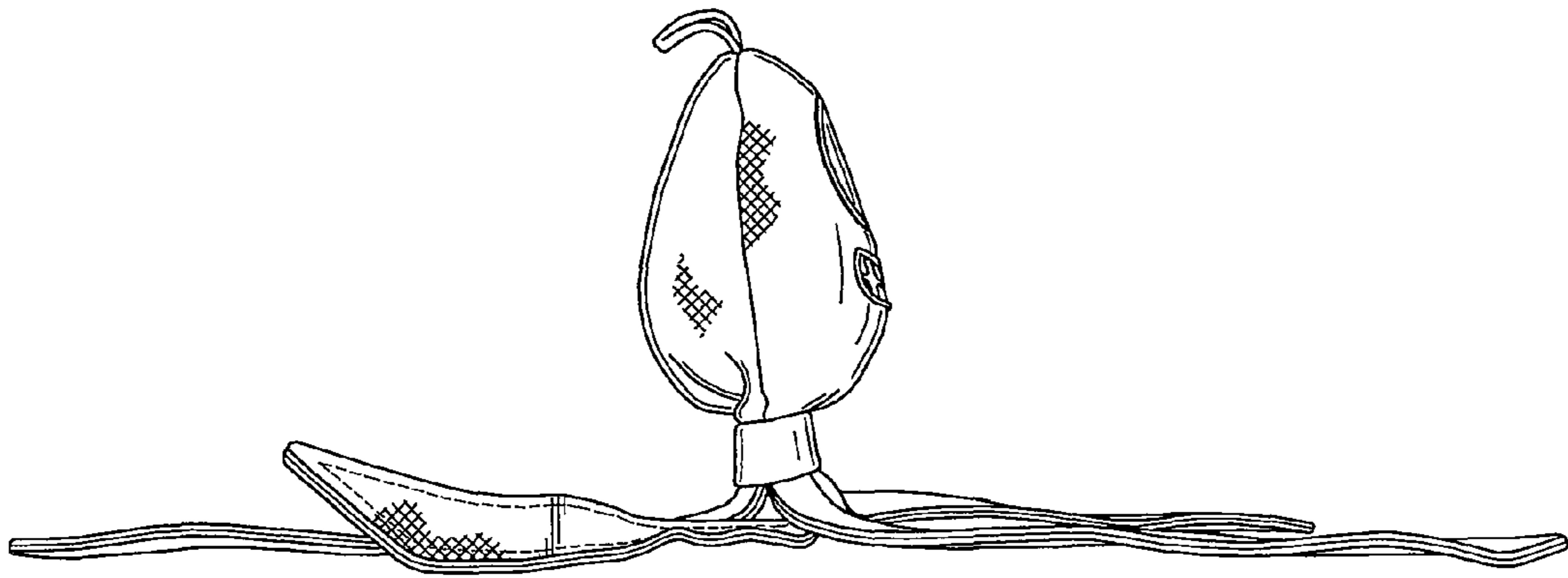

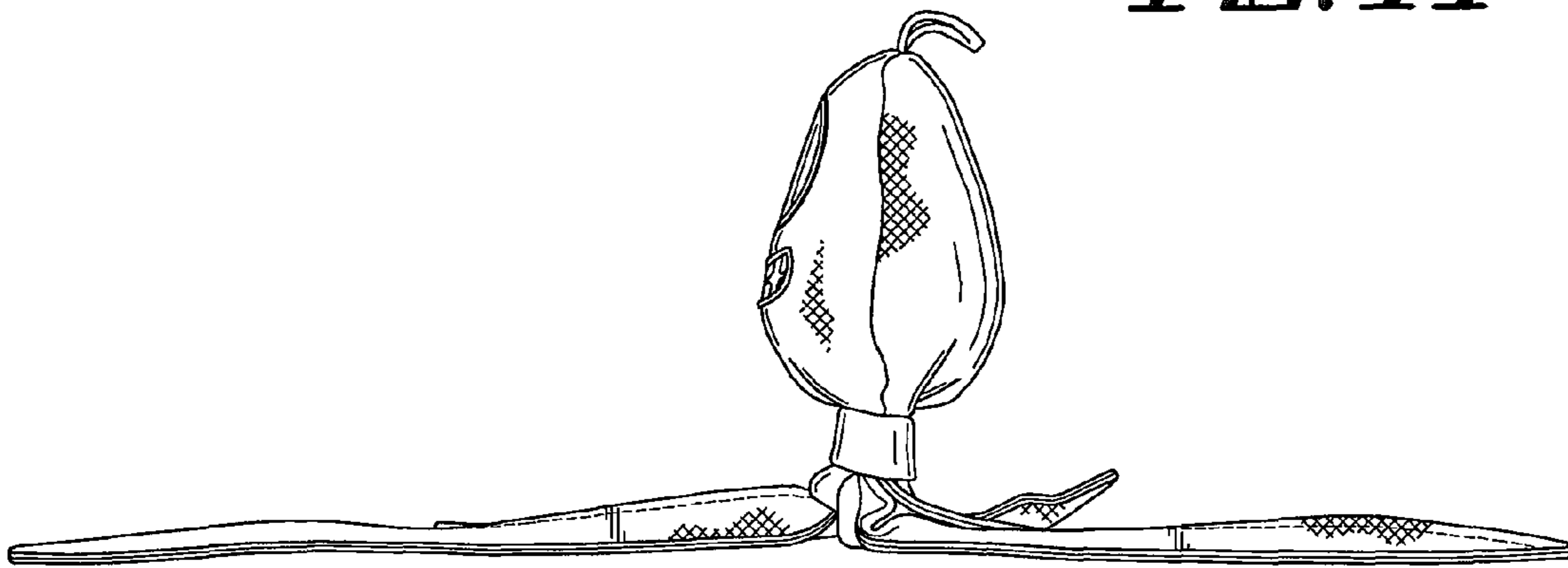
