(57) **CLAIM**

I claim the ornamental design for a T-shirt with a cooling pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a T-shirt with a cooling-pouch showing my design, invented to show the cooling pouch, where the surface shading represents the surface of the T-shirt.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a left side elevational view thereof.

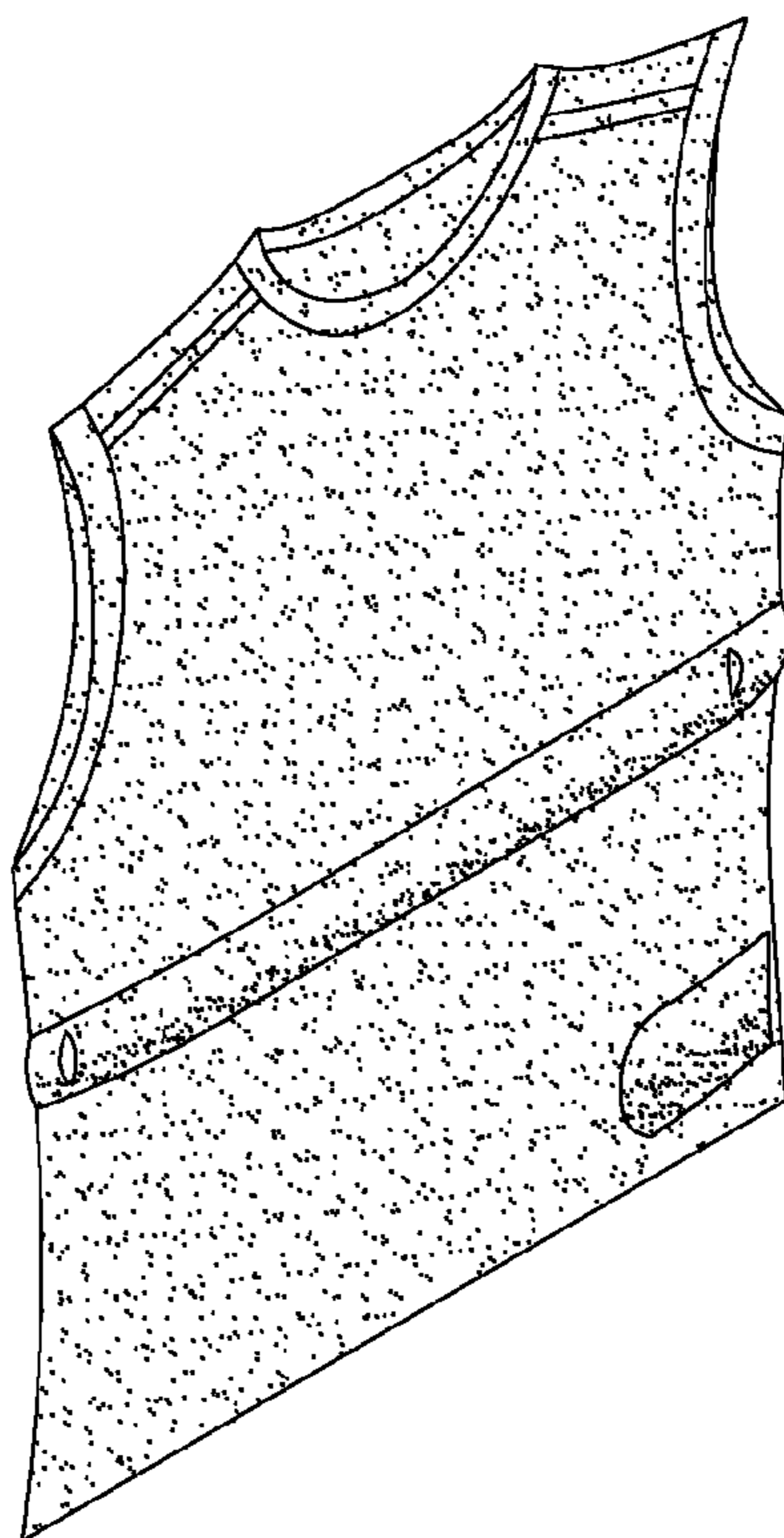
FIG. 5 is a rear elevational view thereof.

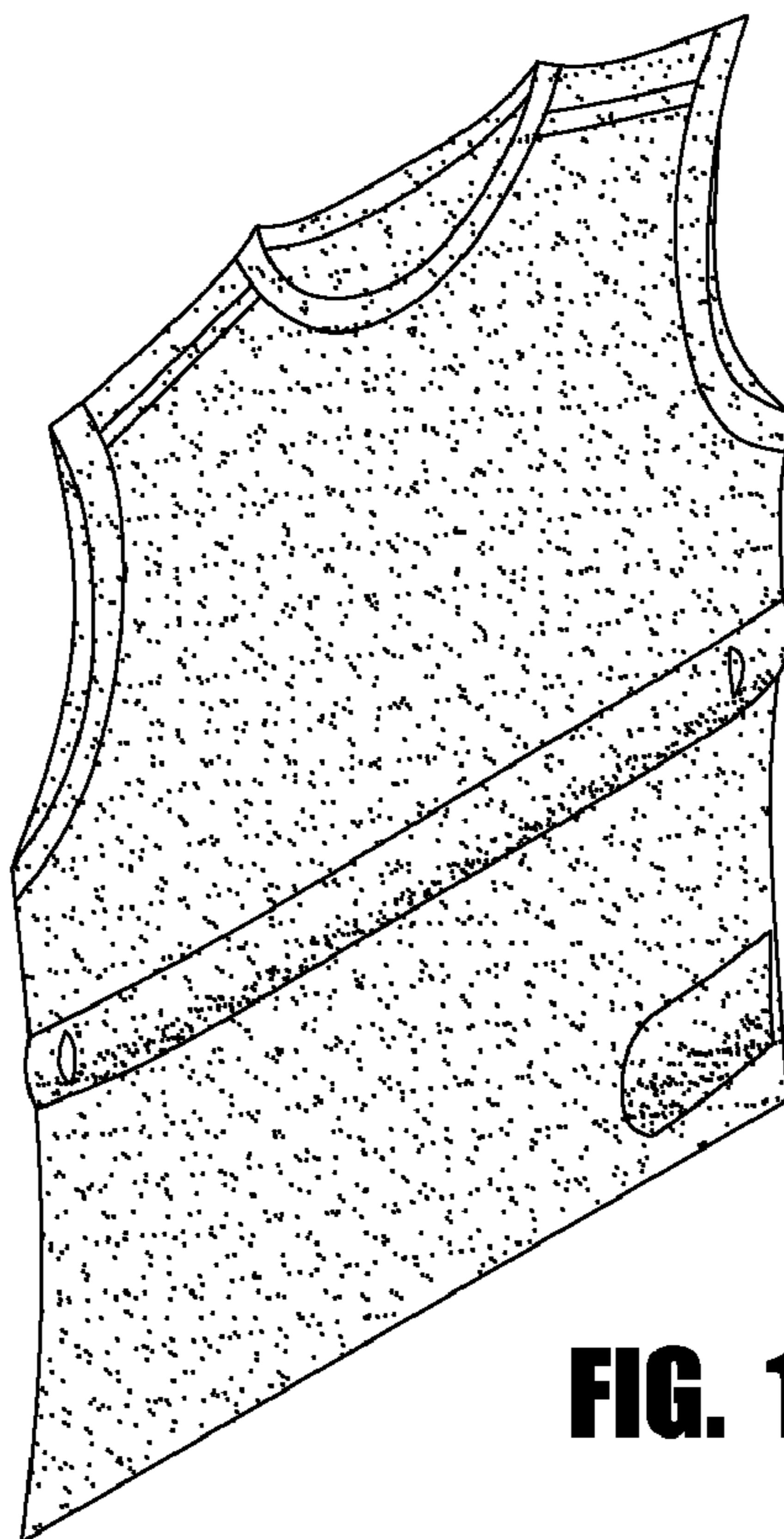

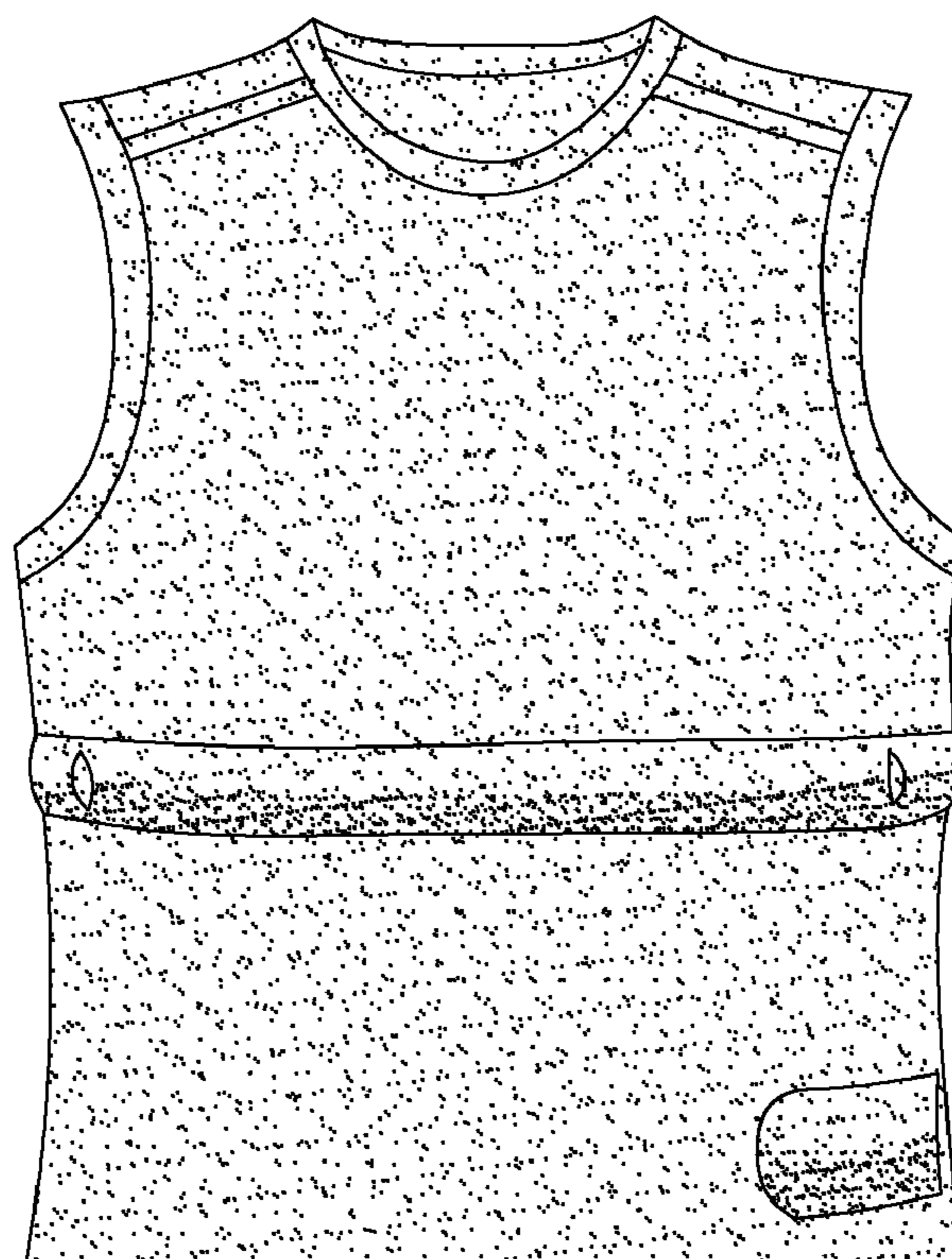

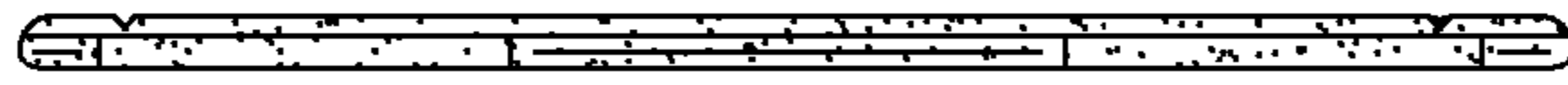

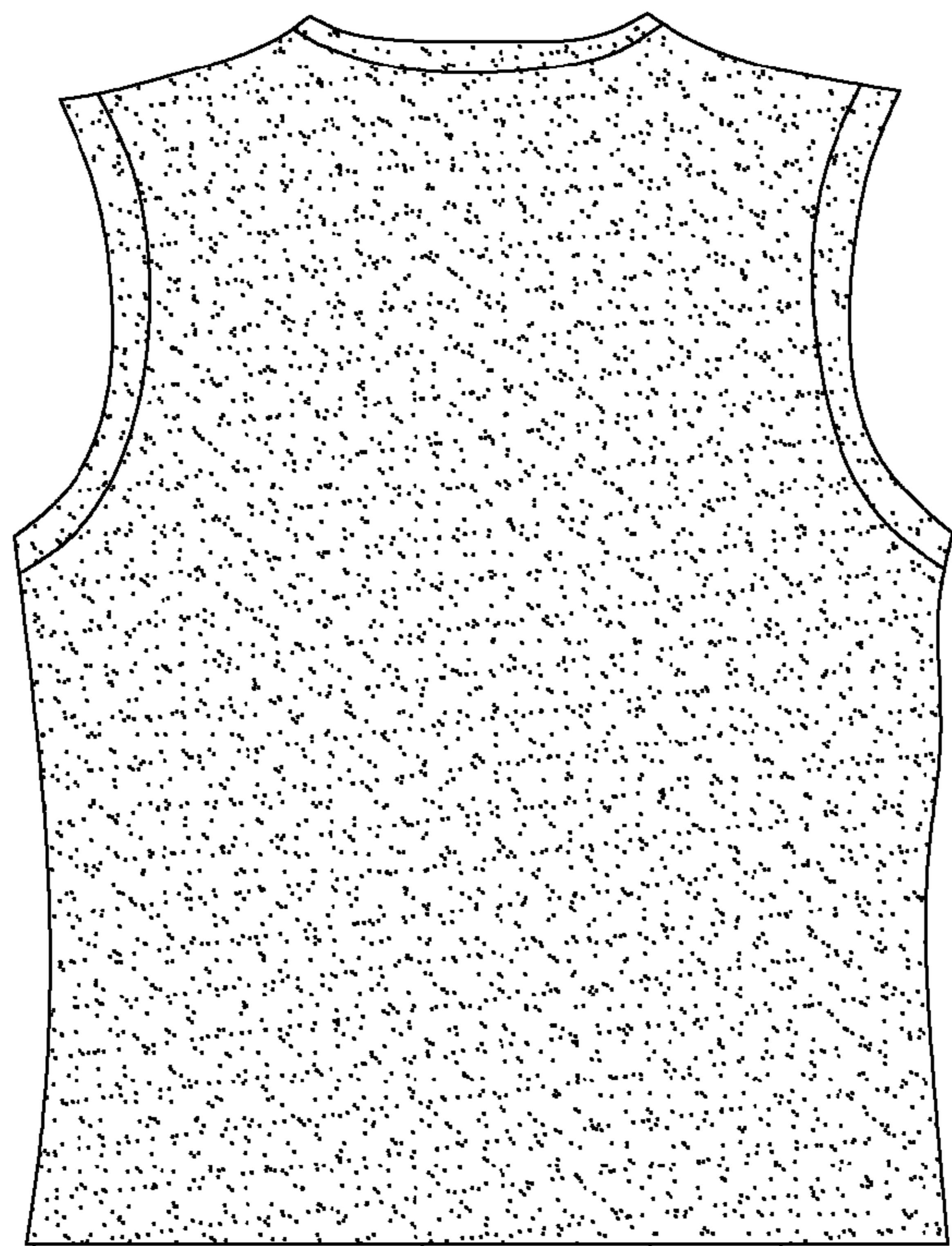

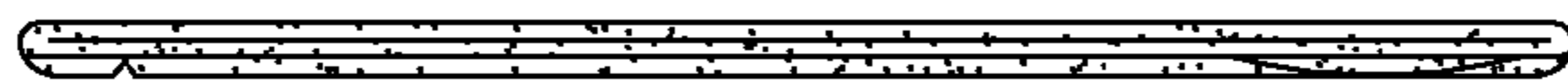
