DESCRIPTION

FIG. 1 is a top perspective view of a beverage container showing my new design;

FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;

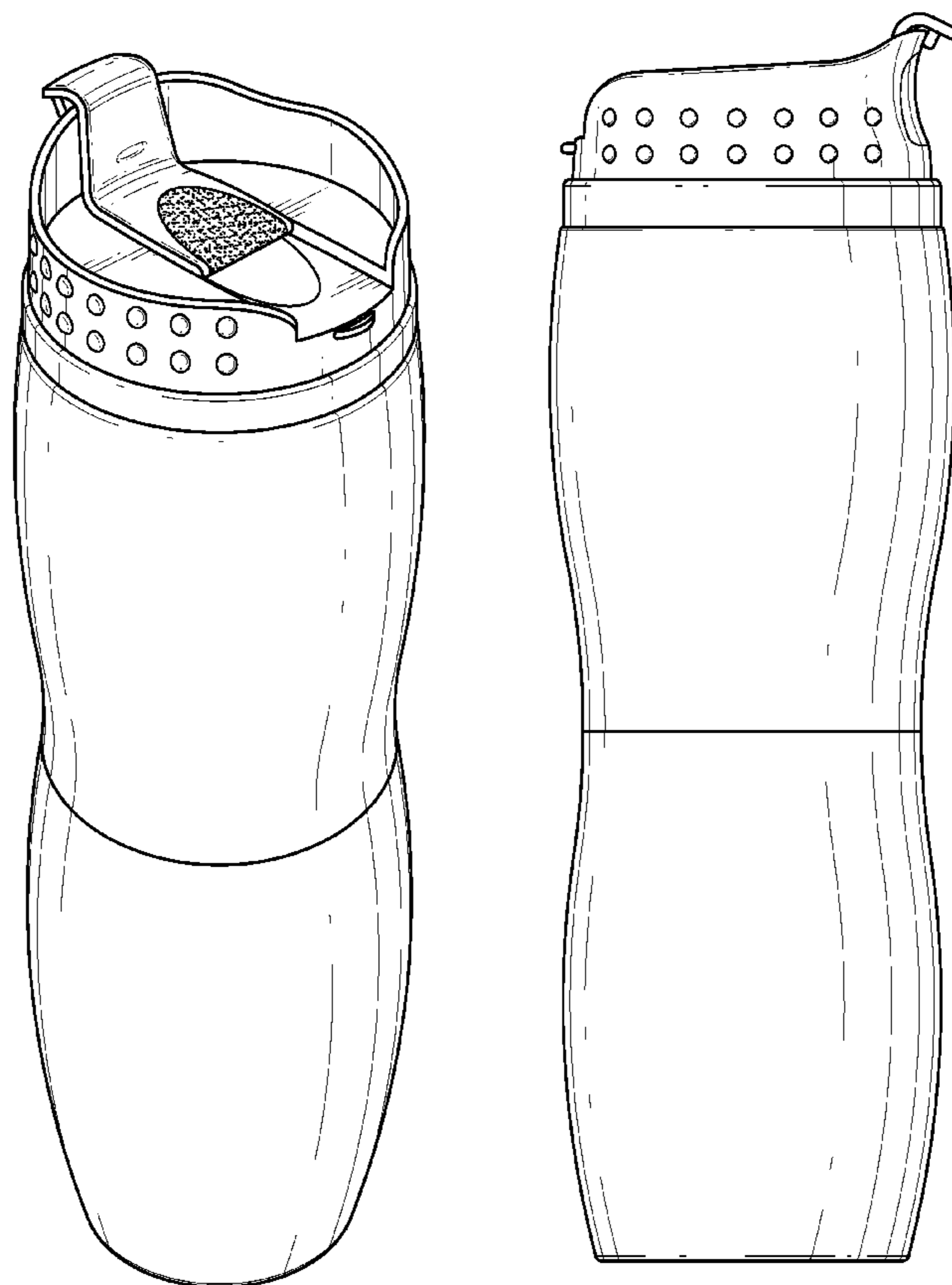
FIG. 3 is a side view of the beverage container of FIG. 1;

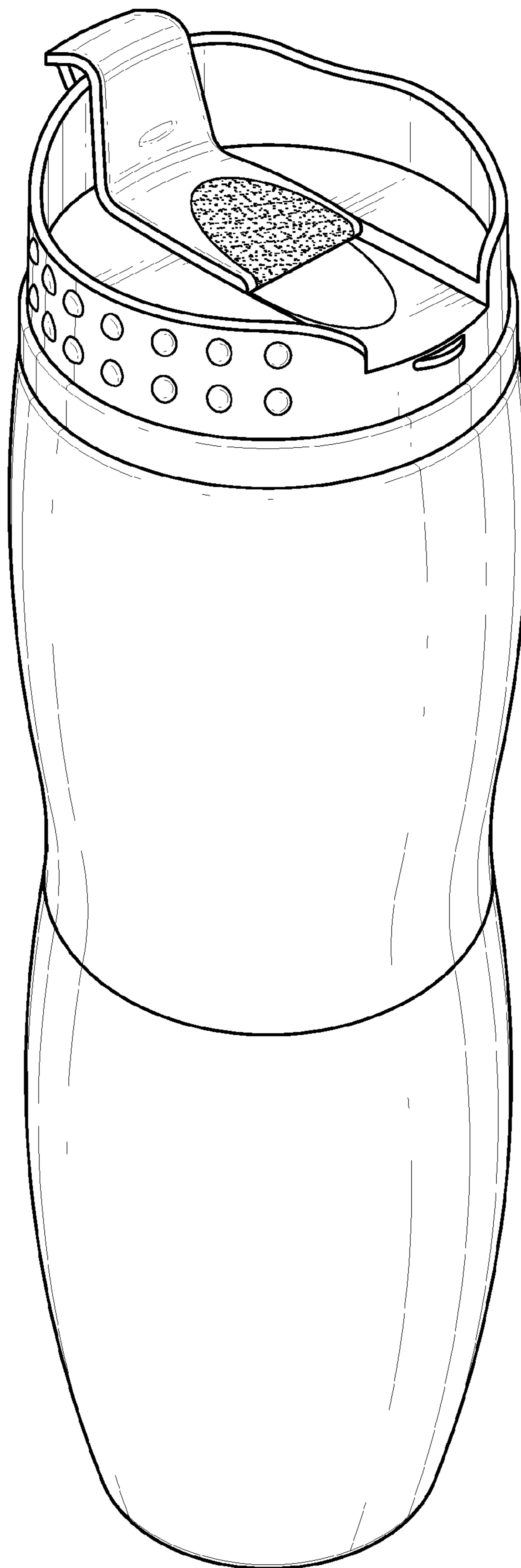

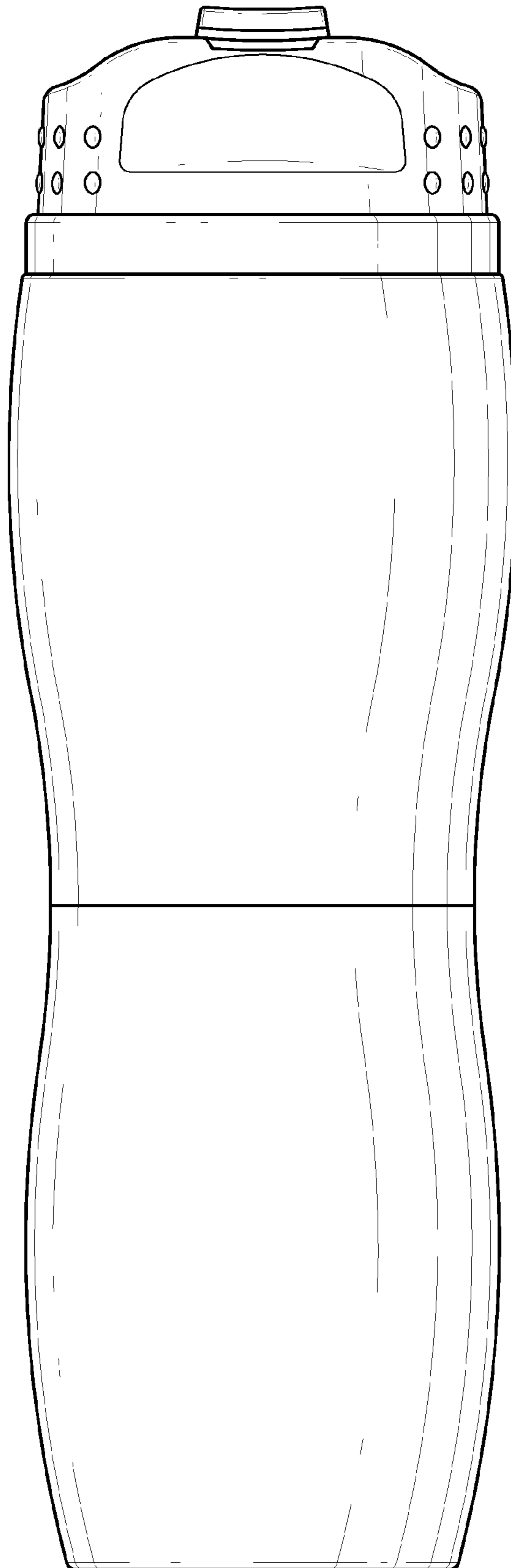

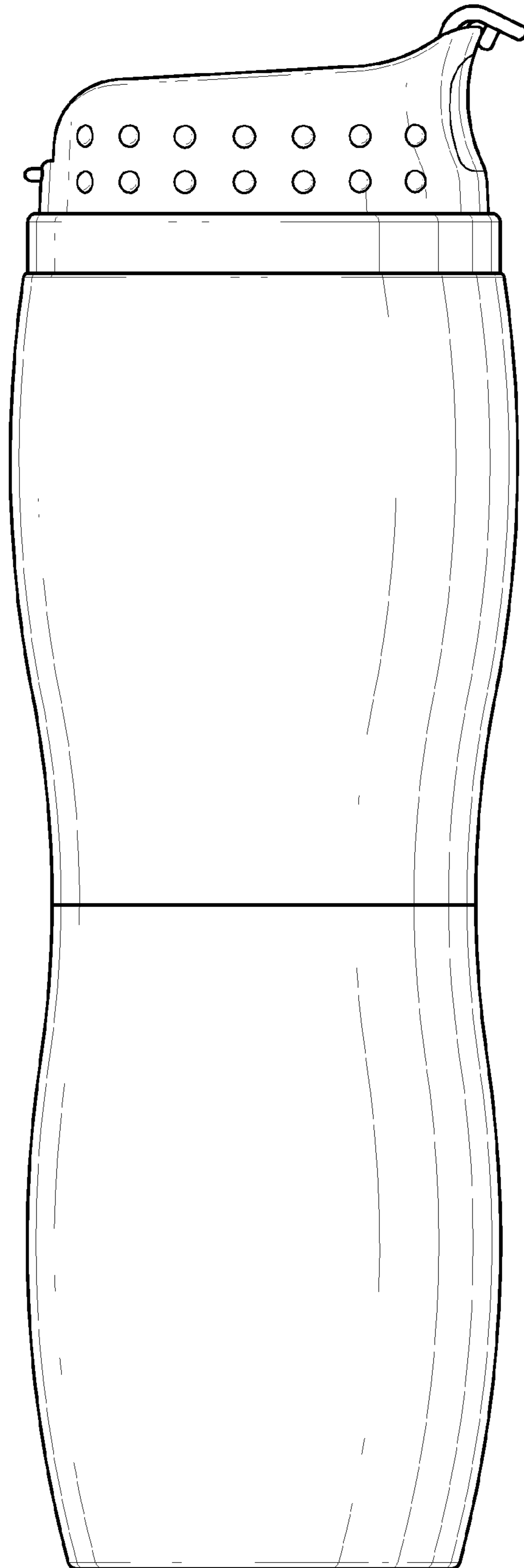

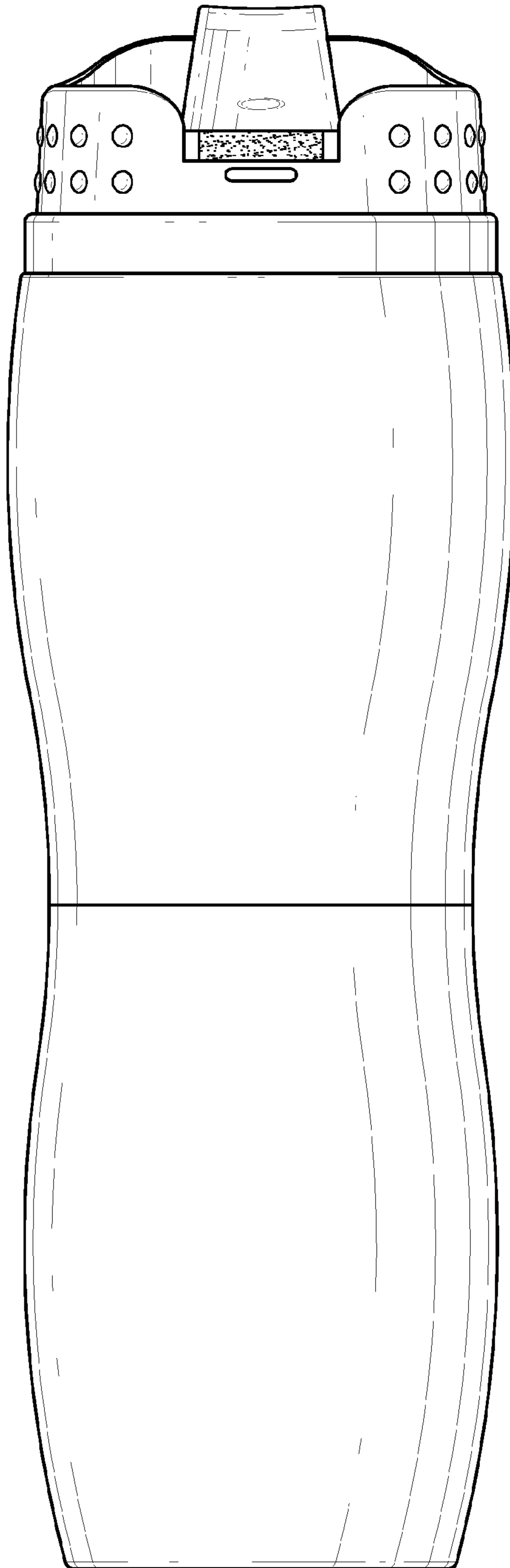

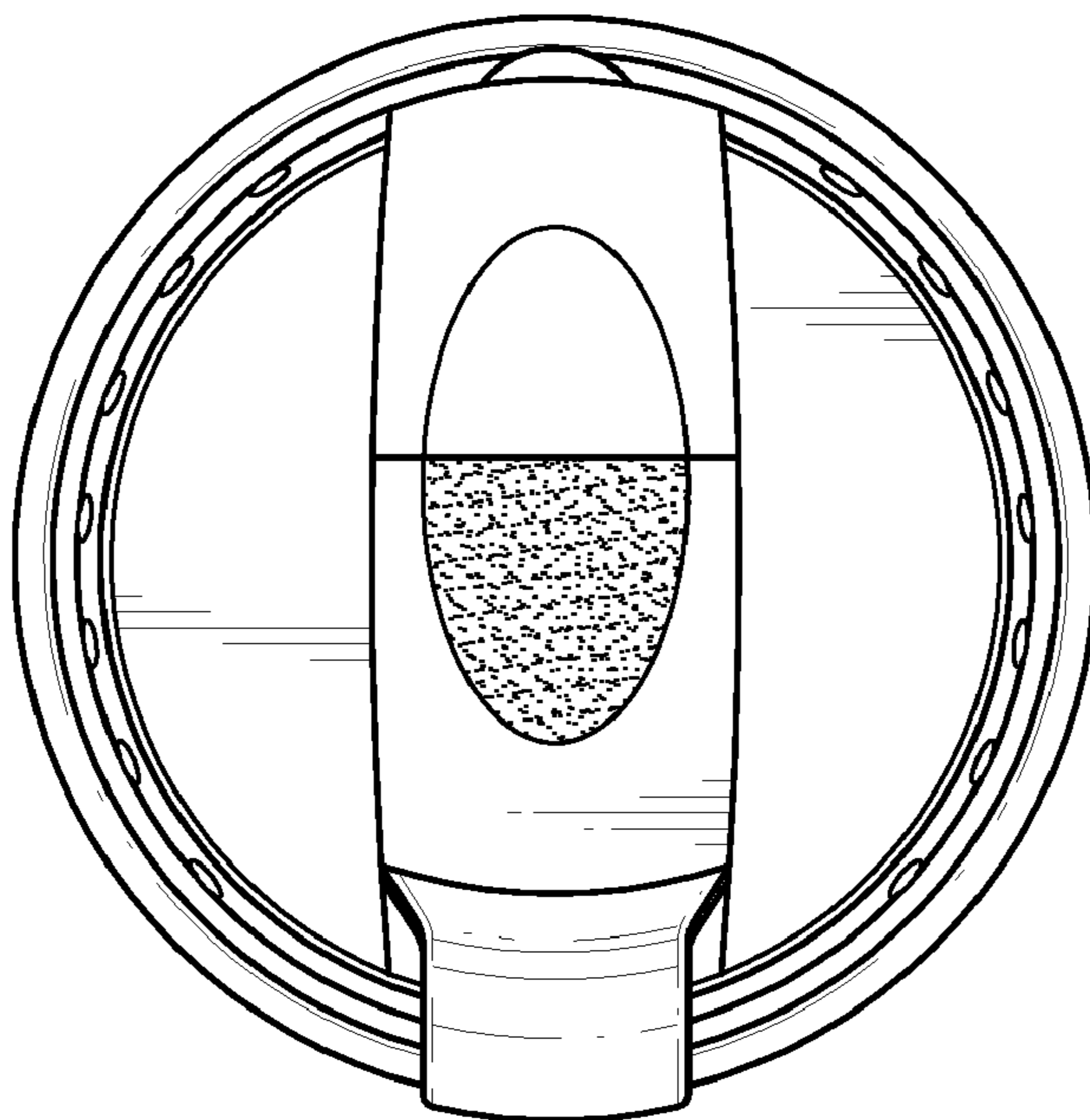

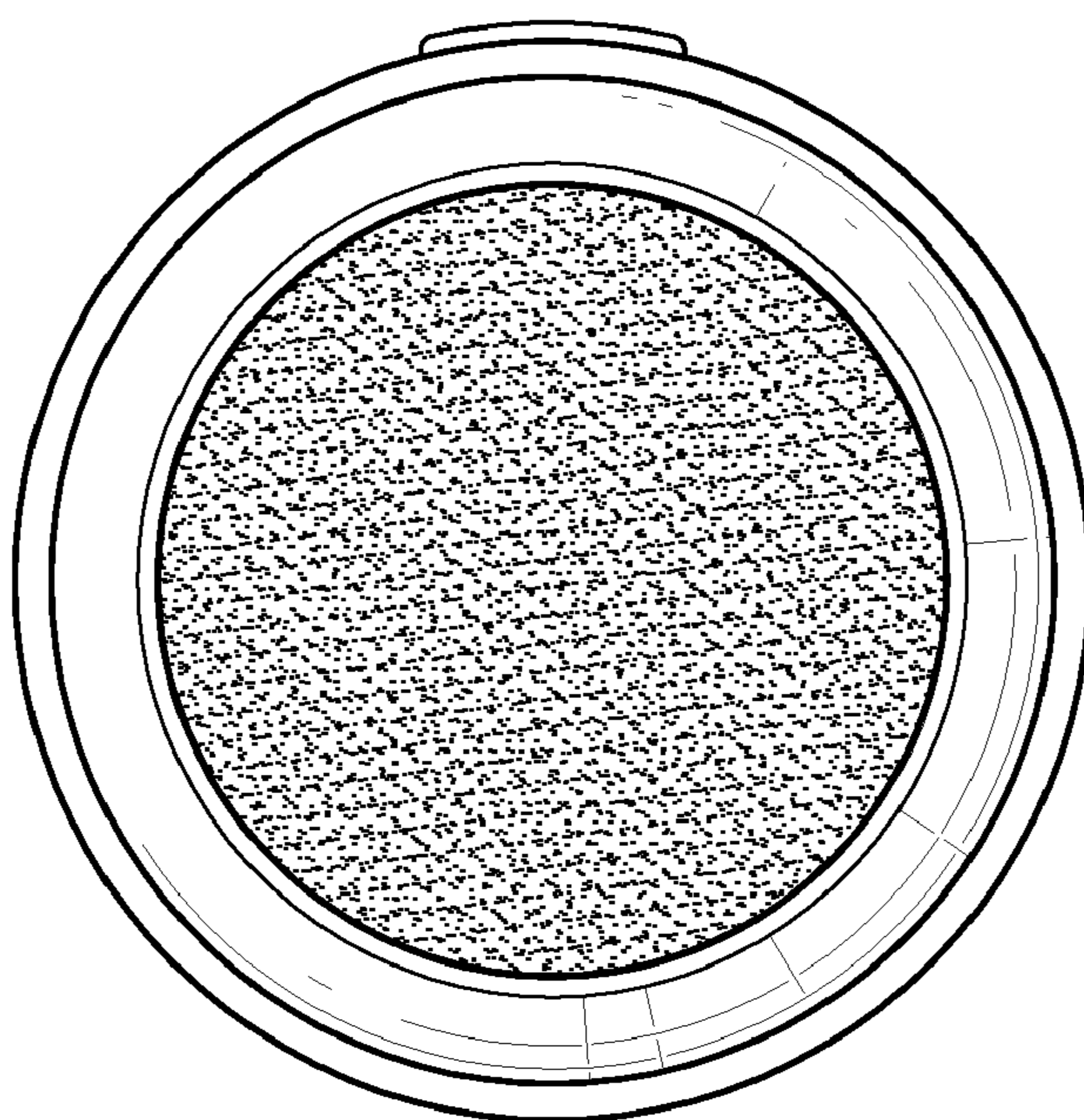
