FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;

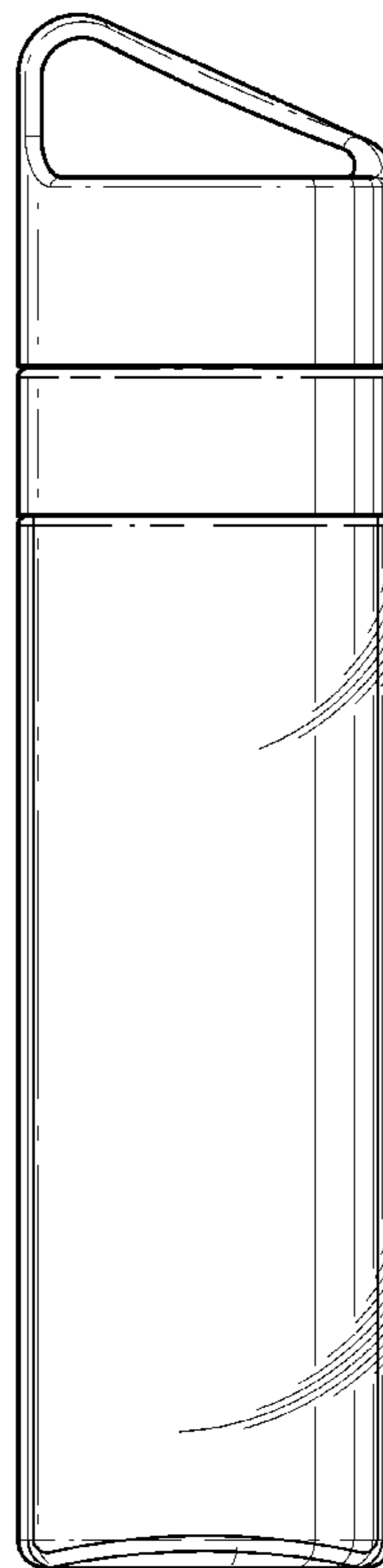
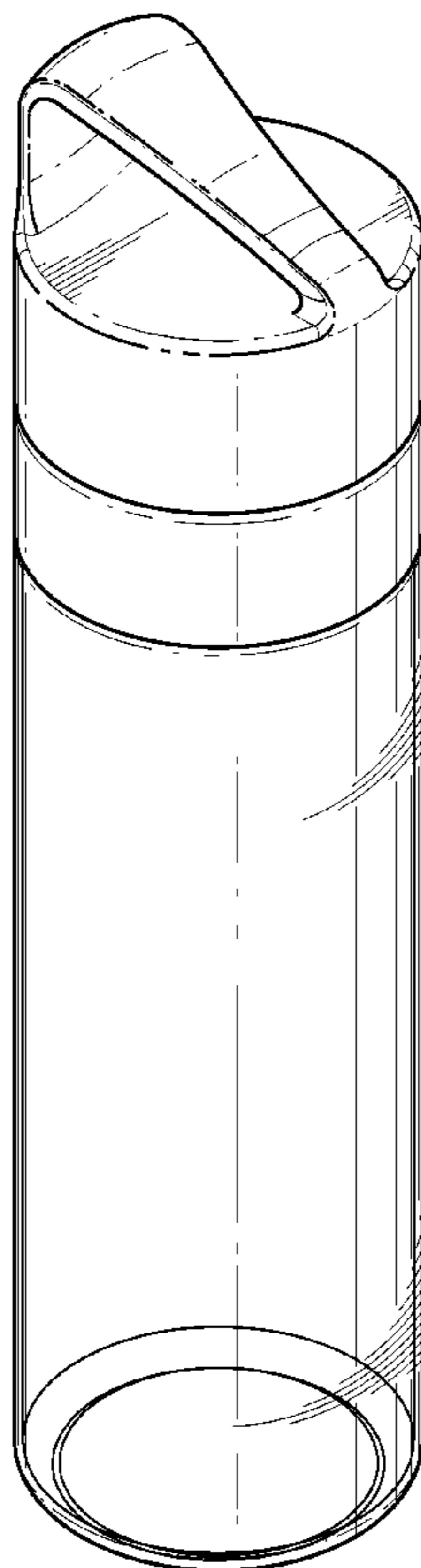
FIG. 3 is a front view of the beverage container of FIG. 1;

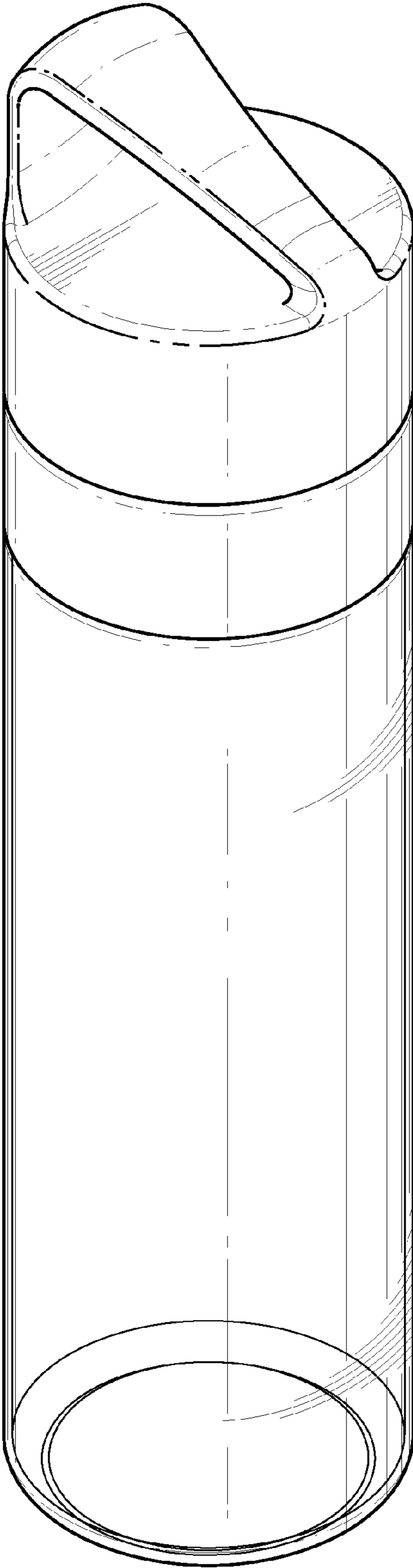
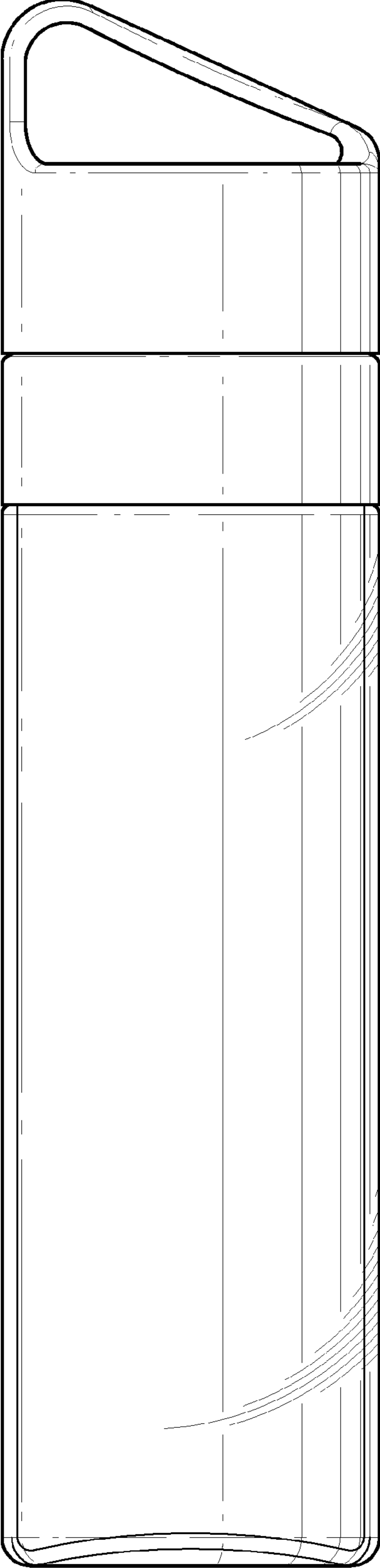

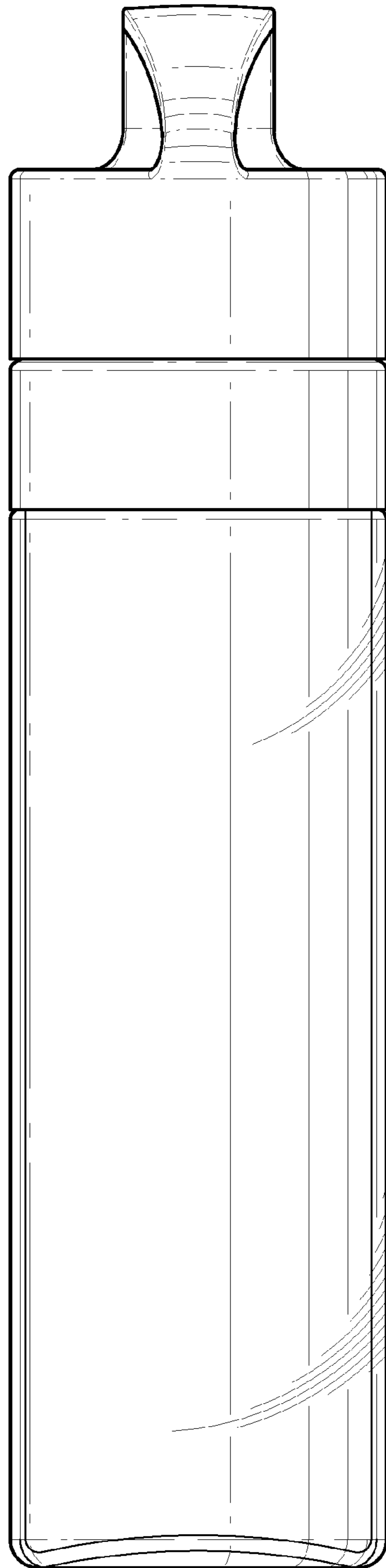

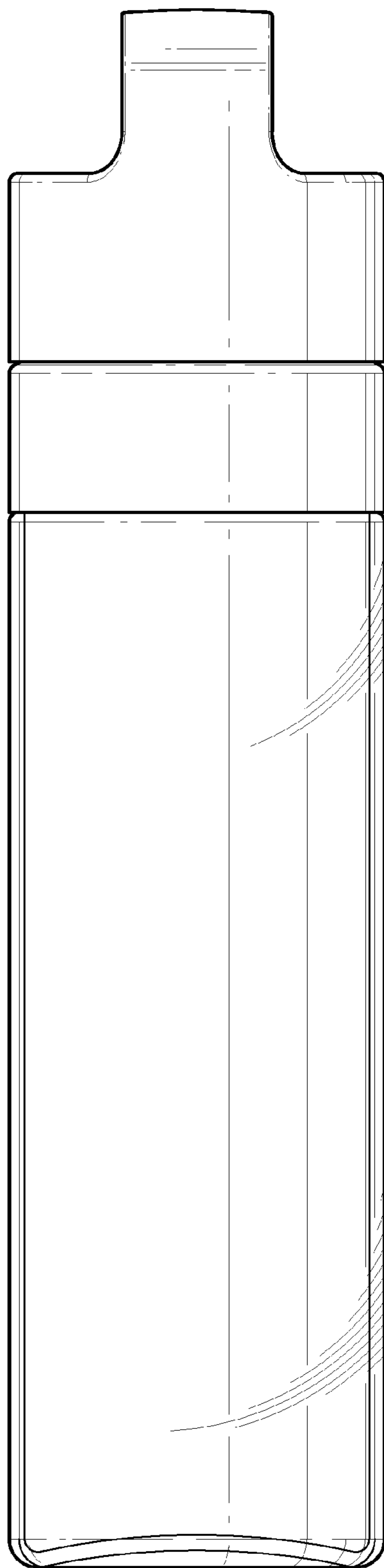

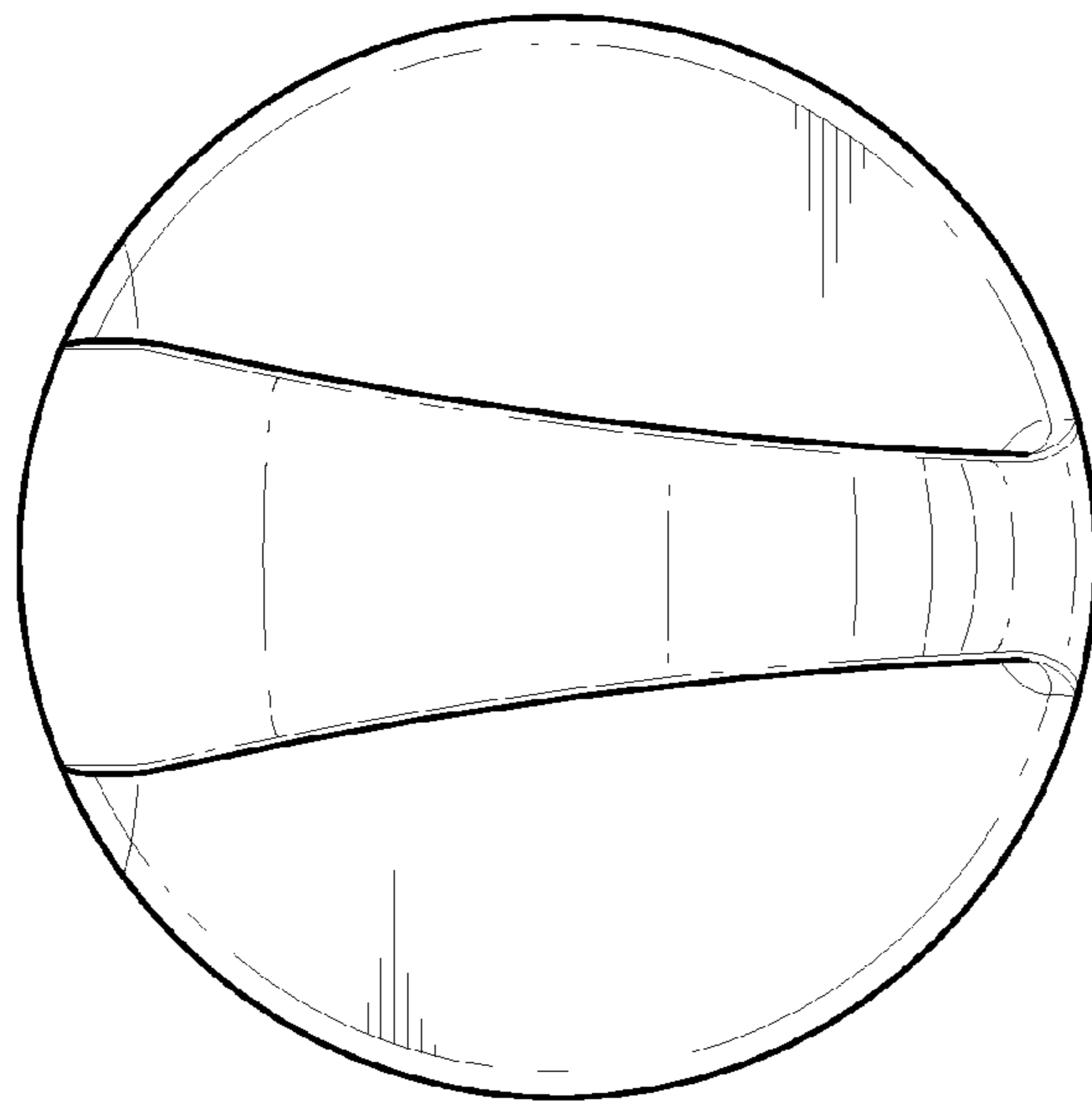

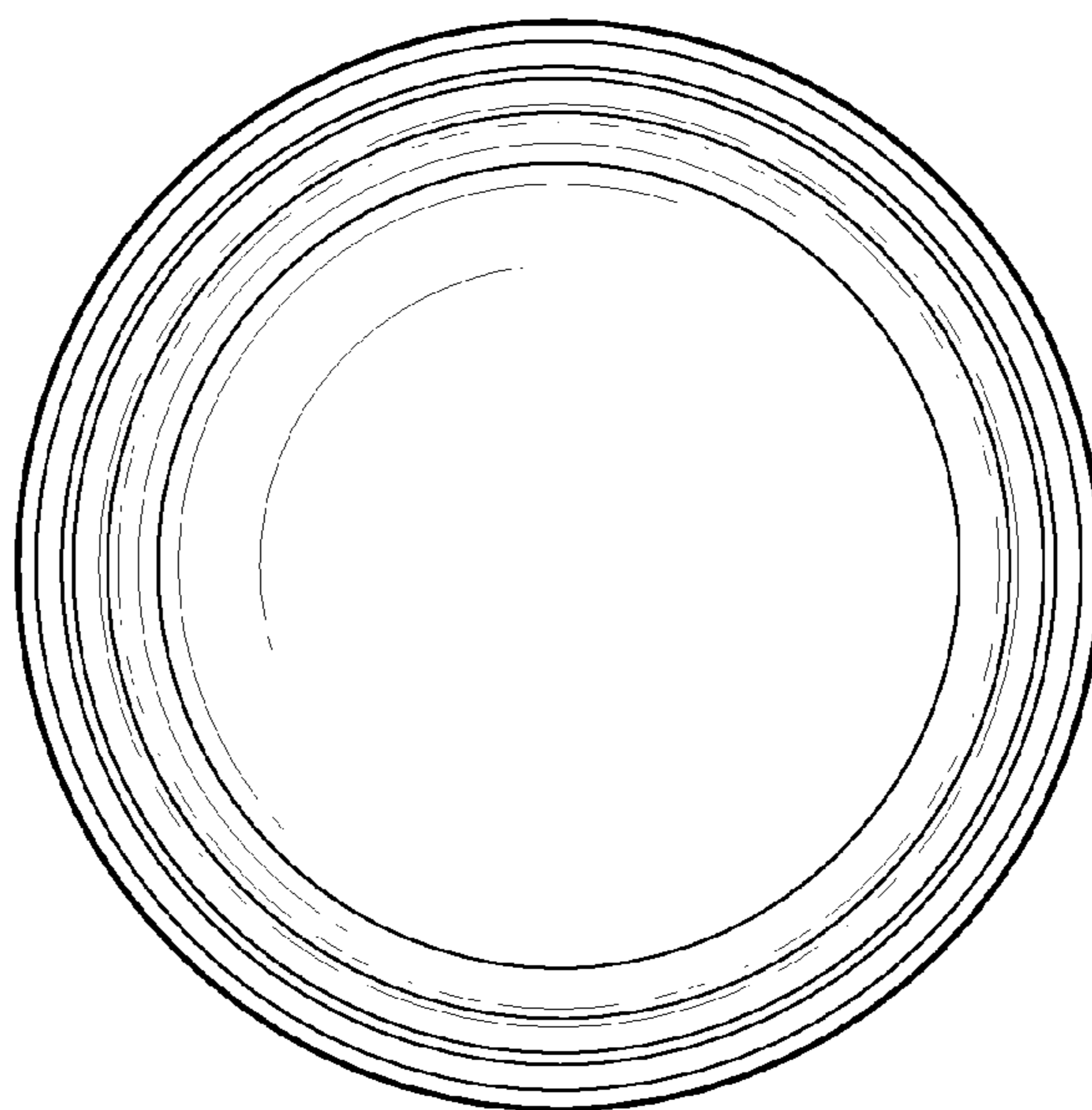
