(57) **CLAIM**

The ornamental design for a shoulder lunch tote, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of the present invention, the rear side being a mirror image thereof, shown in a 'filled use' form.

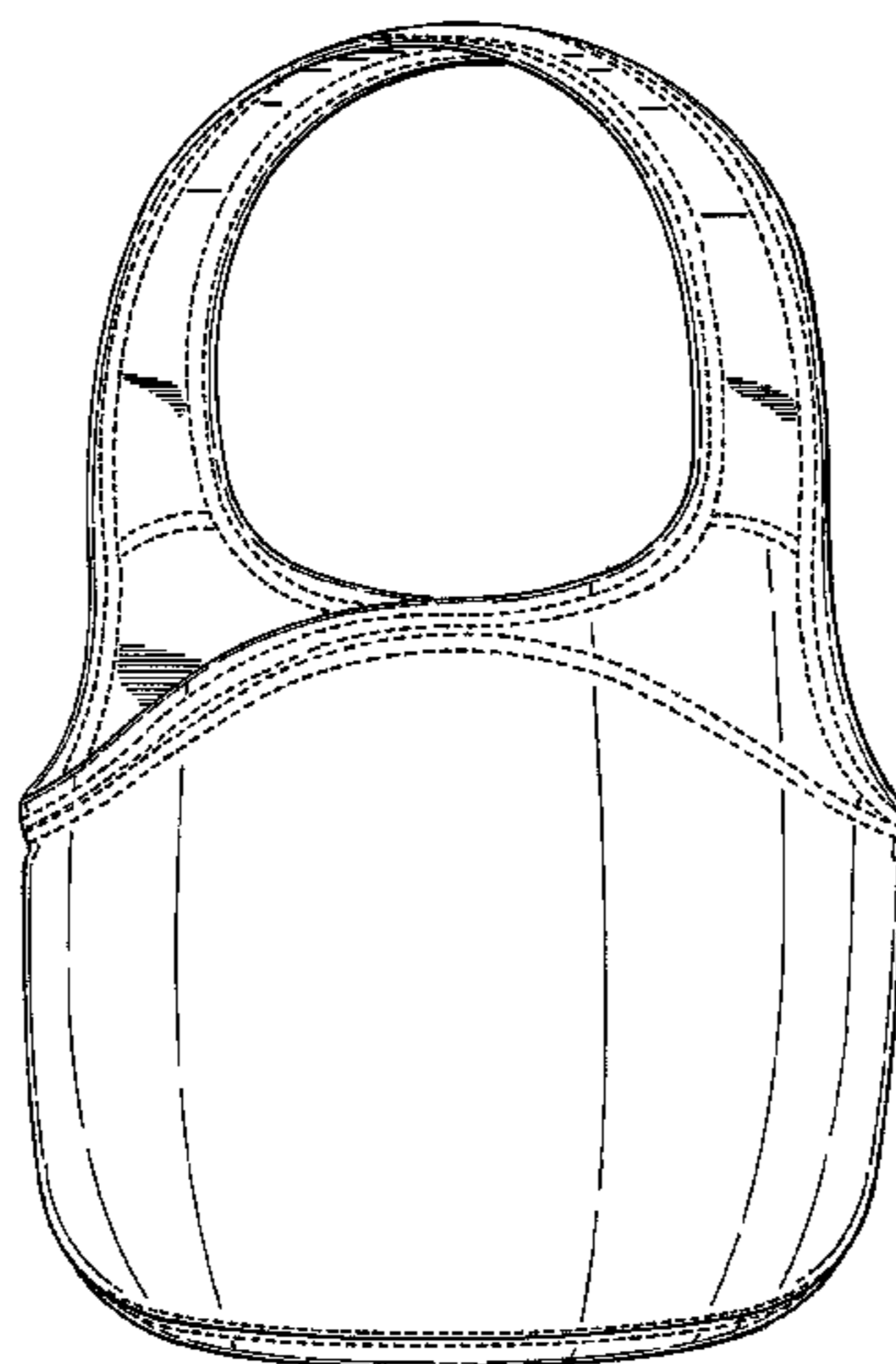
FIG. 2 is a left side elevation view of FIG. 1, the right side being a mirror image thereof.

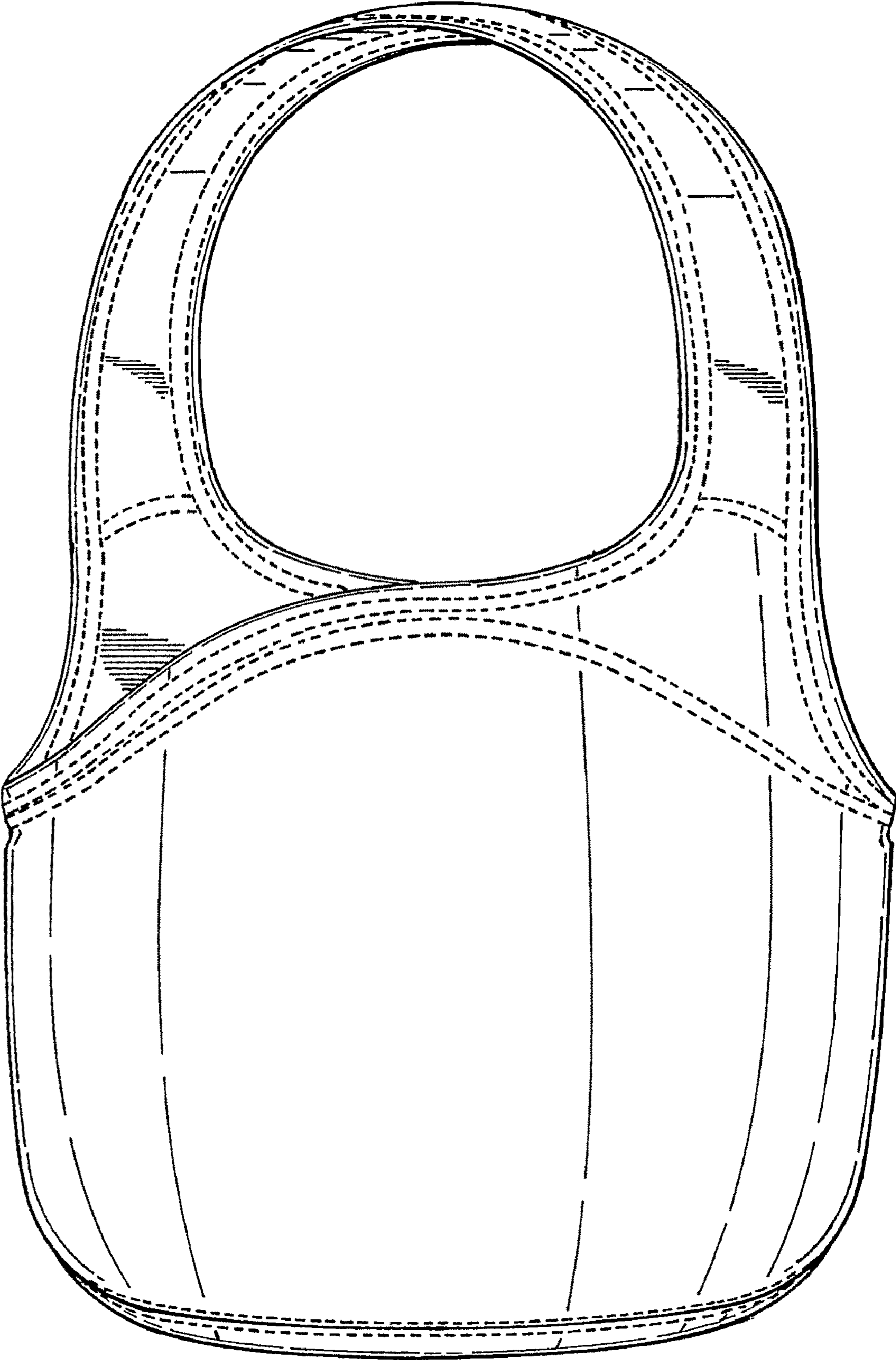

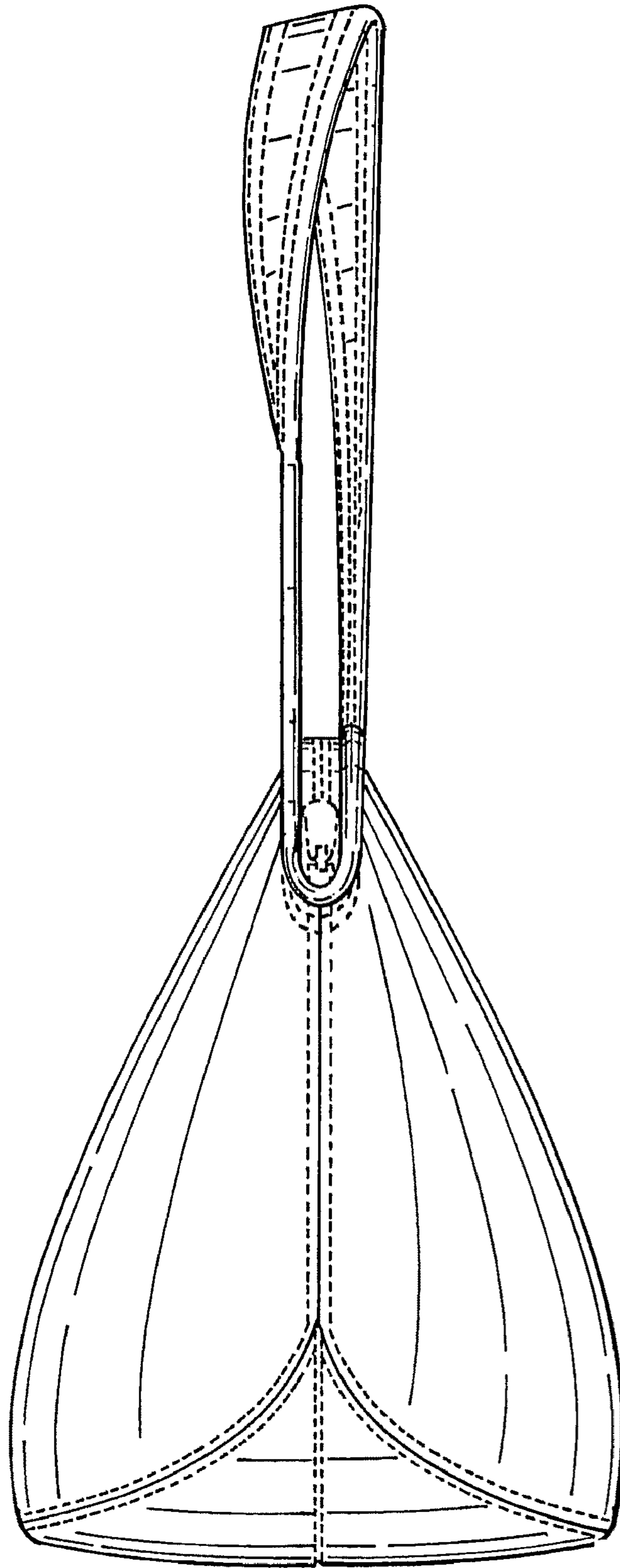

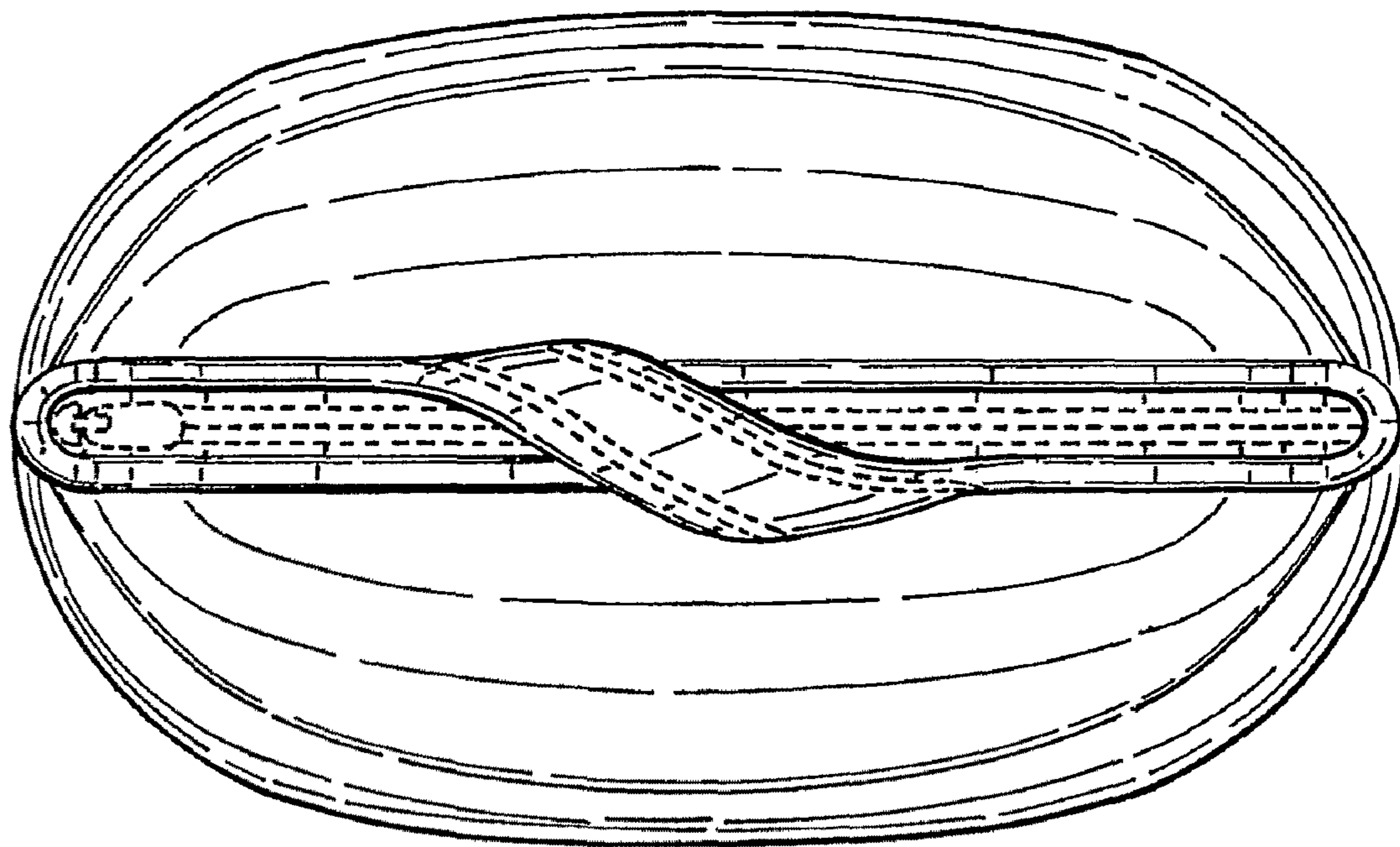

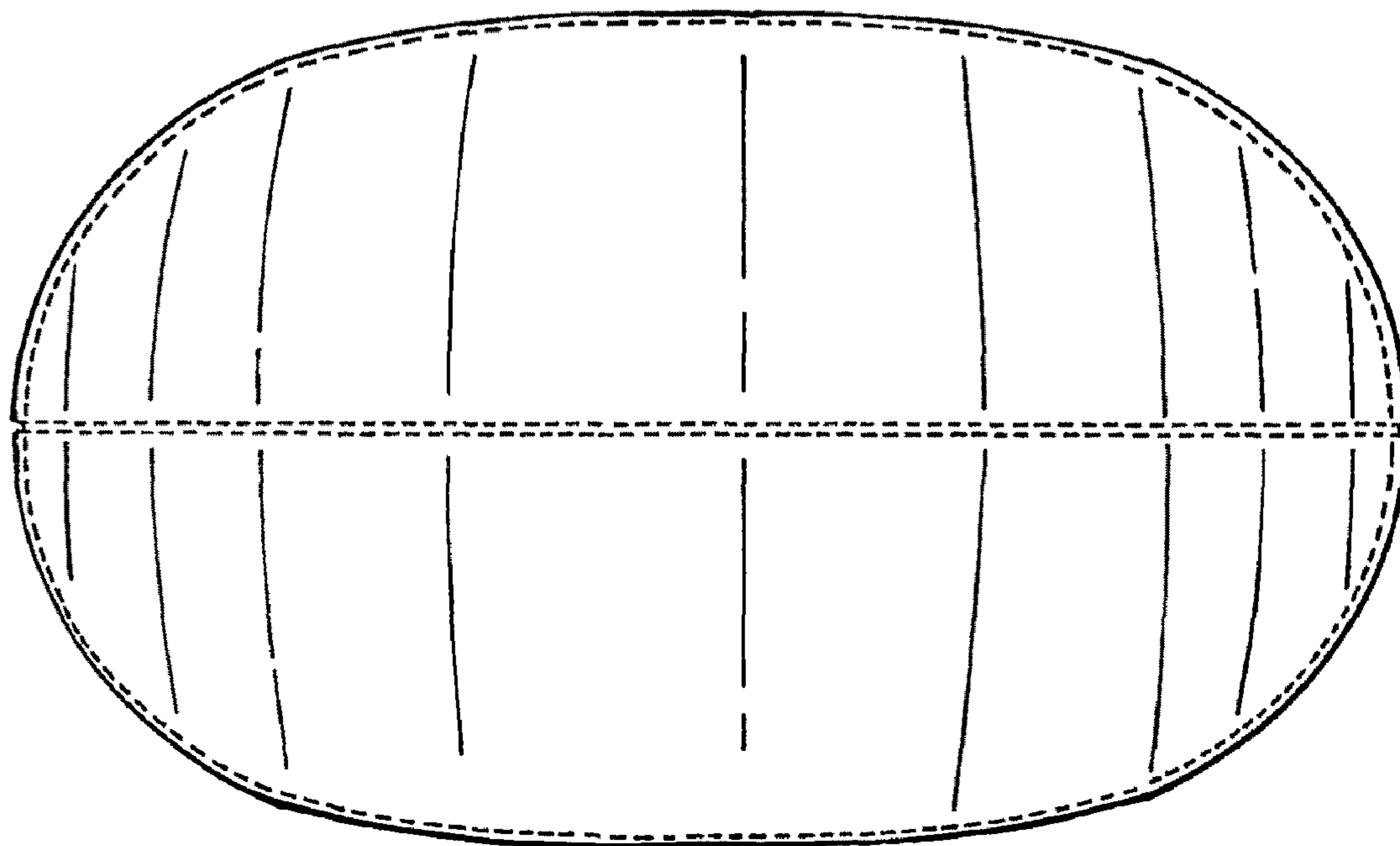
