The ornamental design for a beam support bracket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front/top side perspective view of the beam support bracket according to my design;

FIG. 2 is a left side view with the top side oriented up thereof;

FIG. 3 is a front view with the top side oriented down thereof;

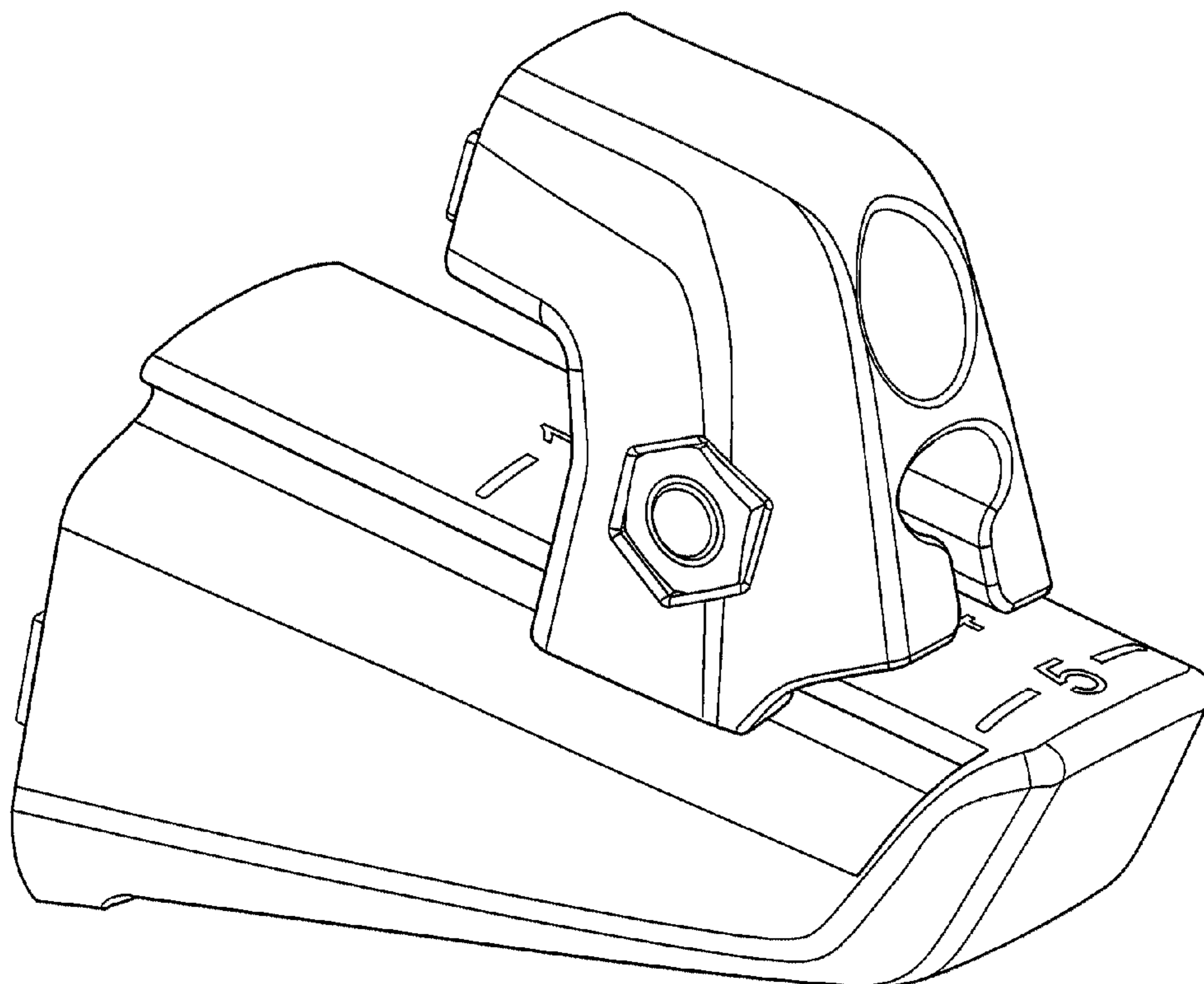
FIG. 4 is a right side view with the top side oriented to the right thereof;

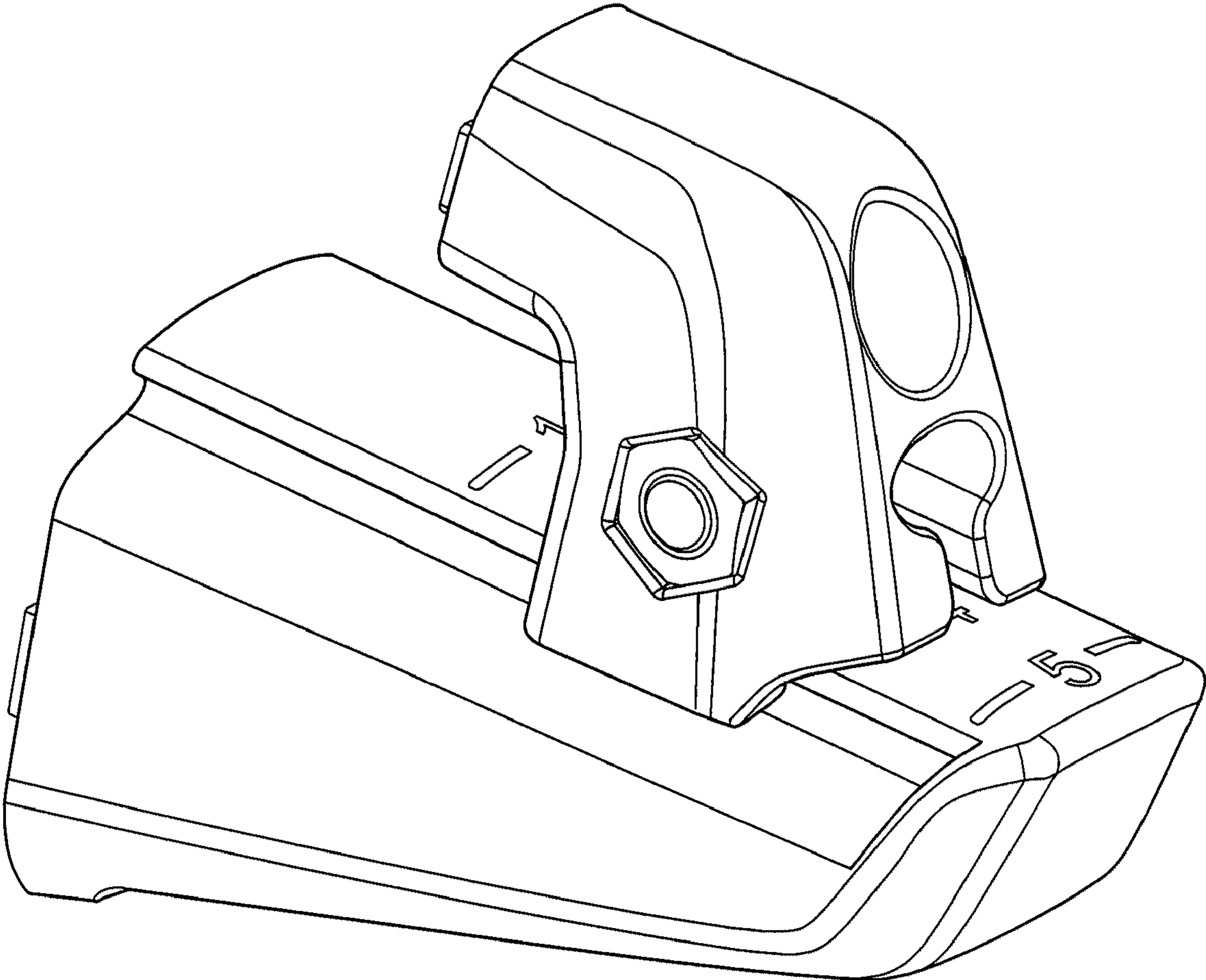

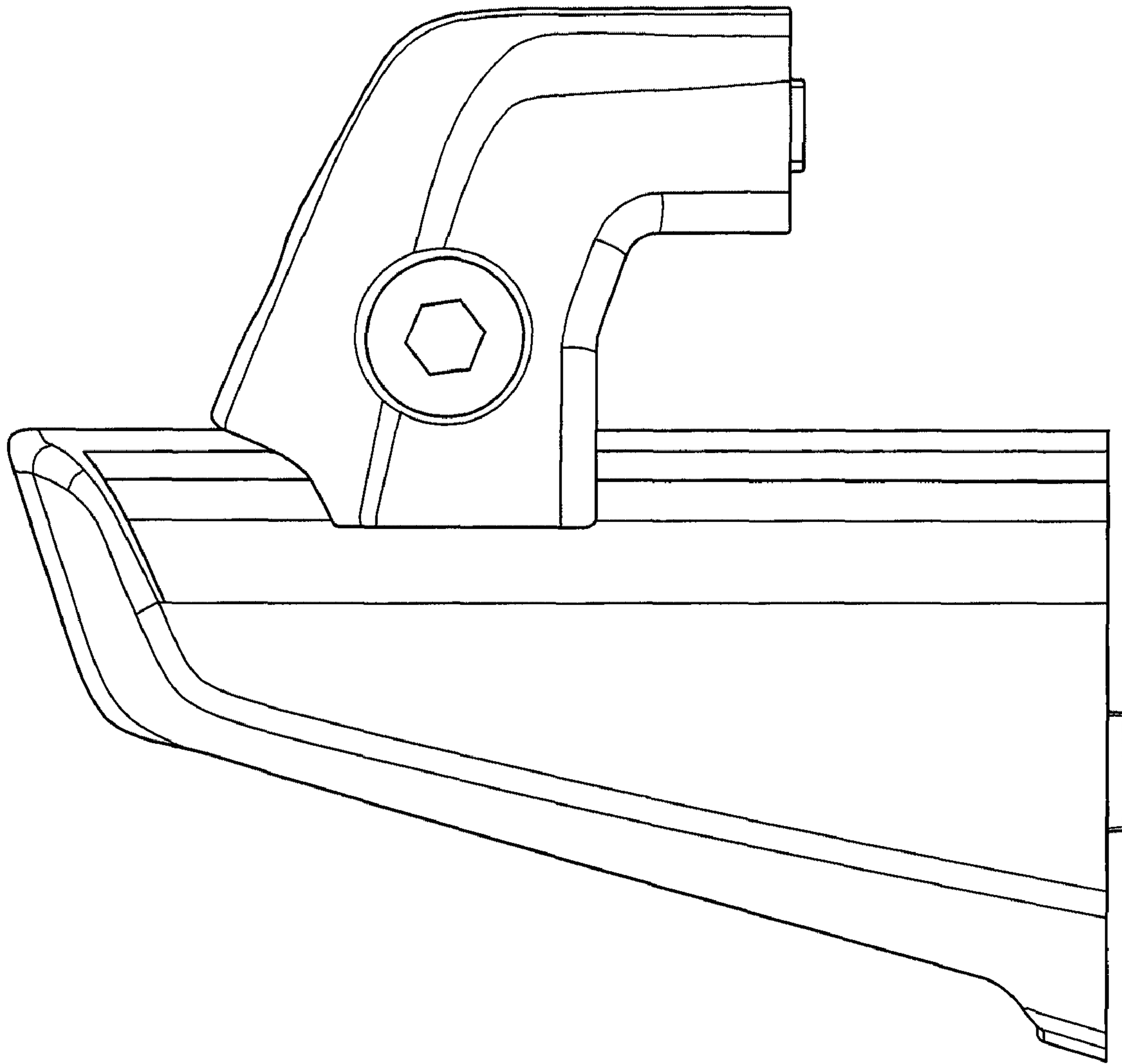

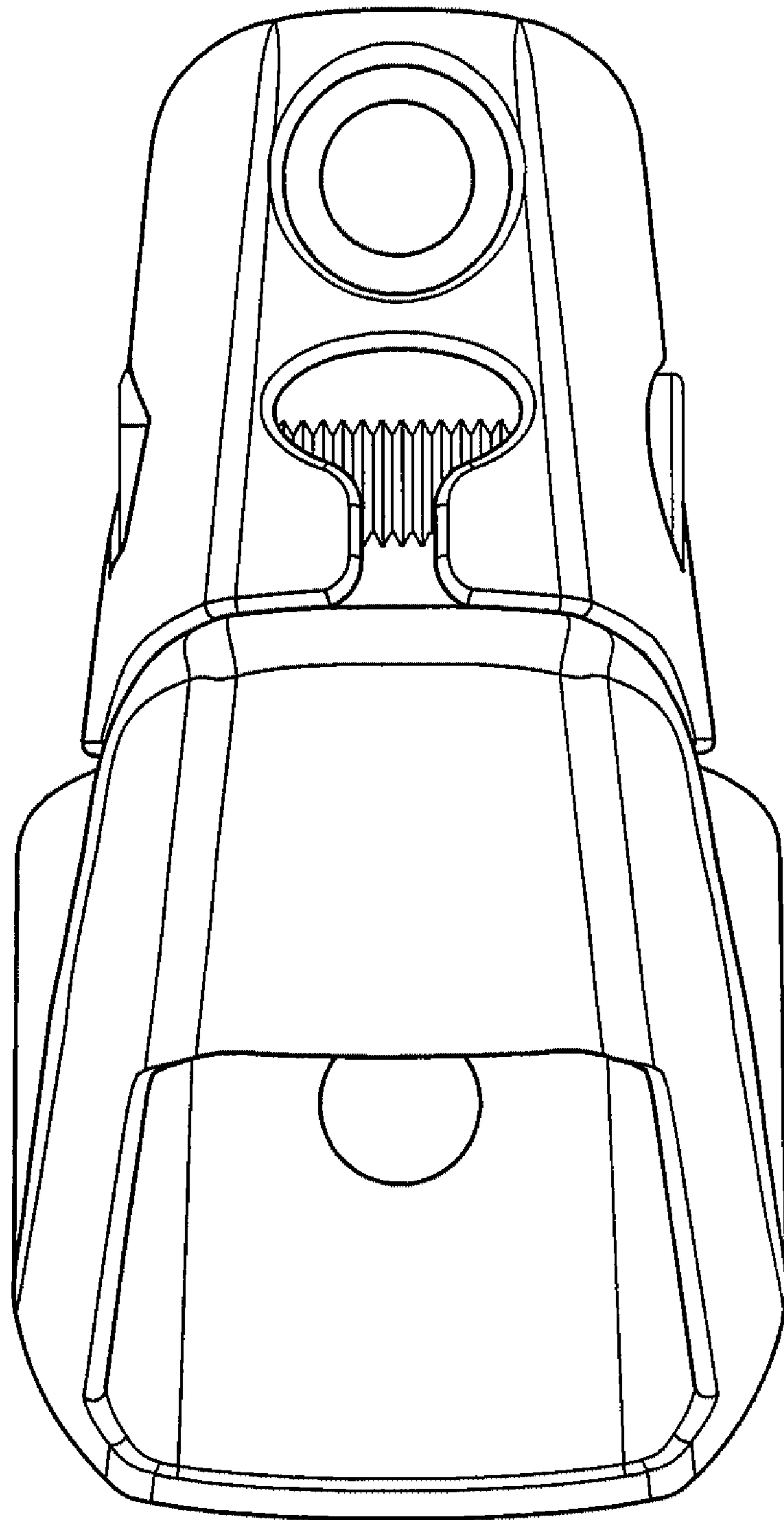

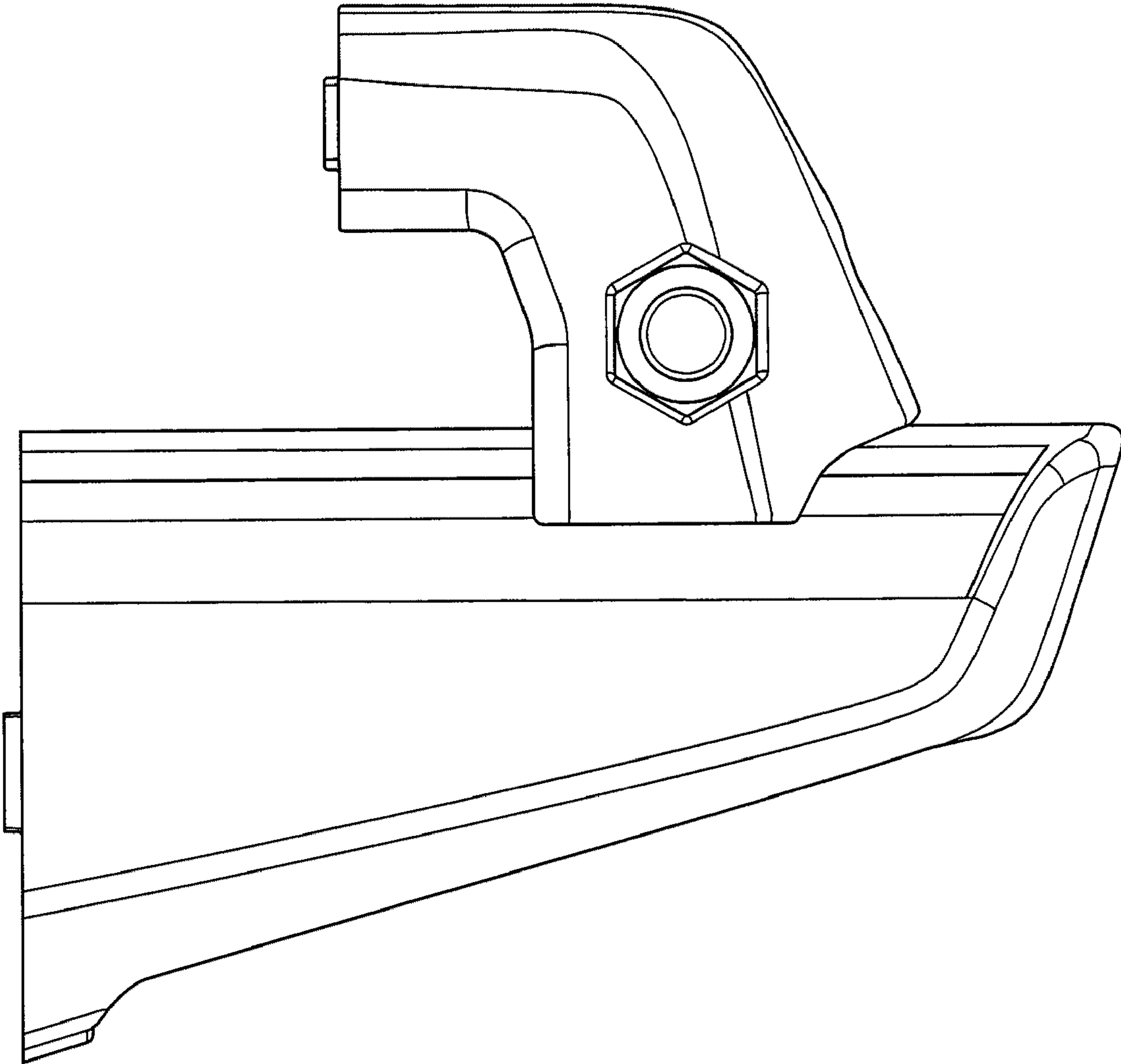

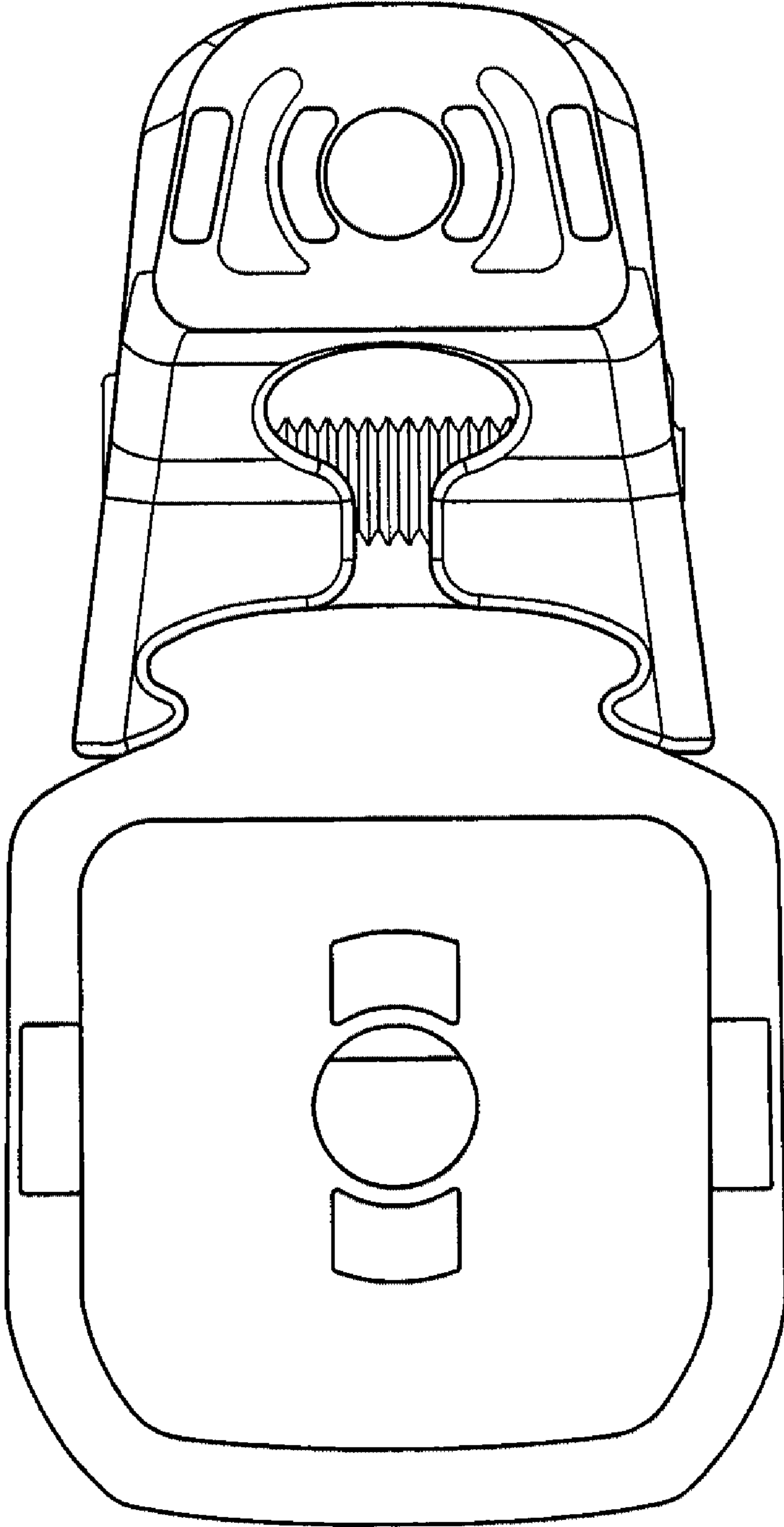

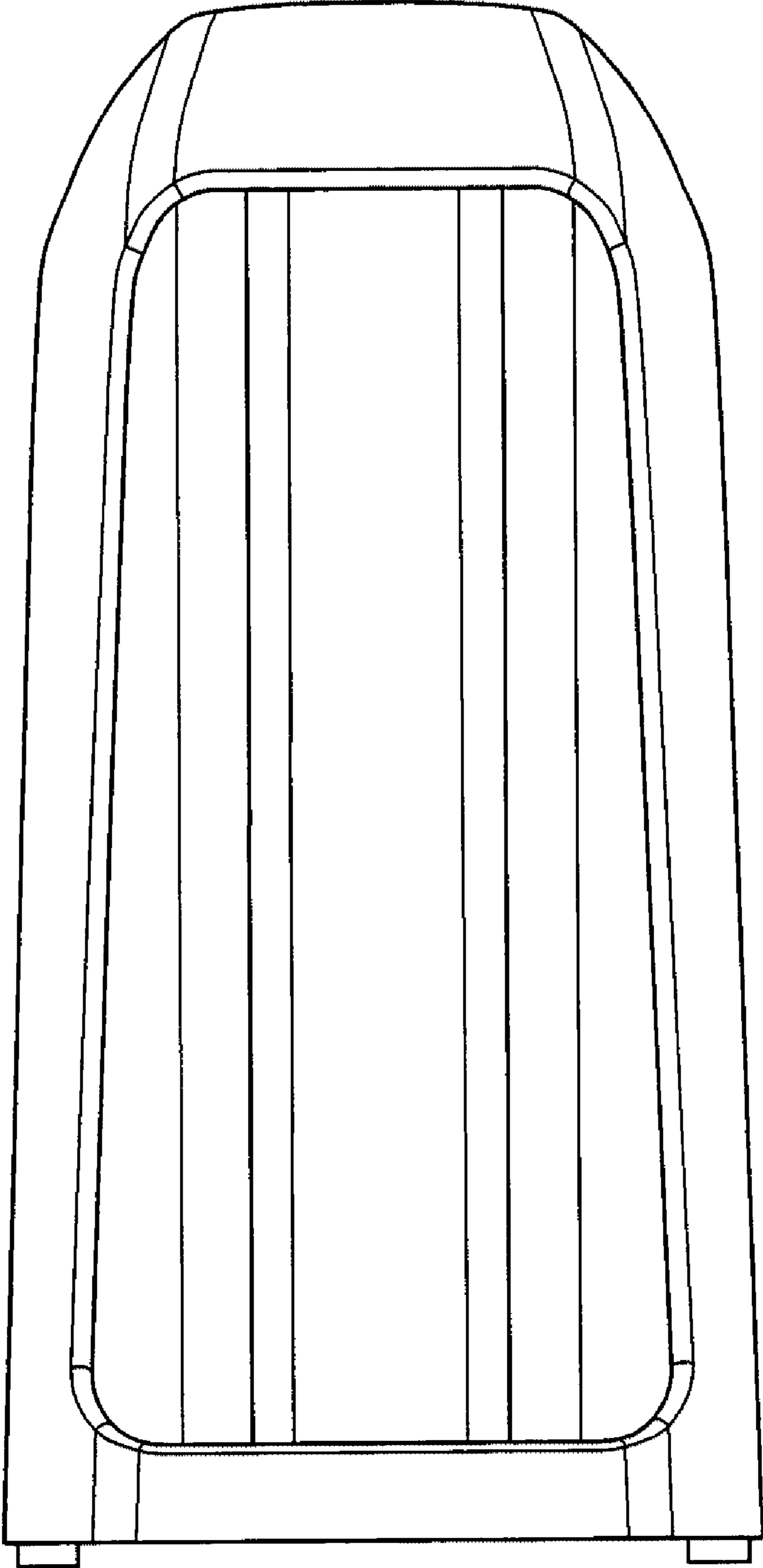

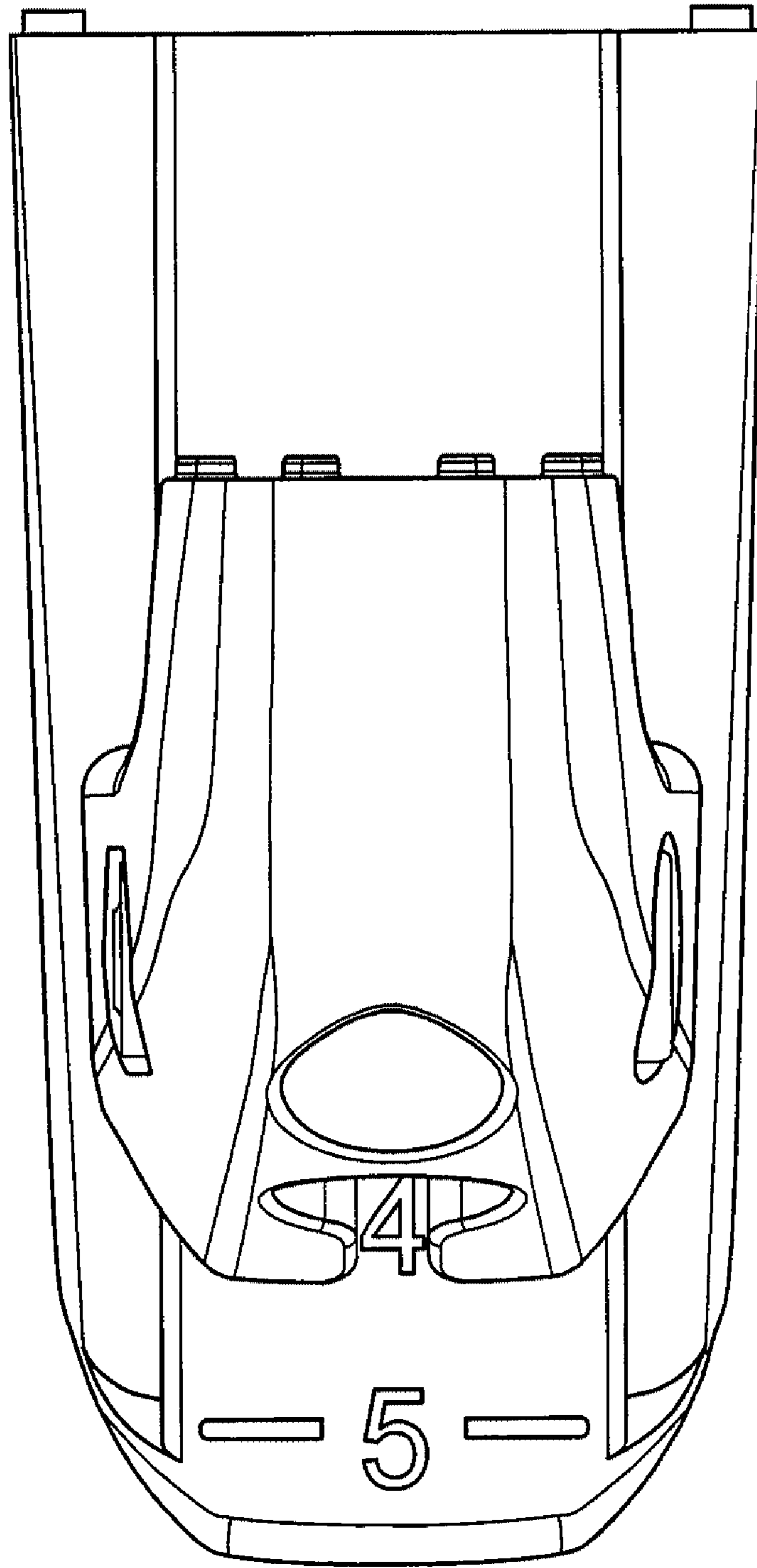
