DESCRIPTION

FIG. 1 is a front elevation view of the container dispenser (shown with a container in broken lines) according to the new design;

FIG. 4 is a right side elevation view thereof;

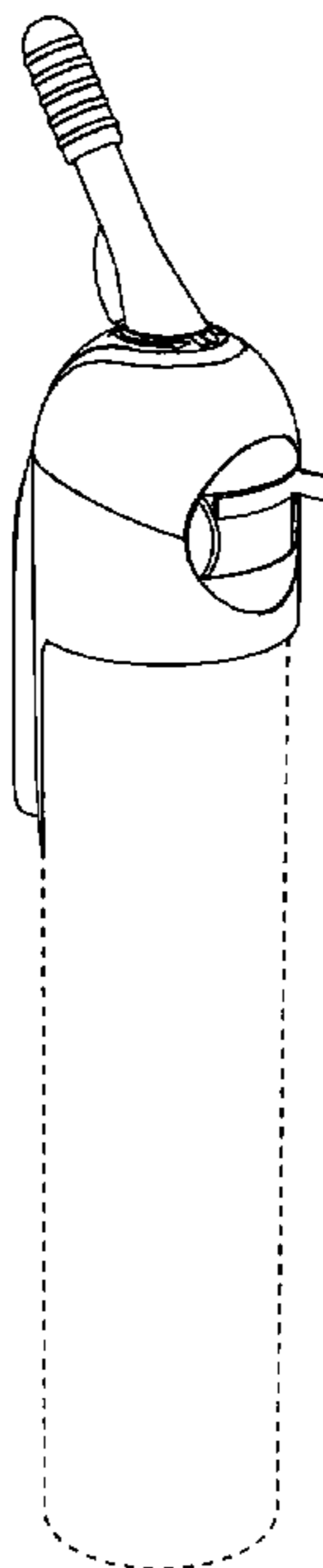
FIG. 5 is a perspective view thereof;

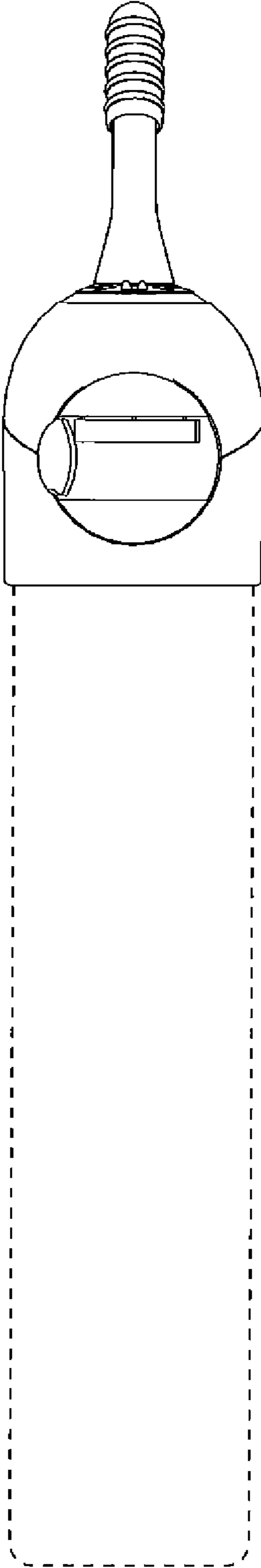

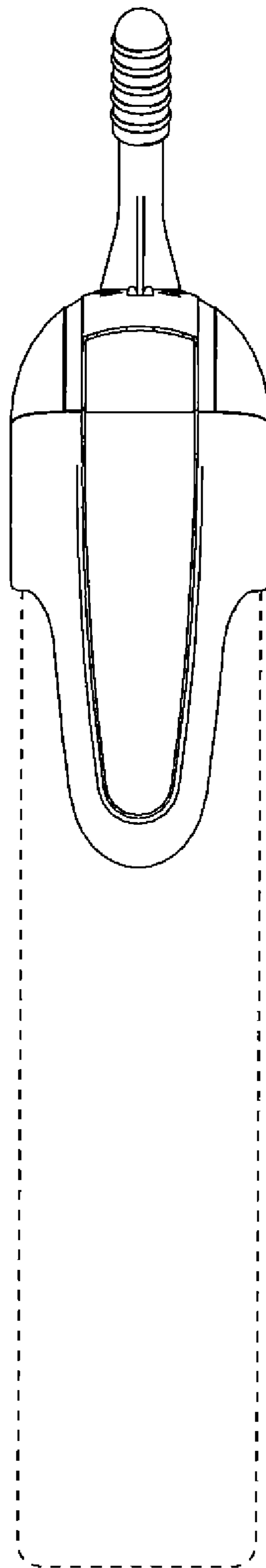

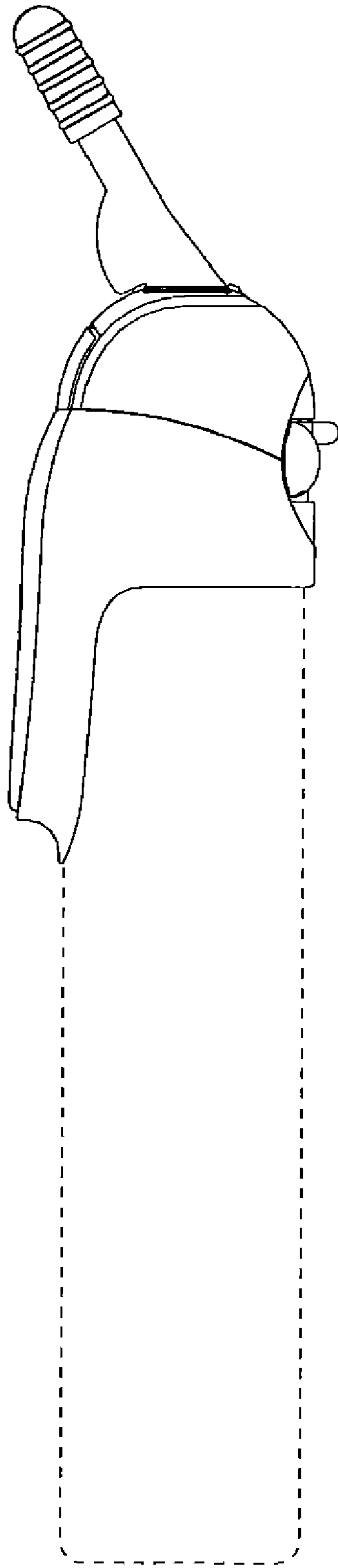

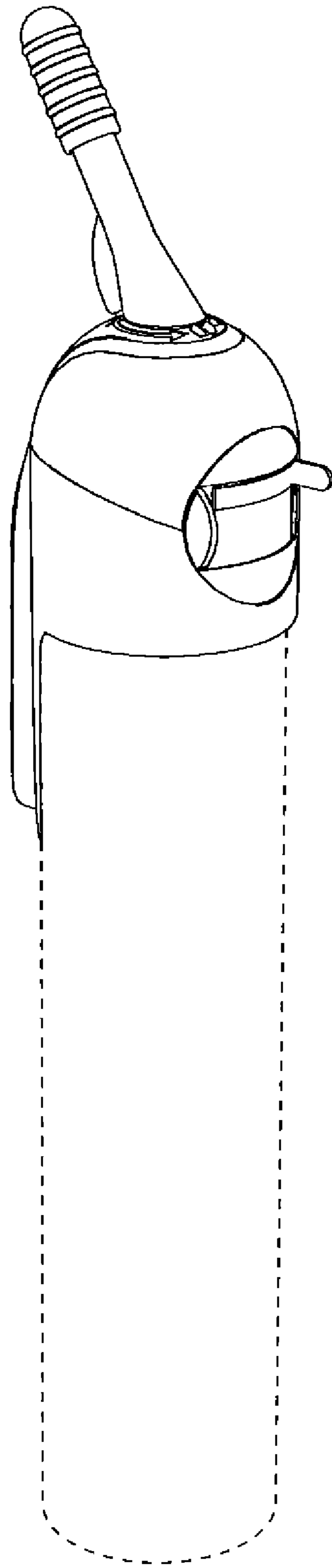

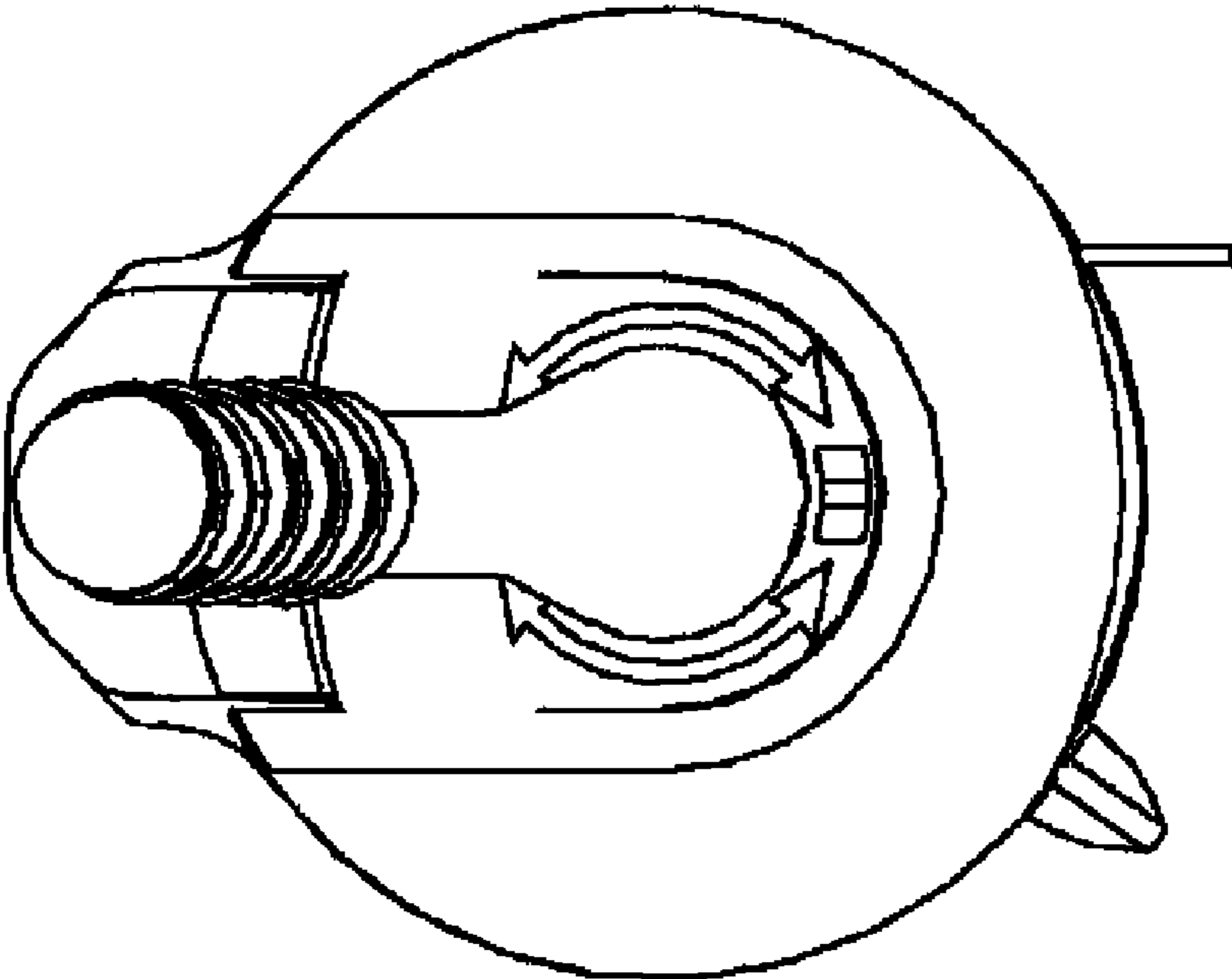

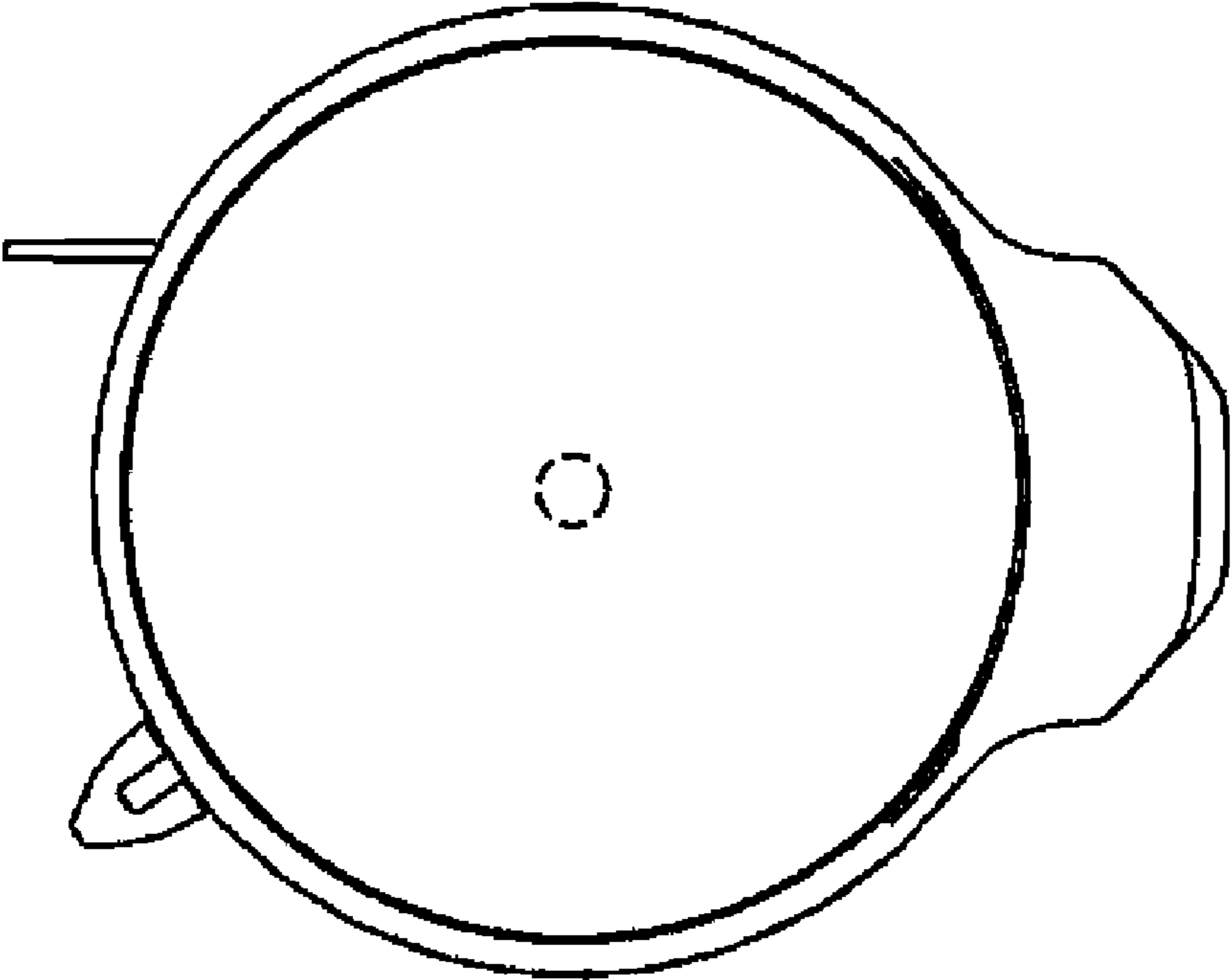
