(57) **CLAIM**

I claim the ornamental design for a cosmetic jar and cover, as shown and described.

DESCRIPTION

FIG. 4 is a bottom plan view of the cosmetic jar and cover shown in FIG. 1

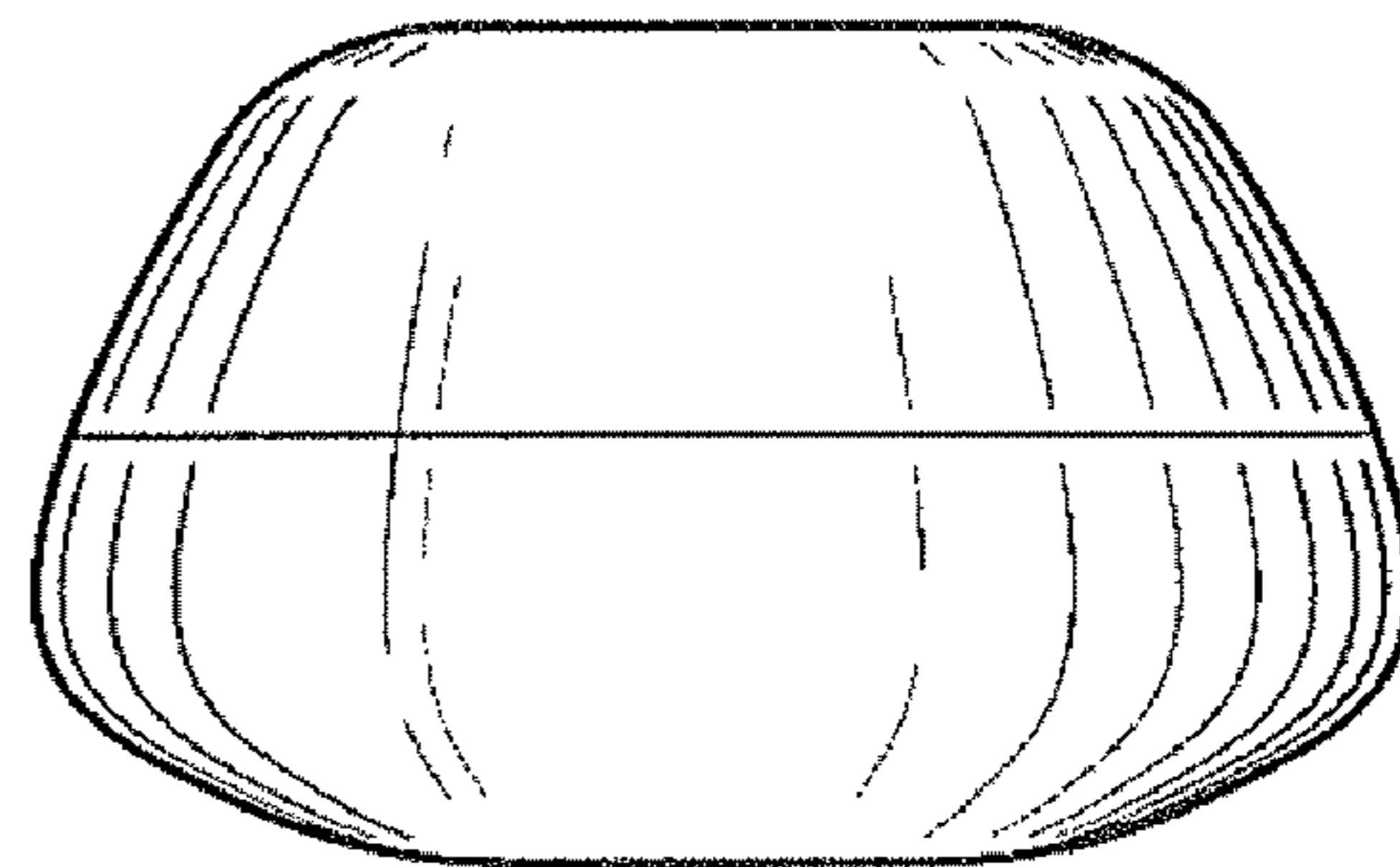
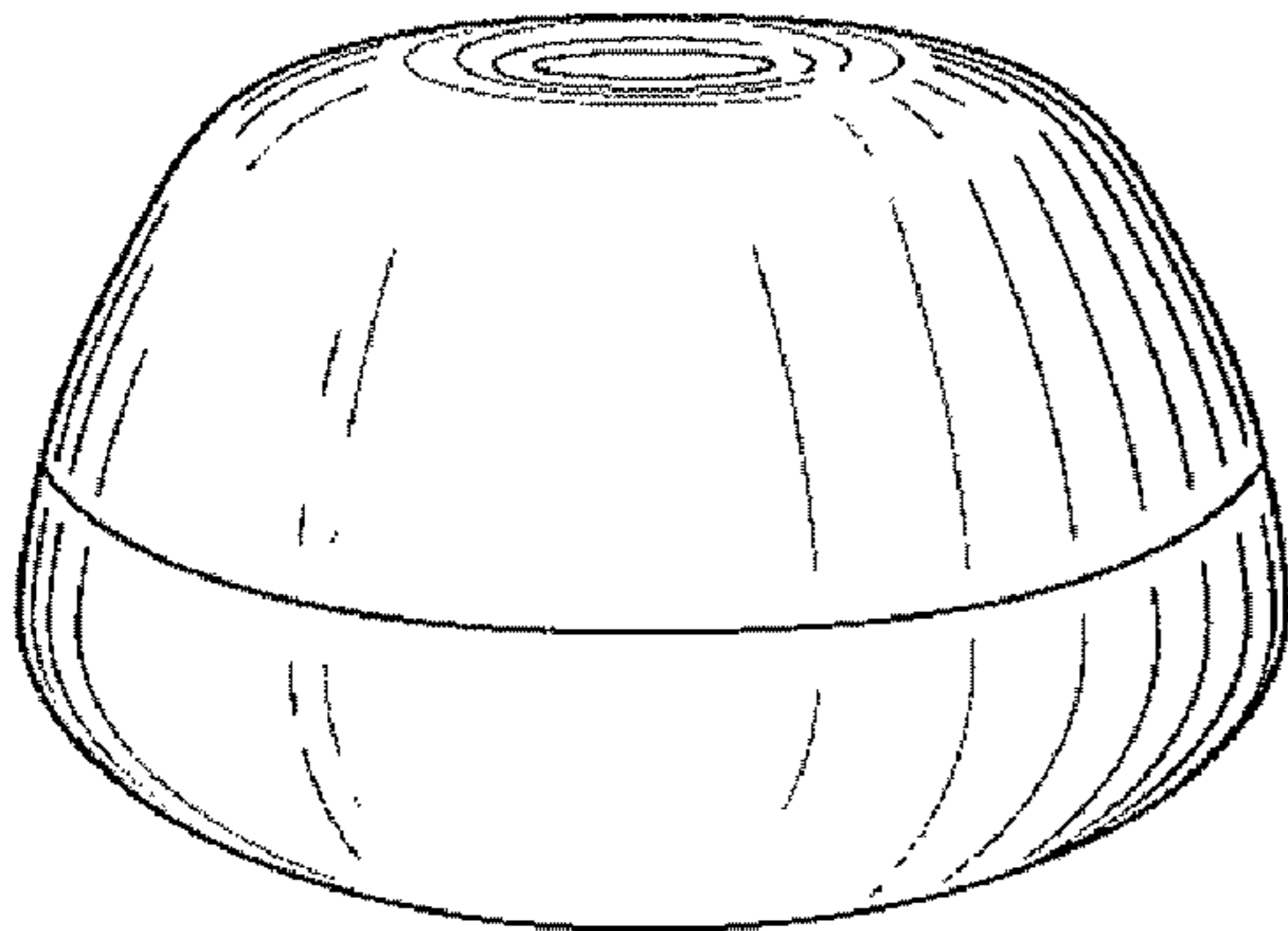
FIG. 5 is a top and side perspective view of a second embodiment of my new design for a cosmetic jar and cover;

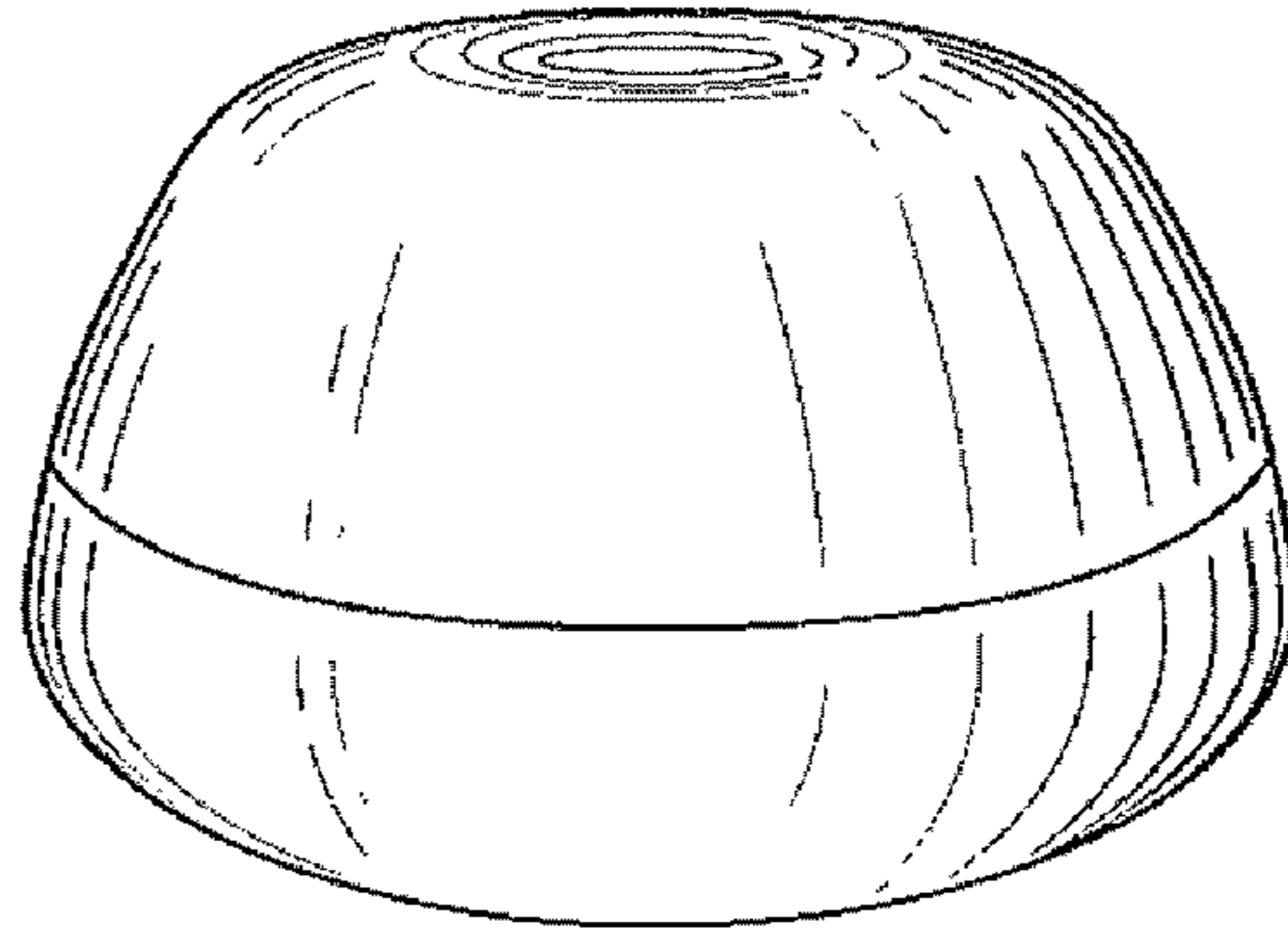

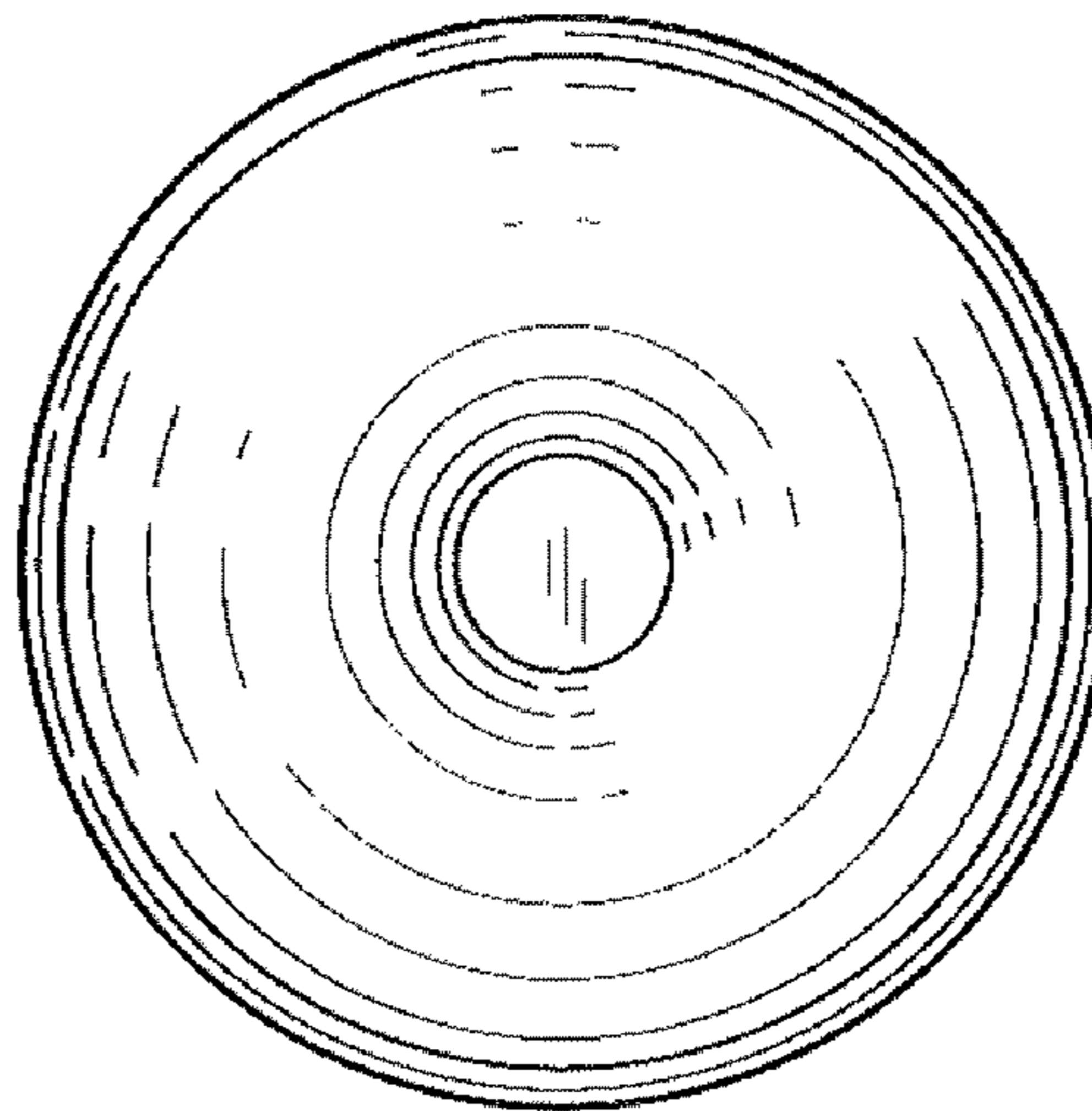

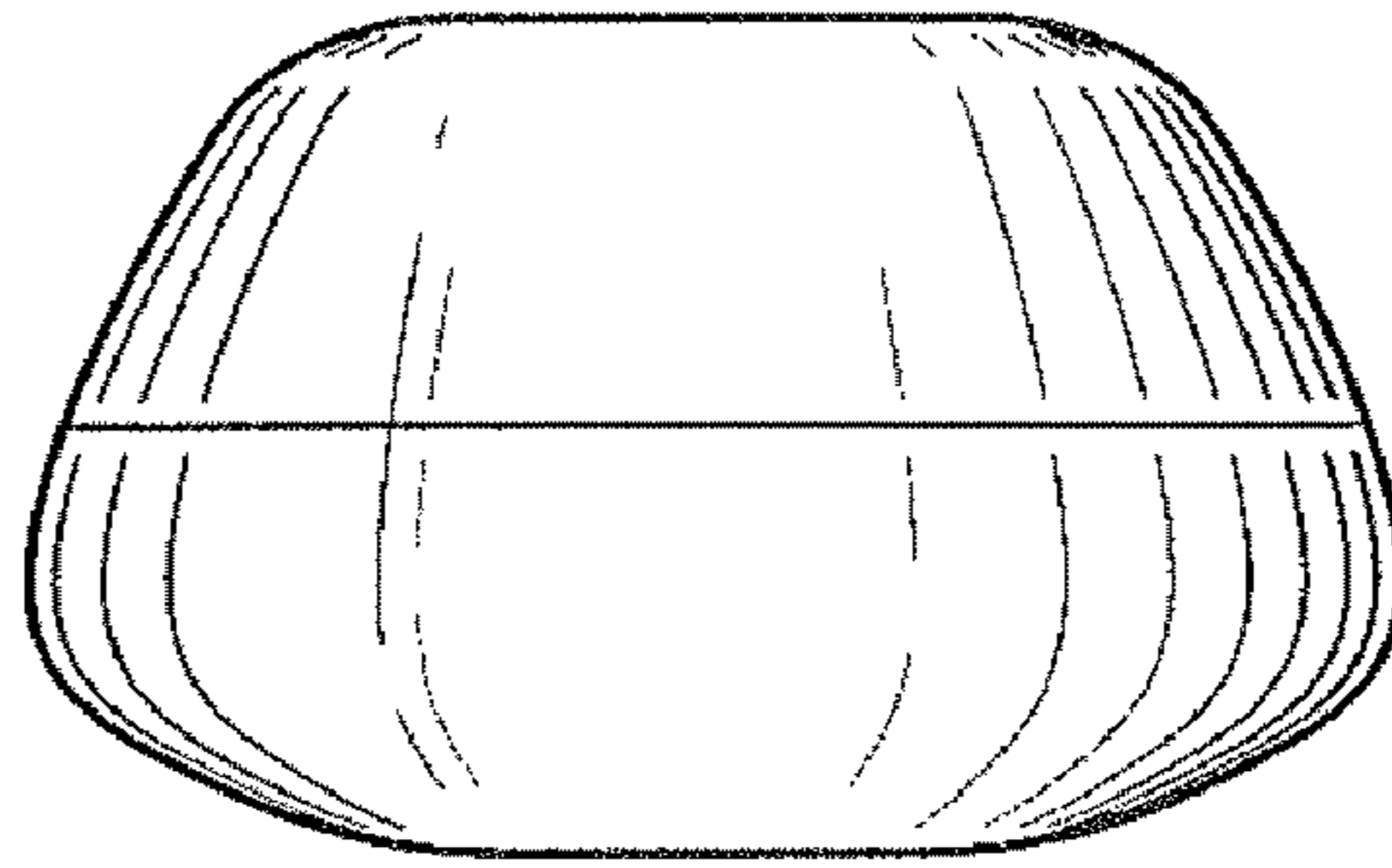

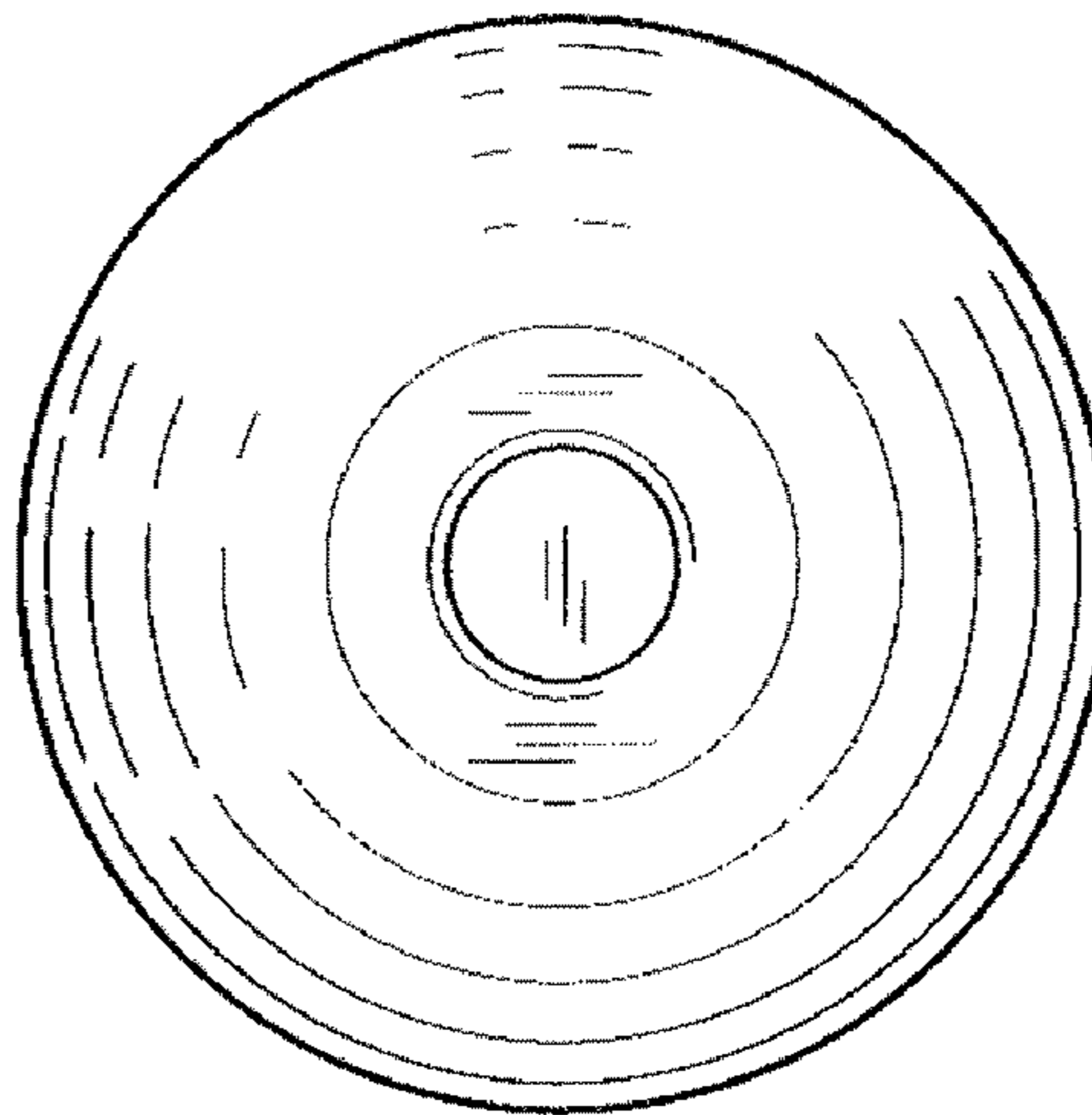

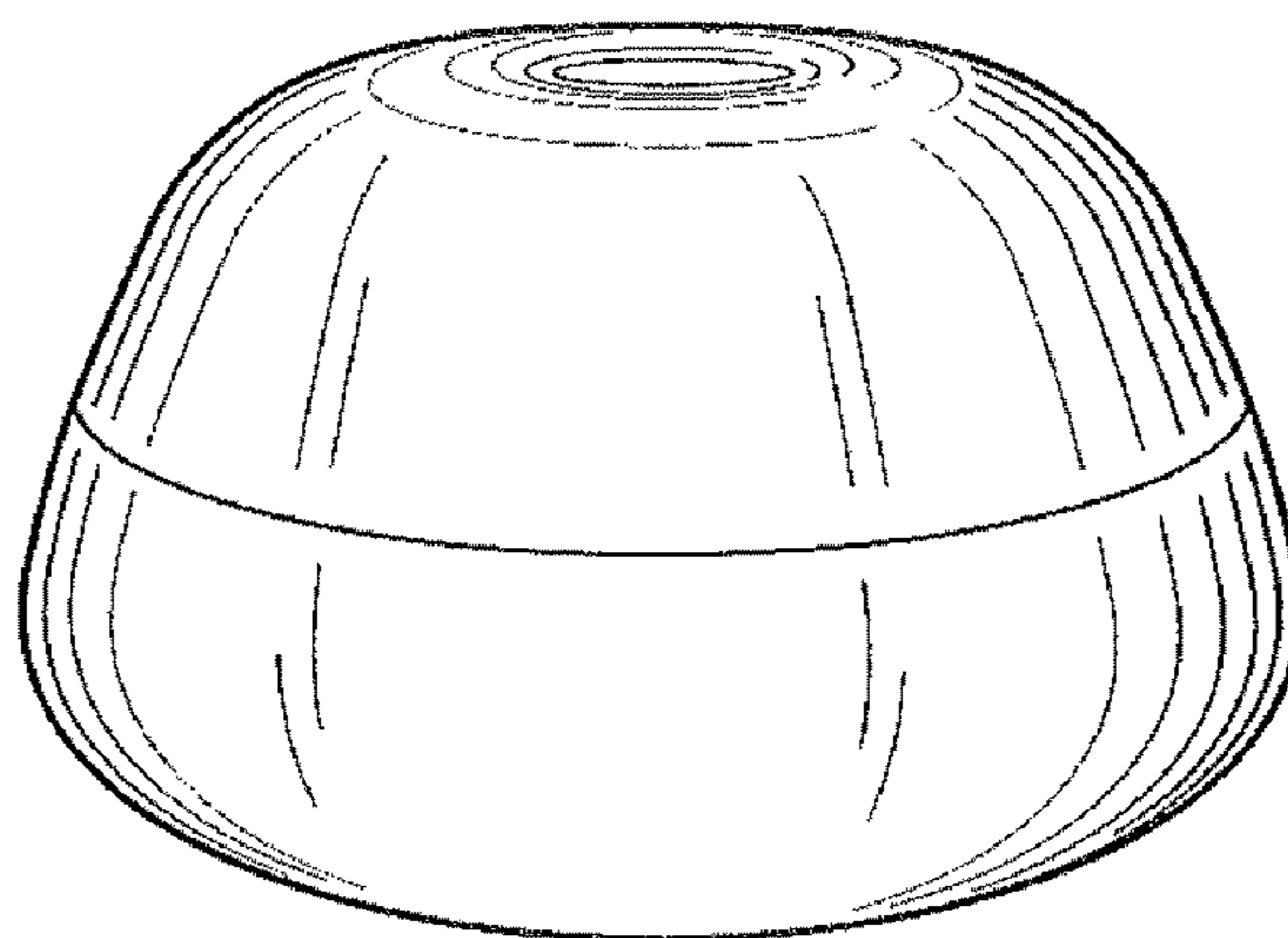

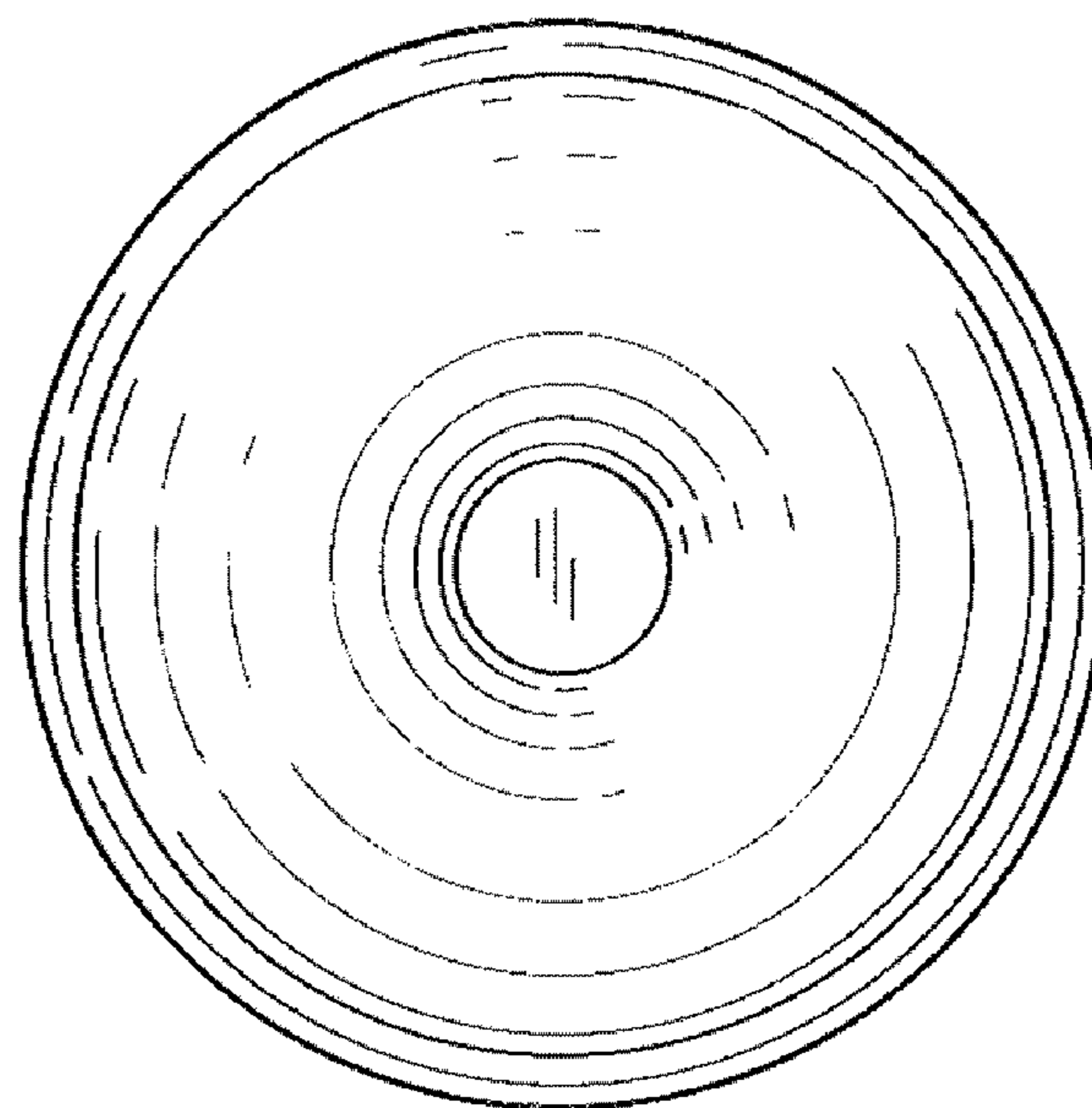

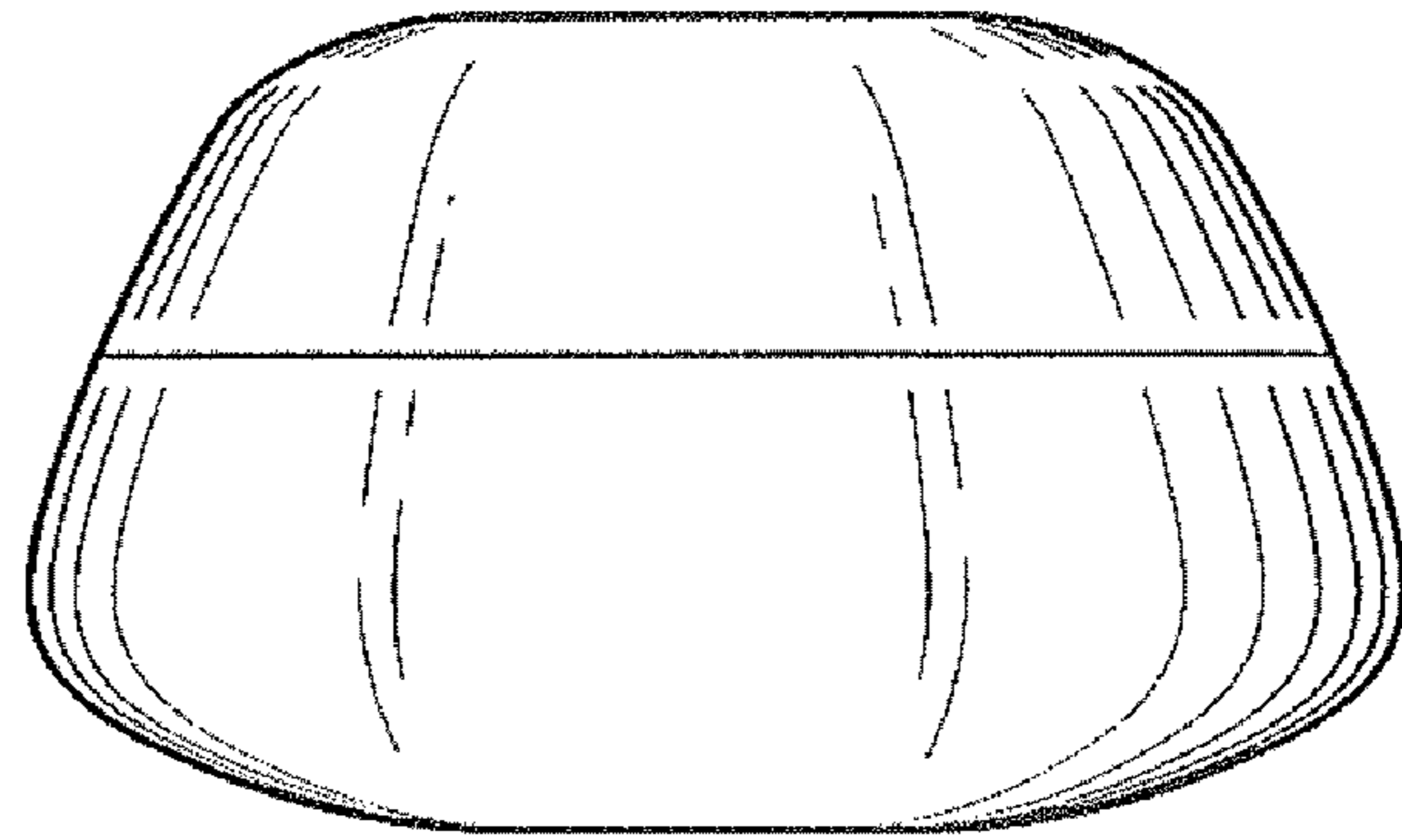
