FIG. 3 is a top view thereof;

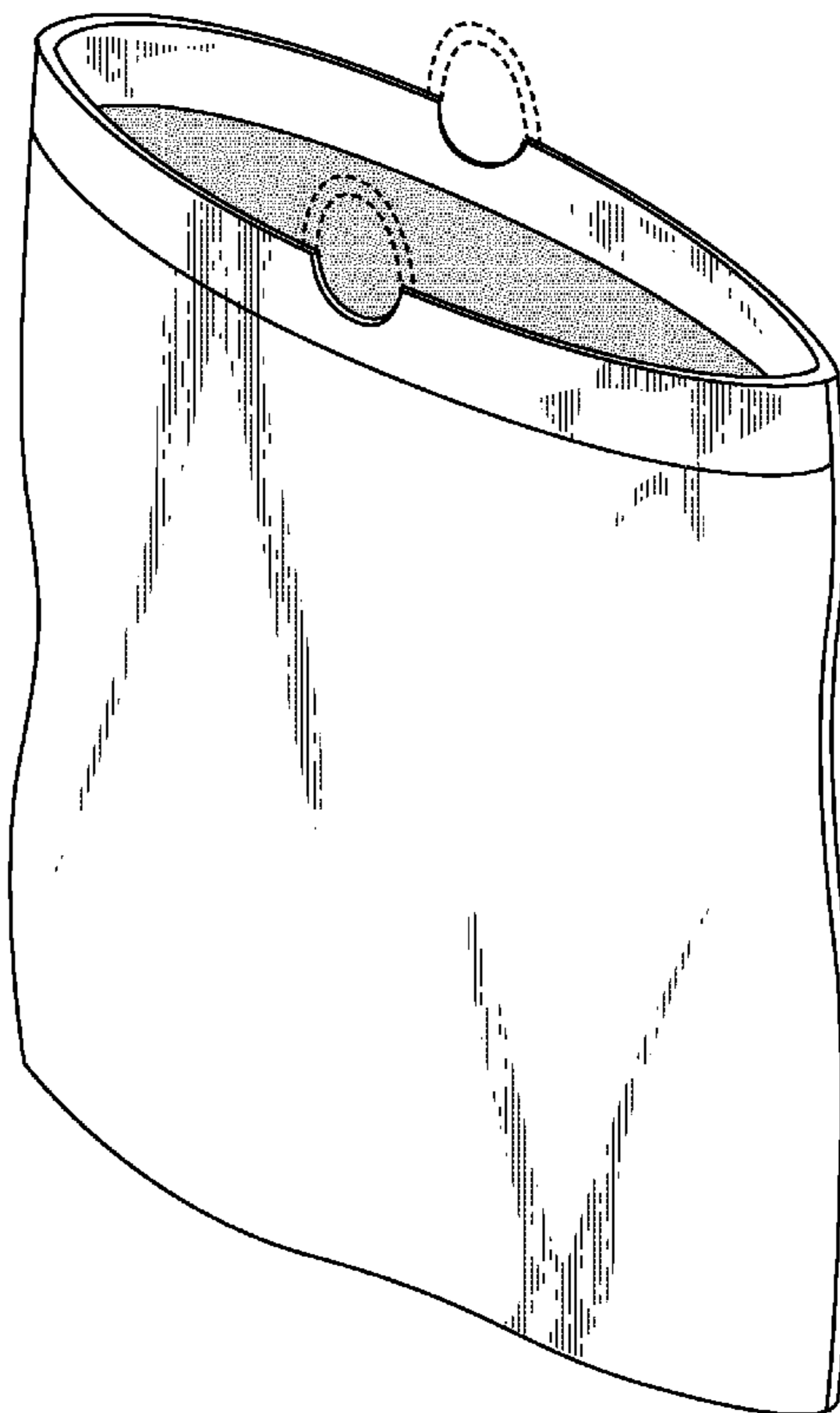
FIG. 4 is a bottom view thereof;

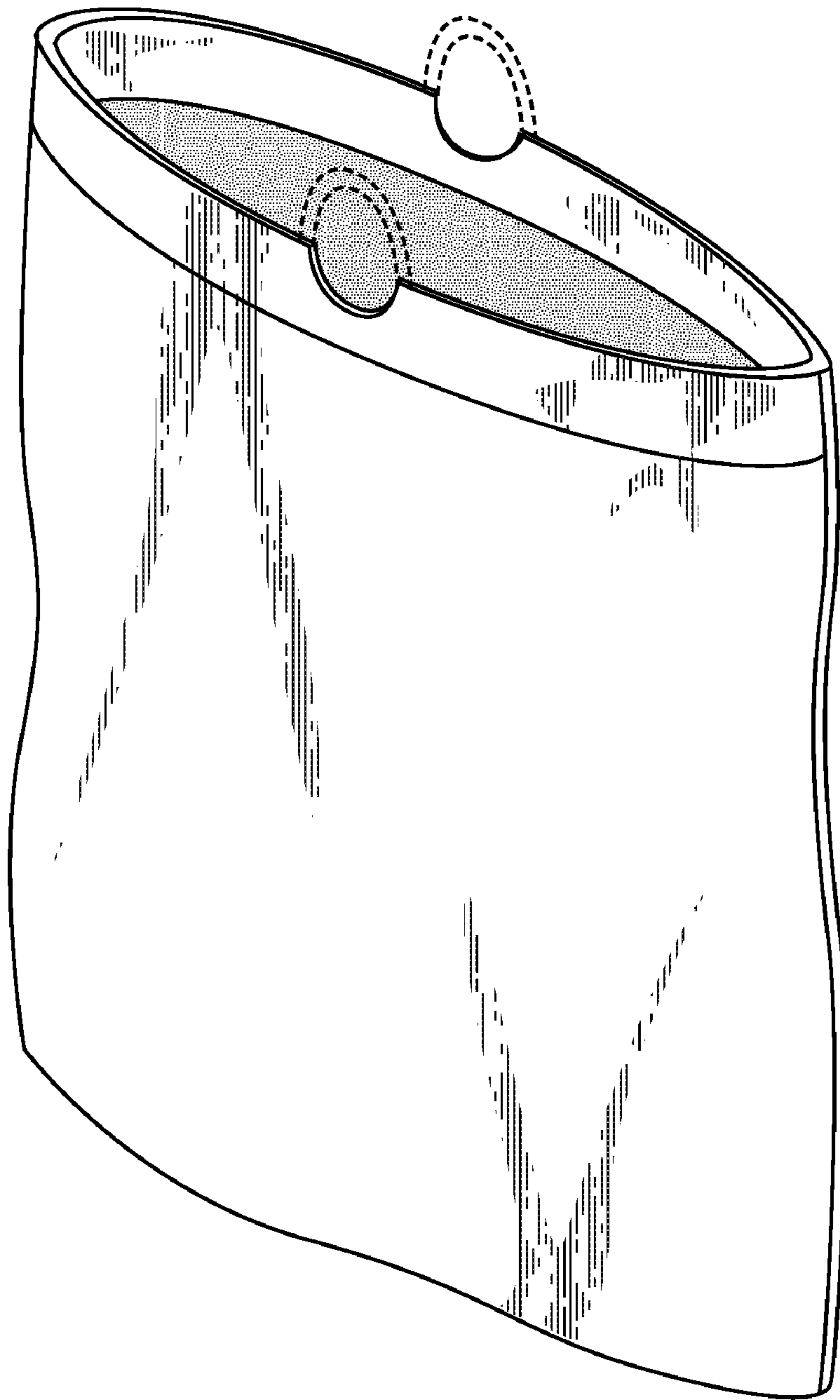
FIG. 5 is a side view thereof; and,

FIG. 6 a cutaway, side view thereof showing a portion with enlarged view for ease of illustration.

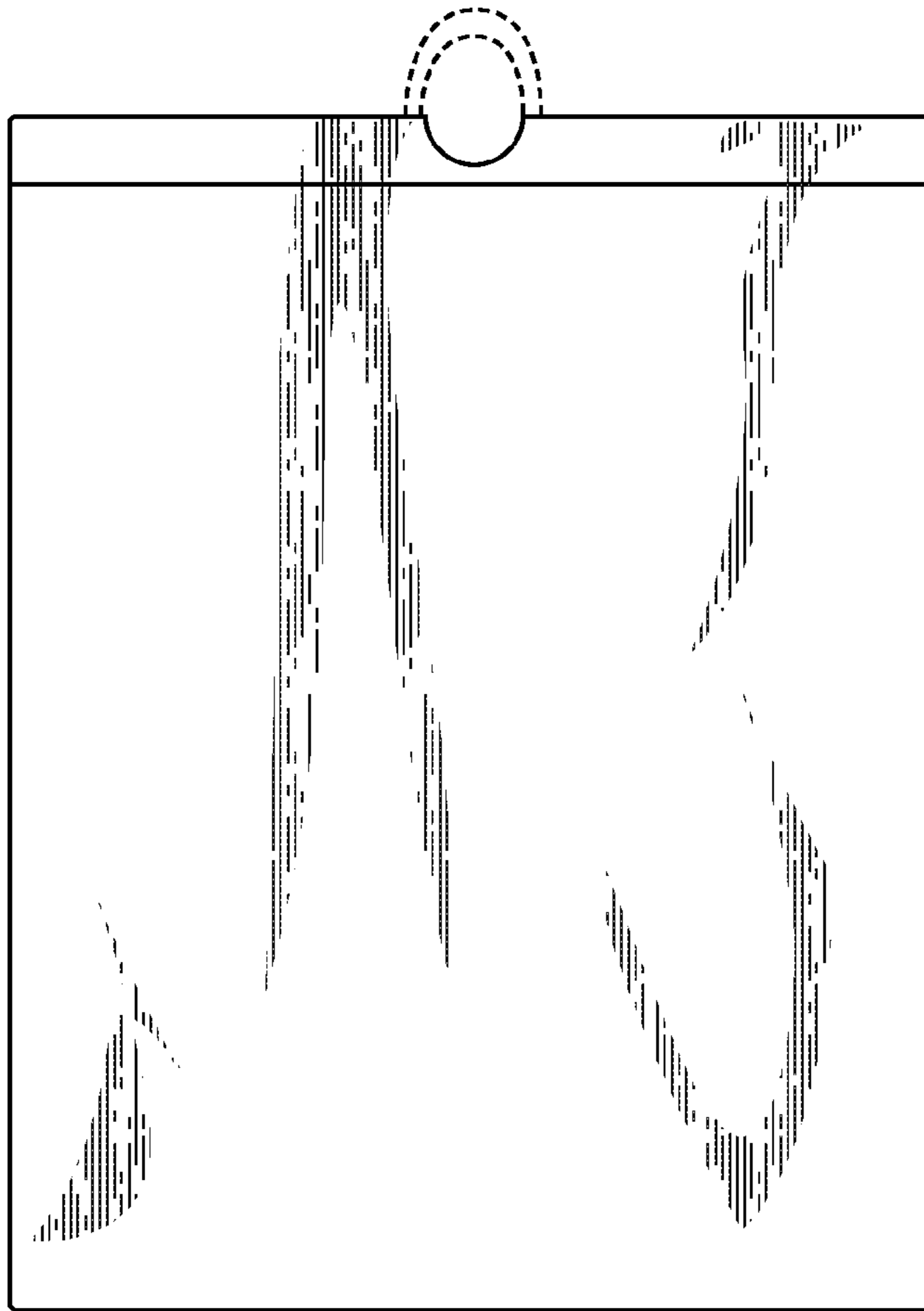
The broken line showing of a portion of the trash bag is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

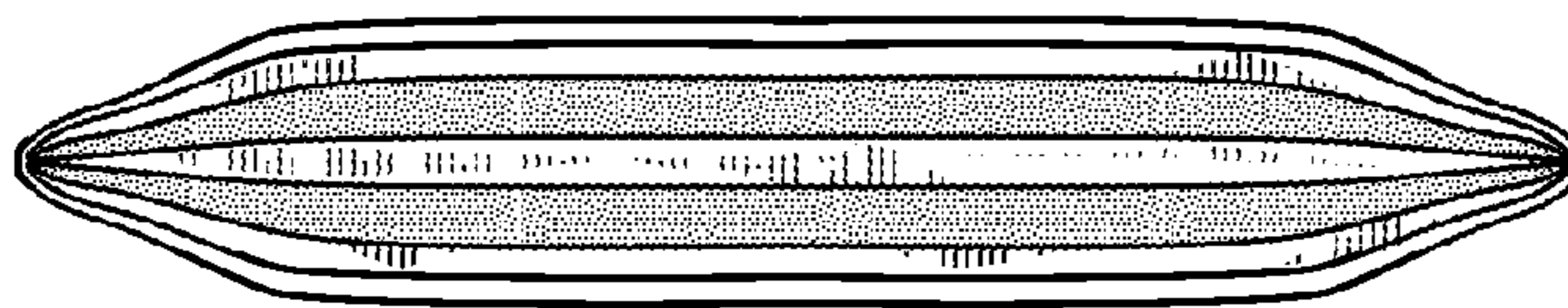




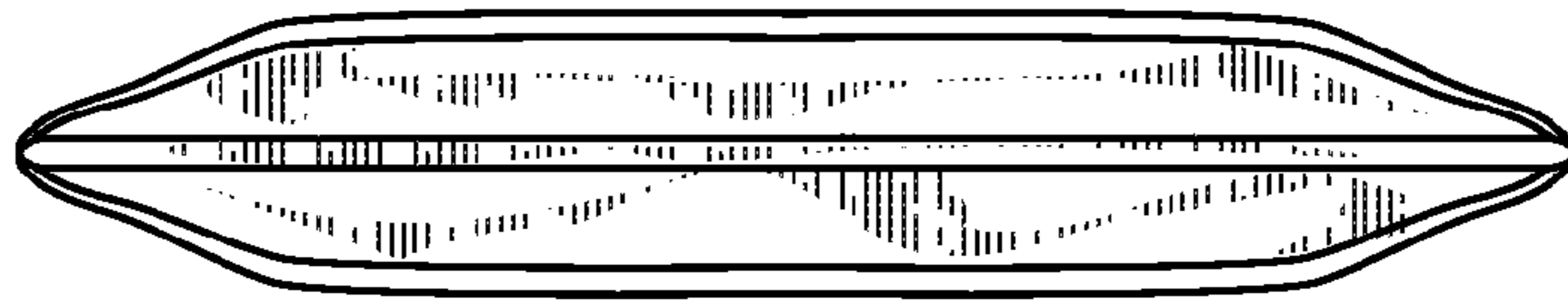

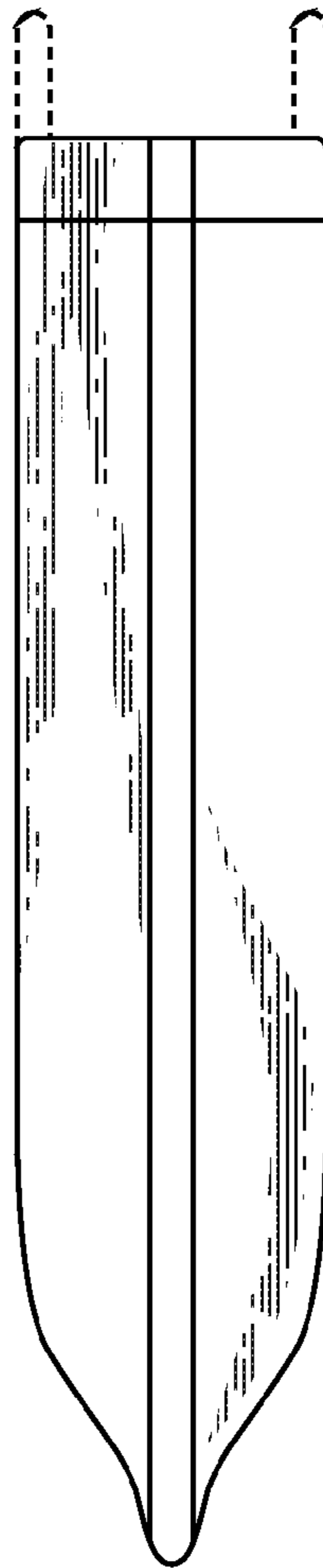

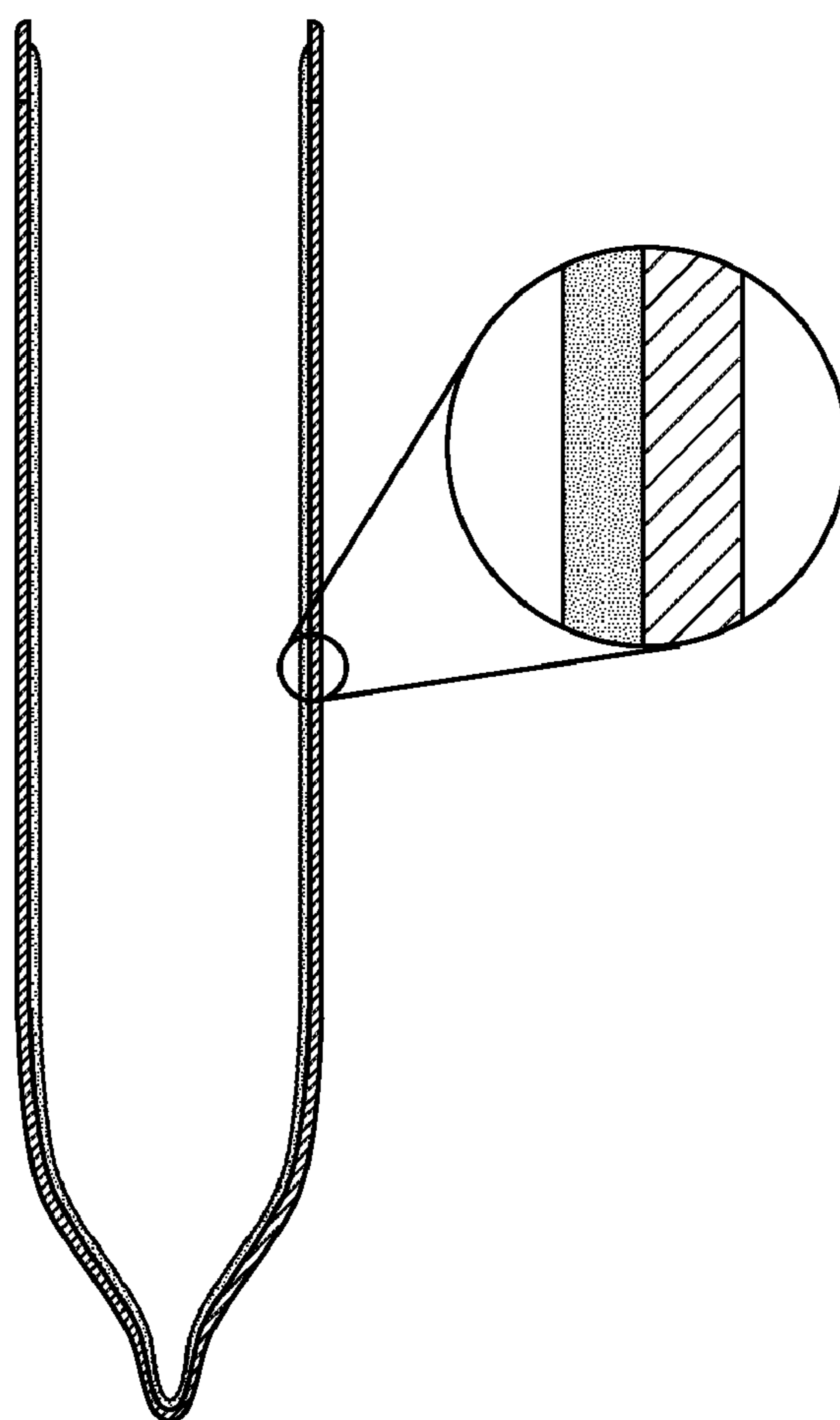
