(57) **CLAIM**

The ornamental design for a pause capsule jewelry, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pause capsule jewelry.

FIG. 2 is a top view of the pause capsule jewelry.

FIG. 3 is a bottom view of the pause capsule jewelry.

FIG. 4 is a left side plan view of the pause capsule jewelry.

FIG. 5 is a right side plan view of the pause capsule jewelry; and,

FIG. 6 is a front-side view of the pause capsule jewelry. The rear-side view of the pause capsule jewelry is identical to the front-side view.

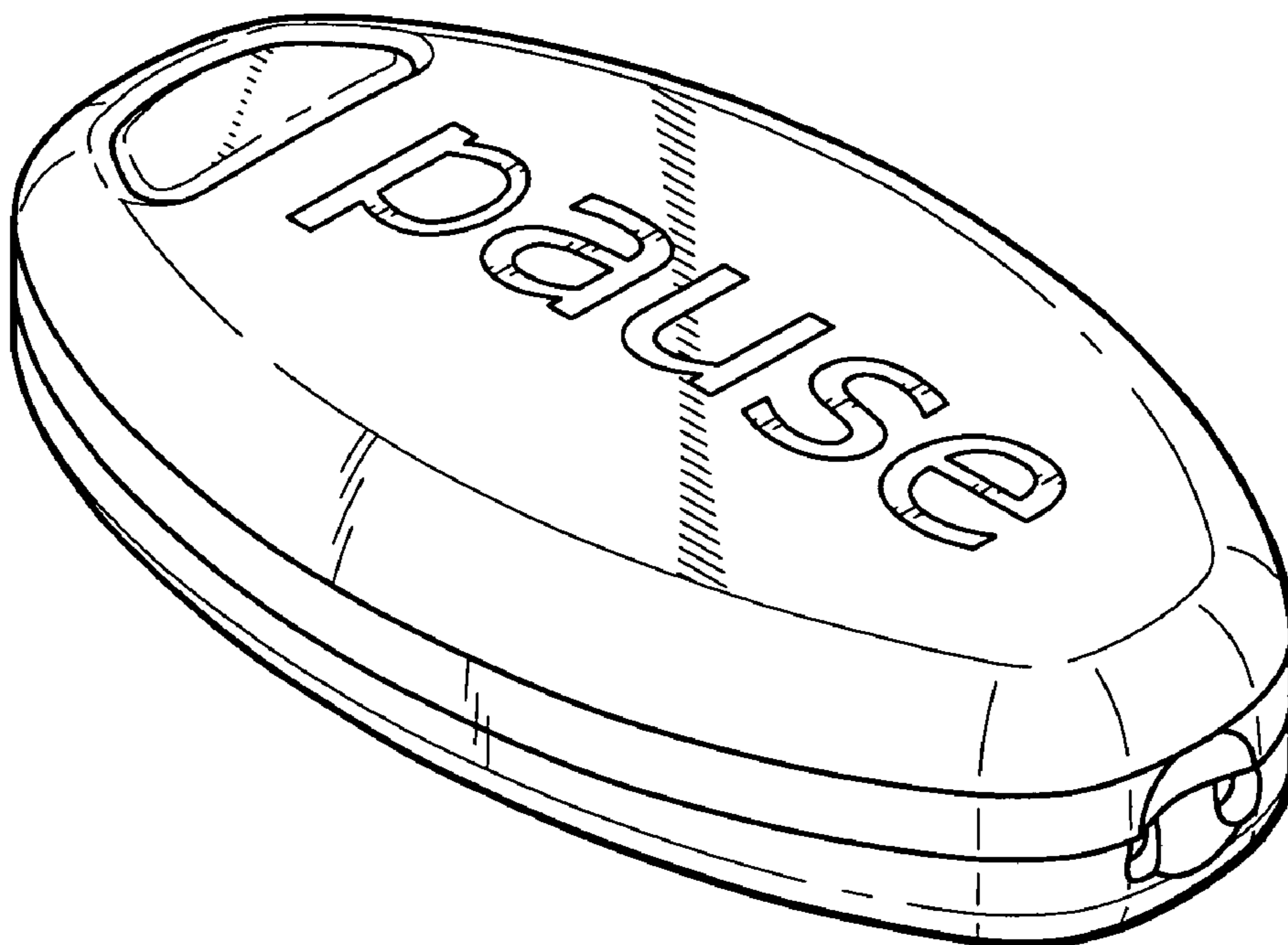

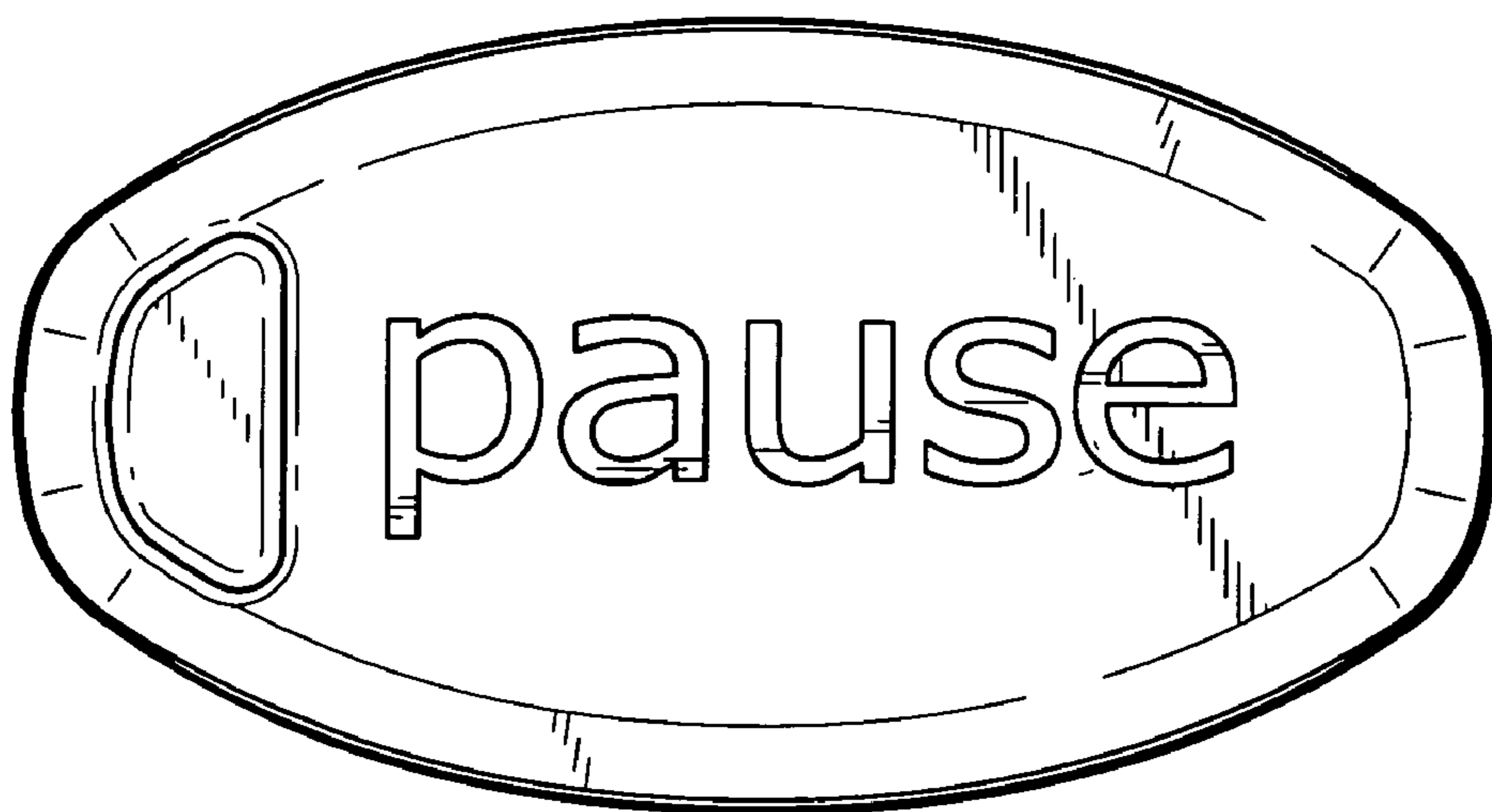
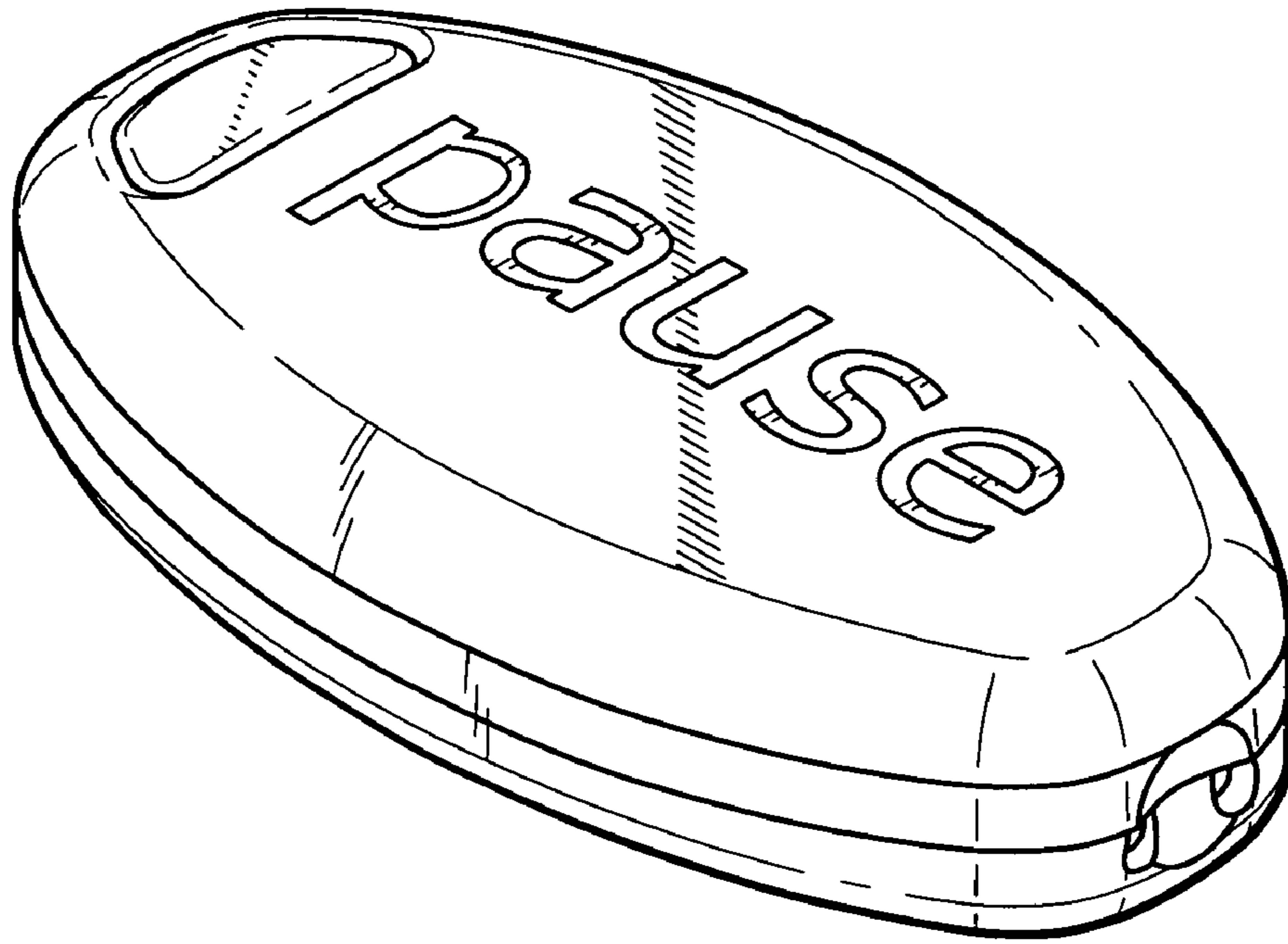

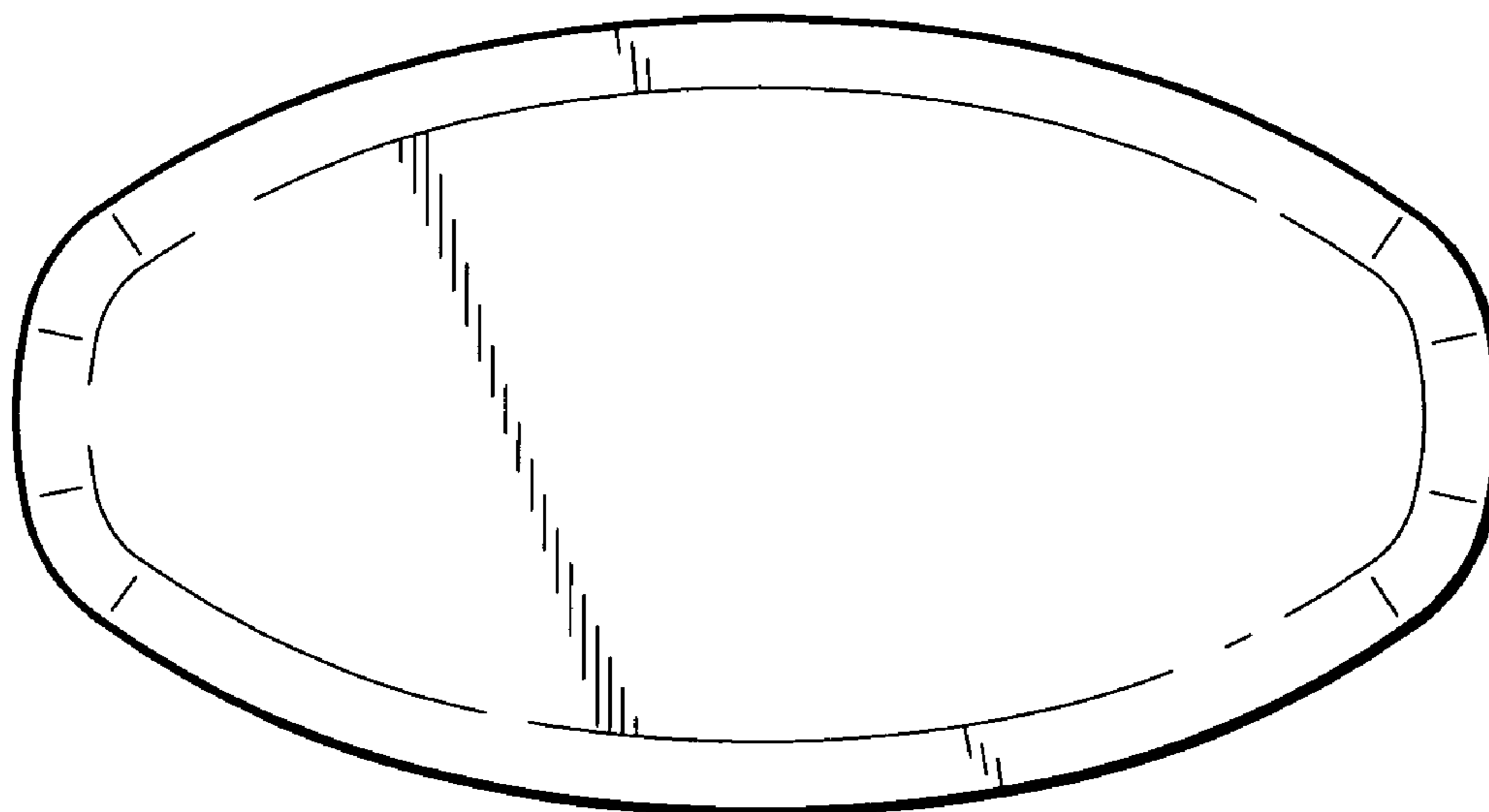

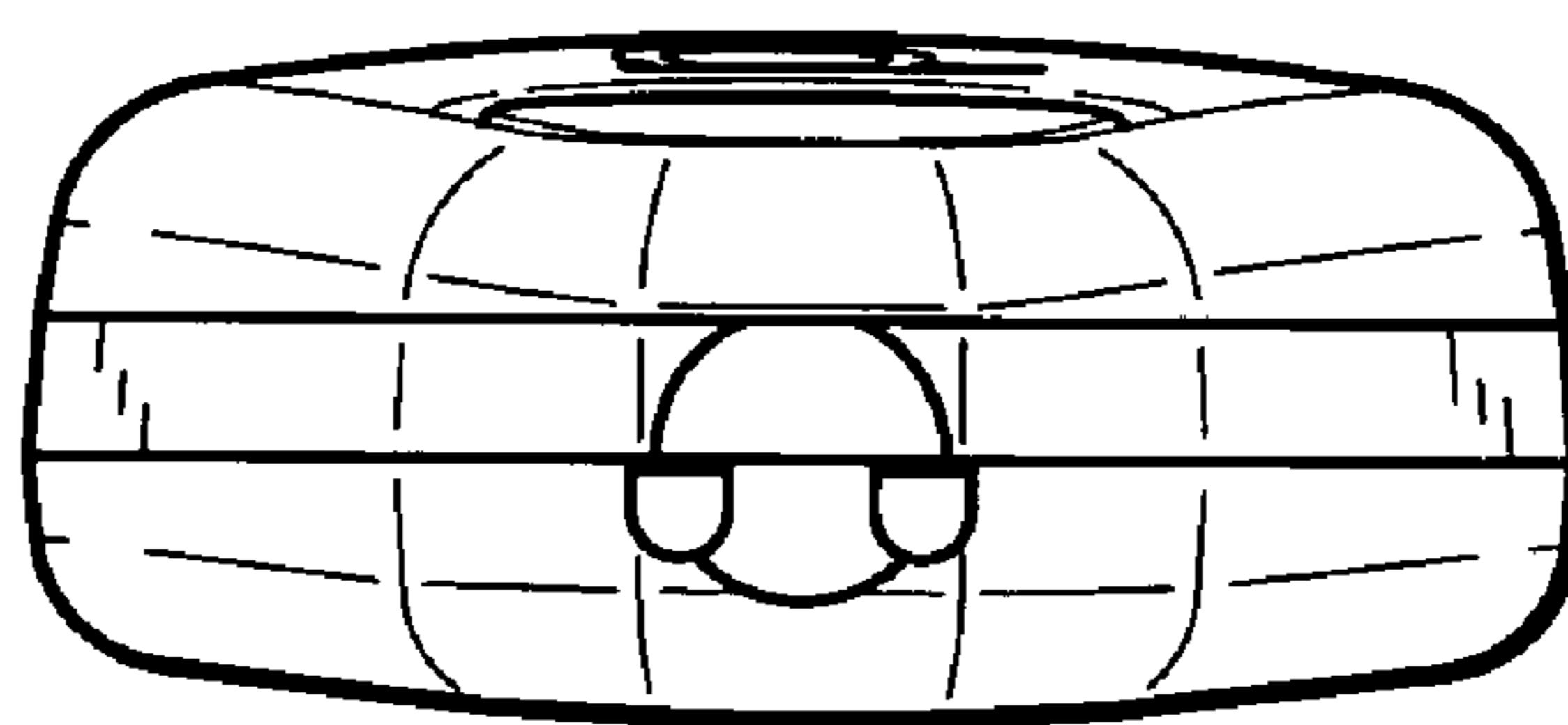

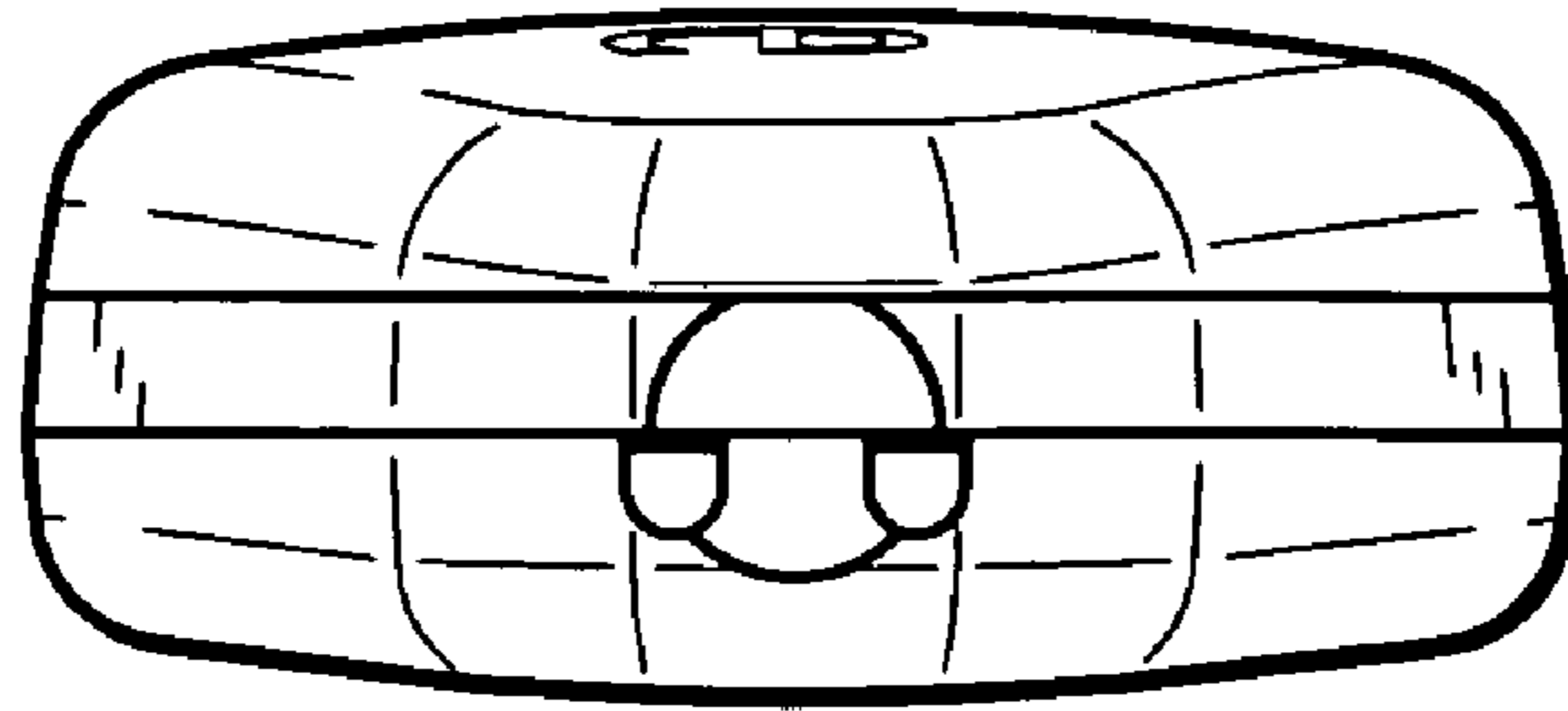

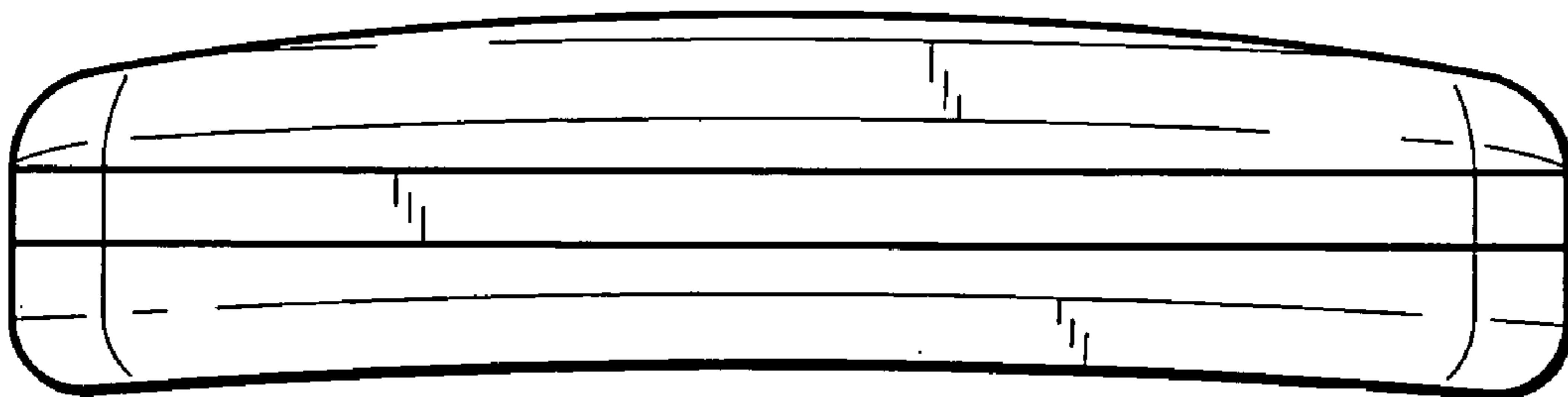
