FIG. 1 is a front view of a first embodiment of a front face of a vehicle wheel according to my novel design; and

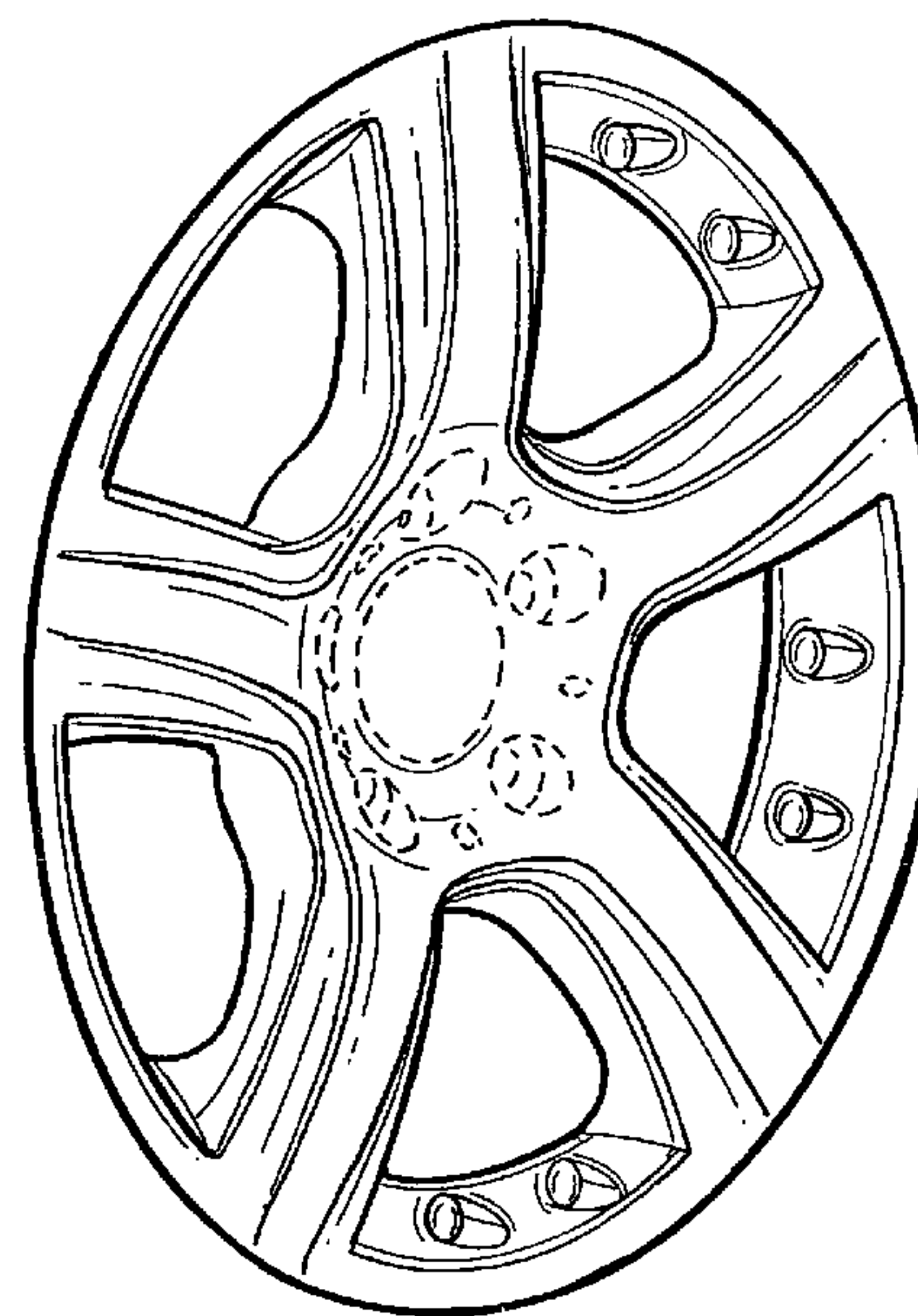
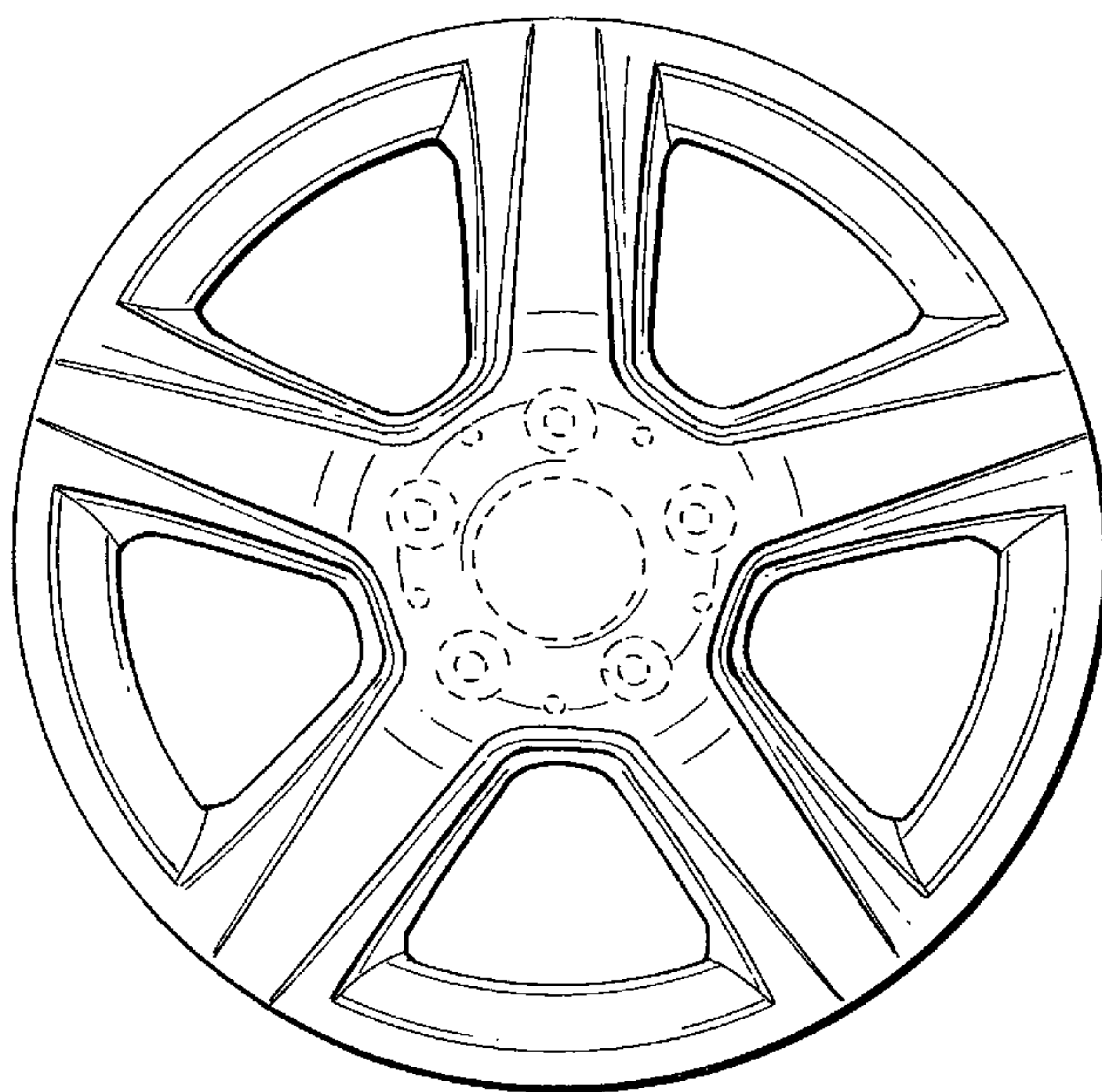
FIG. 2 is a perspective view thereof.

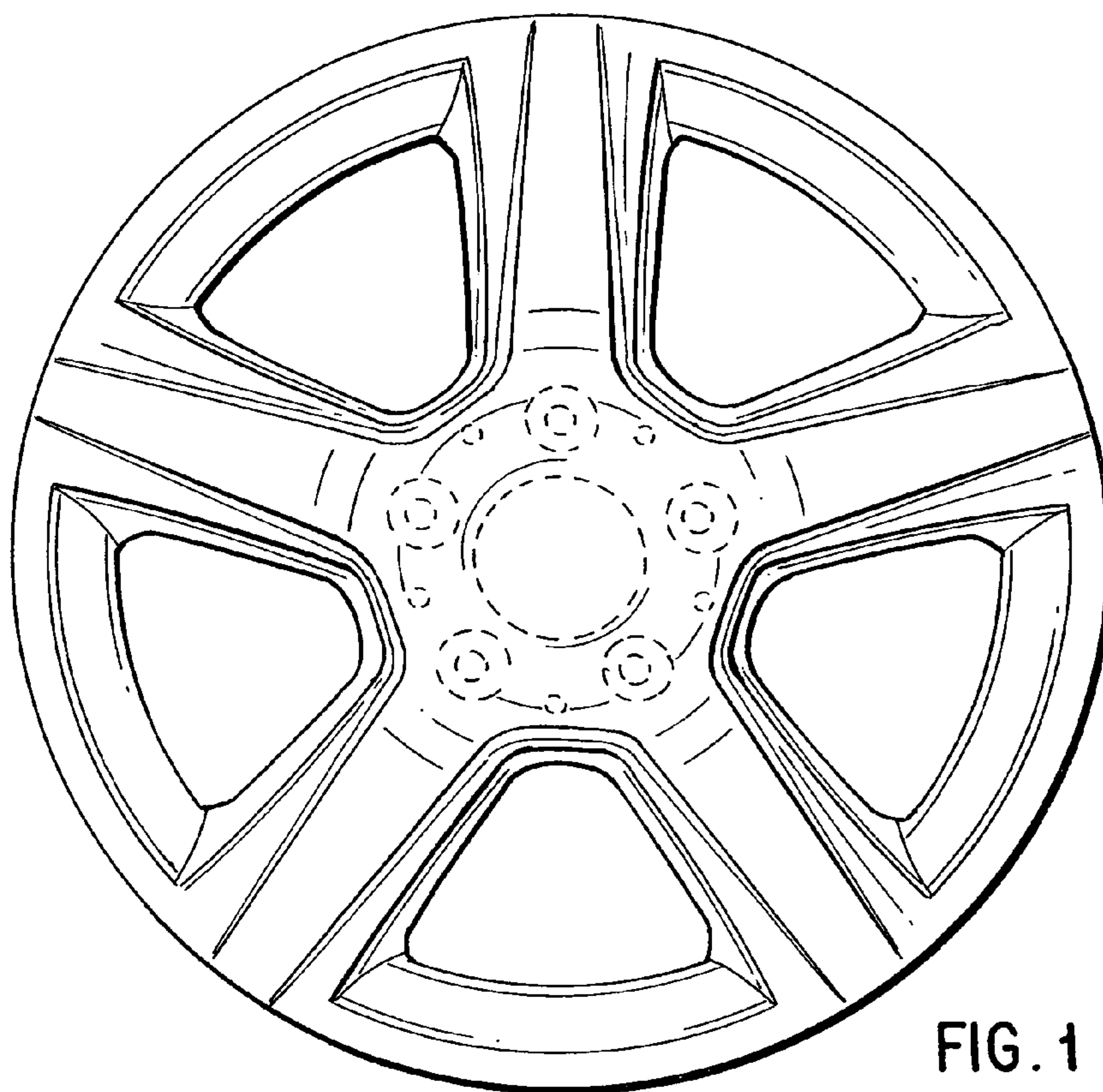

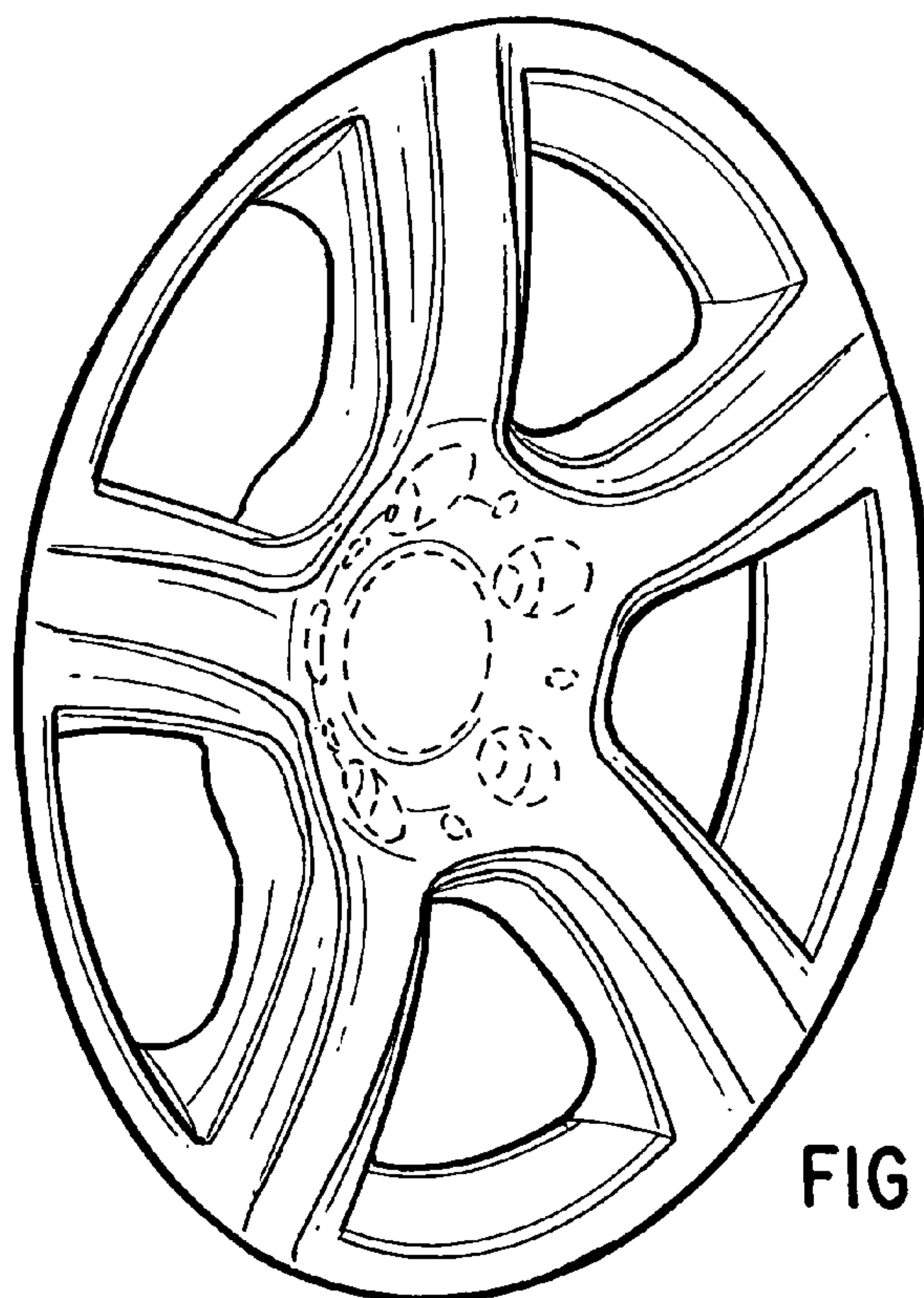

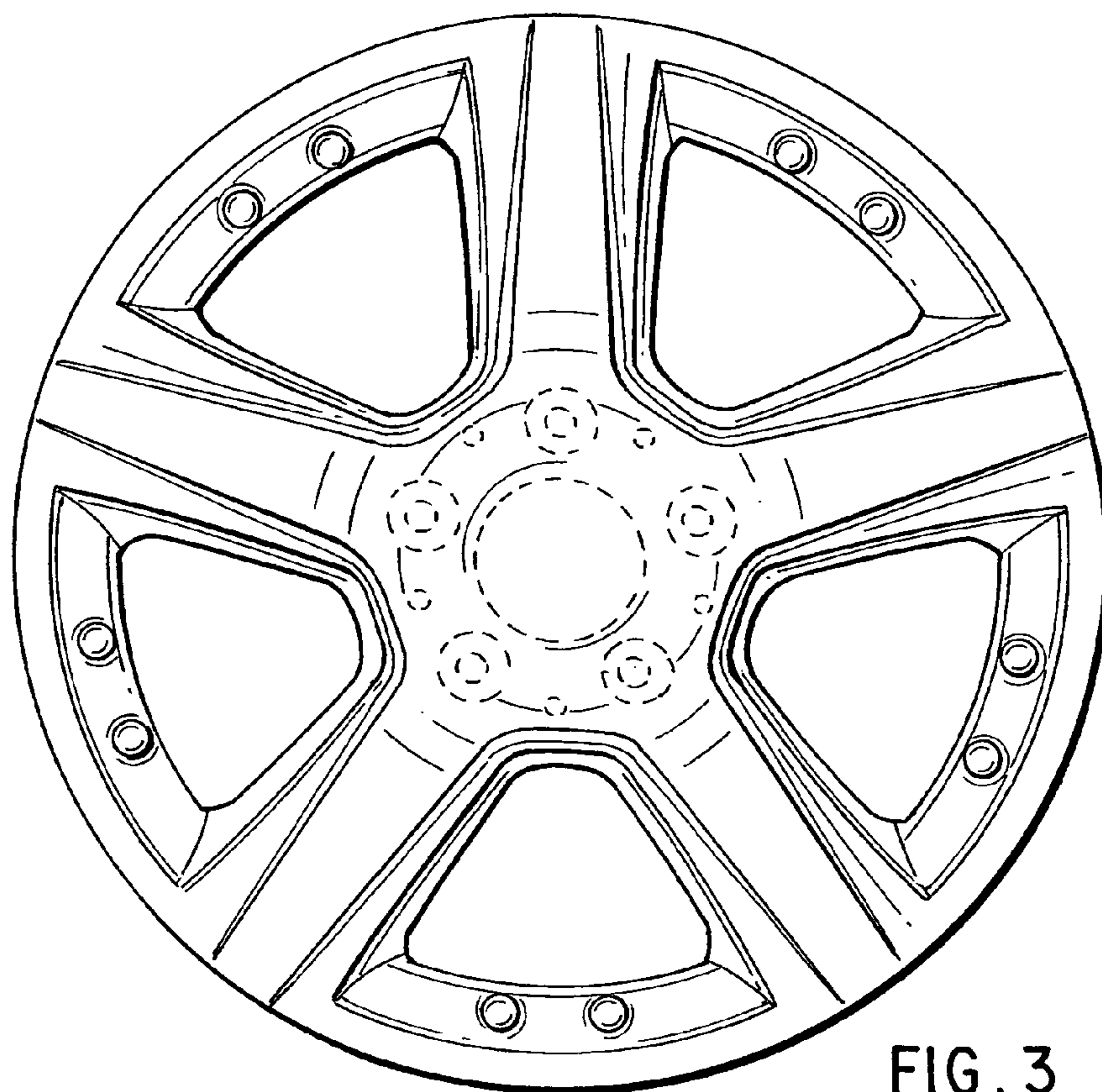

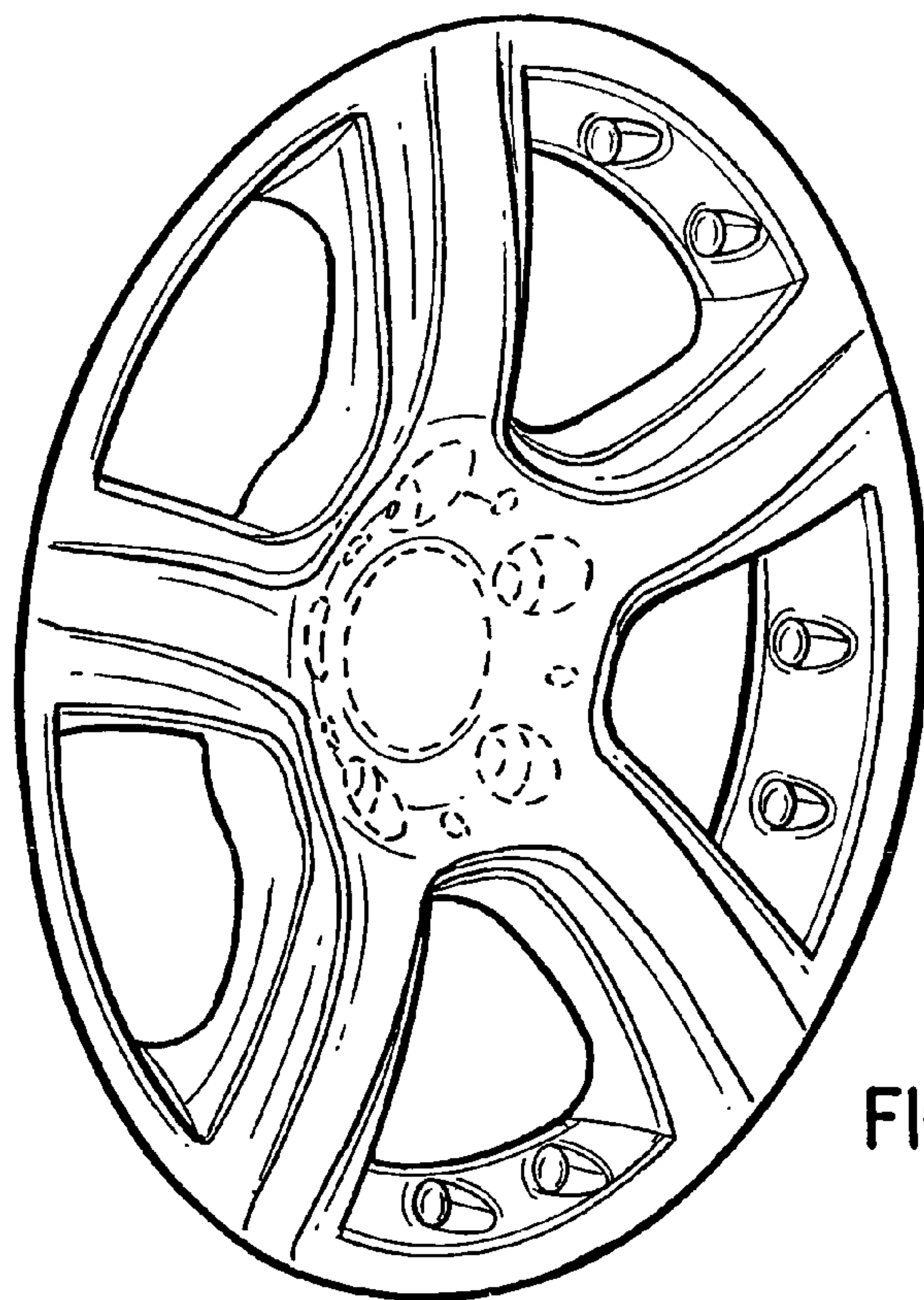
