FIG. 4 is a top view thereof, the portion shown in dotted lines is for illustrative purposes only,

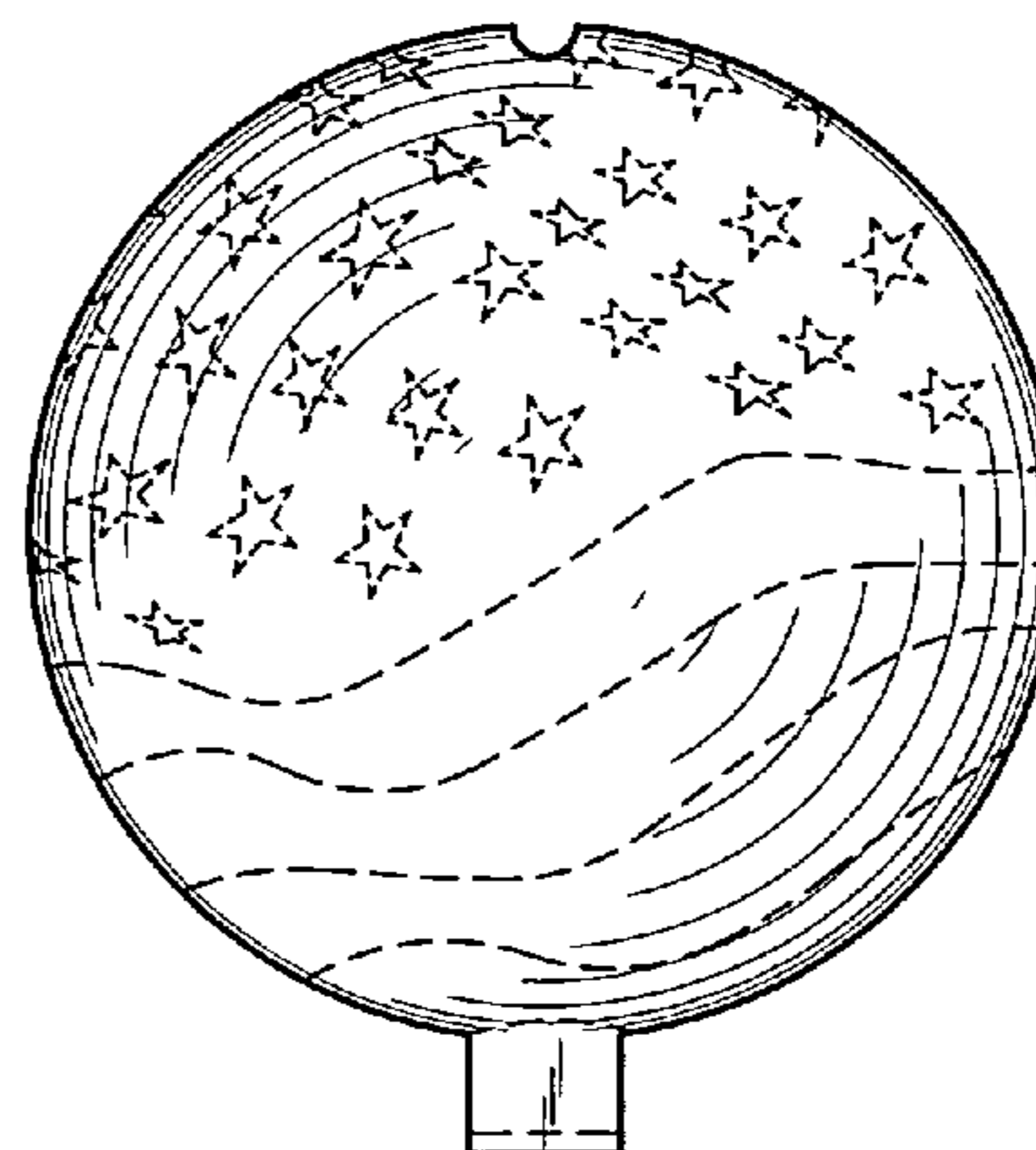
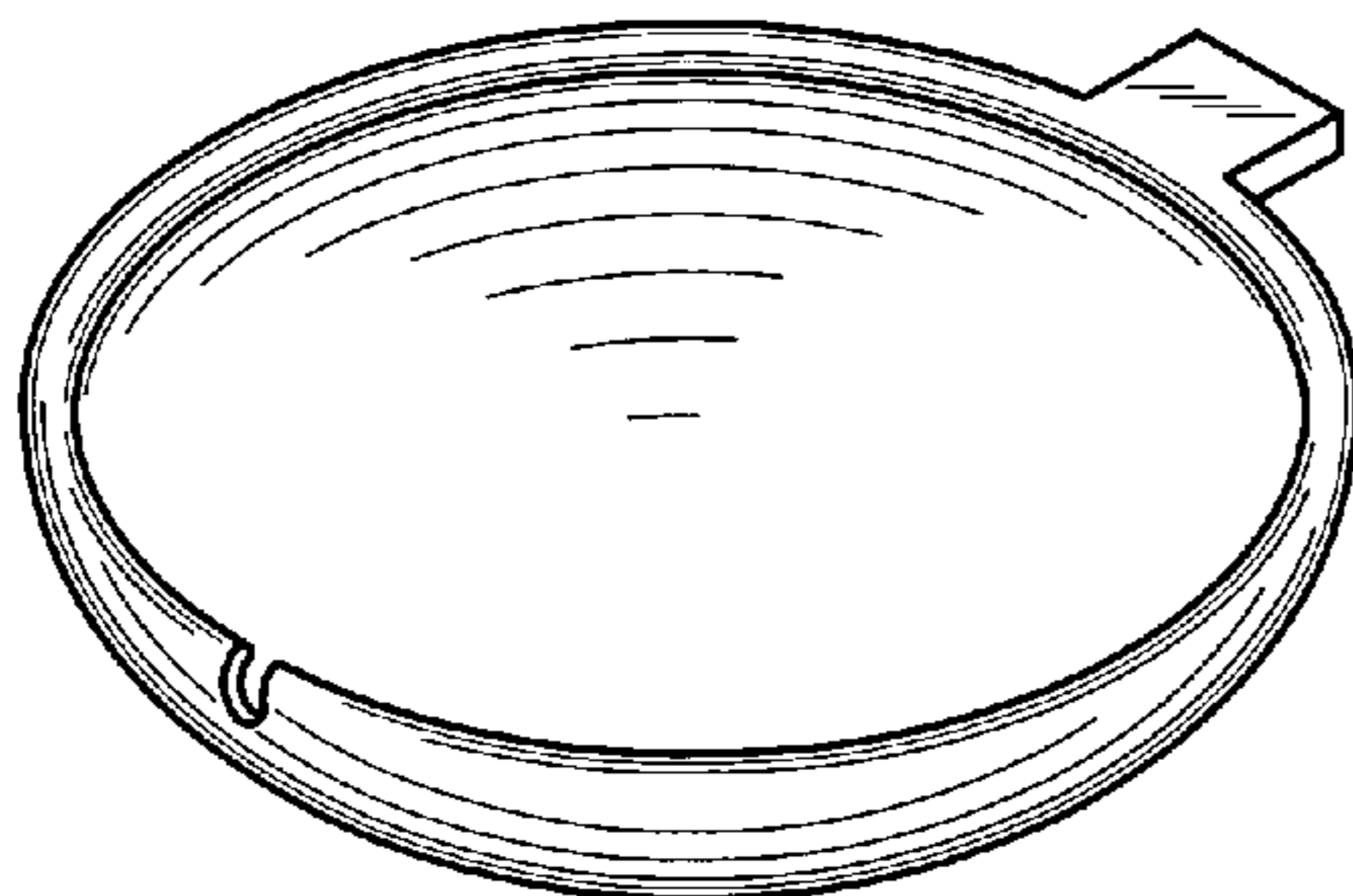
FIG. 5 is a front view thereof,

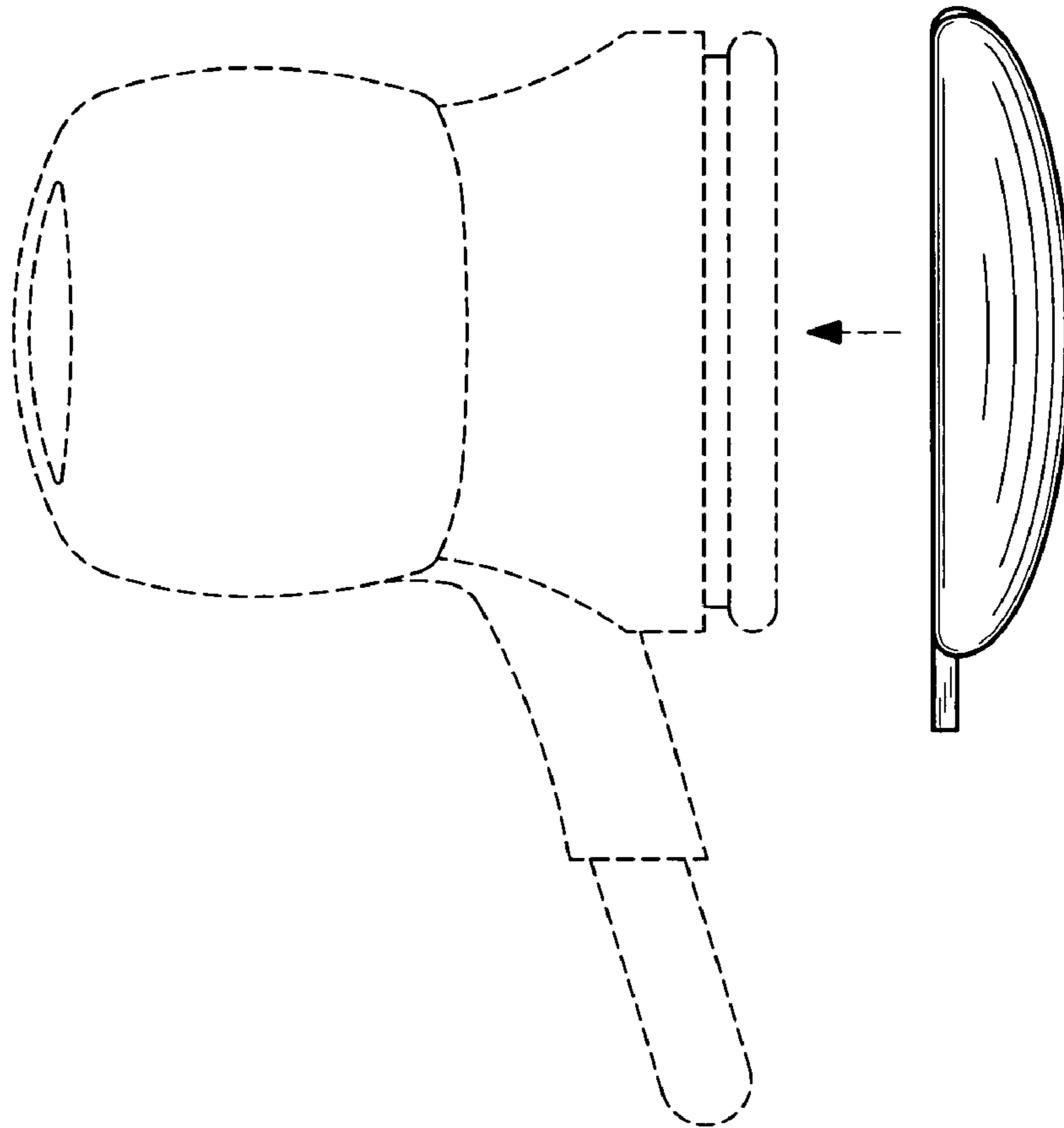

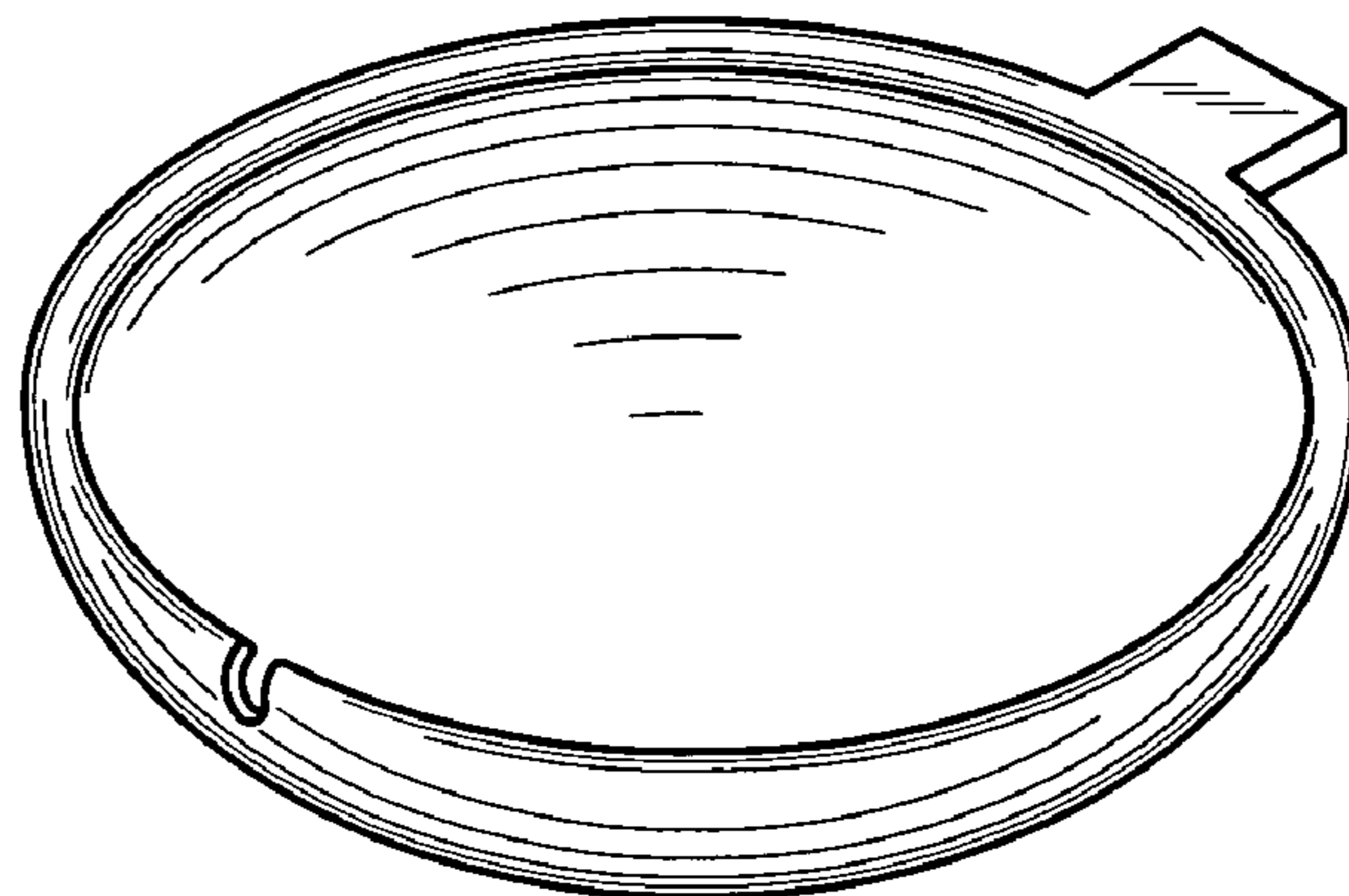

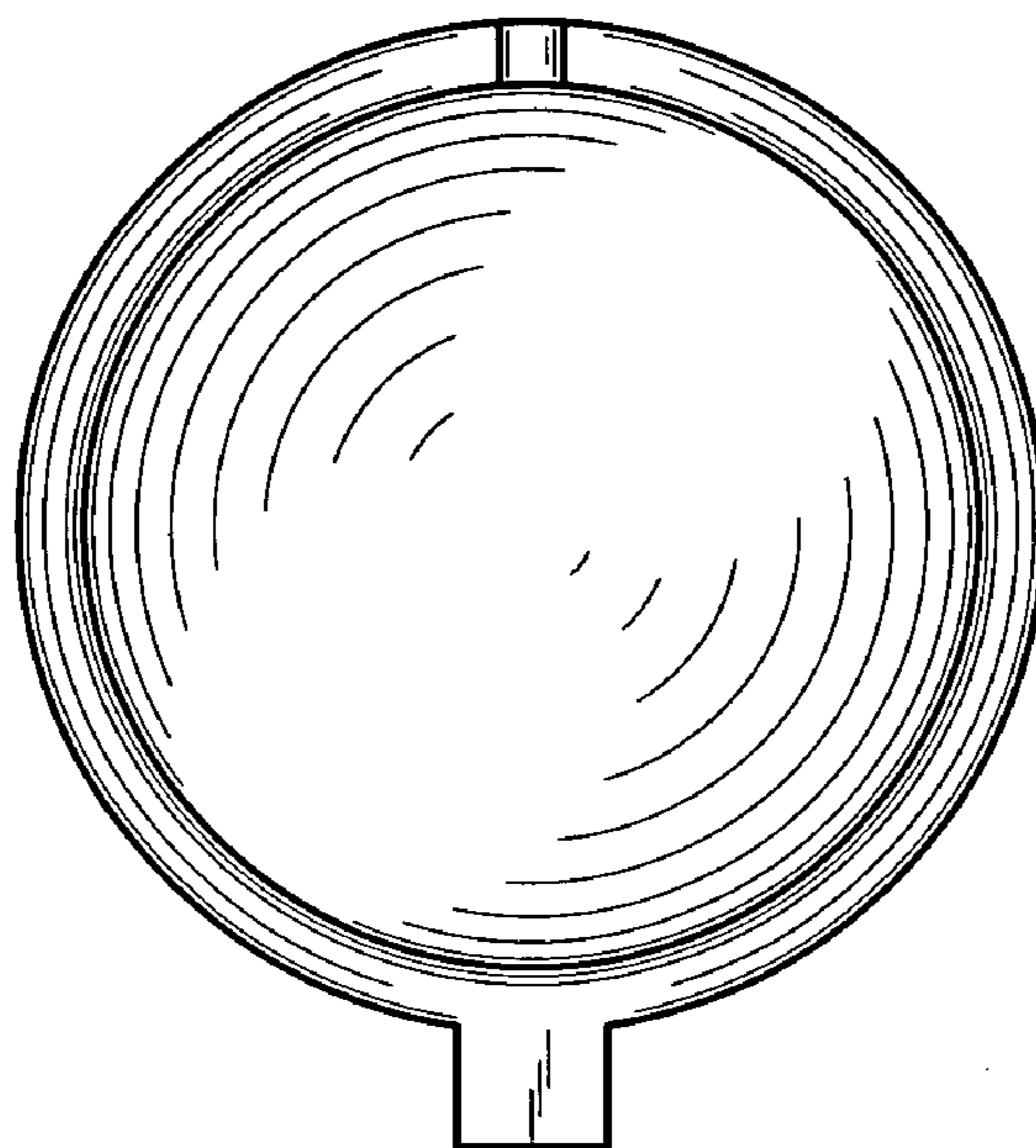

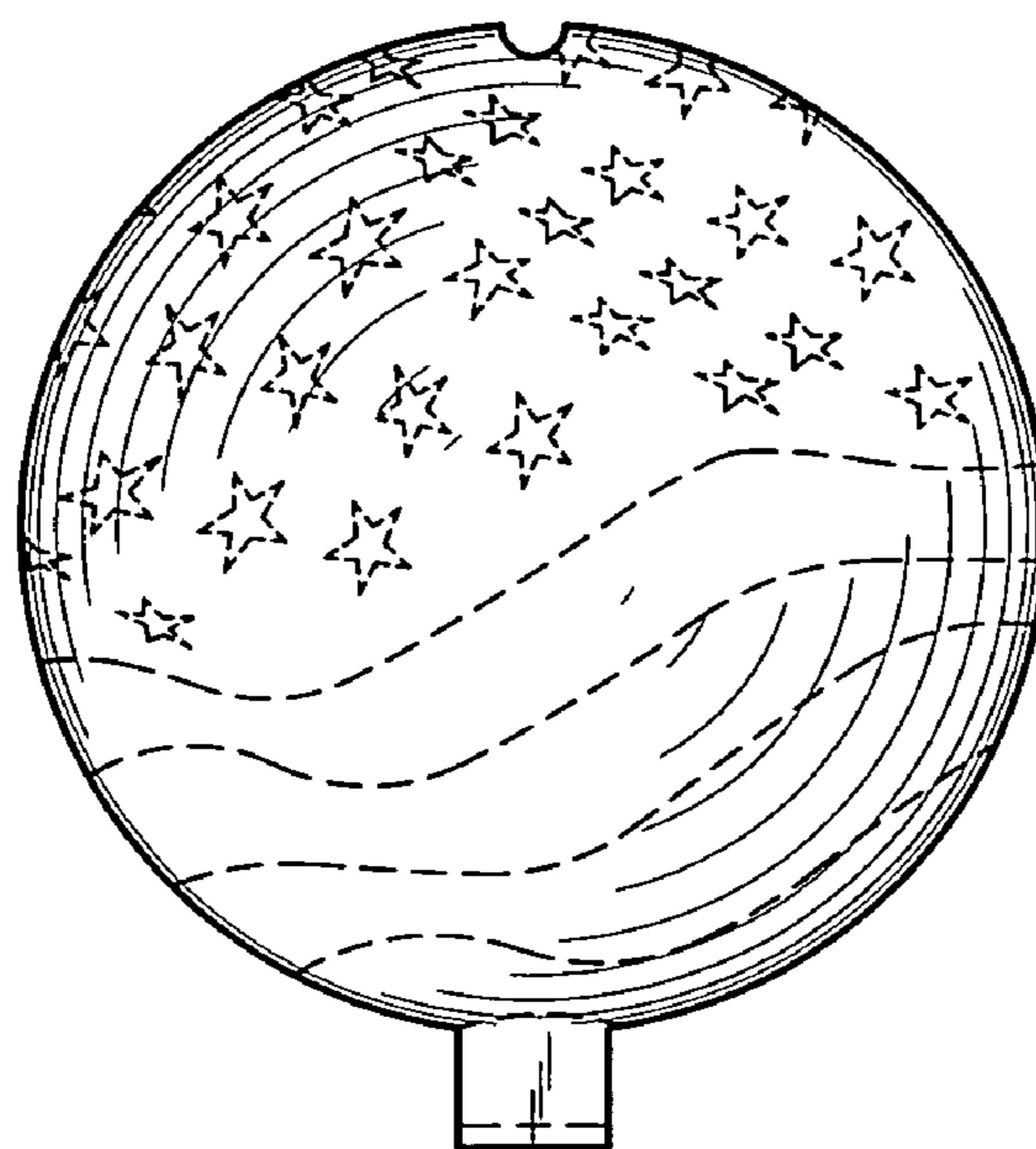
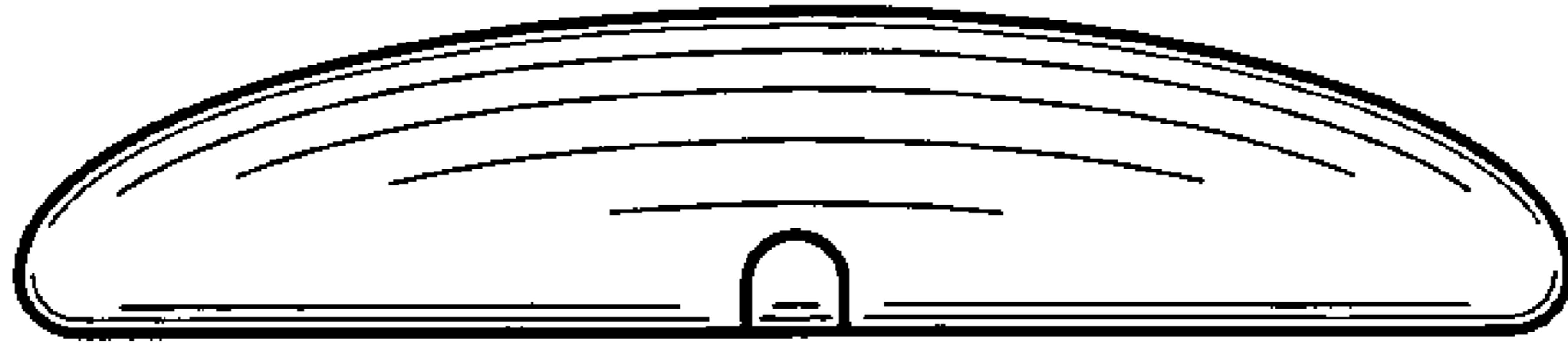
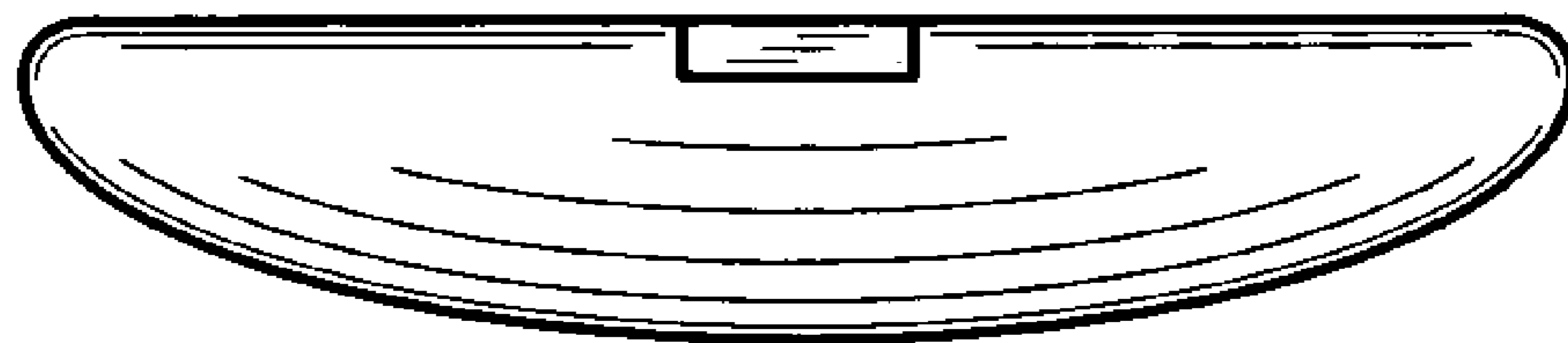

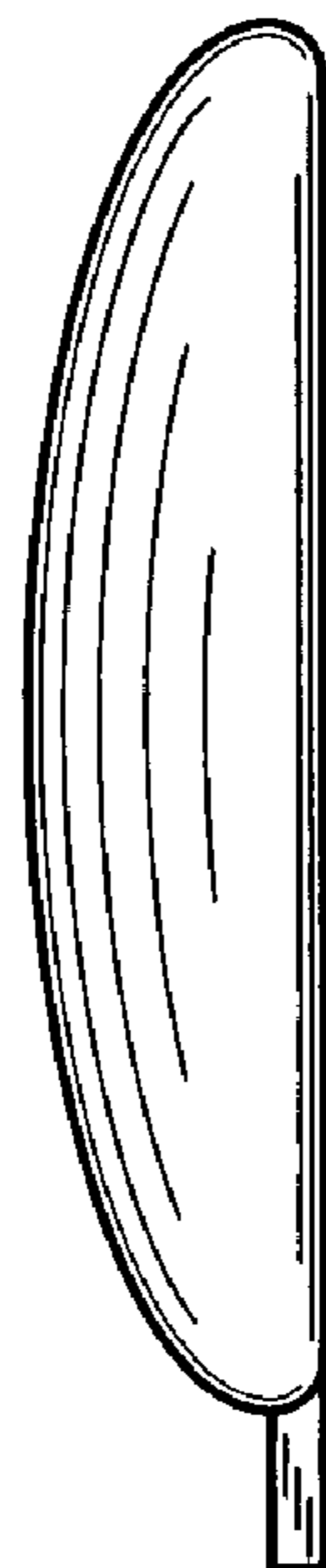

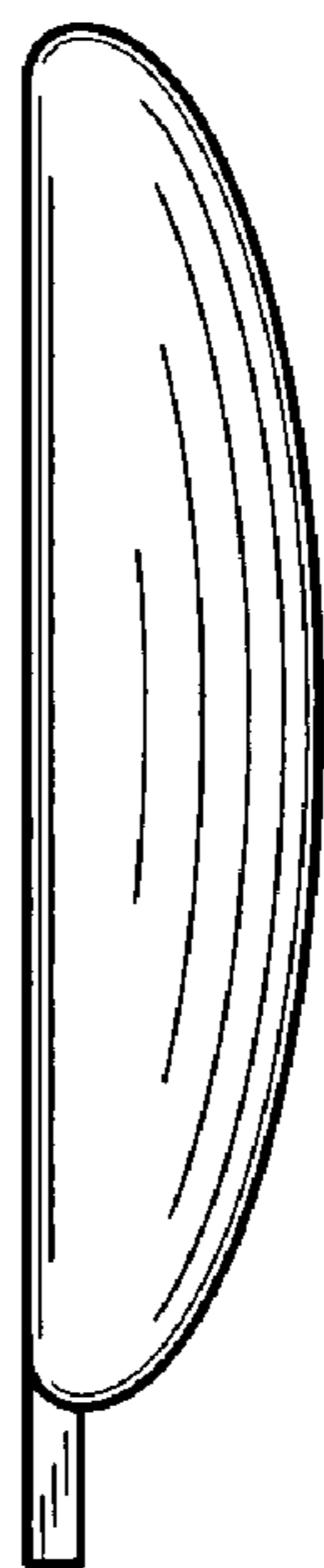
