**DESCRIPTION**

FIG. 1 is a front view of a spade type boring bit;

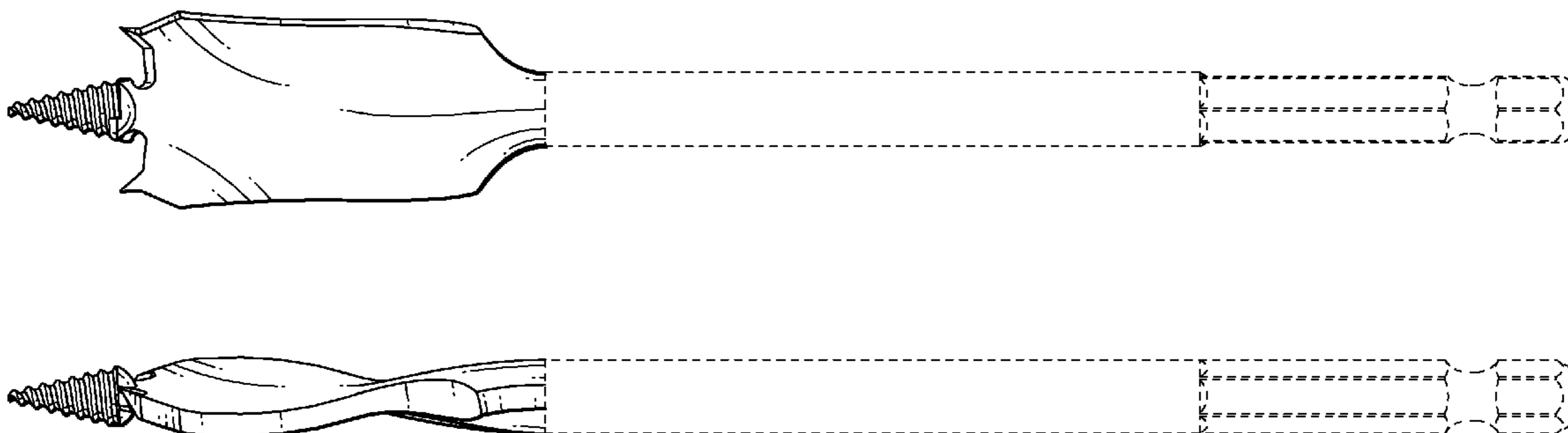
FIG. 2 is a left side elevation view of the spade type boring bit shown in FIG. 1;

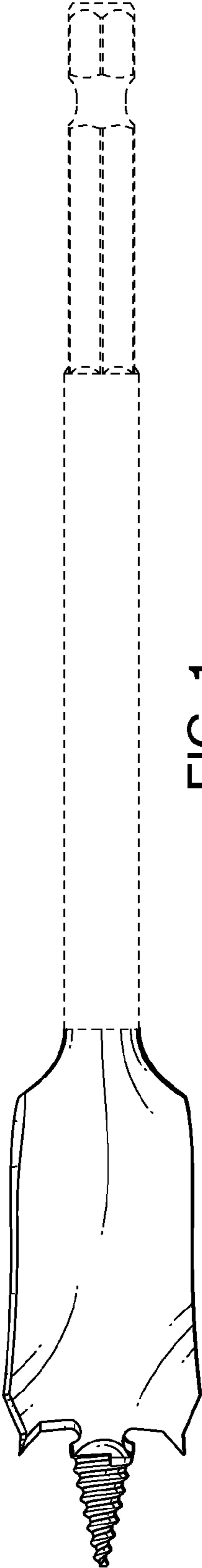

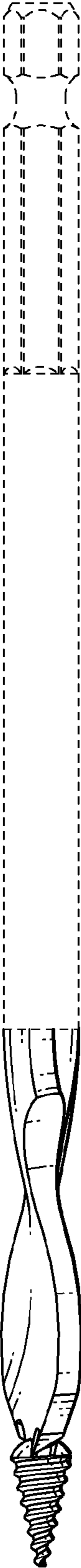

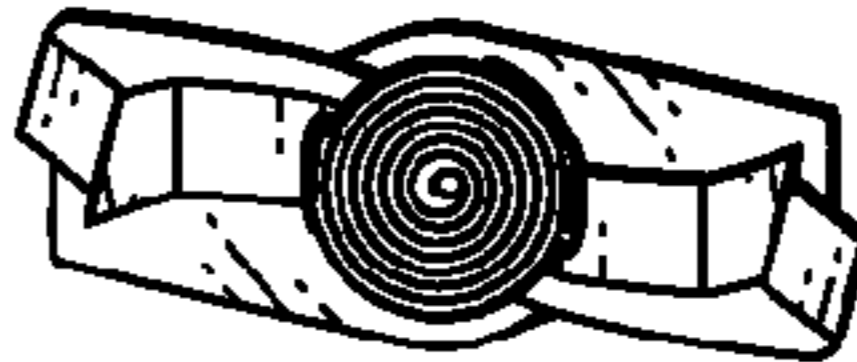

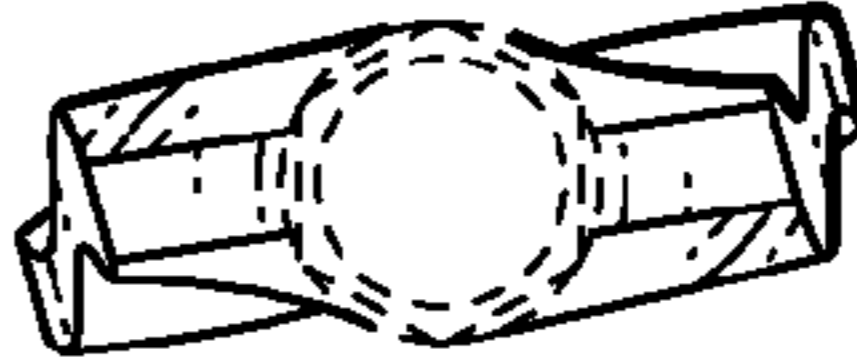
