FIG. 2 is a rear perspective view thereof;

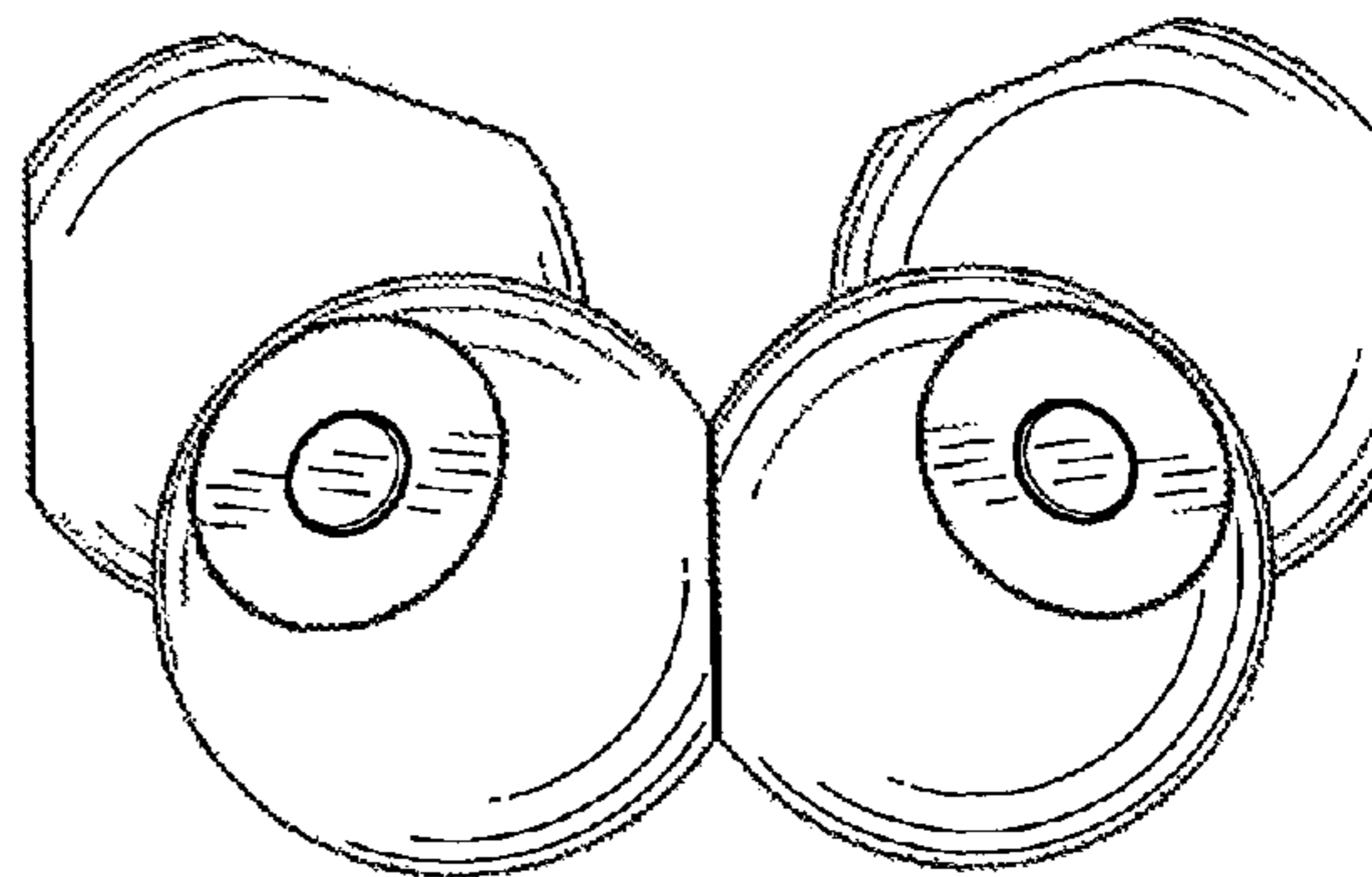
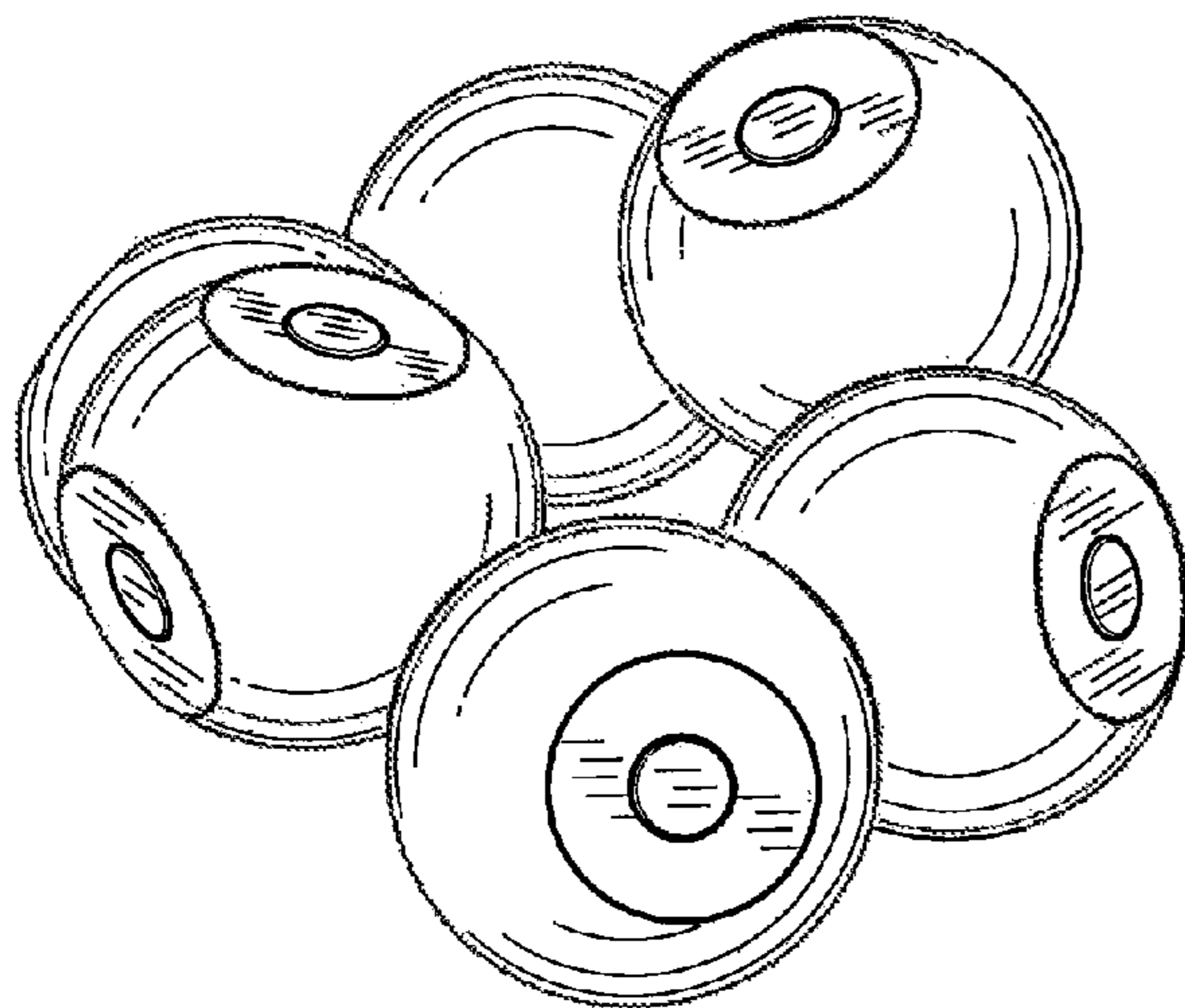
FIG. 3 is a left side view thereof (the right side view is a mirror image);

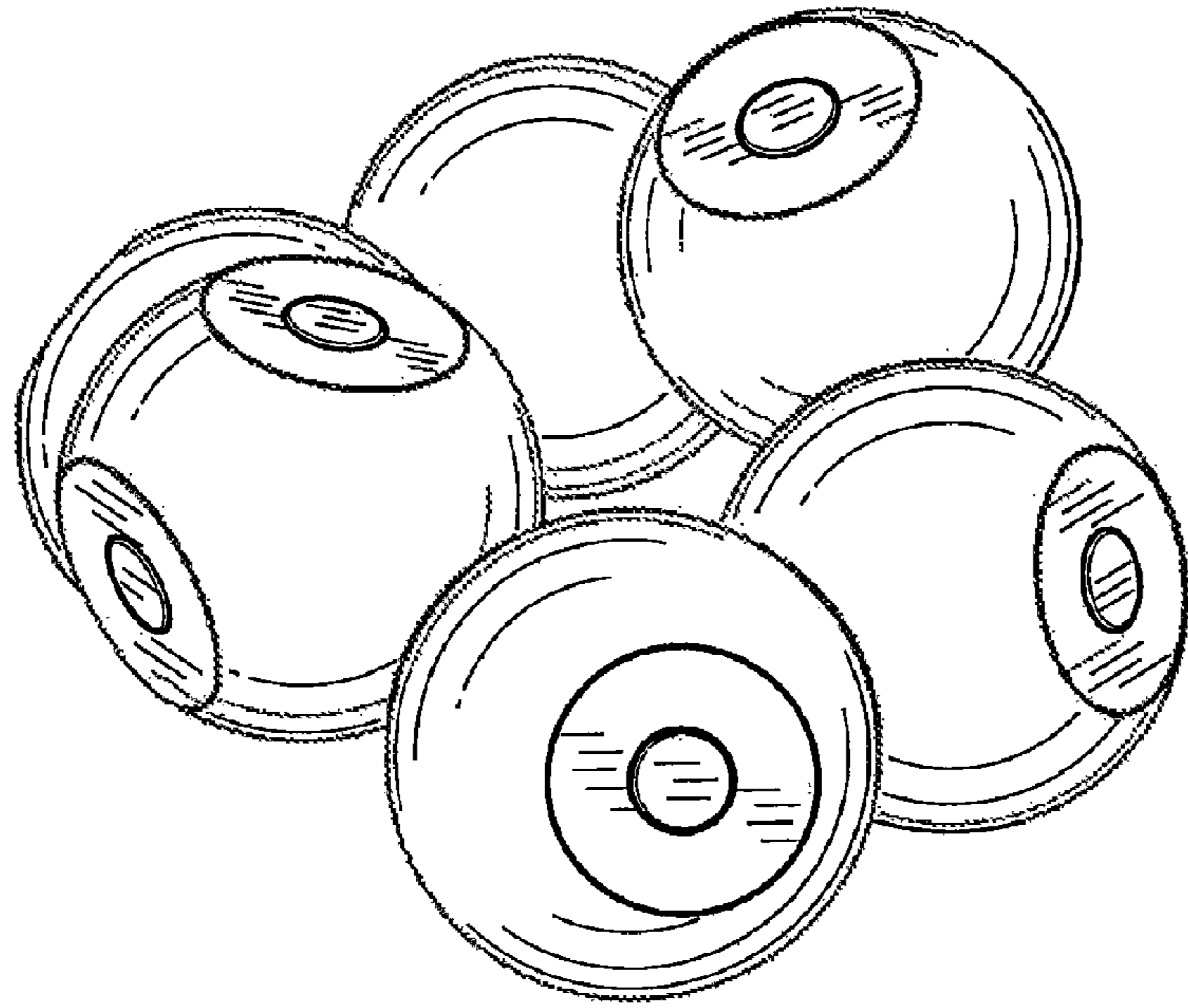

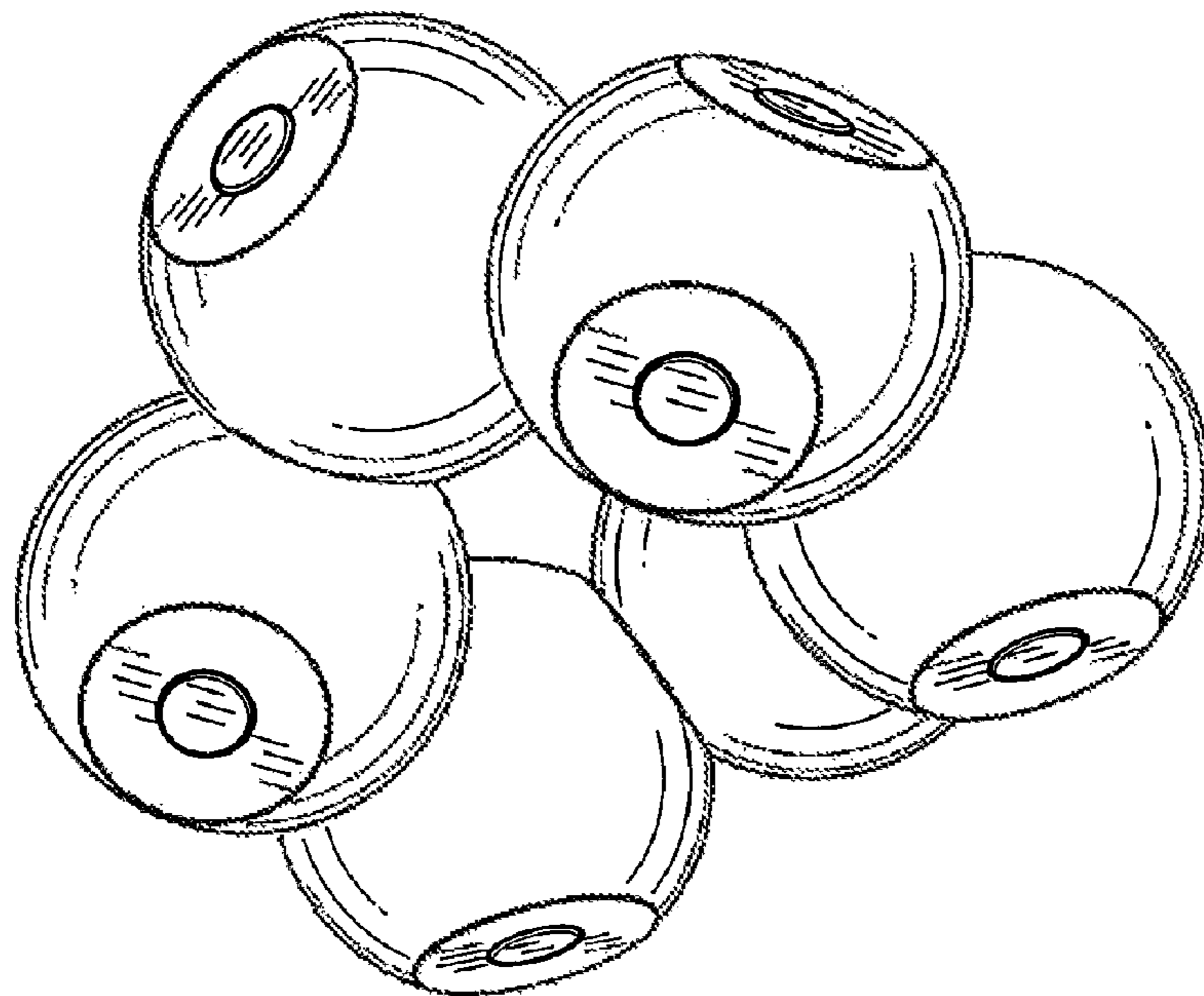

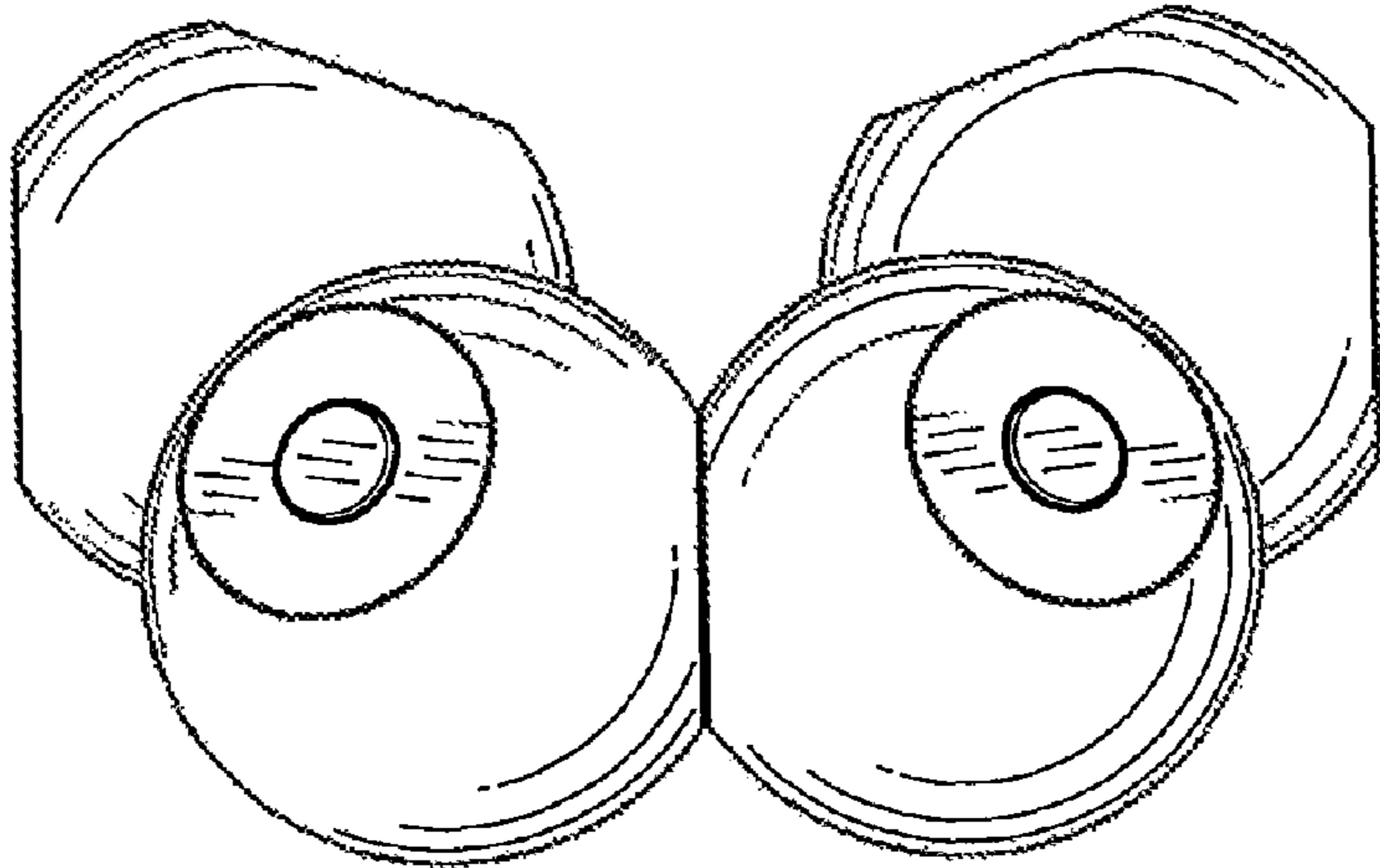

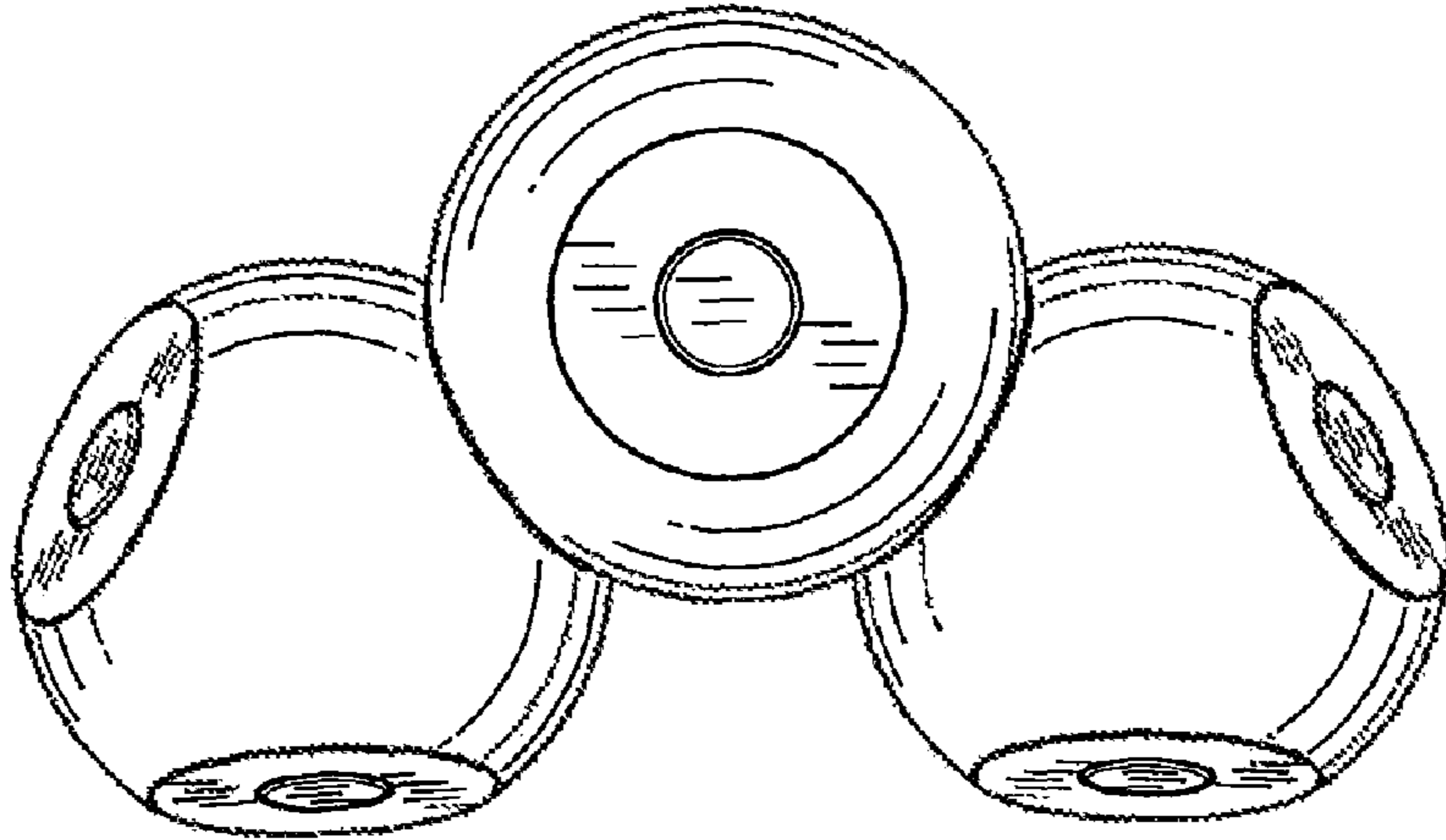

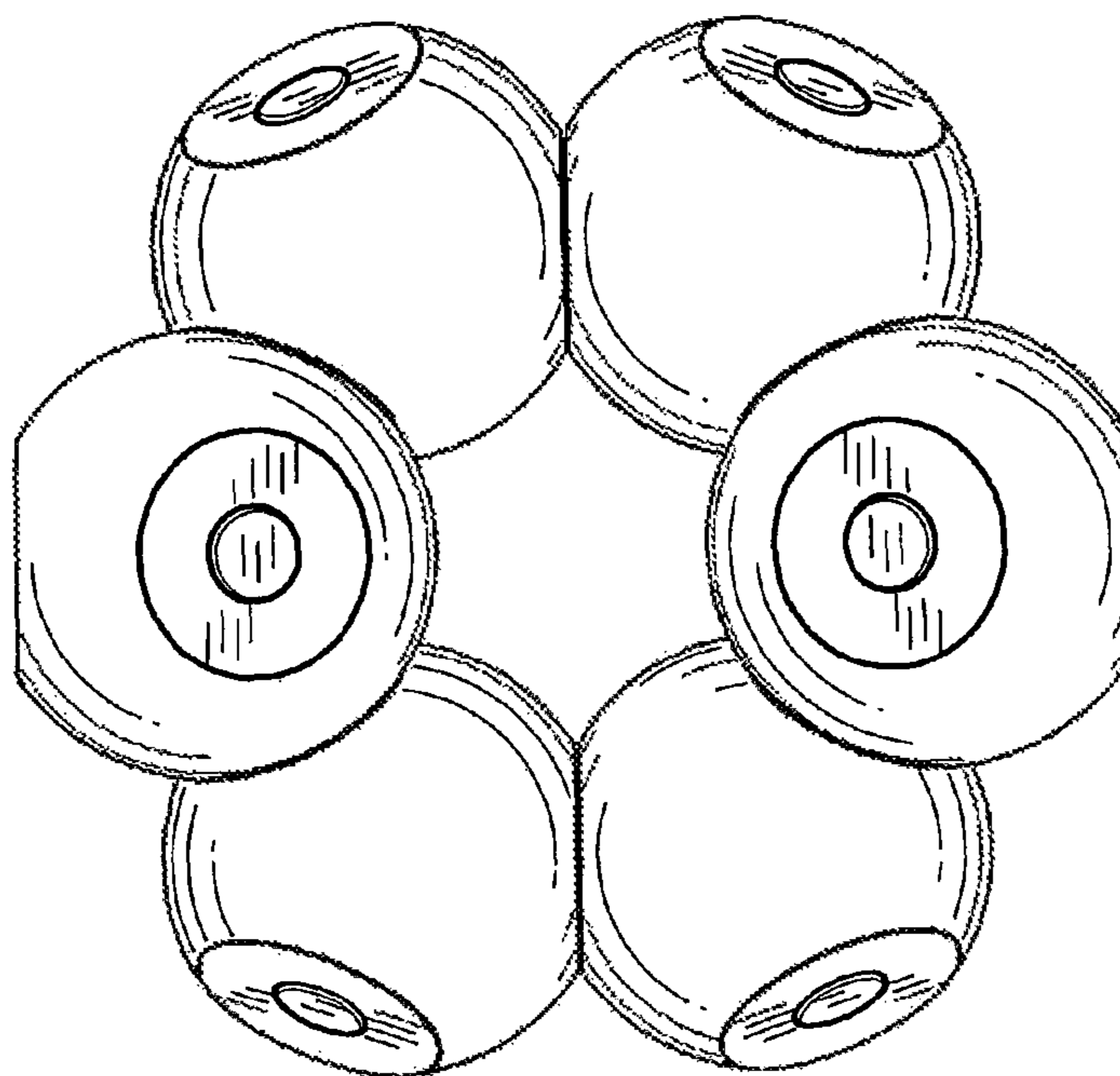

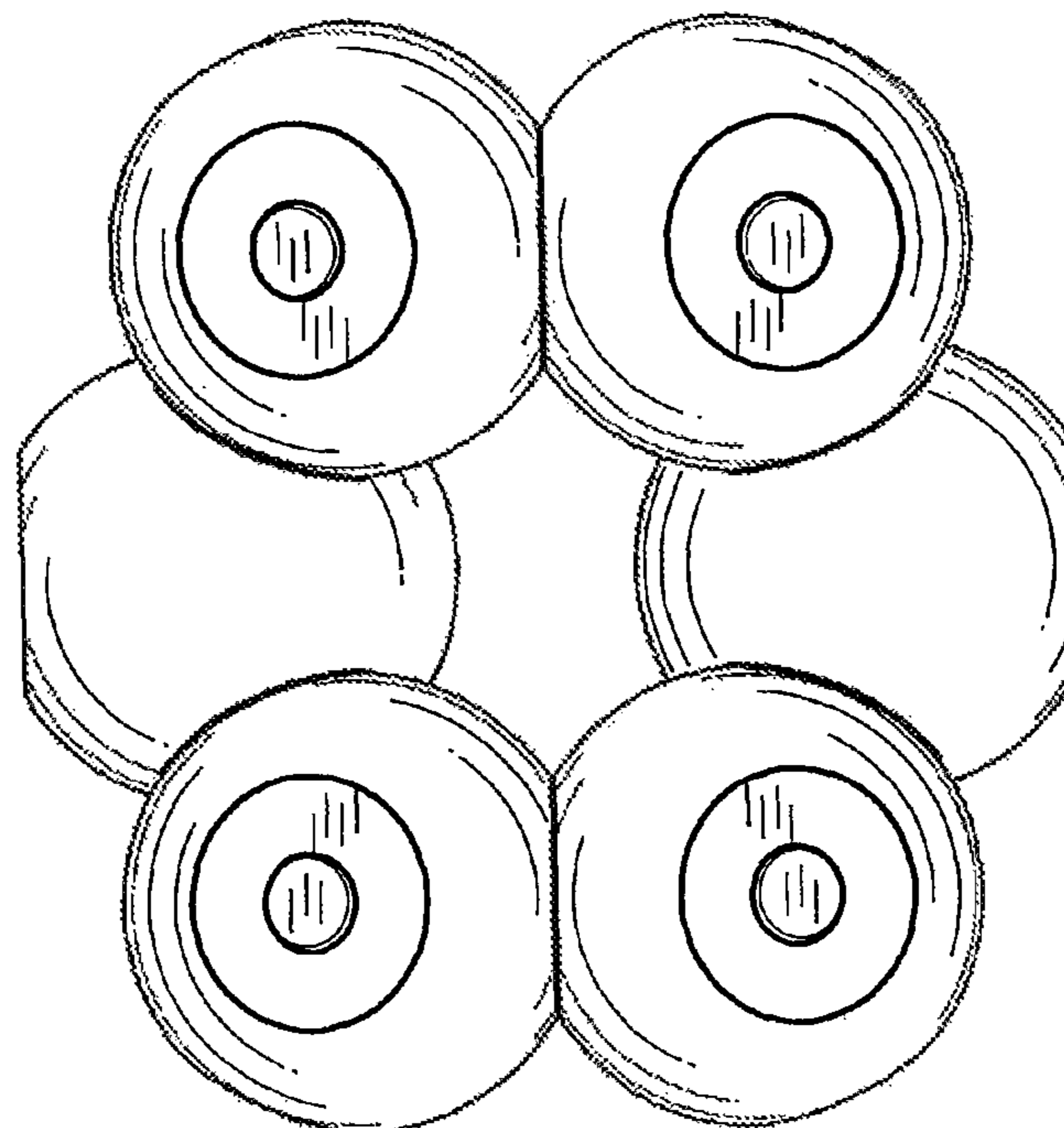
