FIG. 4 is a toe-side elevational view thereof.

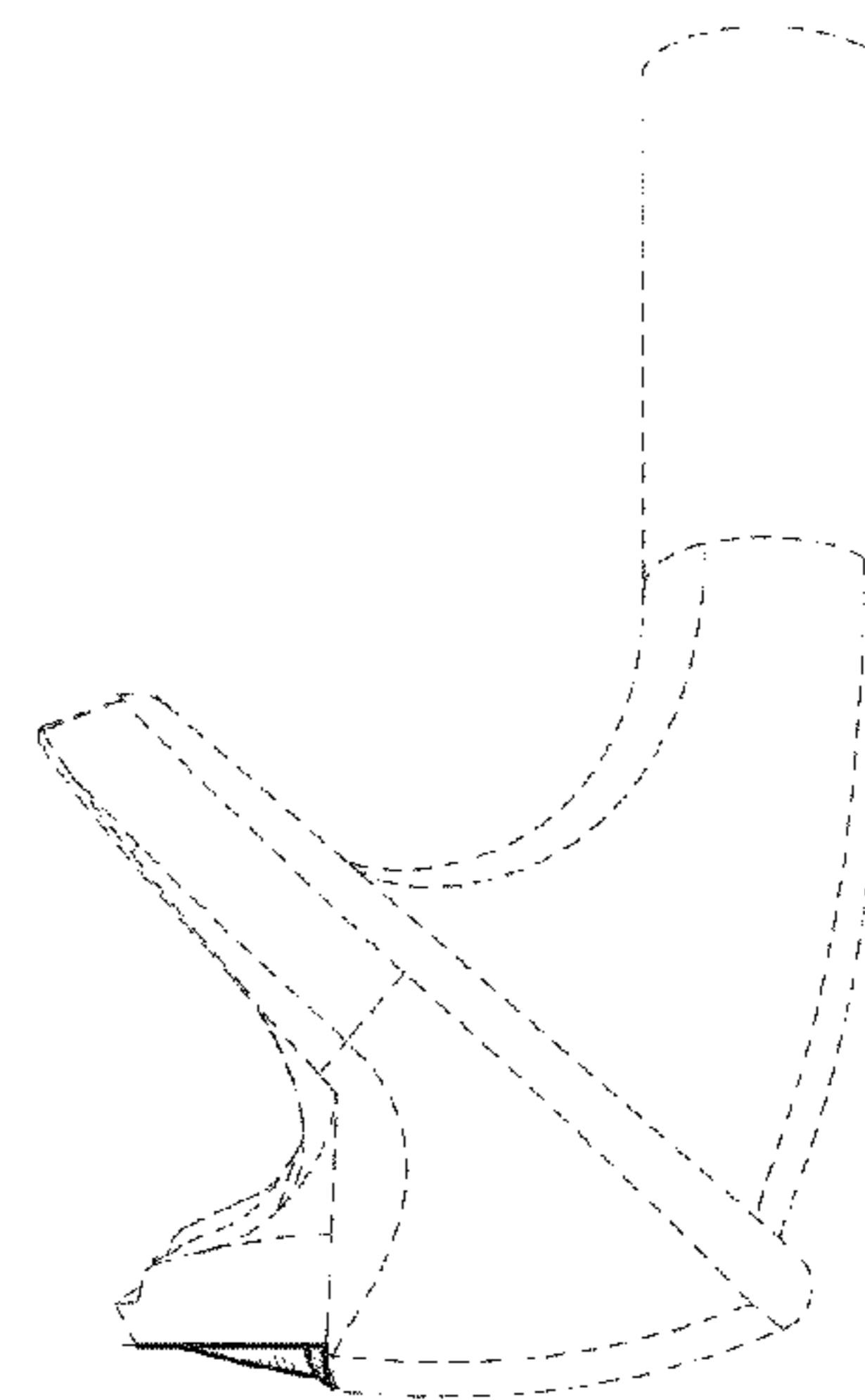
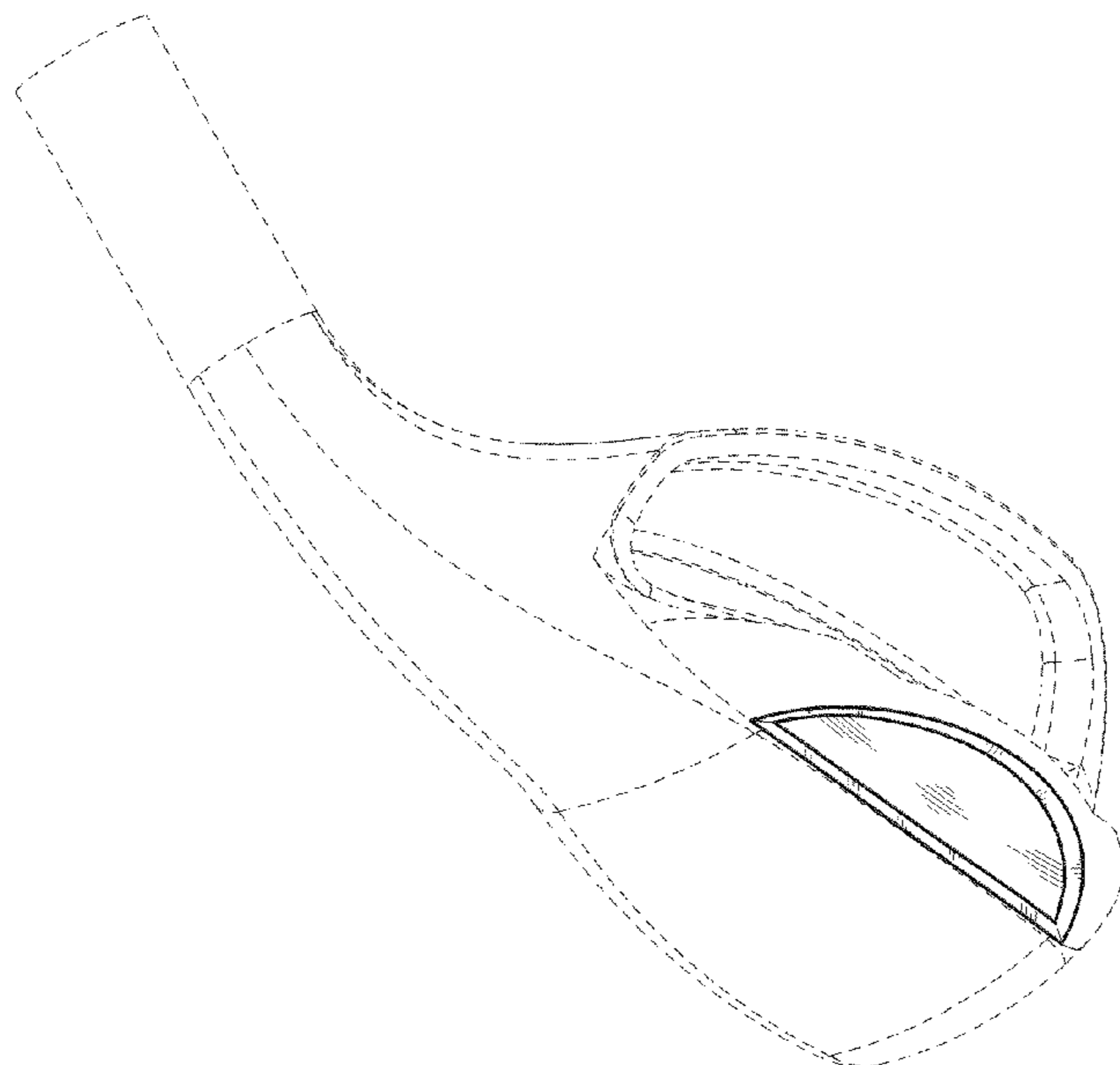
FIG. 5 is a heel-side elevational view thereof.

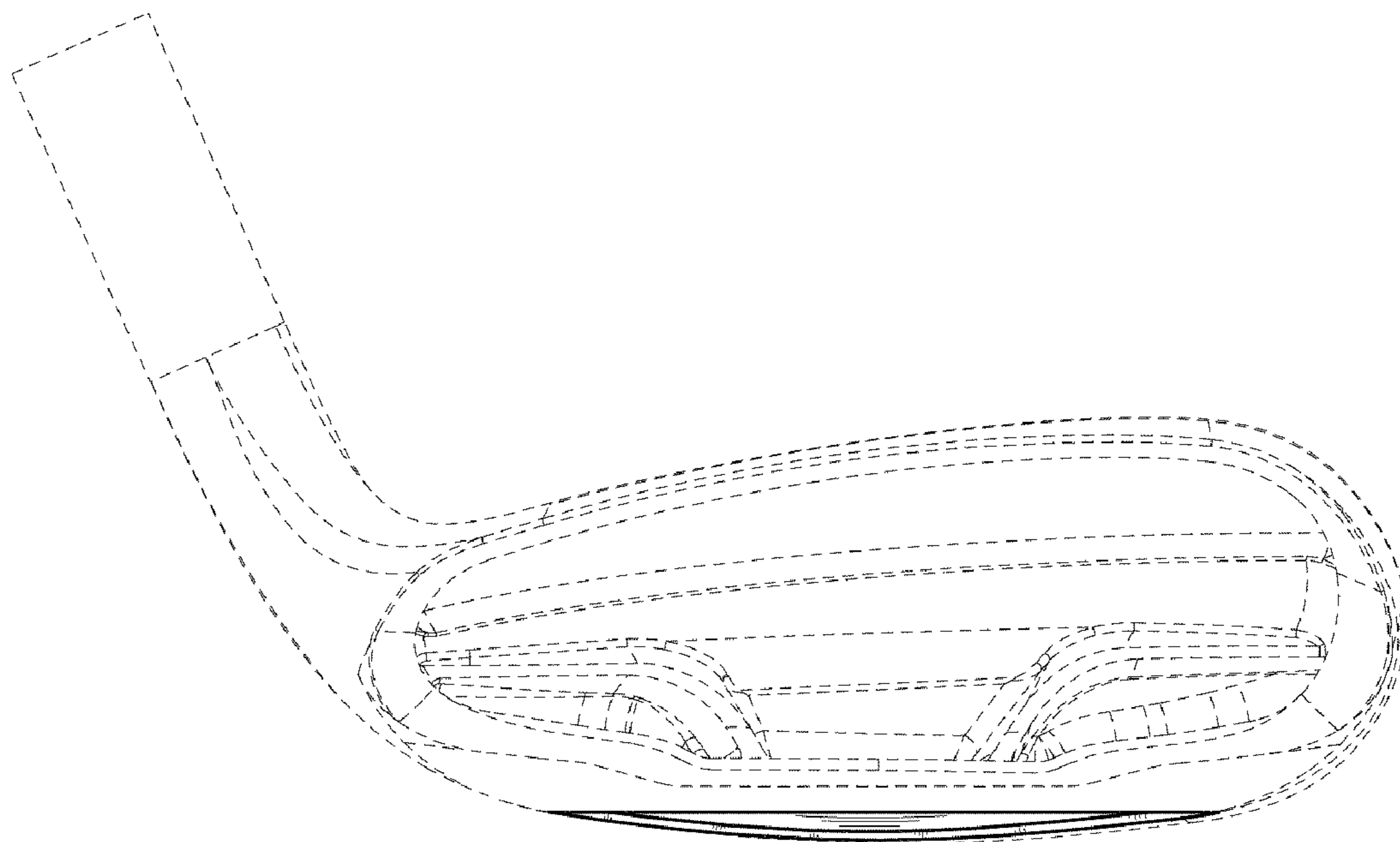

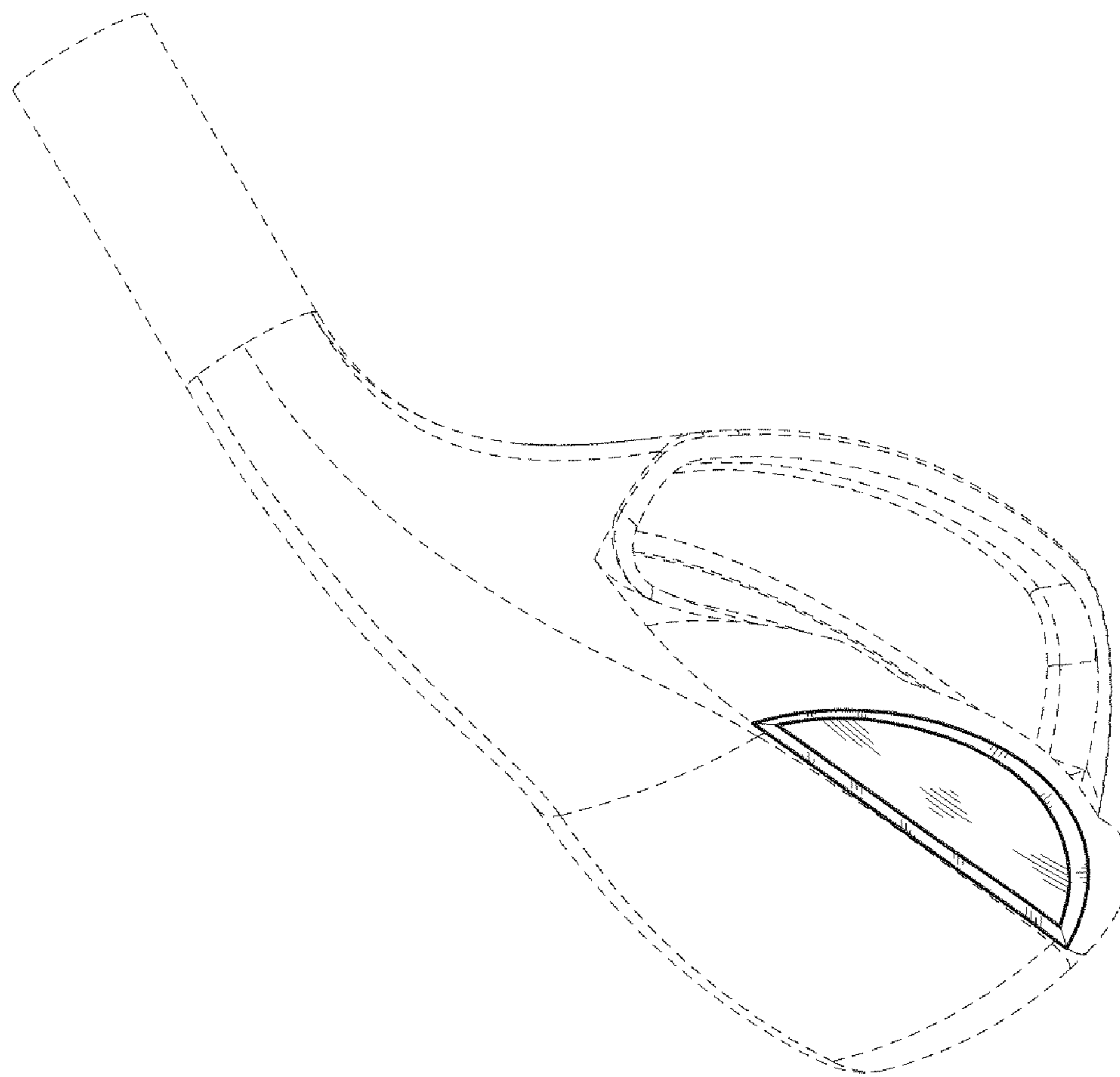

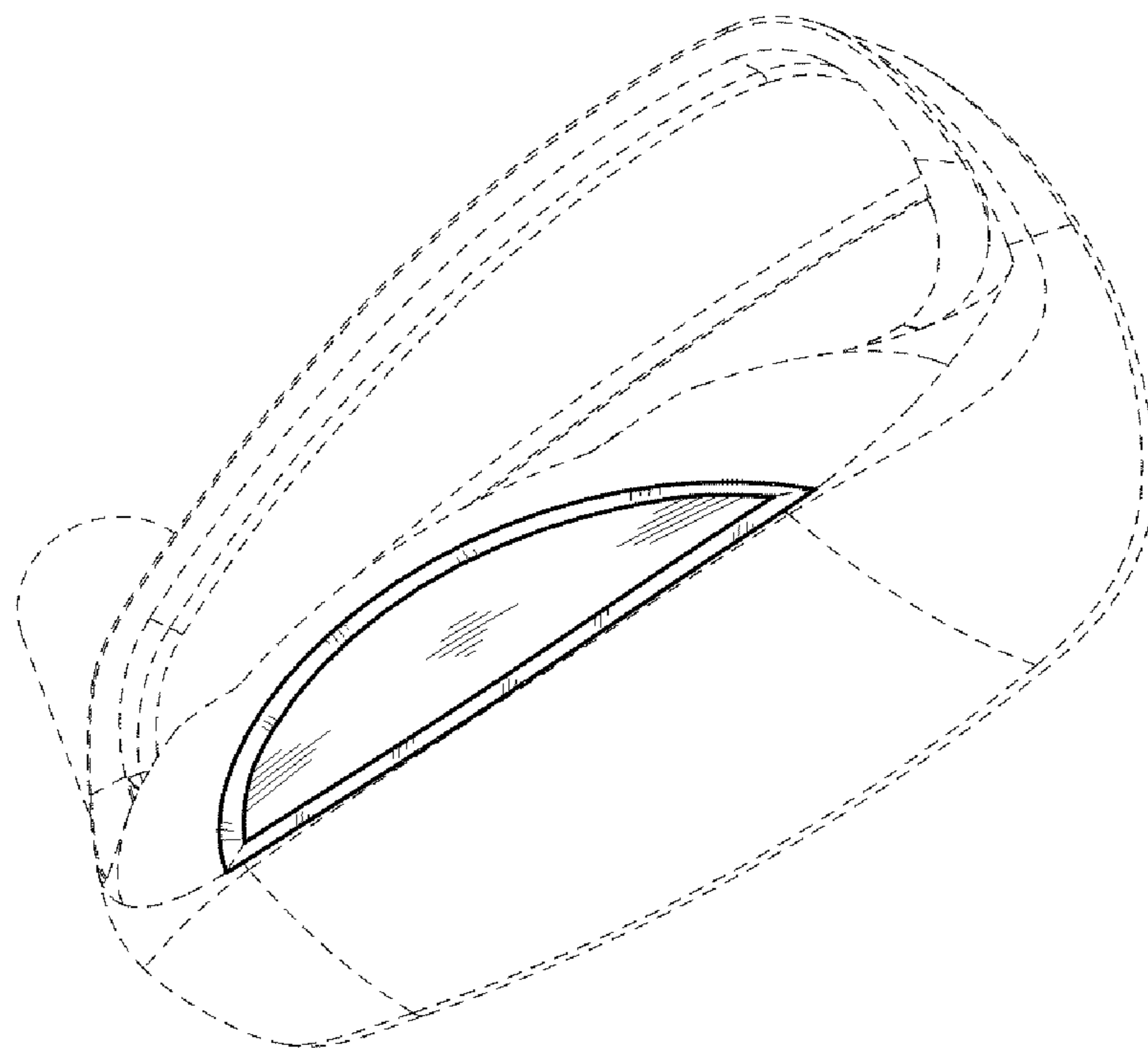

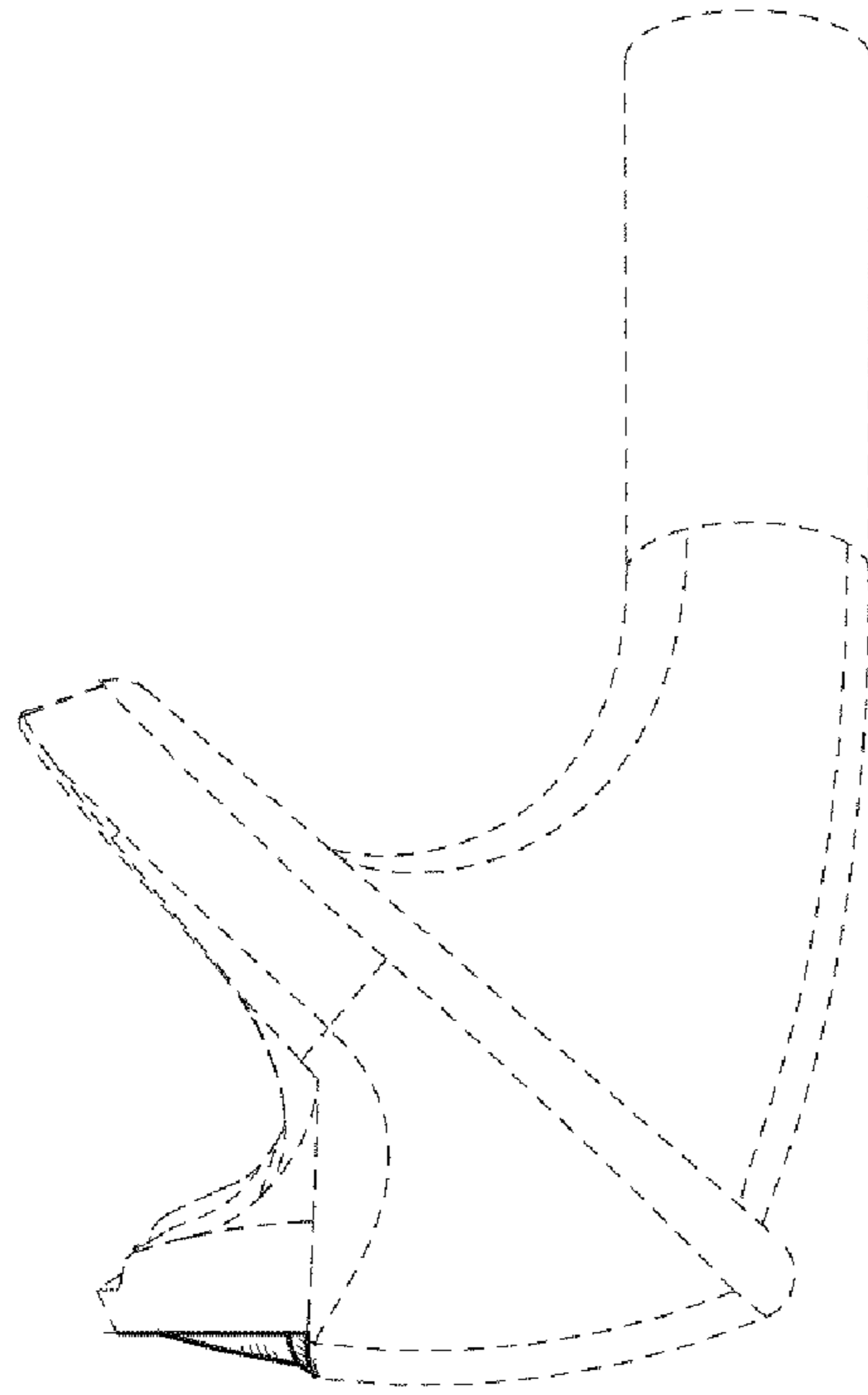

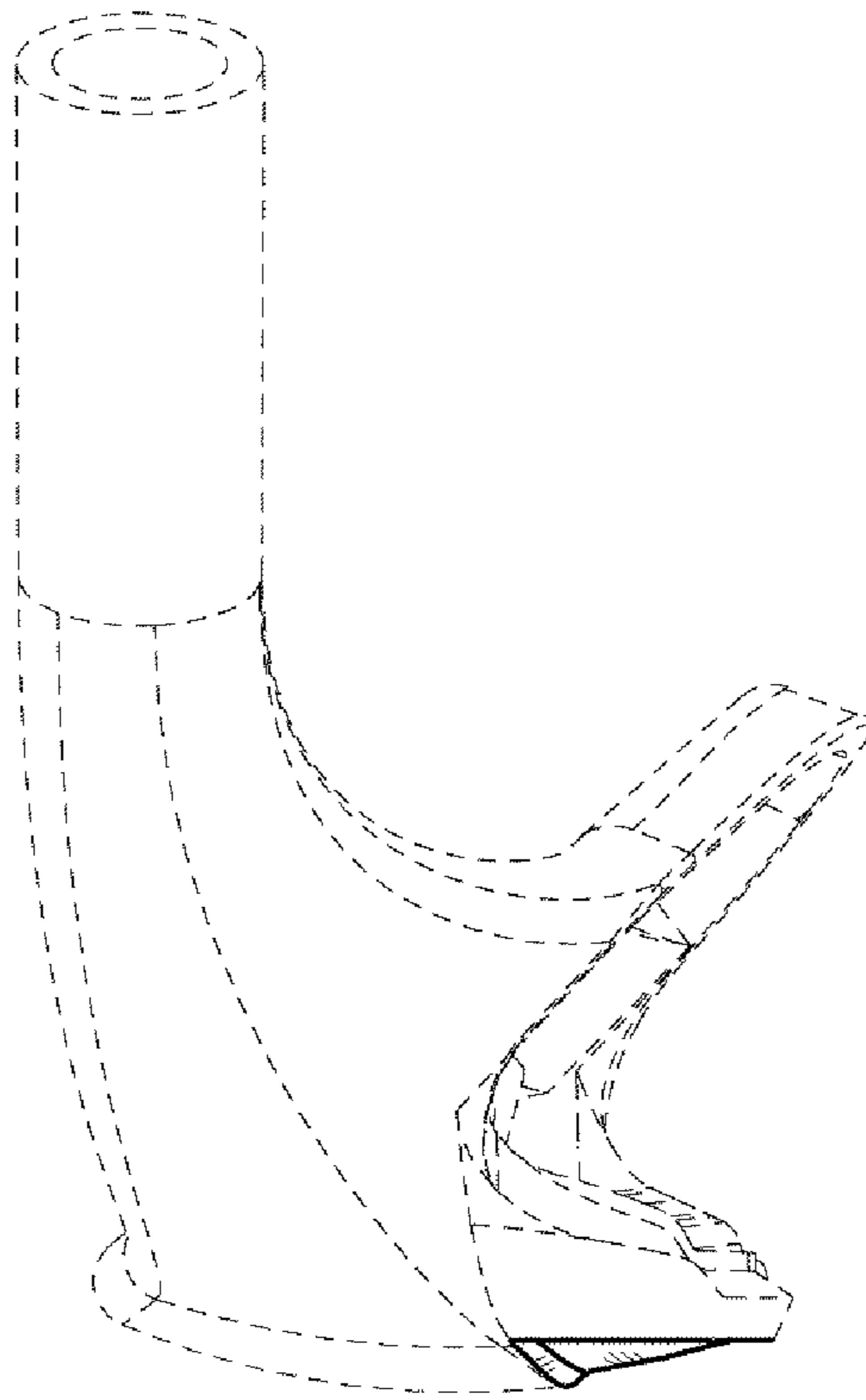

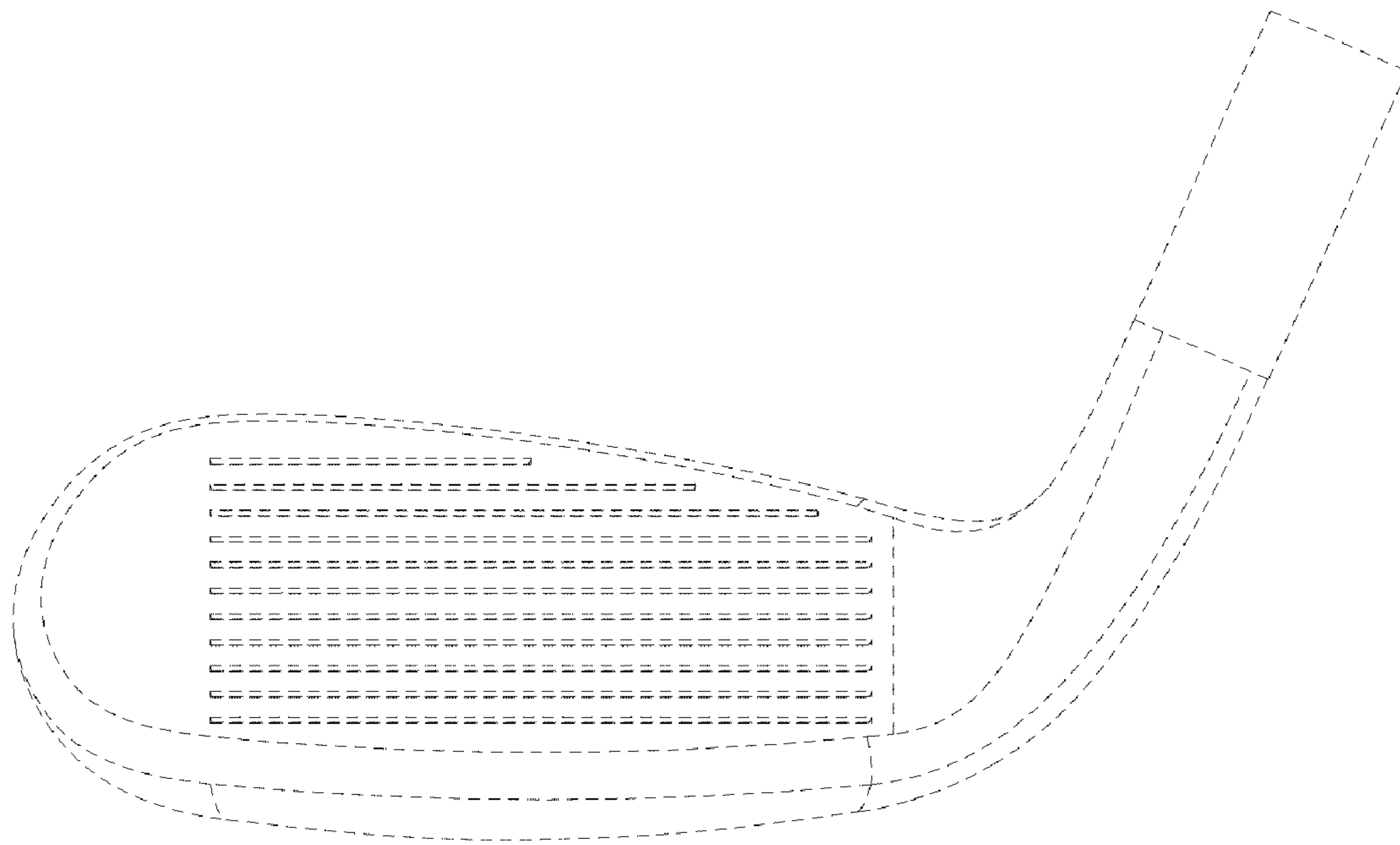

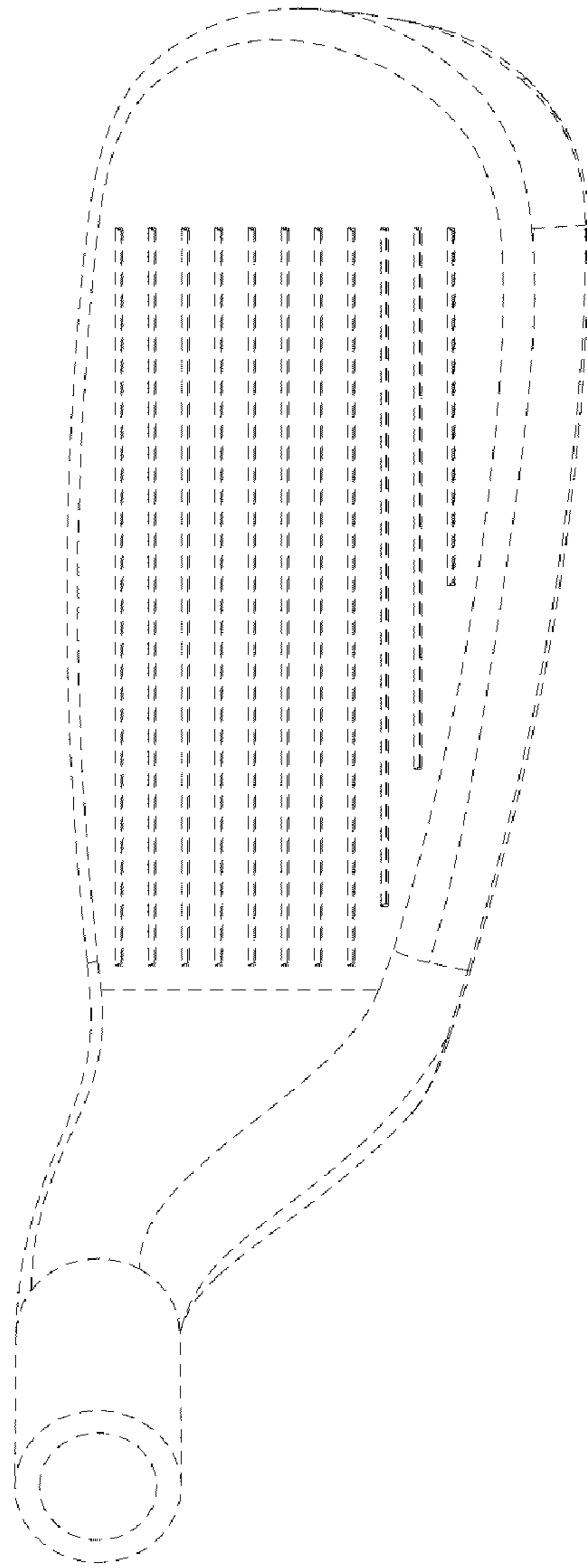
