The ornamental design for a table for nursing of babies, substantially as shown and described.

**DESCRIPTION**

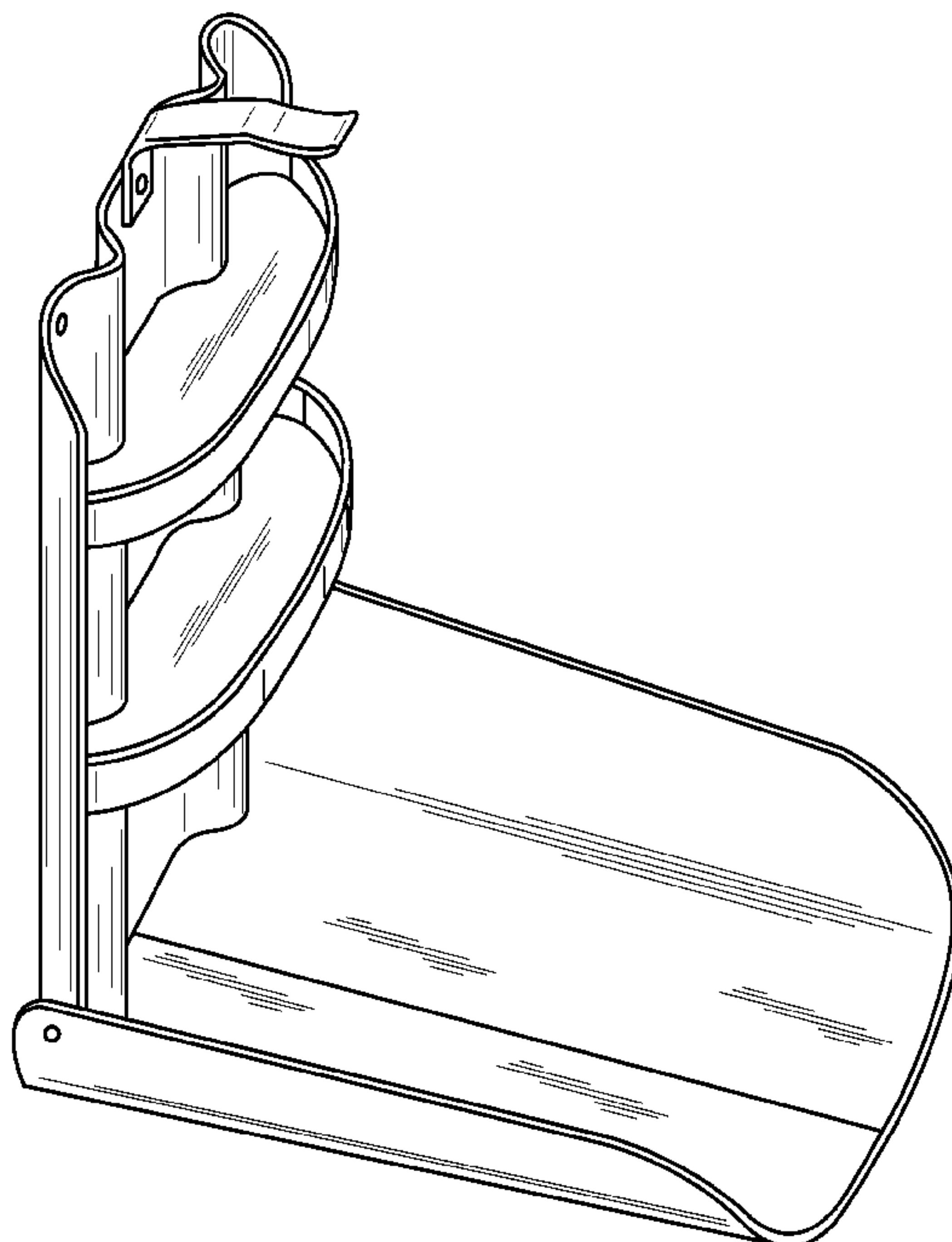
FIG. 1 is an inclined perspective view towards the front, from above of the table for nursing of babies of the present invention, in the open position.

FIG. 2 is an inclined perspective view towards the front, from above of the table for nursing of babies of the present invention, in the closed position.

FIG. 3 is a front elevational view of the table for nursing of babies of the present invention in the closed position. The broken lines are included for the purpose of illustrating a portion of the table for nursing of babies that forms no part of the claimed design; and,

FIG. 4 is a rear elevational view of the table for nursing of babies of the present invention in the open position. The broken lines are included for the purpose of illustrating a portion of the table for nursing of babies that forms no part of the claimed design.

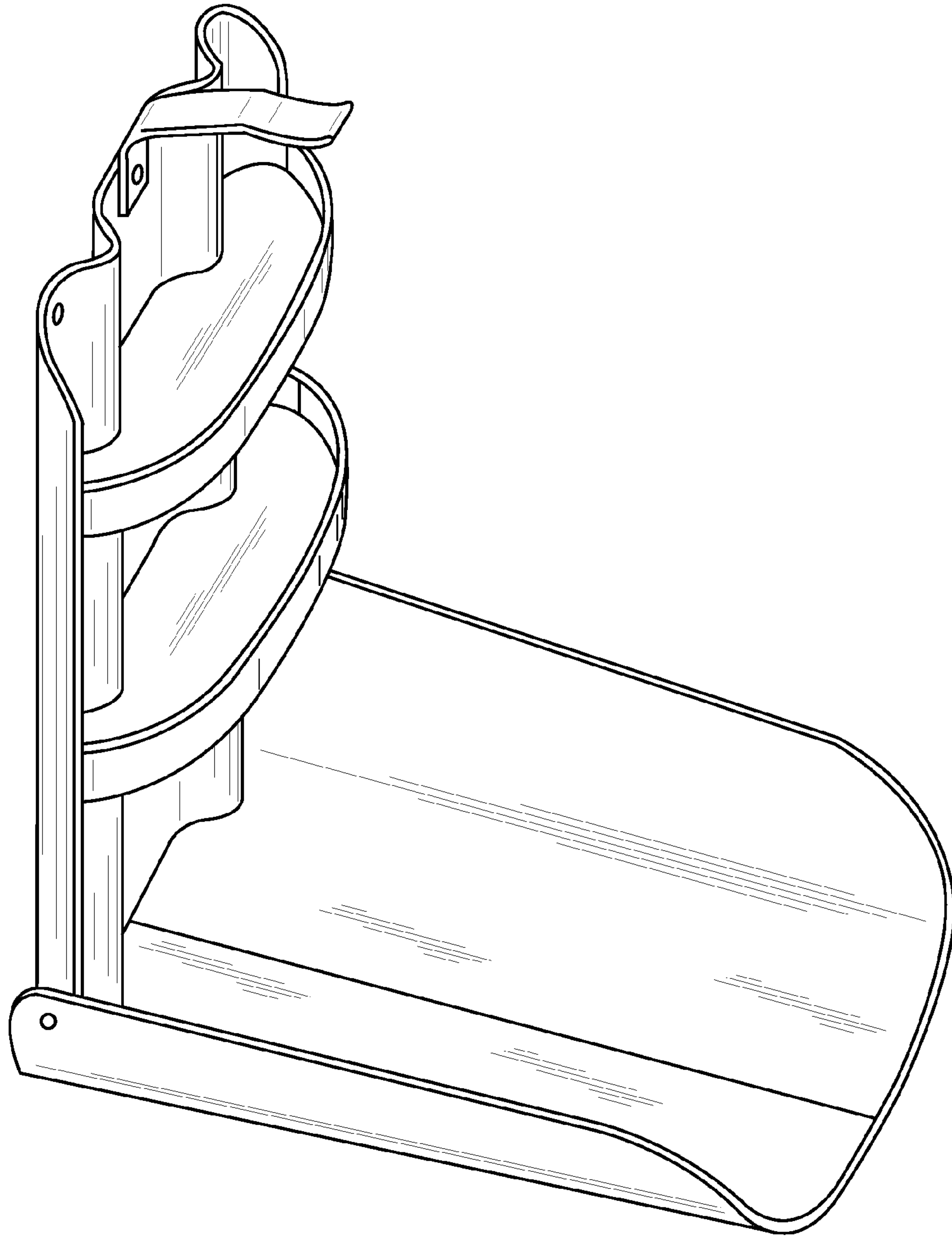

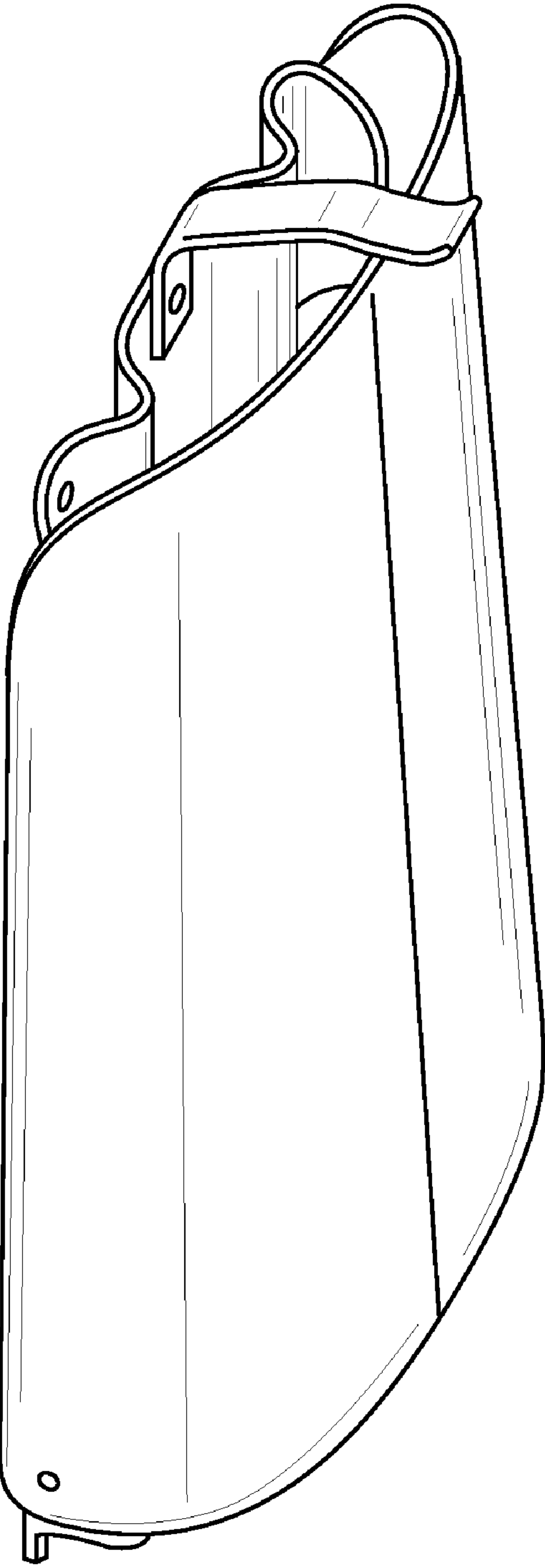

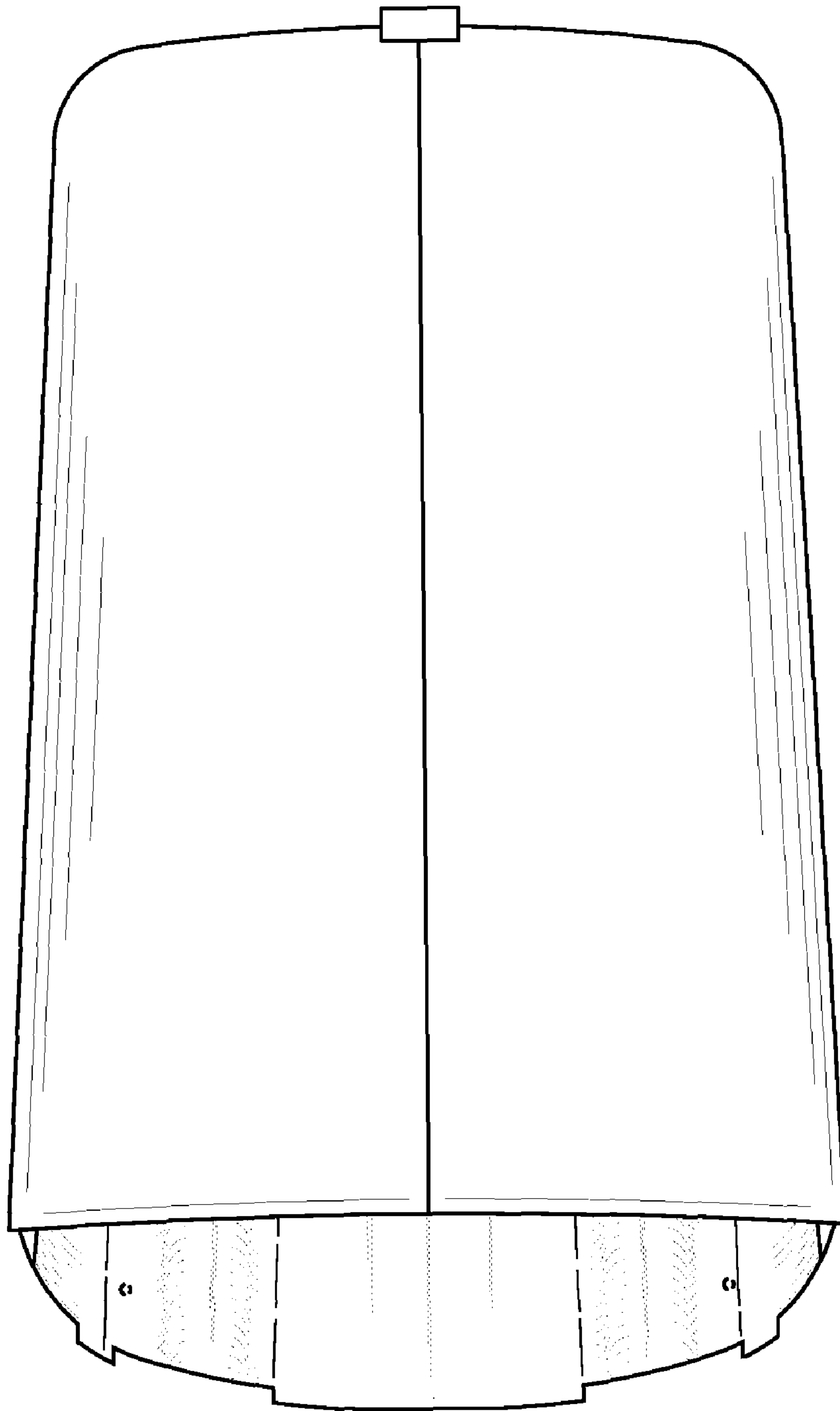

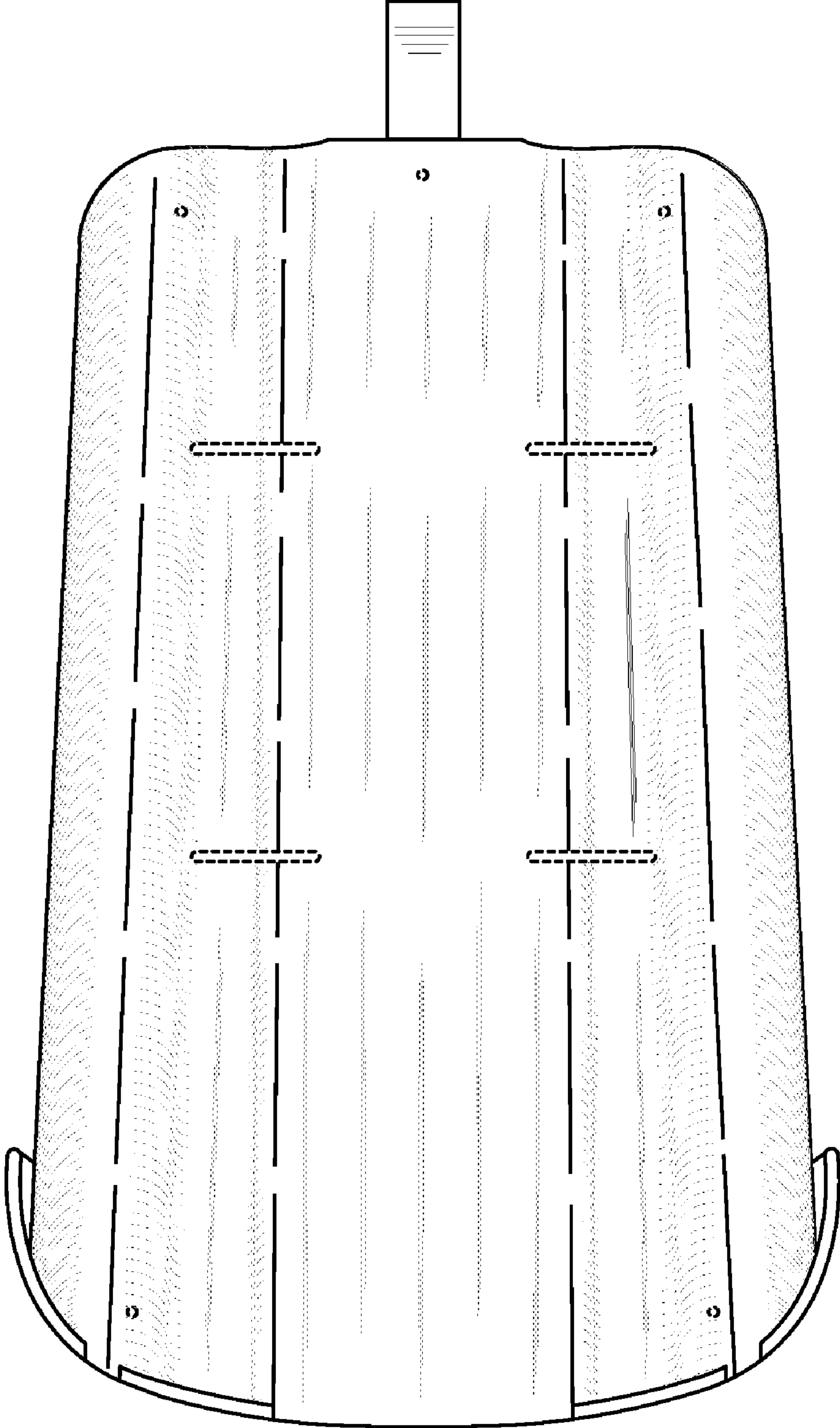
