(57) **CLAIM**

The ornamental design for a personal warming apparatus for hand, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a personal warming apparatus for hand showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a left-side view thereof;

FIG. 7 is a sectional view taken along line 7—7 in FIG. 5;

FIG. 8 is an enlarged sectional view of the portion 8—8 in FIG. 7;

FIG. 9 is an enlarged sectional view of the portion 9—9 in FIG. 7;

FIG. 10 is a reference view of the design in use; and,

FIG. 11 is an additional reference view of the design in use.

The dashed broken line showing of weld spots and fasteners is for the purpose of illustrating portions of the personal warming apparatus for hand and forms no part of the claimed design. The dash-dot-dot showing of a hand in FIGS. 10 and 11 is for the purpose of illustrating environment and forms no part of the claimed design.

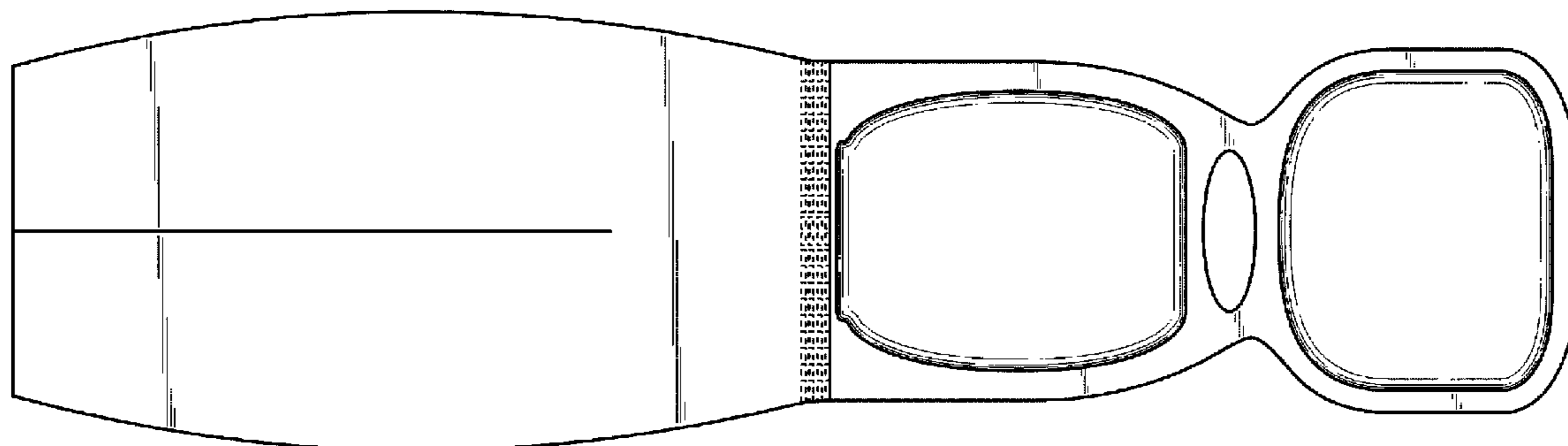

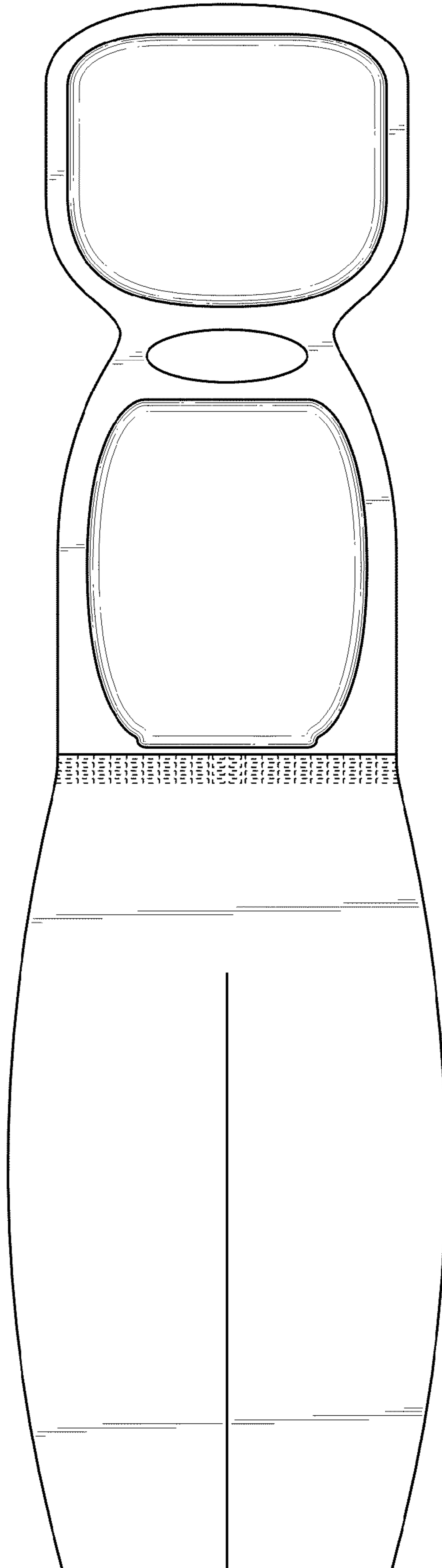

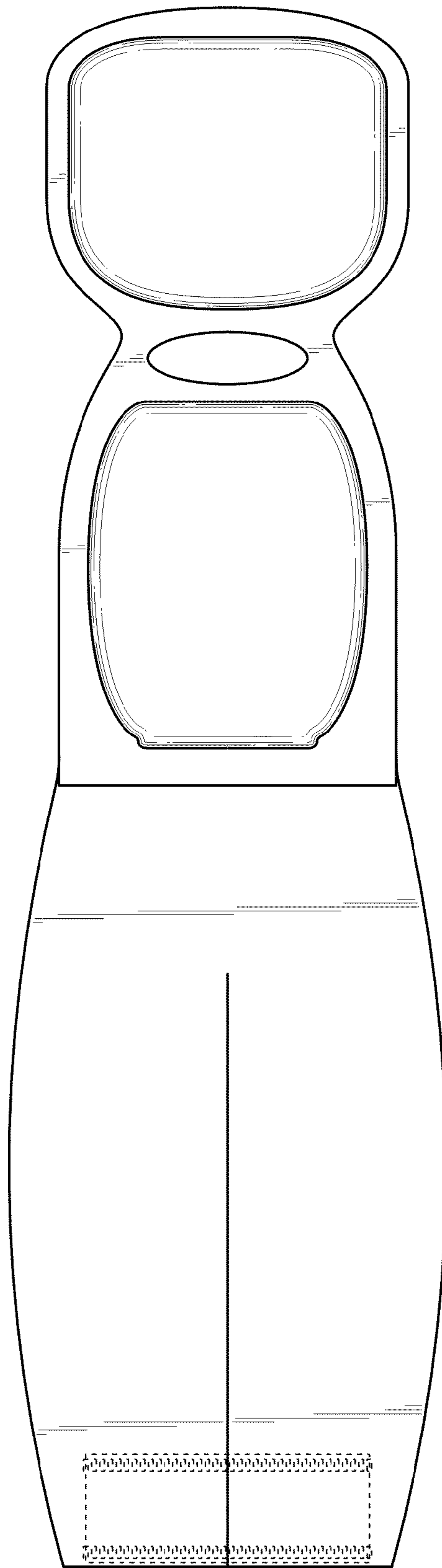

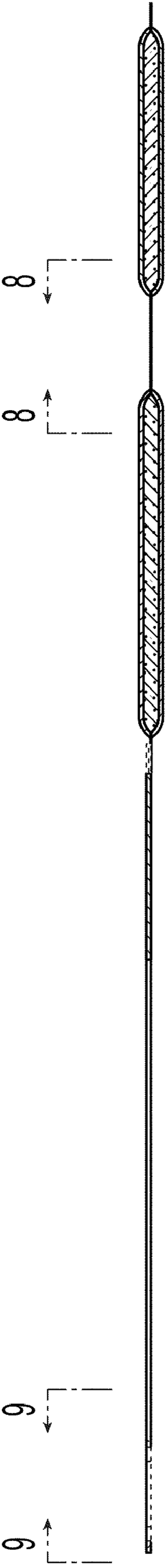

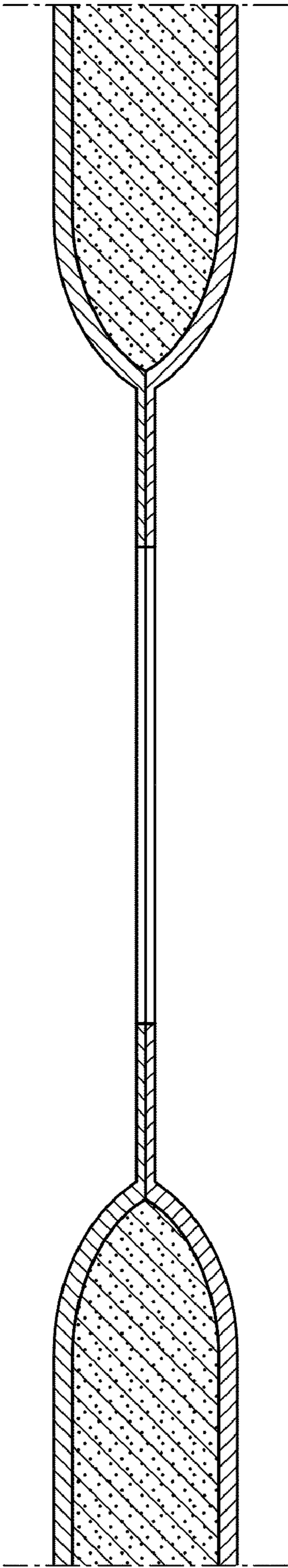

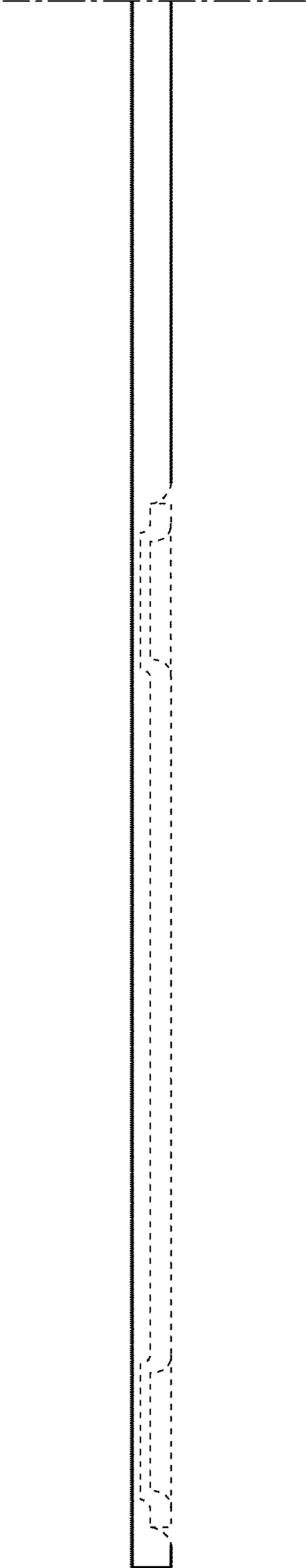

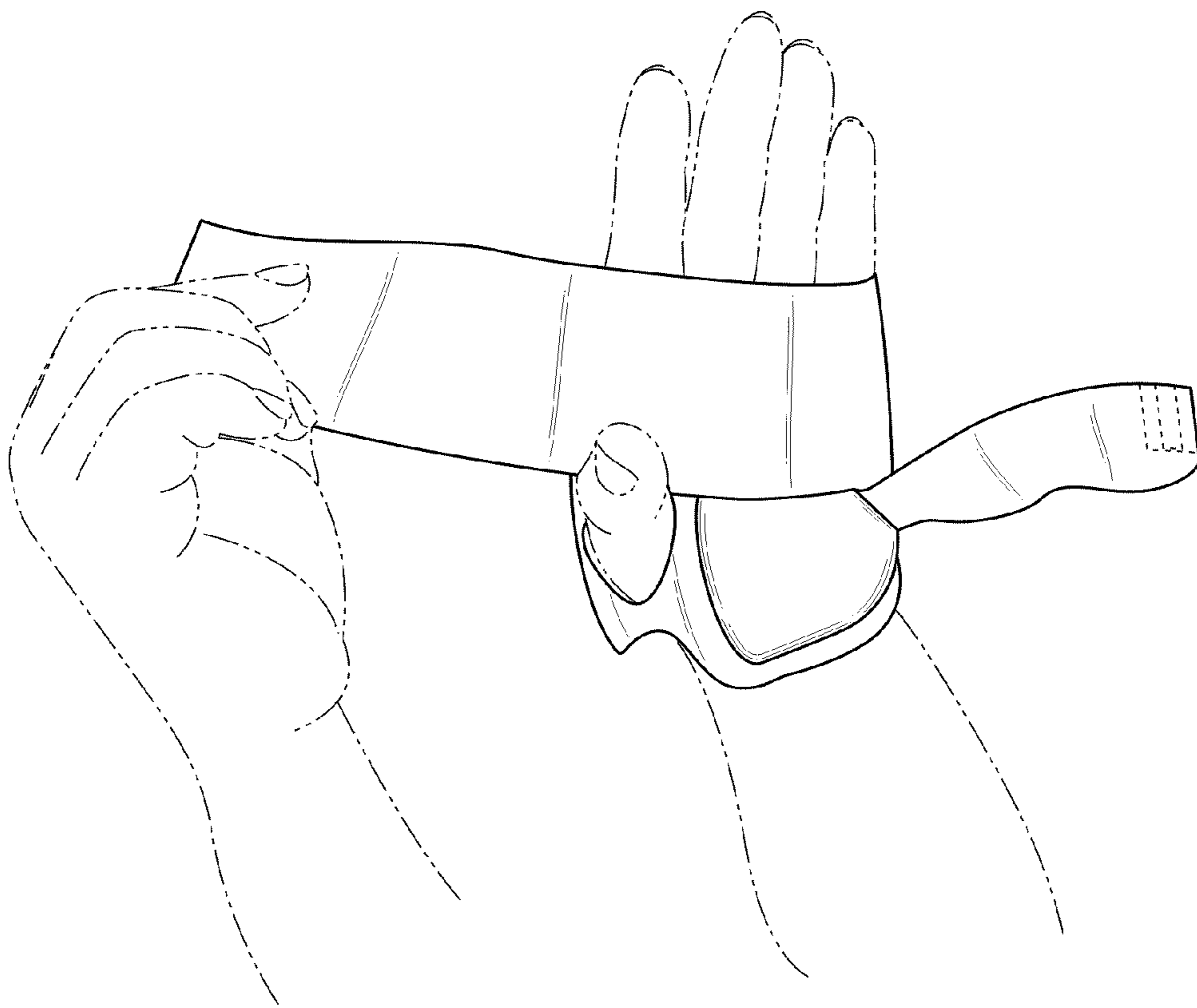

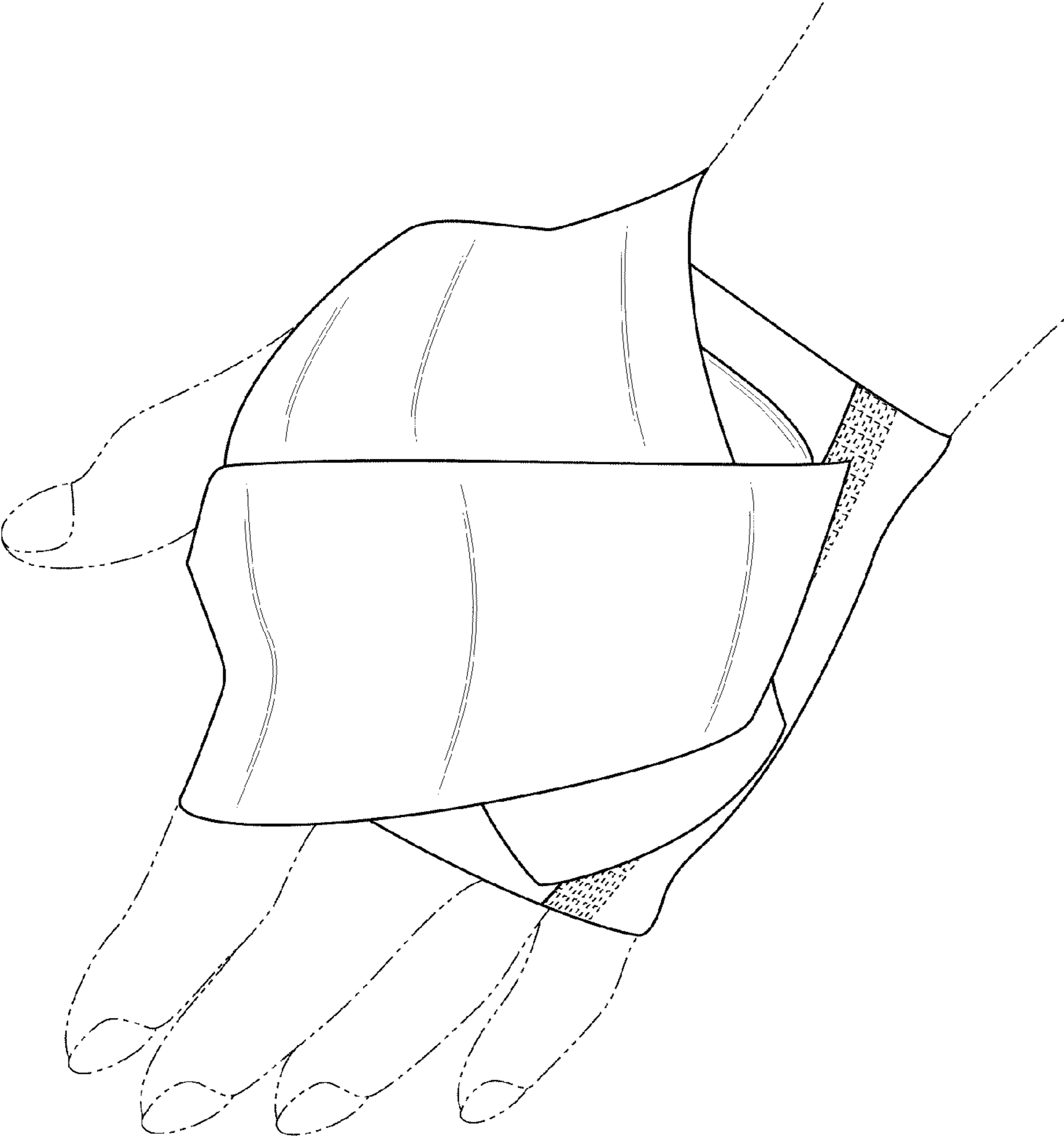
