DESCRIPTION

FIG. 1 is a front perspective view of an asymmetrical one shoulder seamless brassiere;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

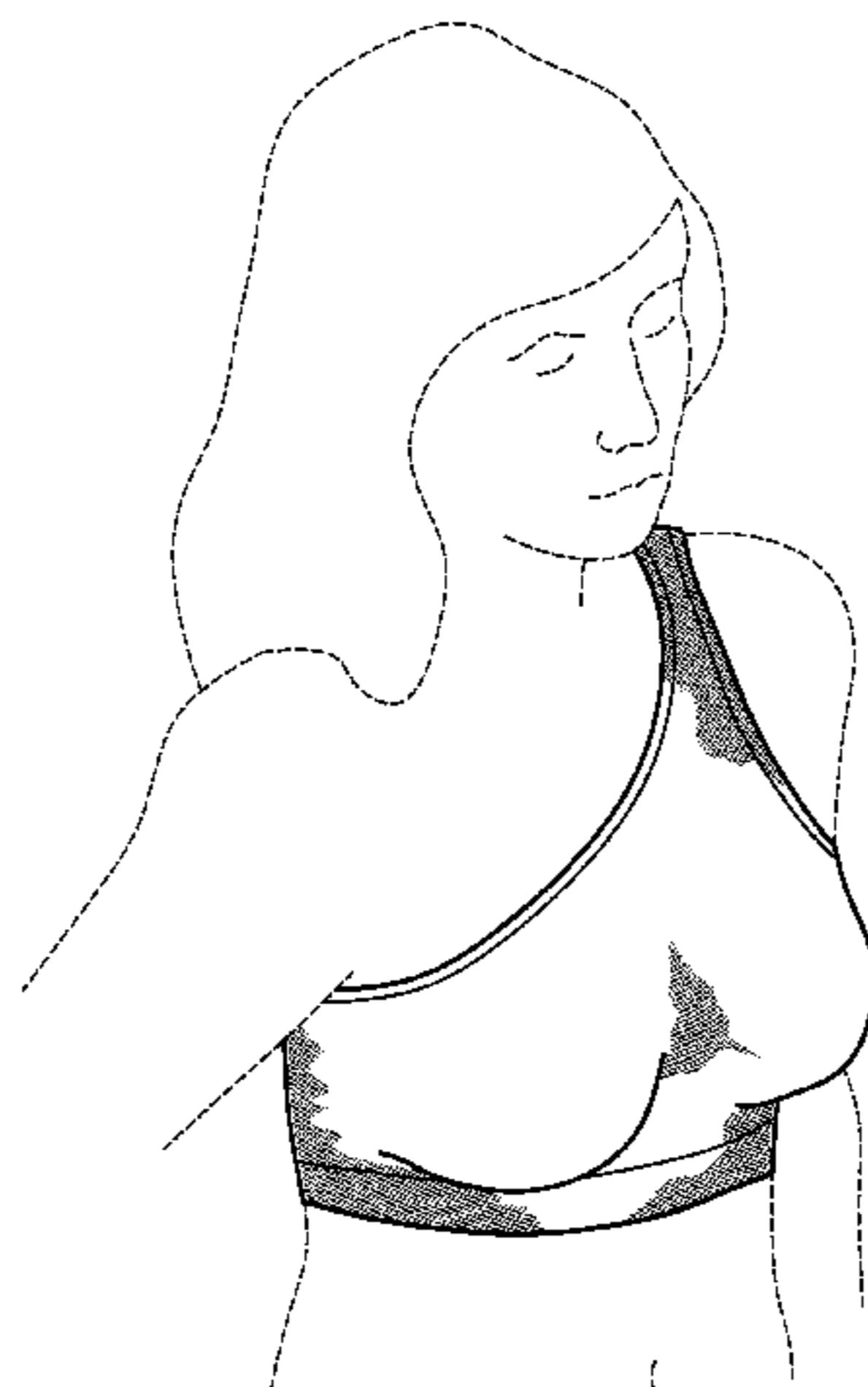
FIG. 4 is a left side elevational view thereof;

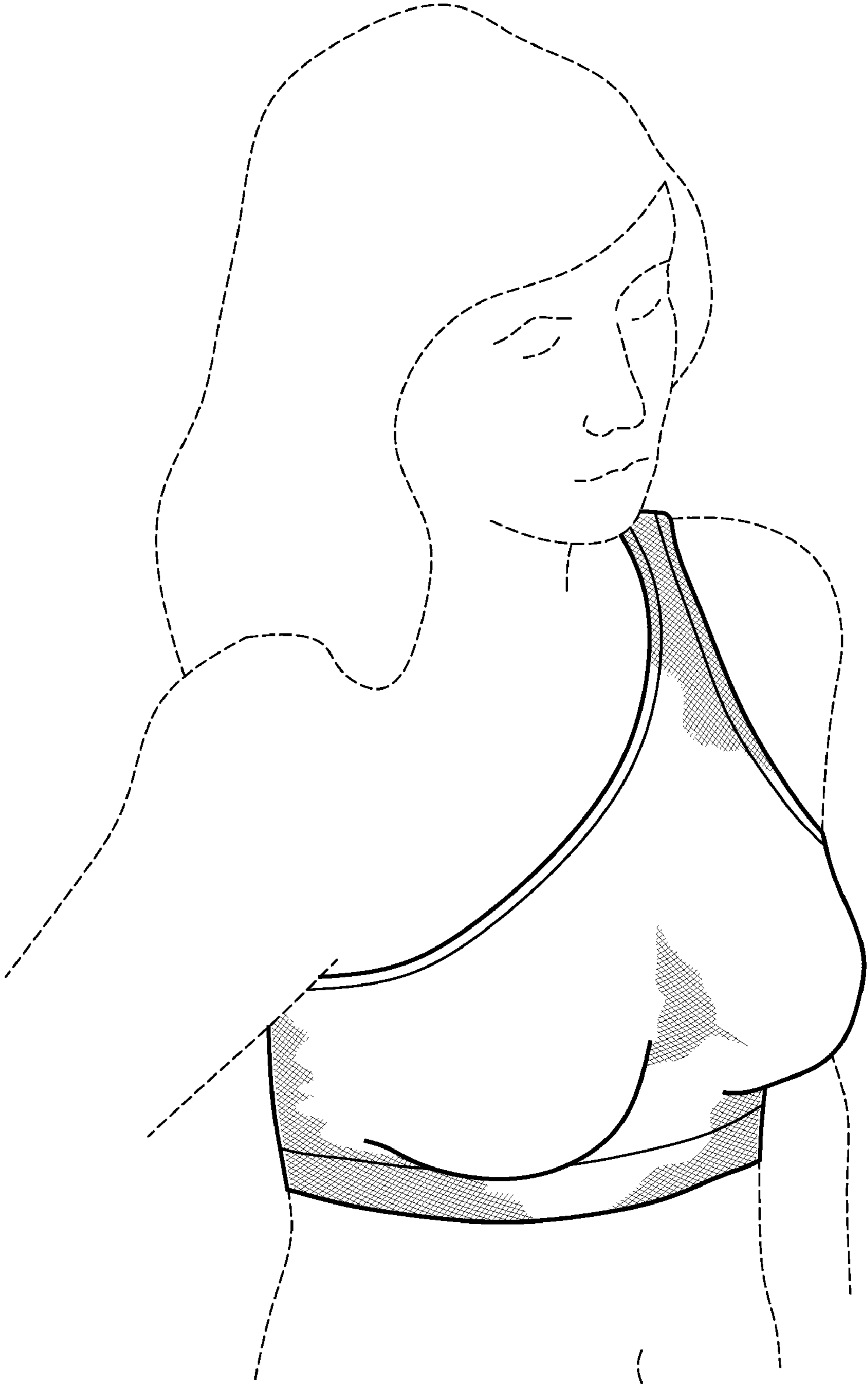

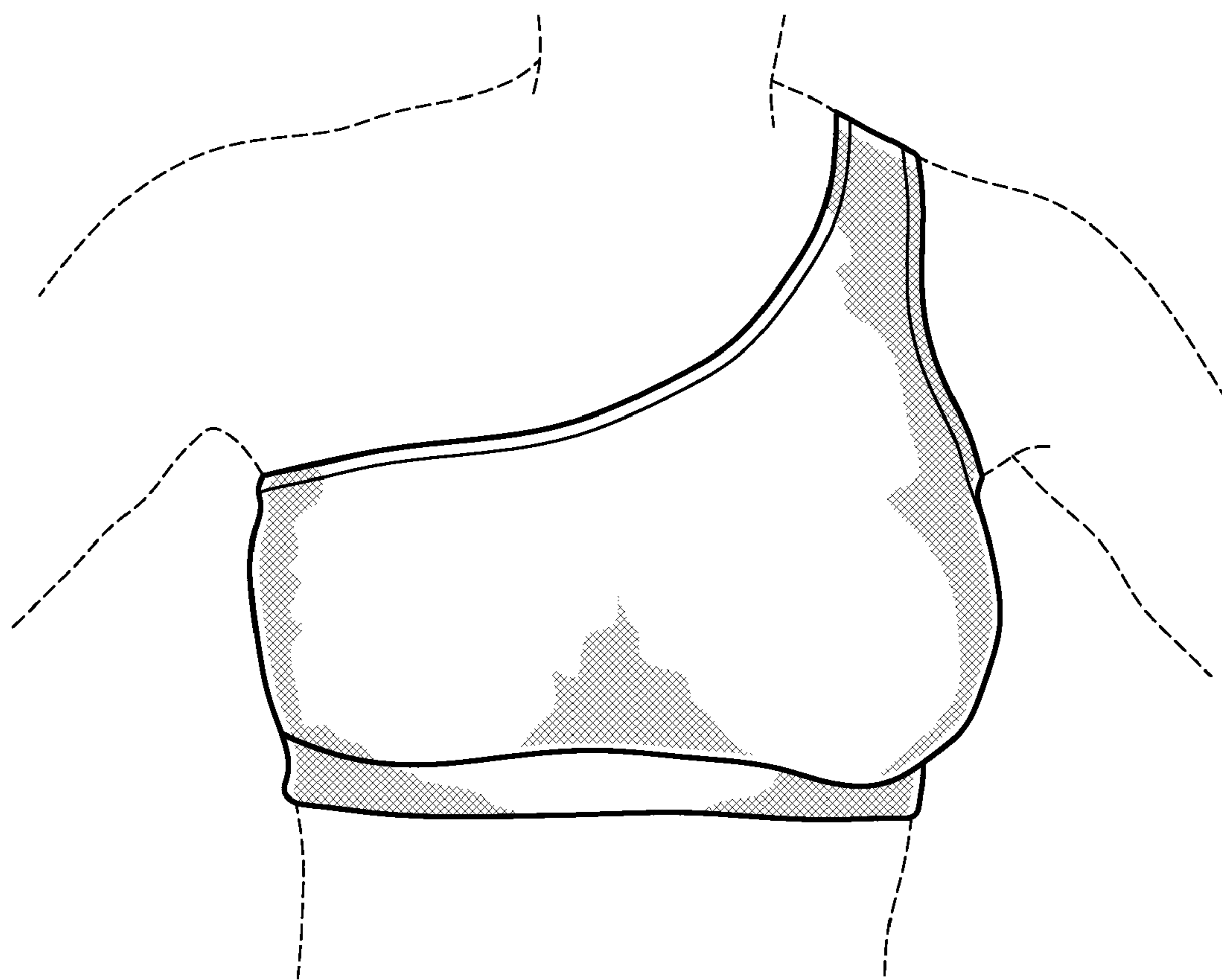

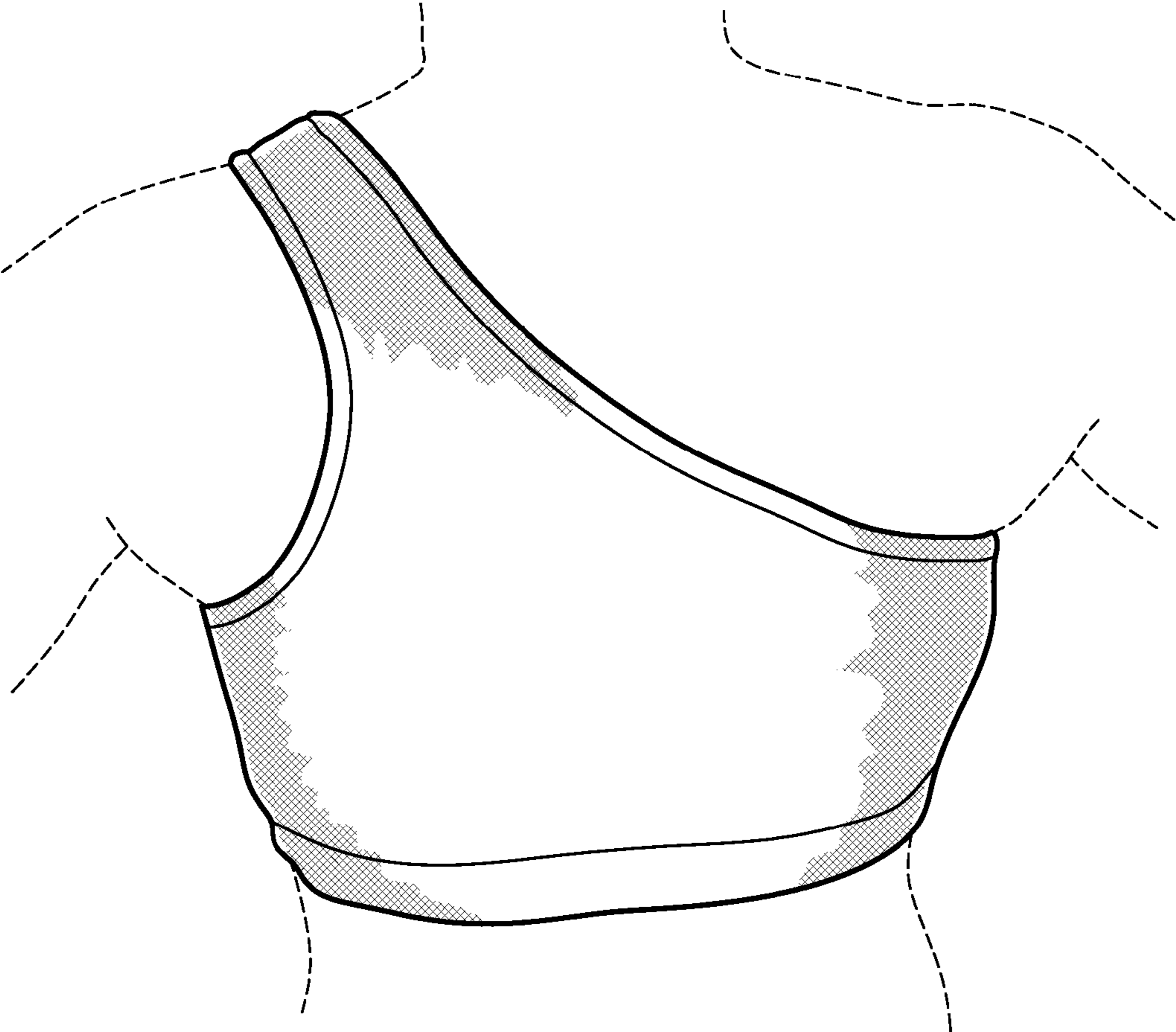

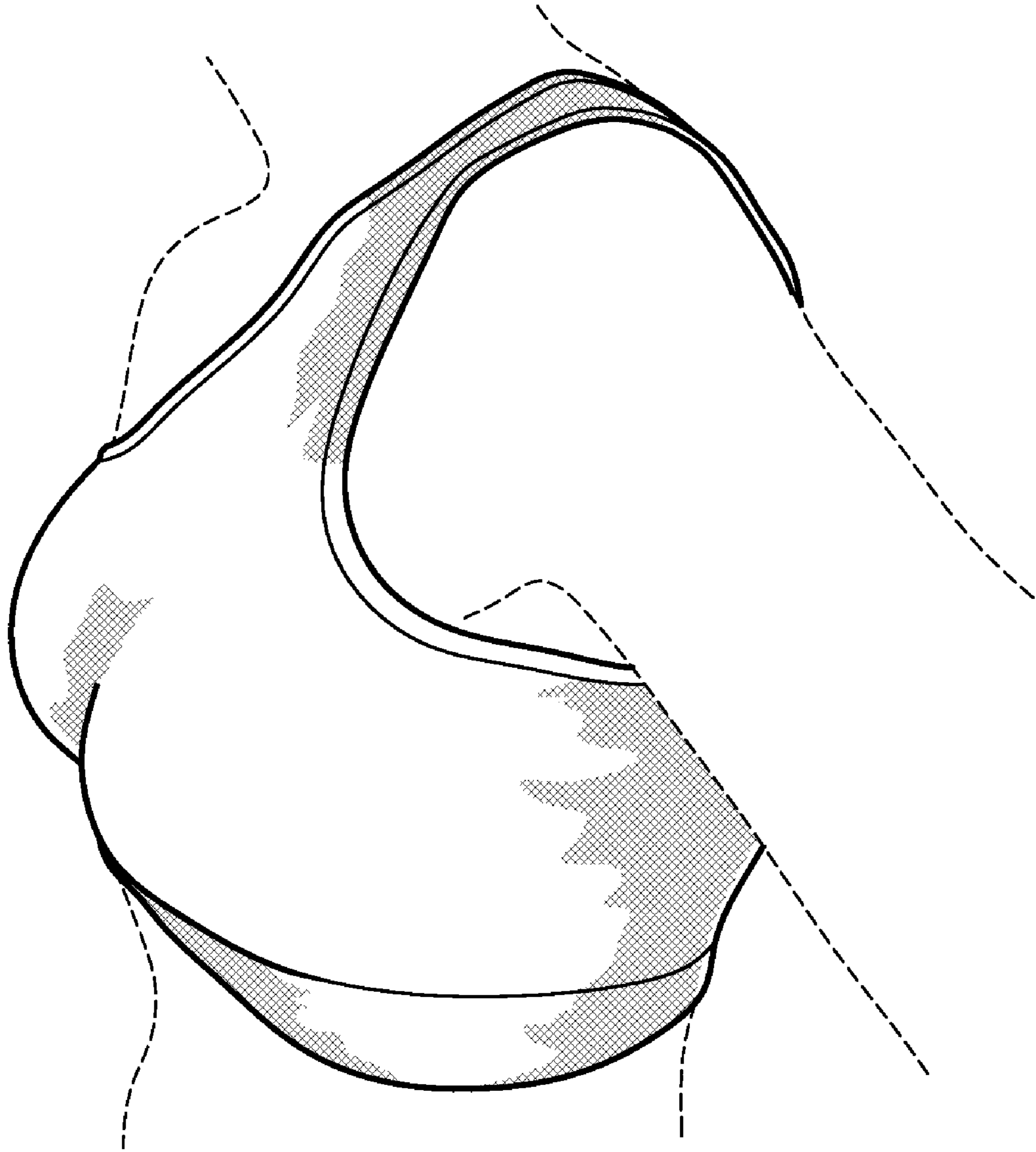

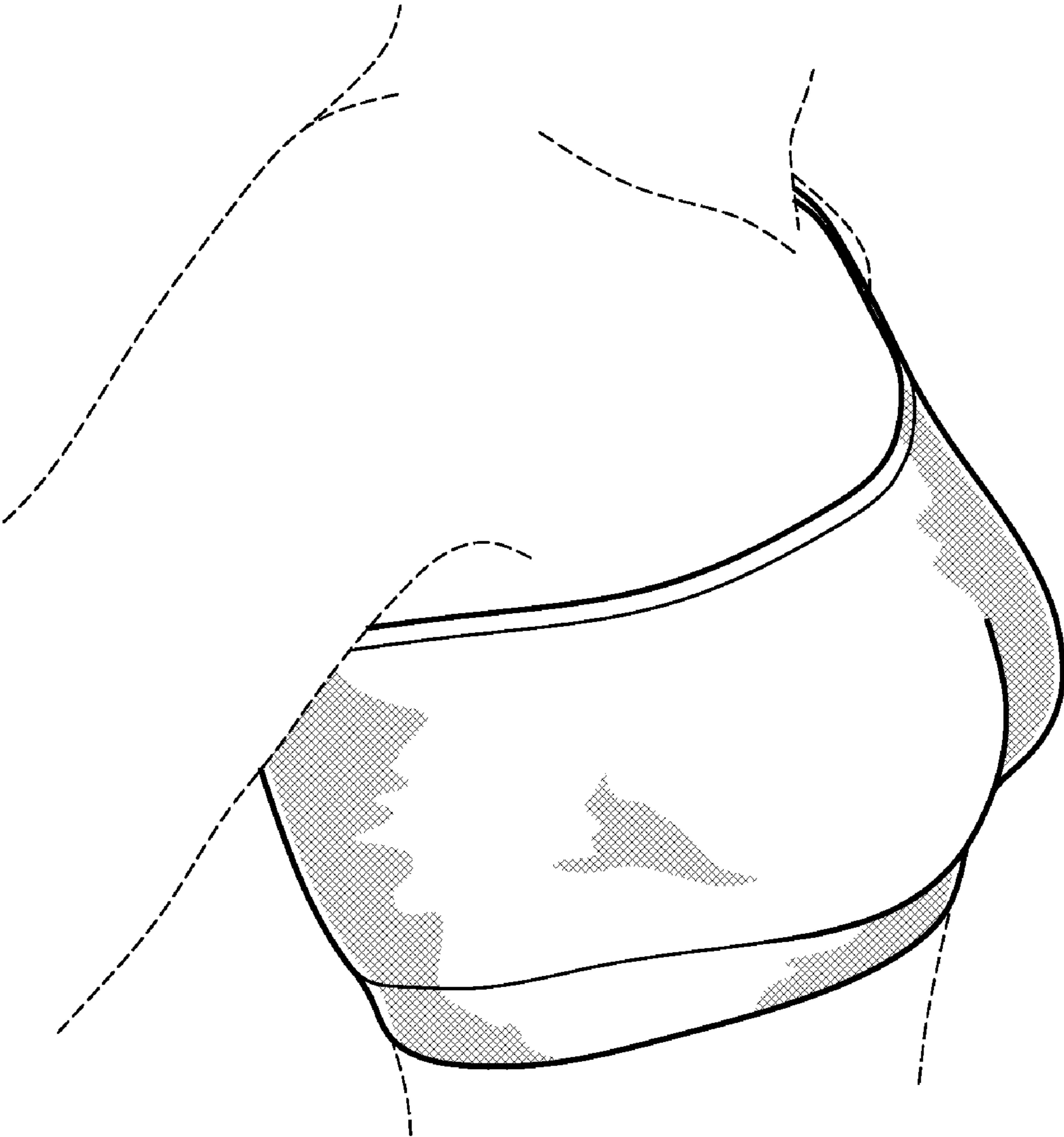

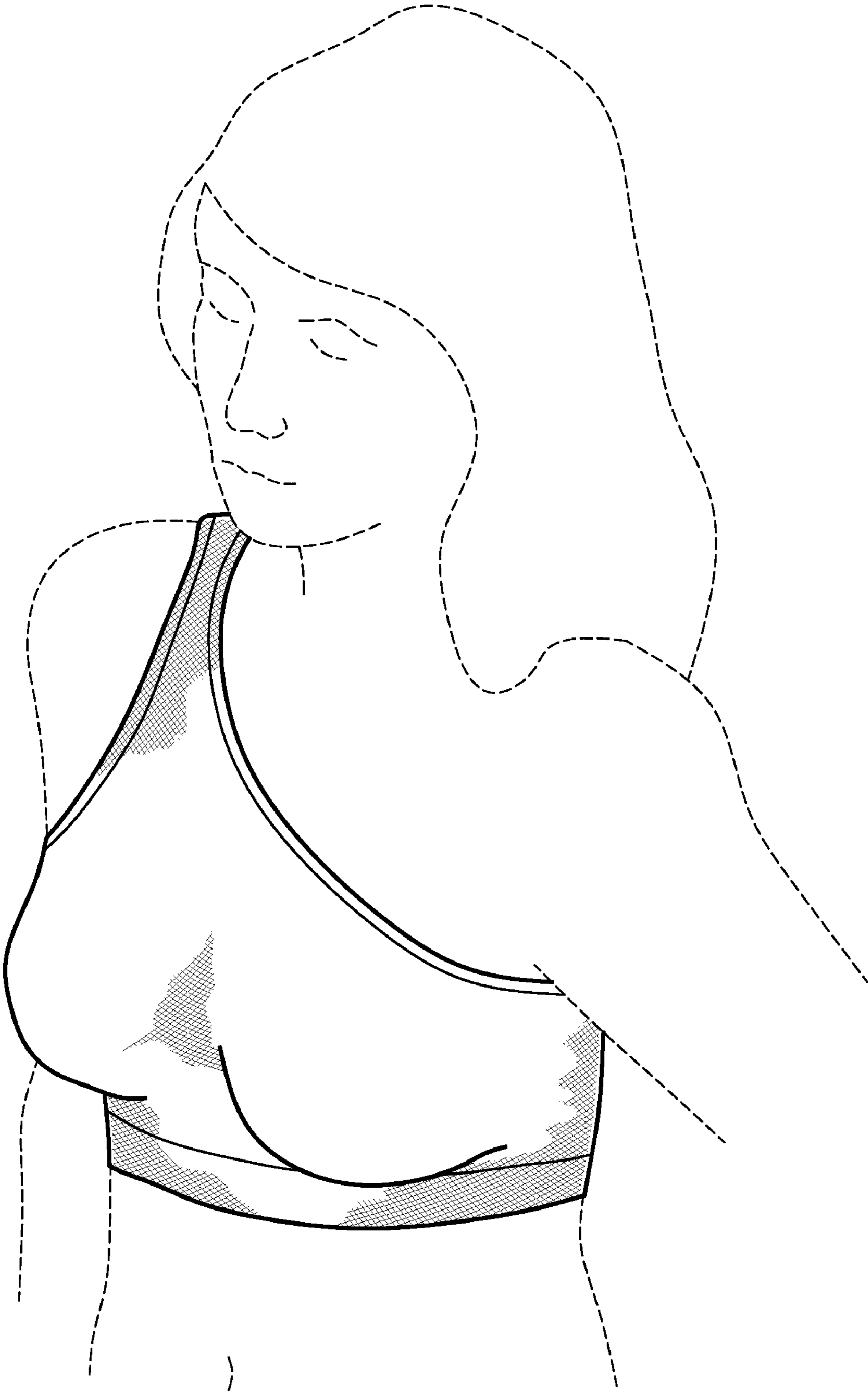
