(57) **CLAIM**

The ornamental design for a handle for a hairbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for hairbrush showing my new design;

FIG. 2 is a side elevational view thereof, the other side being a mirror image;

FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

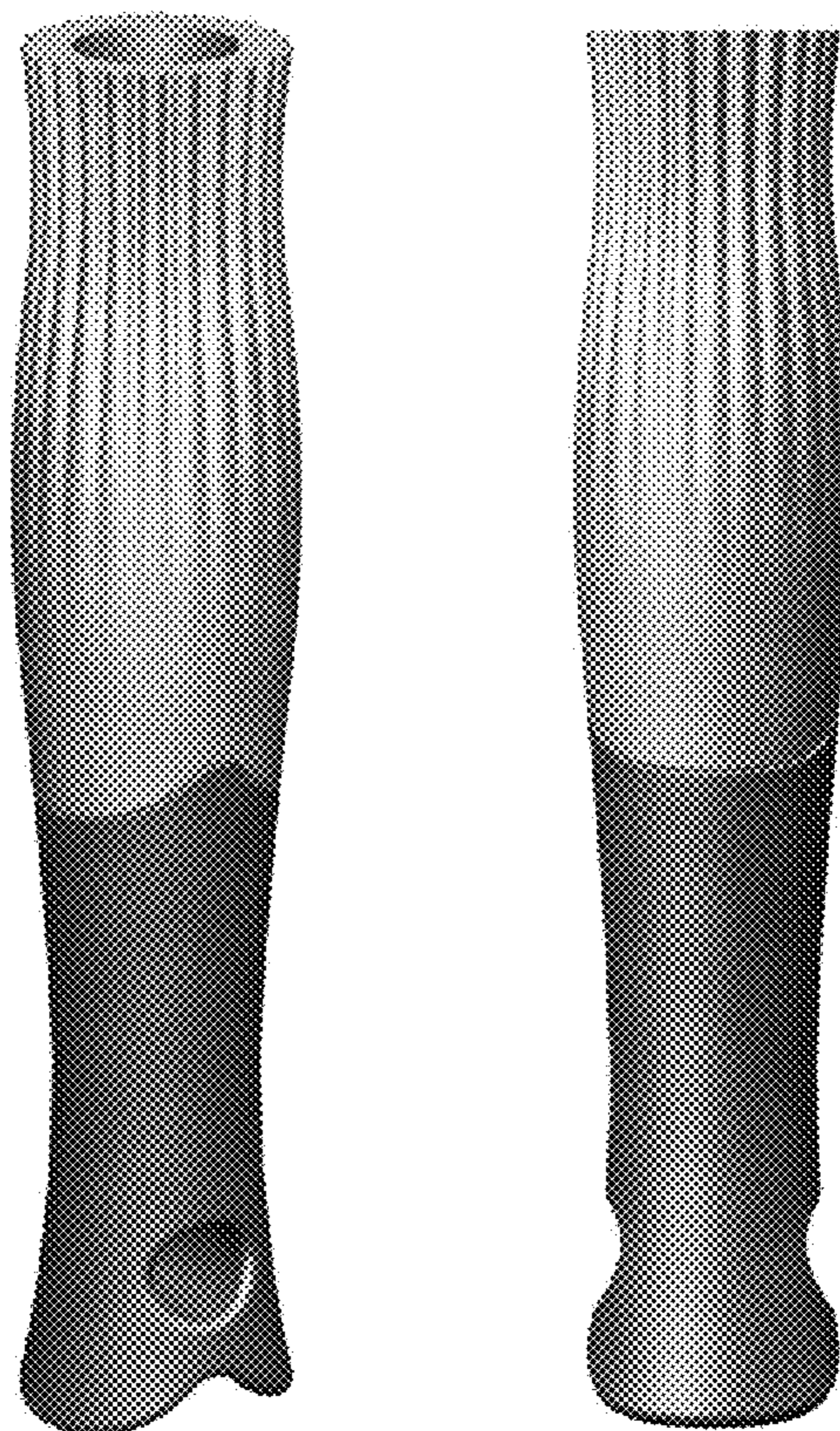

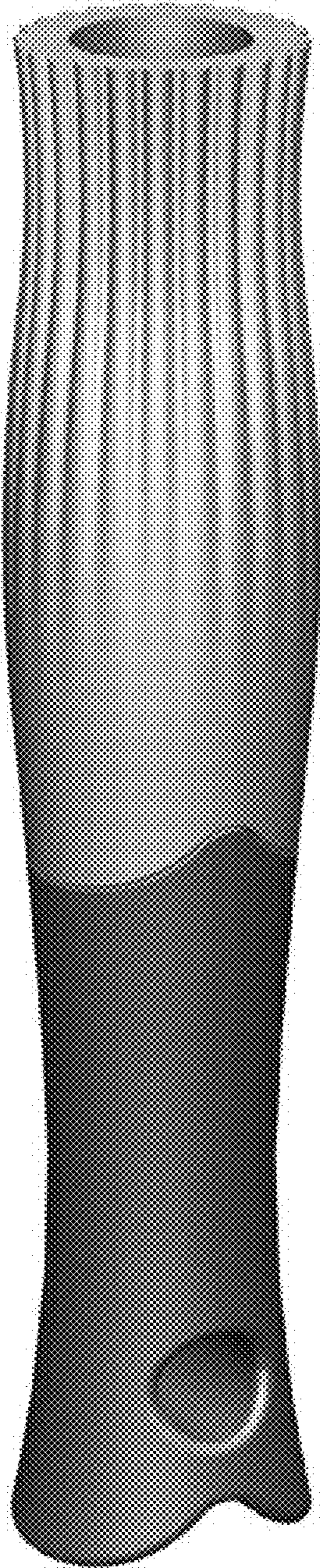

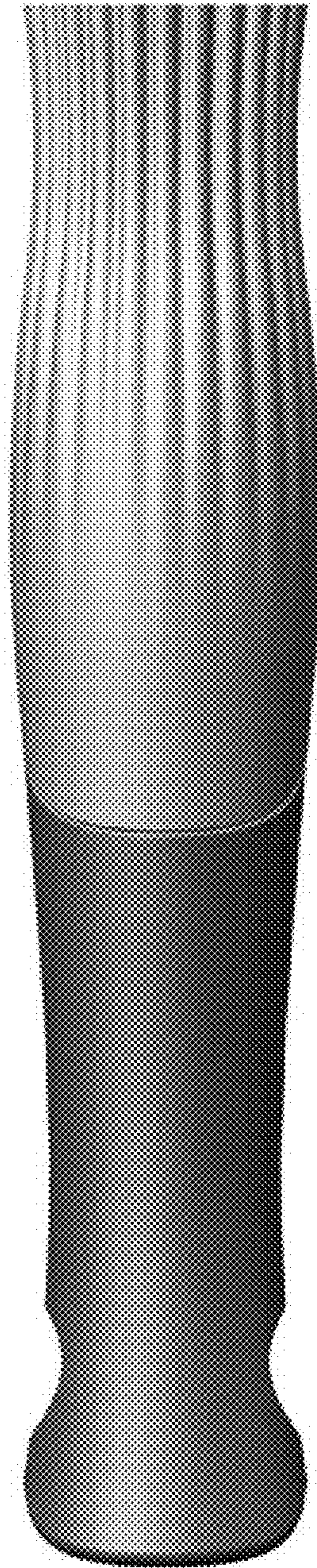

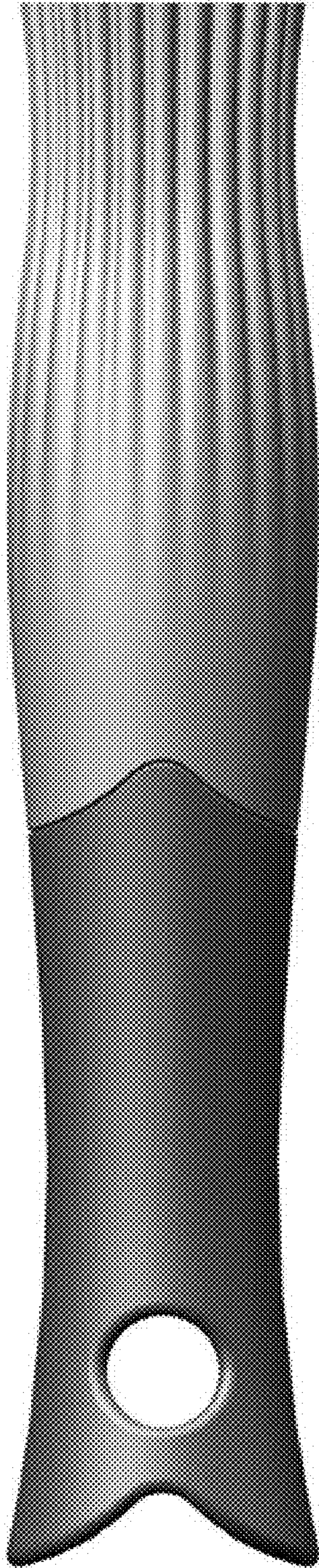

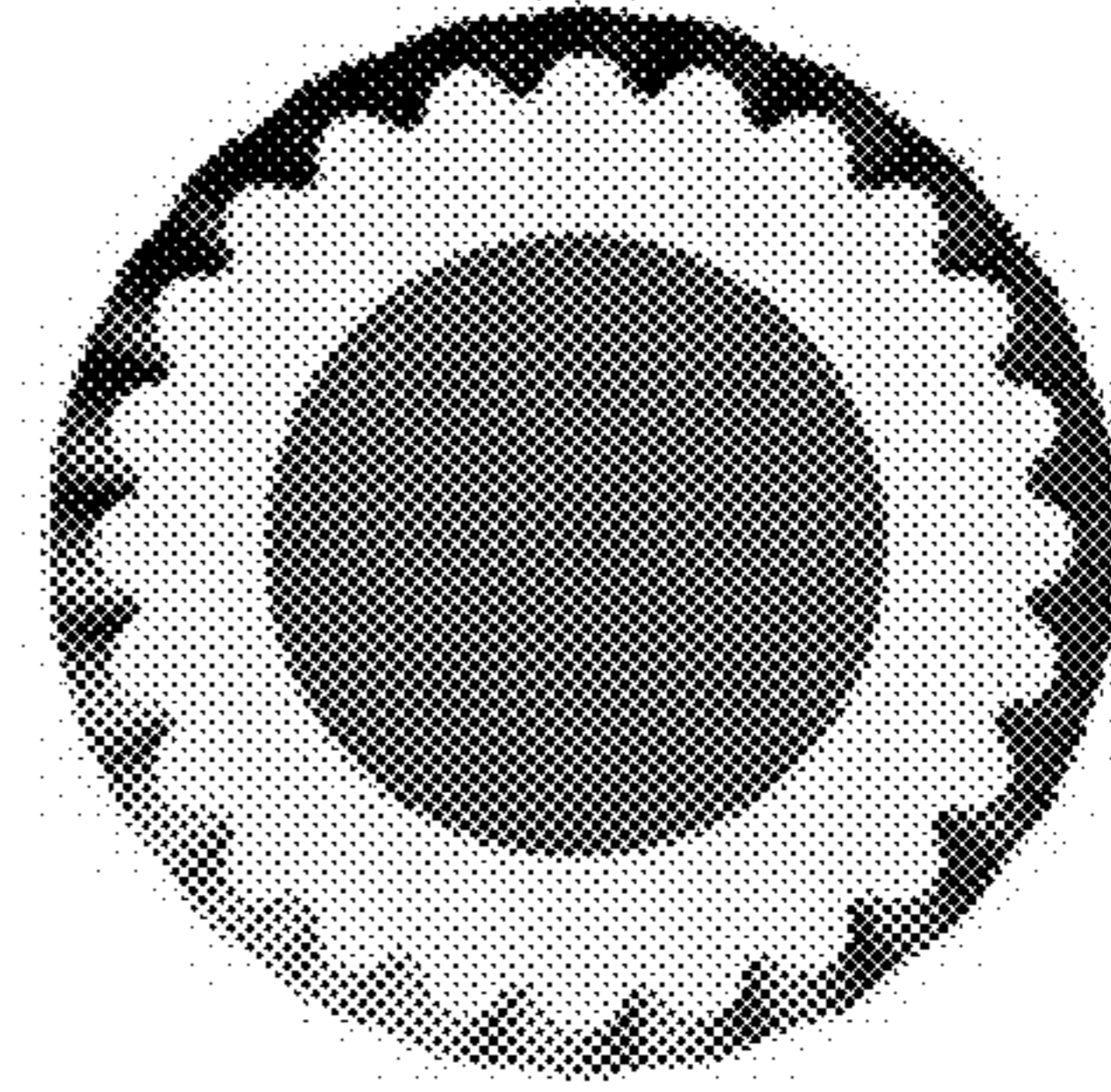
