DESCRIPTION

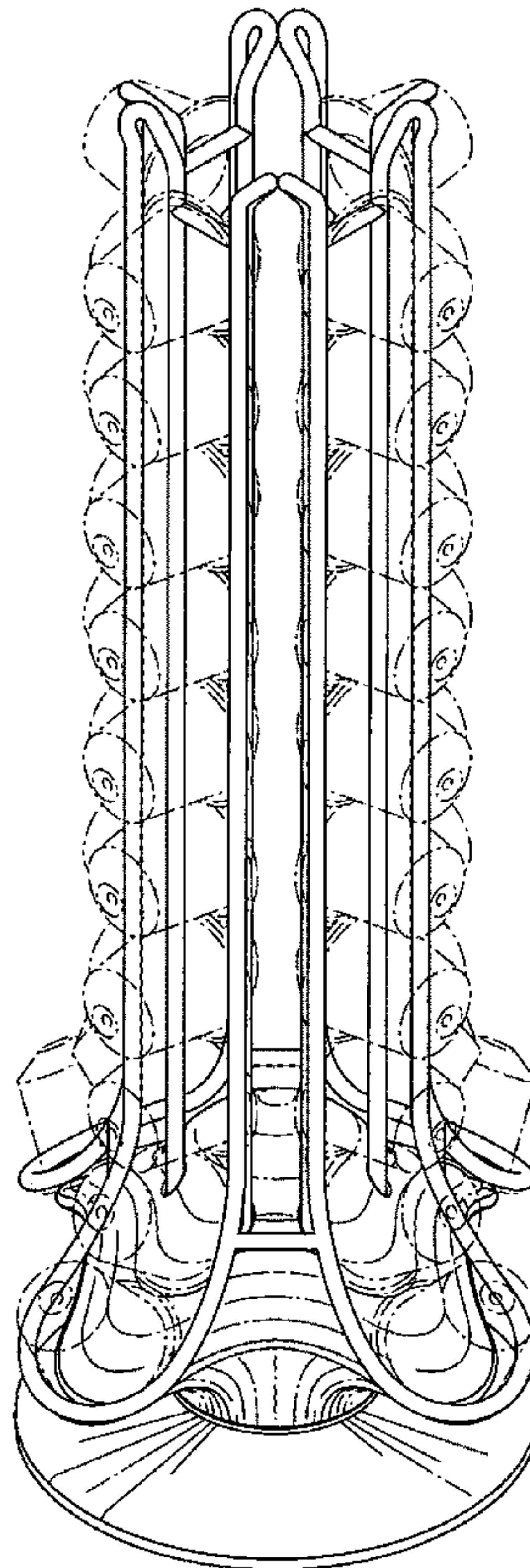
FIG. 1 is a side view of a dispenser formed in accordance with the present invention;

FIG. 2 is a top view of the dispenser of FIG. 1;

FIG. 3 is a perspective view of the dispenser of FIG. 1; and,

FIG. 4 is a perspective view like FIG. 3, but showing coffee creamers in broken lines held by the dispenser, the coffee creamers being illustrative only and forming no part of the claimed design.

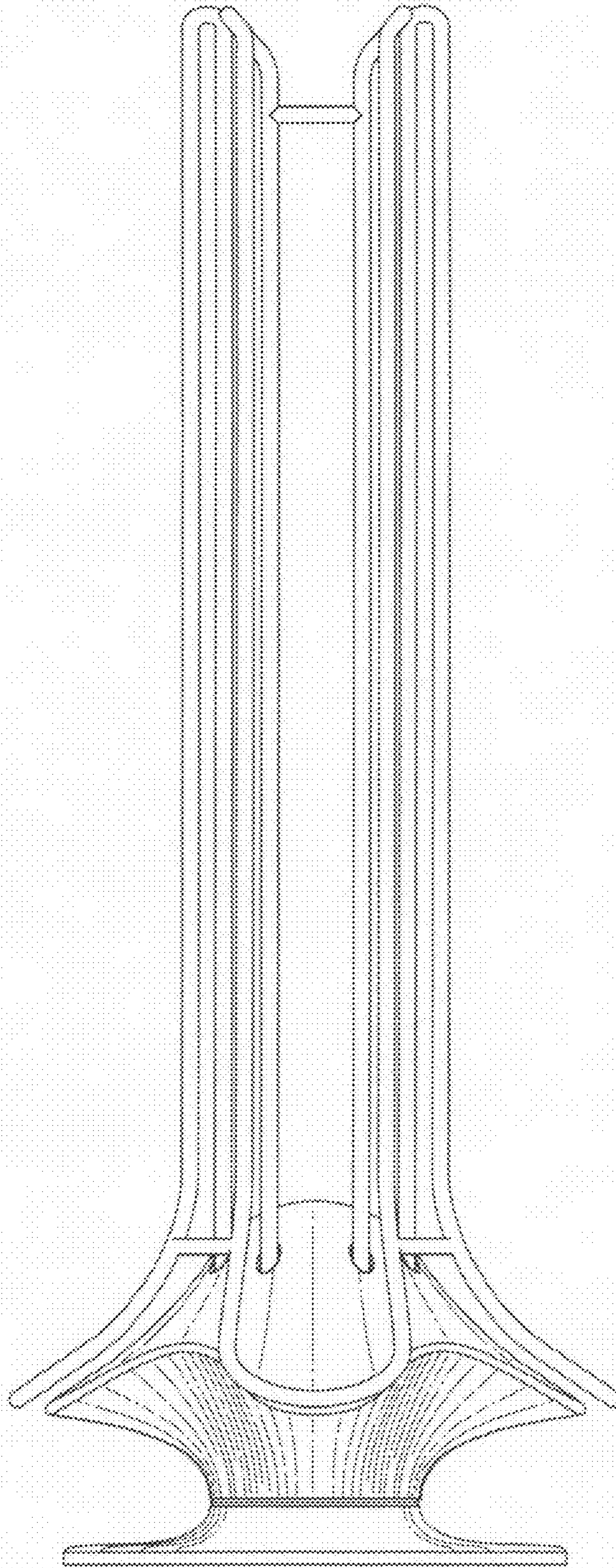

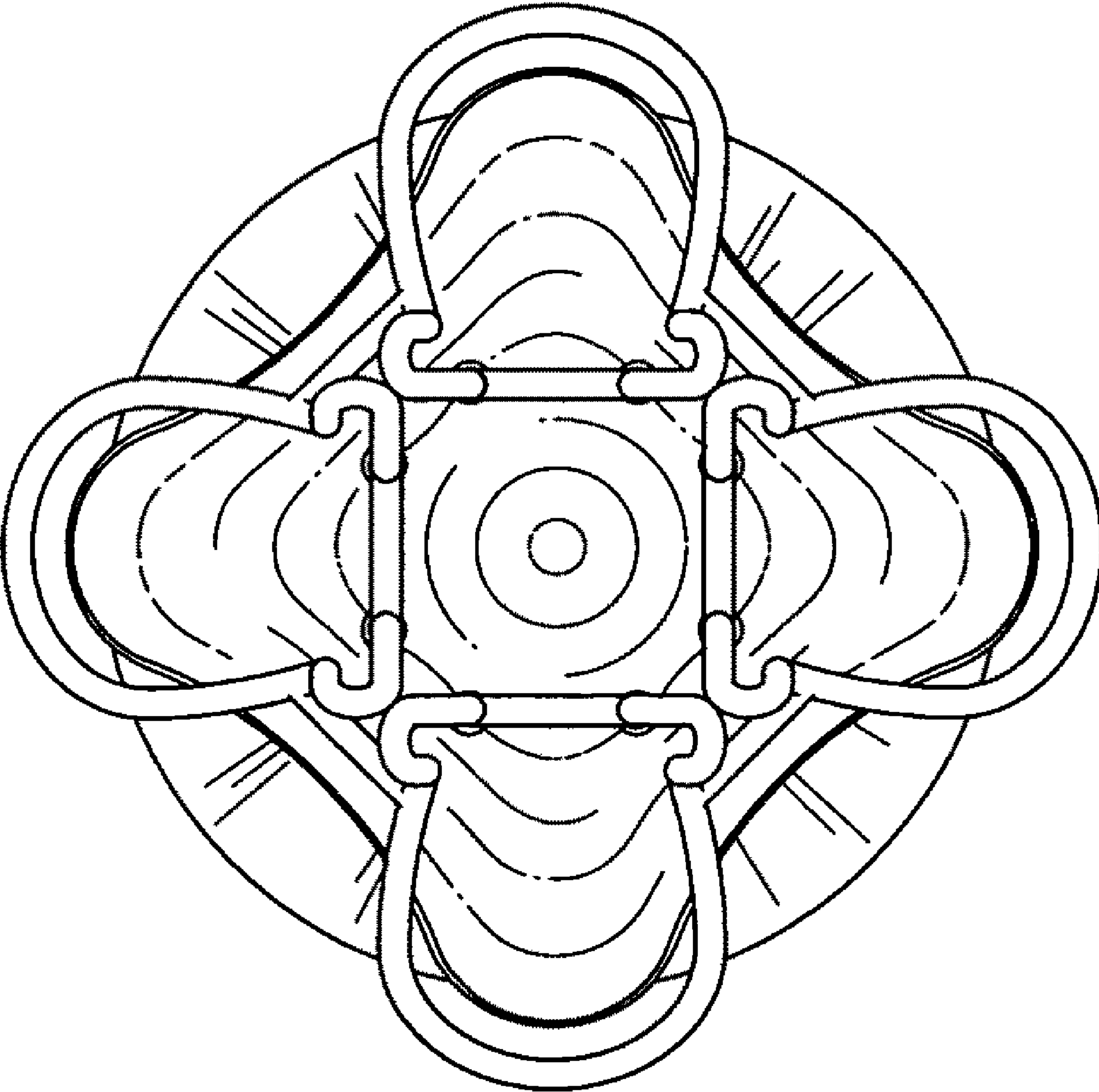

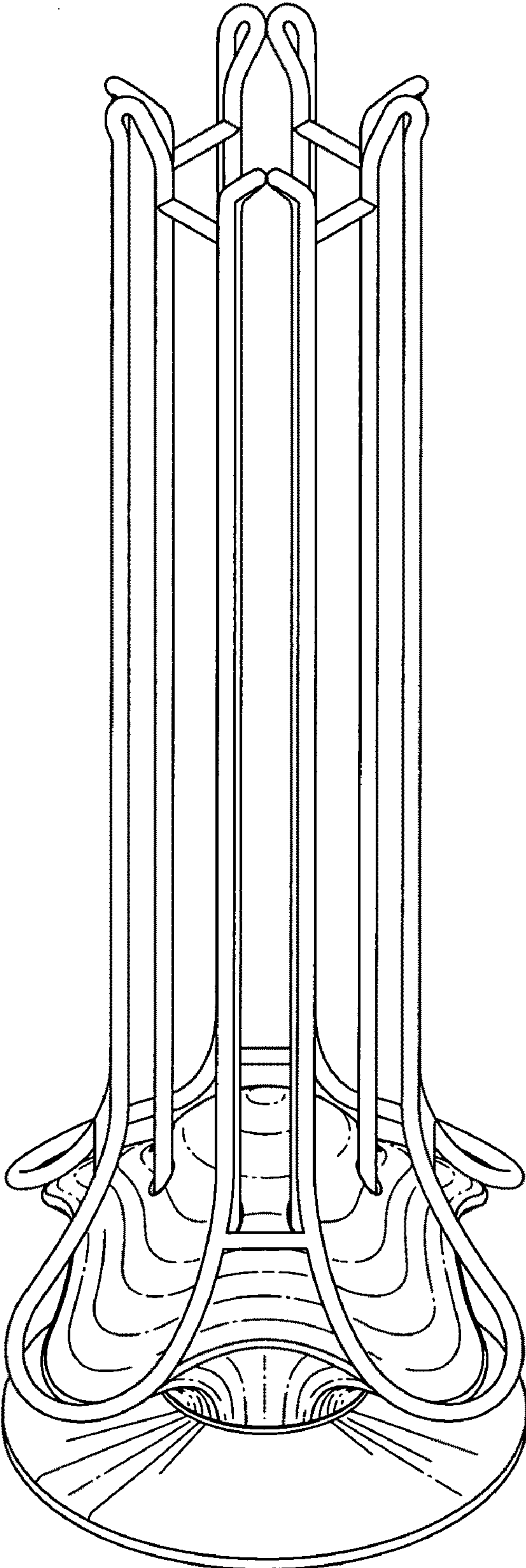

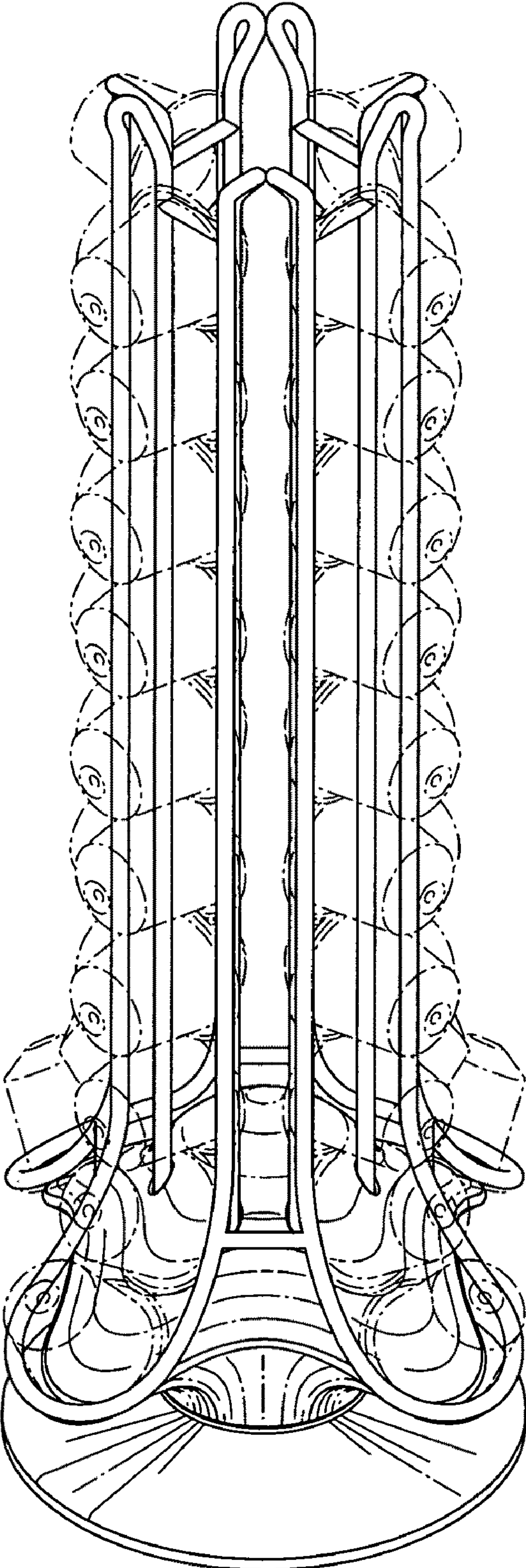
