DESCRIPTION

FIG. 1 is a bottom view of the slide protector system for a safety bar of a chairlift chair showing my new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a side elevation view thereof, shown at an enlarged scale relative to the other figures;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a perspective view thereof.

The broken lines showing a person seated on a neighboring chairlift seat and the chairlift with a seat divider is included for the purpose of illustrating environment of the design and forms no part of the claimed design.

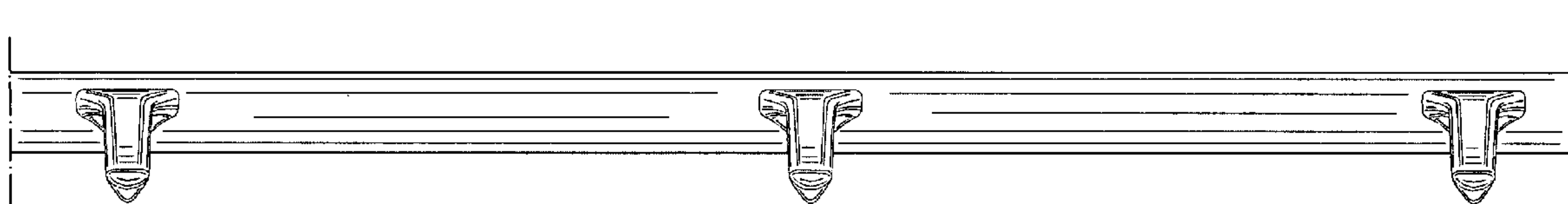
The dash-dot lines in the drawing show boundaries of the claim and do not form part of the claim.

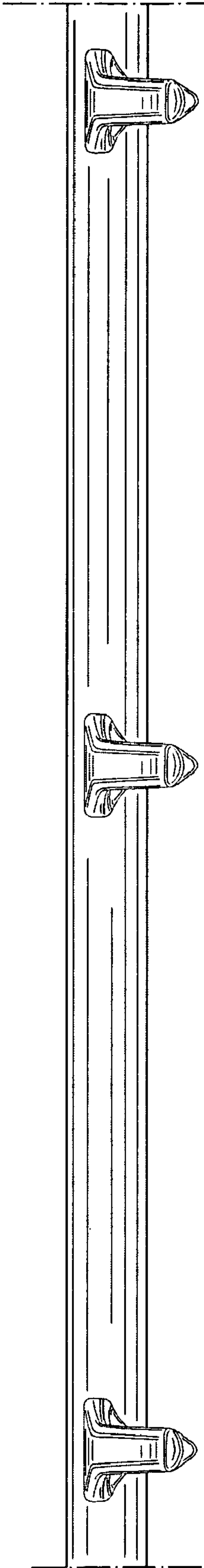

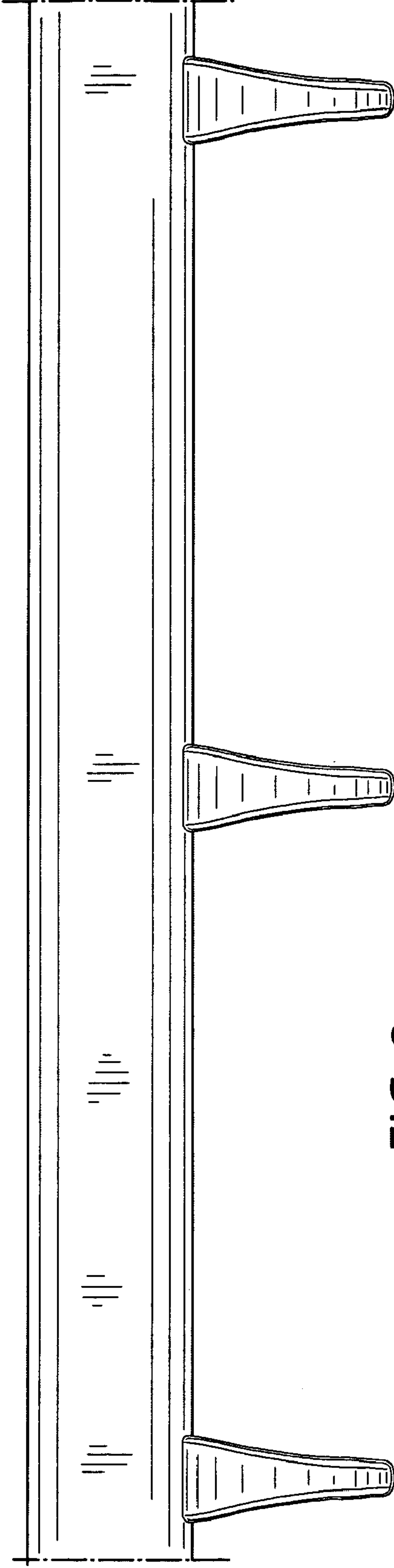

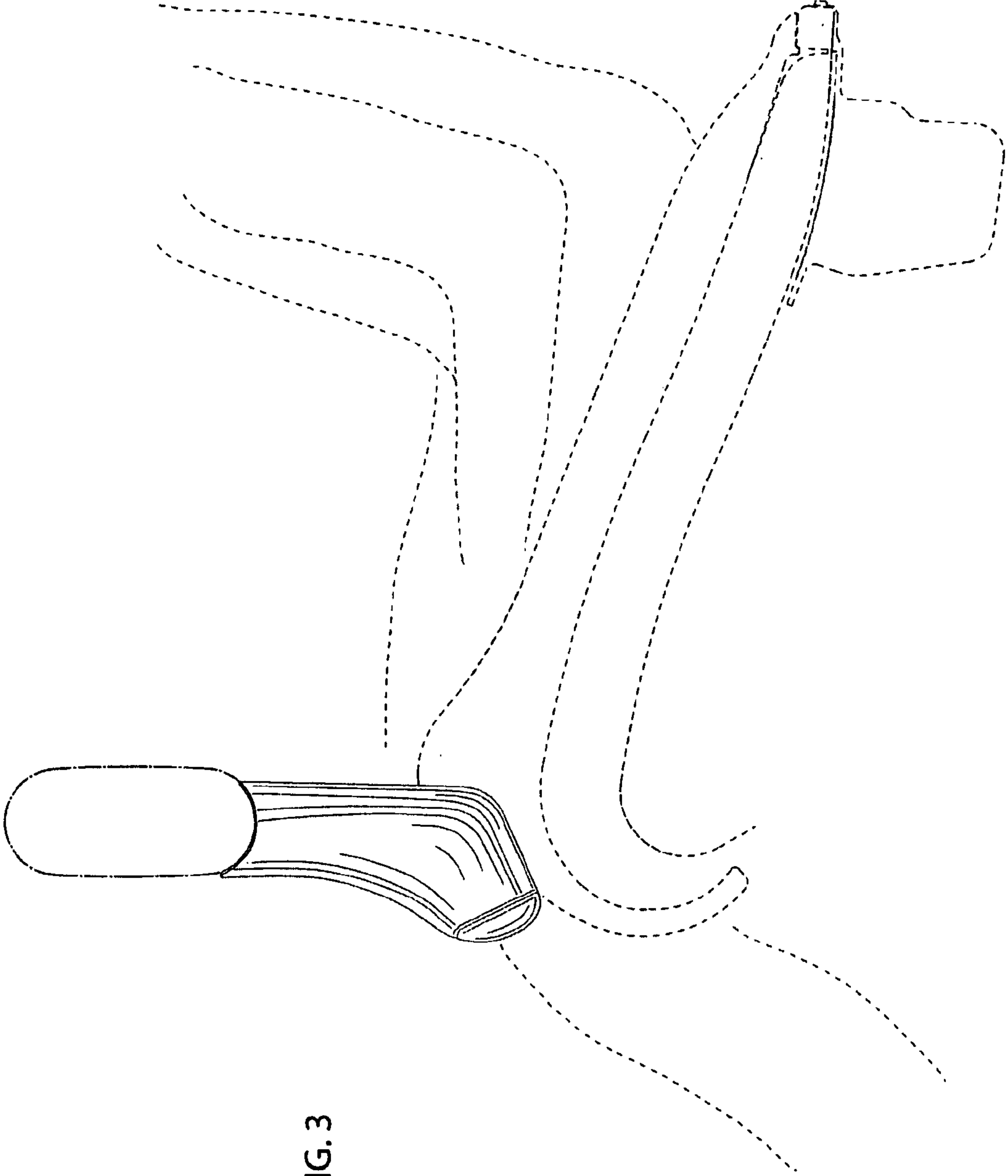

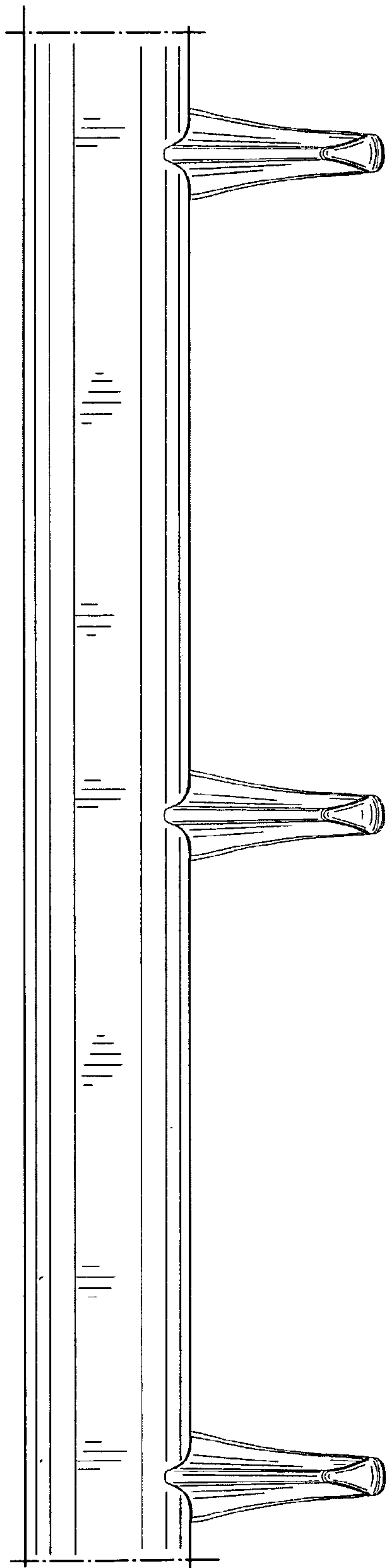

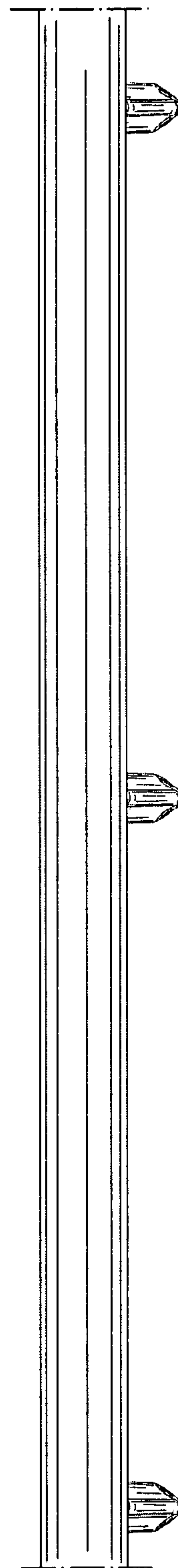

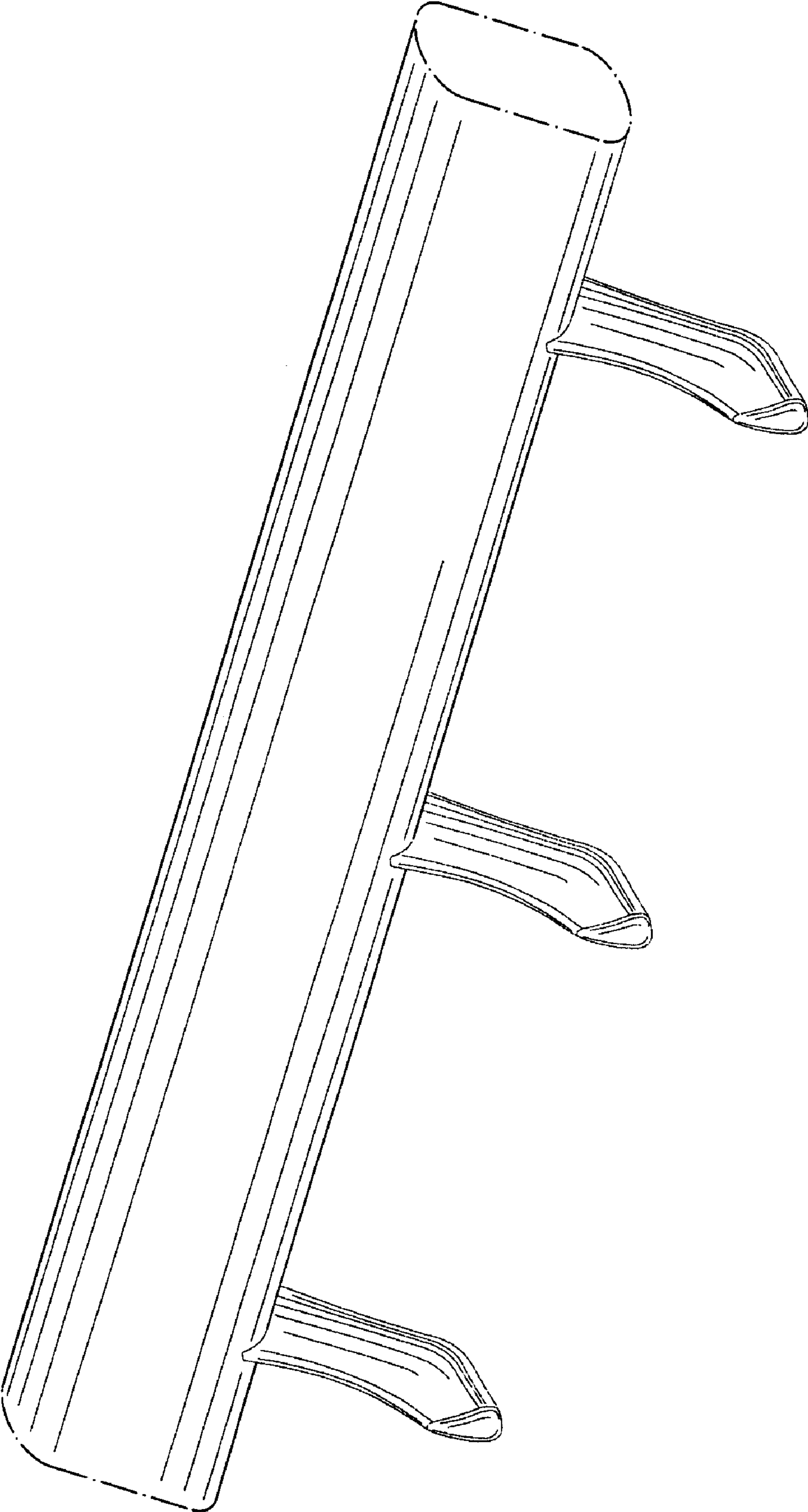
