The ornamental design for crimping jaws for a crimping tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the crimping jaws for a crimping tool of my design;

FIG. 2 is a front elevational view thereof;

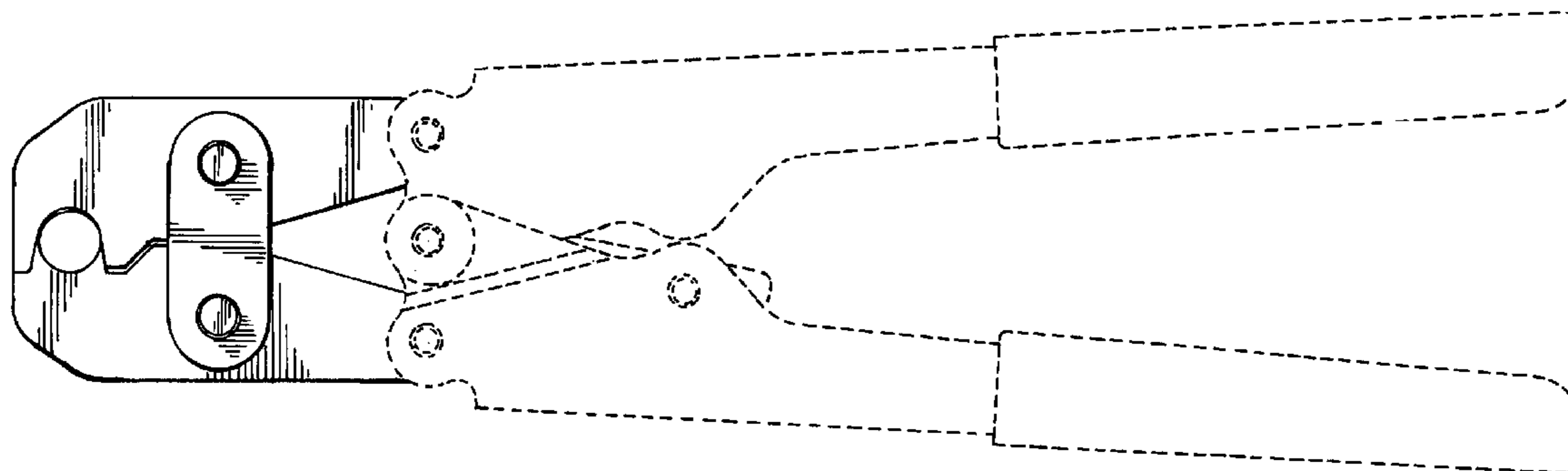
FIG. 3 is a top plan view, the bottom plan view being a mirror image thereof;

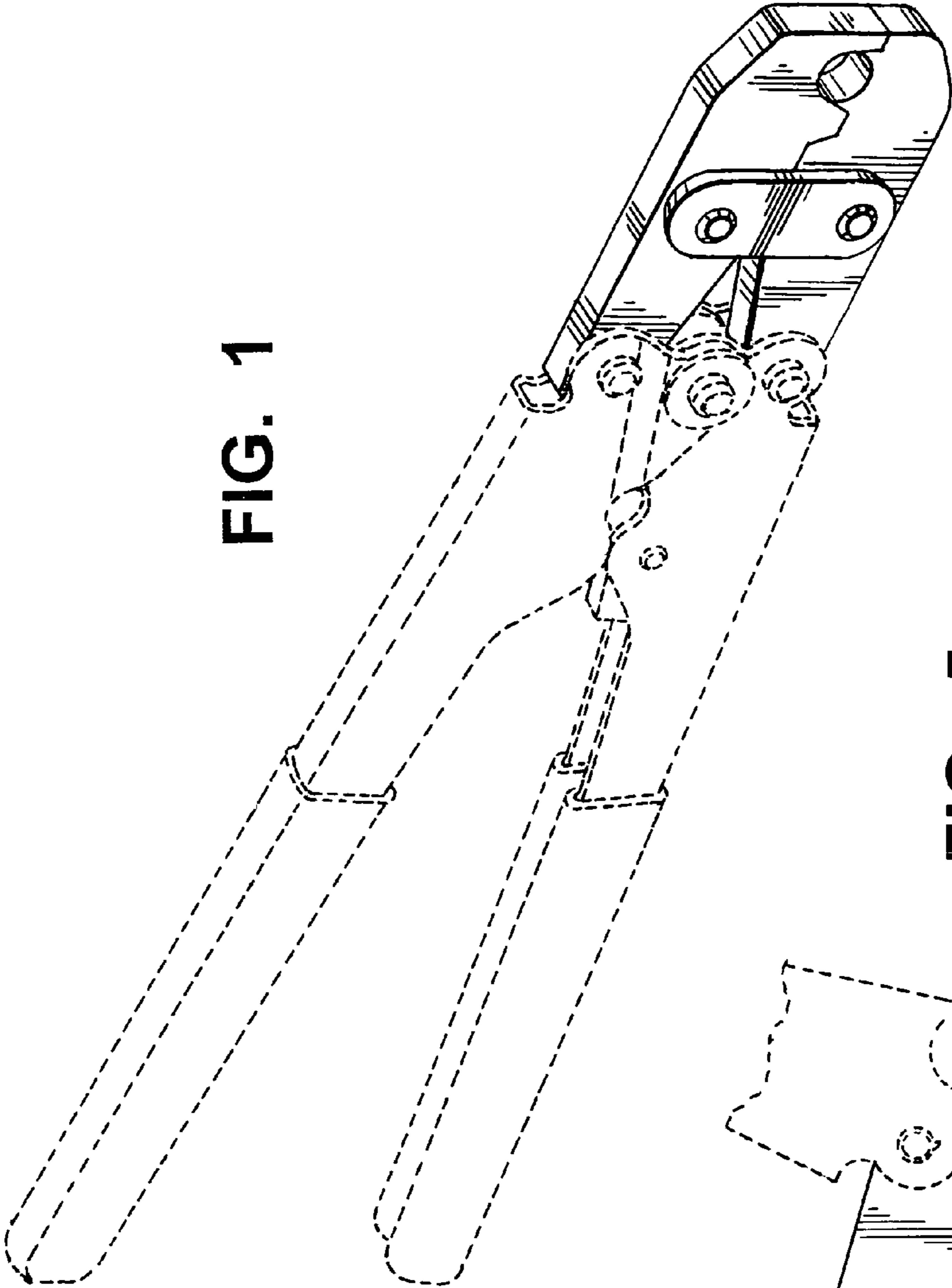

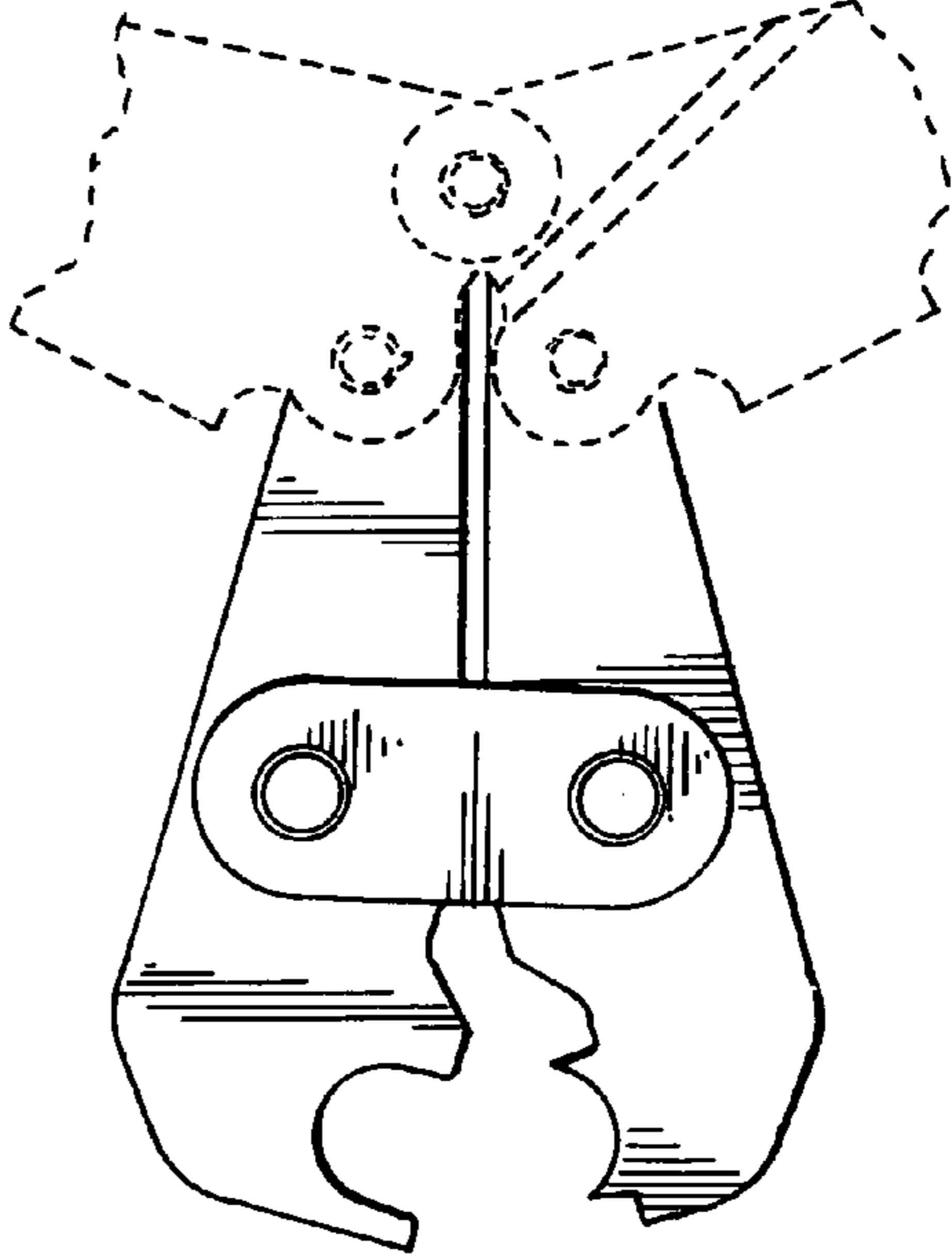

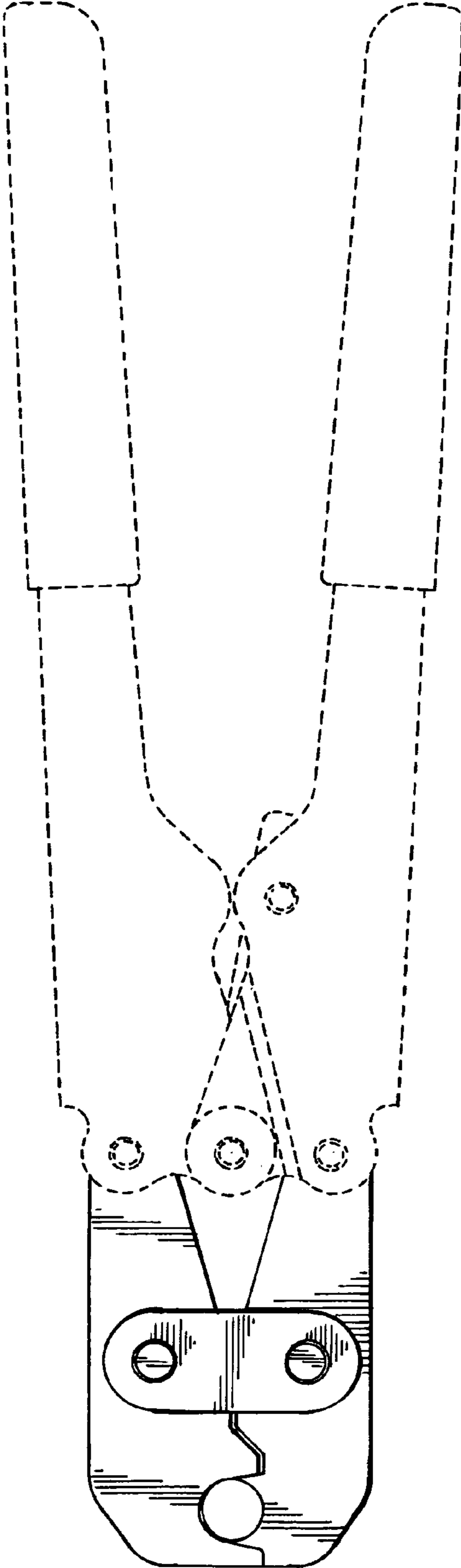
