FIG. 3 is the back elevation view thereof;

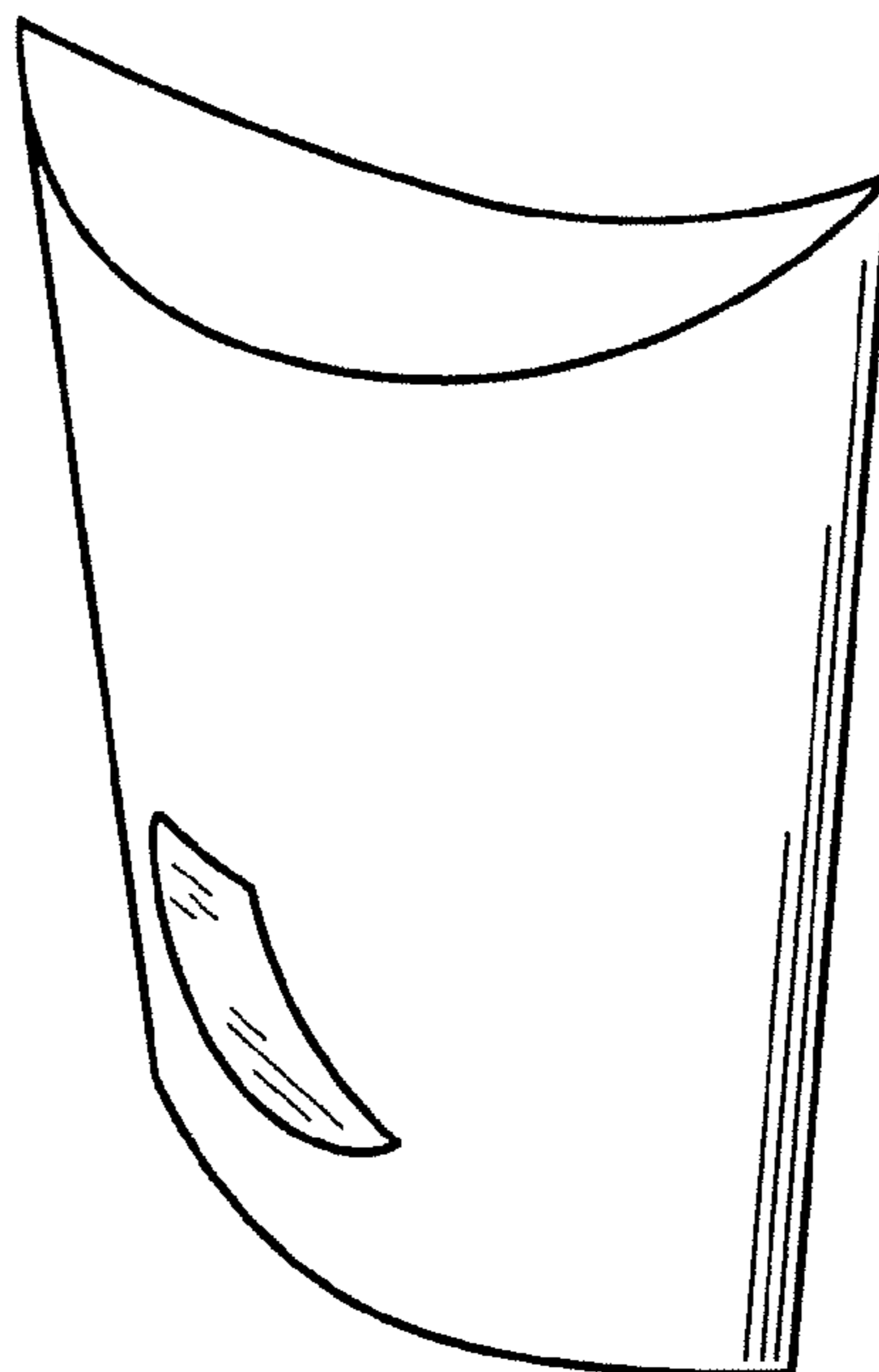
FIG. 4 is the left elevation view thereof;

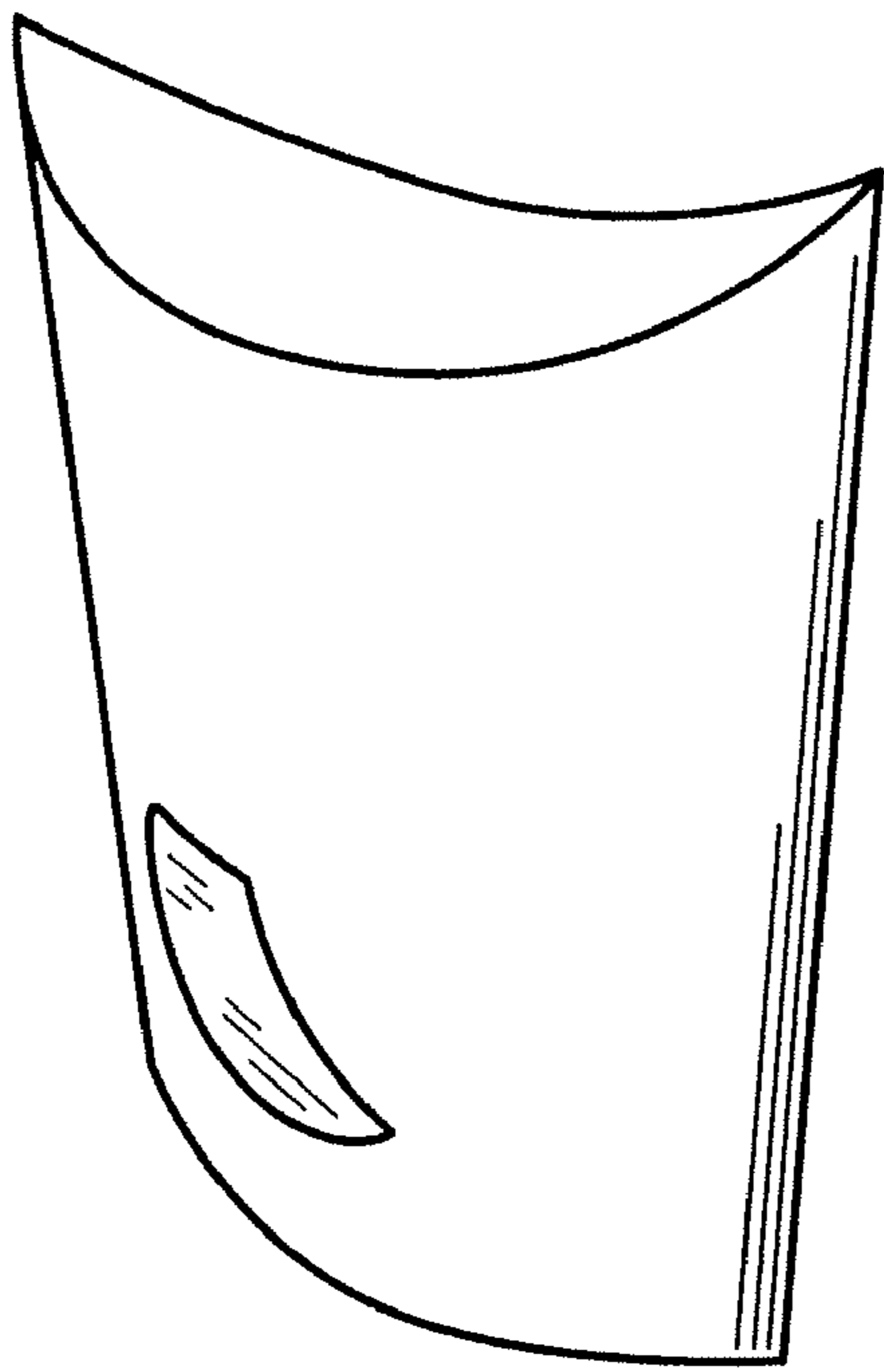

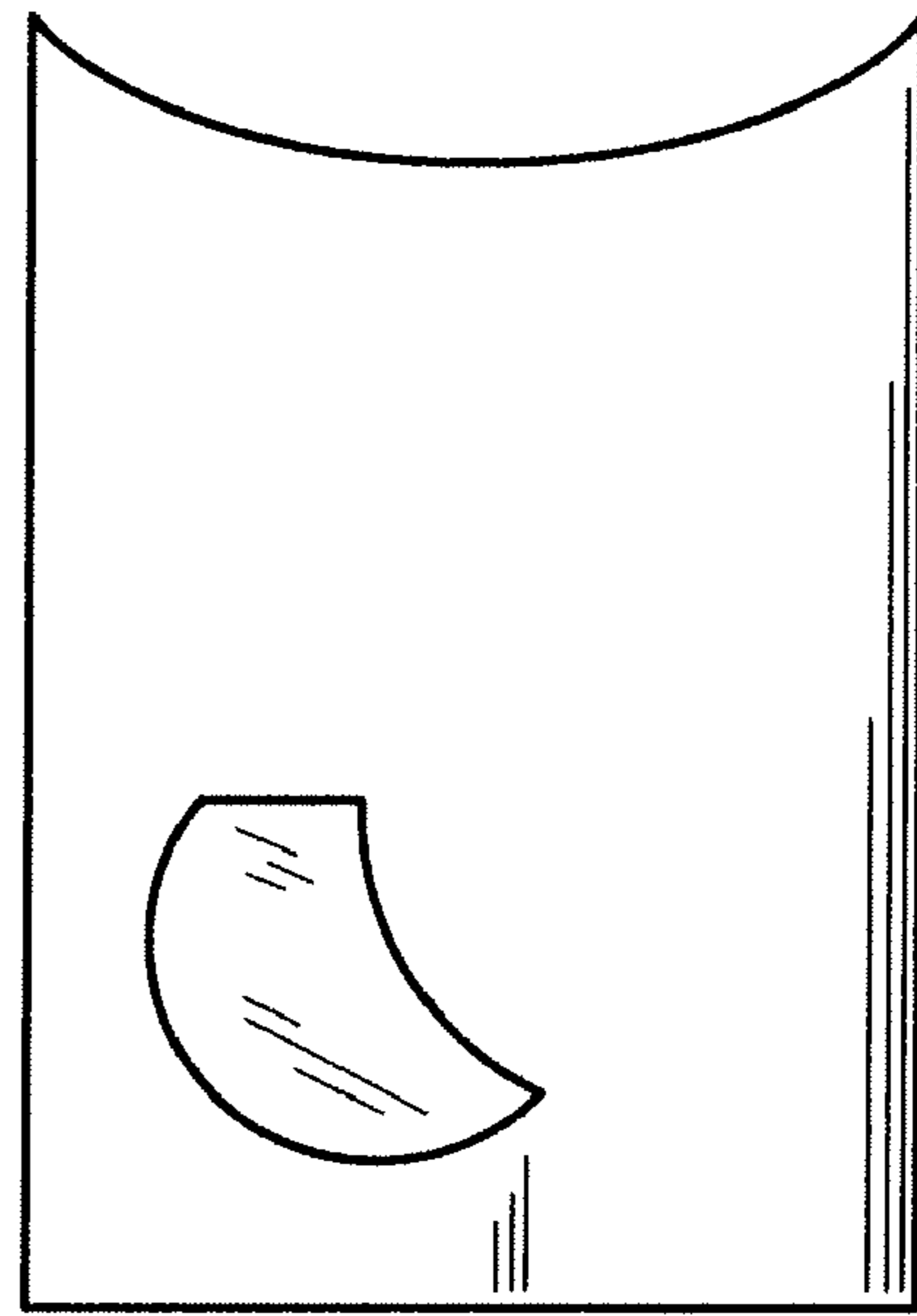

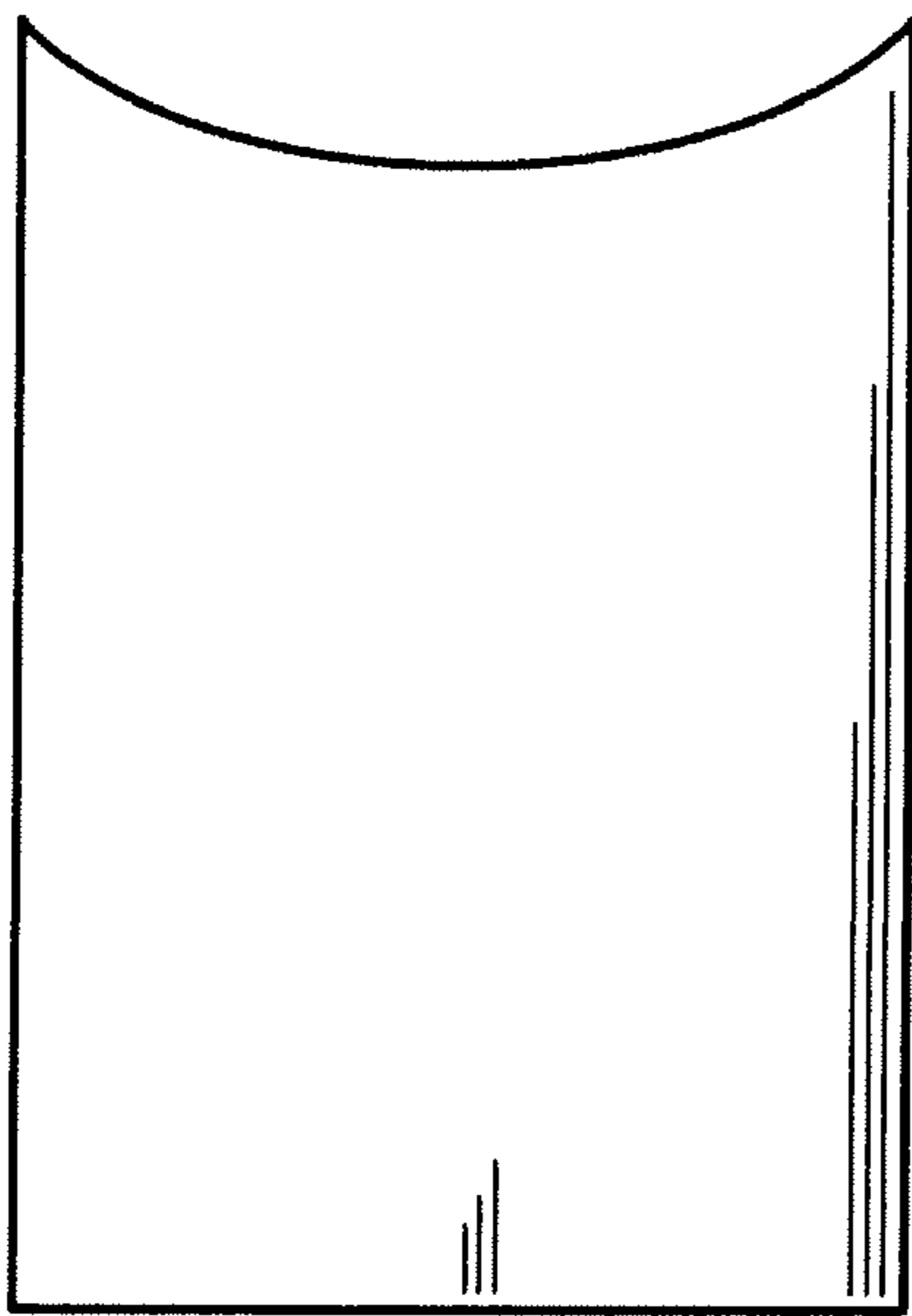

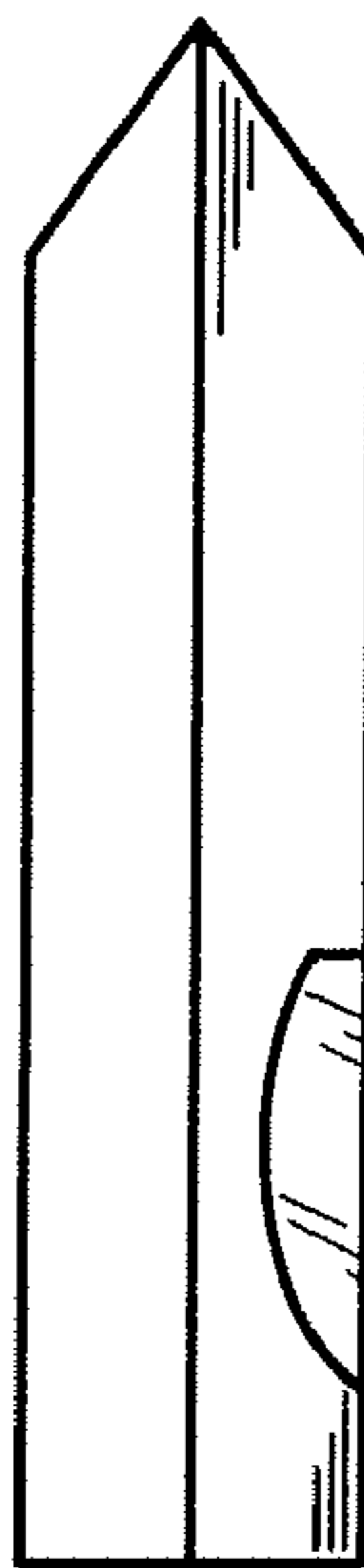

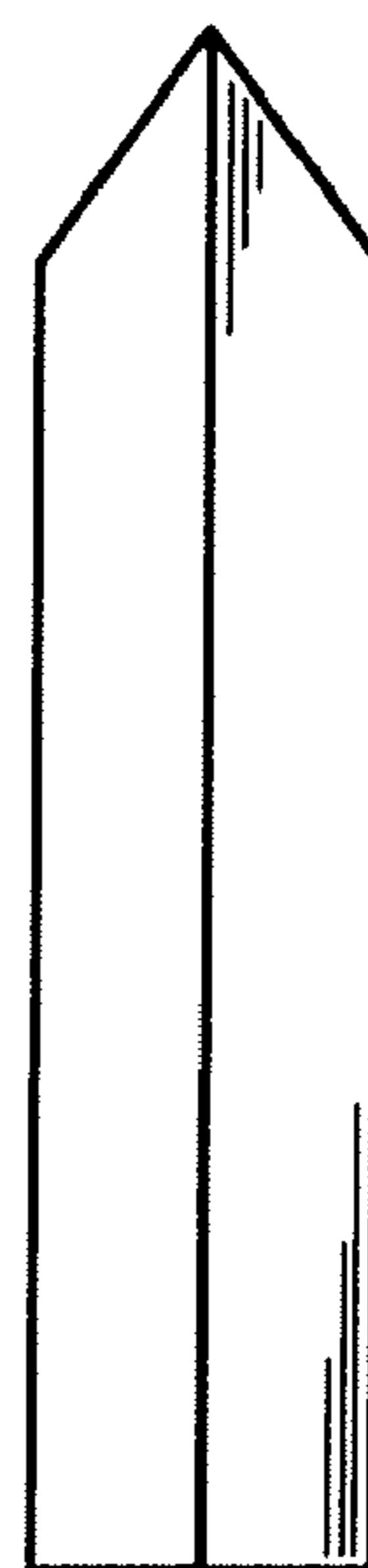
