(57) **CLAIM**

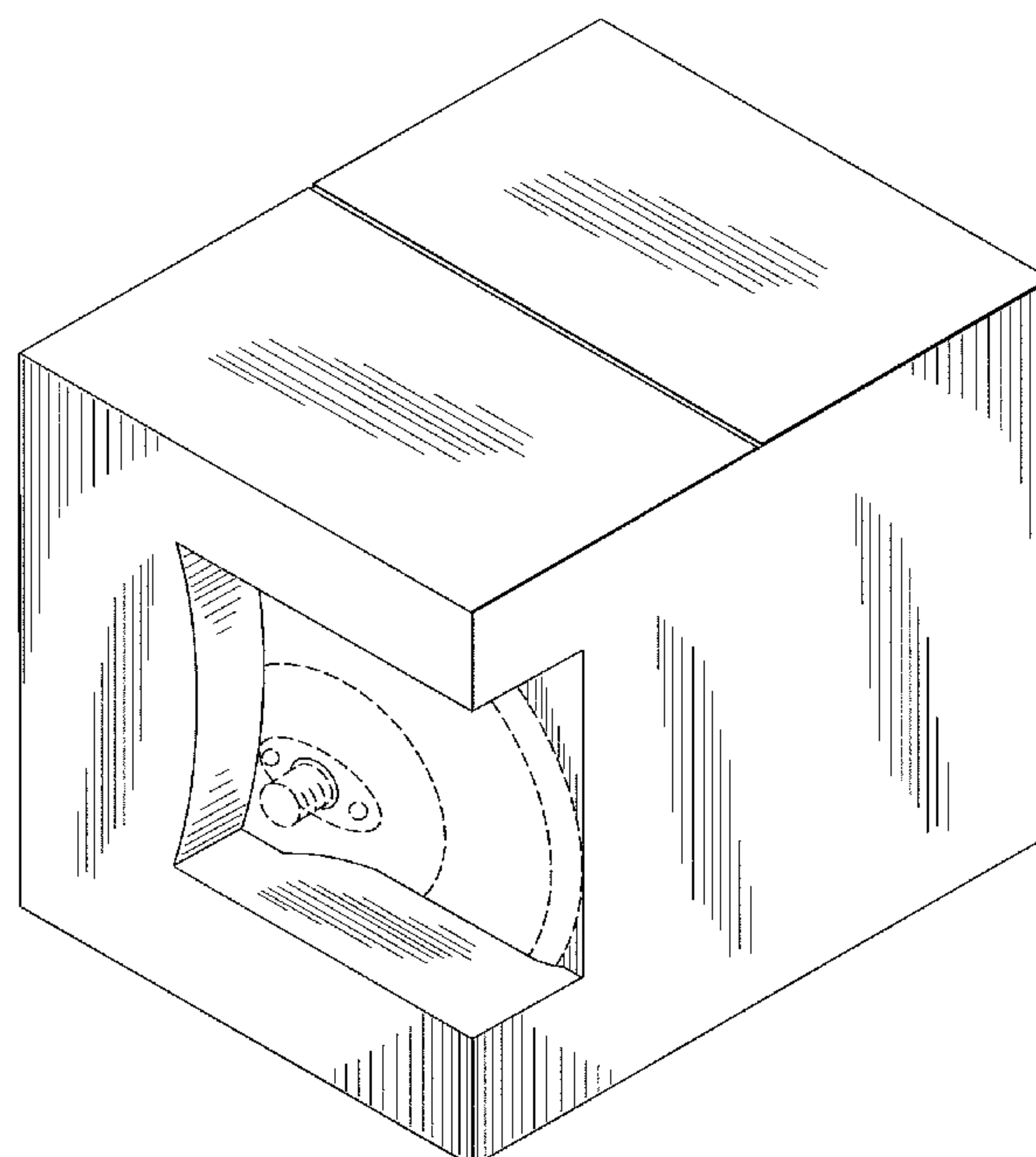
The ornamental design for a packaging for a hose reel, as shown and described.

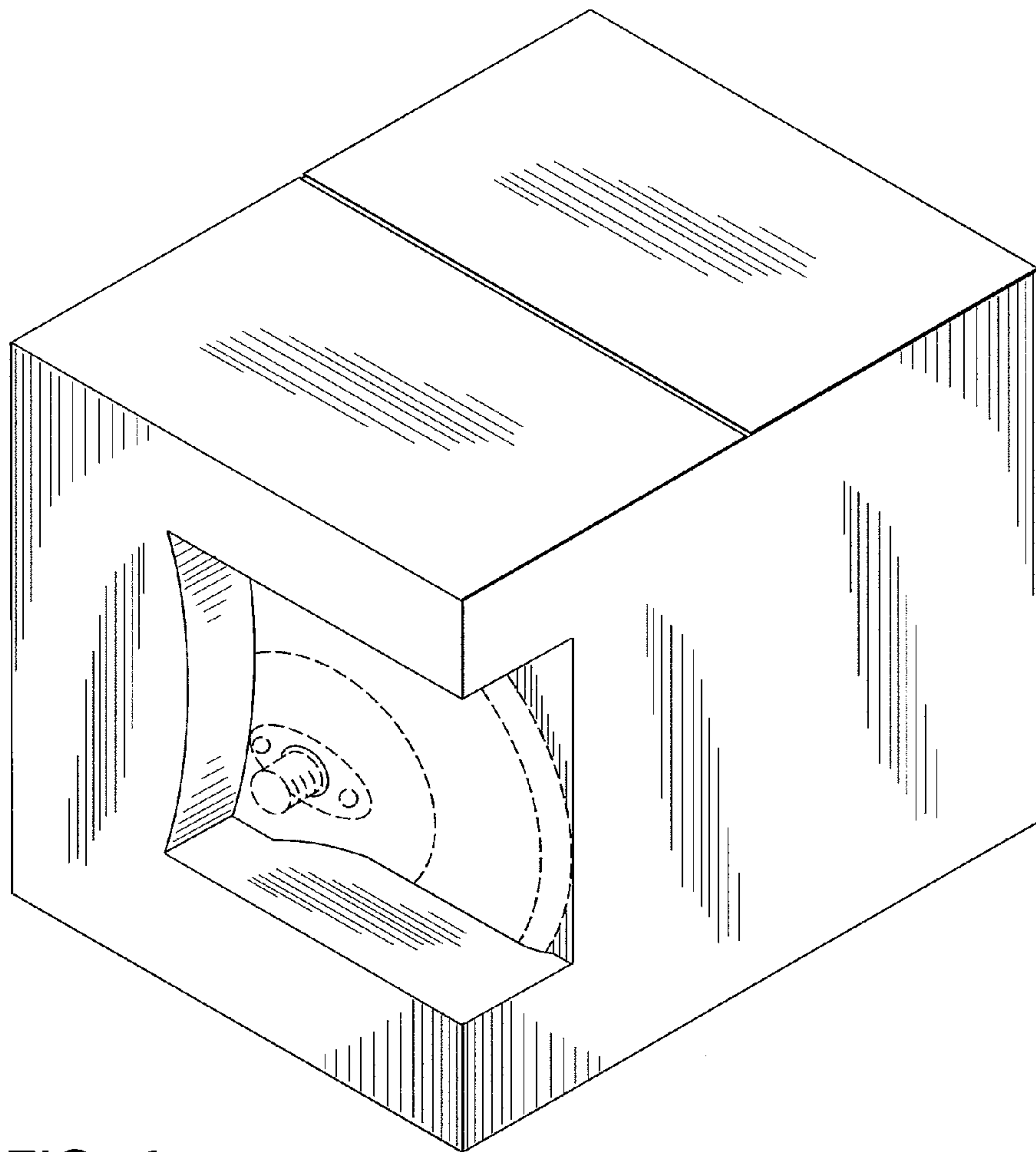

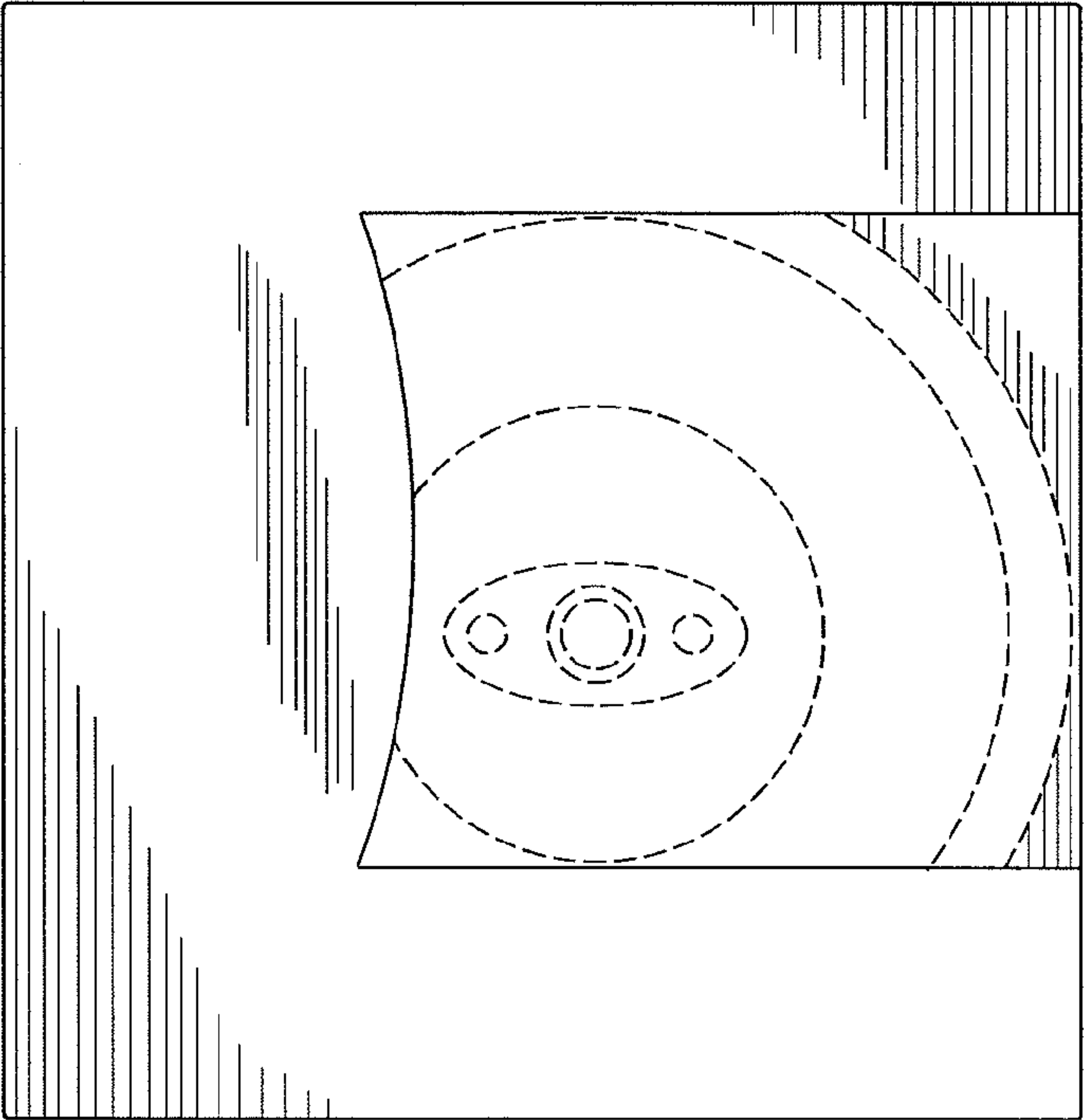

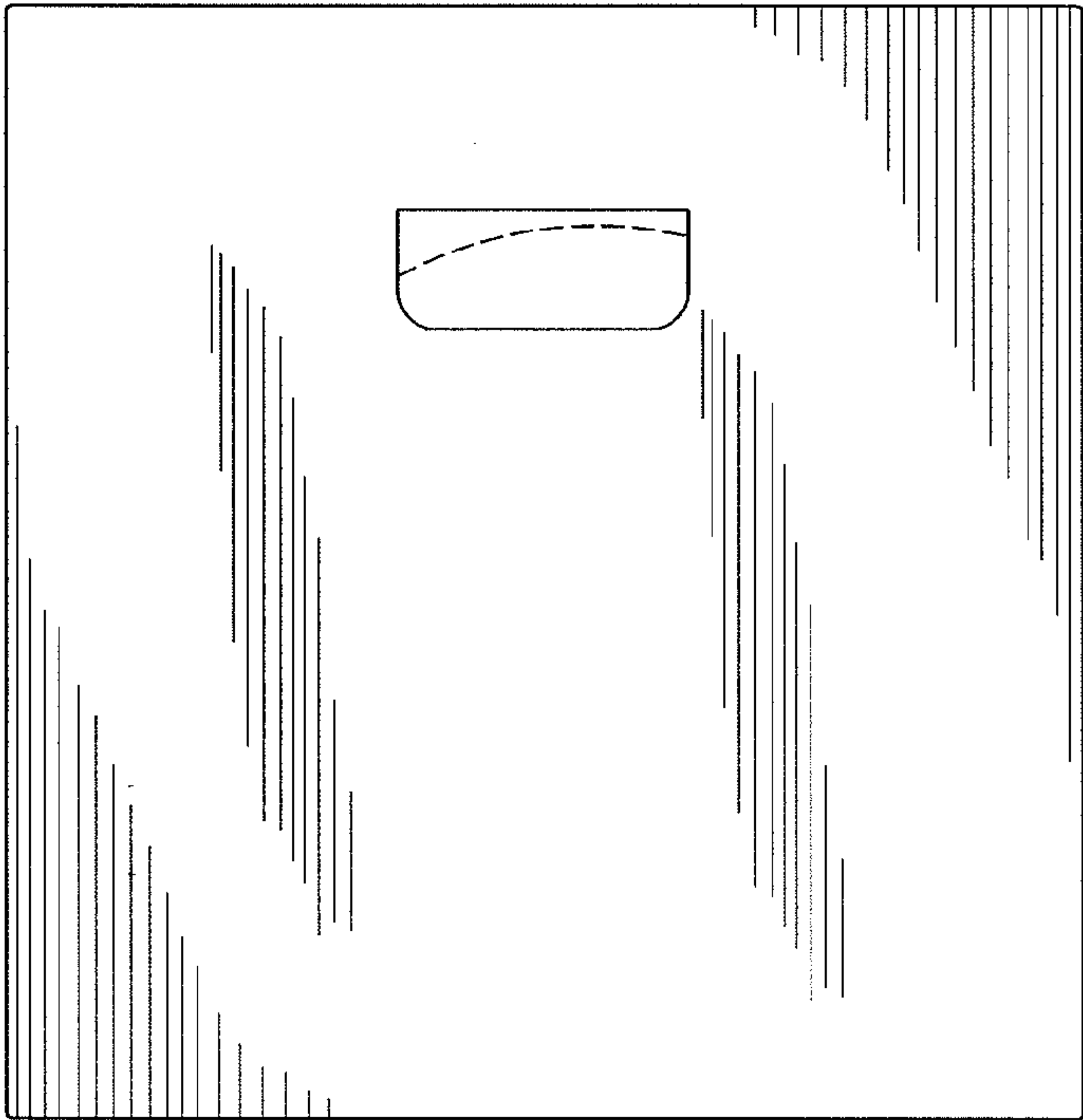

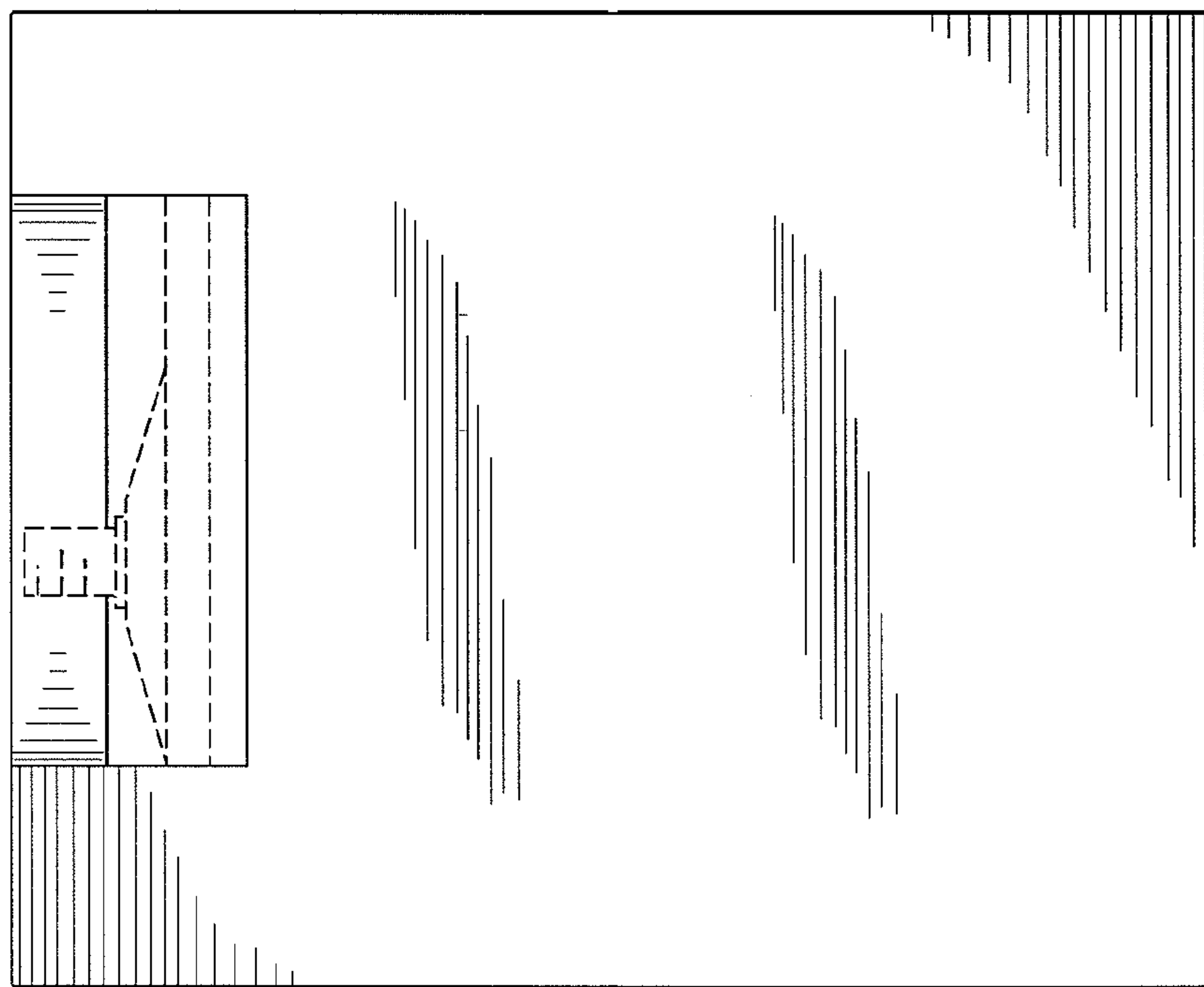

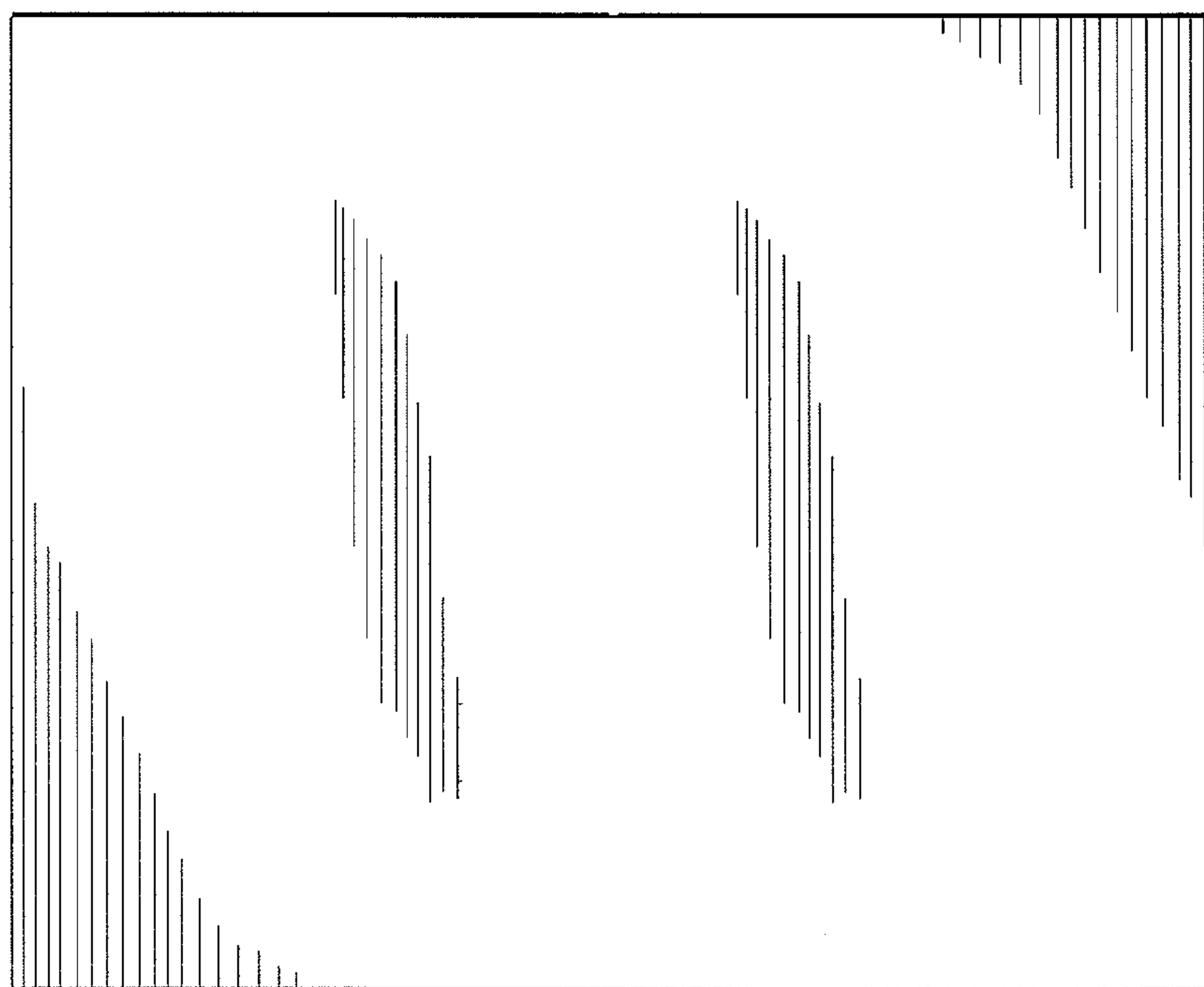

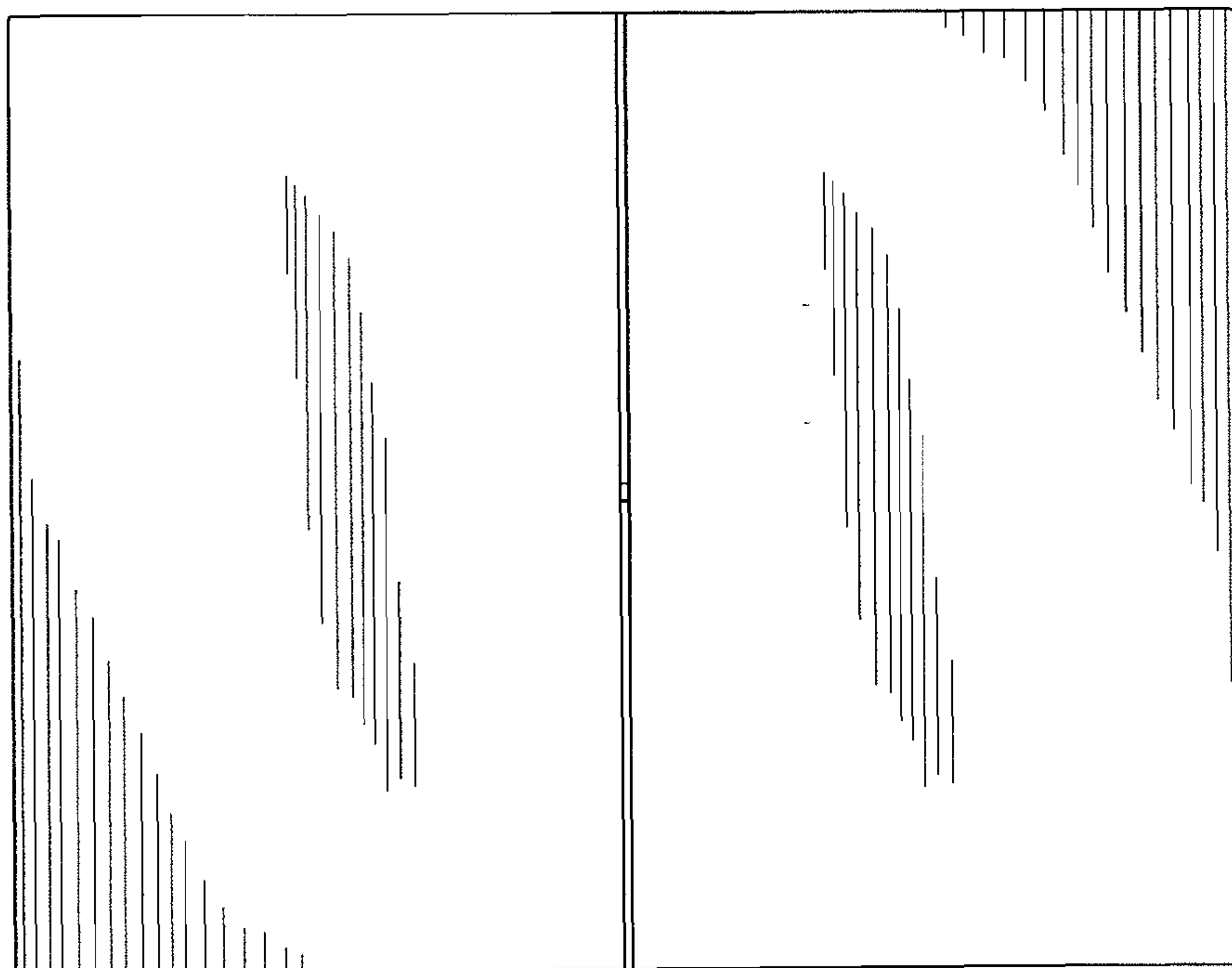

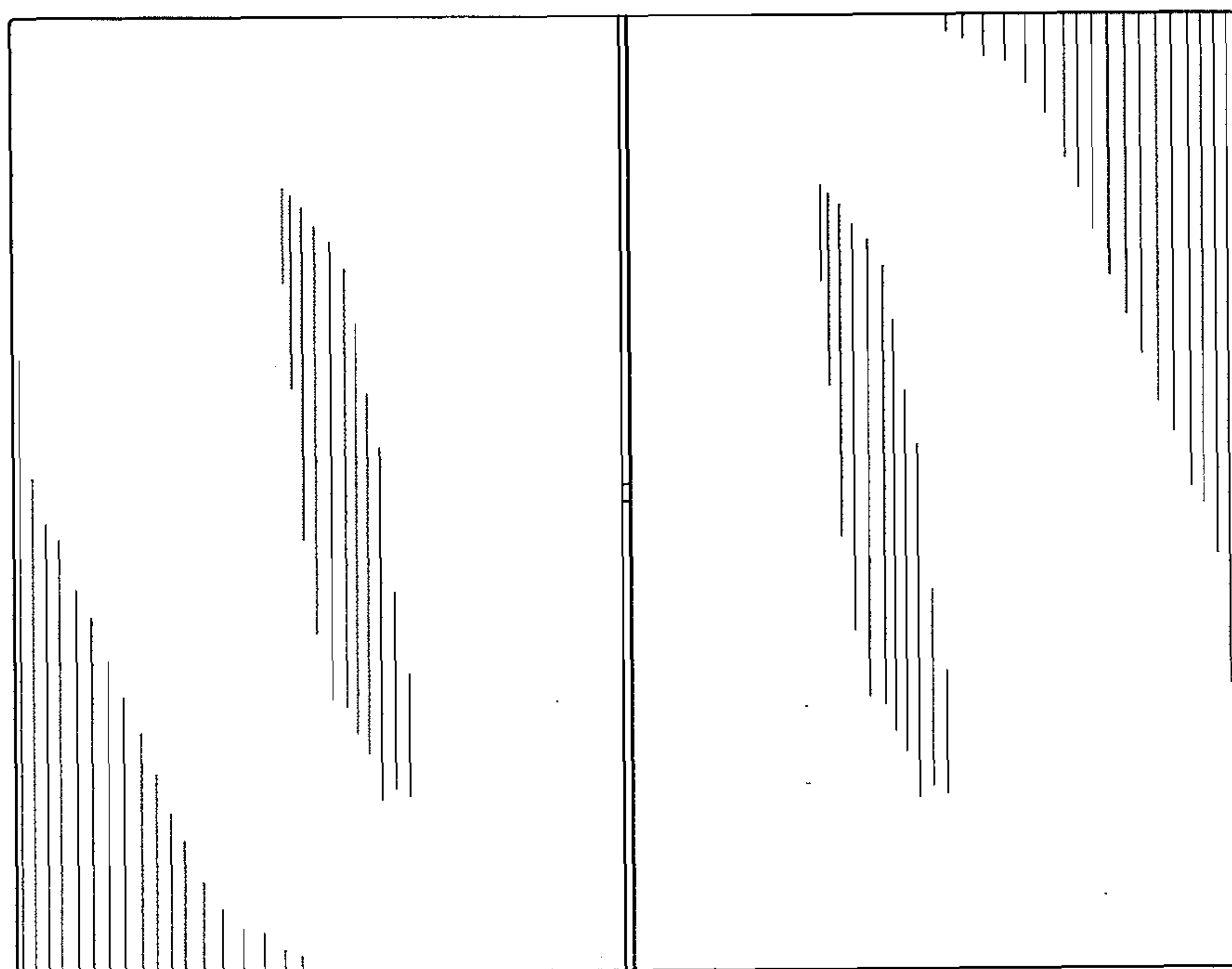
