FIG. 1 is a perspective view of the pivoting lid for a beverage can showing my new design;

FIG. 2 is a perspective pivoted partially open view of my new design;

FIG. 3 is a side view, the other side being a mirror image of the side shown;

FIG. 4 is a front view of the pivoting lid for a beverage can;

FIG. 5 is a back view of the pivoting lid for a beverage can;

FIG. 6 is a top view of the pivoting lid for a beverage can as shown in FIG. 1; and,

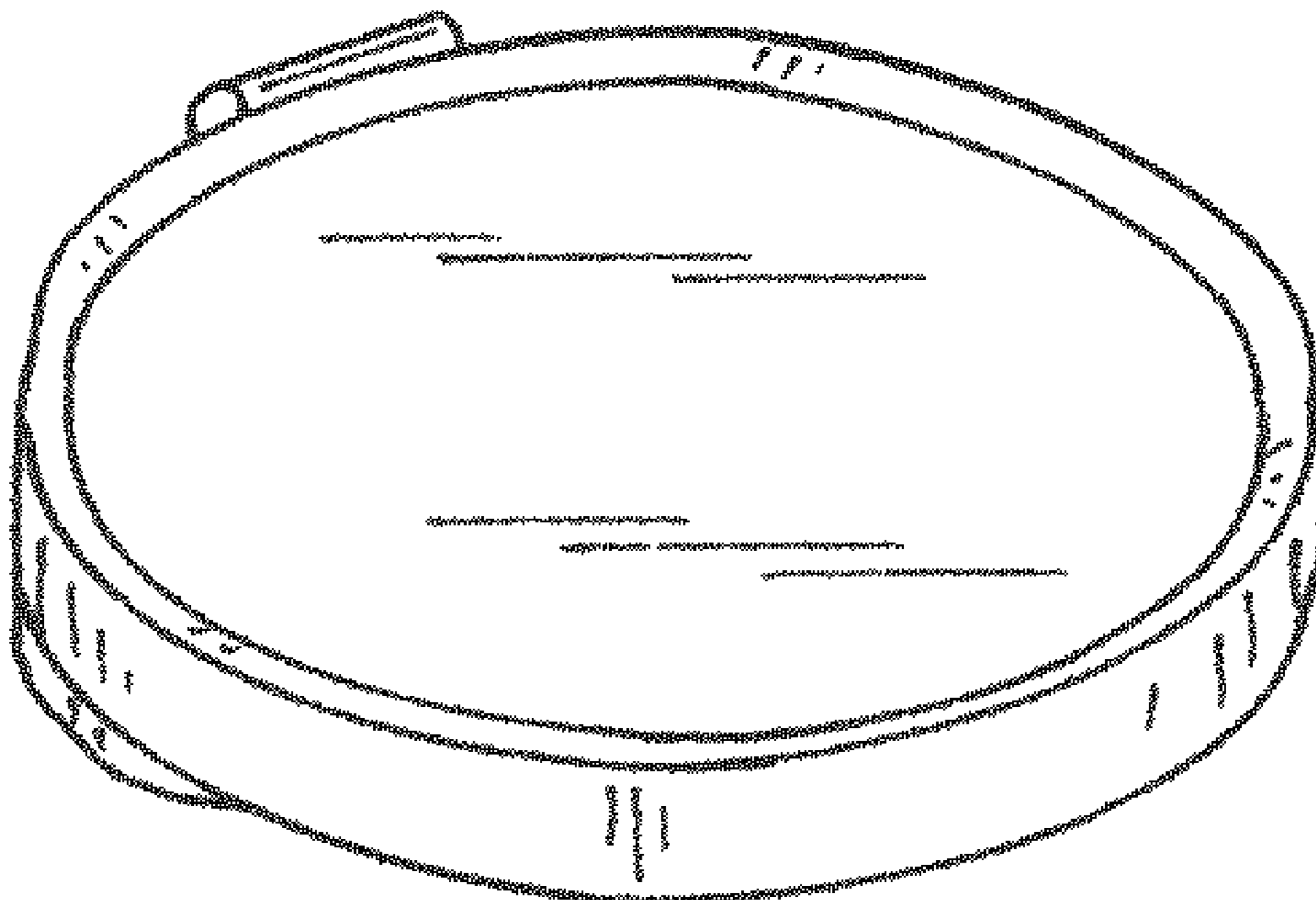
FIG. 7 is a bottom view of the pivoting lid for a beverage can as shown in FIG. 1.

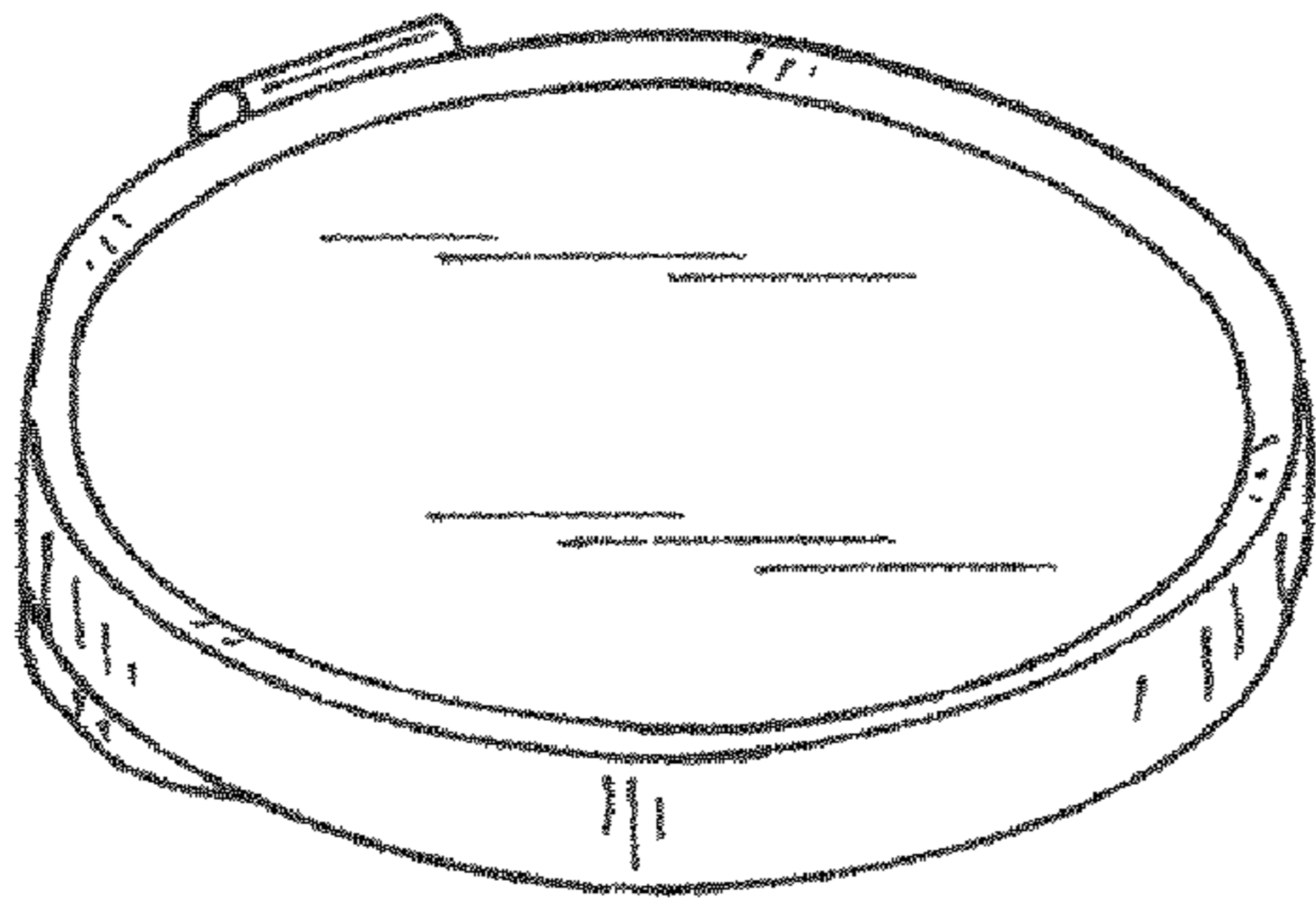

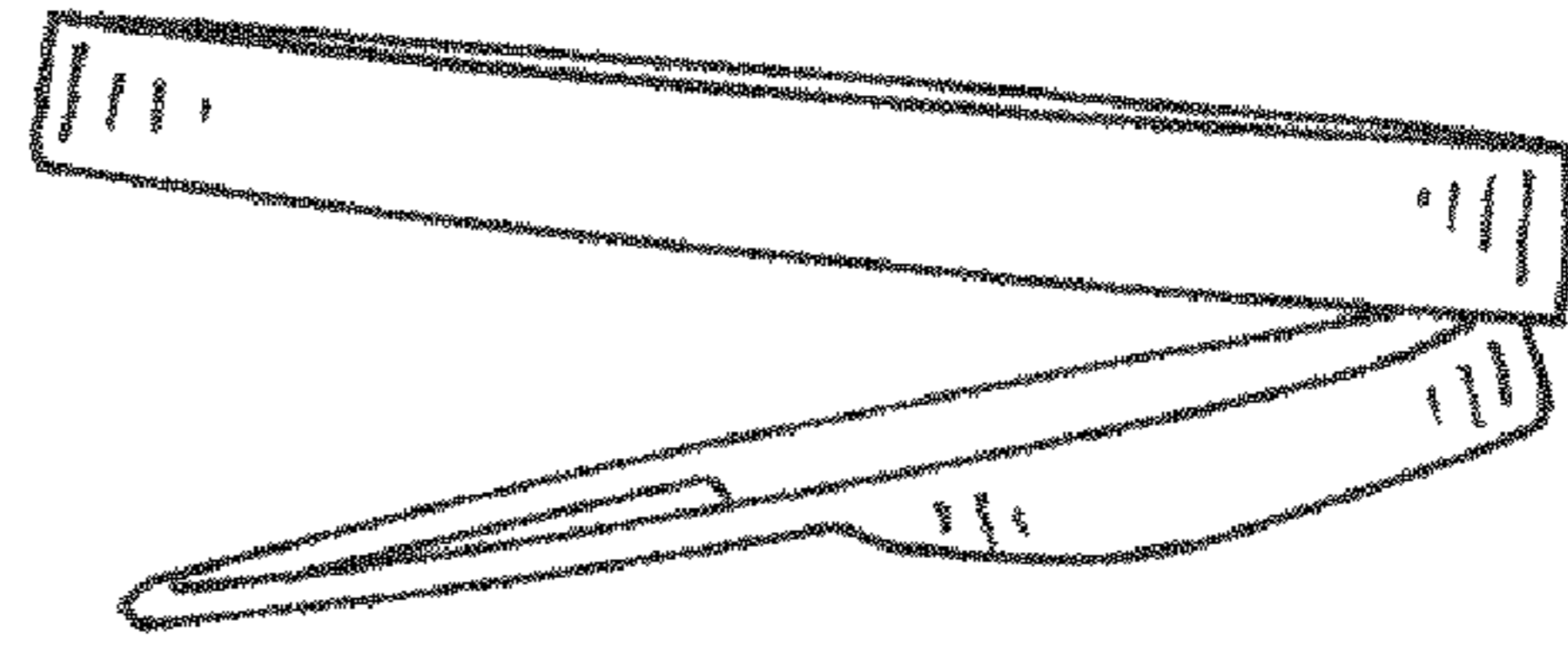

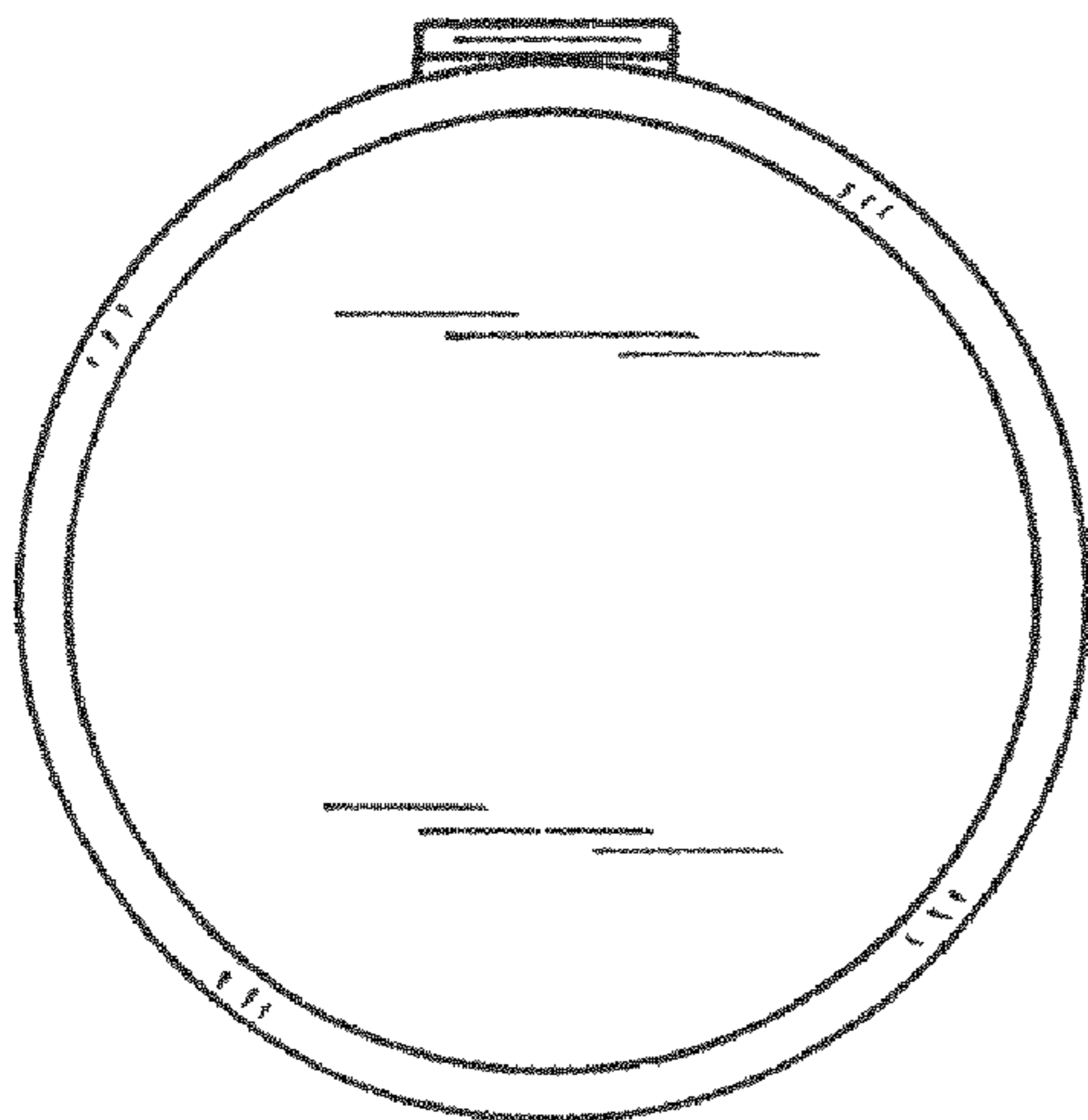
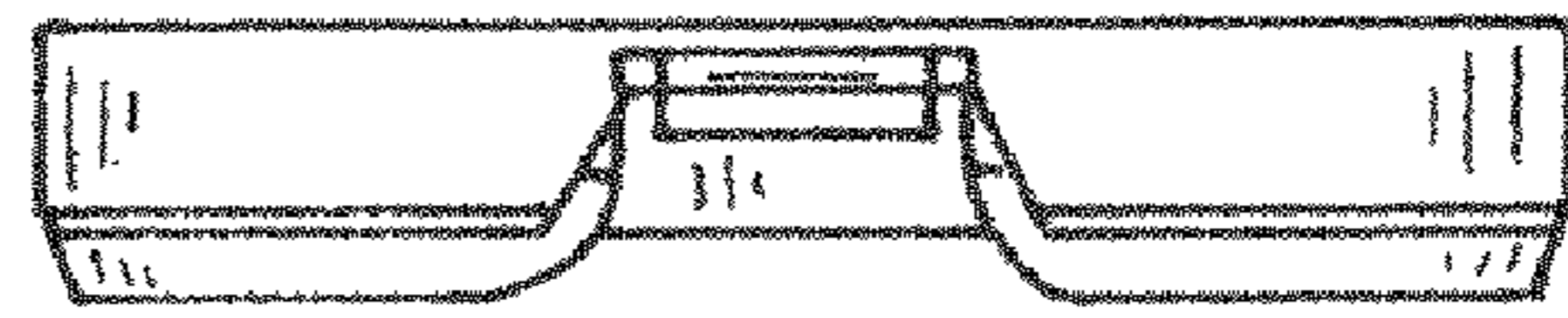

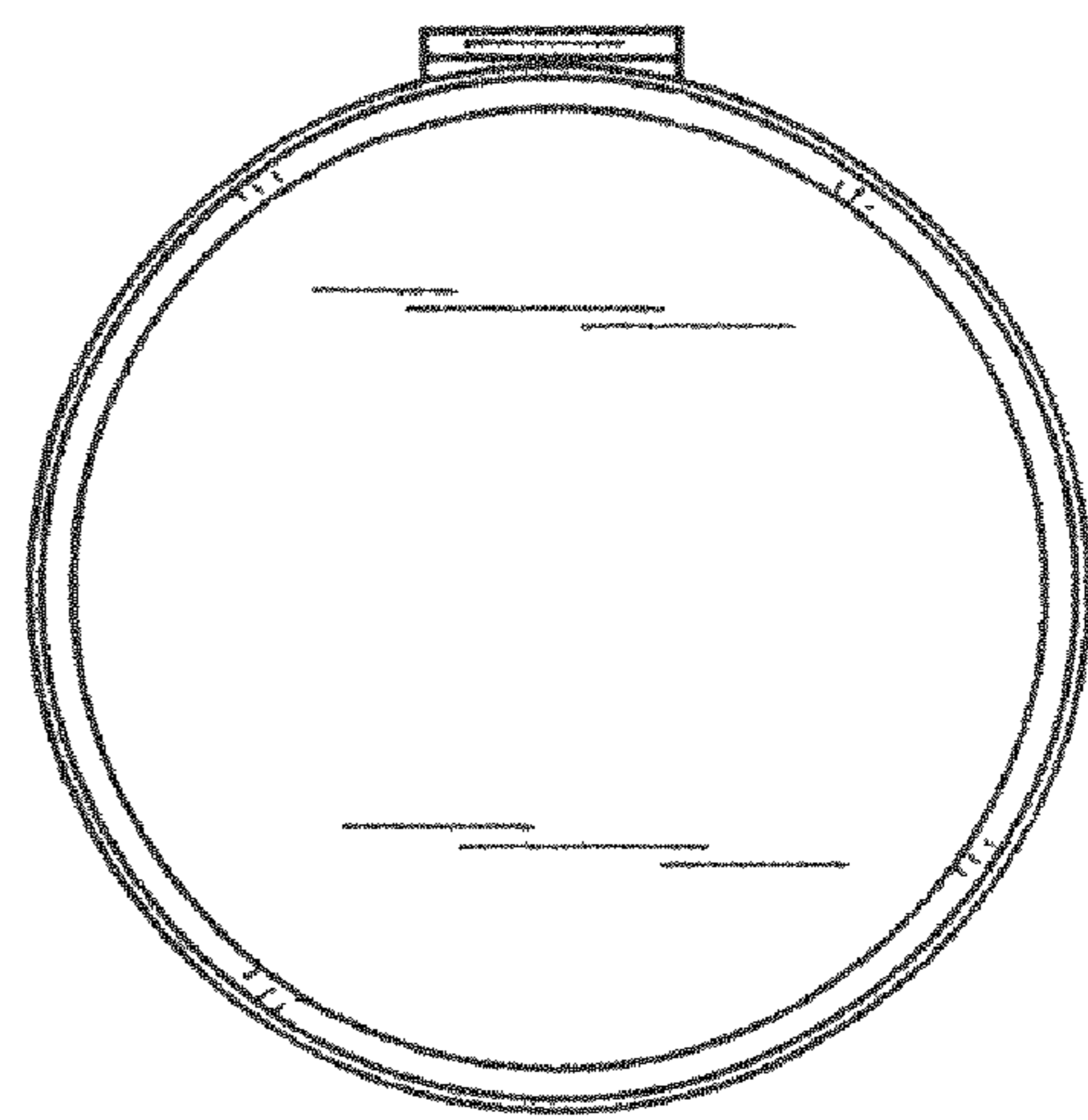
