FIG. 6 is a right side elevation view thereof;

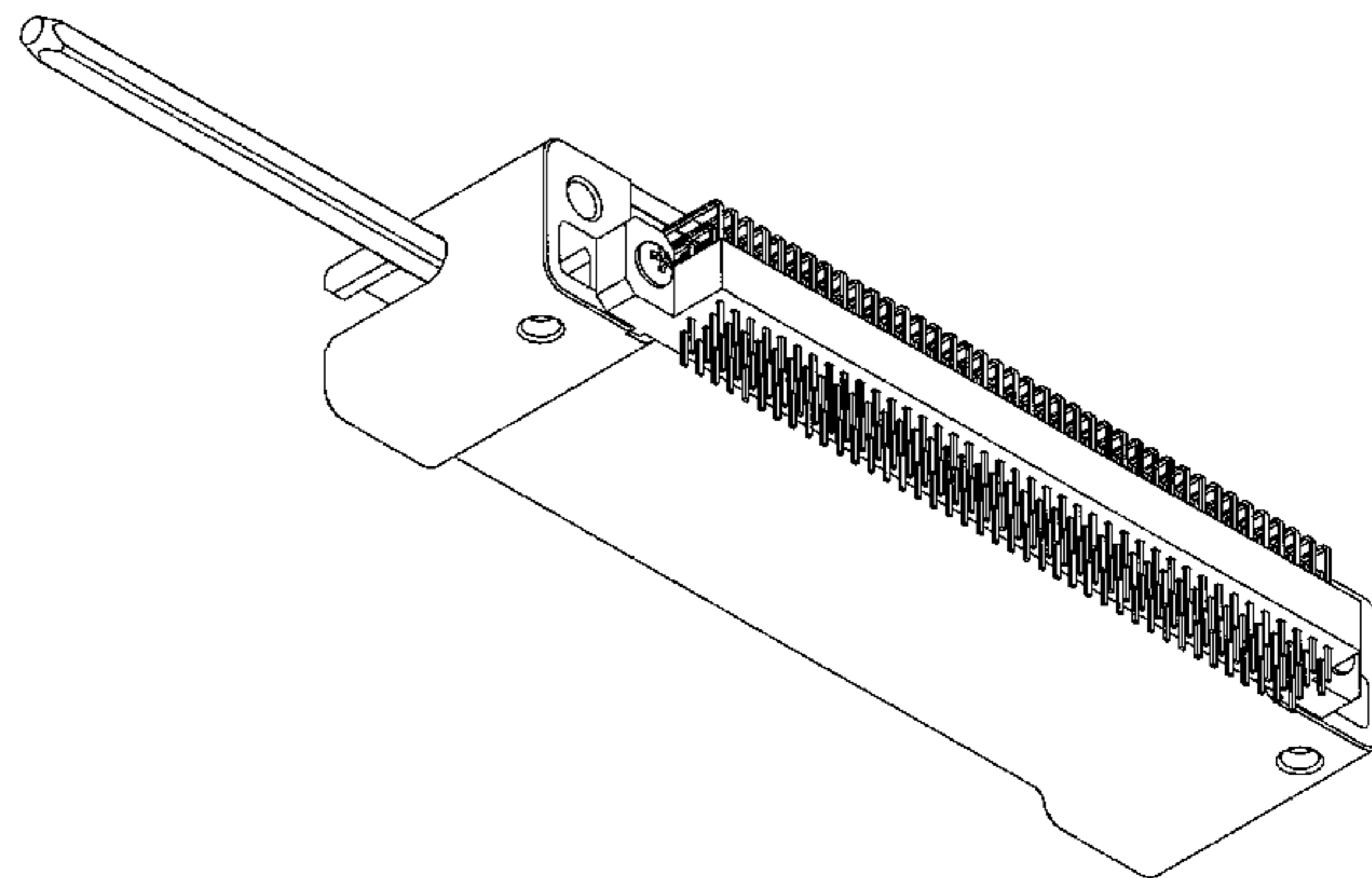
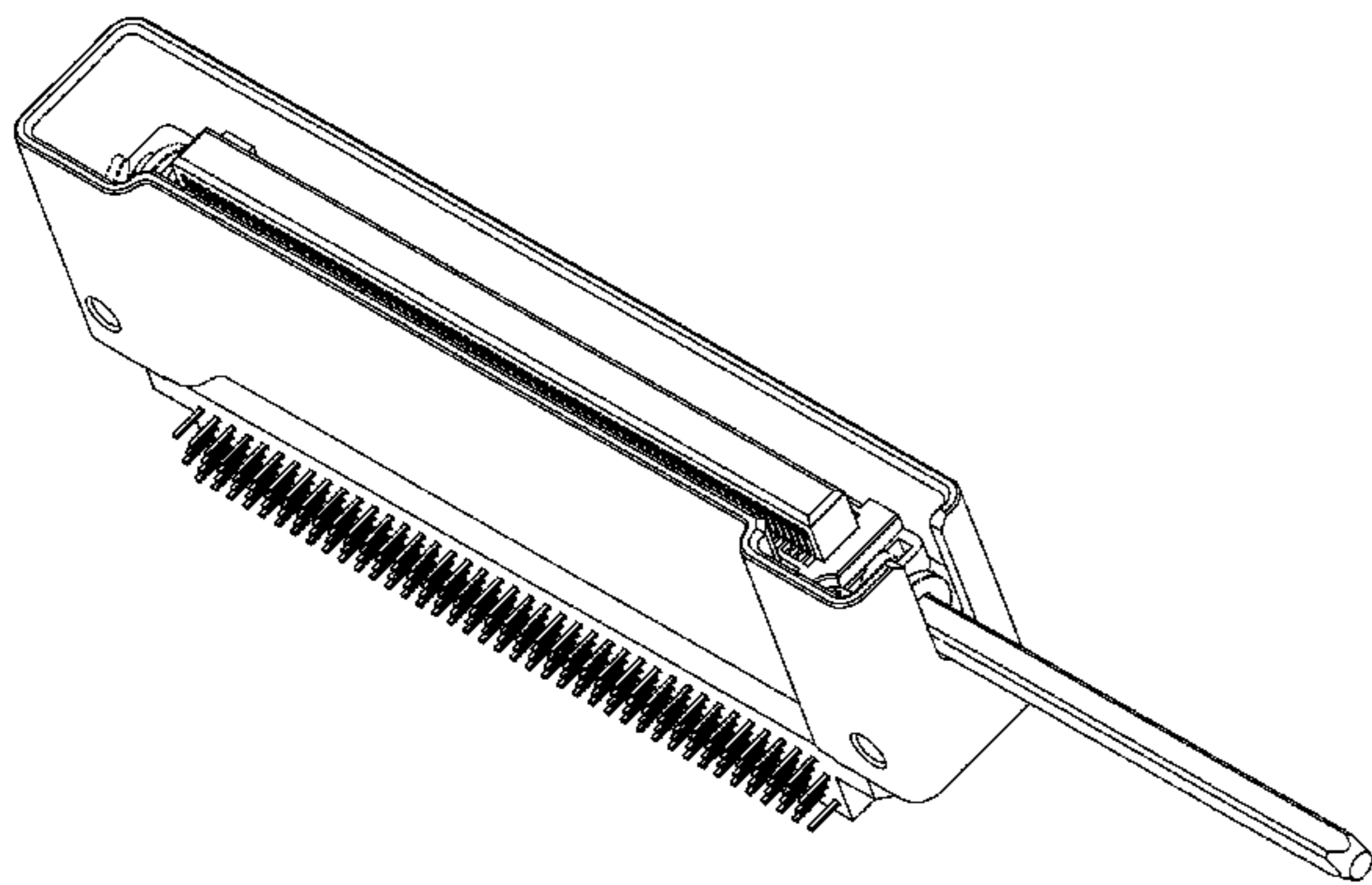
FIG. 7 is a front, top, and right side perspective view thereof;

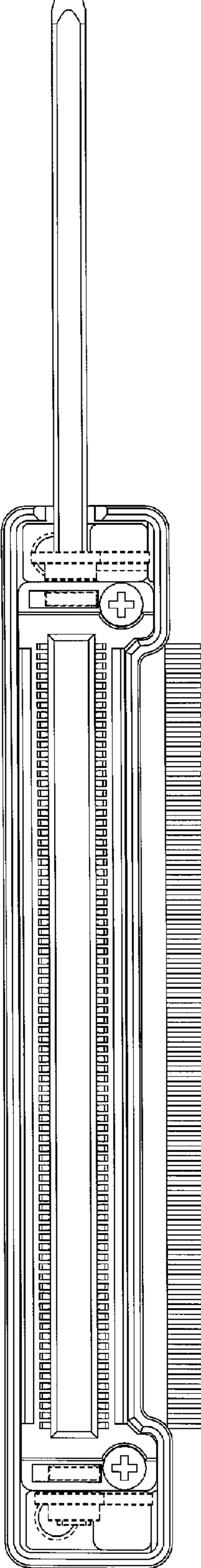
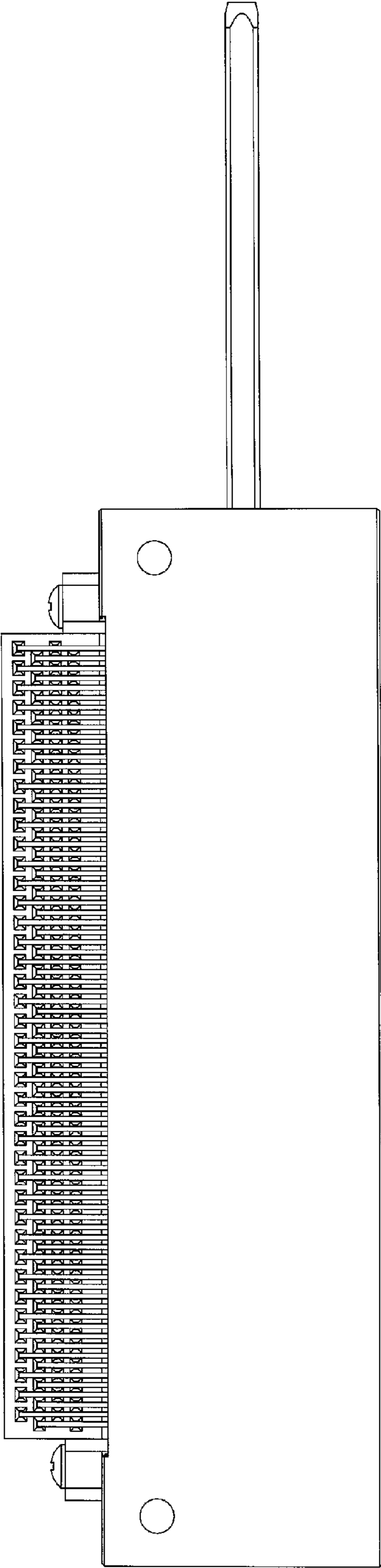

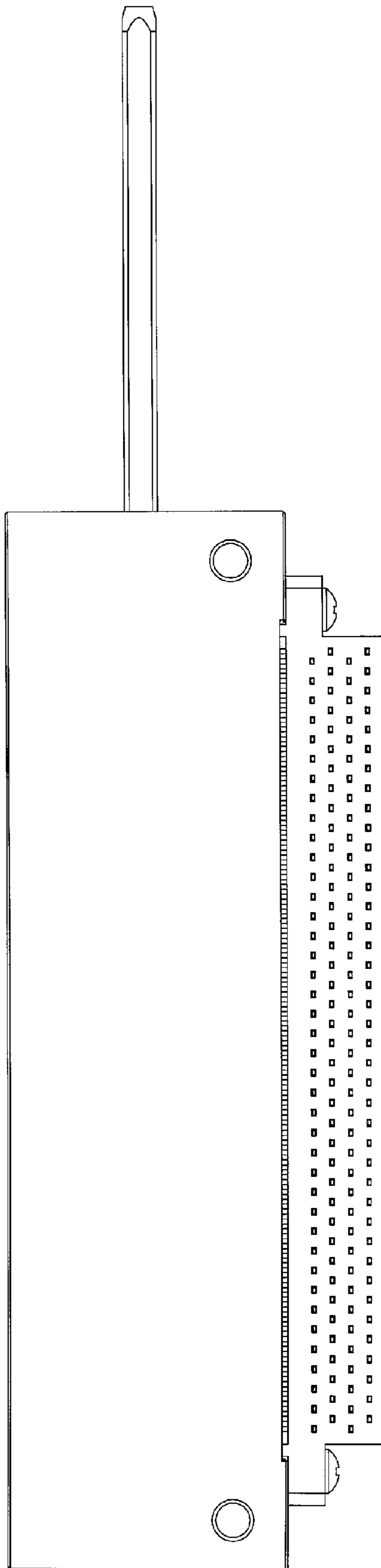

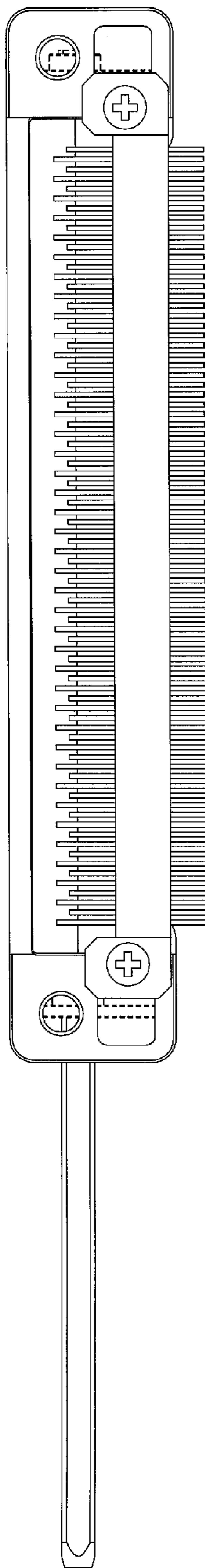
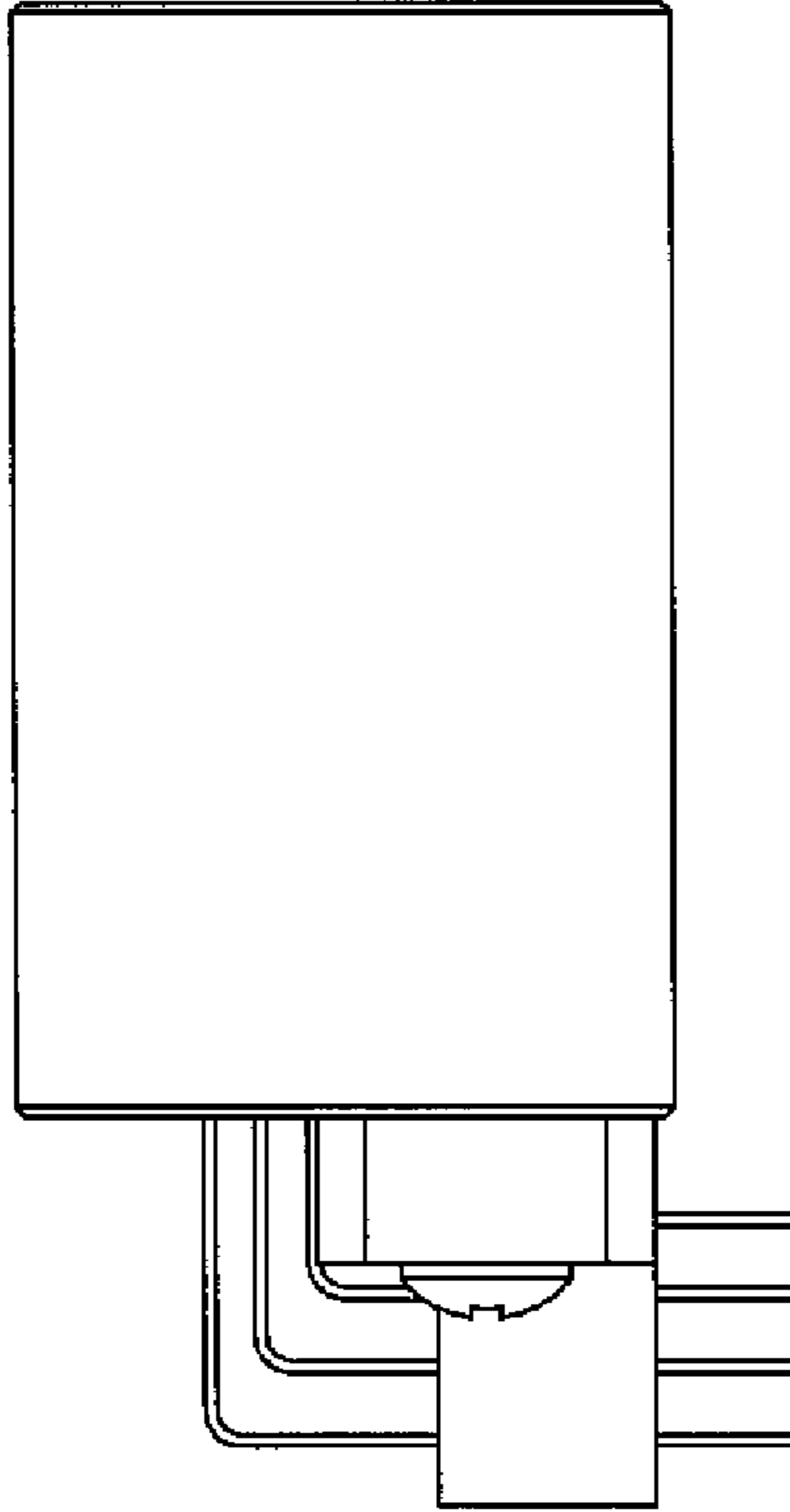
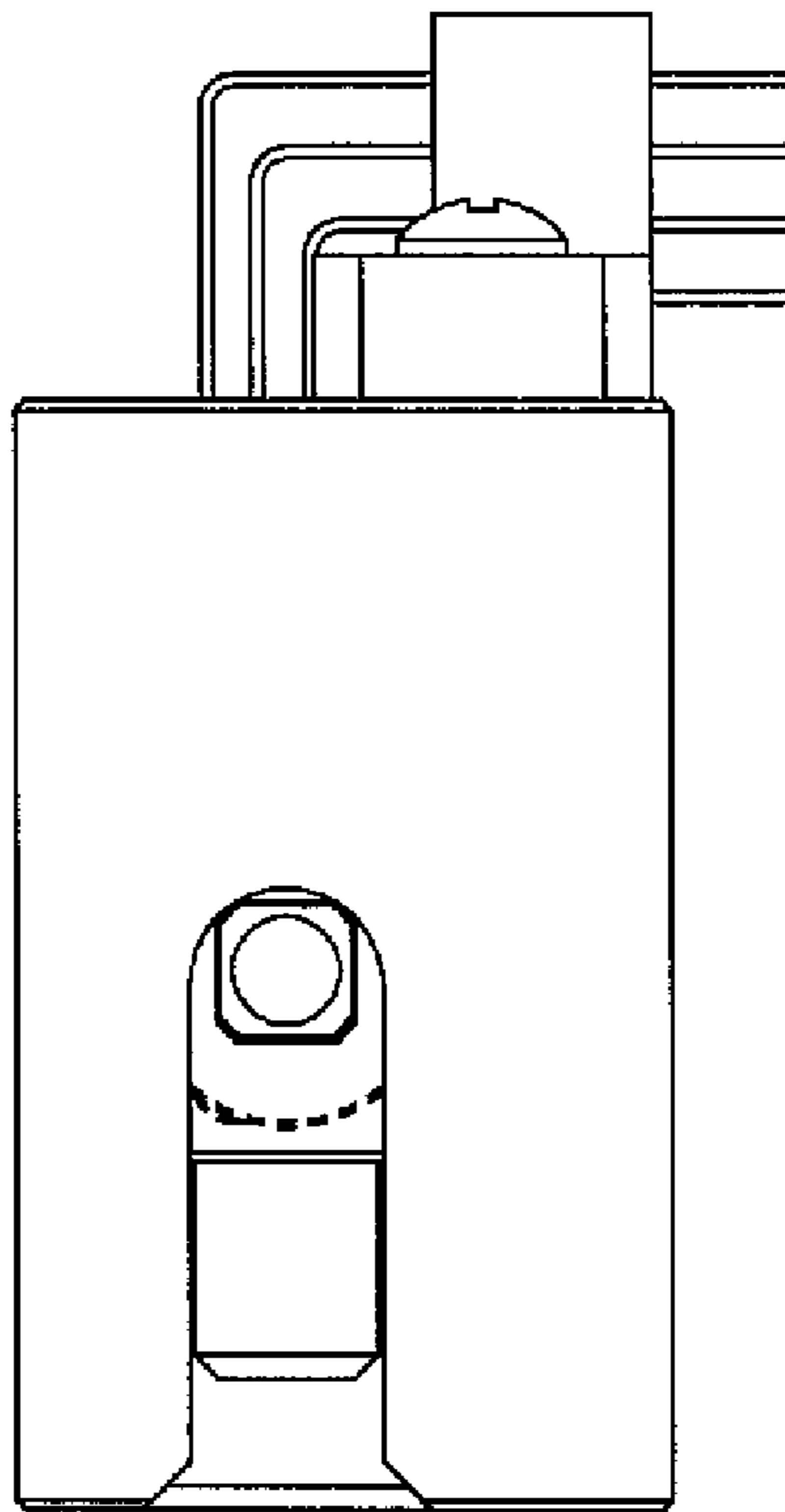

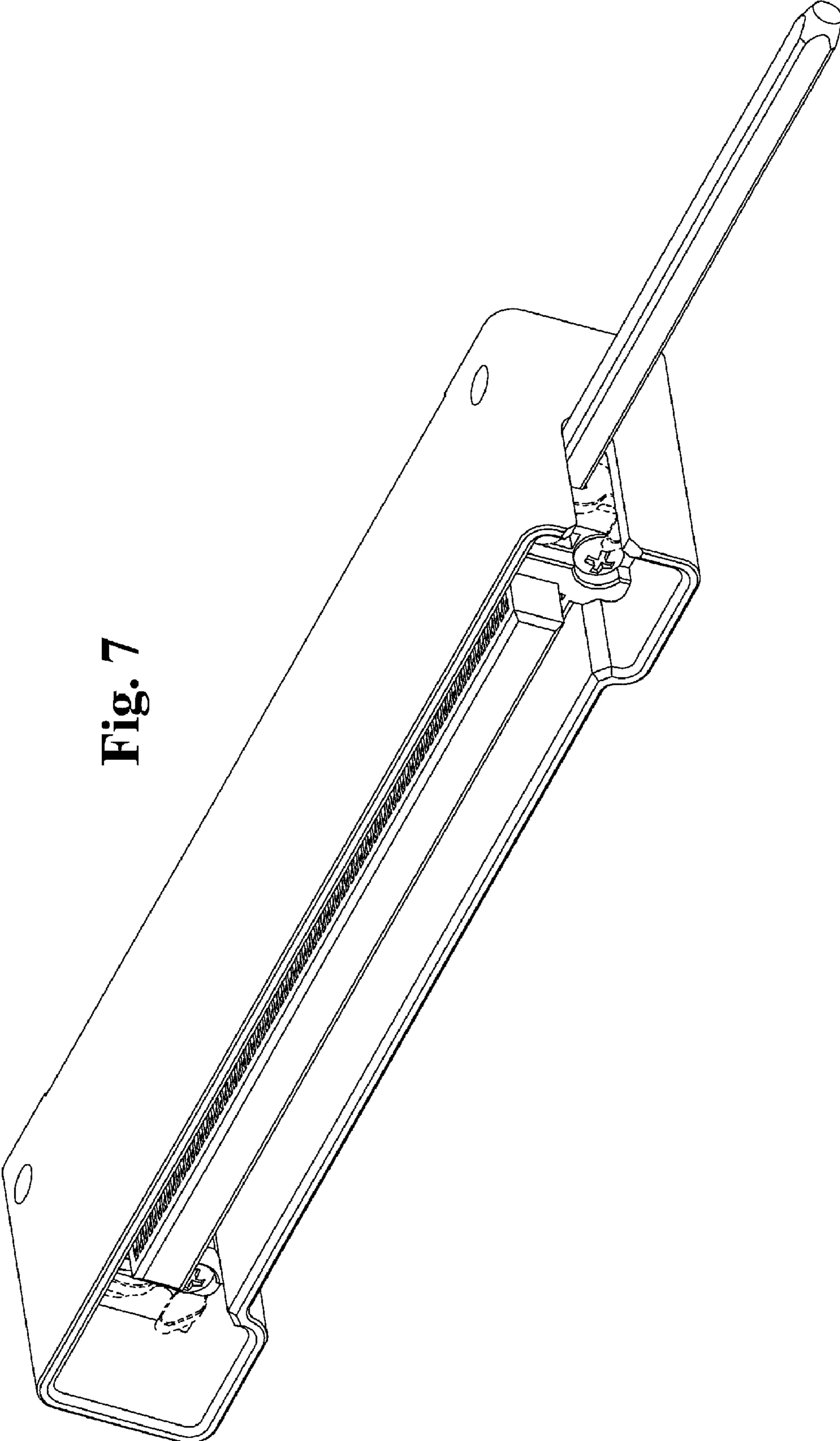
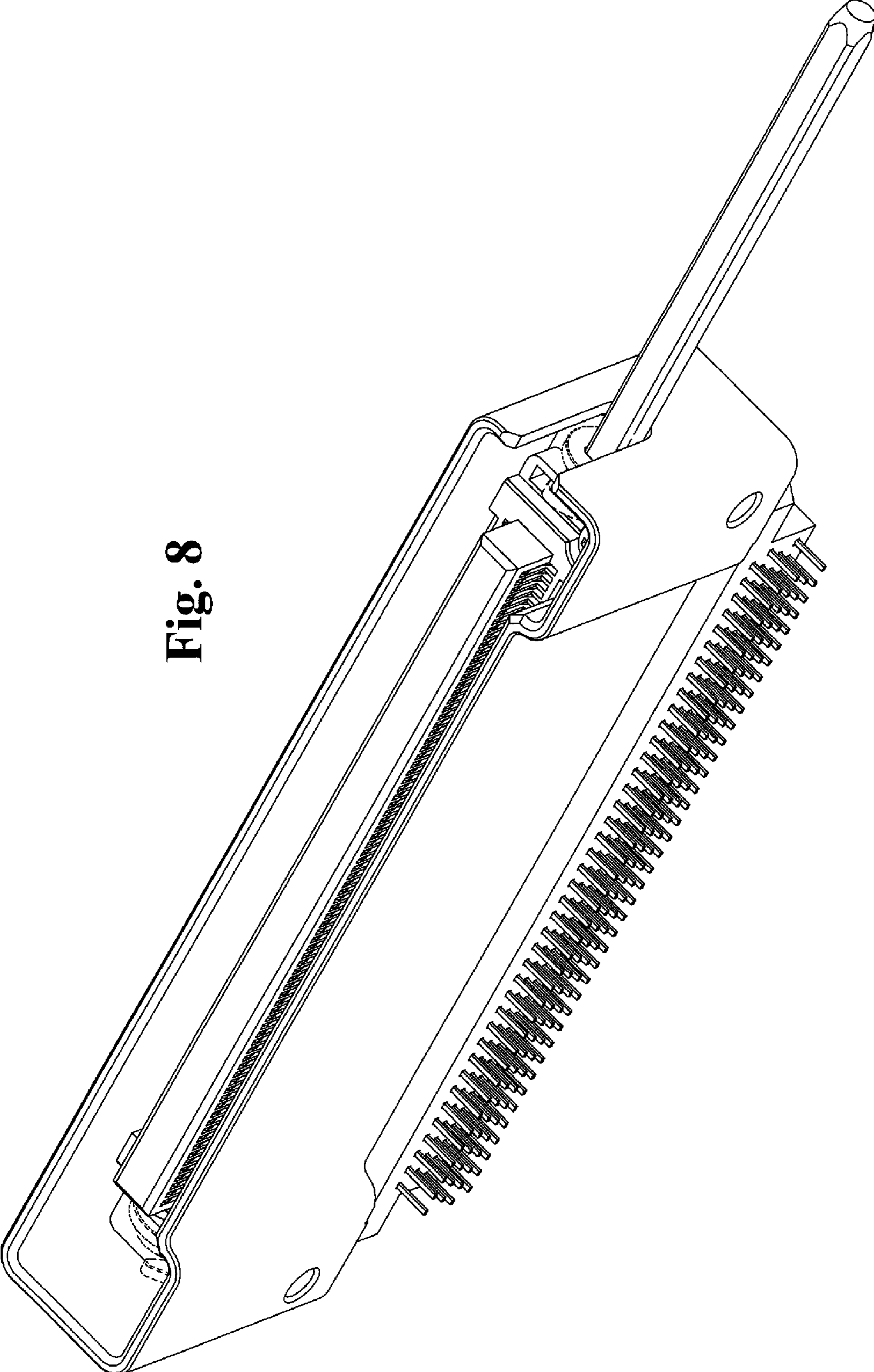
