FIG. 2 is a front view of a second embodiment thereof.

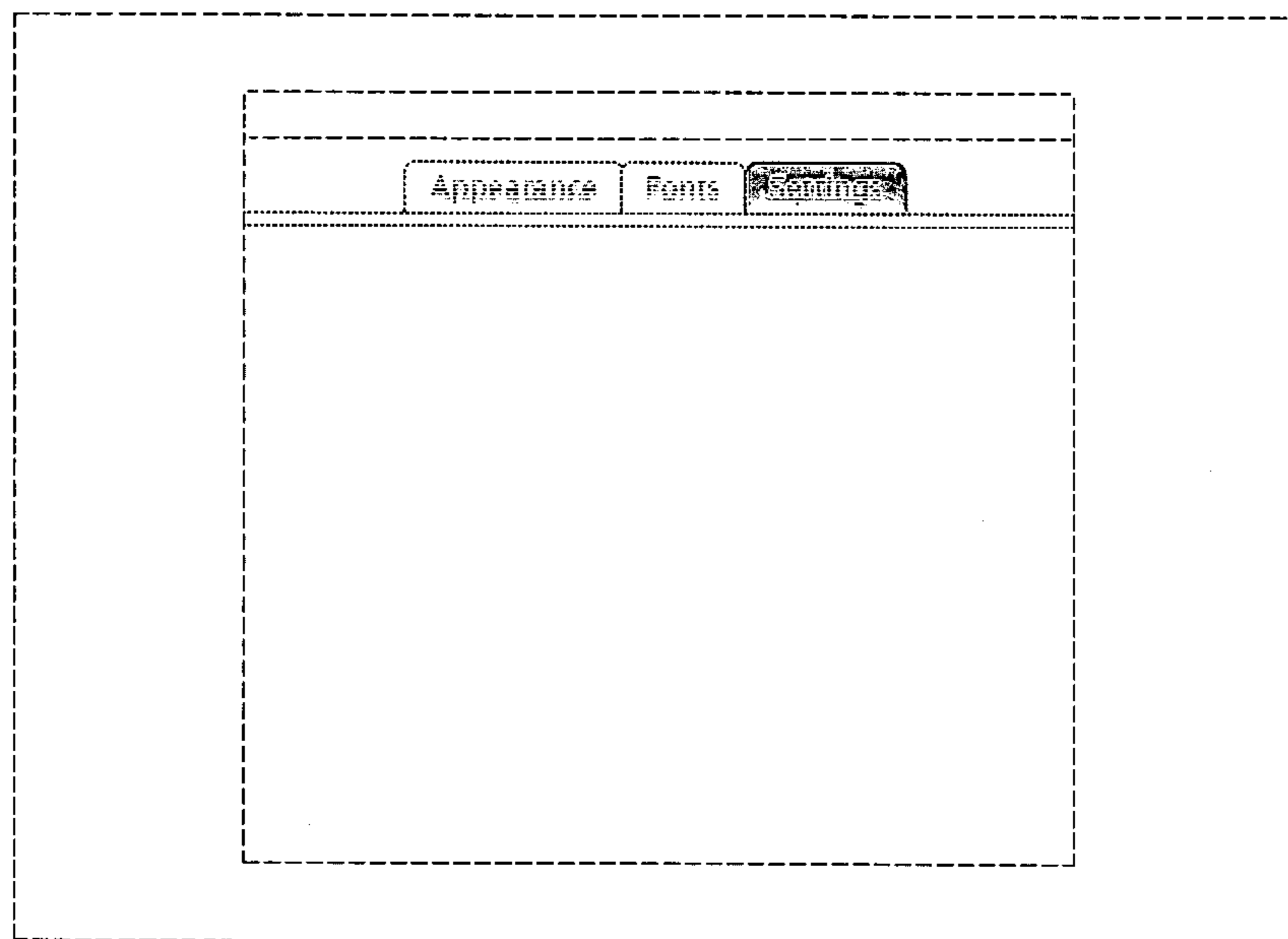
The broken line showing of a computer display, window and words forms no part of the claimed design.

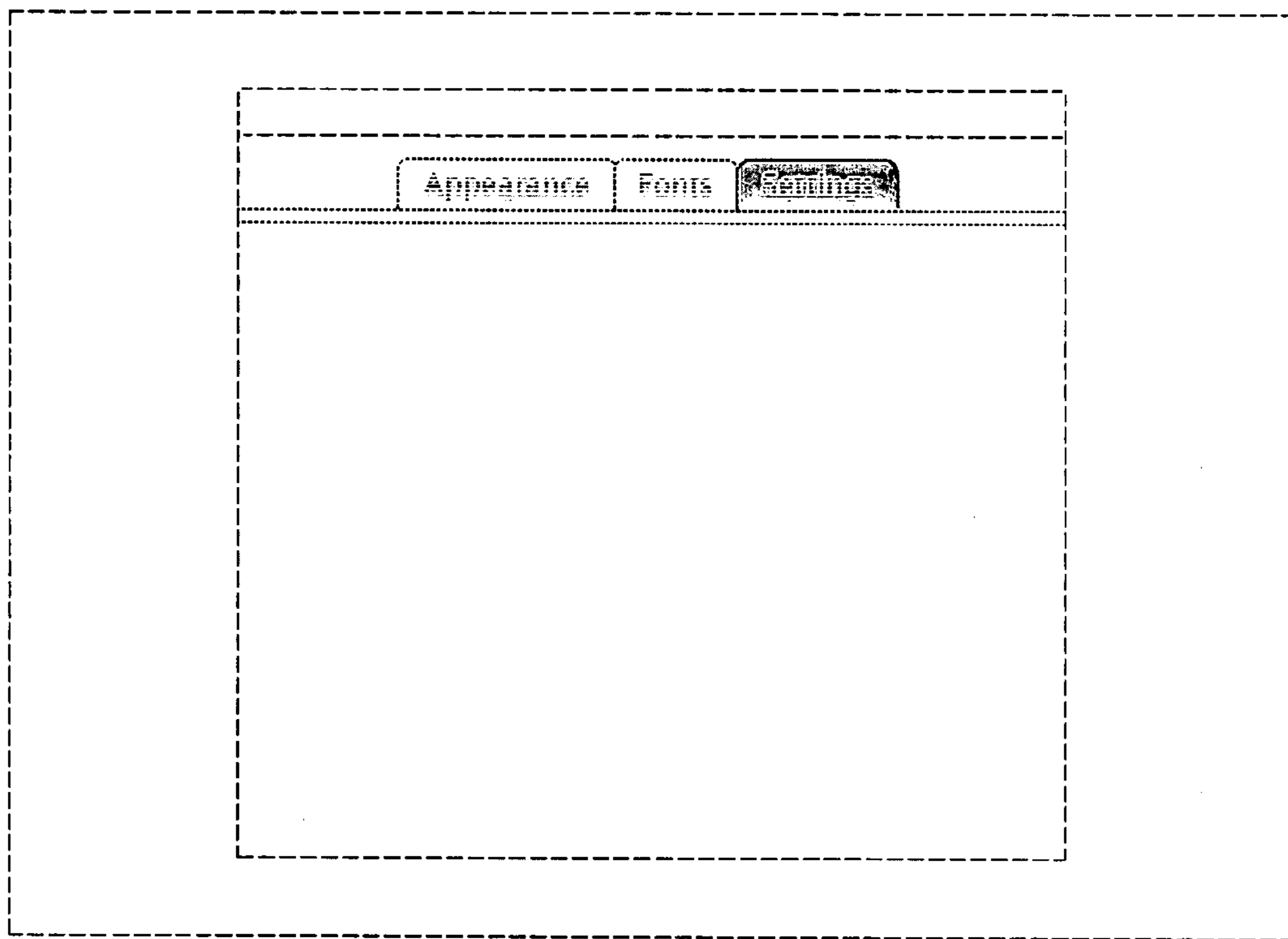

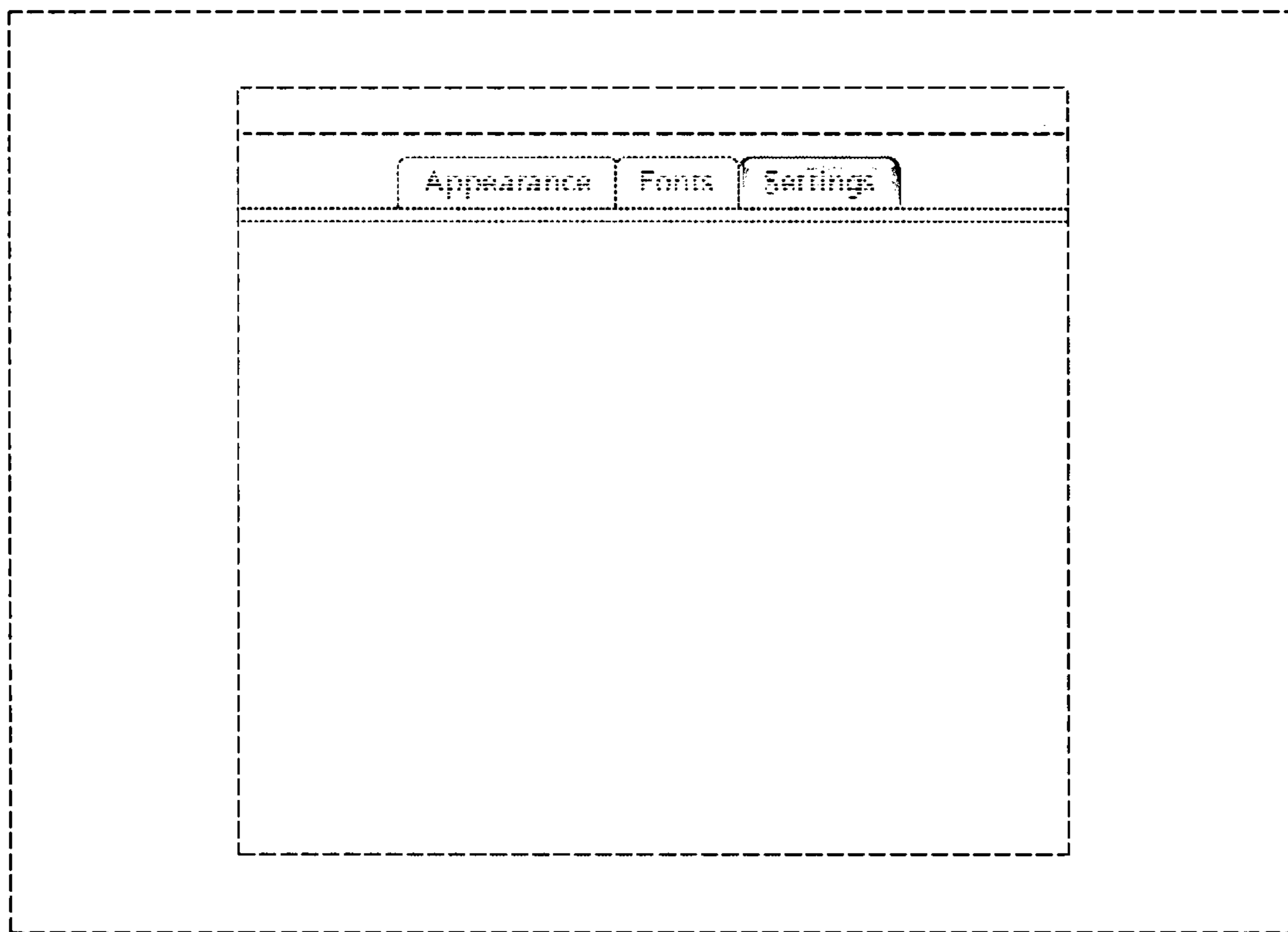
