FIG. 4 depicts a side elevational view of FIG. 1.

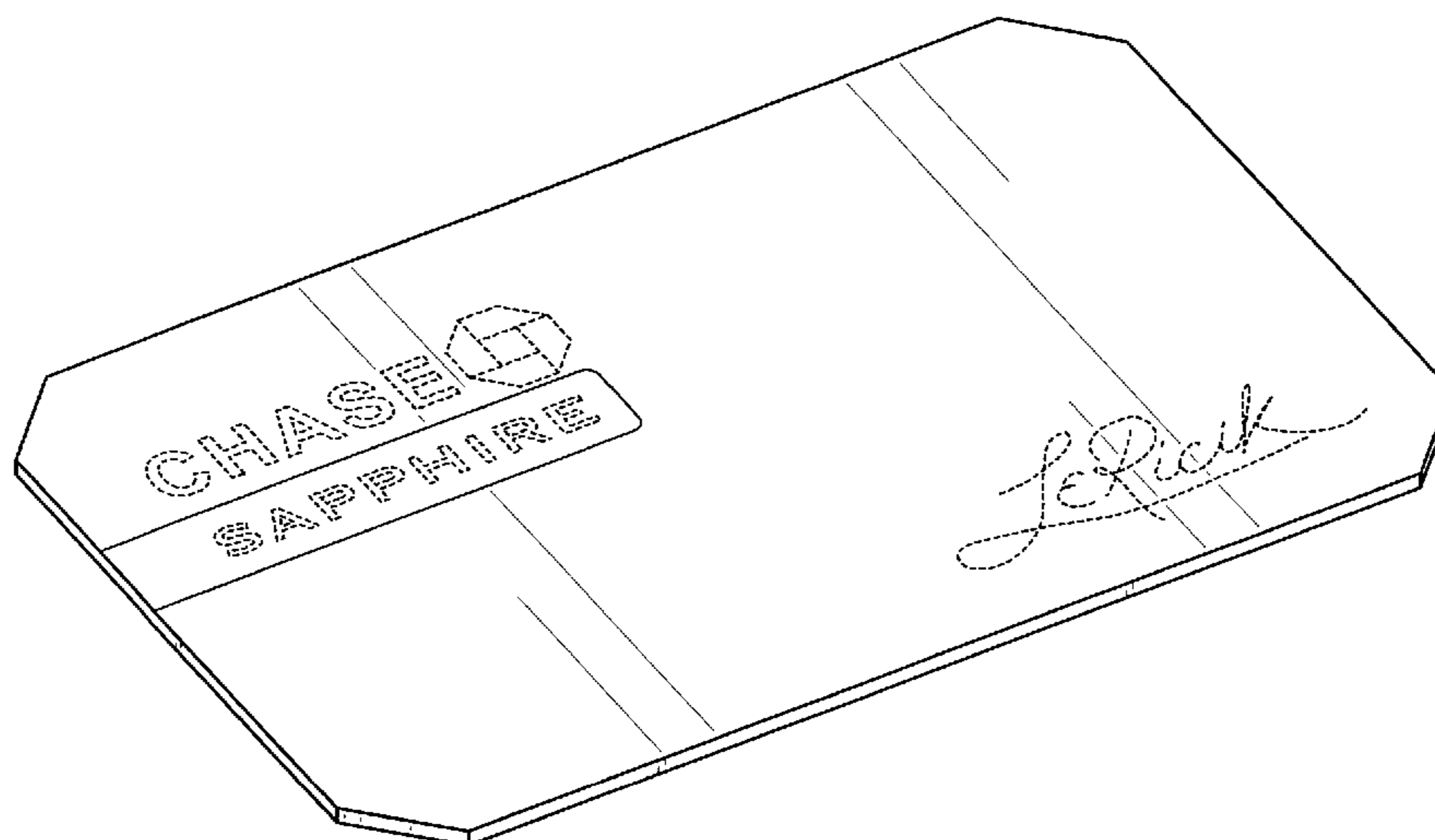
FIG. 5 depicts an opposite side elevational view of FIG. 1.

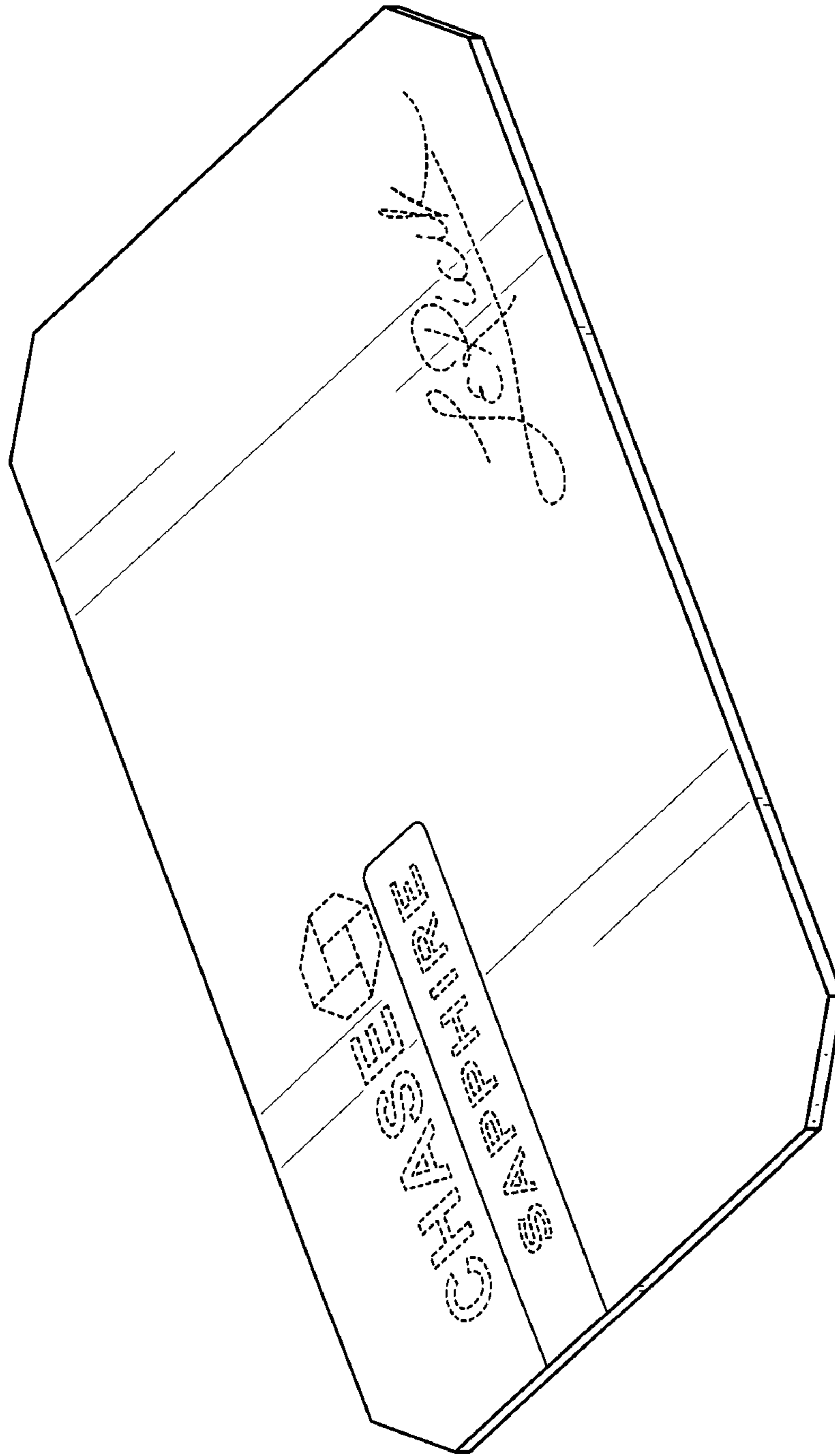

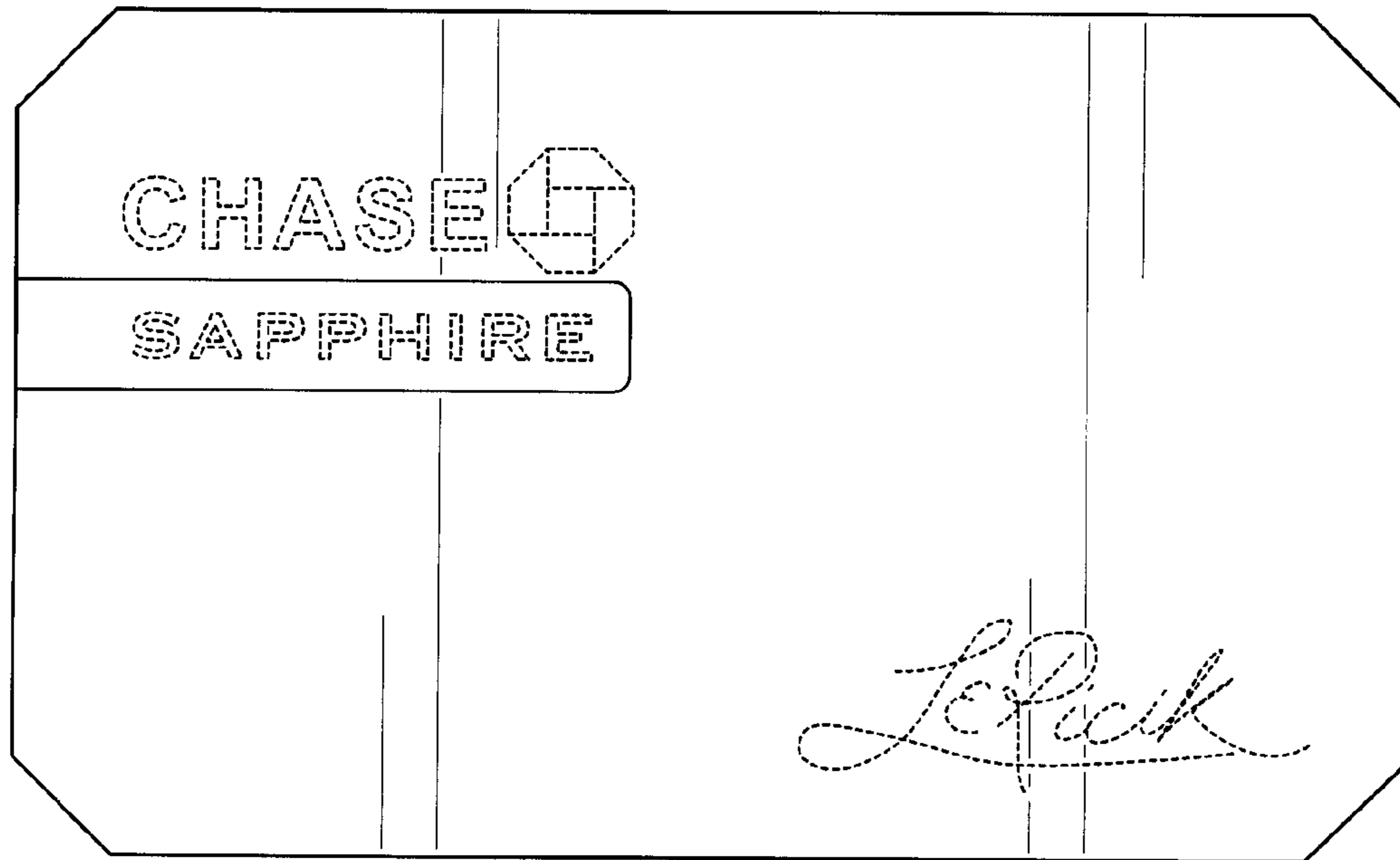

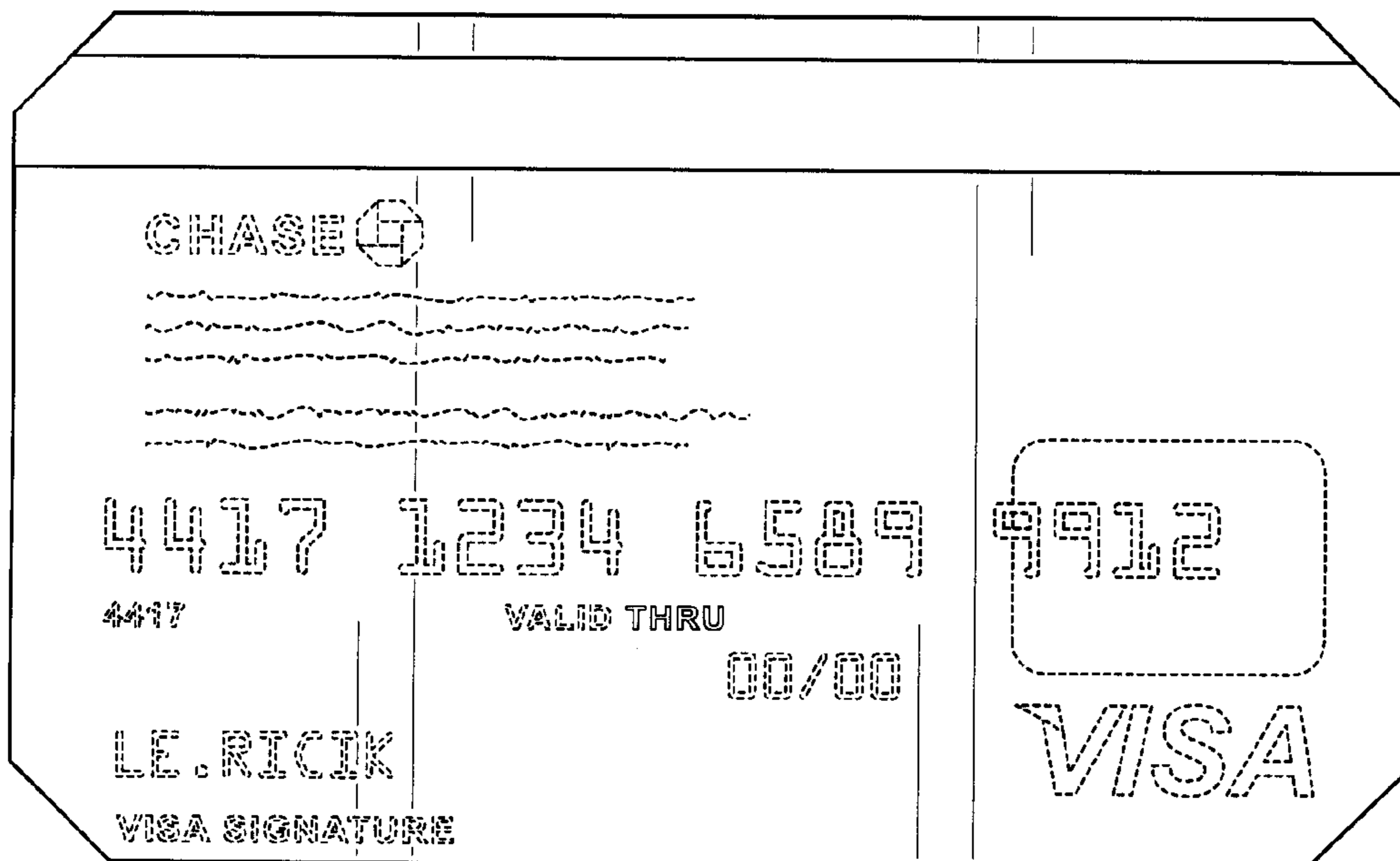

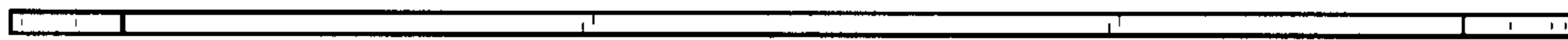

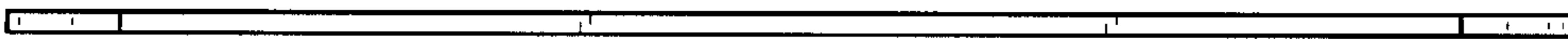
