(57) **CLAIM**

The ornamental design for a firearm suppressor wrap, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a firearm suppressor wrap in accordance with the present invention;

FIG. 2 is a top view of the firearm suppressor wrap shown in FIG. 1;

FIG. 3 is a bottom view of the firearm suppressor wrap shown in FIG. 1;

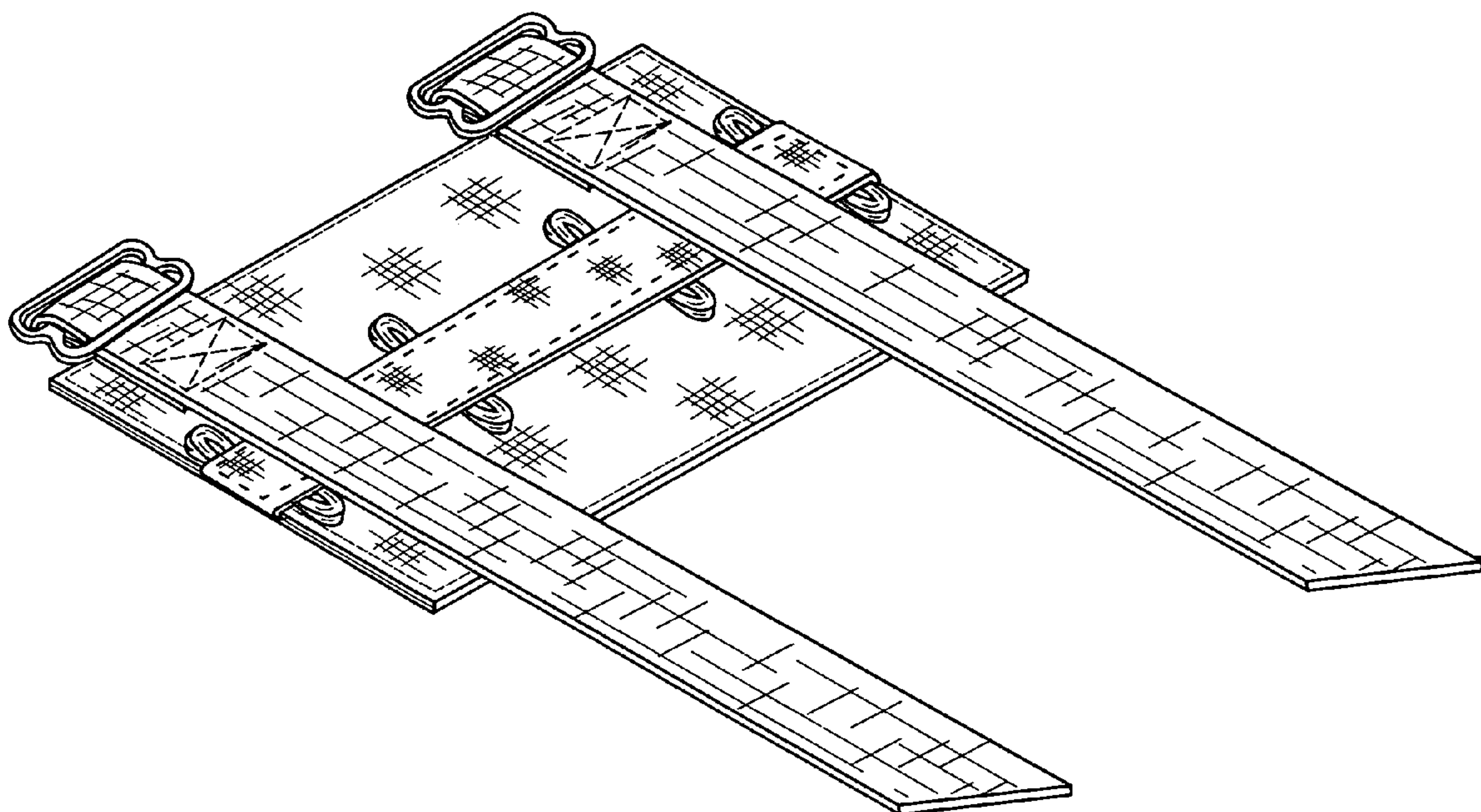
FIG. 4 is a right side view of the suppressor wrap shown in FIG. 1, which is a mirror image of the left side view thereof;

FIG. 5 is a front edge view of the firearm suppressor wrap shown in FIG. 1; and,

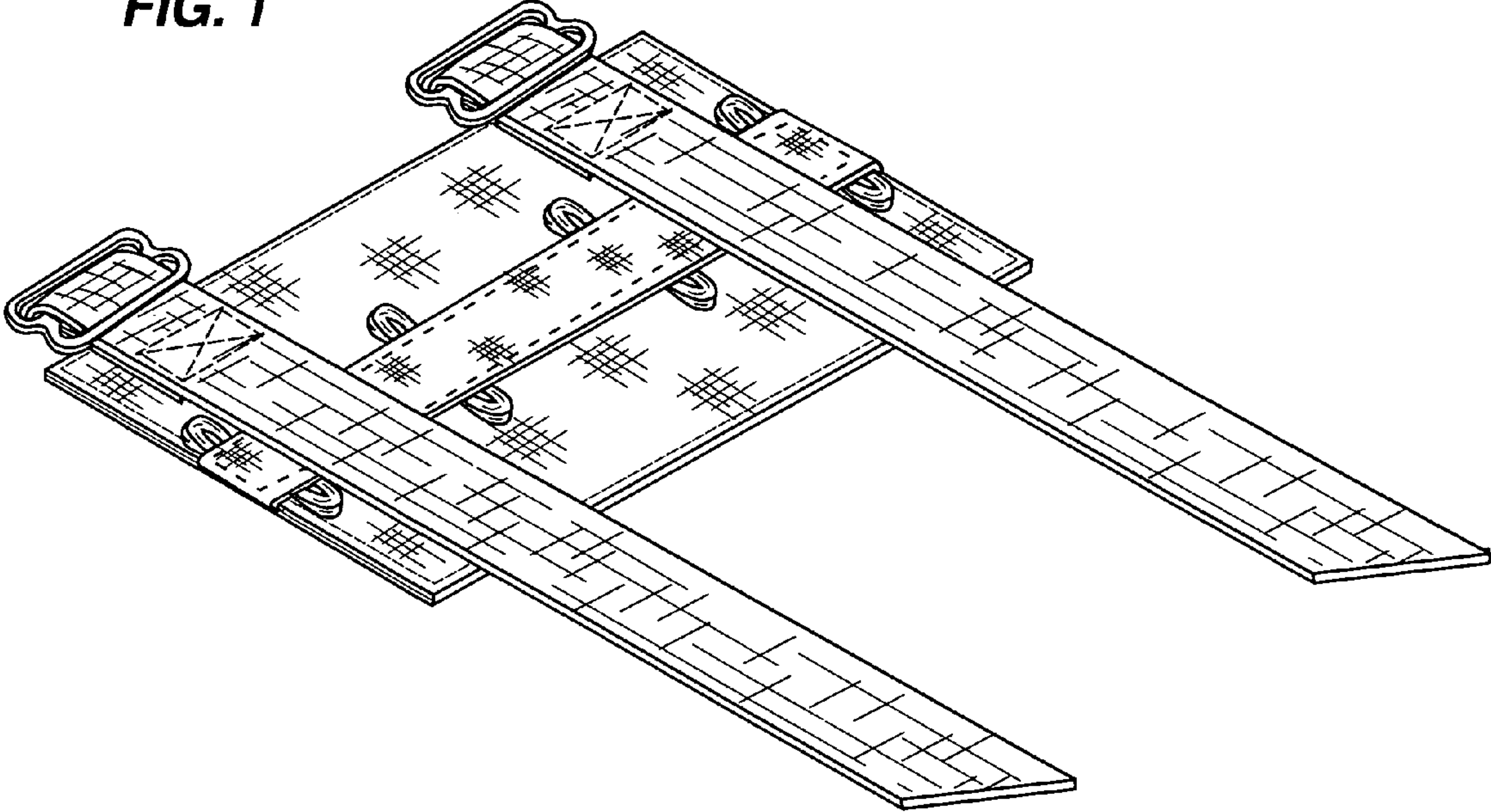
FIG. 6 is a rear edge view of the firearm suppressor wrap shown in FIG. 1.

The dashed lines in FIGS. 1 through 3 represents stitching and forms a part of the claimed design.

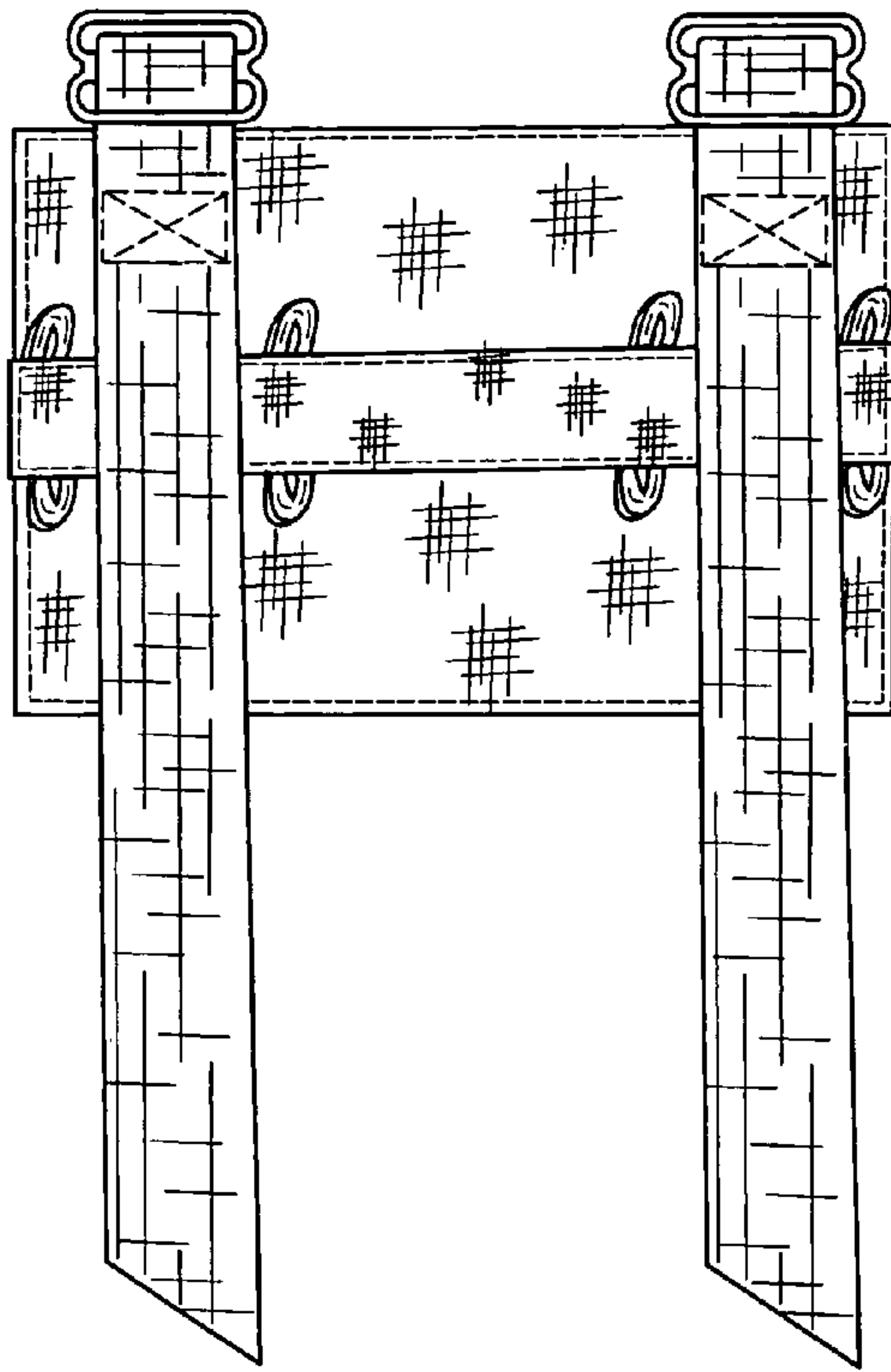

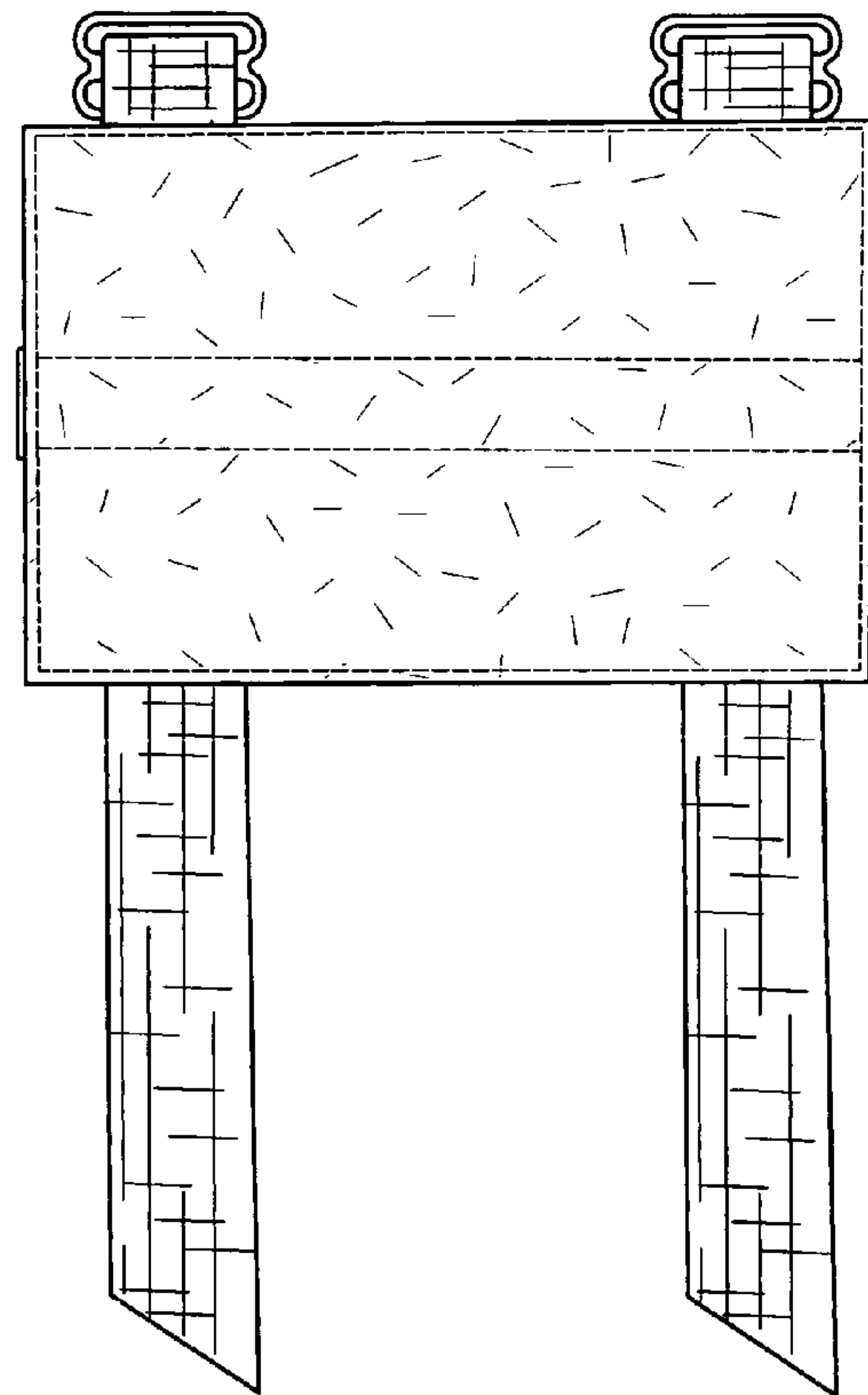

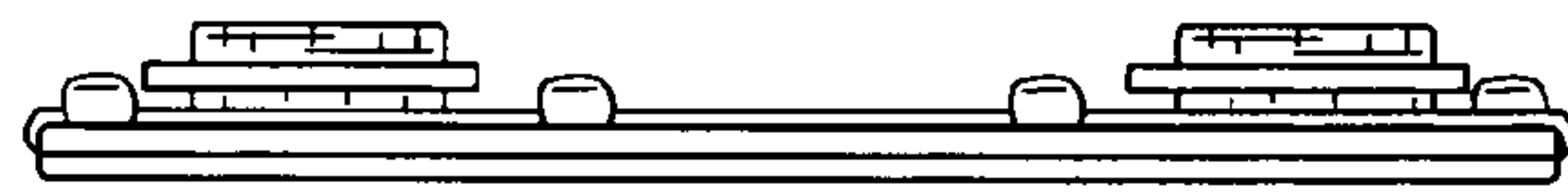
