FIG. 6 is a bottom view thereof;

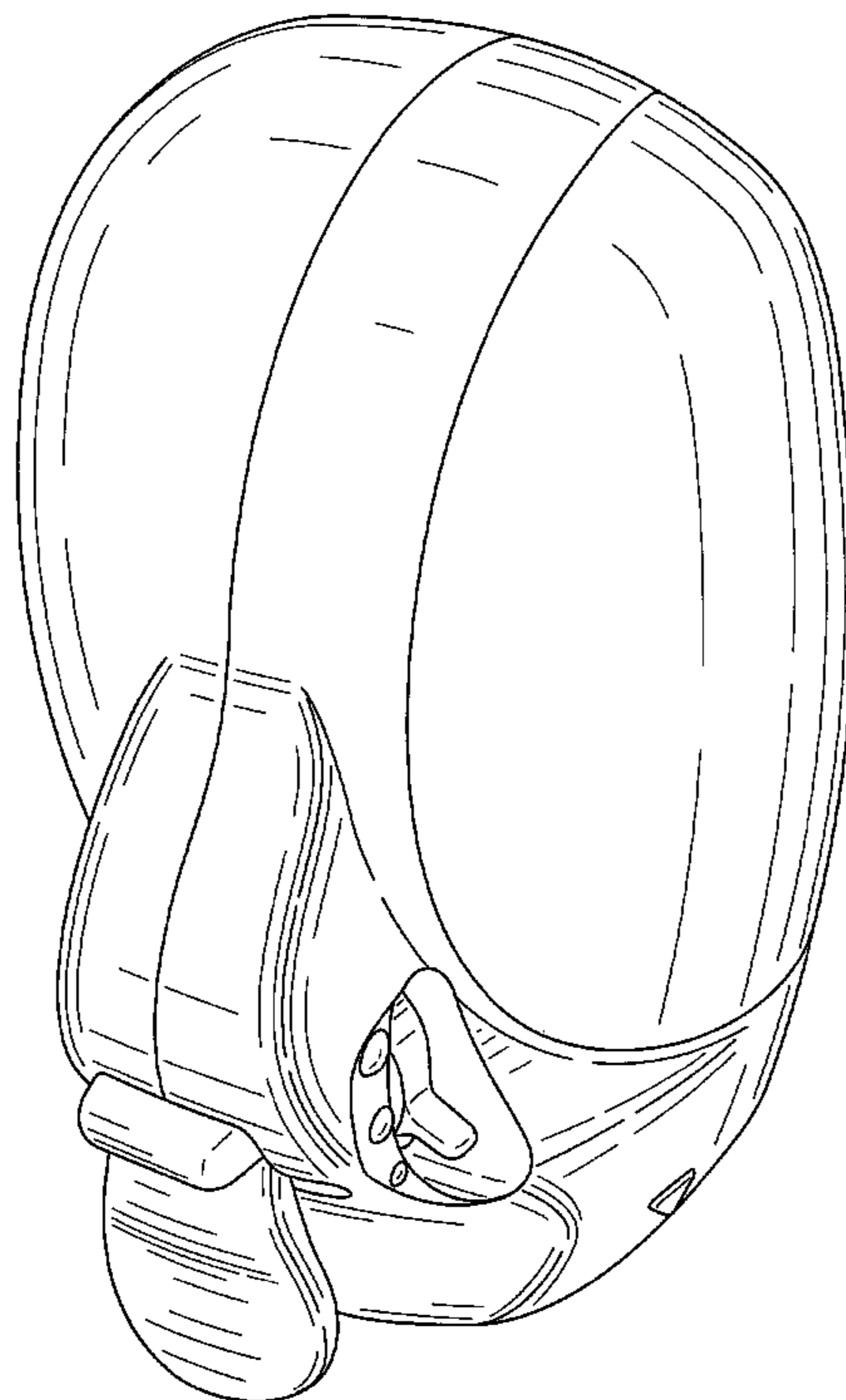
FIG. 7 is a left side view thereof;

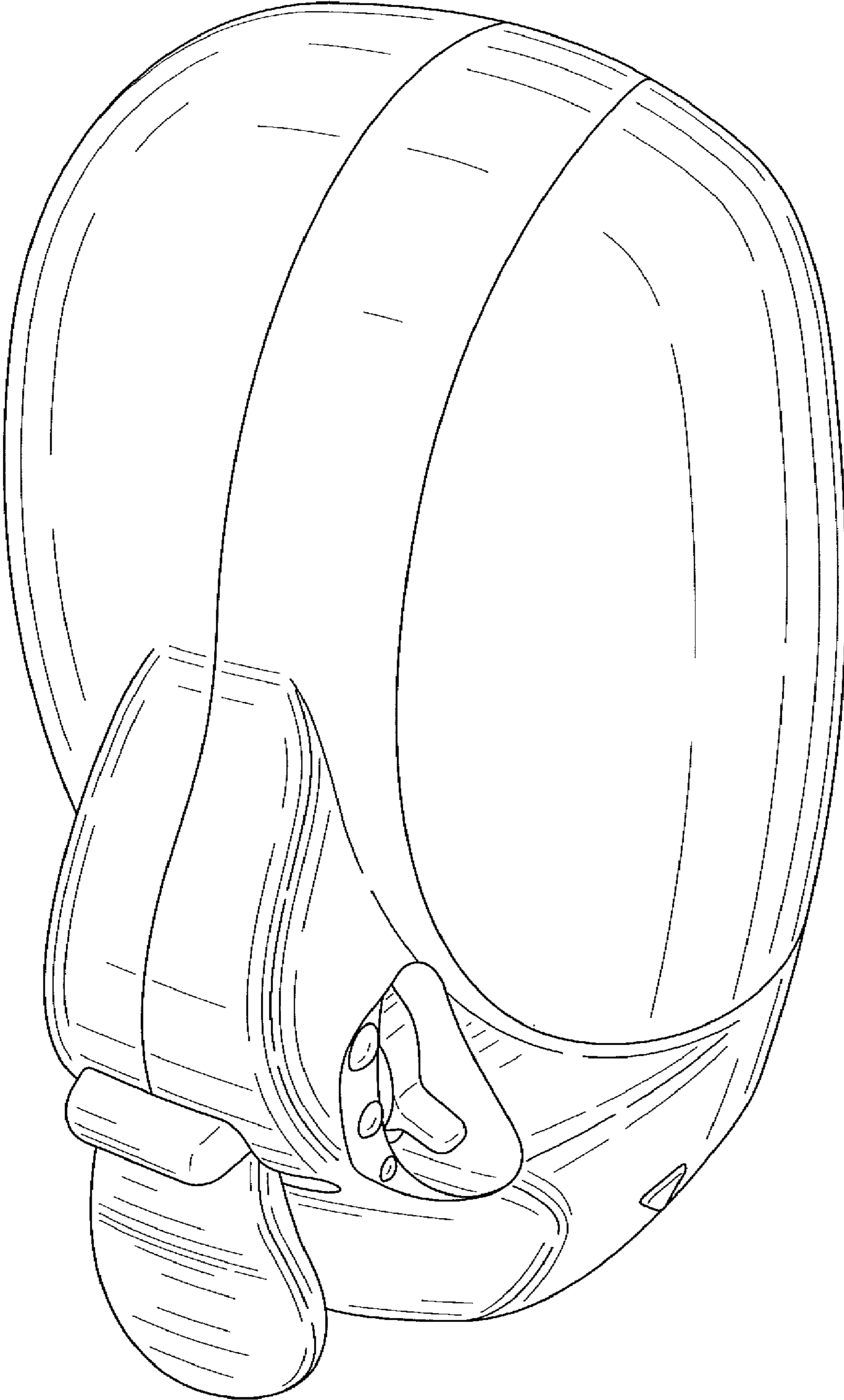

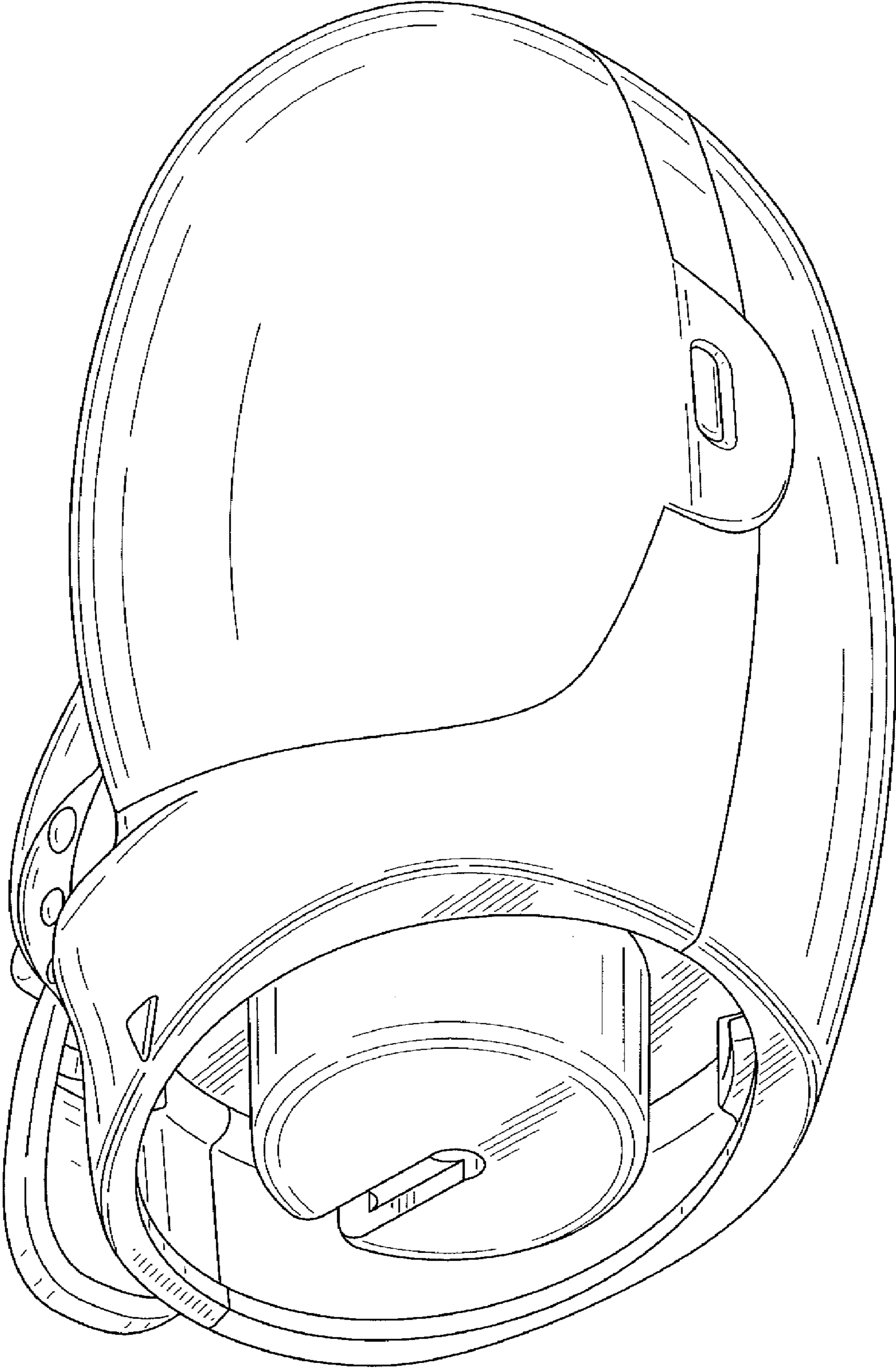

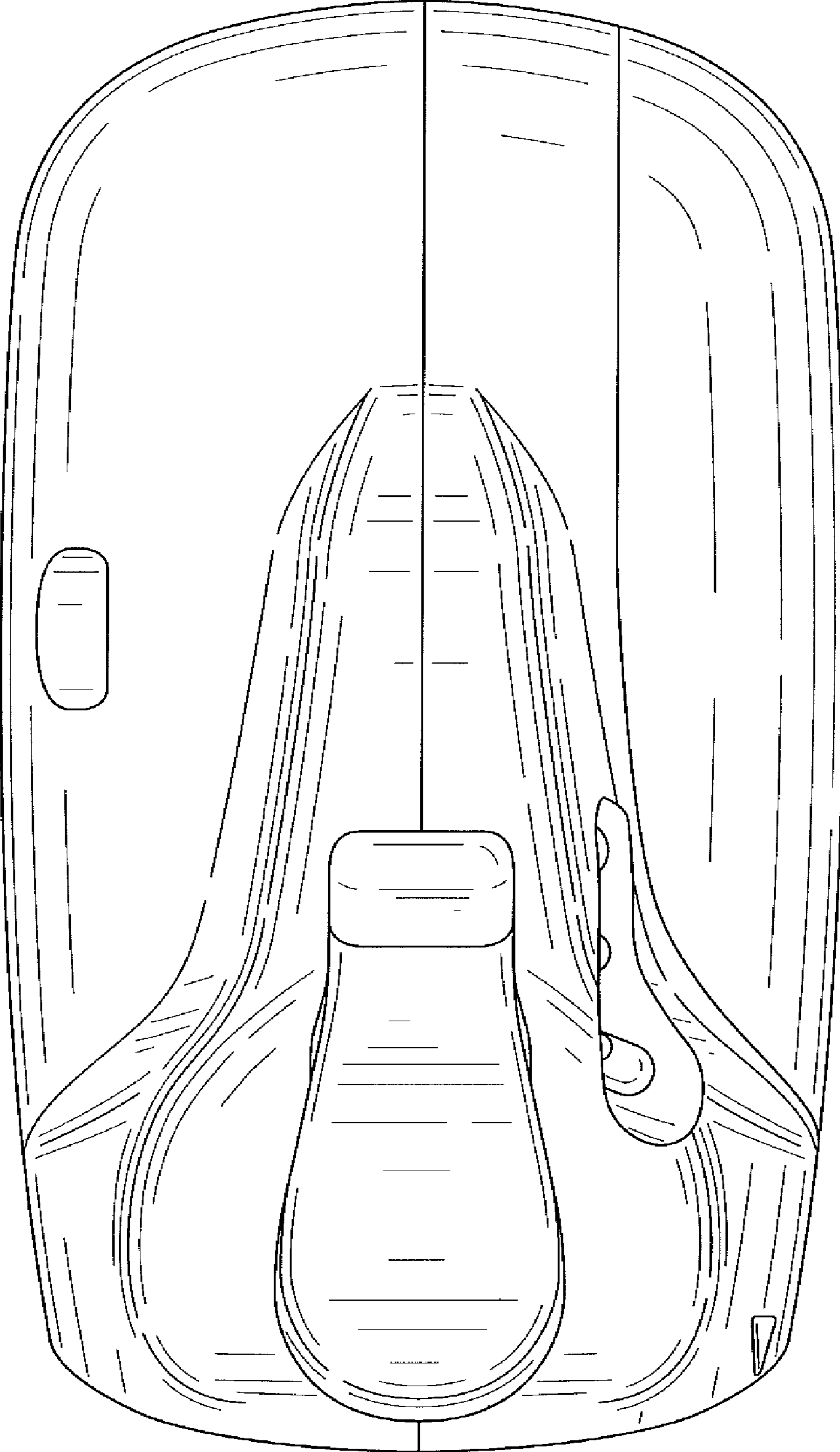

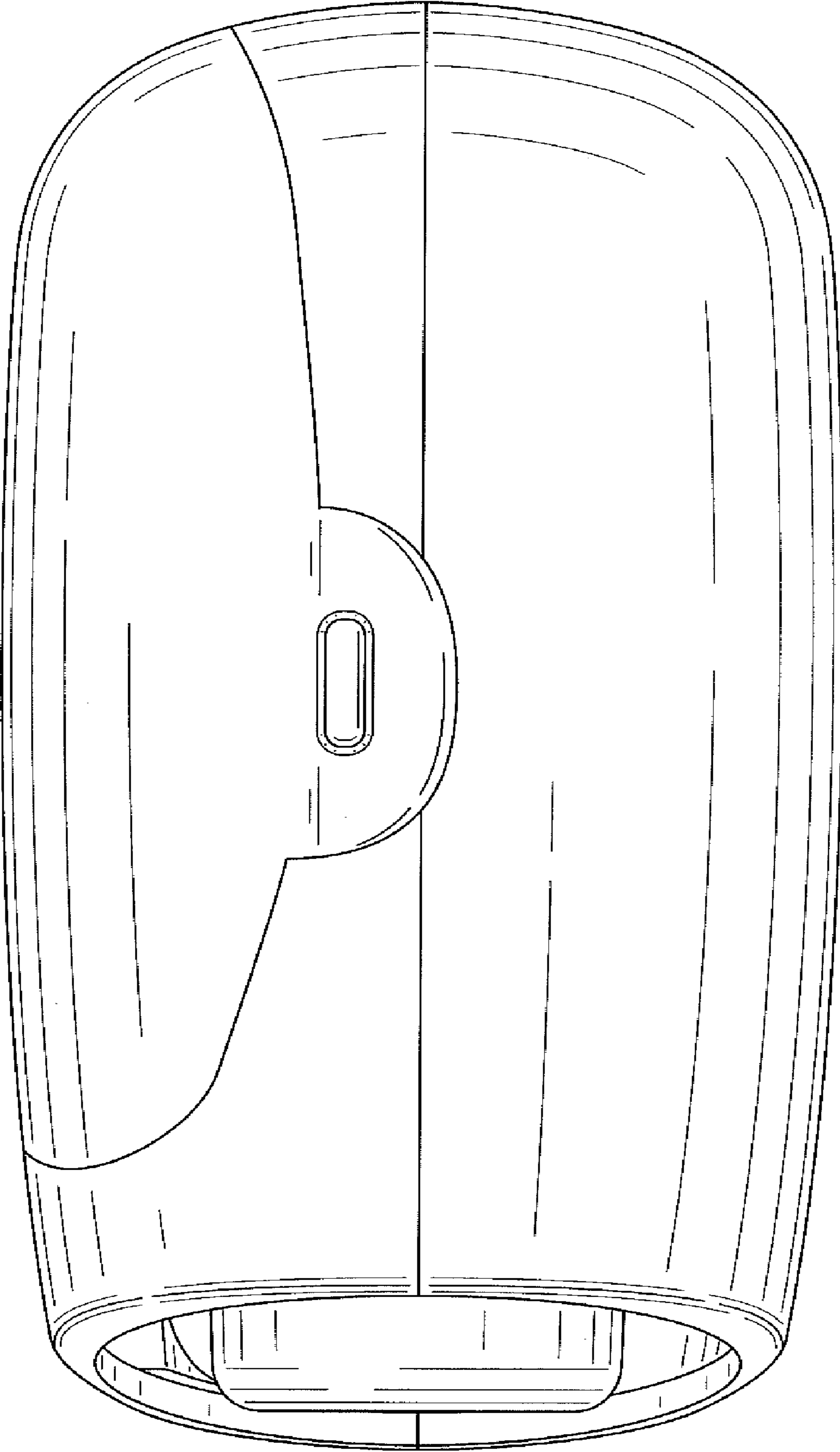

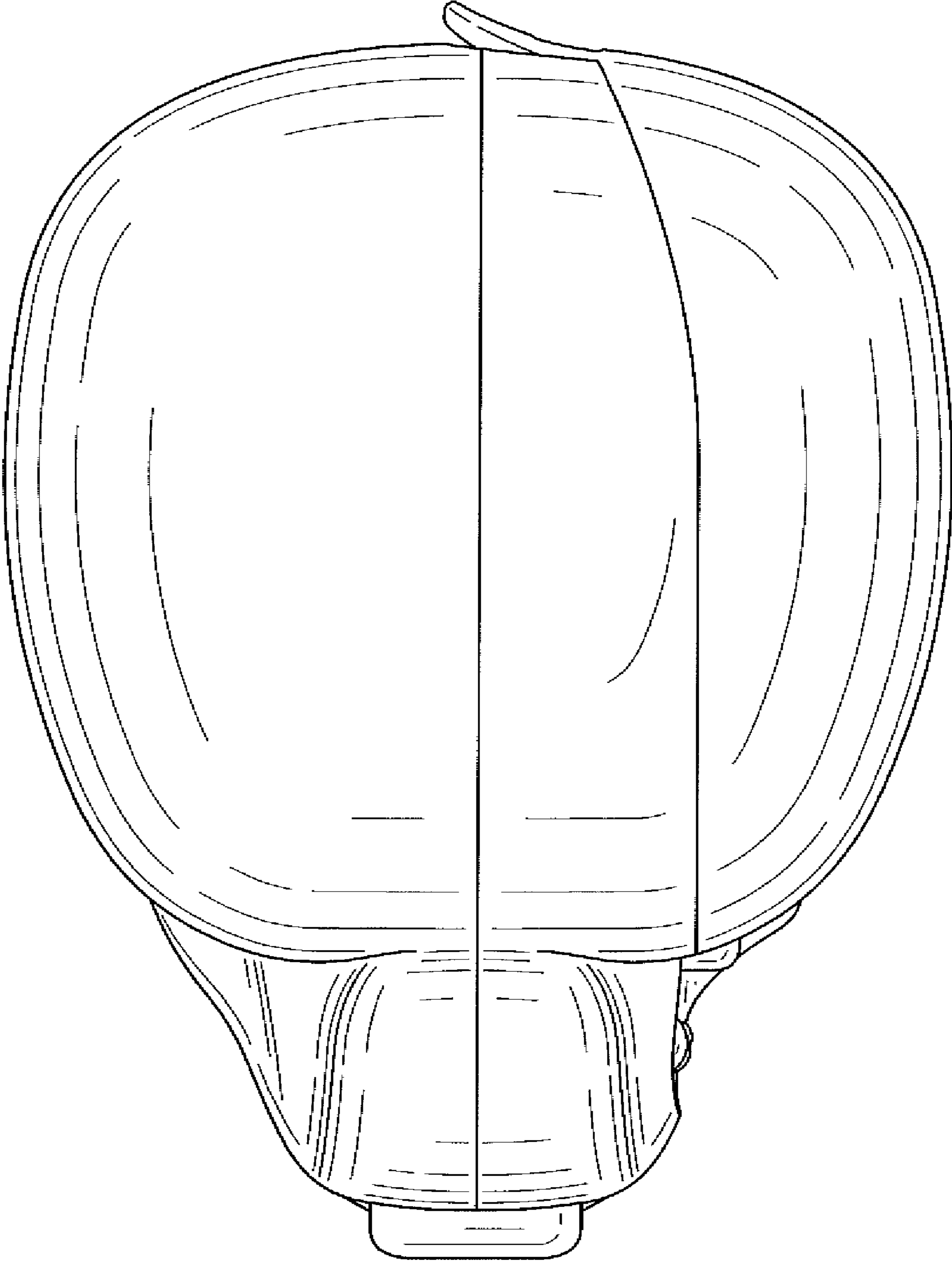

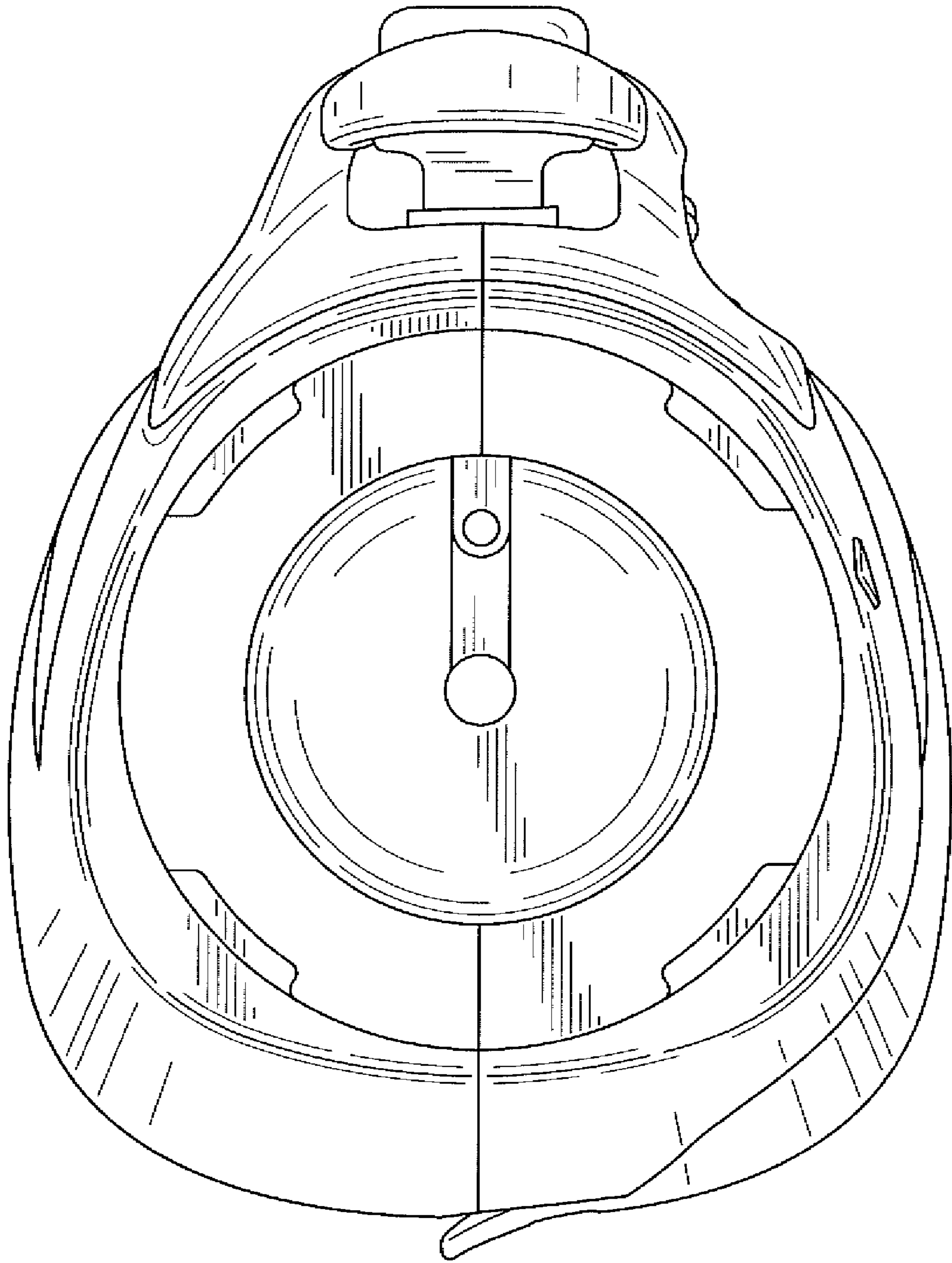

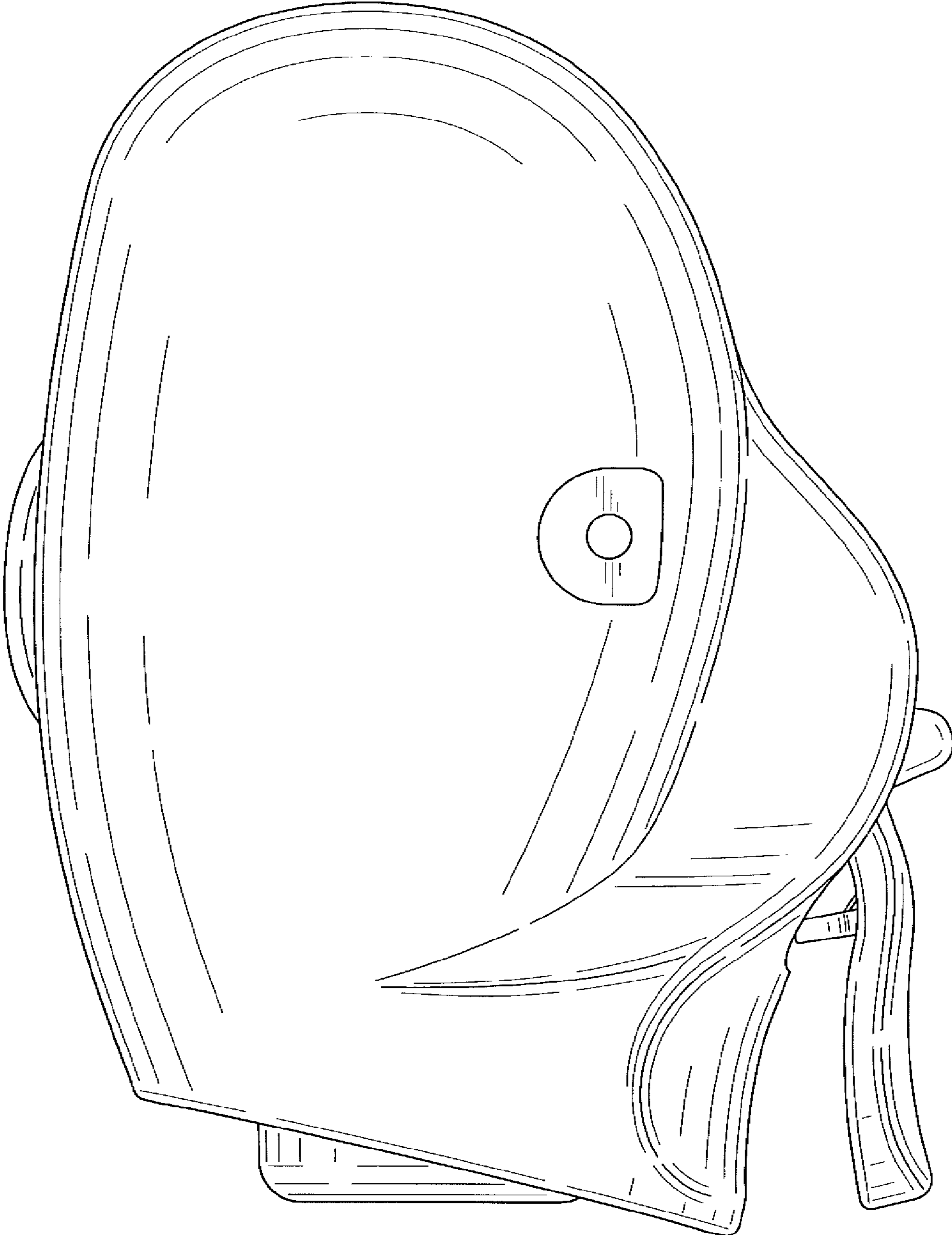

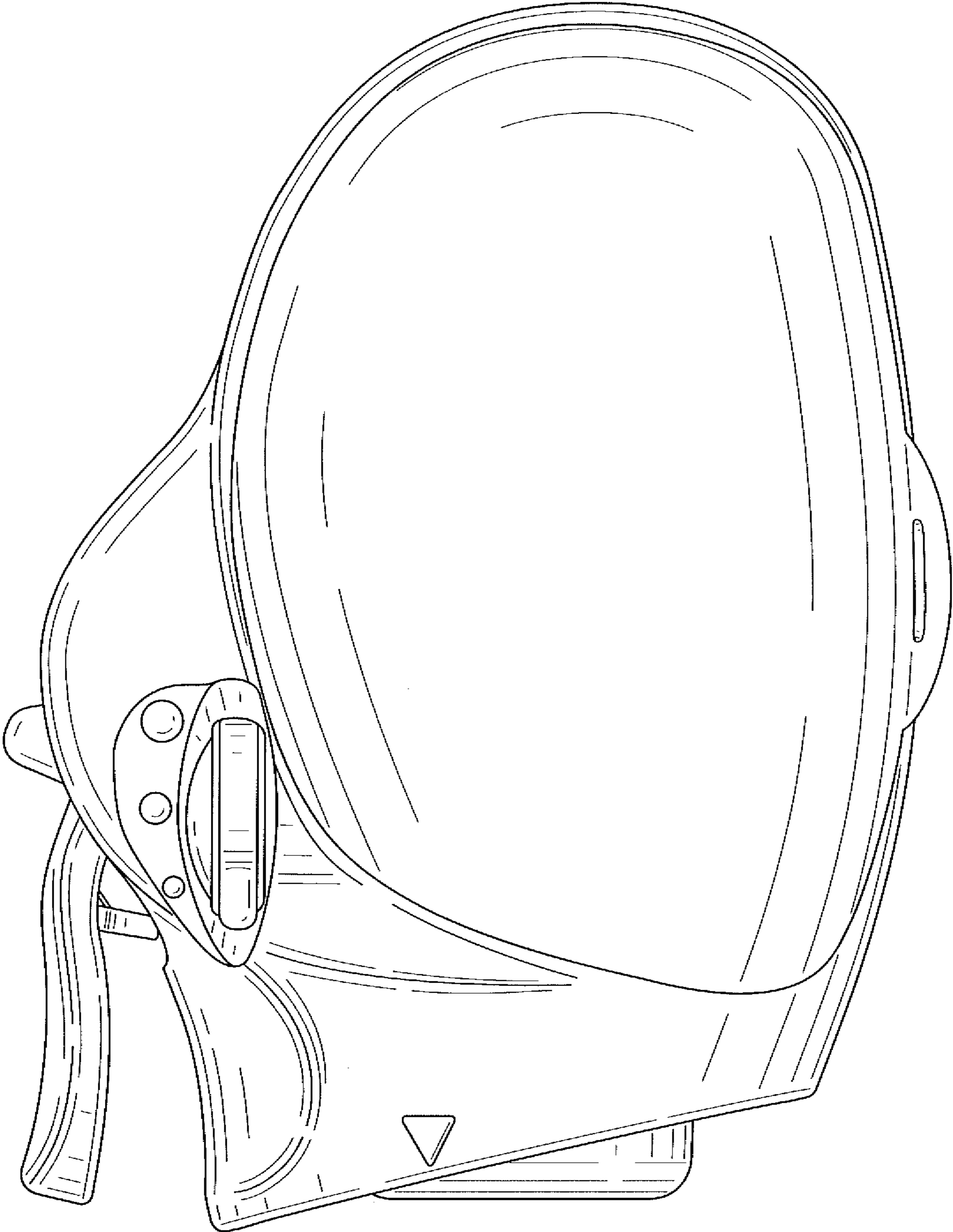

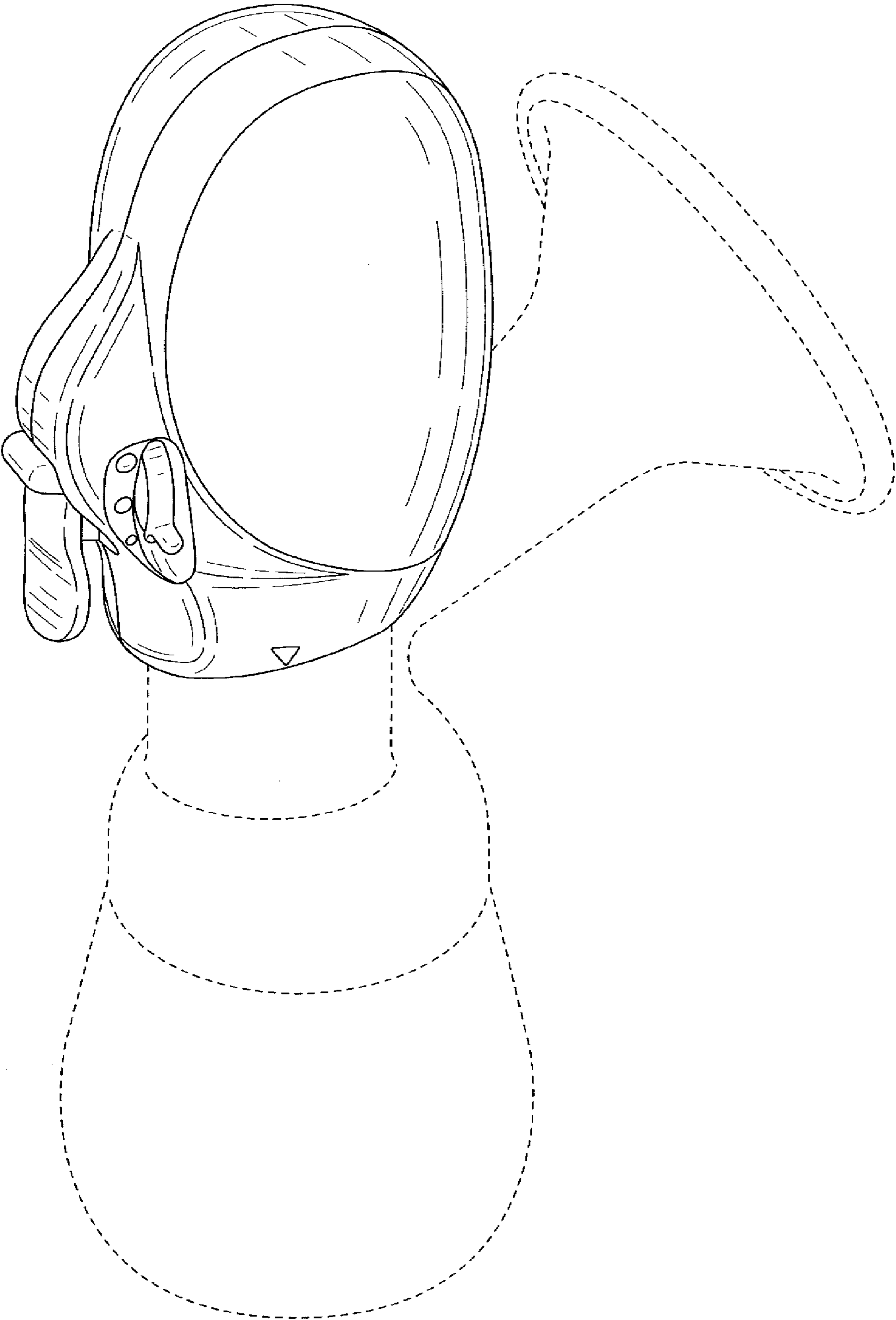
