FIG. 4 shows a right side view of the design;

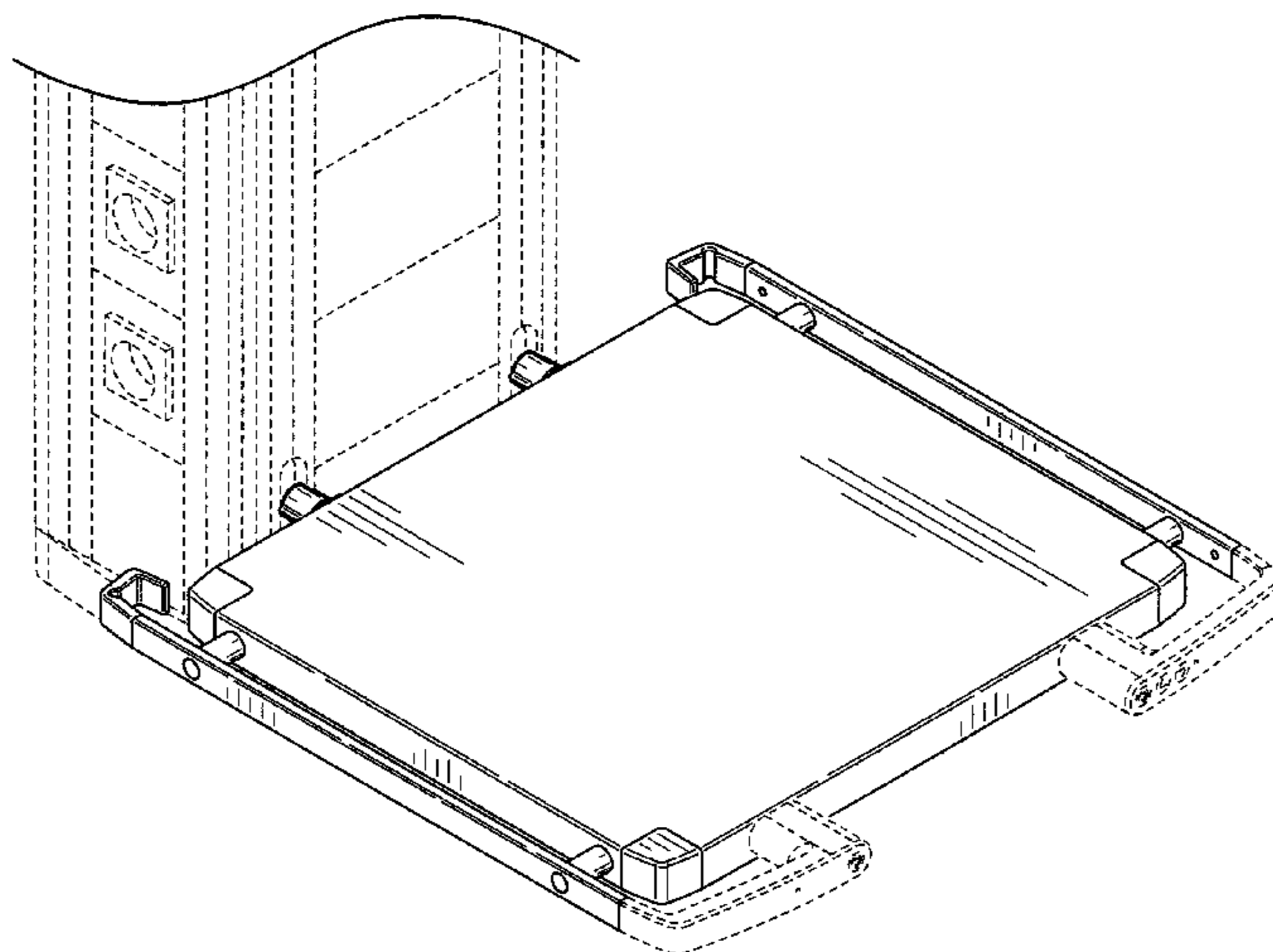
FIG. 5 shows a left side view of the design;

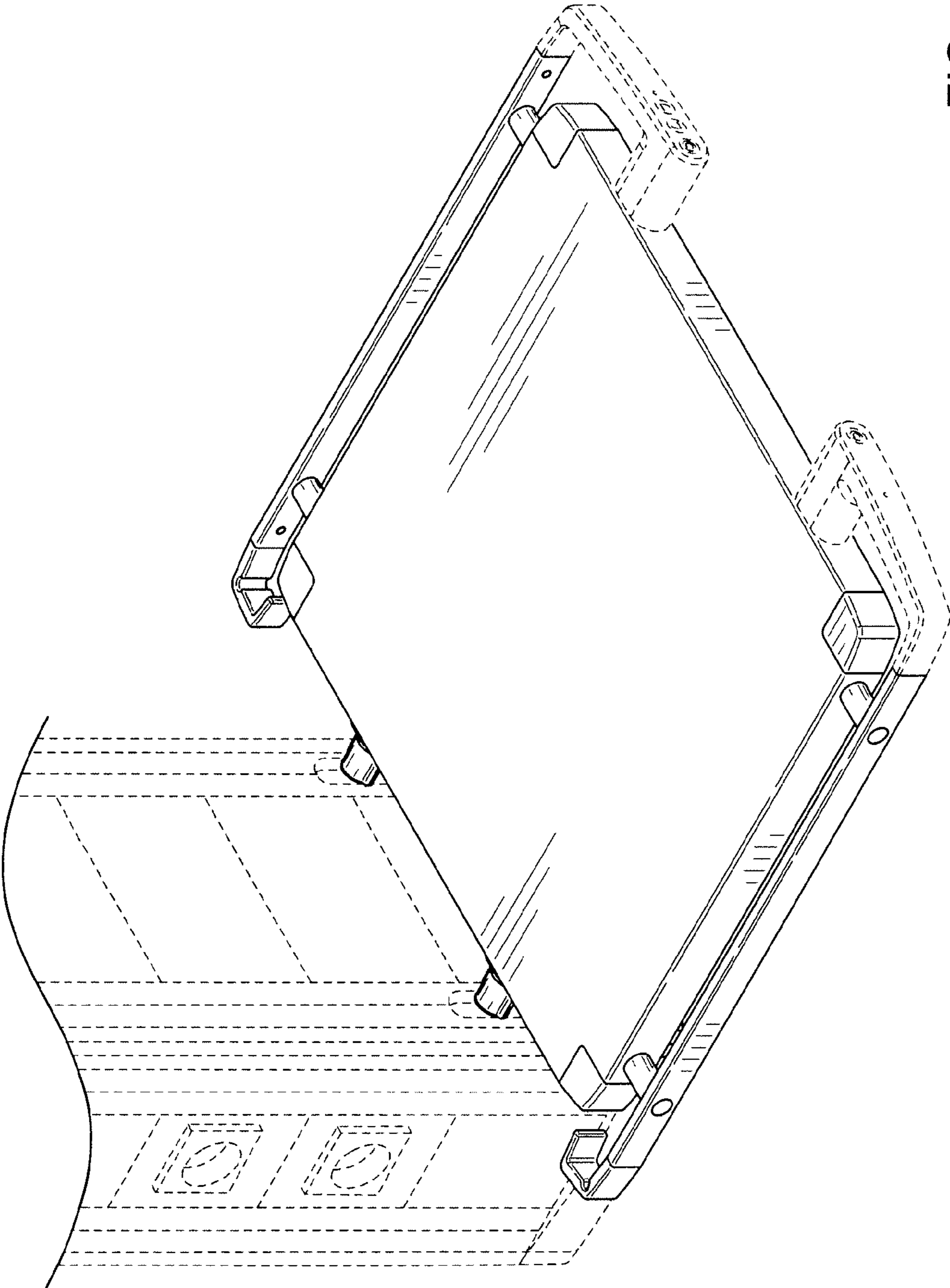

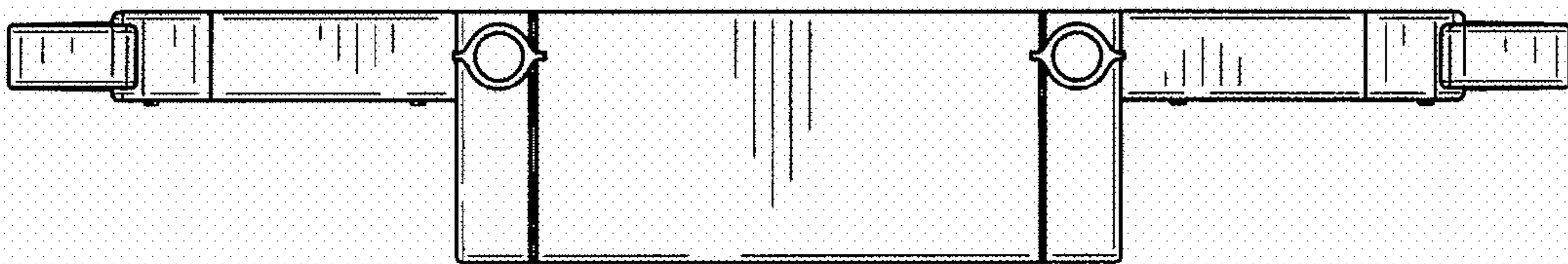

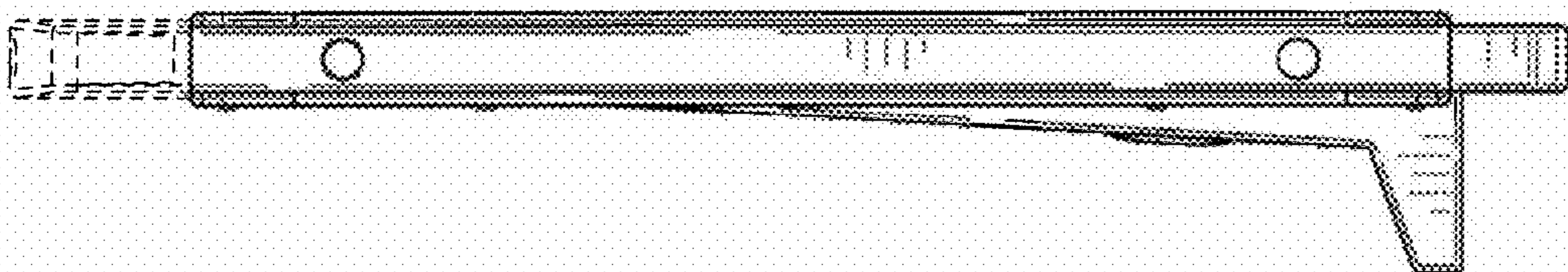

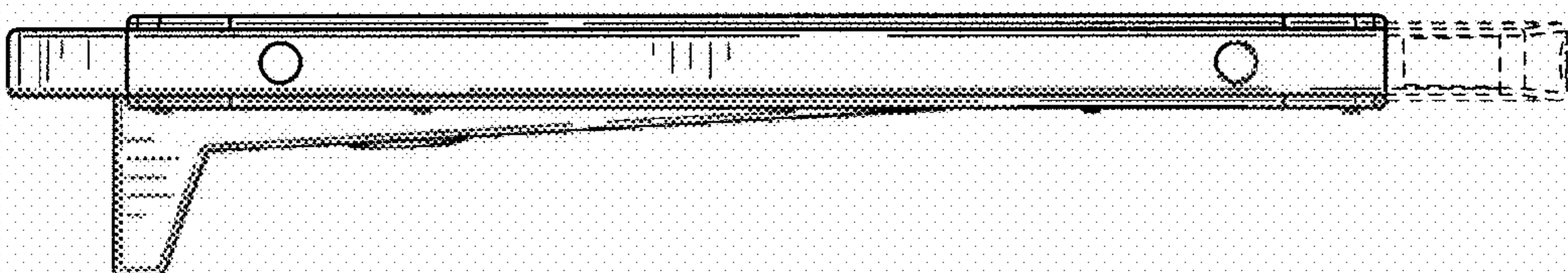

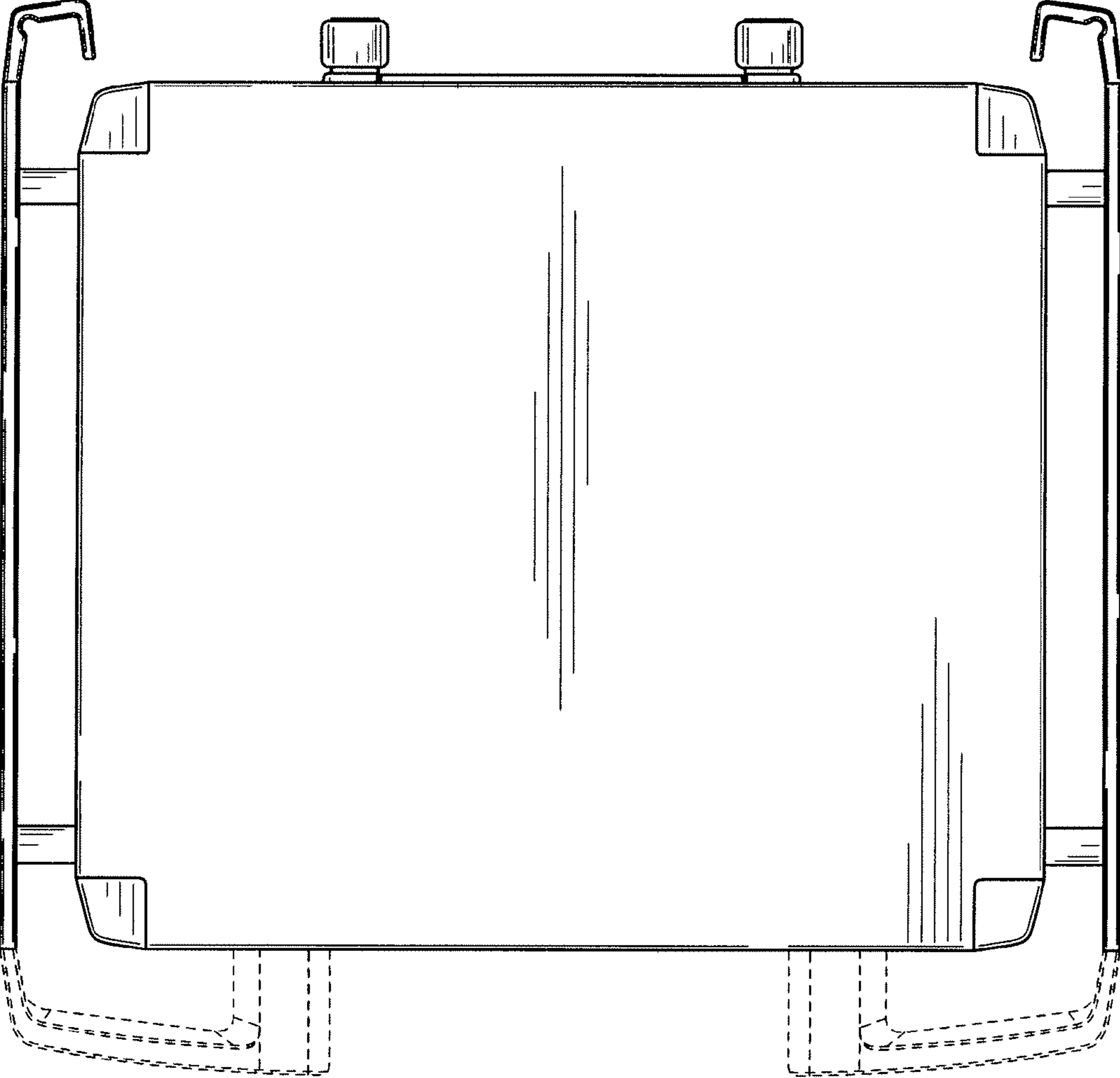

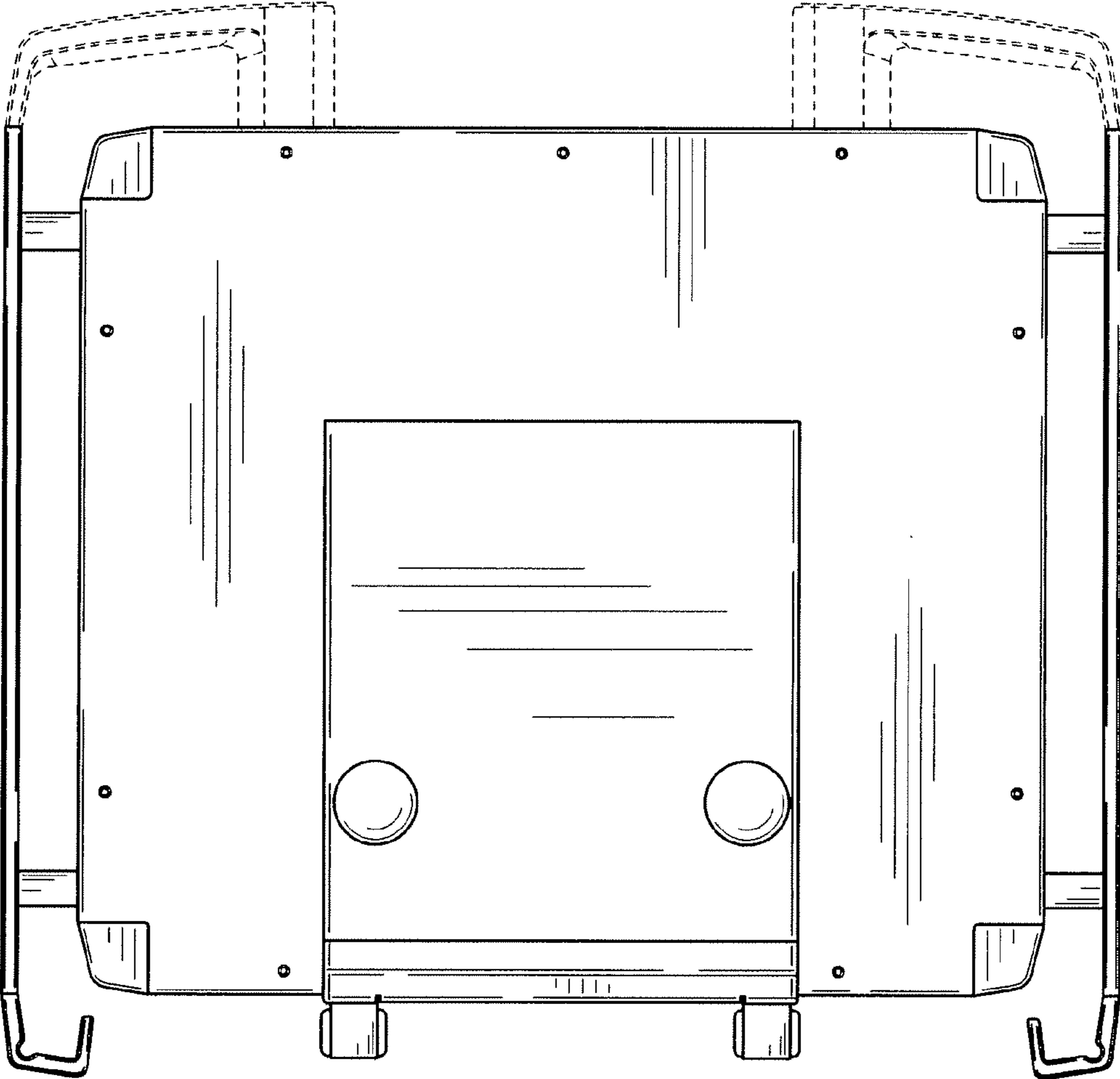
