FIG. 4 is a left view thereof;

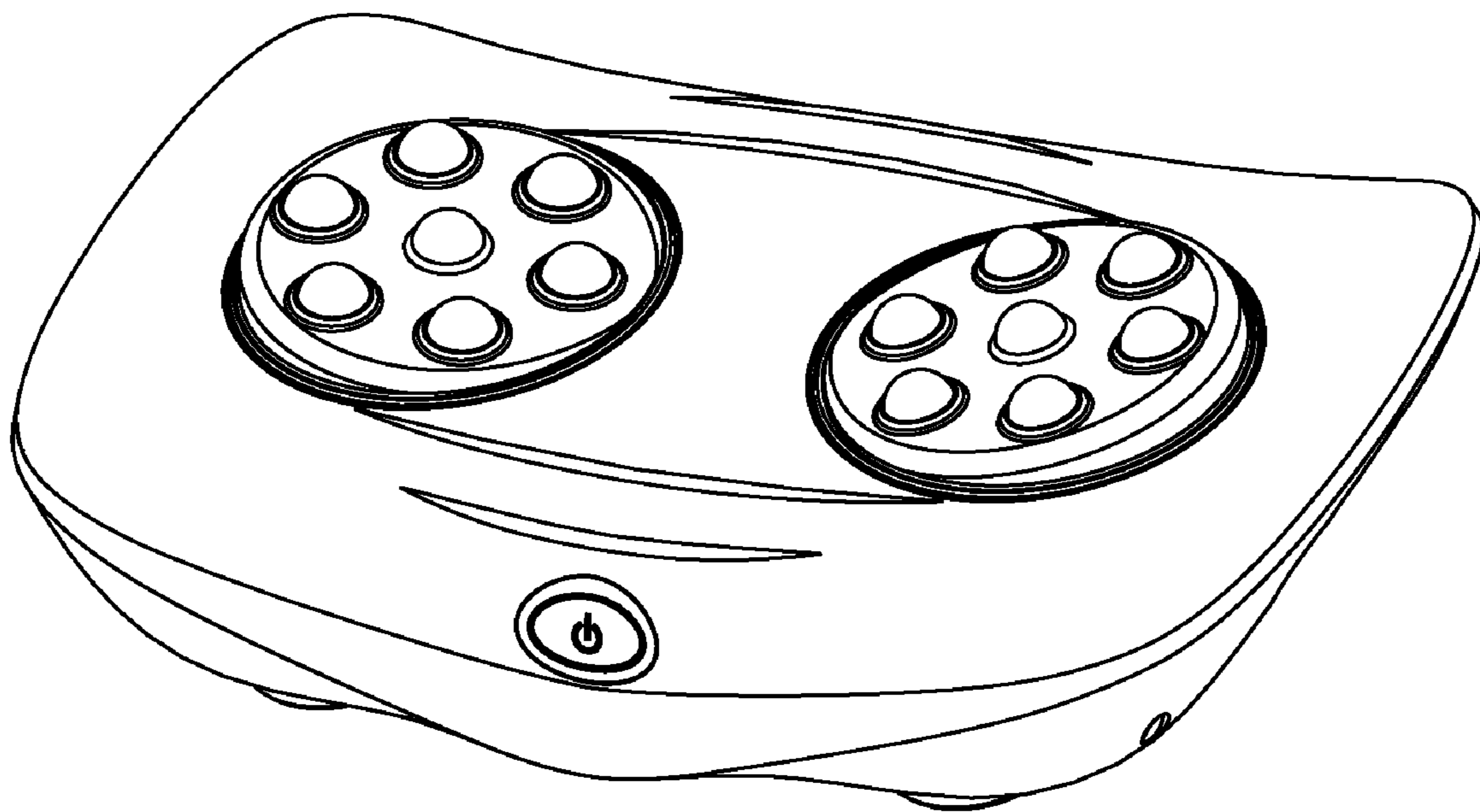
FIG. 5 is a right view thereof;

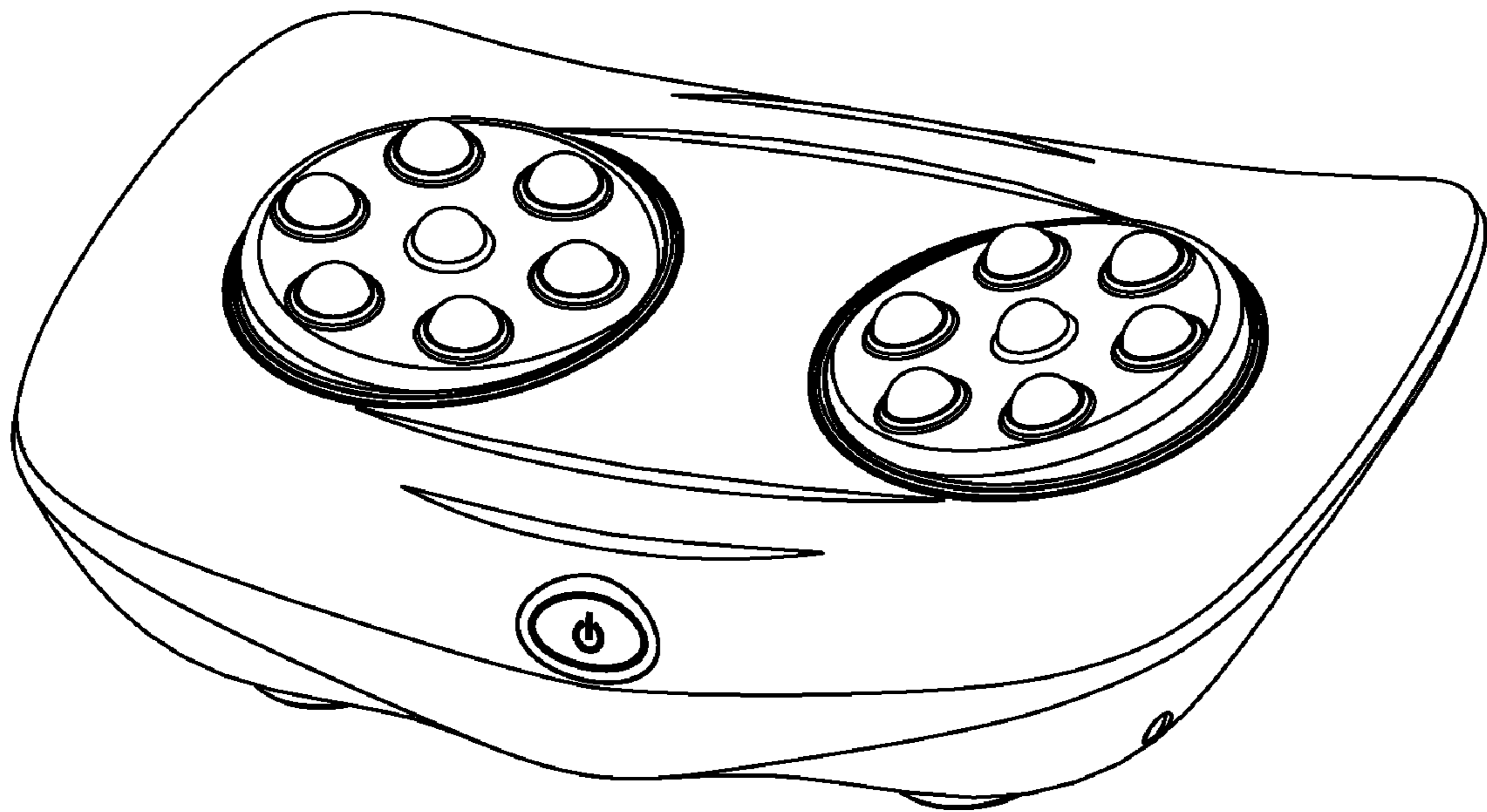
FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view.

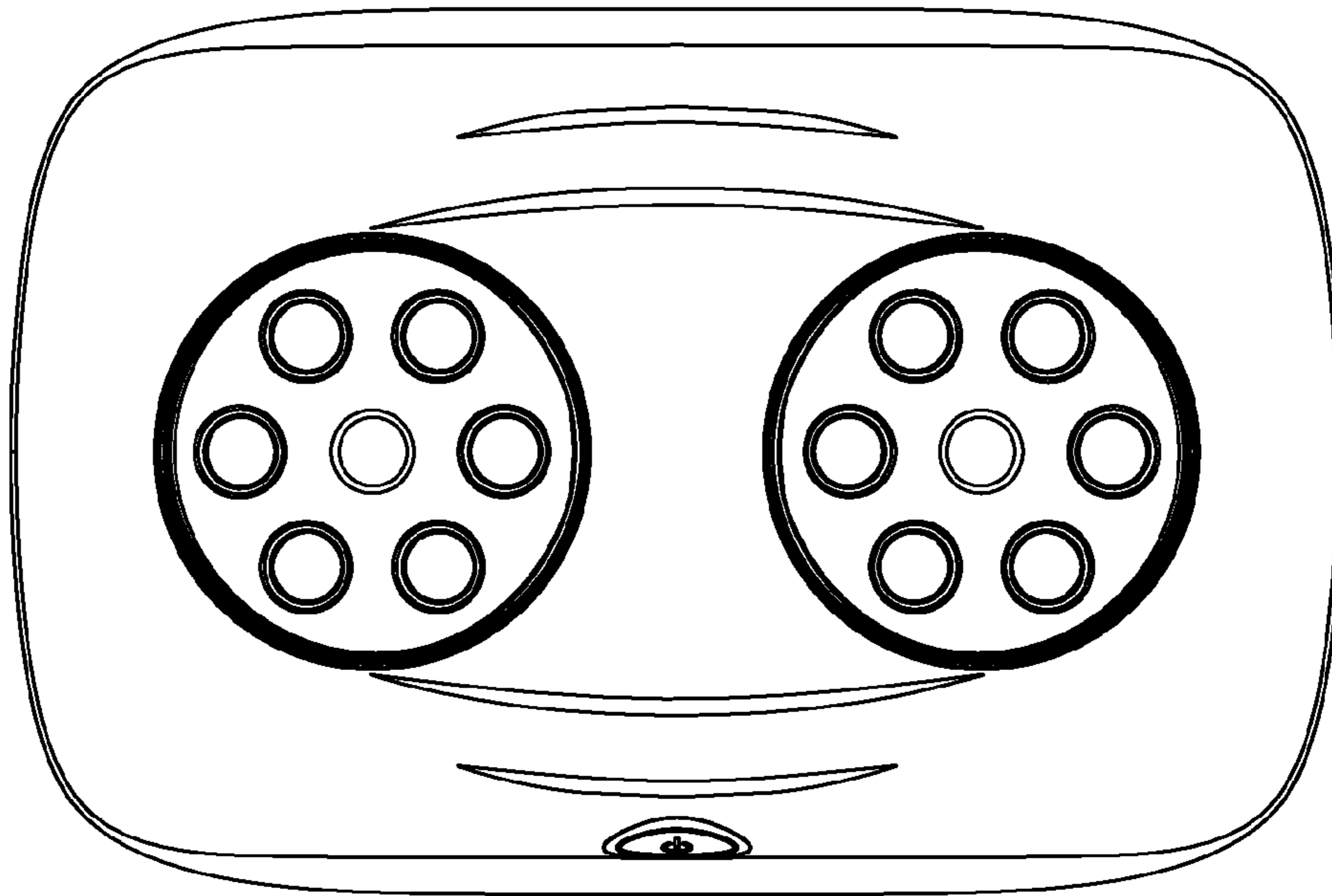

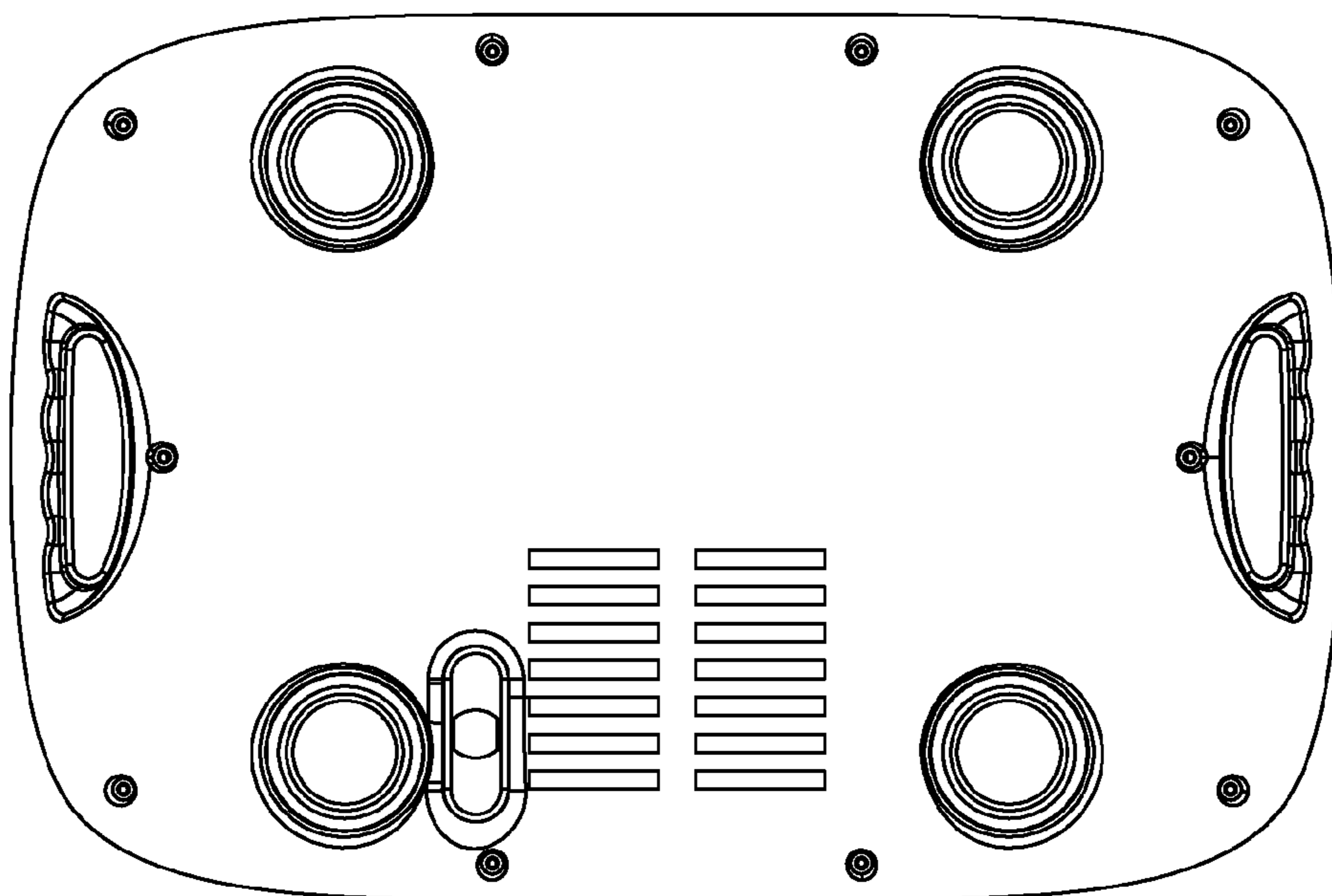




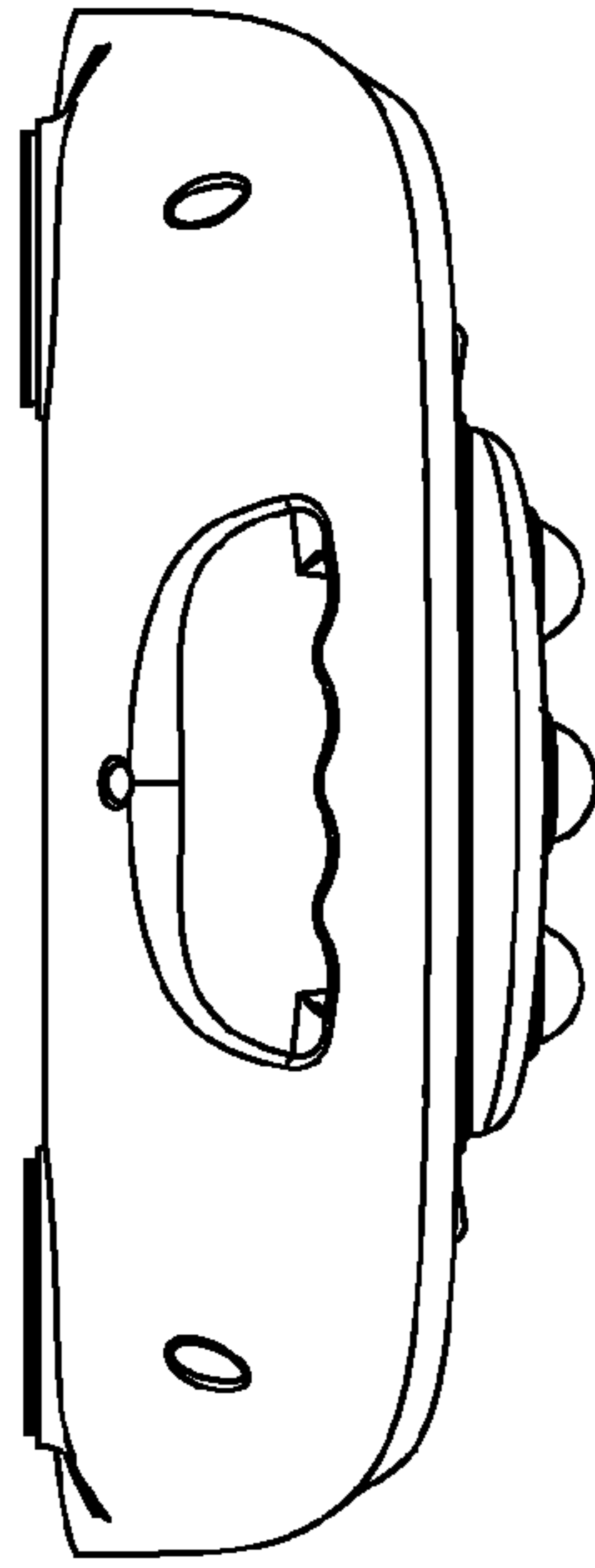

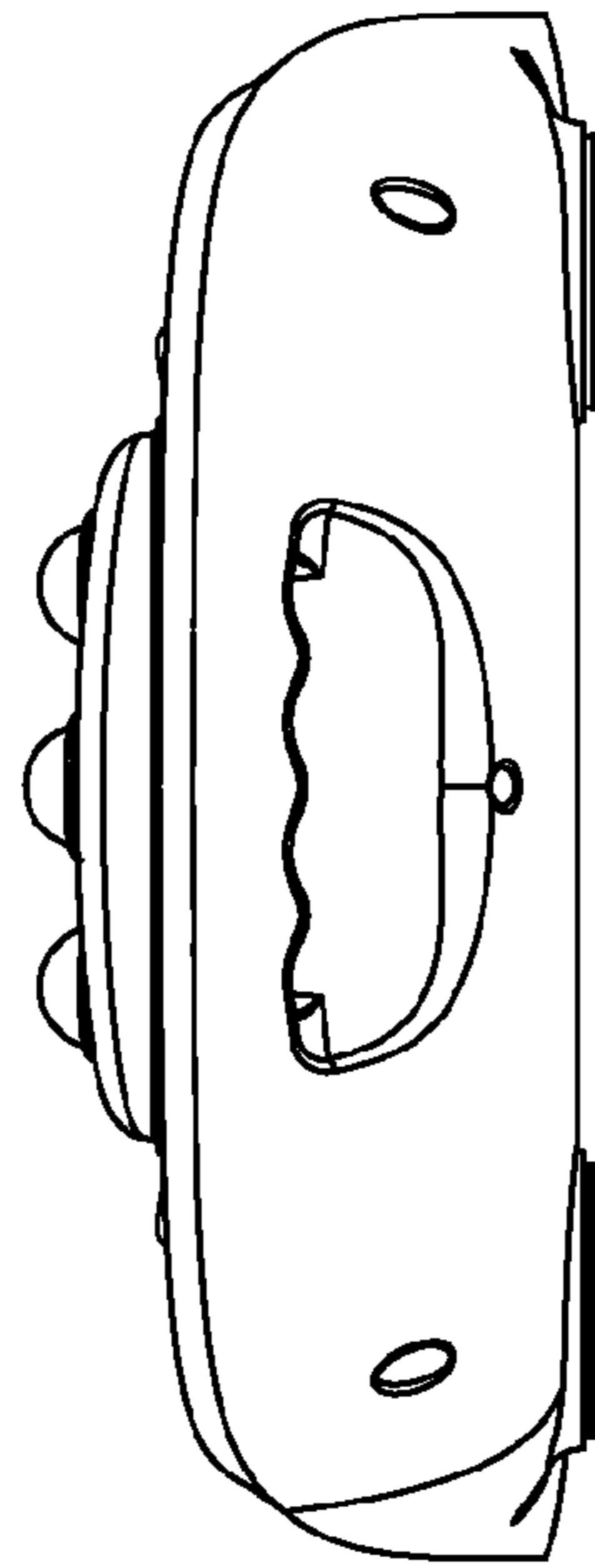

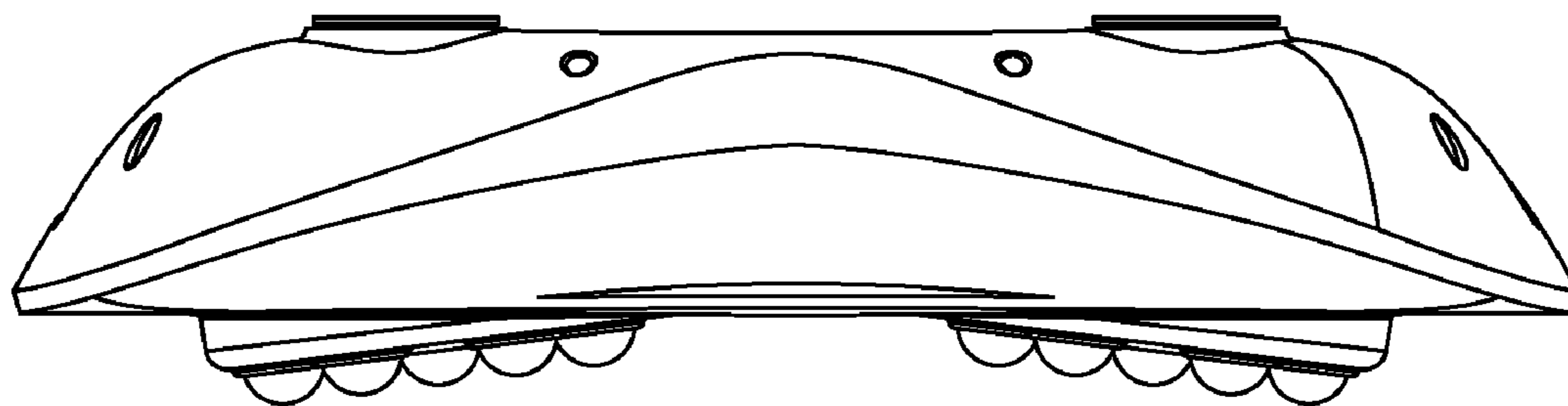

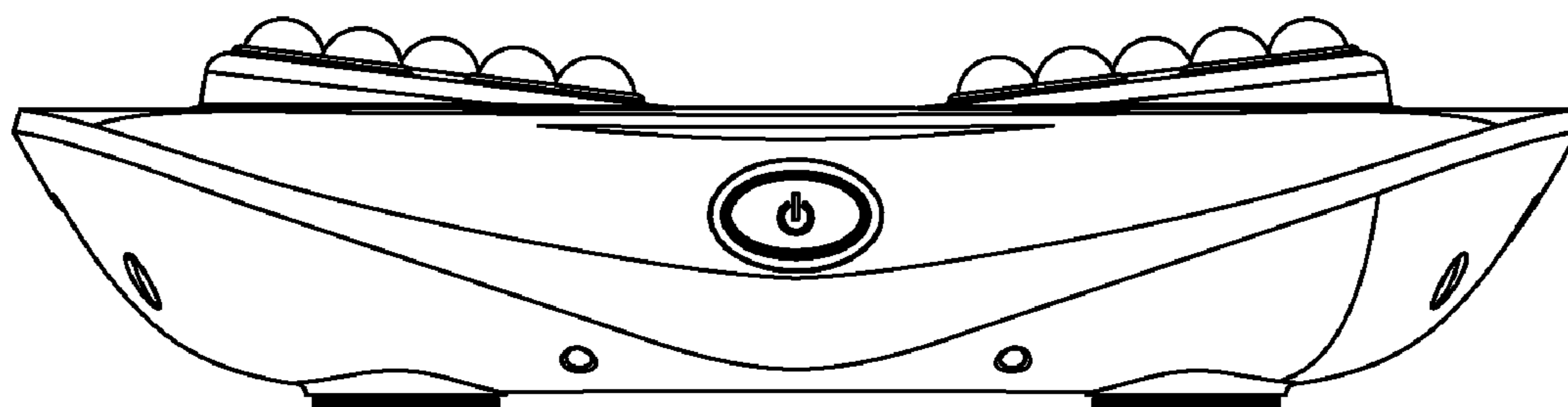
