The ornamental design for a pet ear lifter, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the pet ear lifter showing my design therefor;

FIG. 2 is a top plan view thereof;

FIG. 3 is a side elevational view thereof, the opposite side being identical;

FIG. 4 is a left-end view thereof;

FIG. 5 is a cross-sectional view thereof, taken along line 5—5 of FIG. 2;

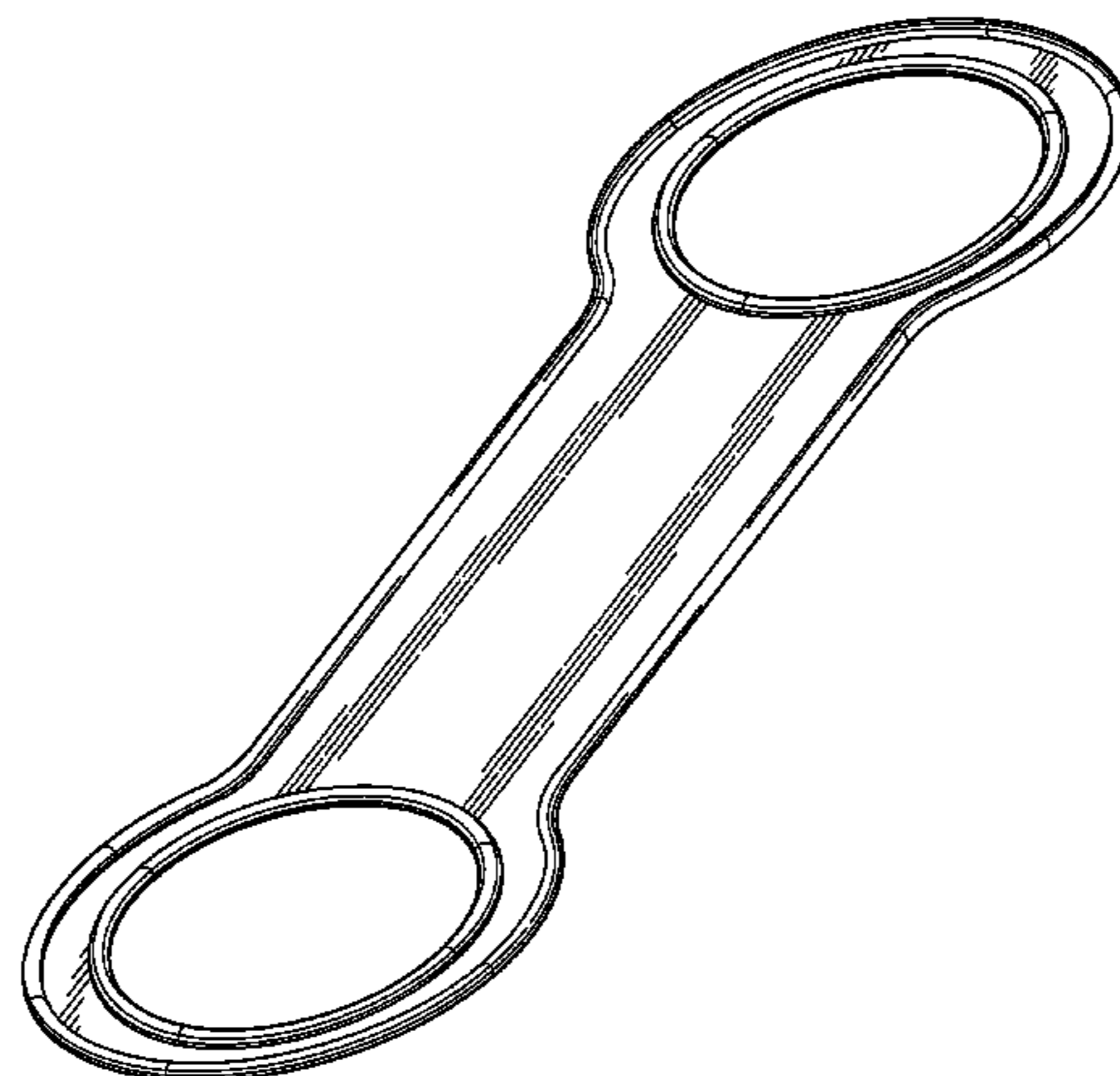
FIG. 6 is a top perspective view of a second embodiment of the invention, the bottom perspective view being identical;

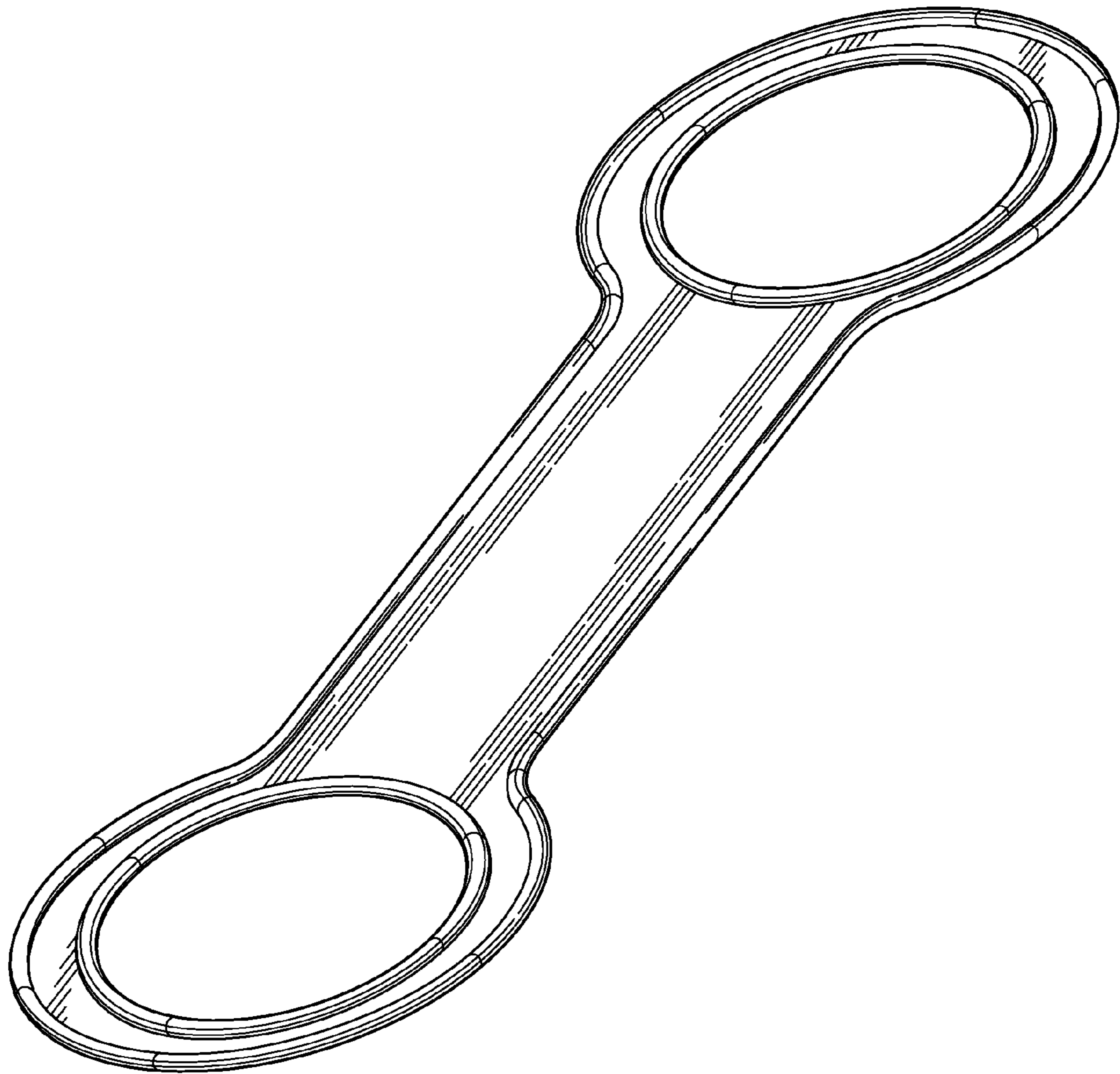

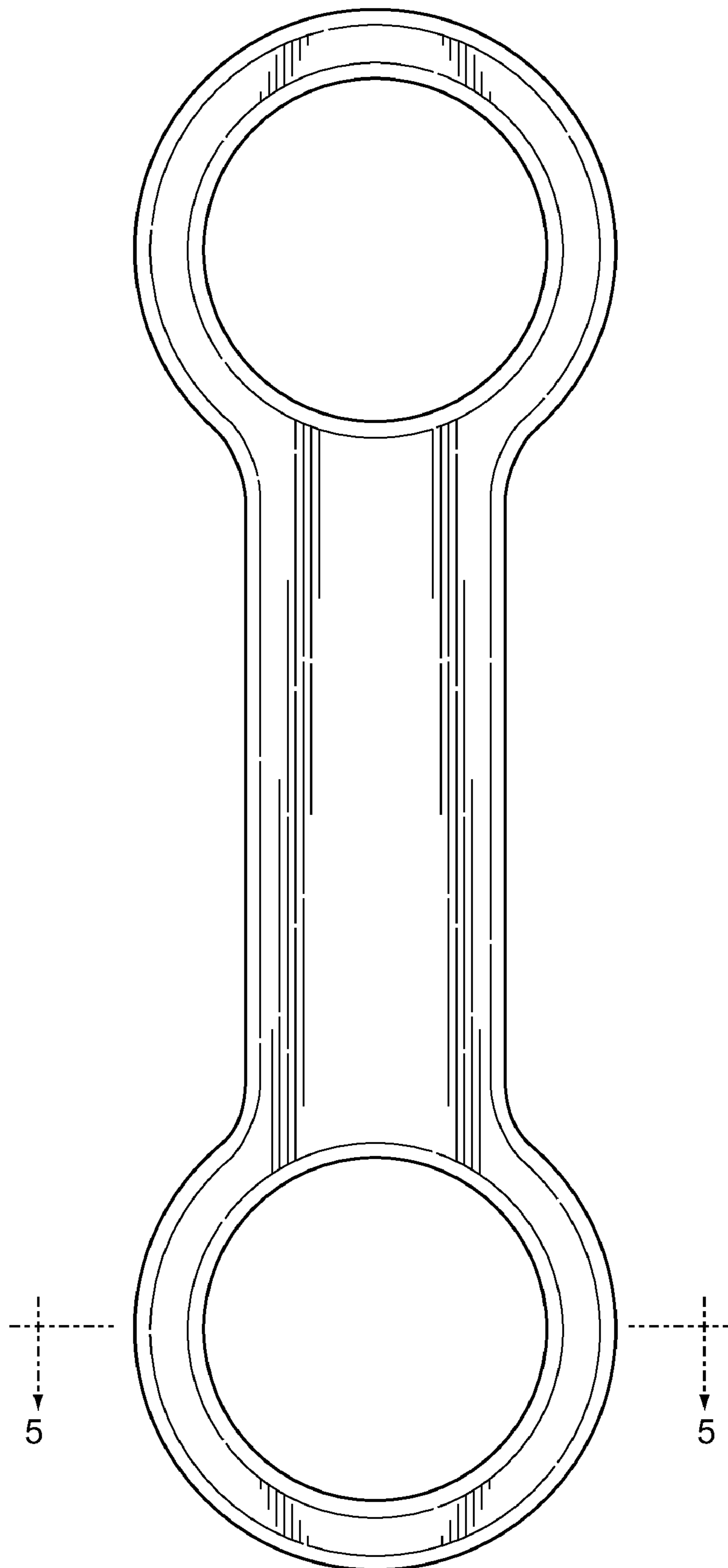

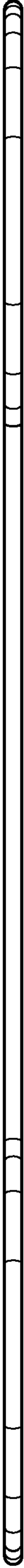

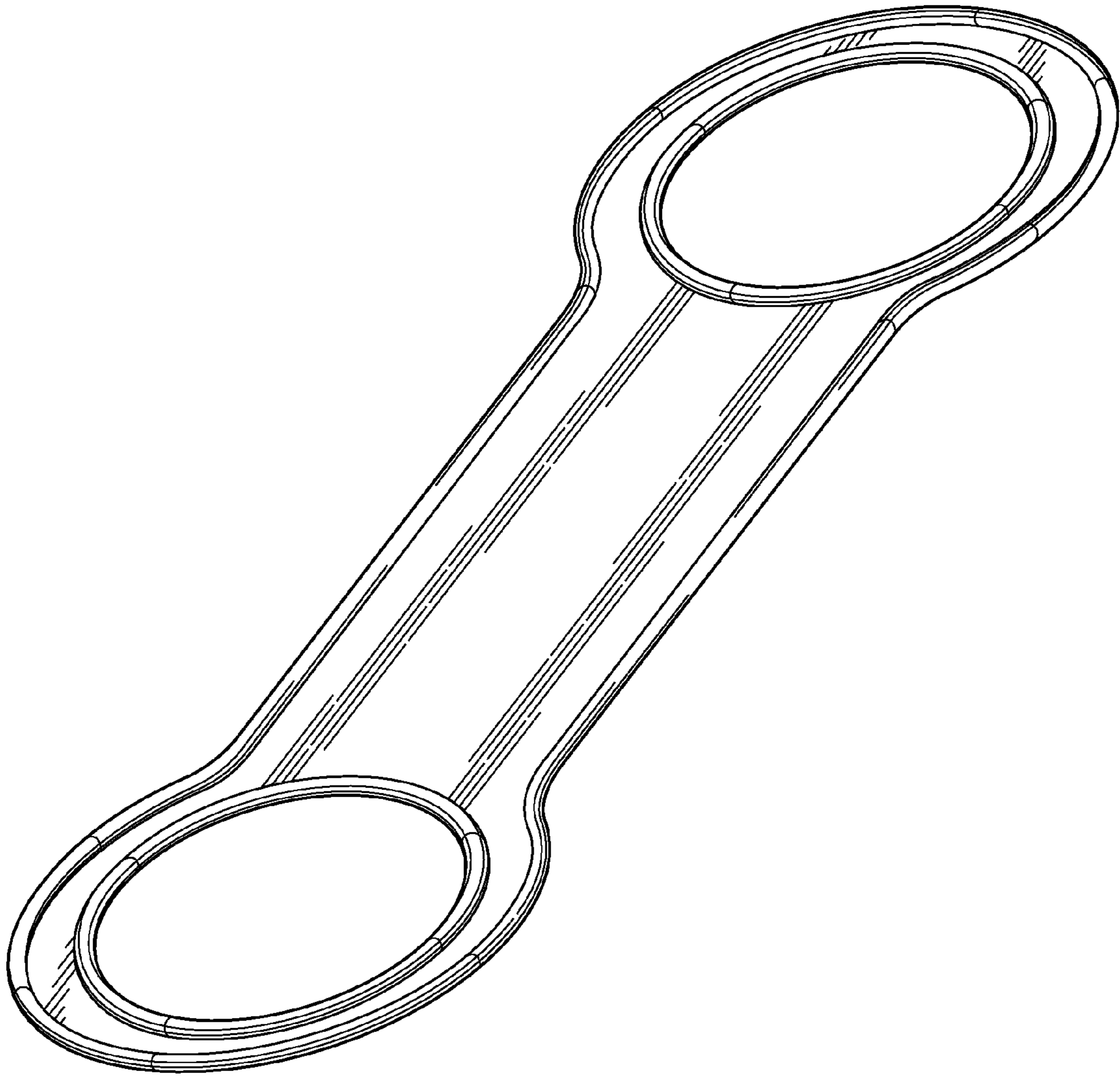

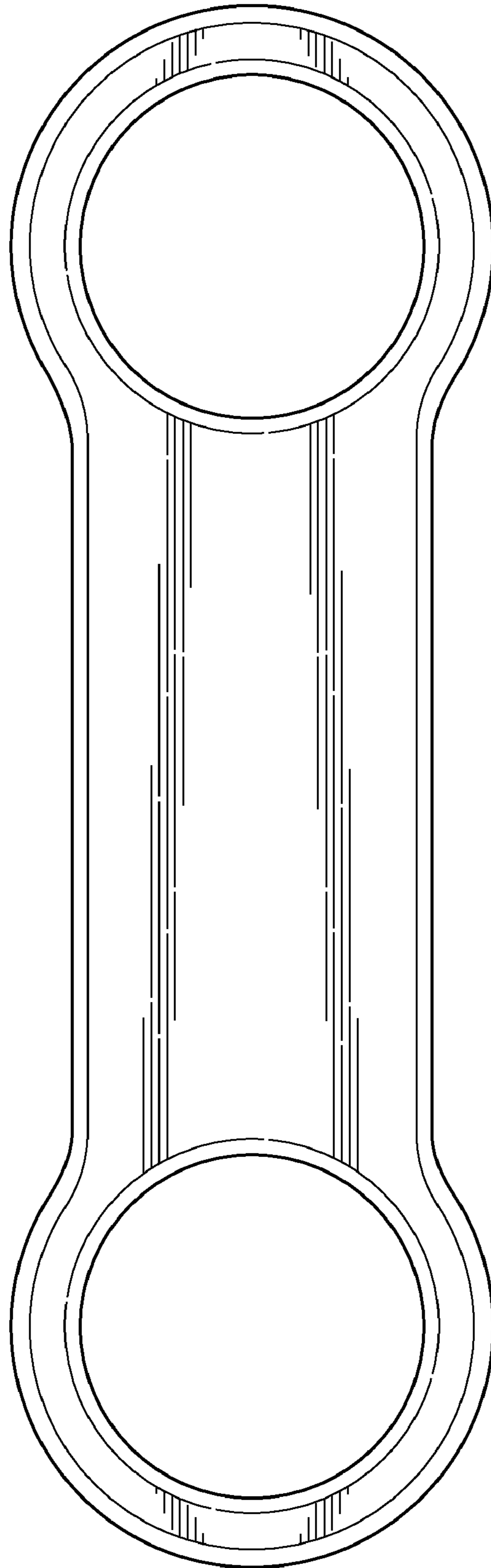
