What is claimed is an ornamental design for headwear, as shown and described.

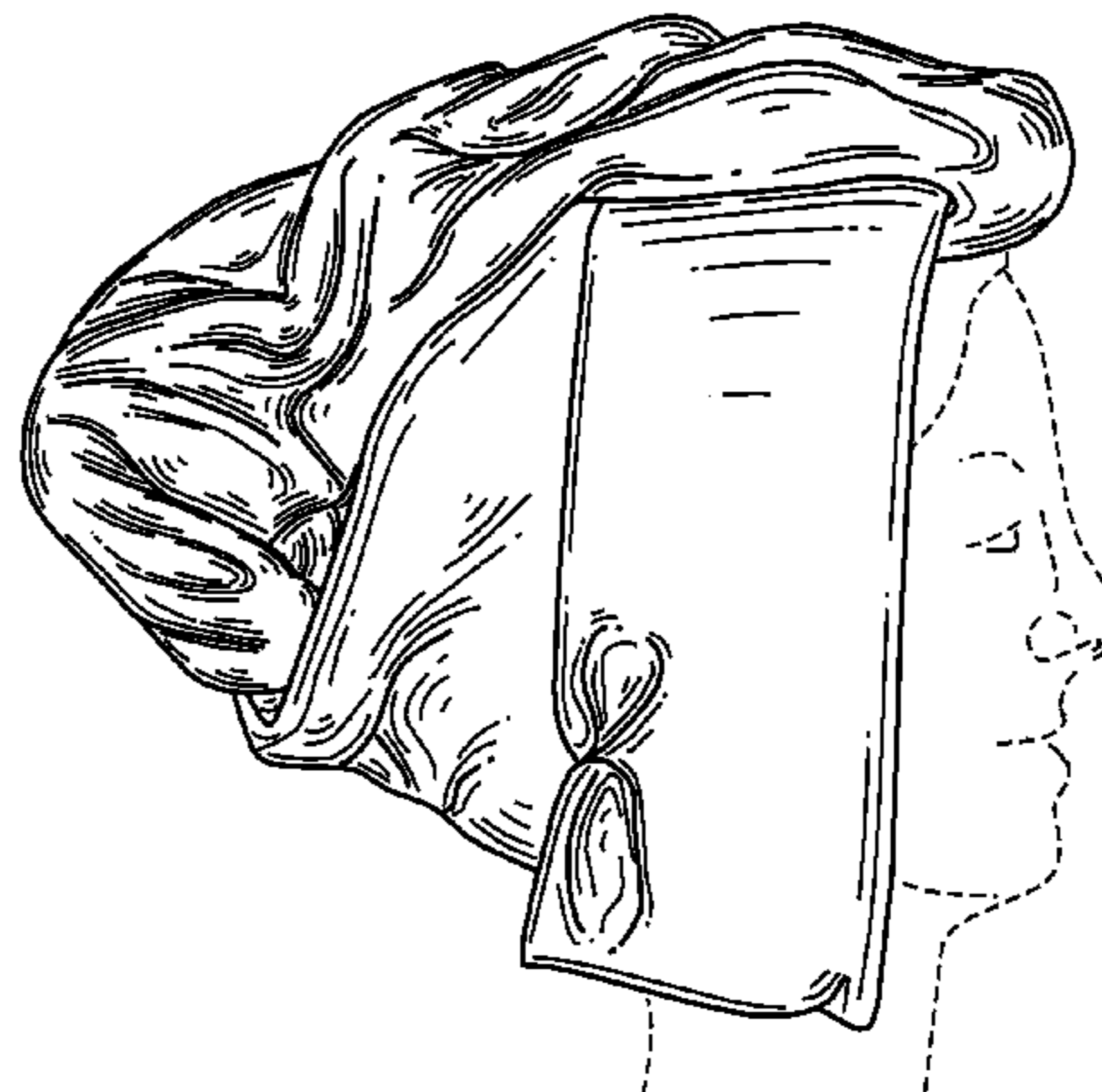
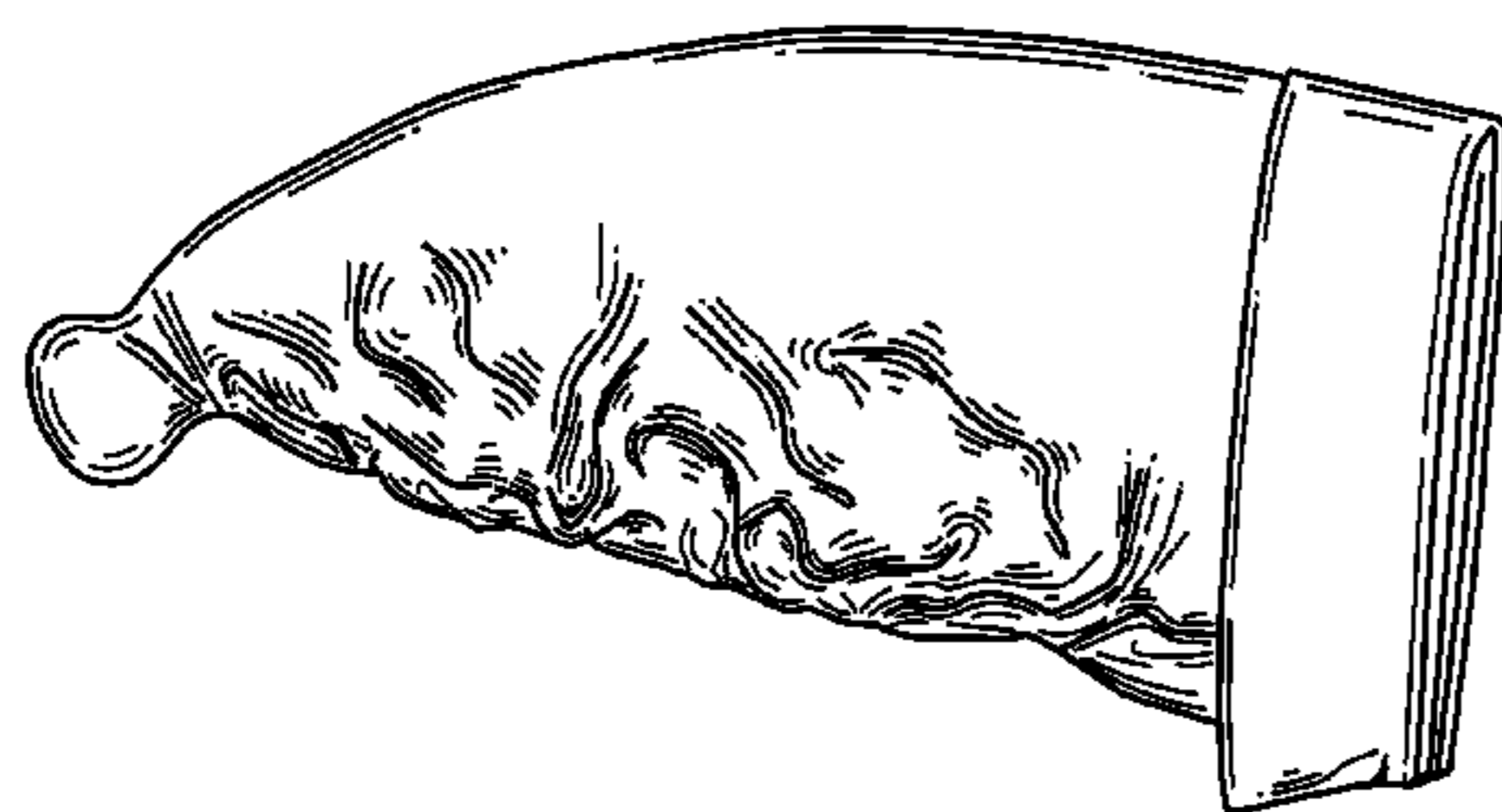

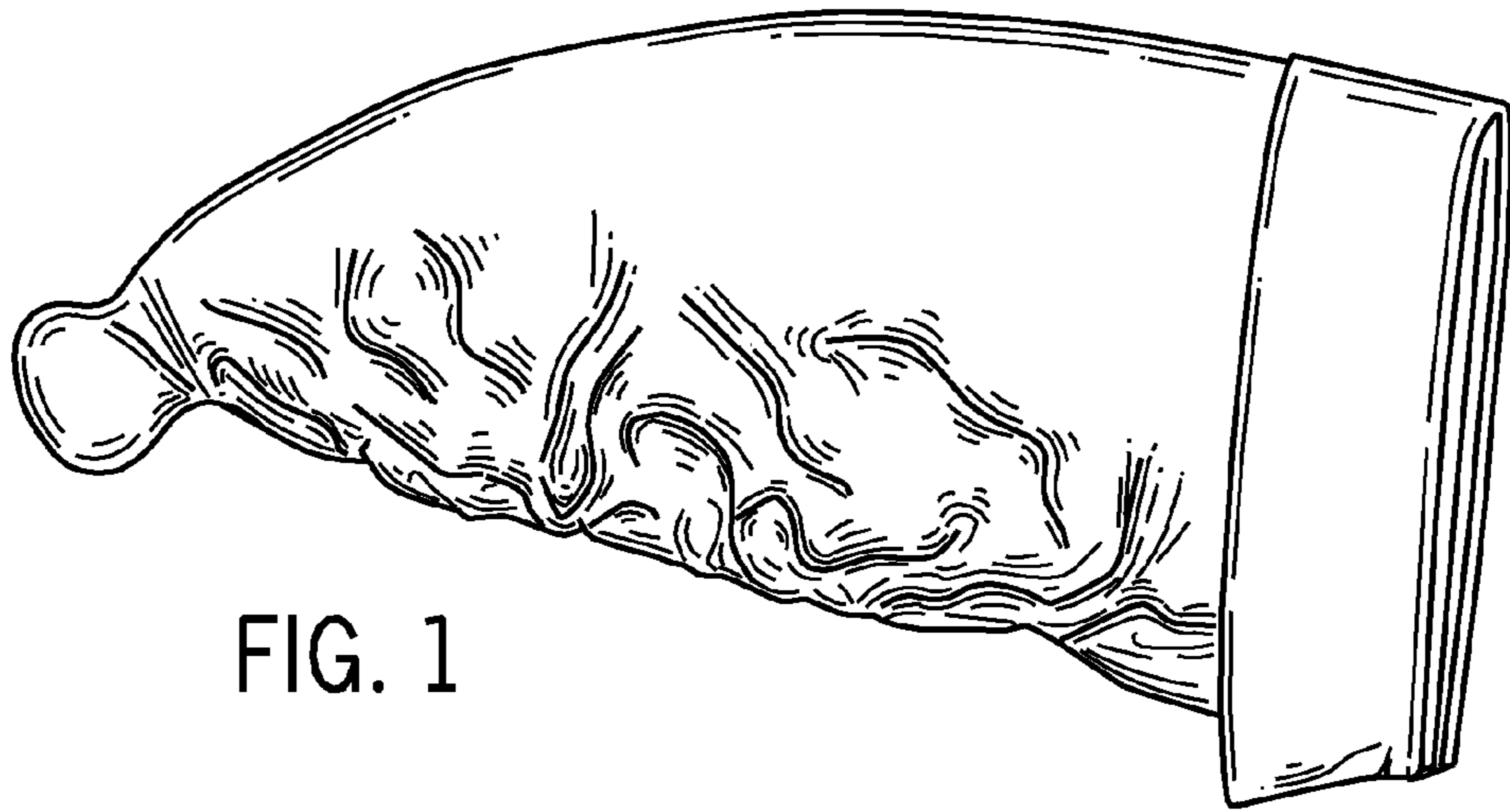

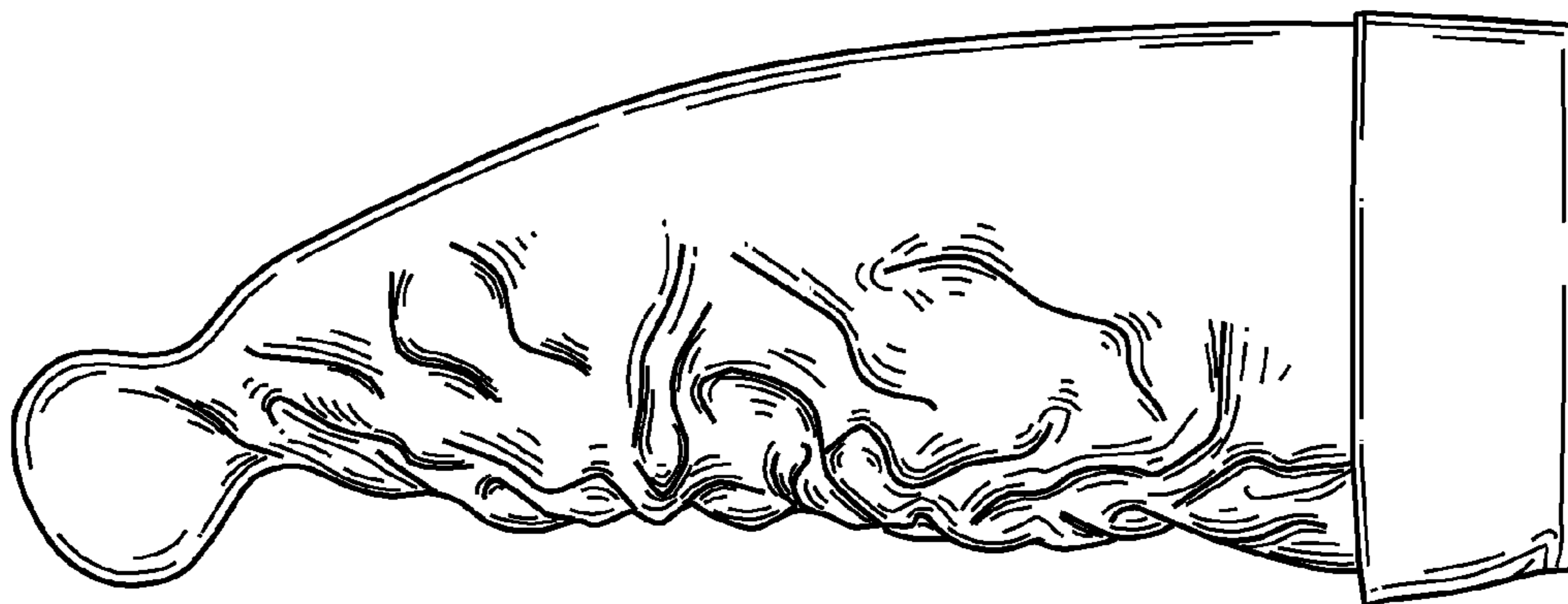

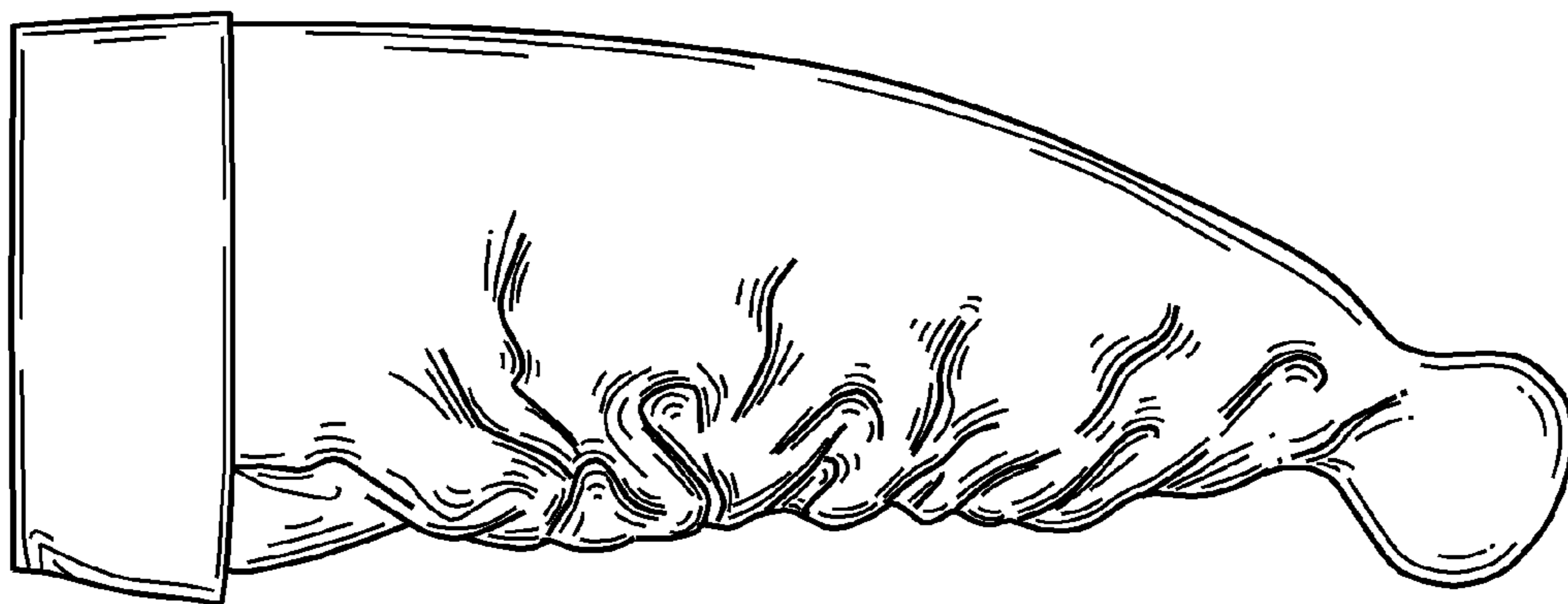

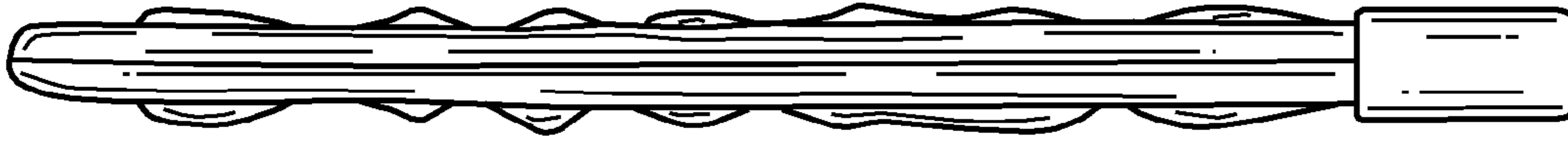

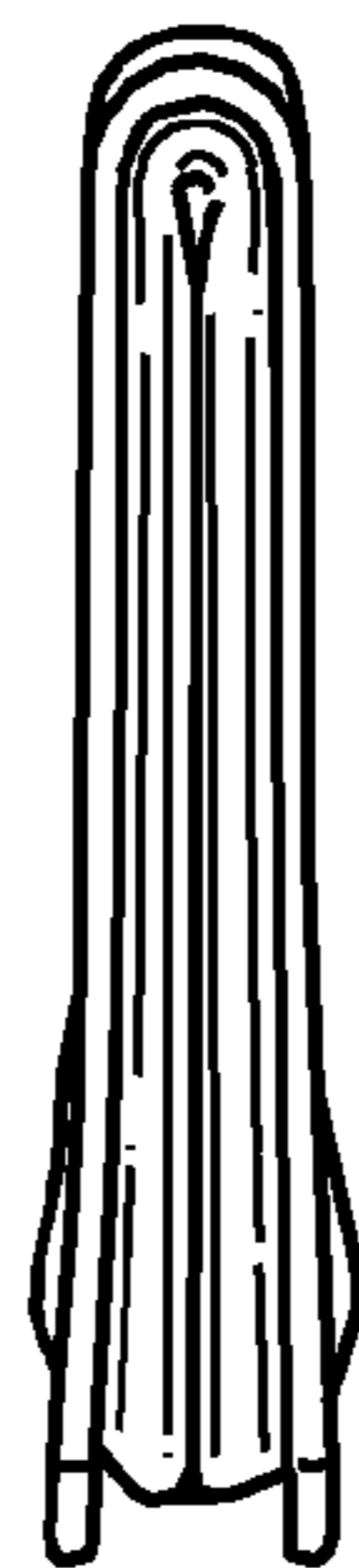

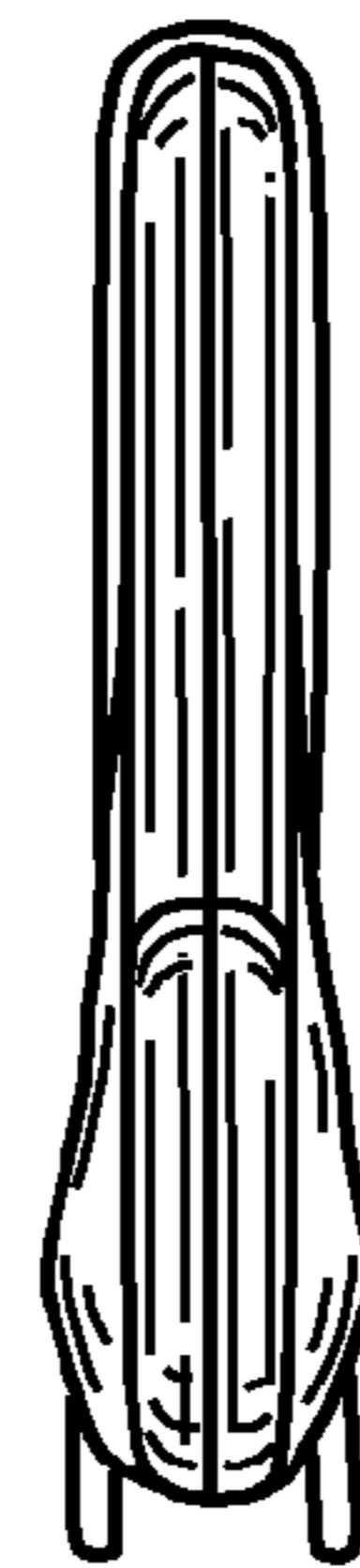

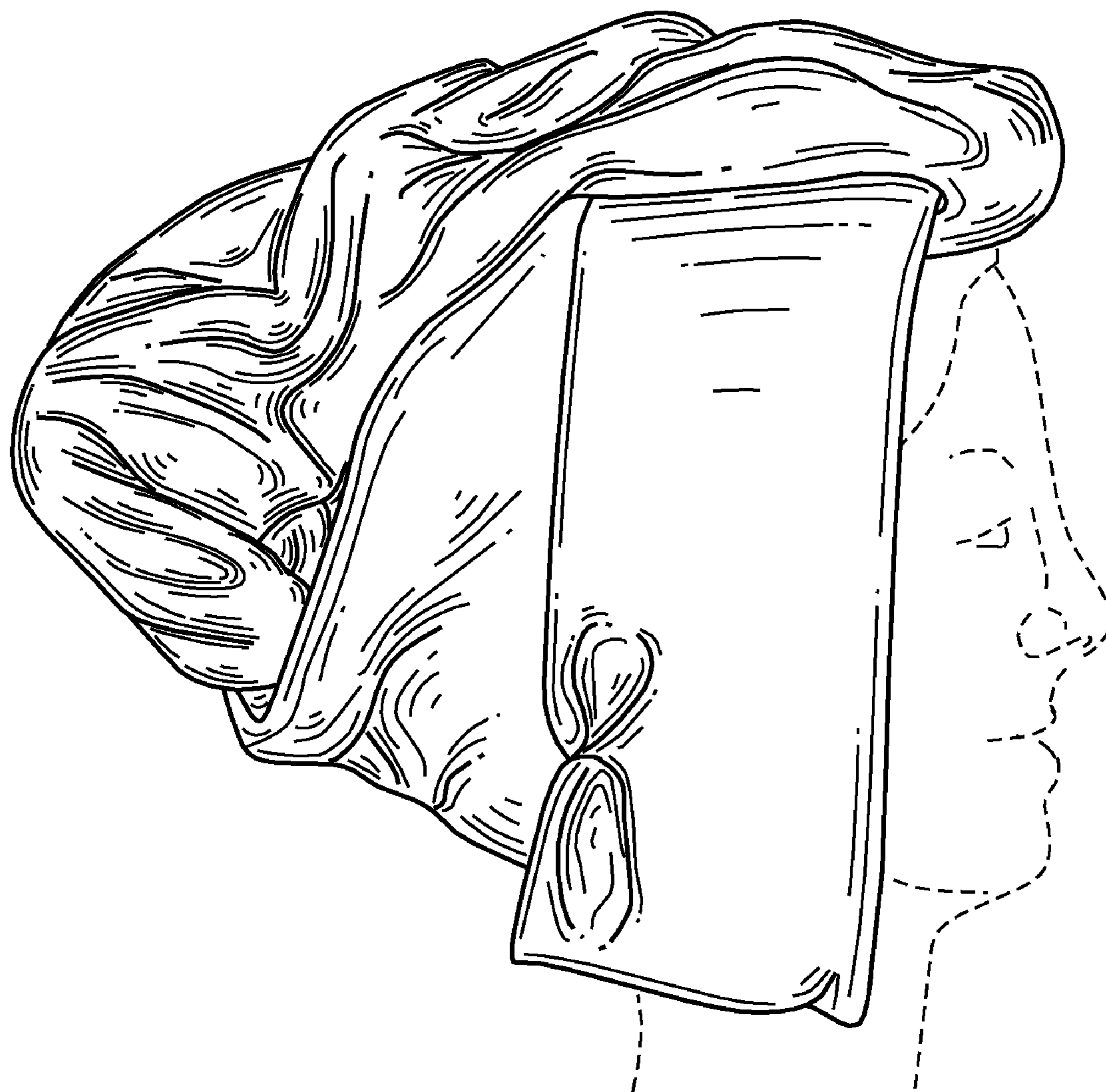
