(57) **CLAIM**

I claim the ornamental design for cleaning kit, substantially as shown and described.

DESCRIPTION

FIG. 4 is a right side view in the open configuration of the cleaning kit;

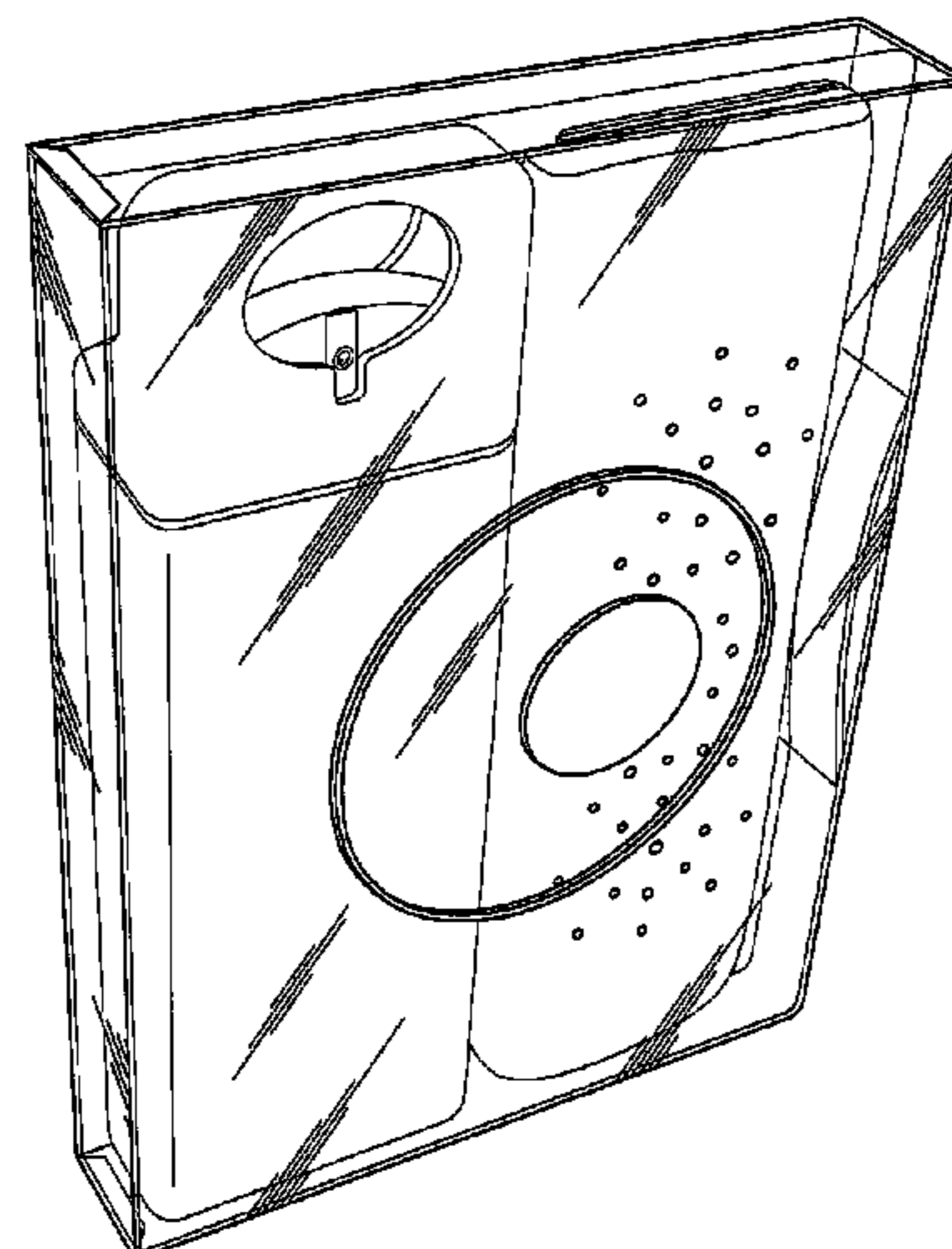
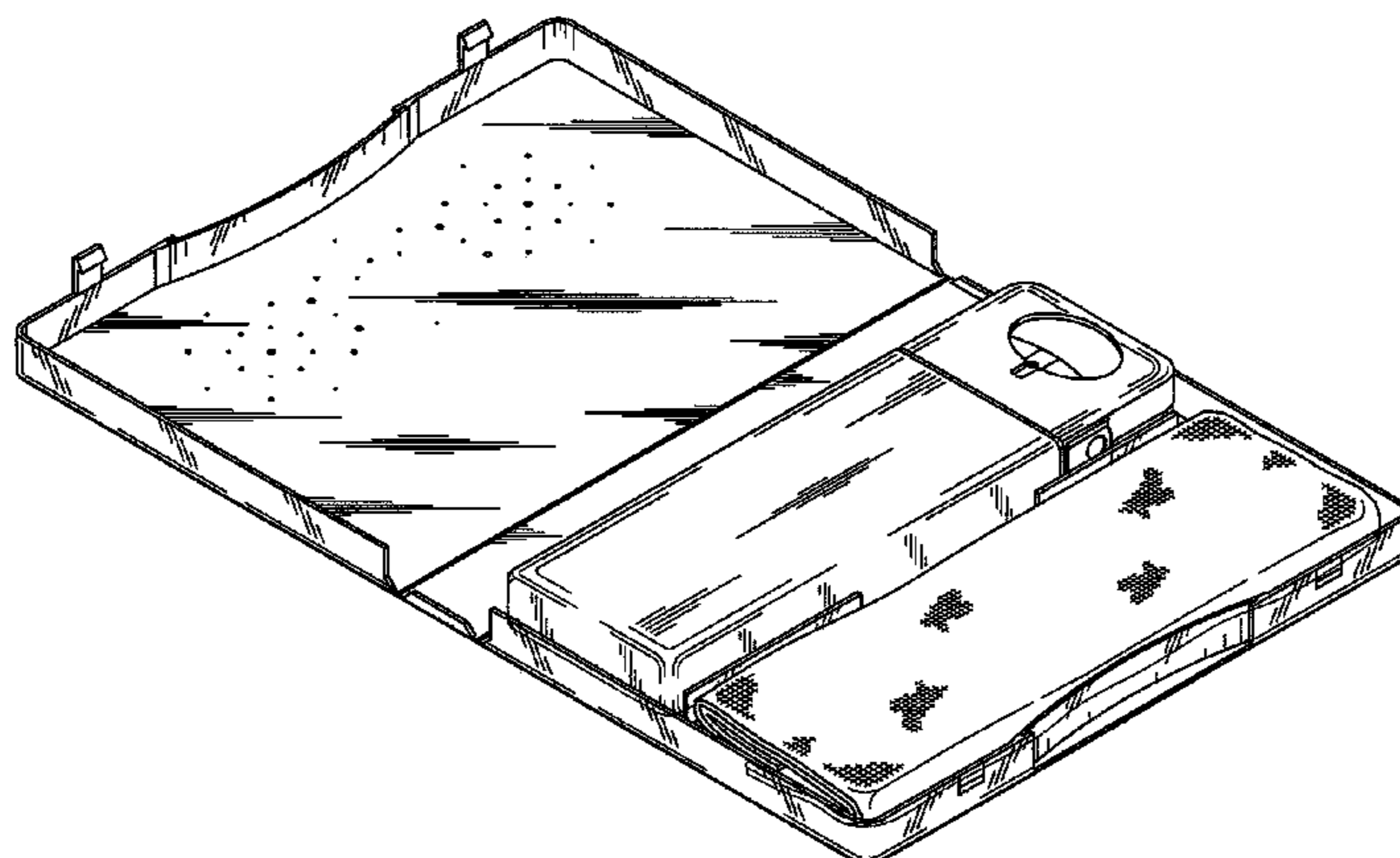
FIG. 5 is a bottom view in the open configuration of the cleaning kit;

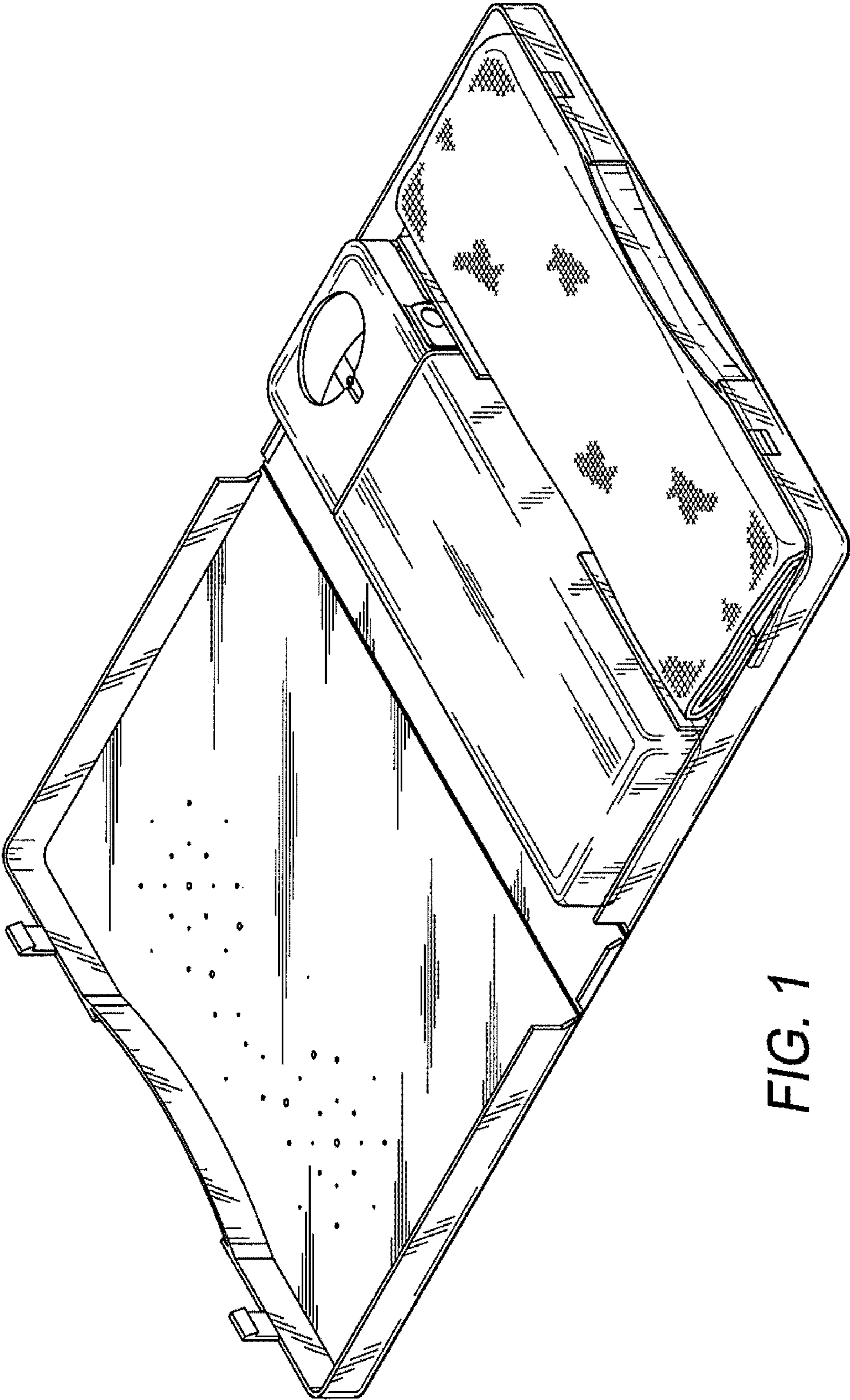

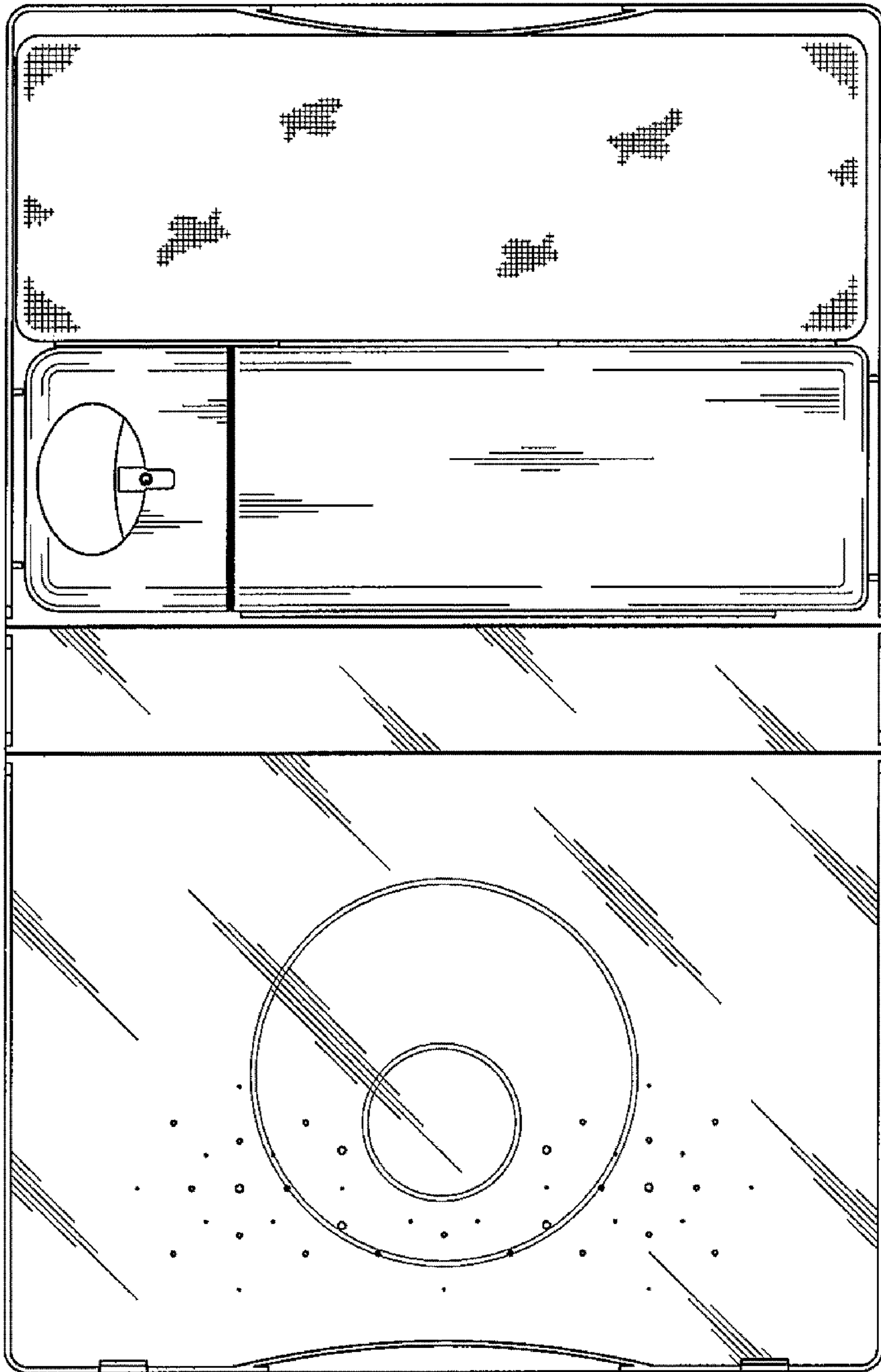

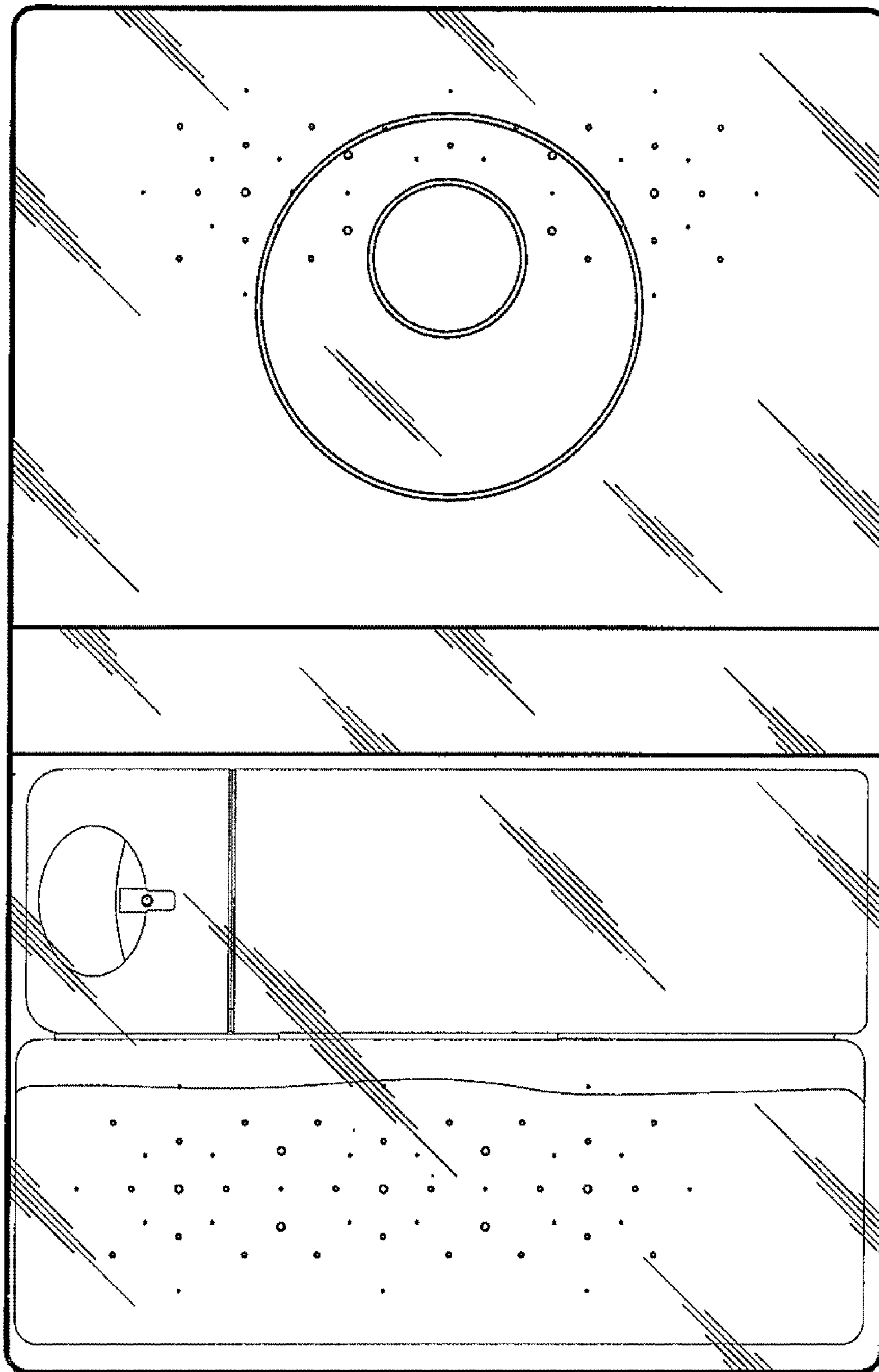

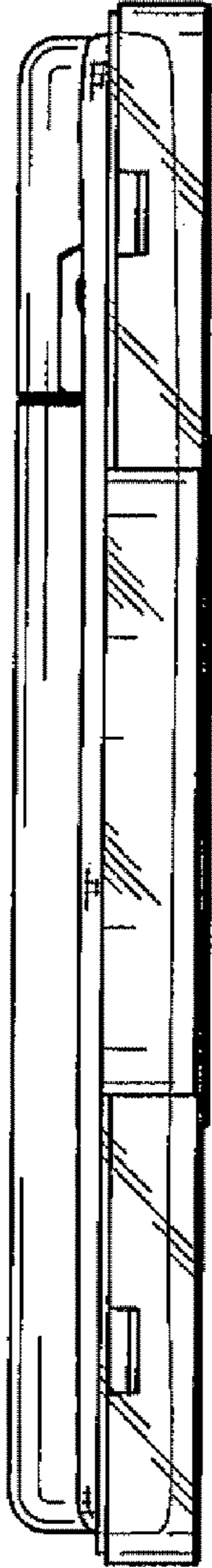

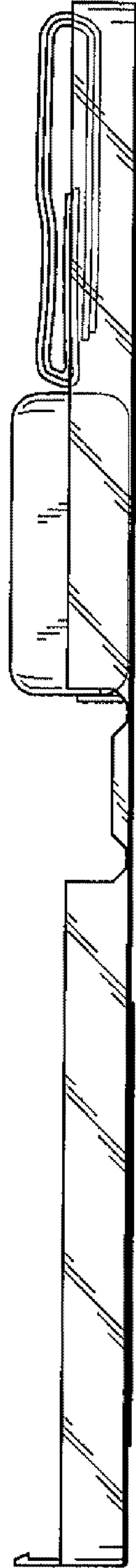

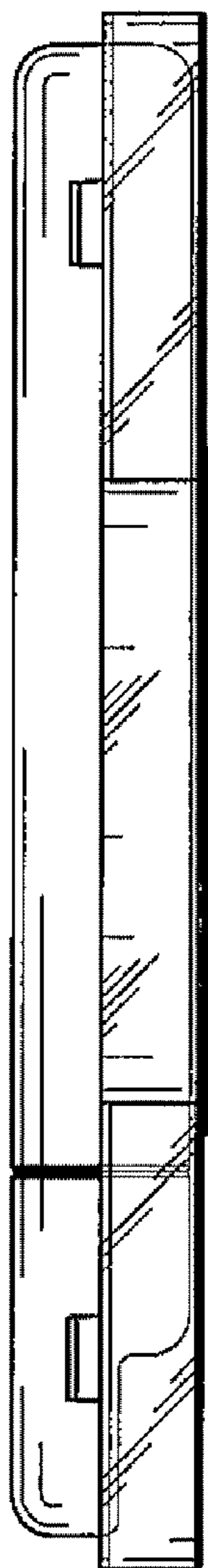

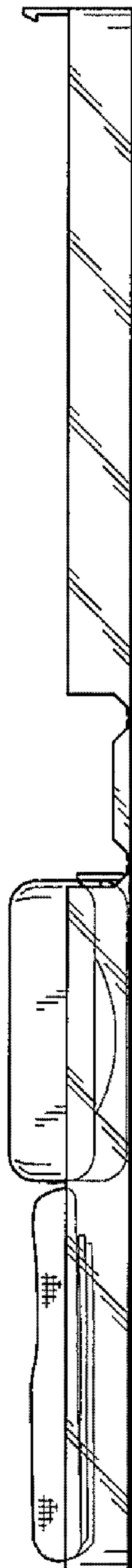

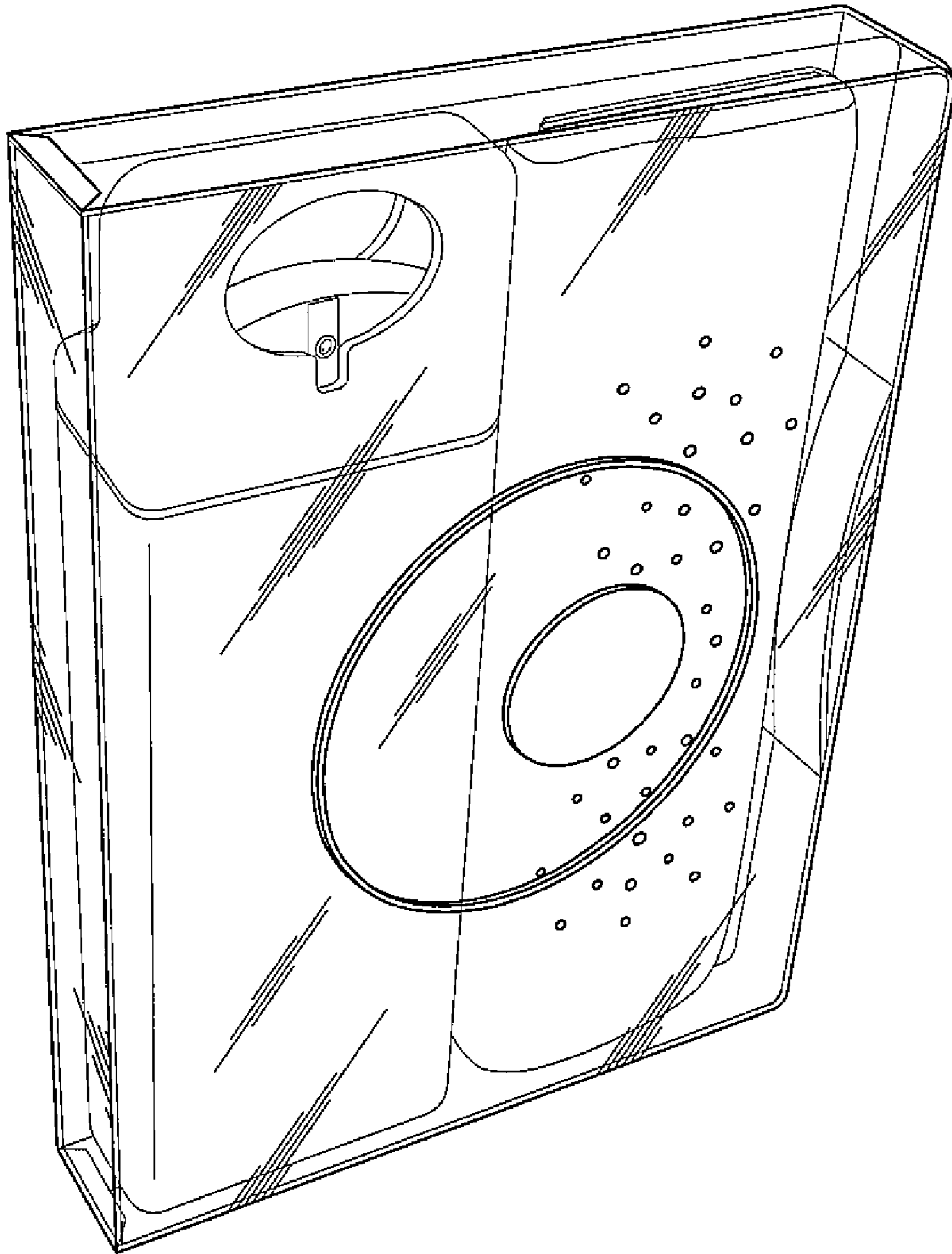
