FIG. 2 is a top plan view of the bath mat shown in FIG. 1;

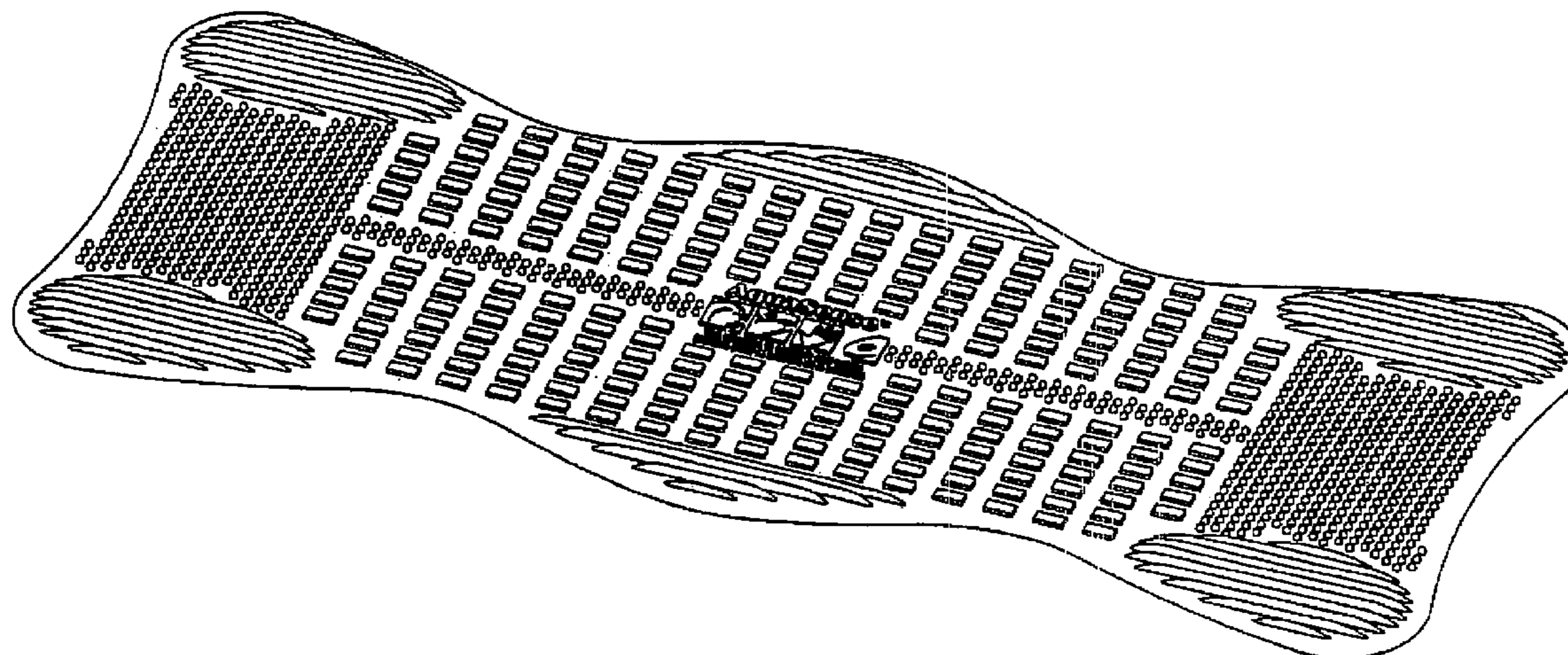
FIG. 3 is a bottom plan view of the bath mat shown in FIG. 1; and,

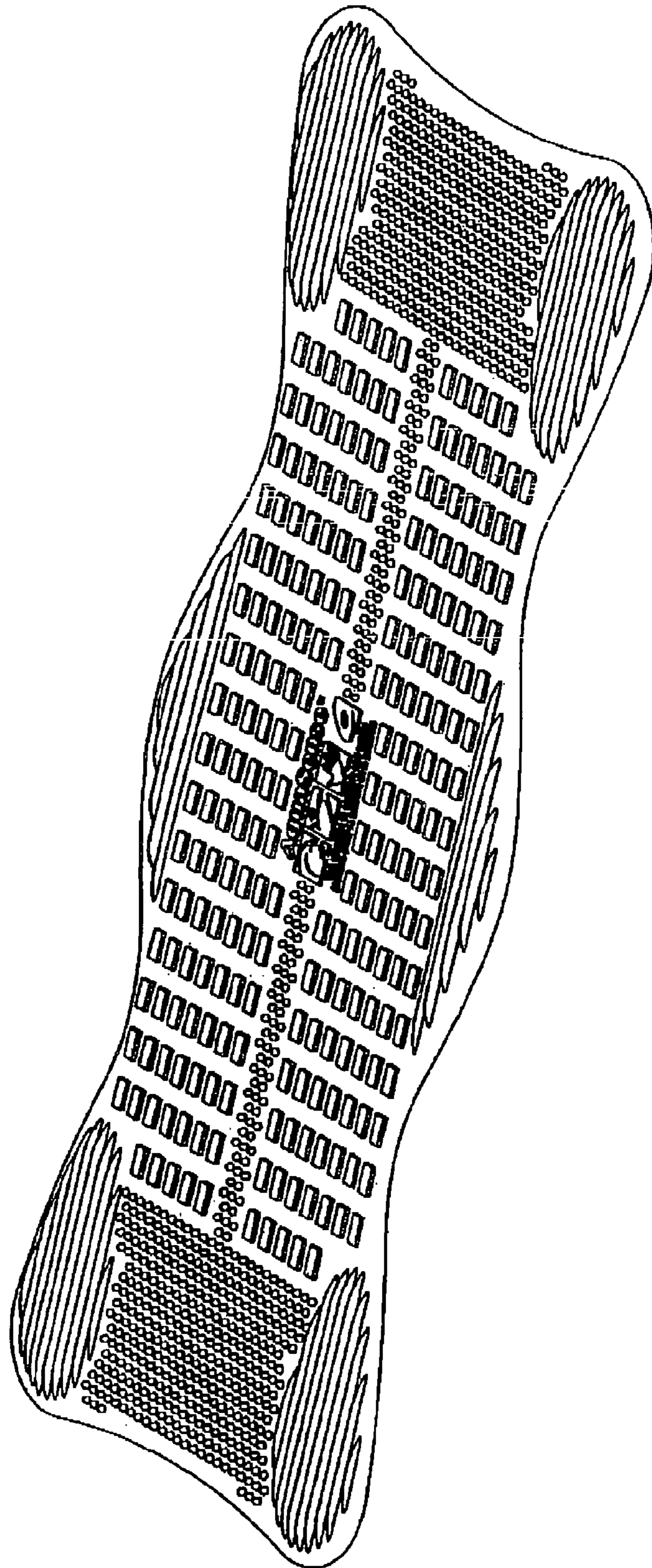

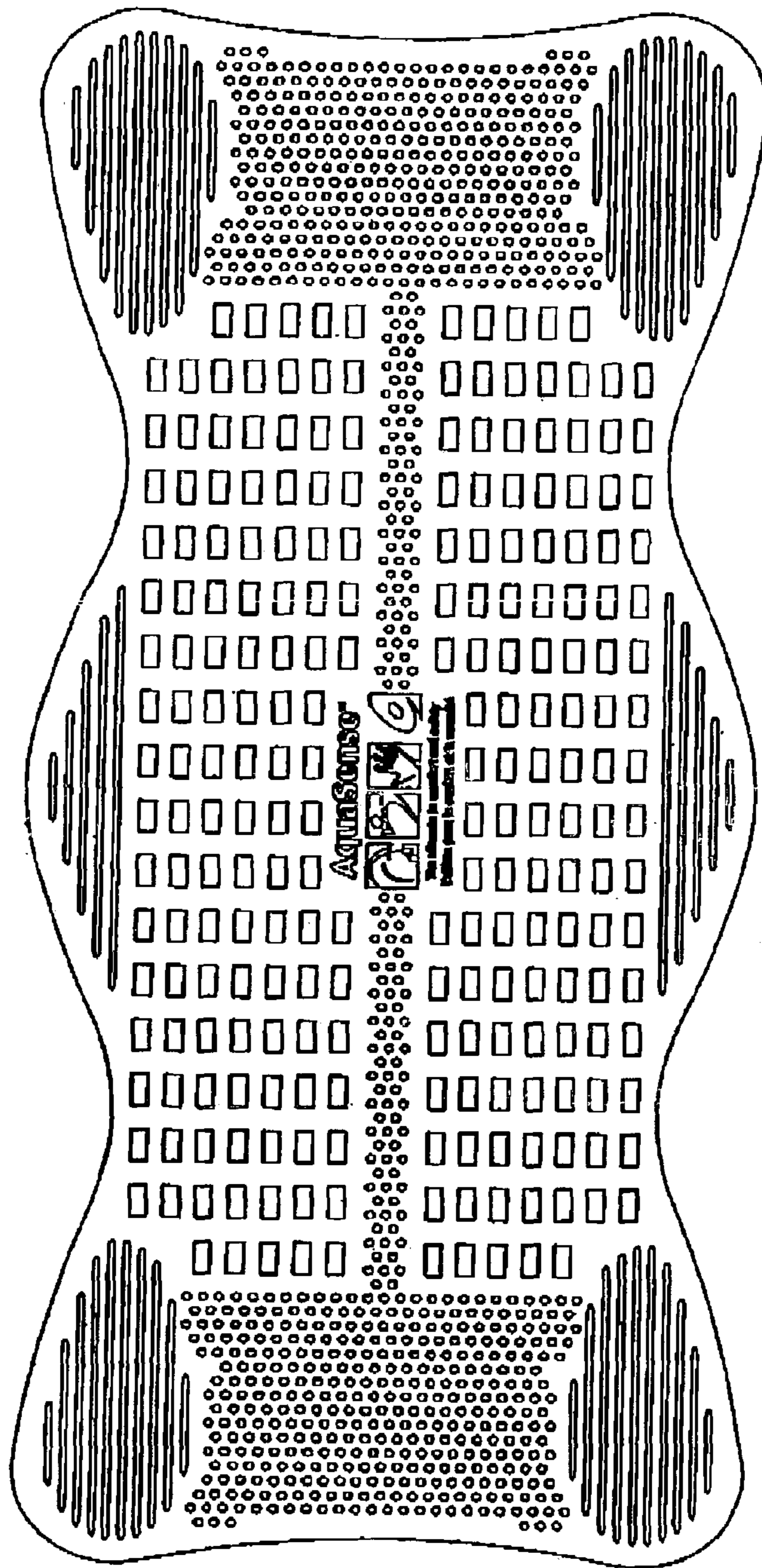

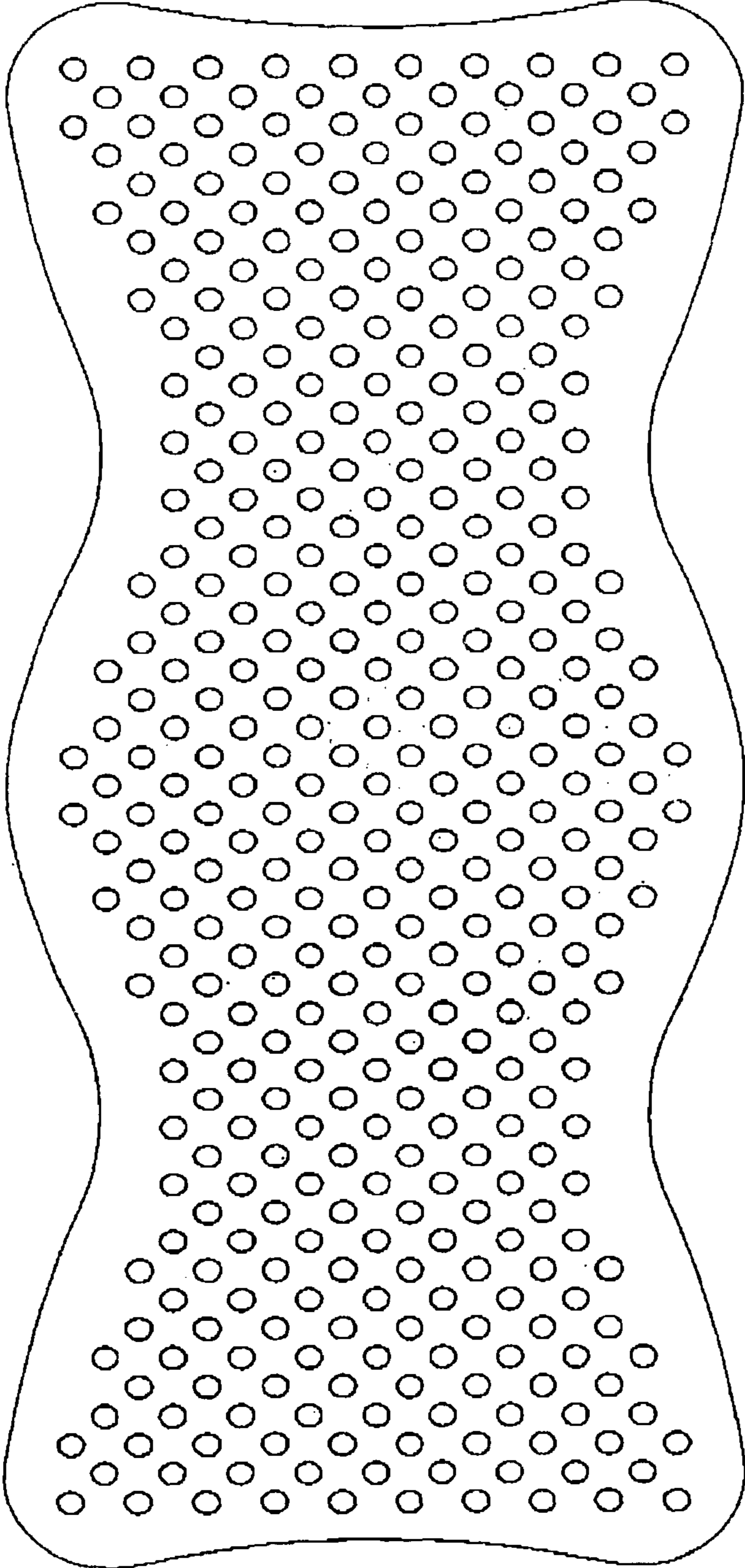
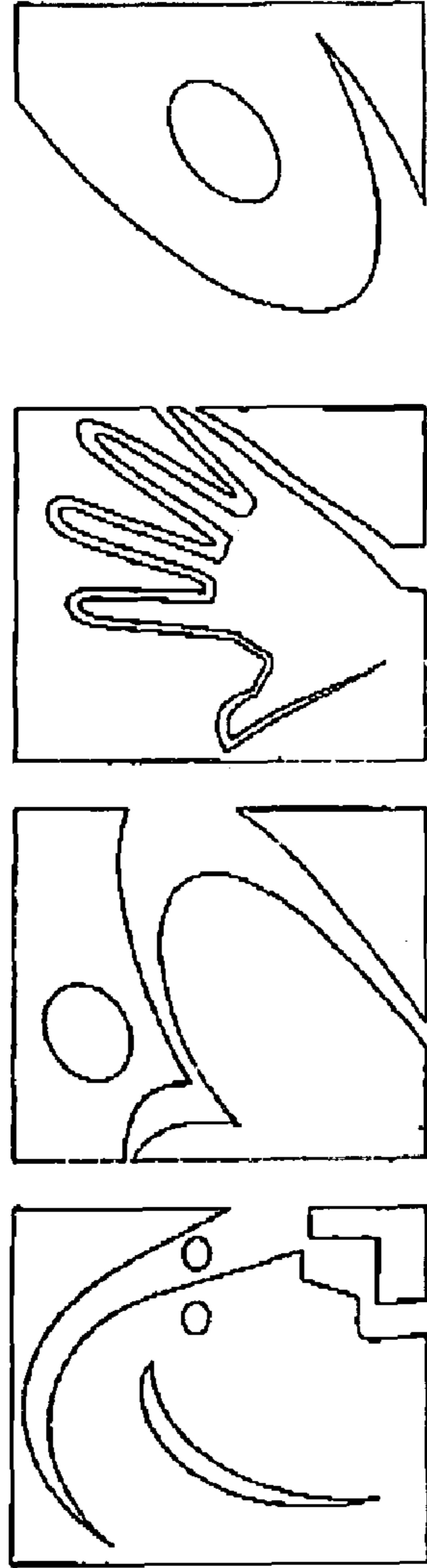
