(57) **CLAIM**

The ornamental design for a cookie sheet, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a cookie sheet in accordance with the invention shown;

FIG. 2 is a front view of the cookie sheet from FIG. 1;

FIG. 3 is a top view of the cookie sheet from FIG. 1;

FIG. 4 is an enlarged top perspective of the cookie sheet from box 4 illustrated in FIG. 3,

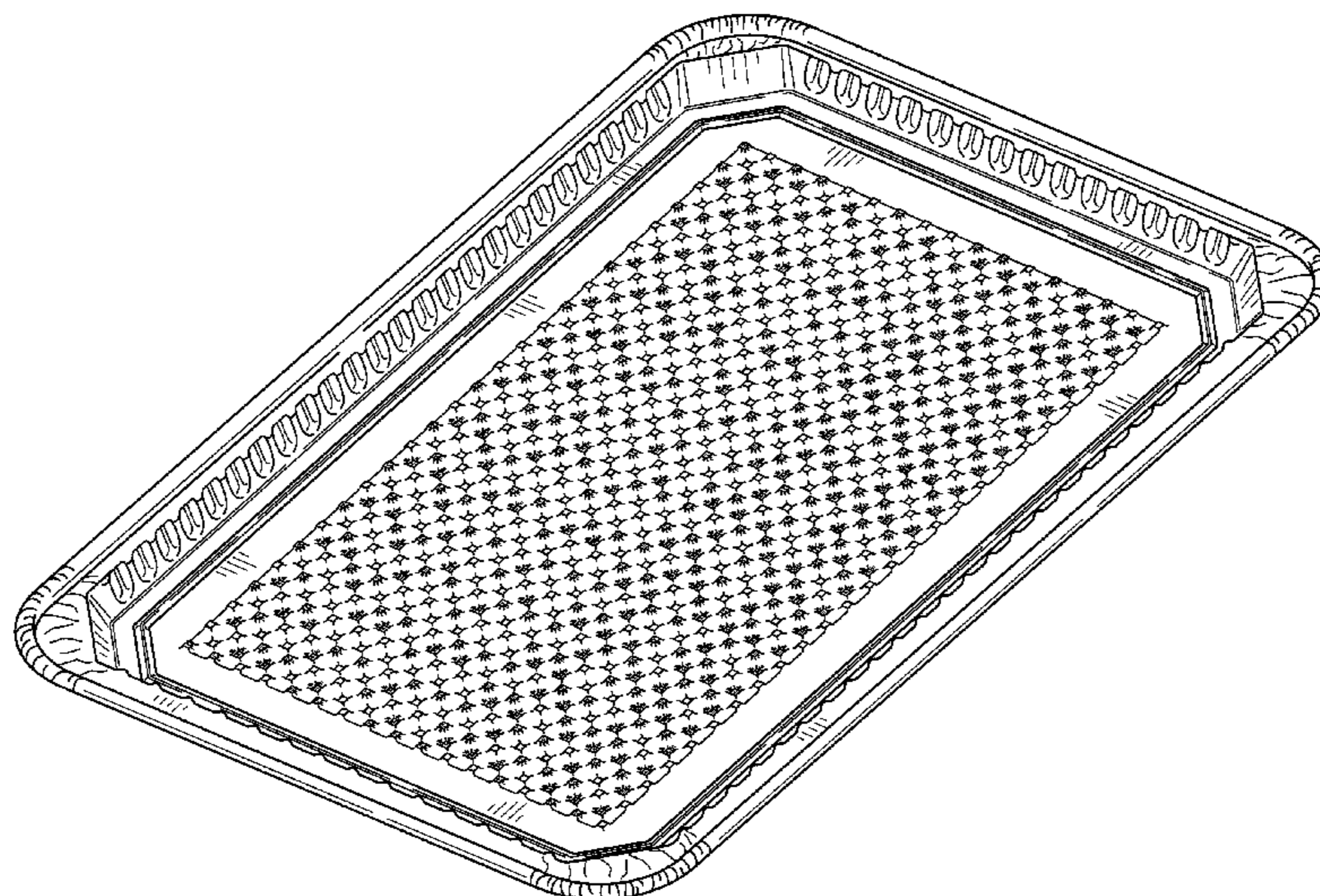
FIG. 5 is a cross sectional view of the cookie sheet from line 5 illustrated in FIG. 3;

FIG. 6 is a top view of the cookie sheet from FIG. 1;

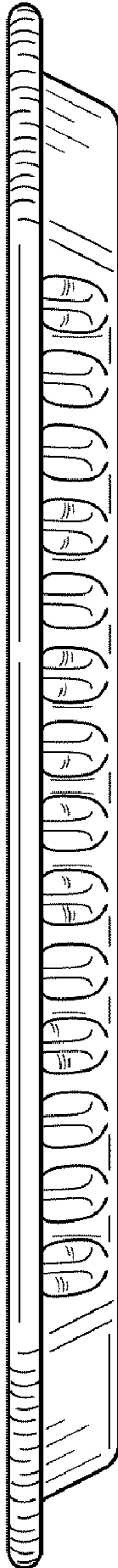

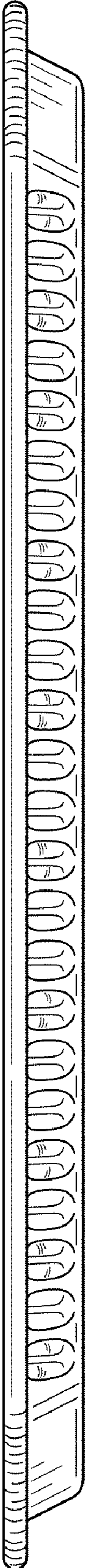

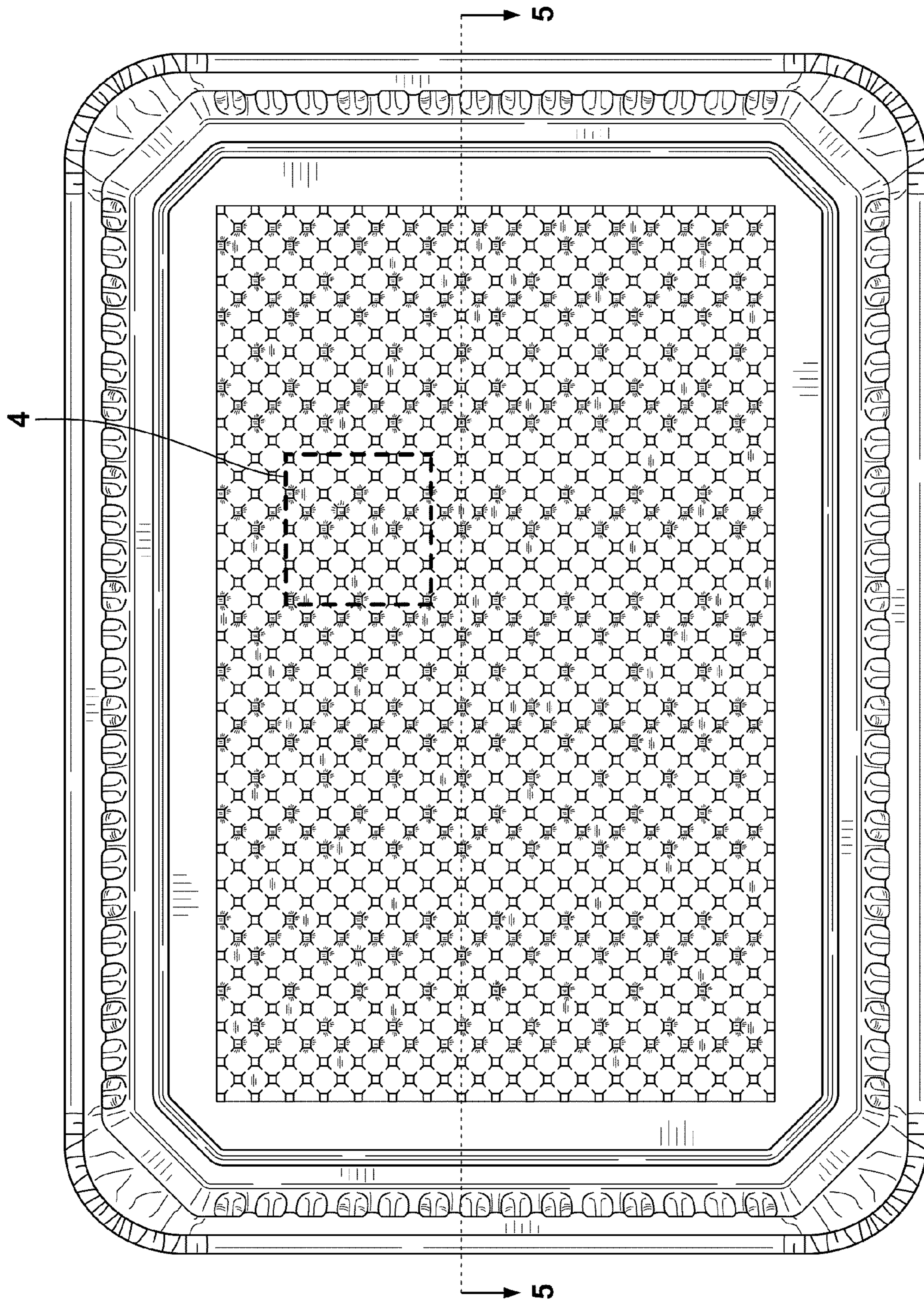

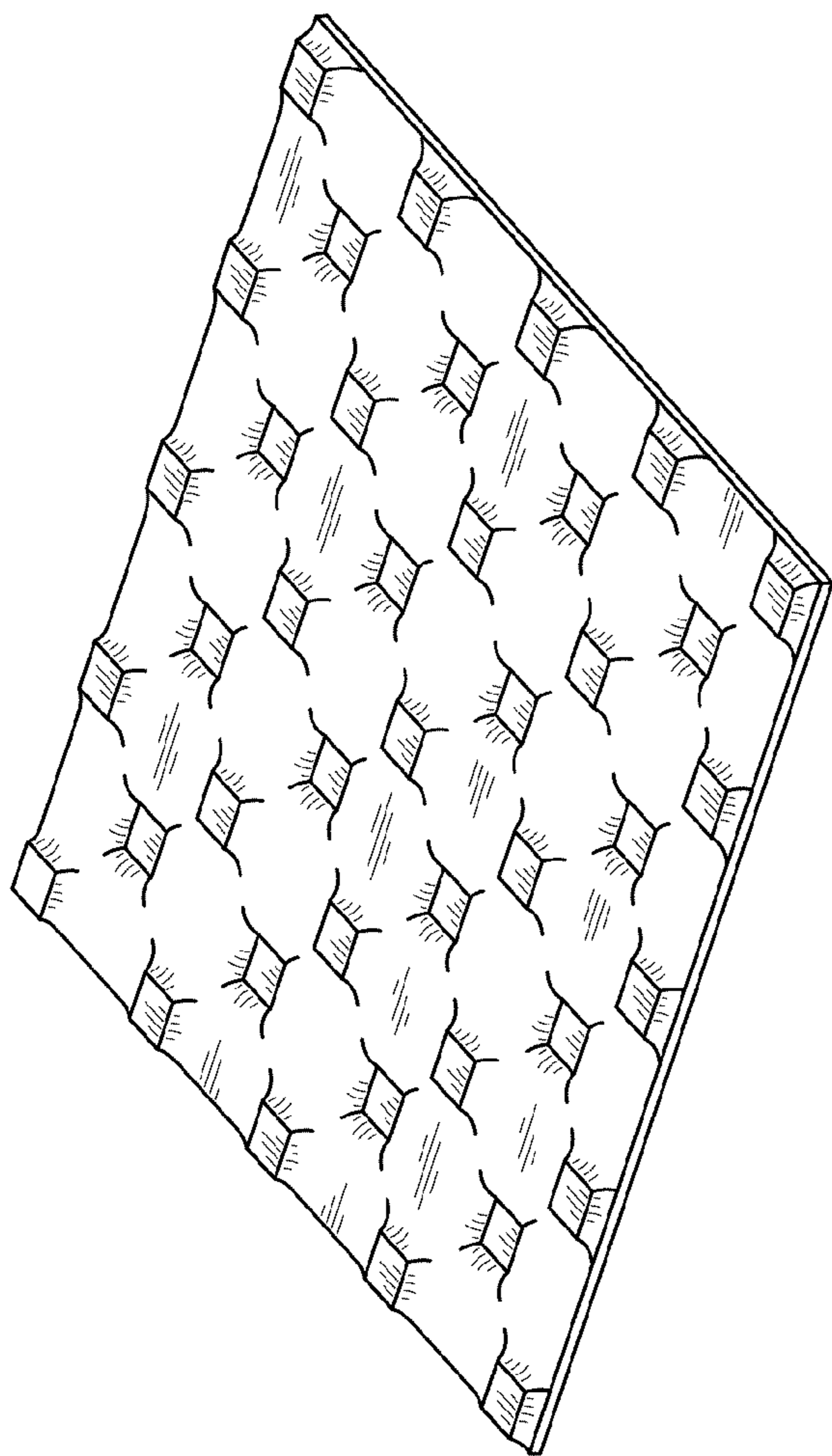

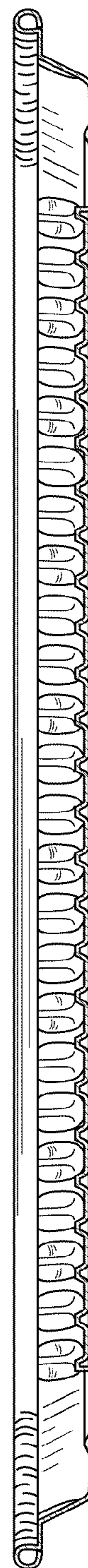

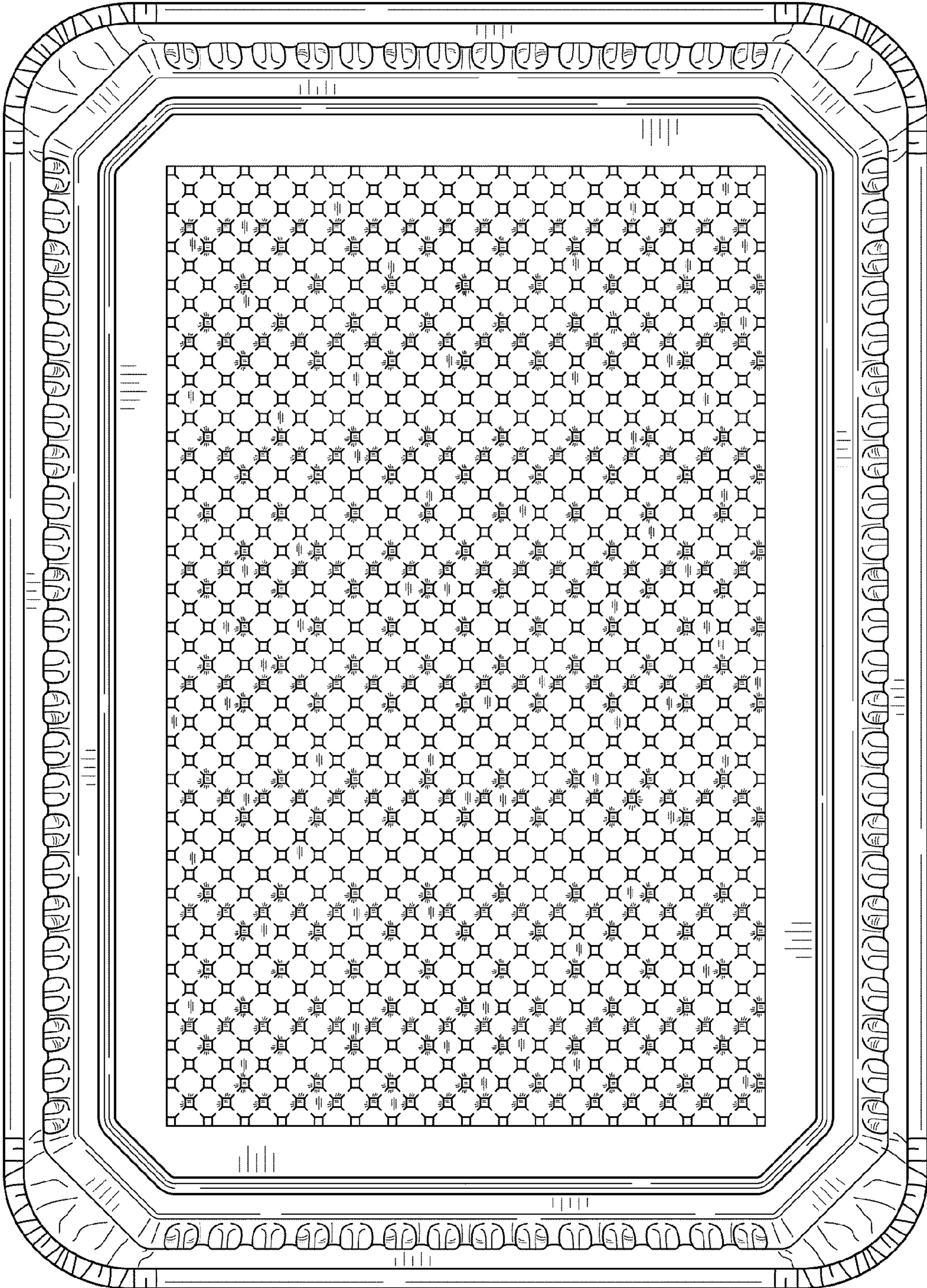

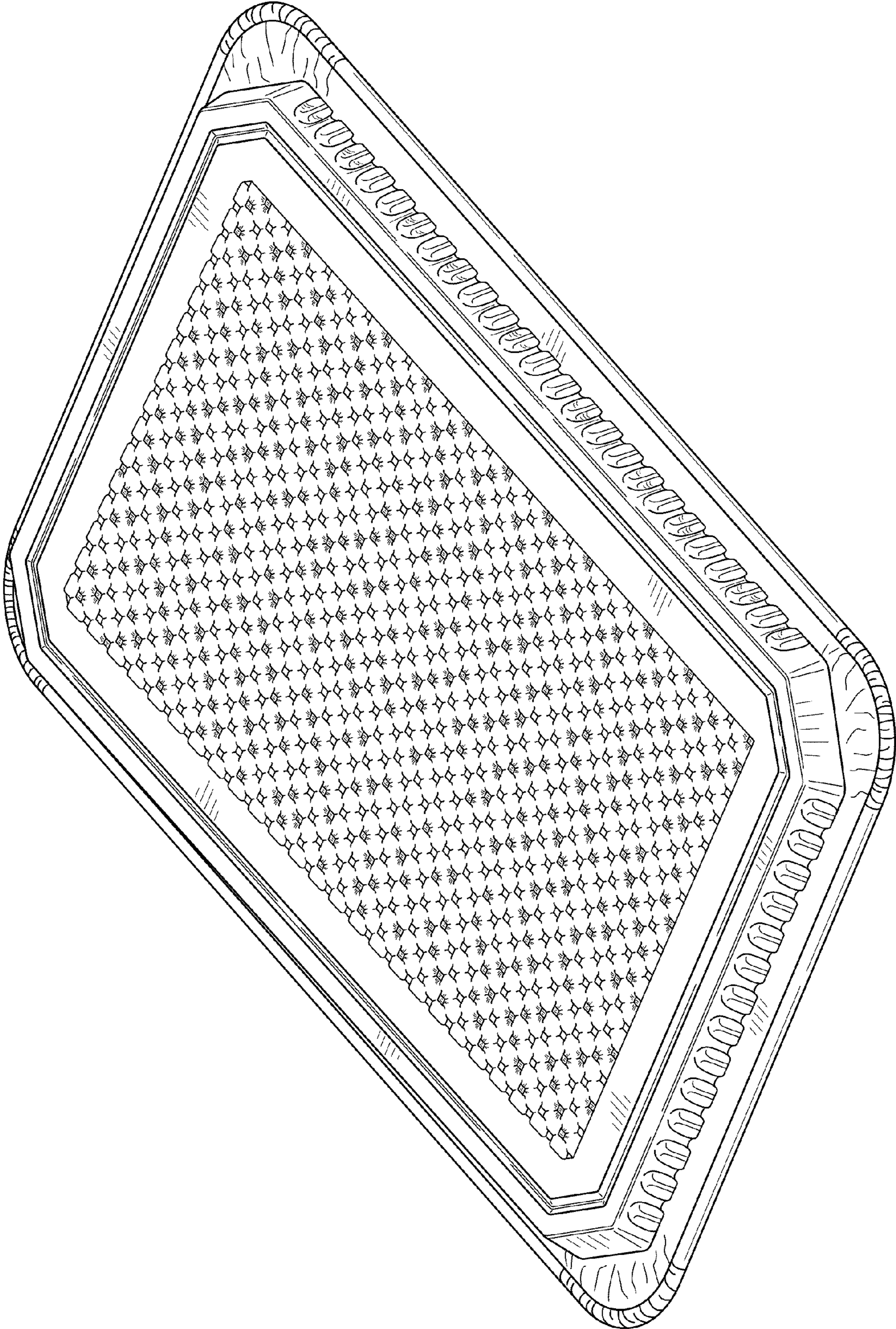

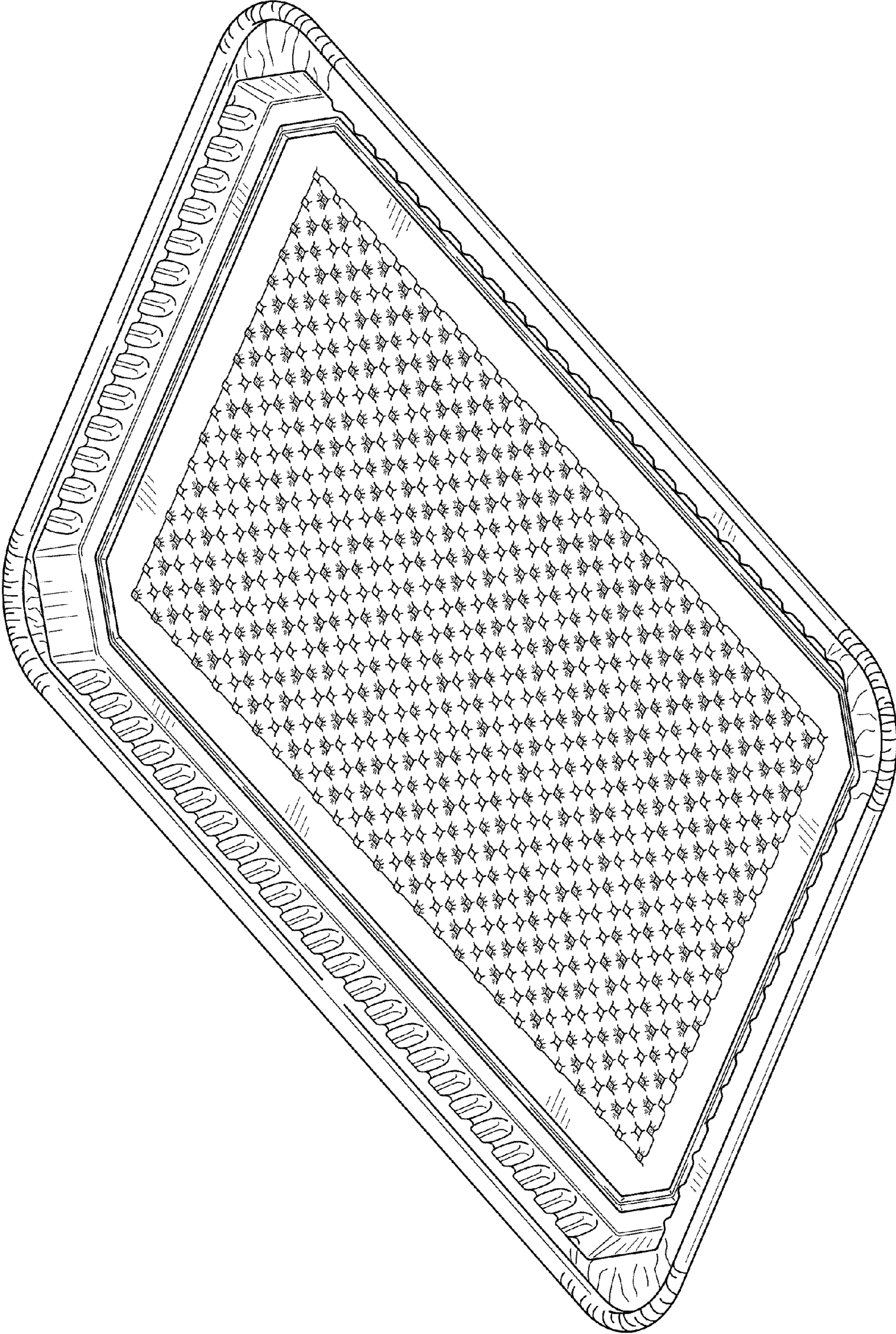
