The ornamental design for a drinking mug, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a drinking mug of the present invention;

FIG. 2 is front view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is back side view thereof;

FIG. 5 is a left side view thereof;

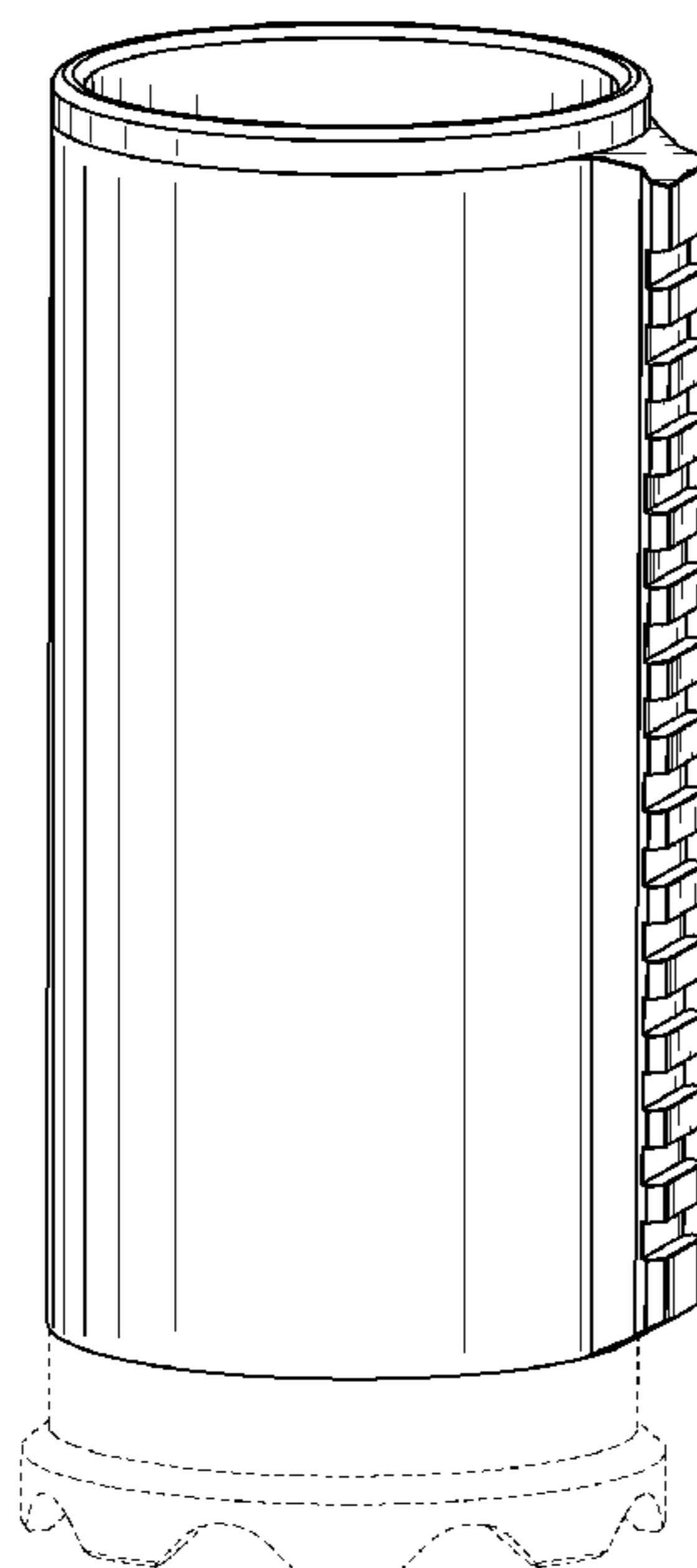
FIG. 6 is a top view thereof;

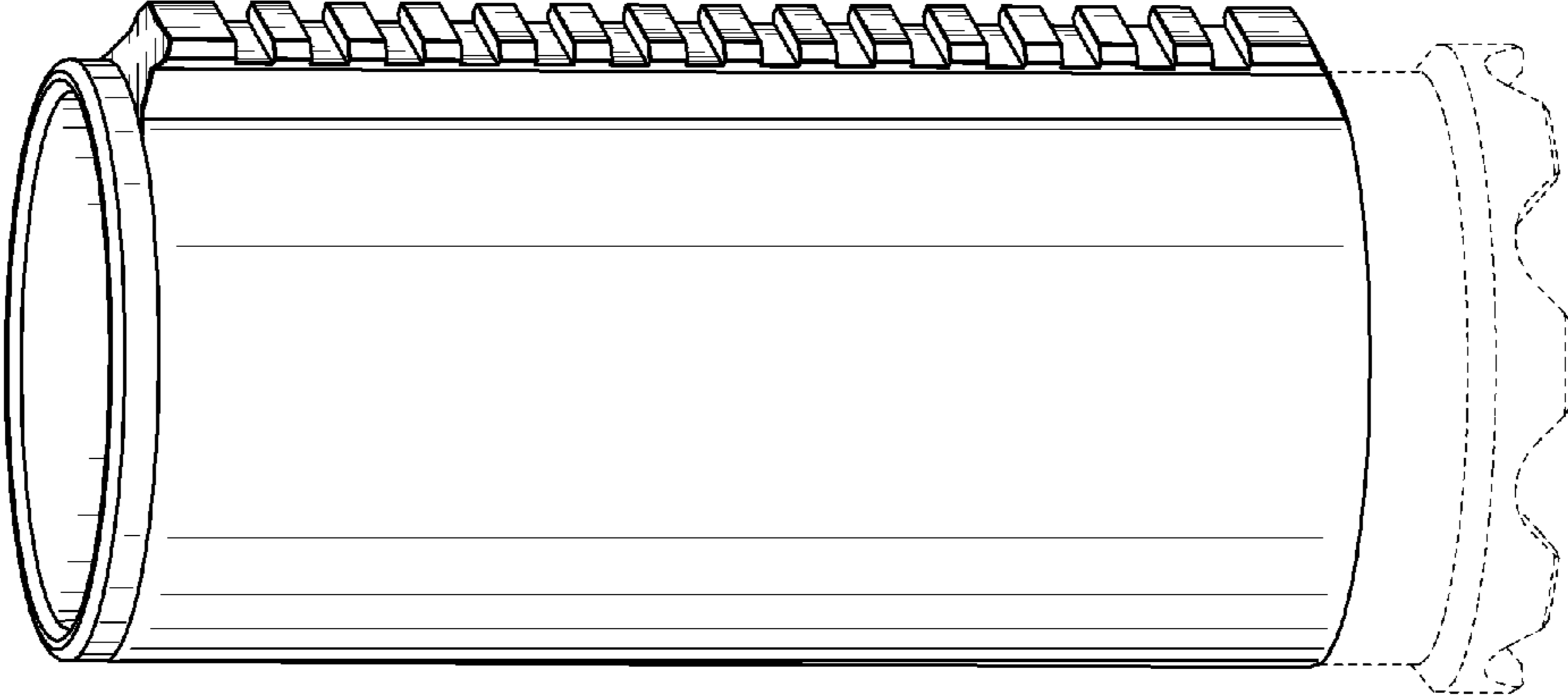

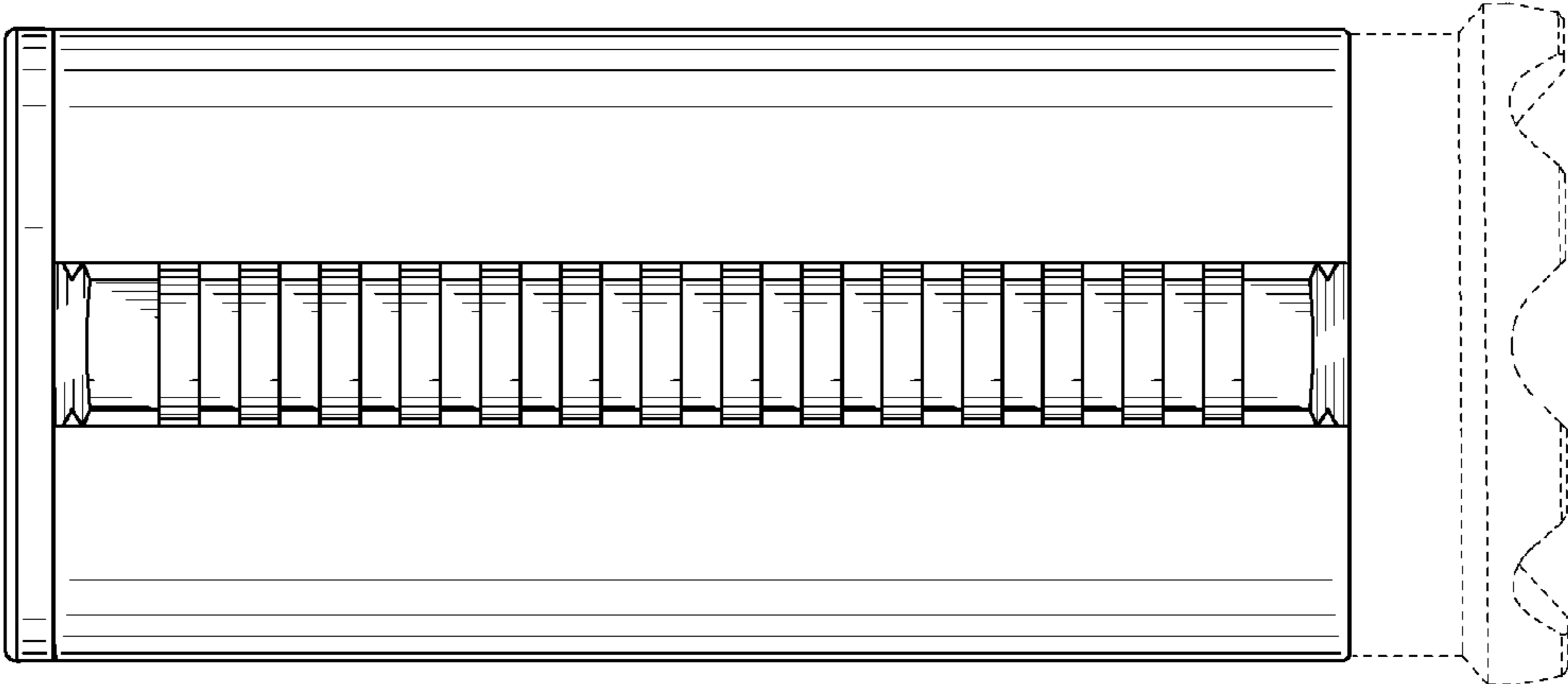

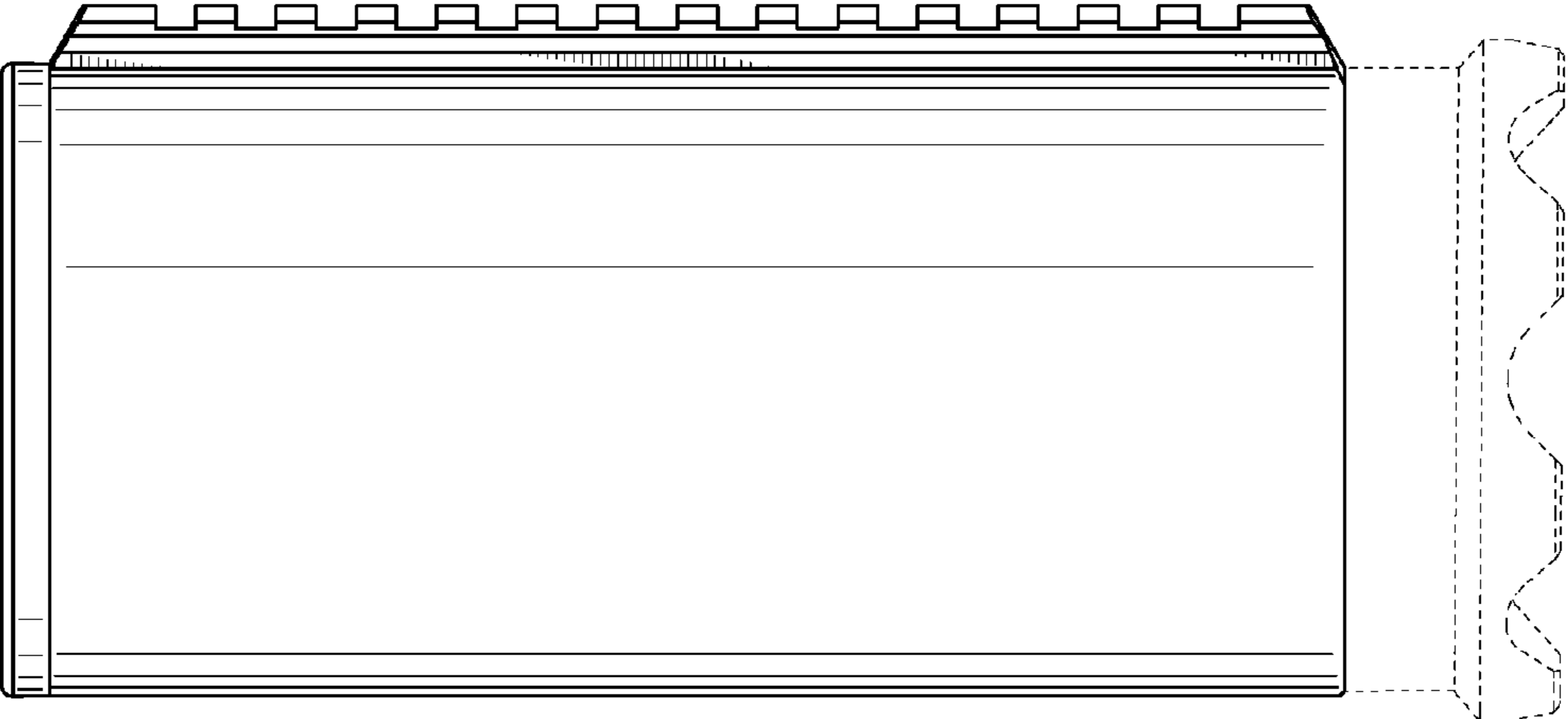

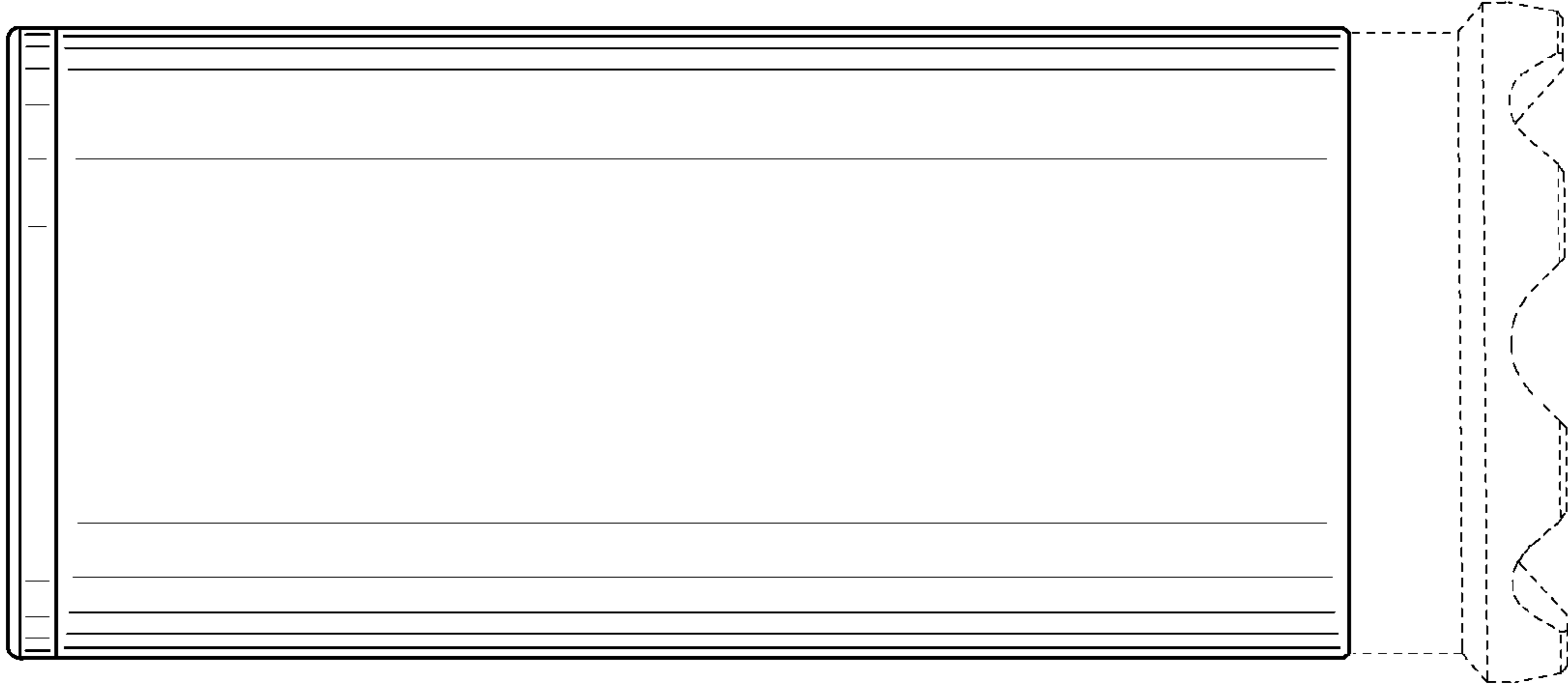

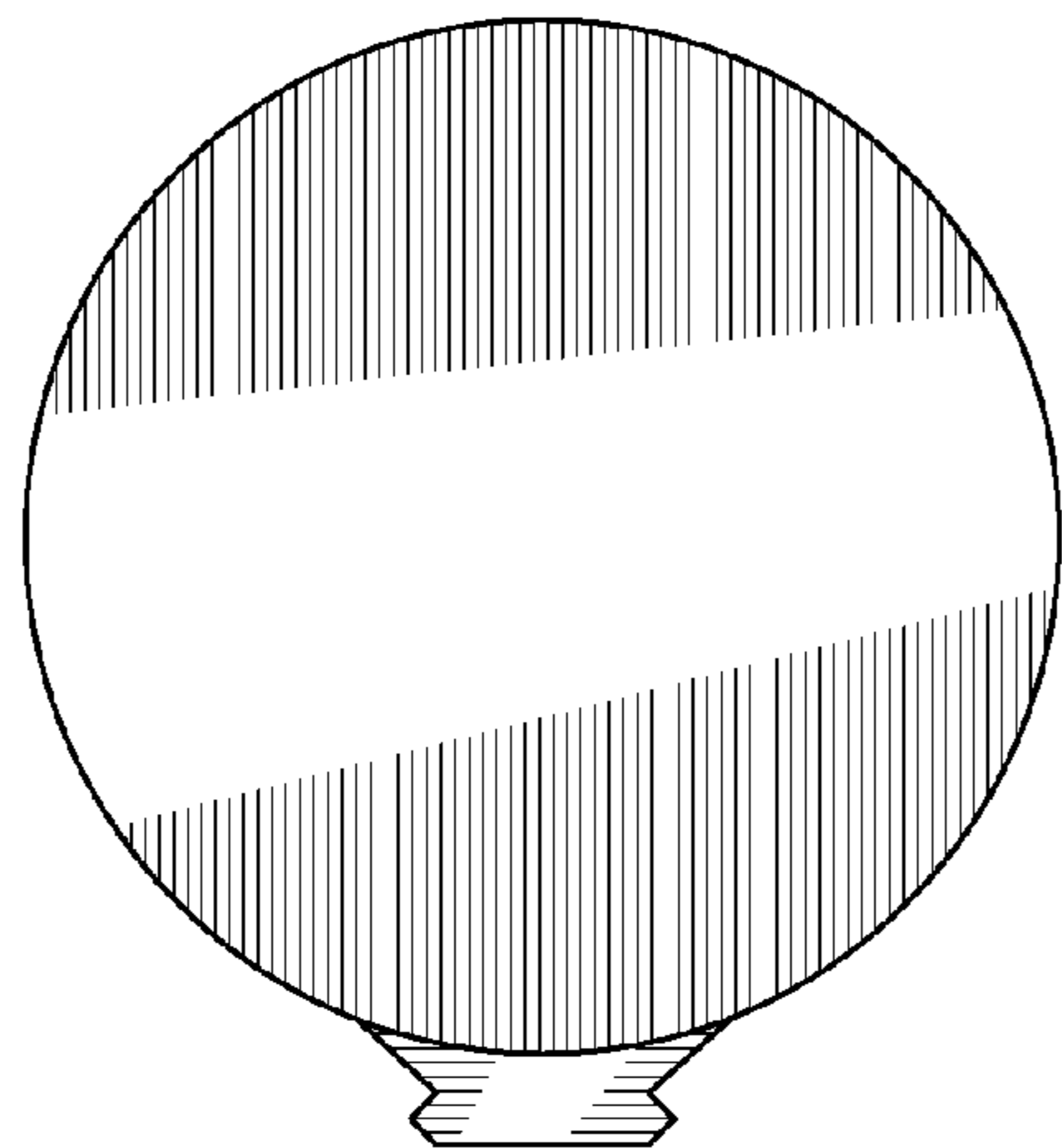

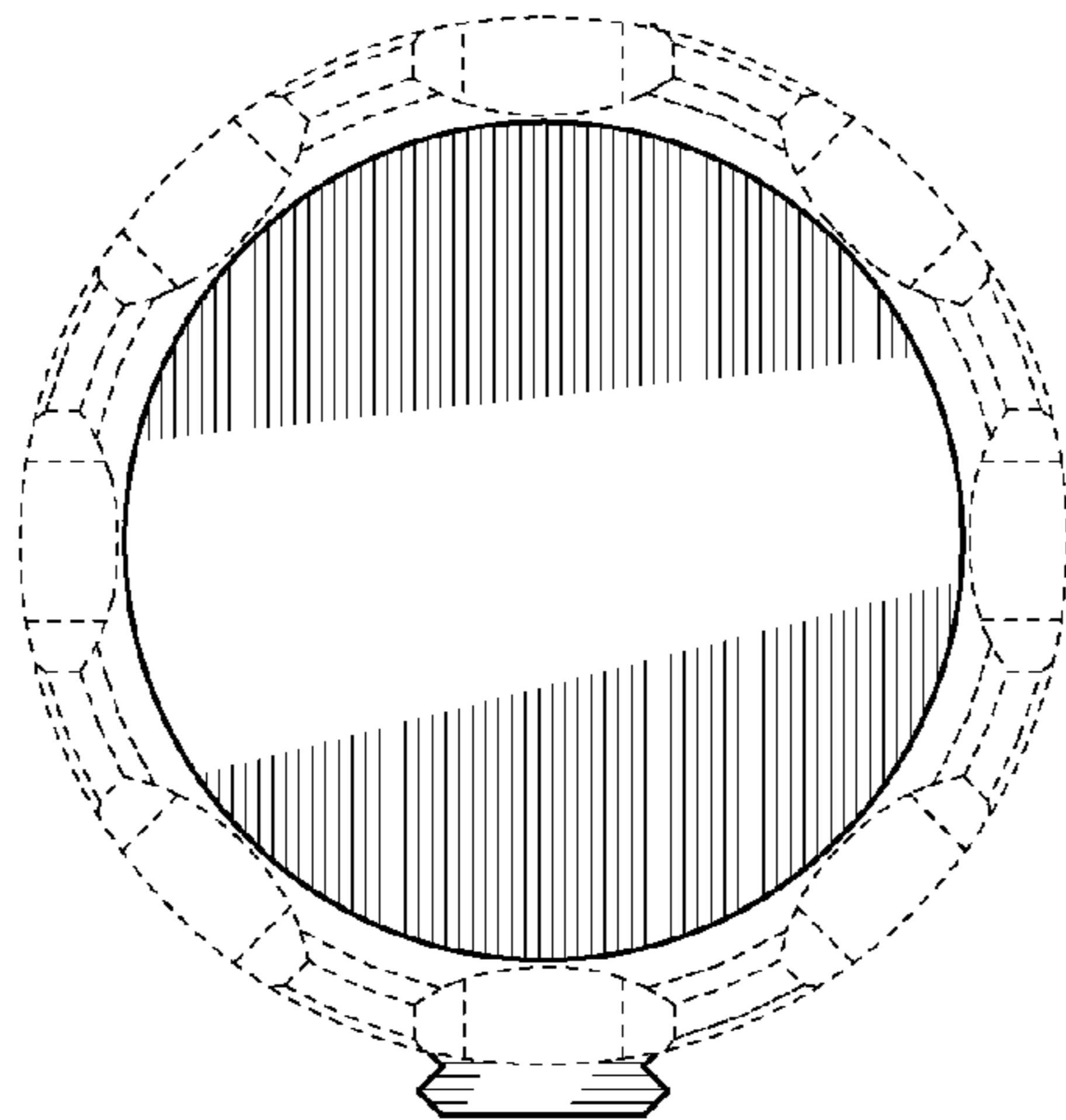

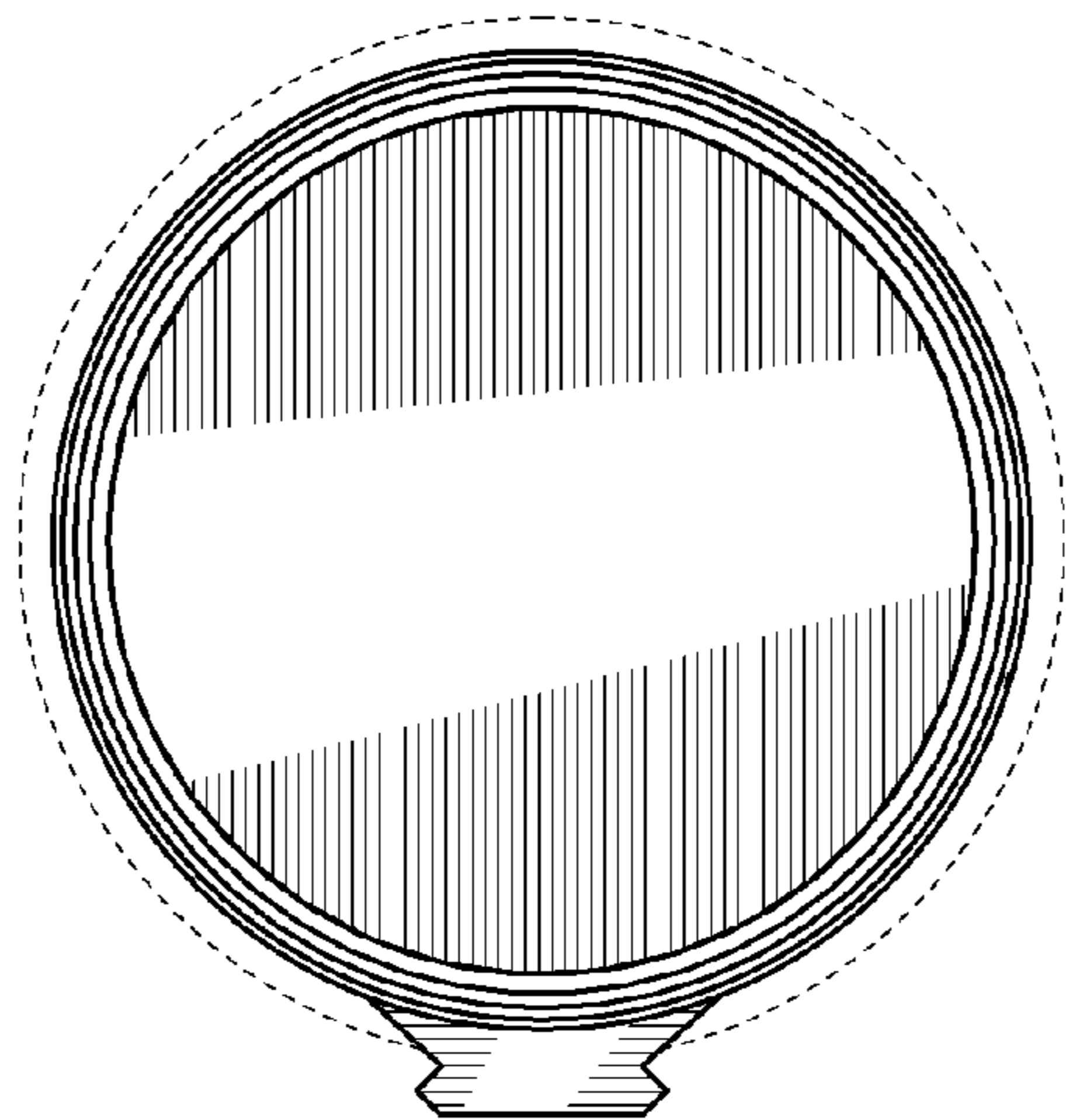
