DESCRIPTION

FIG. 1 is a perspective view of a protective cover for wires, showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

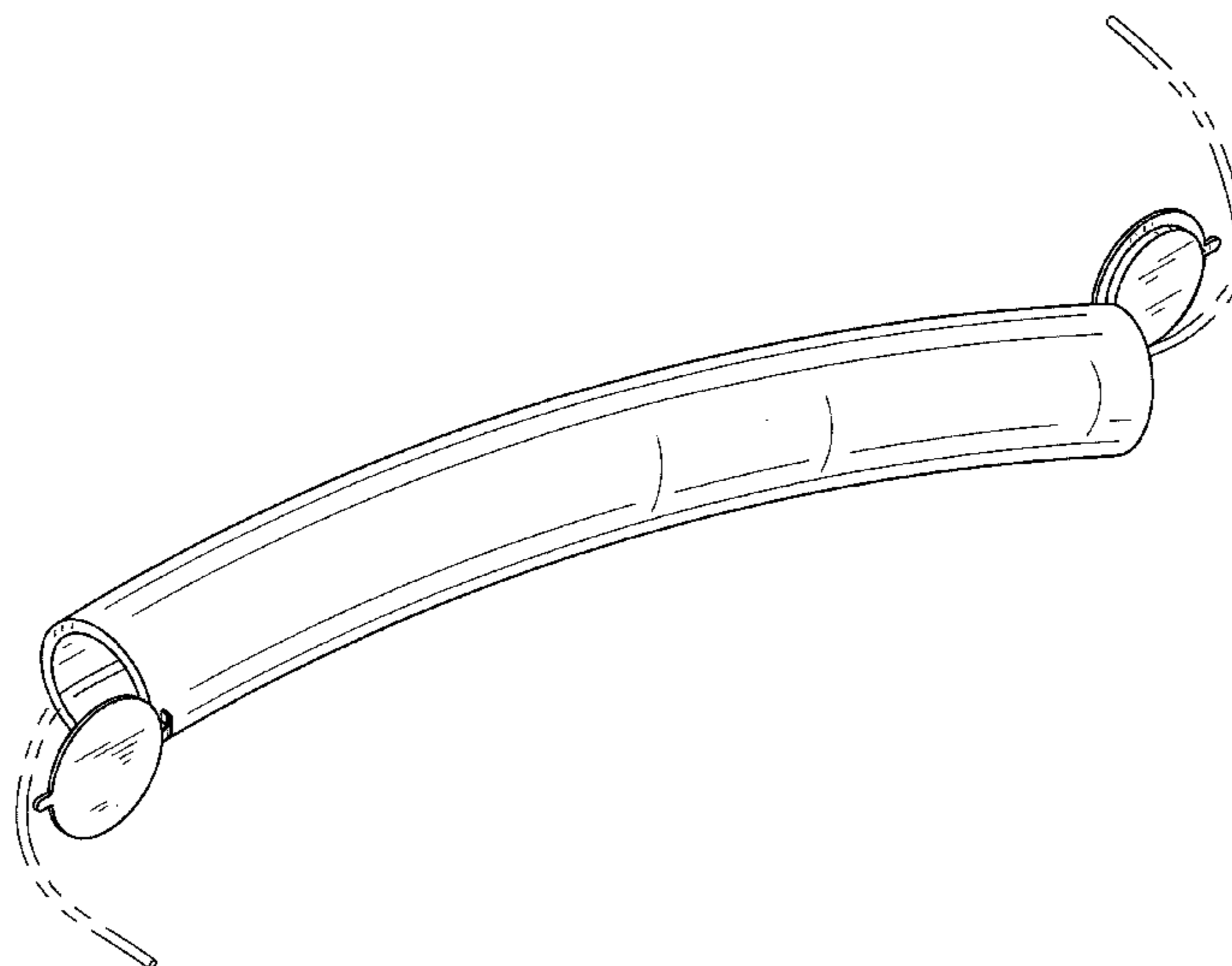
FIG. 4 is a top view thereof;

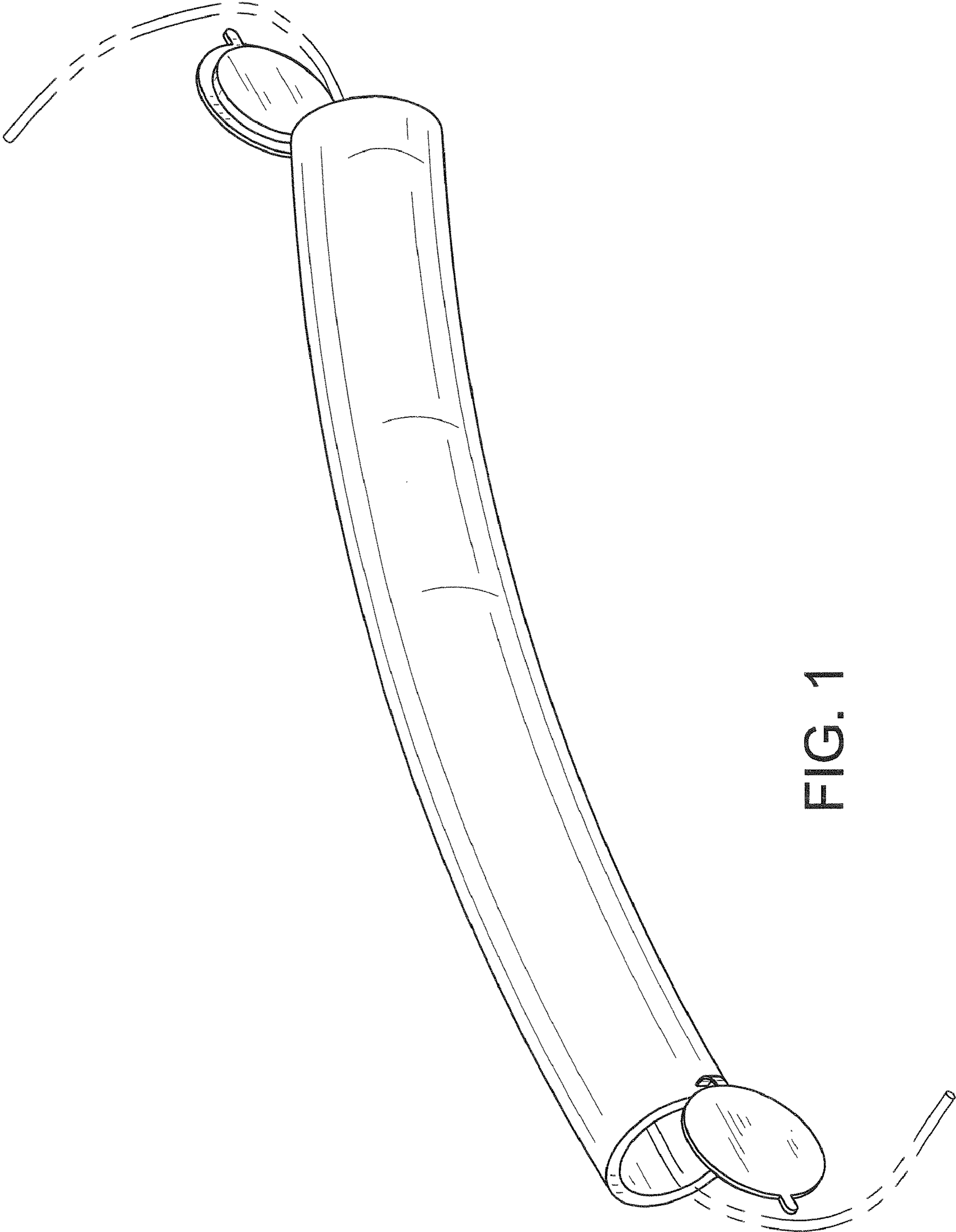

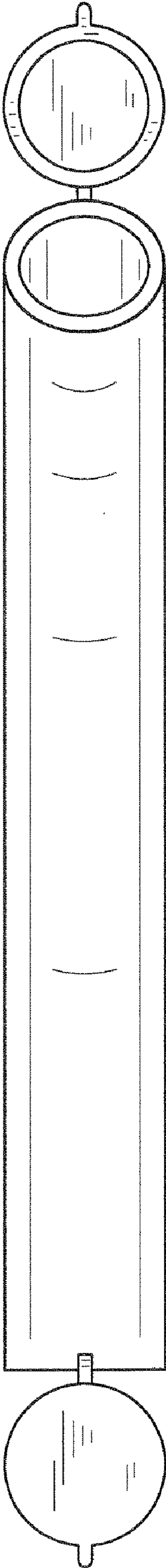

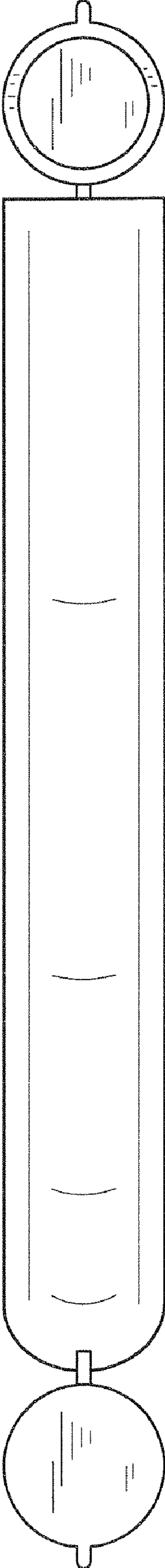

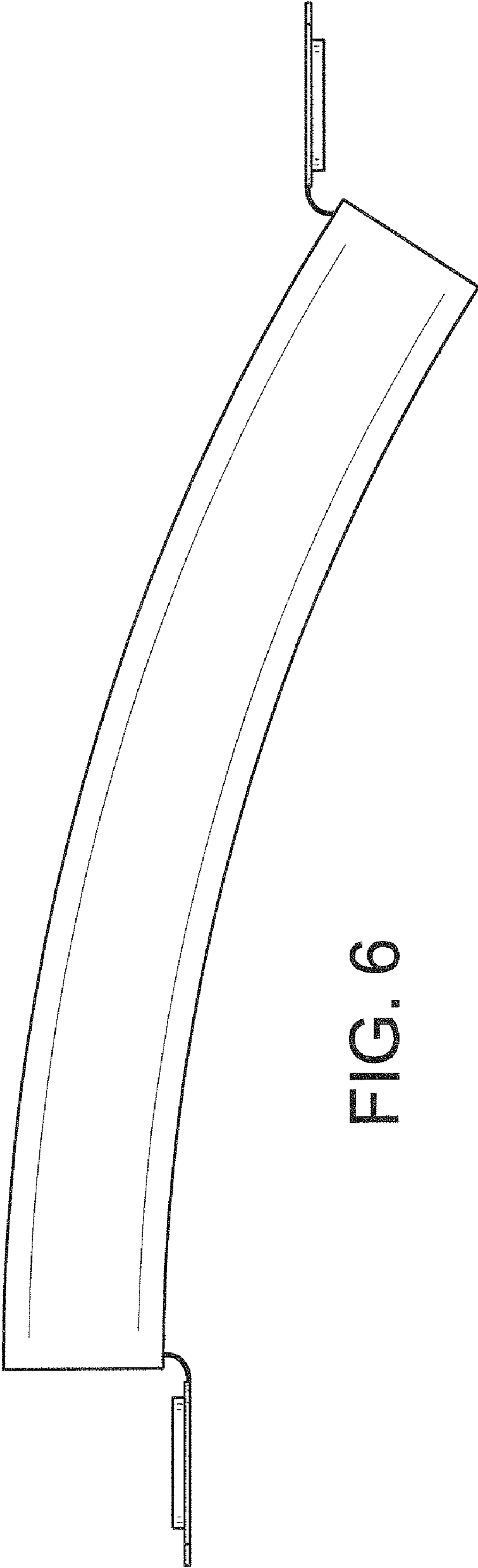
