The ornamental design for a container with complementary sawtooth features on lid and basket to facilitate opening, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a container with complementary sawtooth features on lid and basket to facilitate opening showing our new design;

FIG. 3 is a front elevation view thereof;

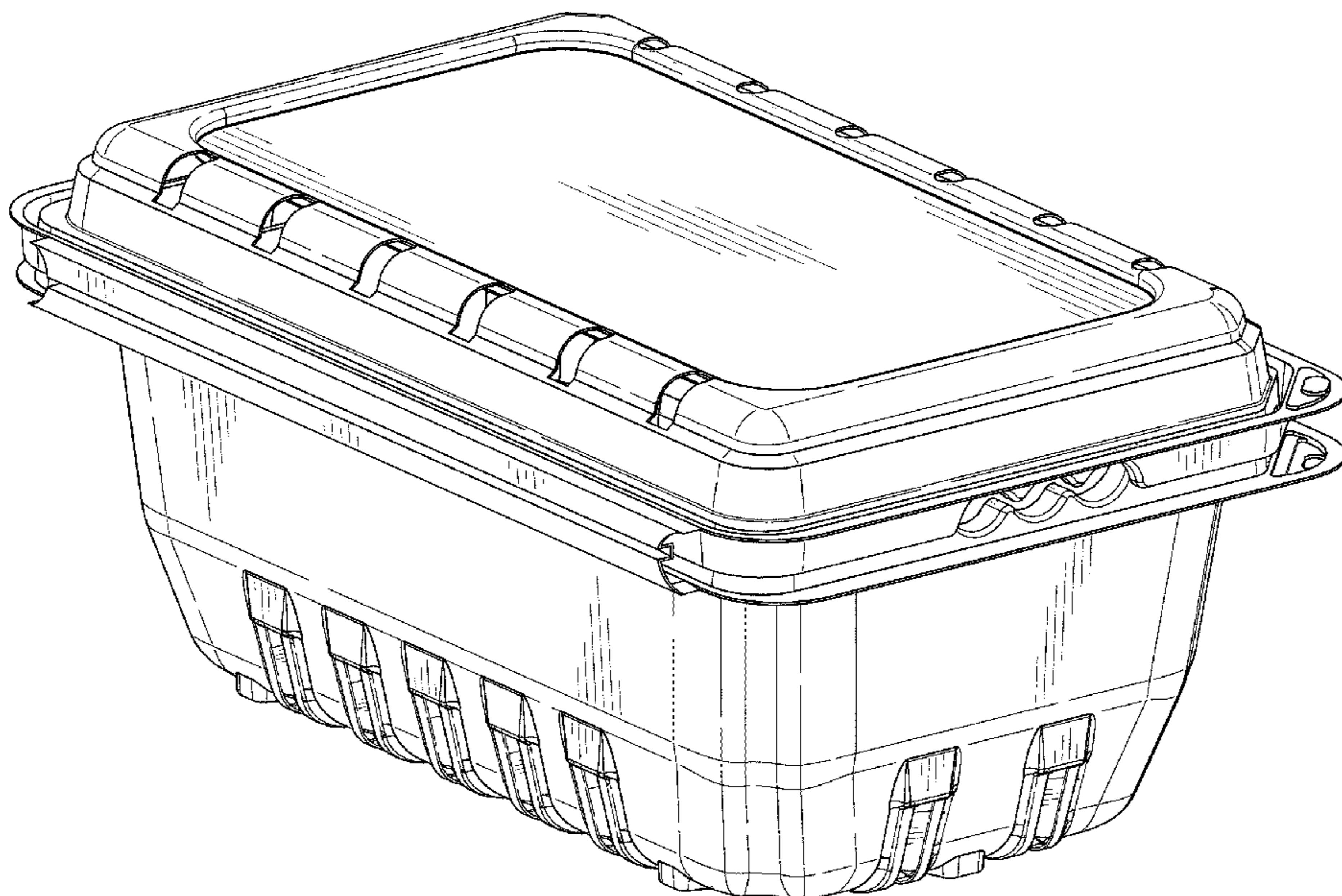
FIG. 4 is a bottom plan view thereof;

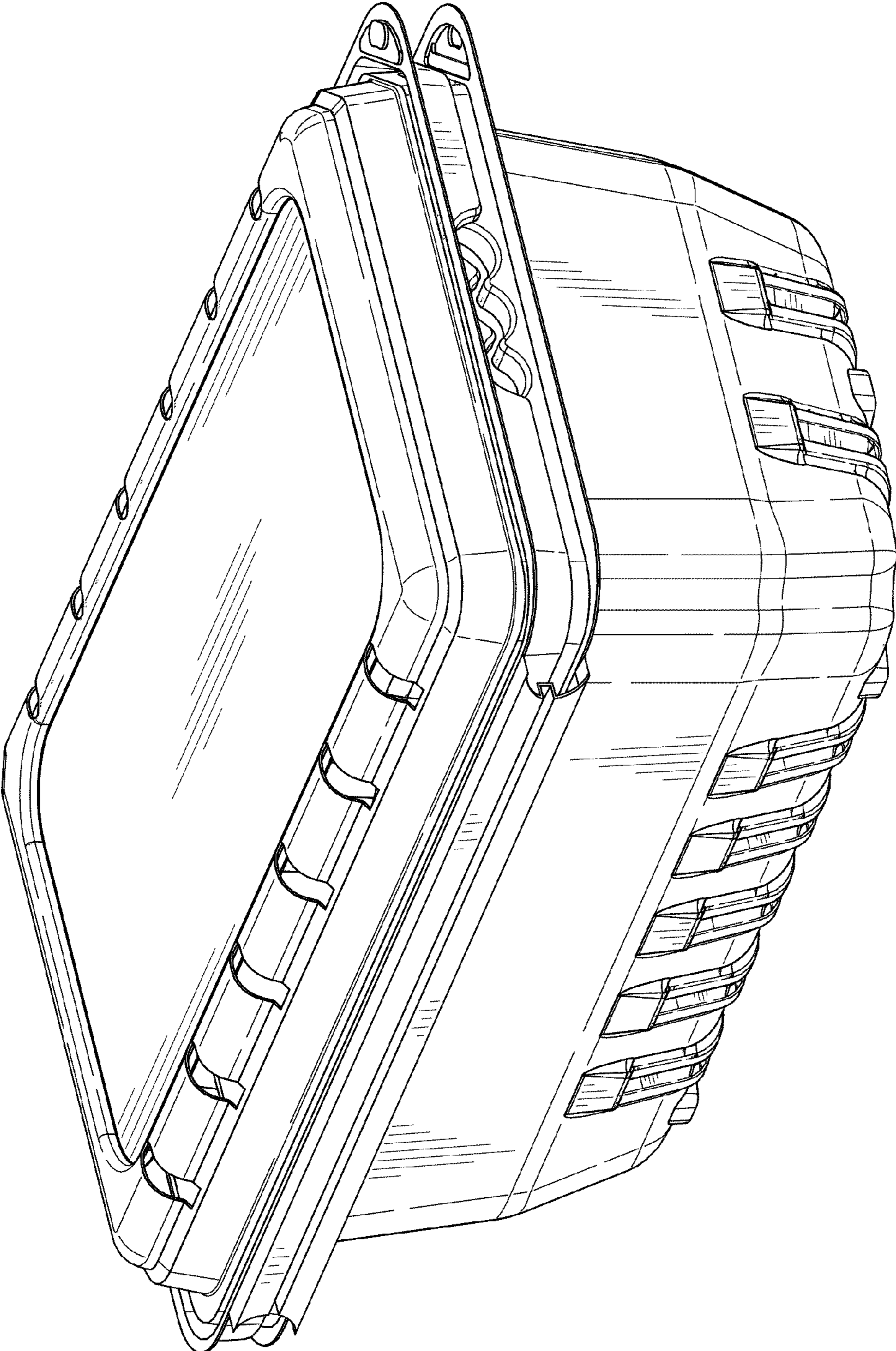

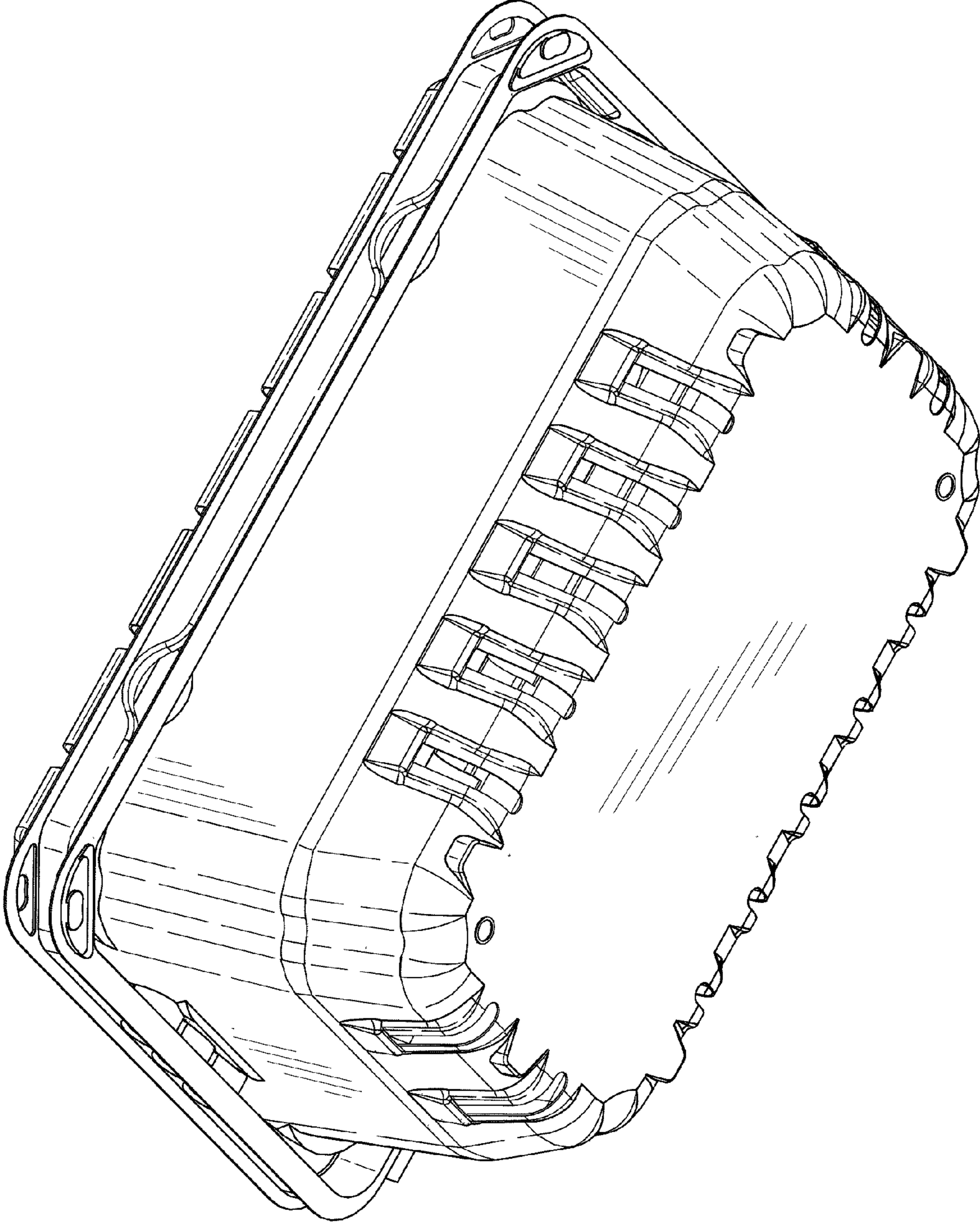

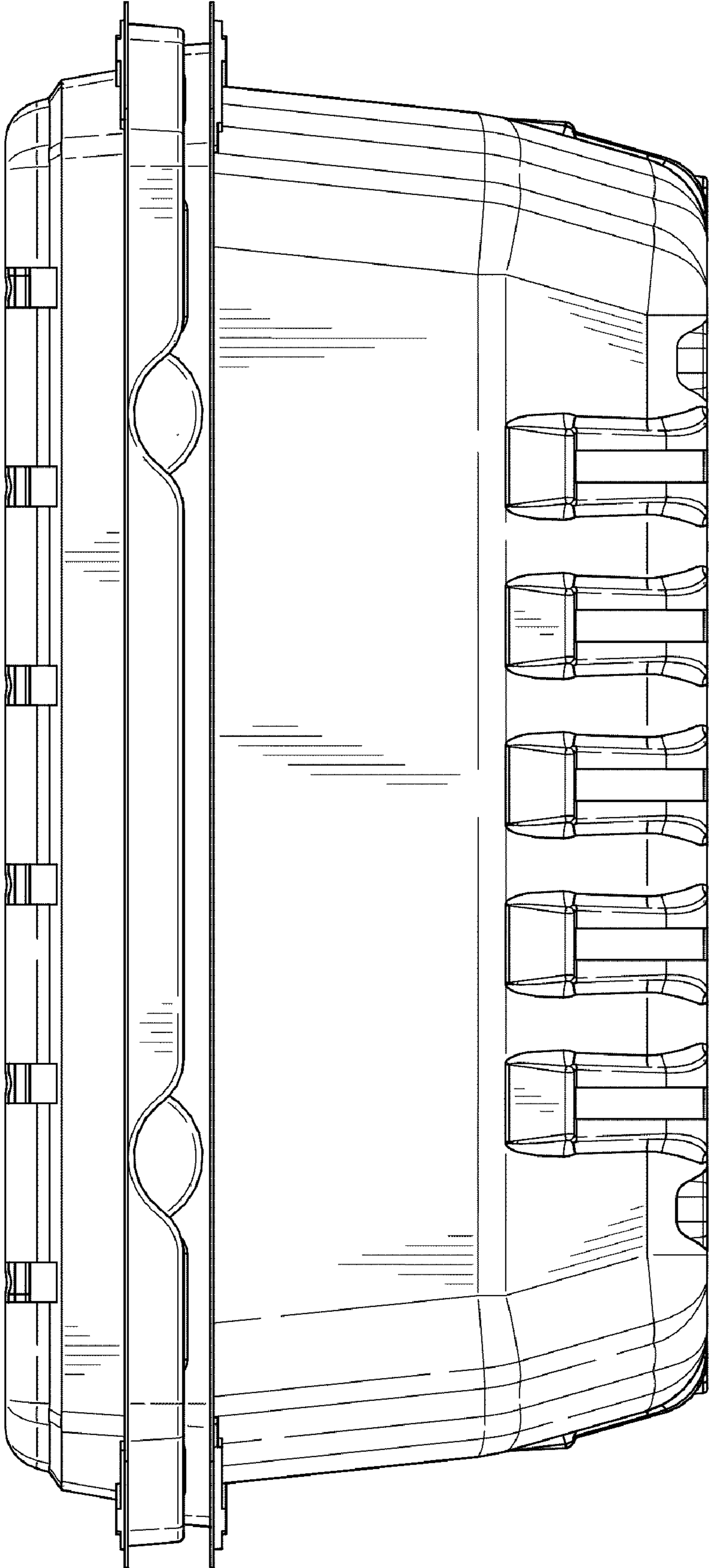

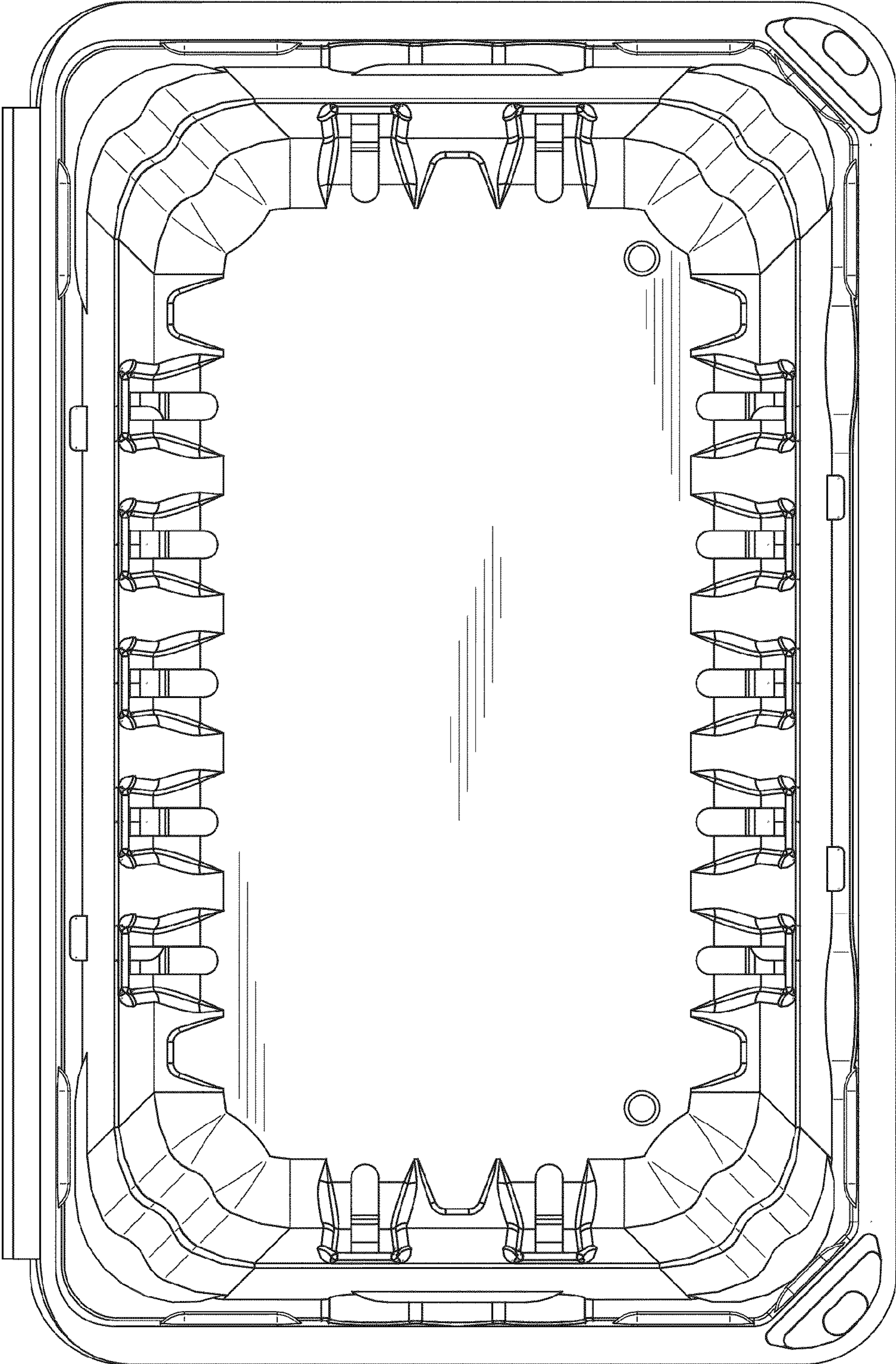

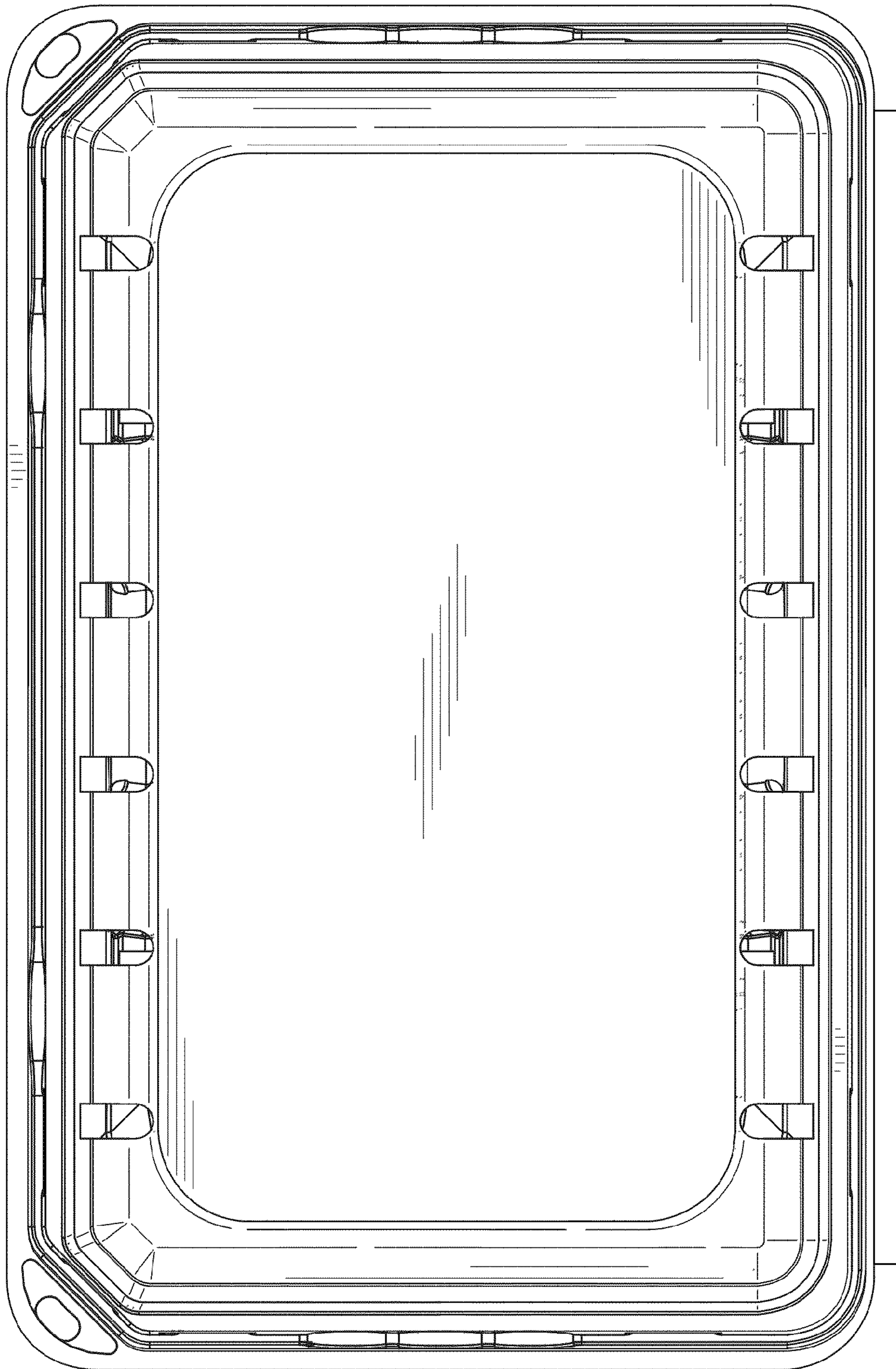

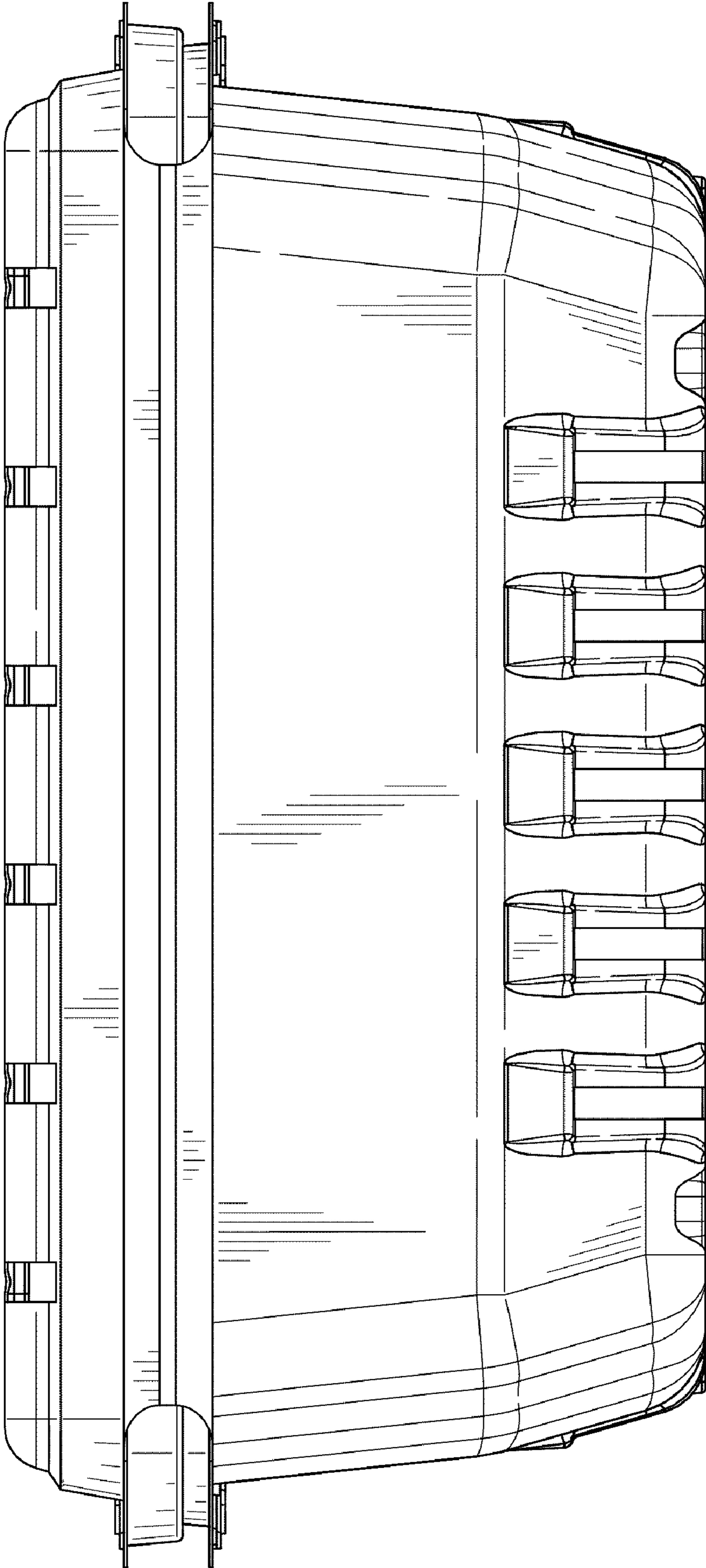

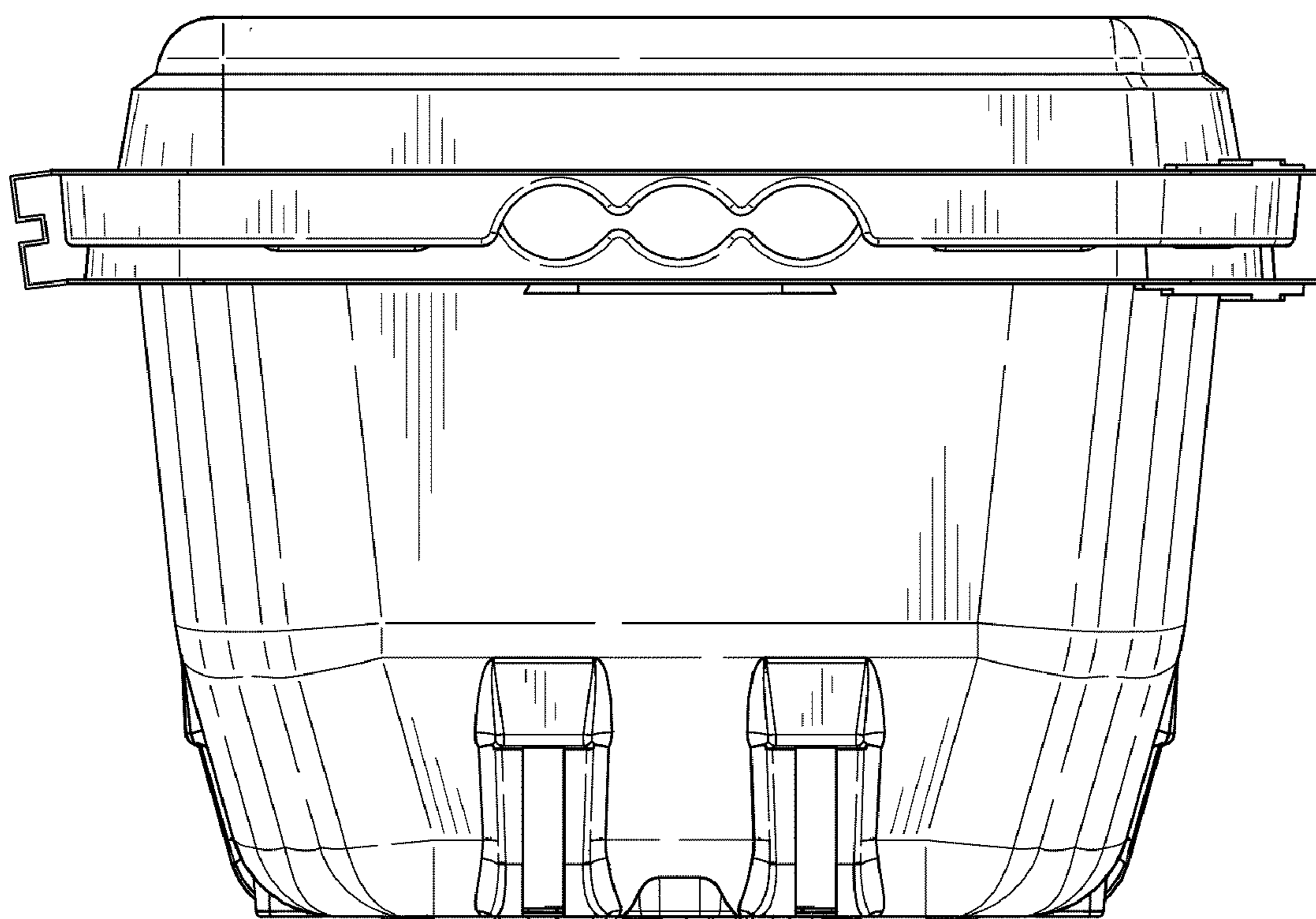
