FIG. 3 is a front view of the invention;

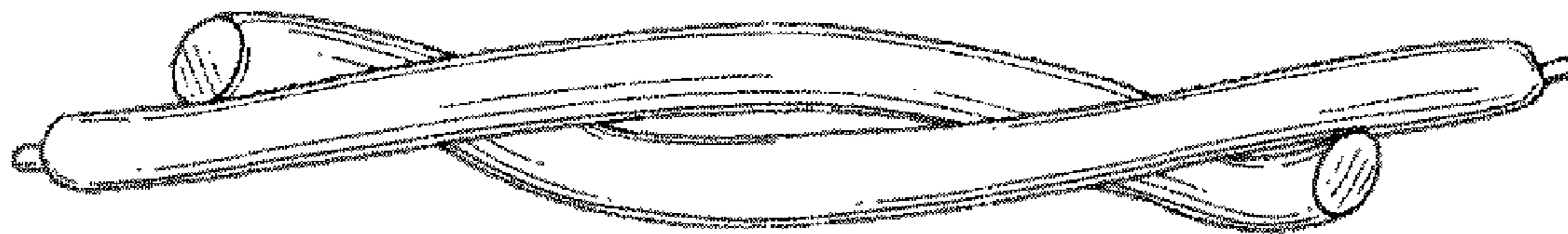
FIG. 4 is a back view of the invention;

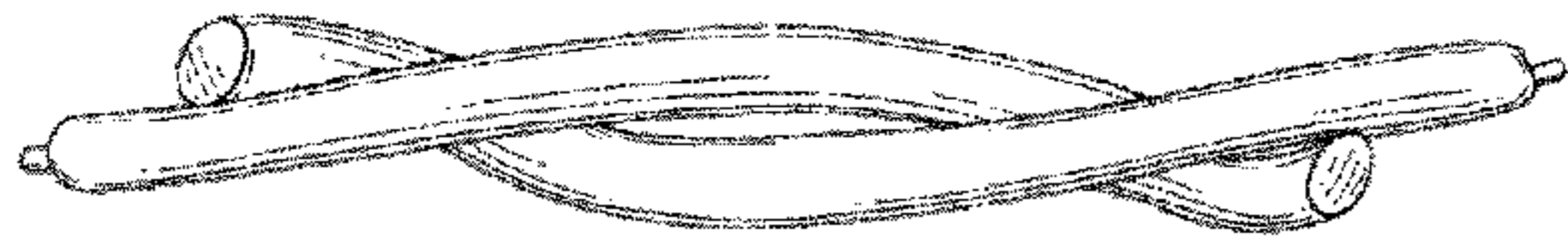

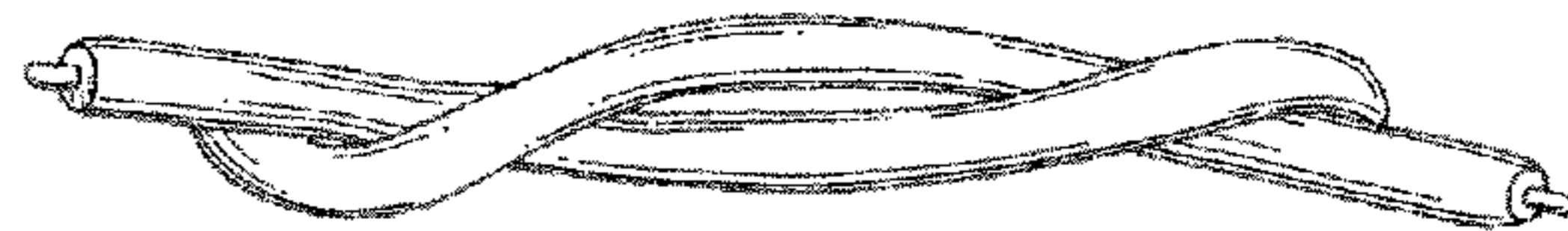

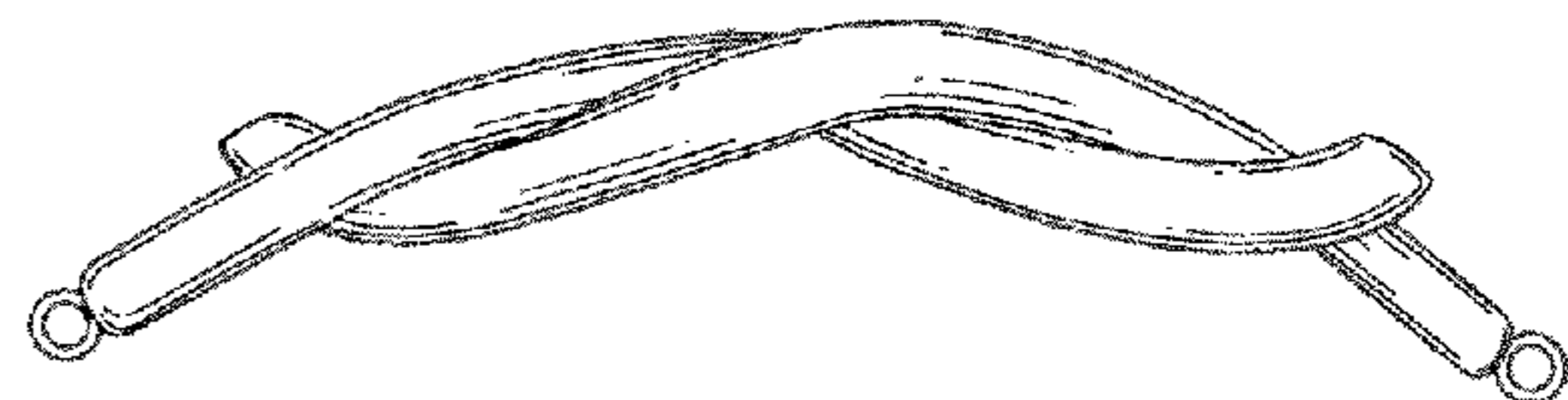

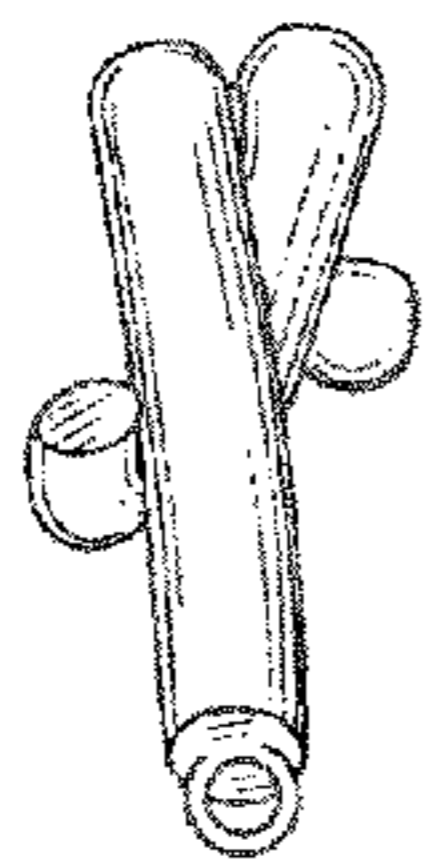

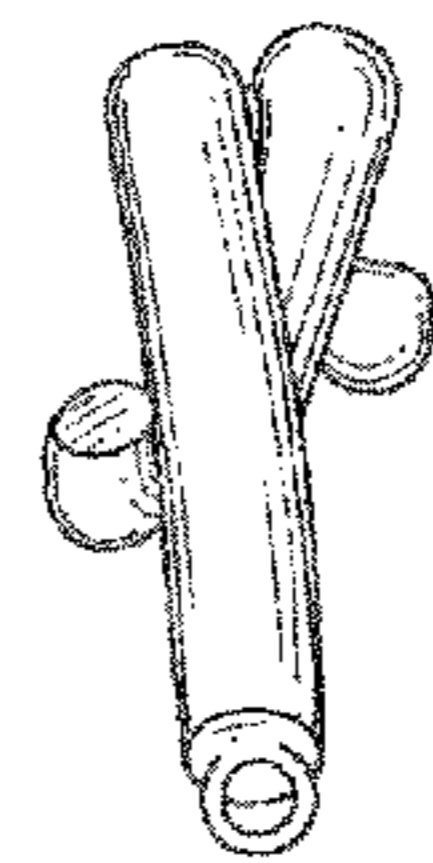

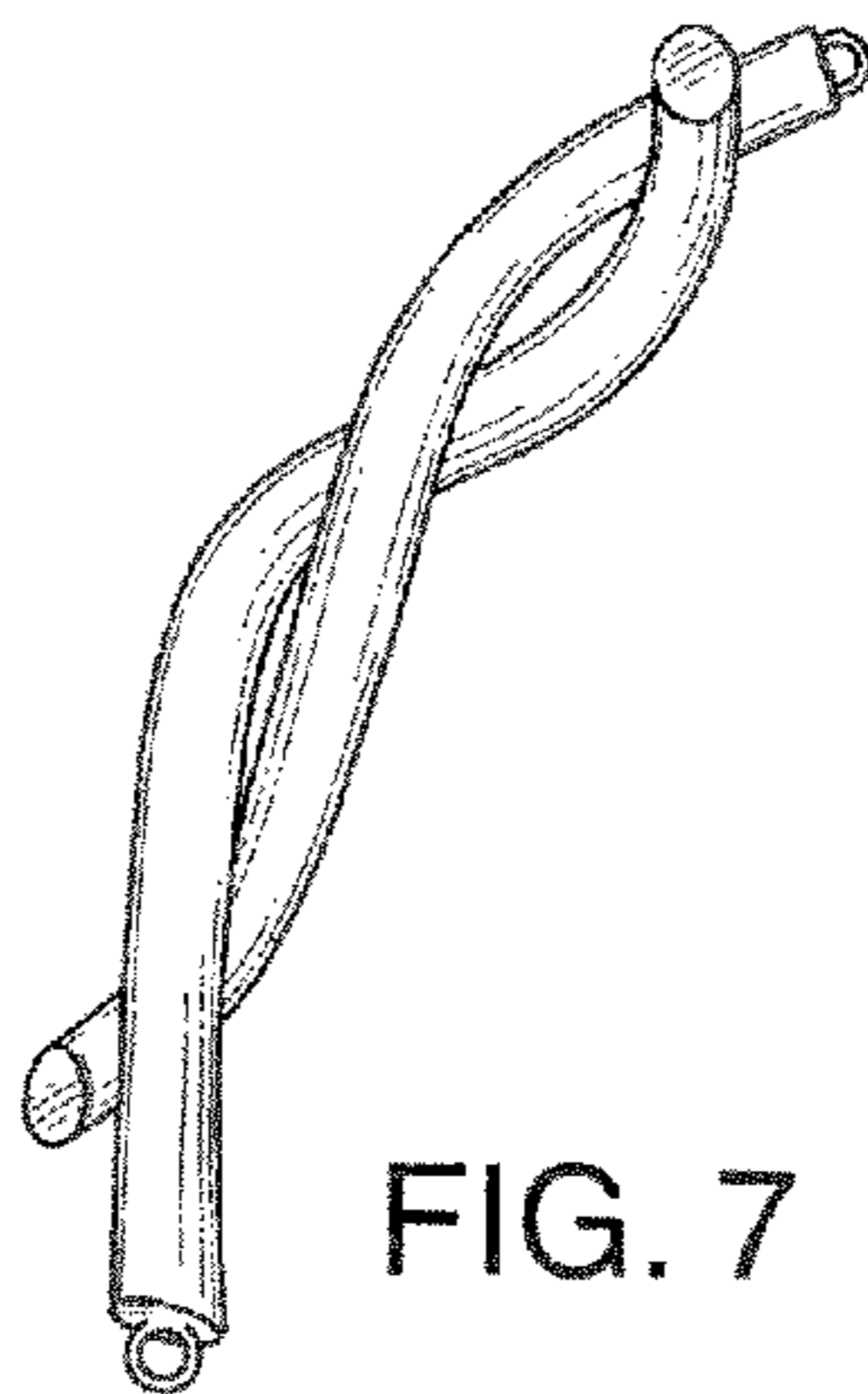
