FIG. 10 is a rear view thereof;

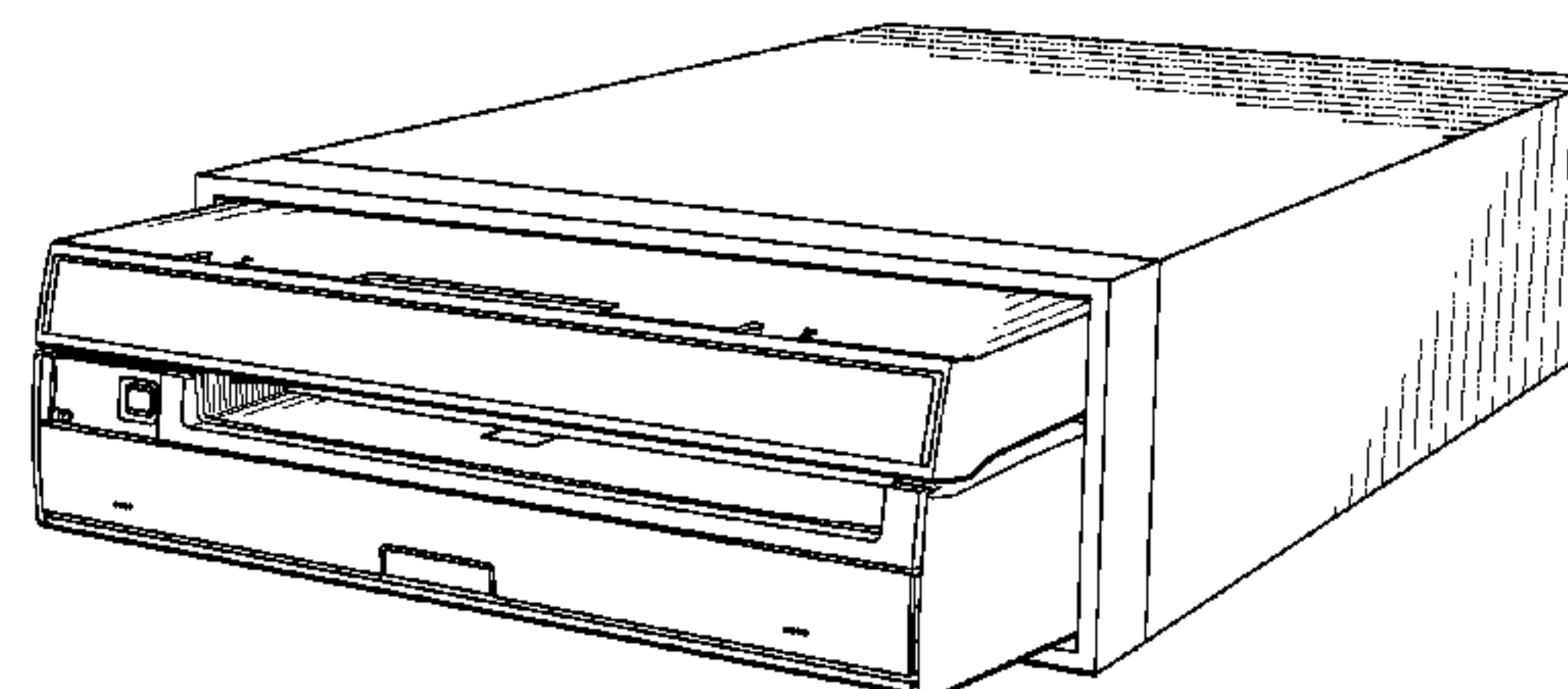
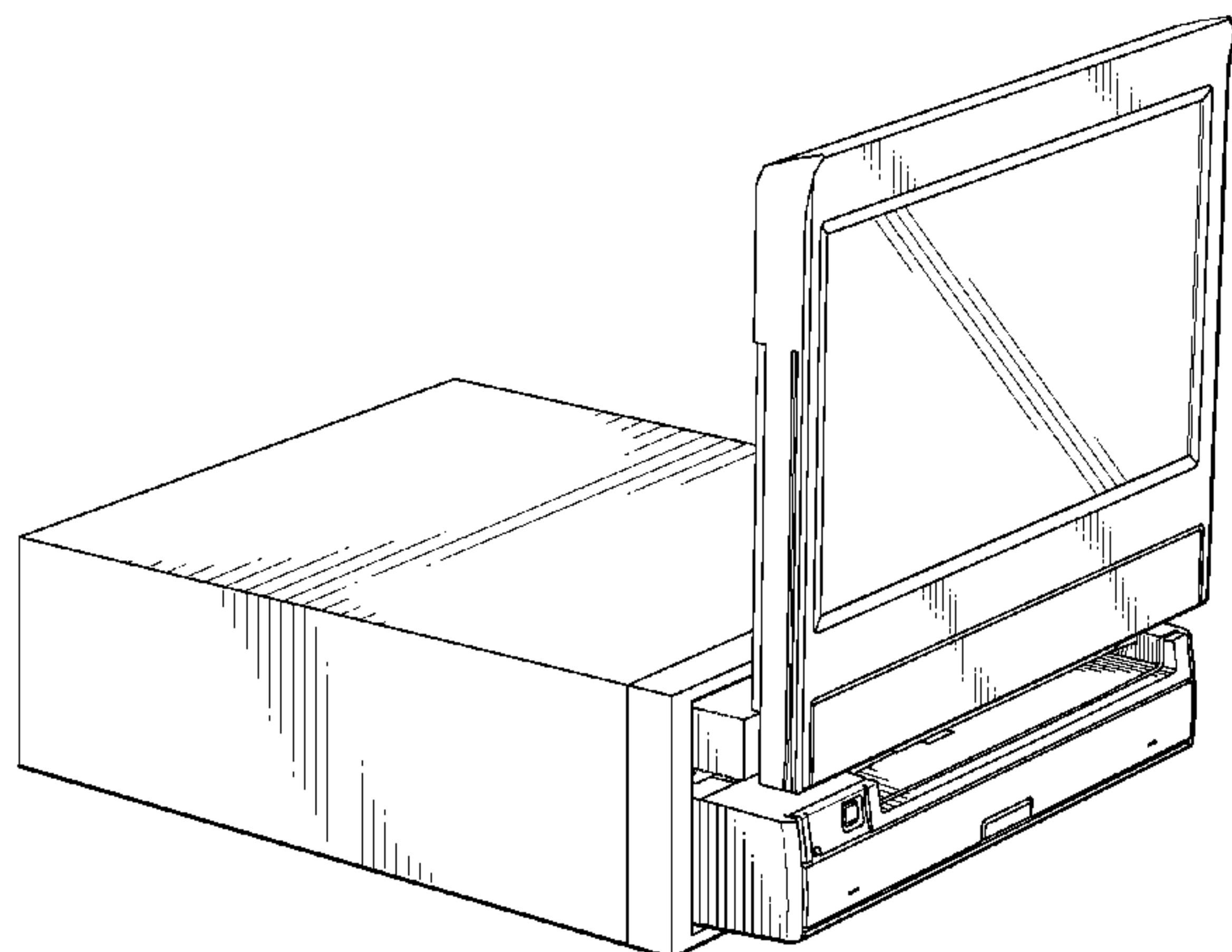
FIG. 11 is a side view thereof, the opposite side view being a mirror image;

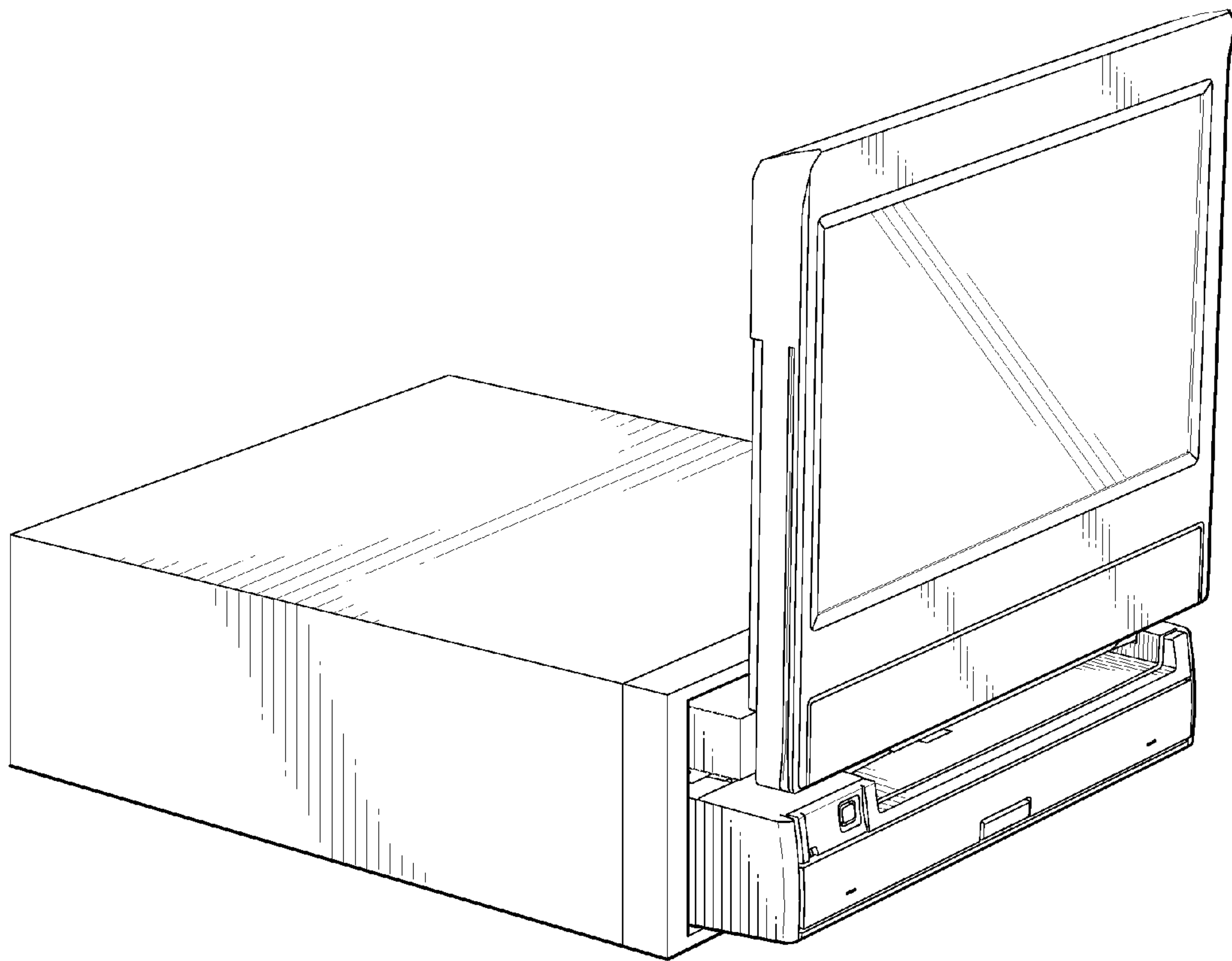

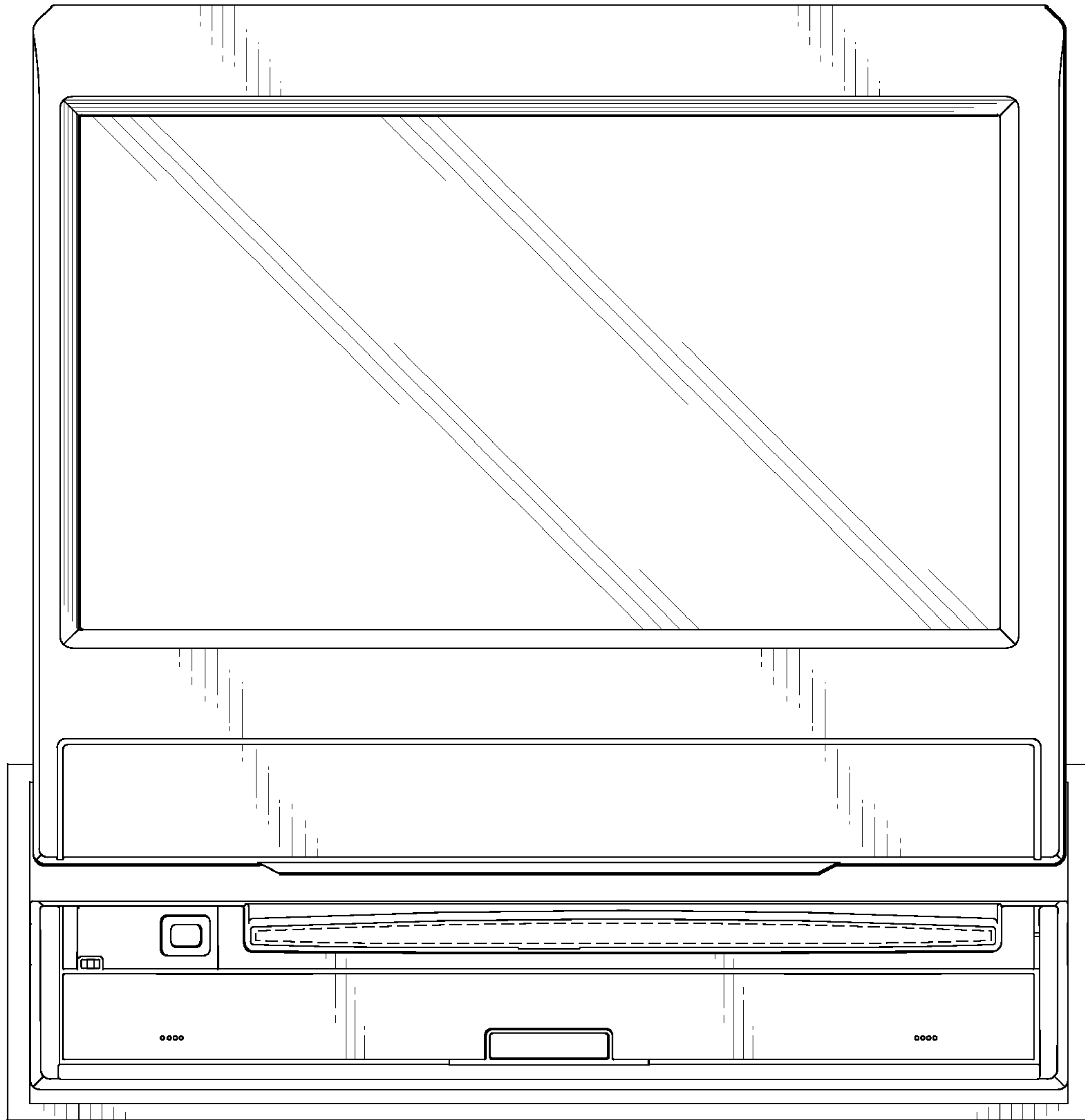

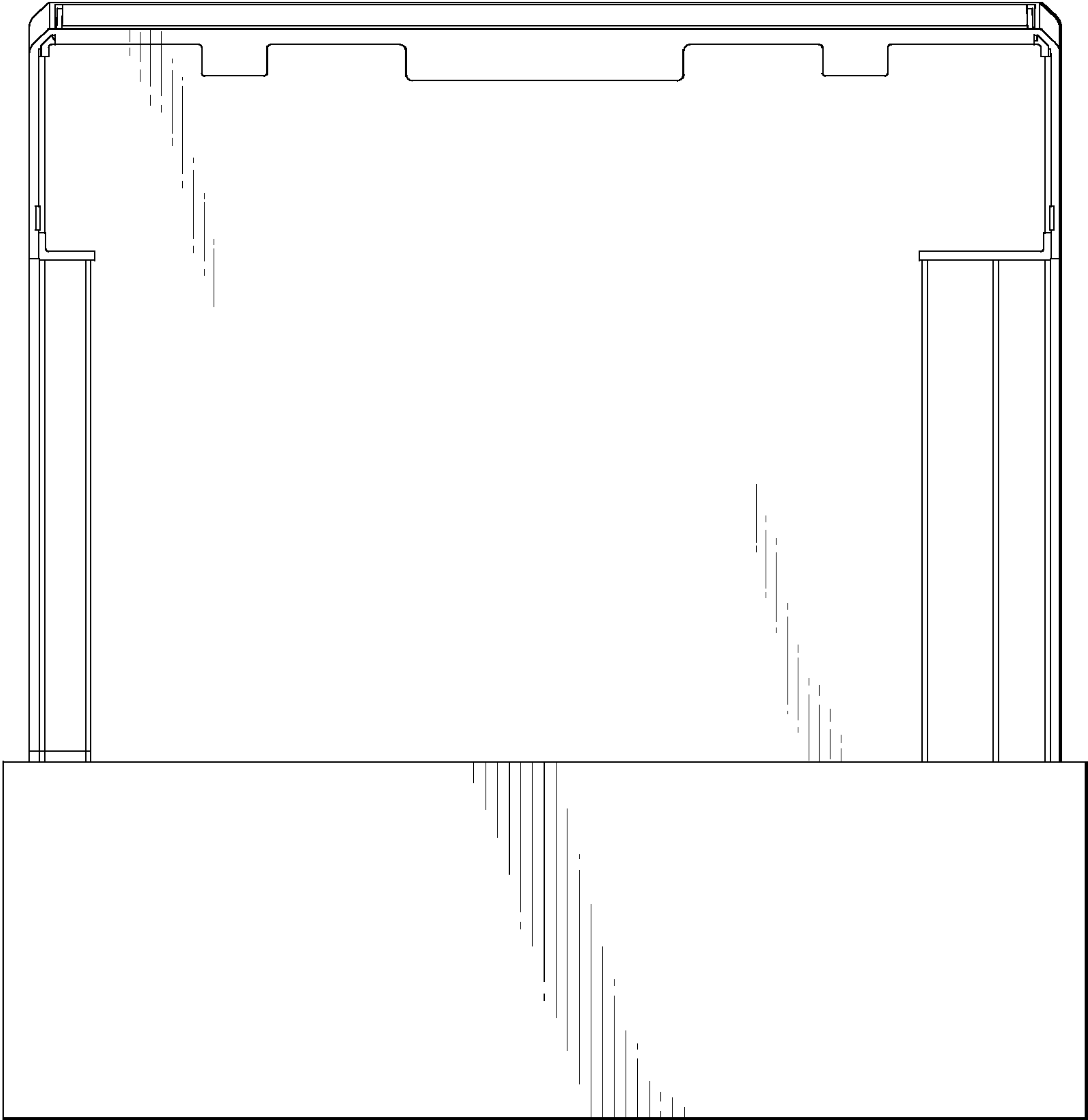

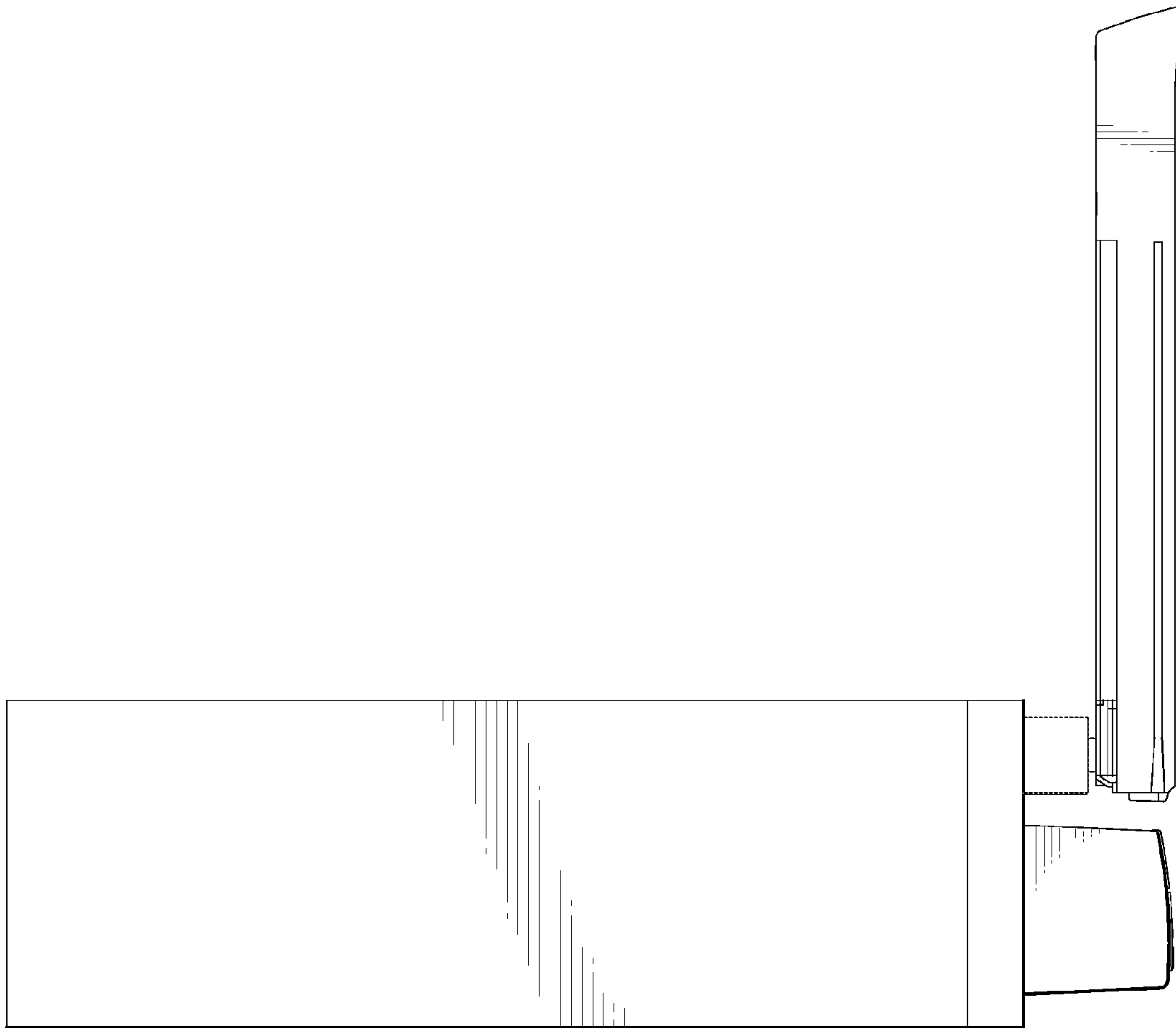

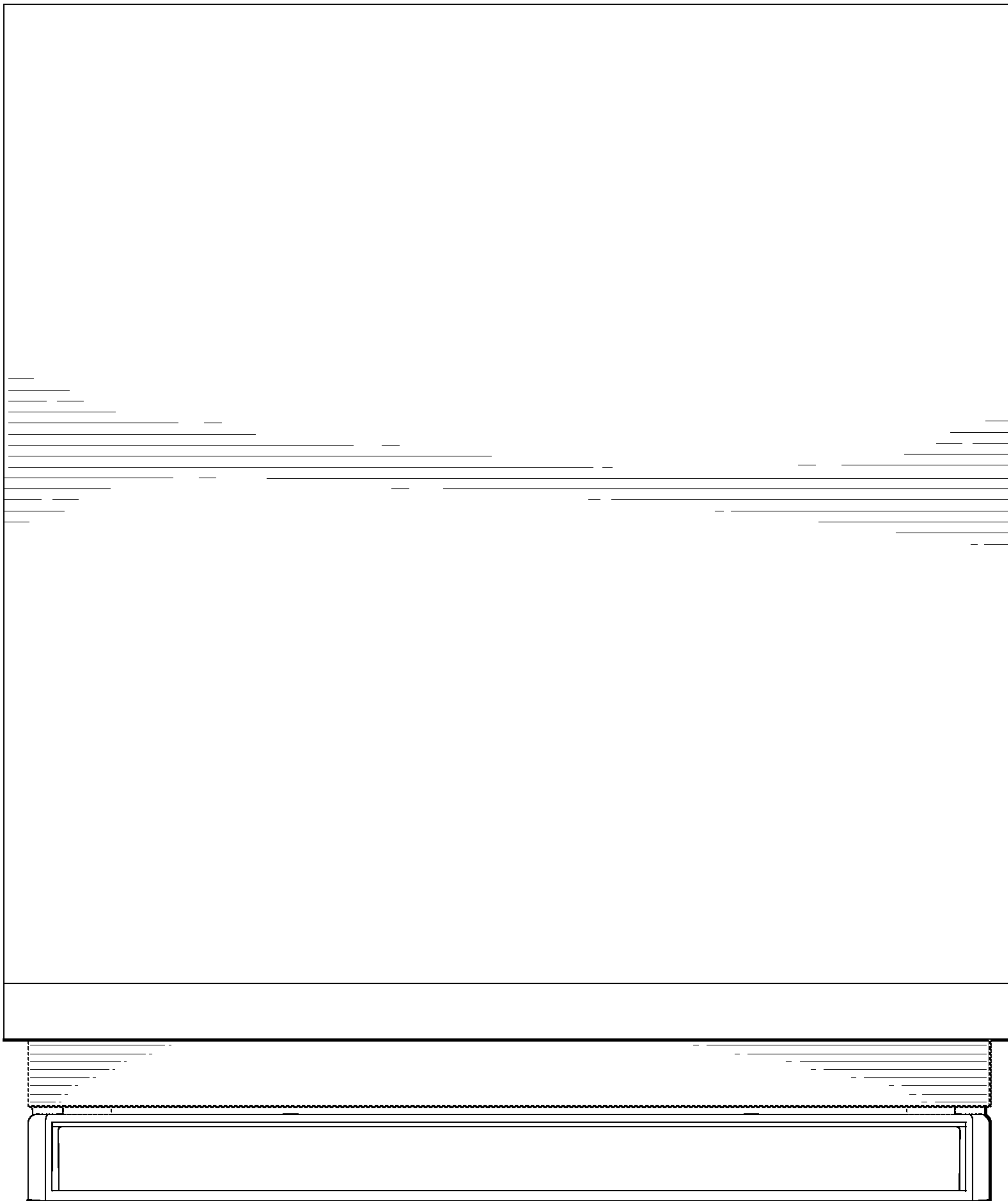

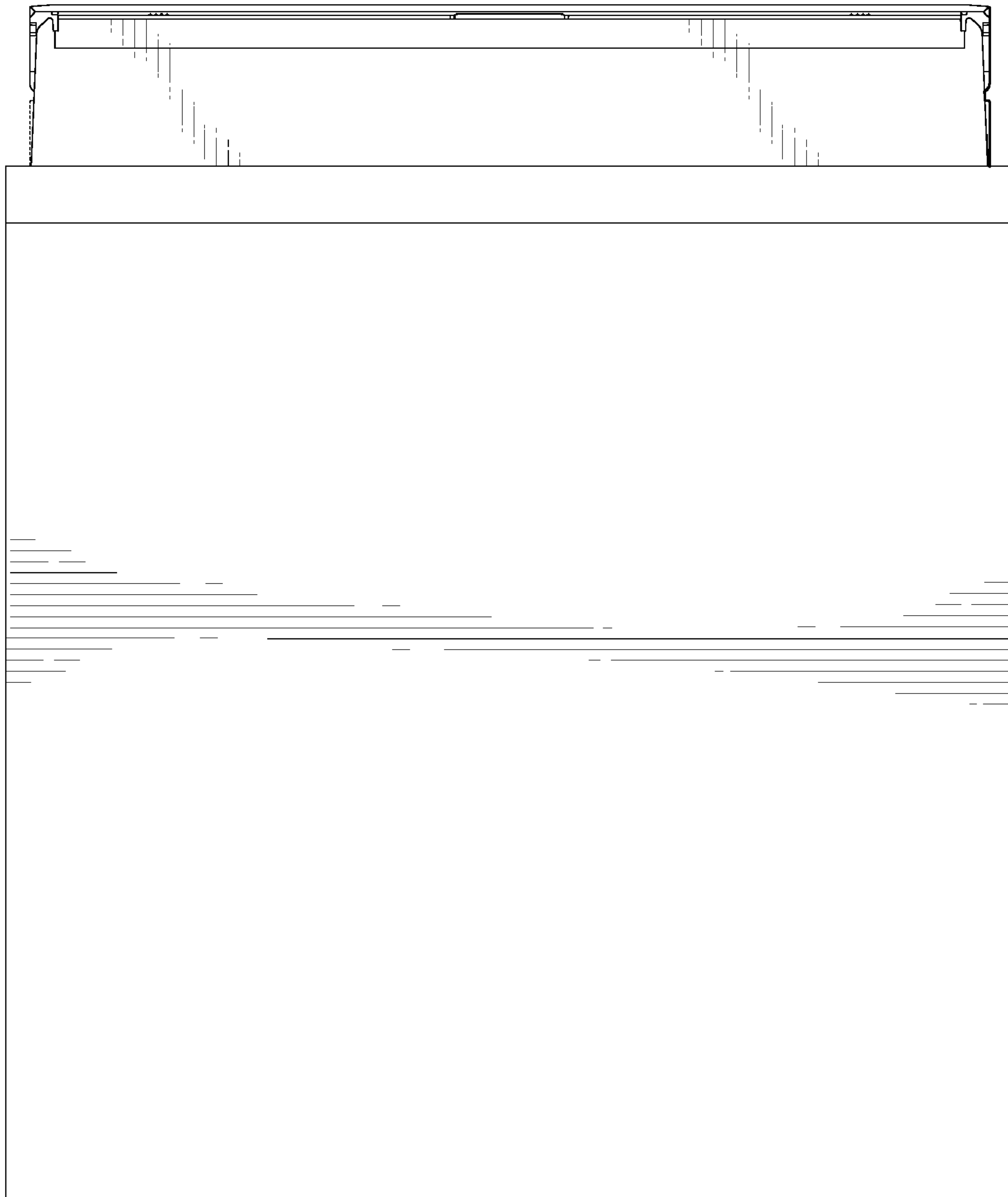

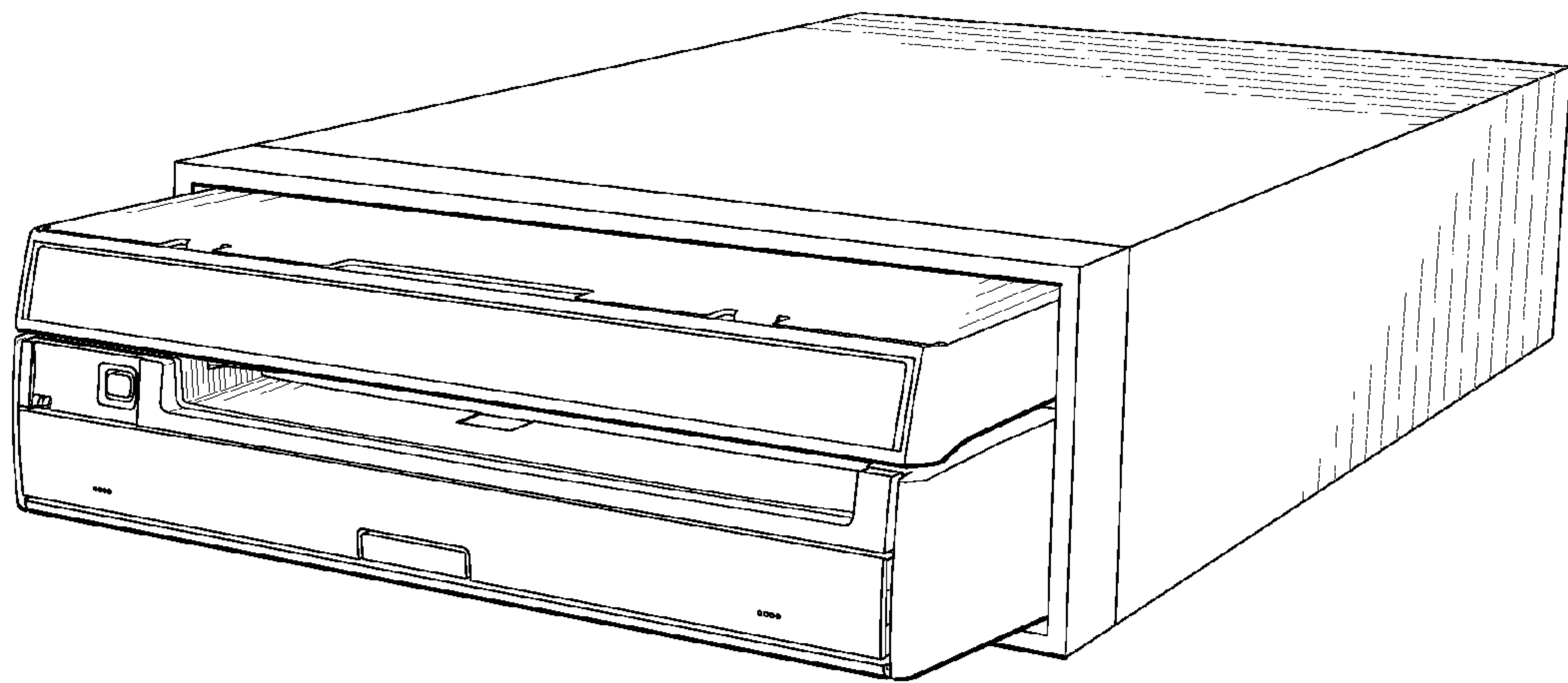

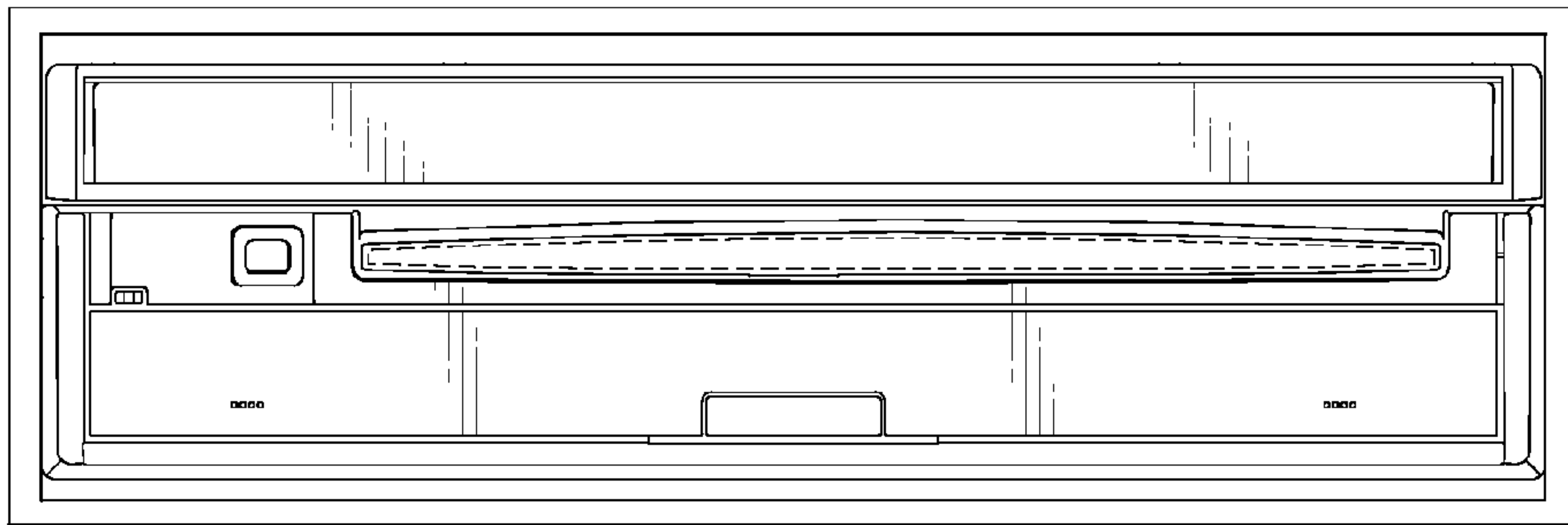

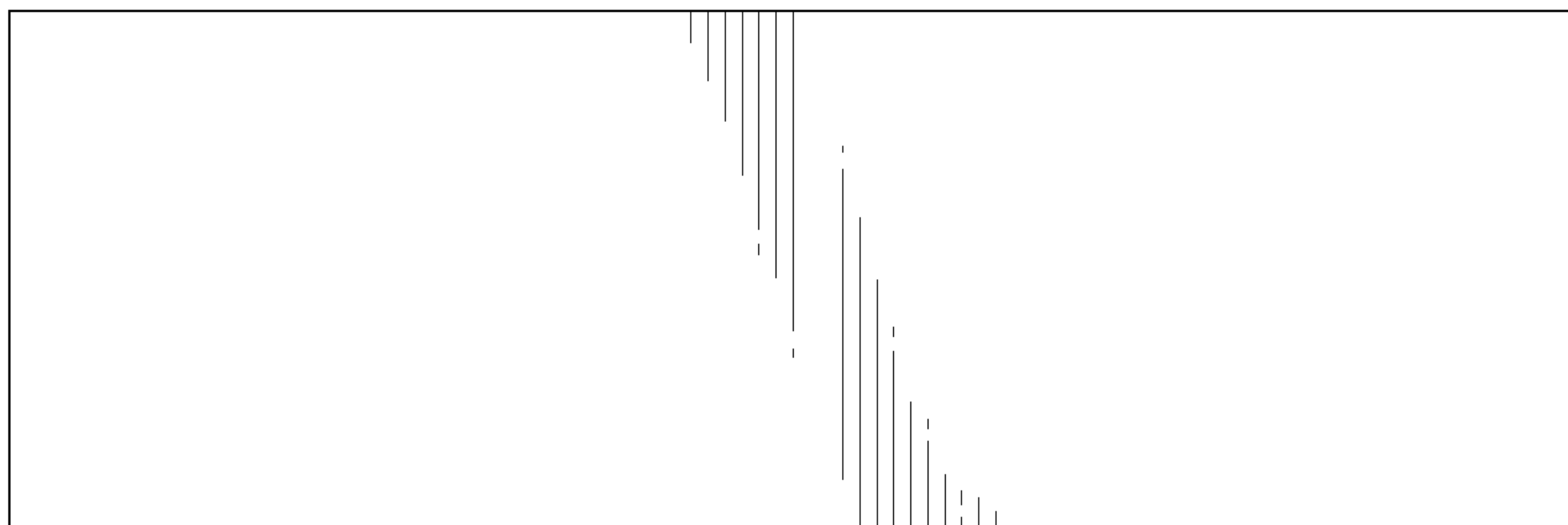

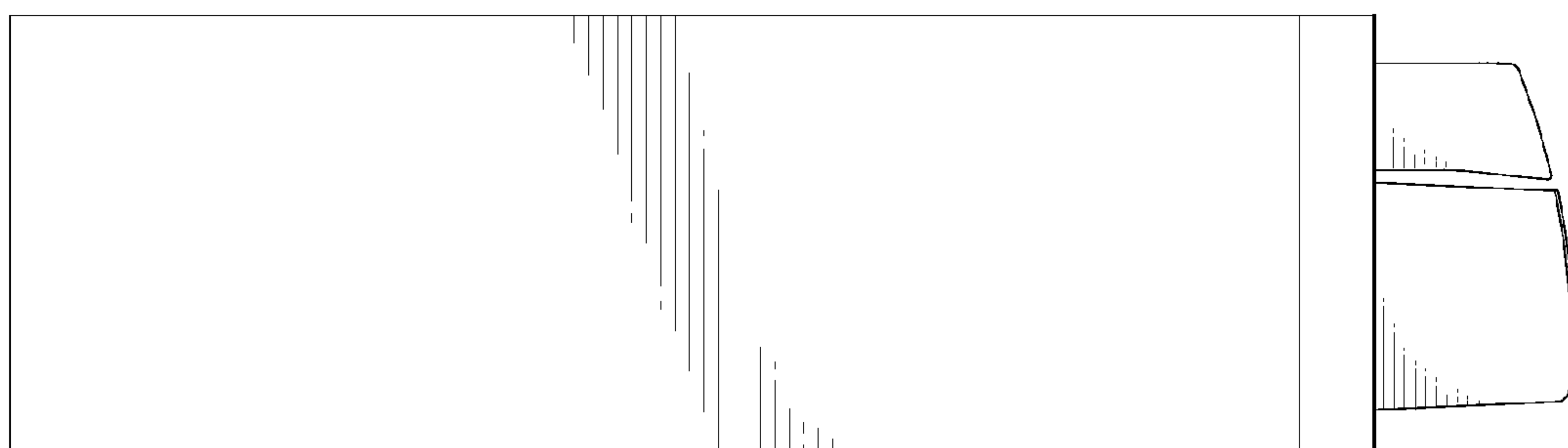

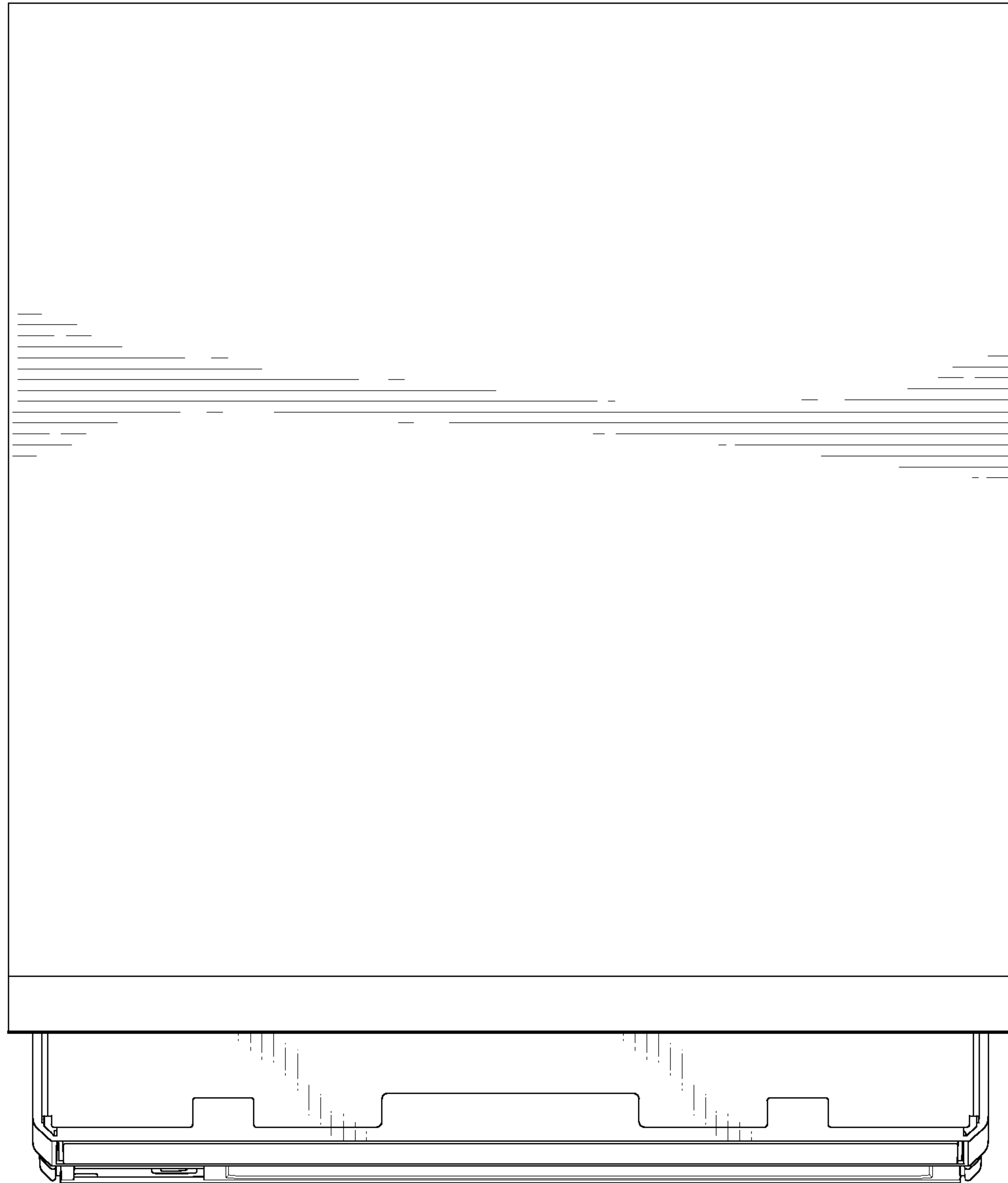

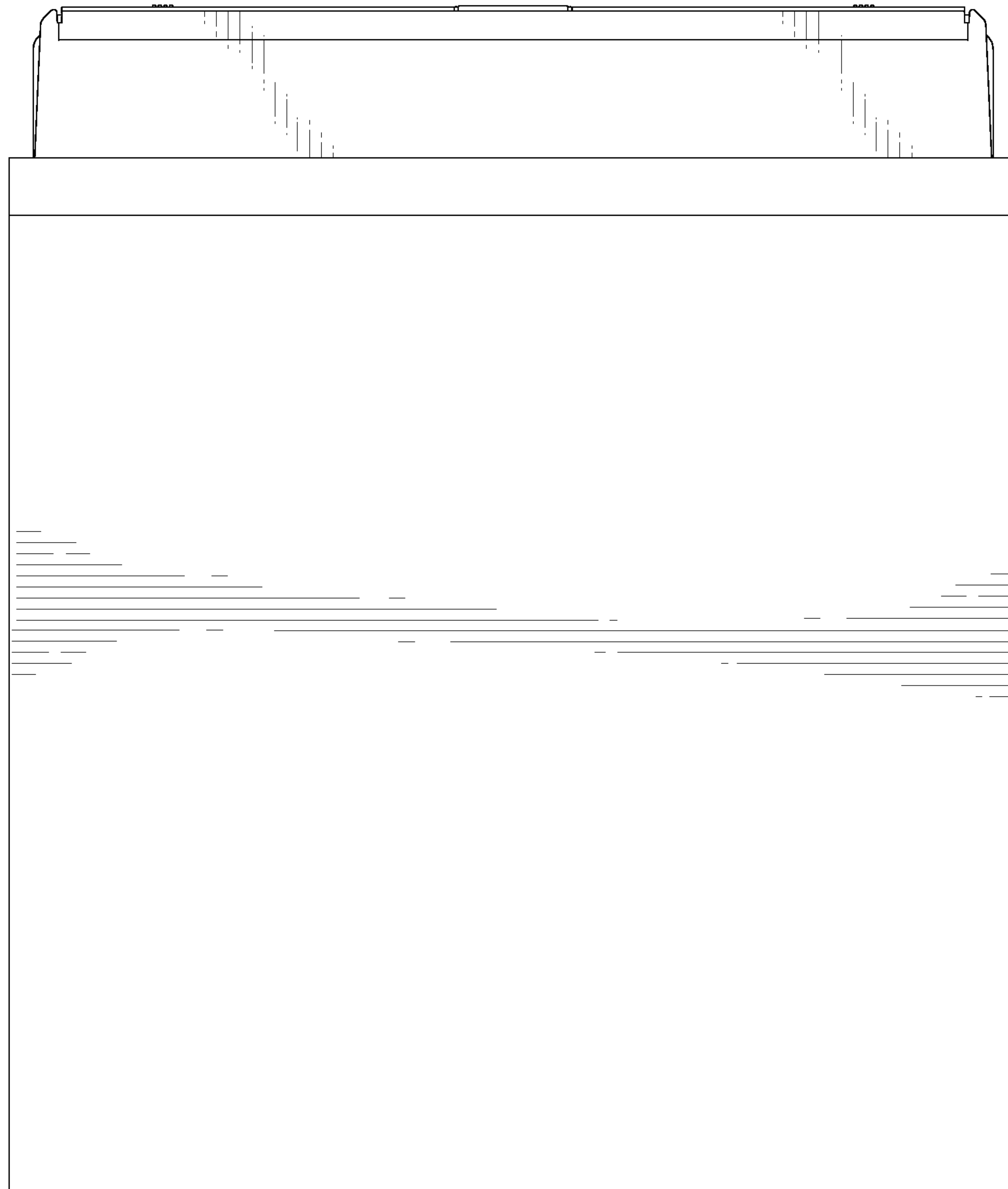
