**DESCRIPTION**

FIG. 4 is back view of the headphone shown in FIG. 1;

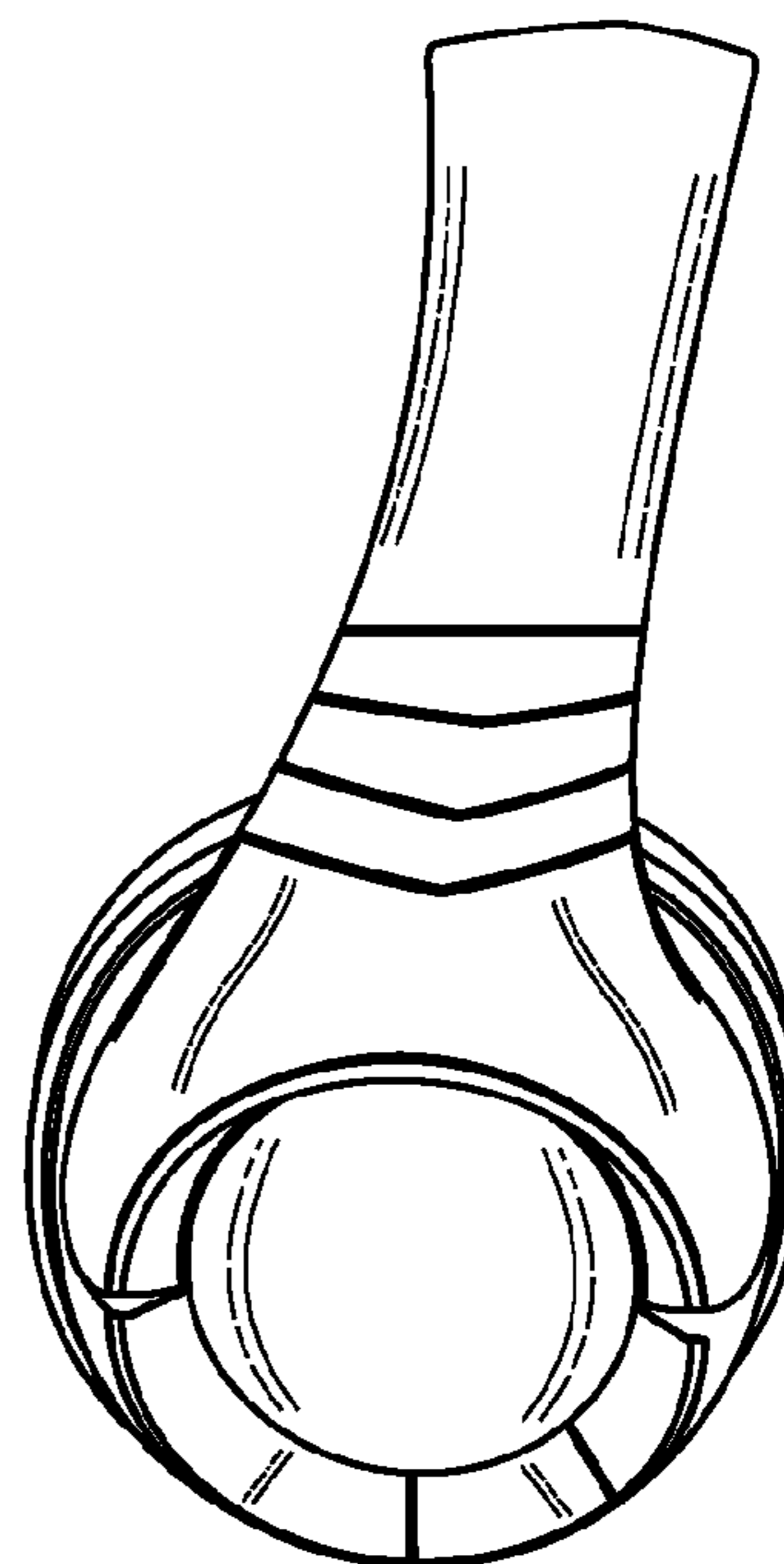
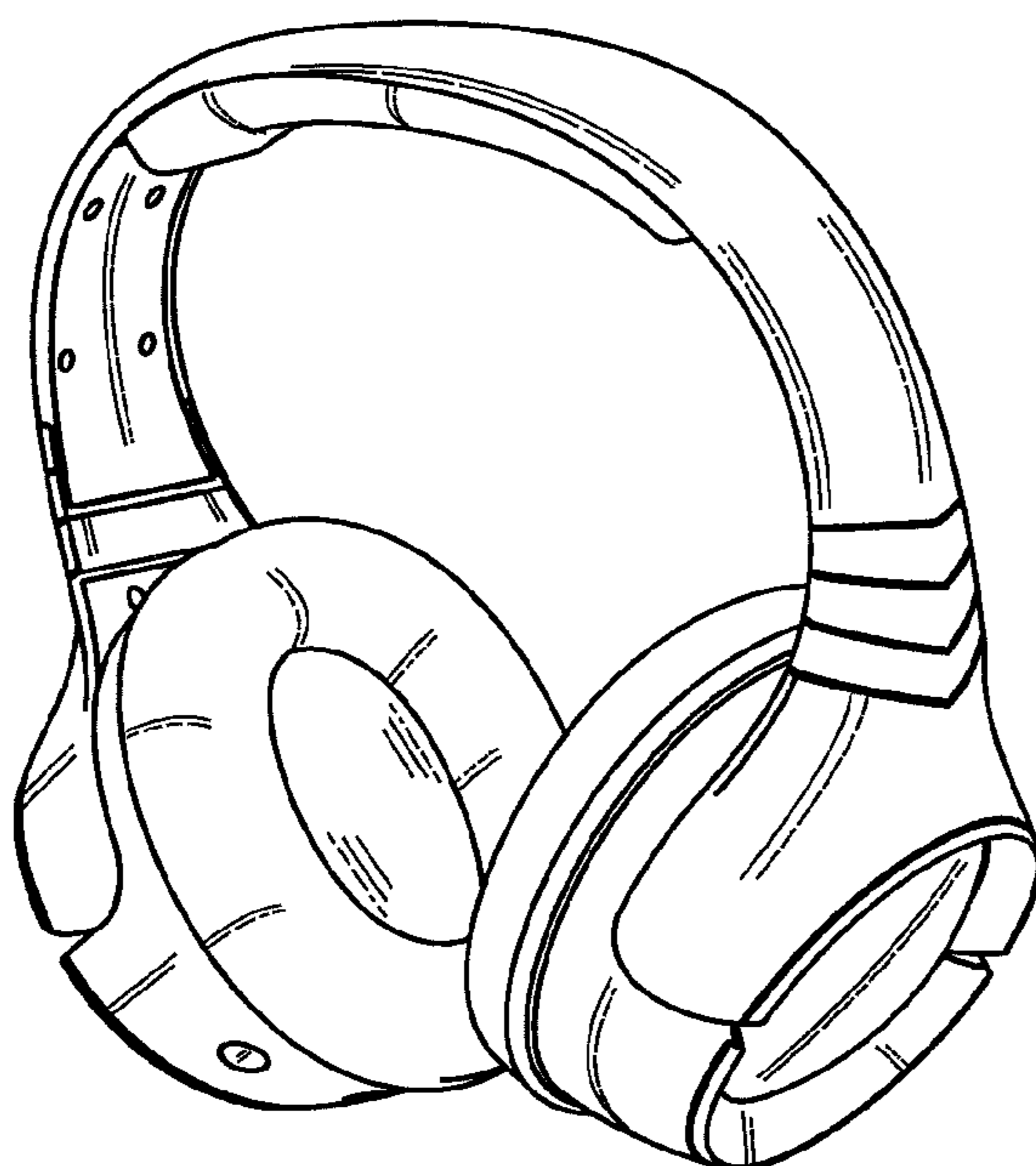
FIG. 5 is a left view of the headphone shown in FIG. 1;

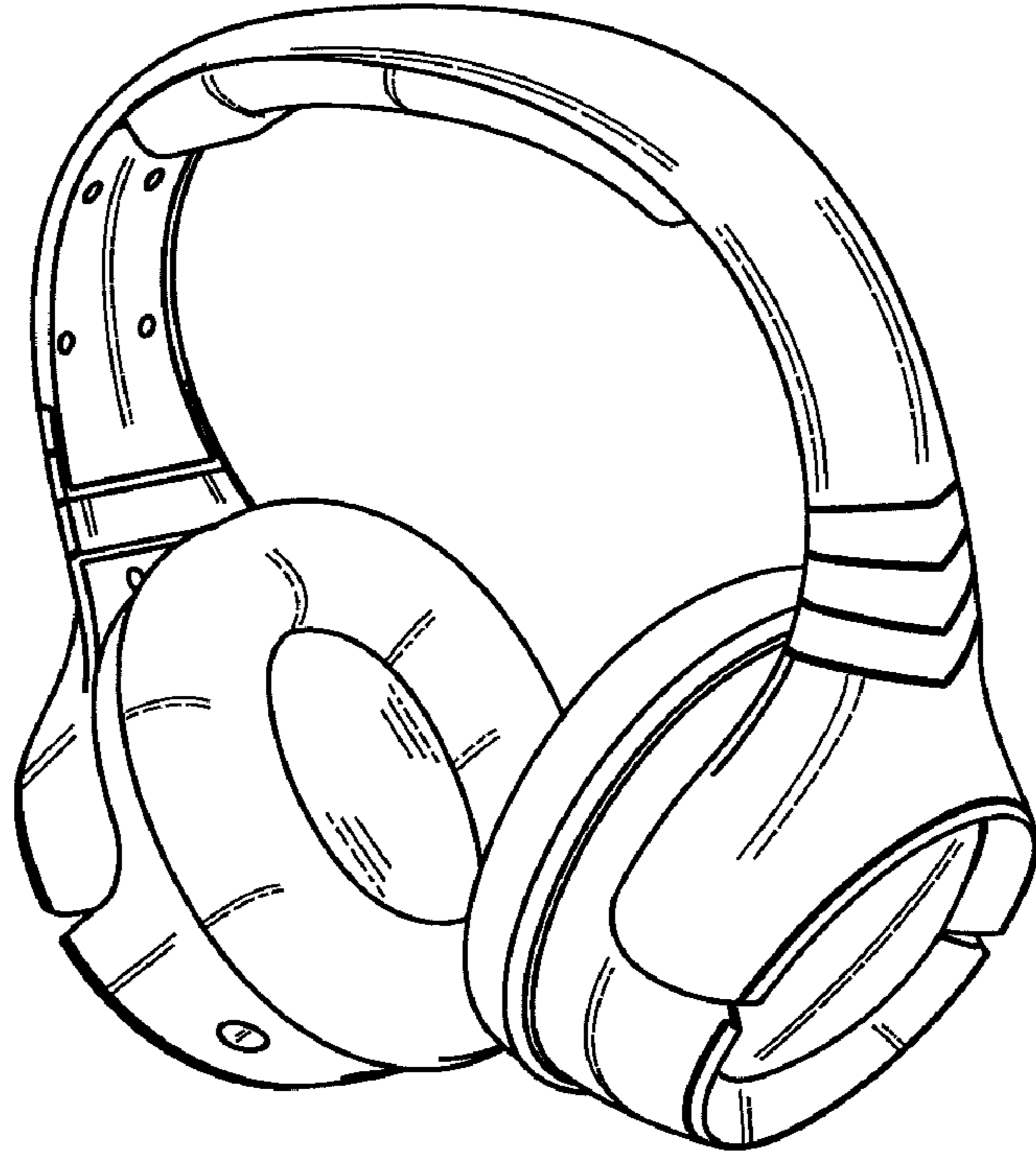

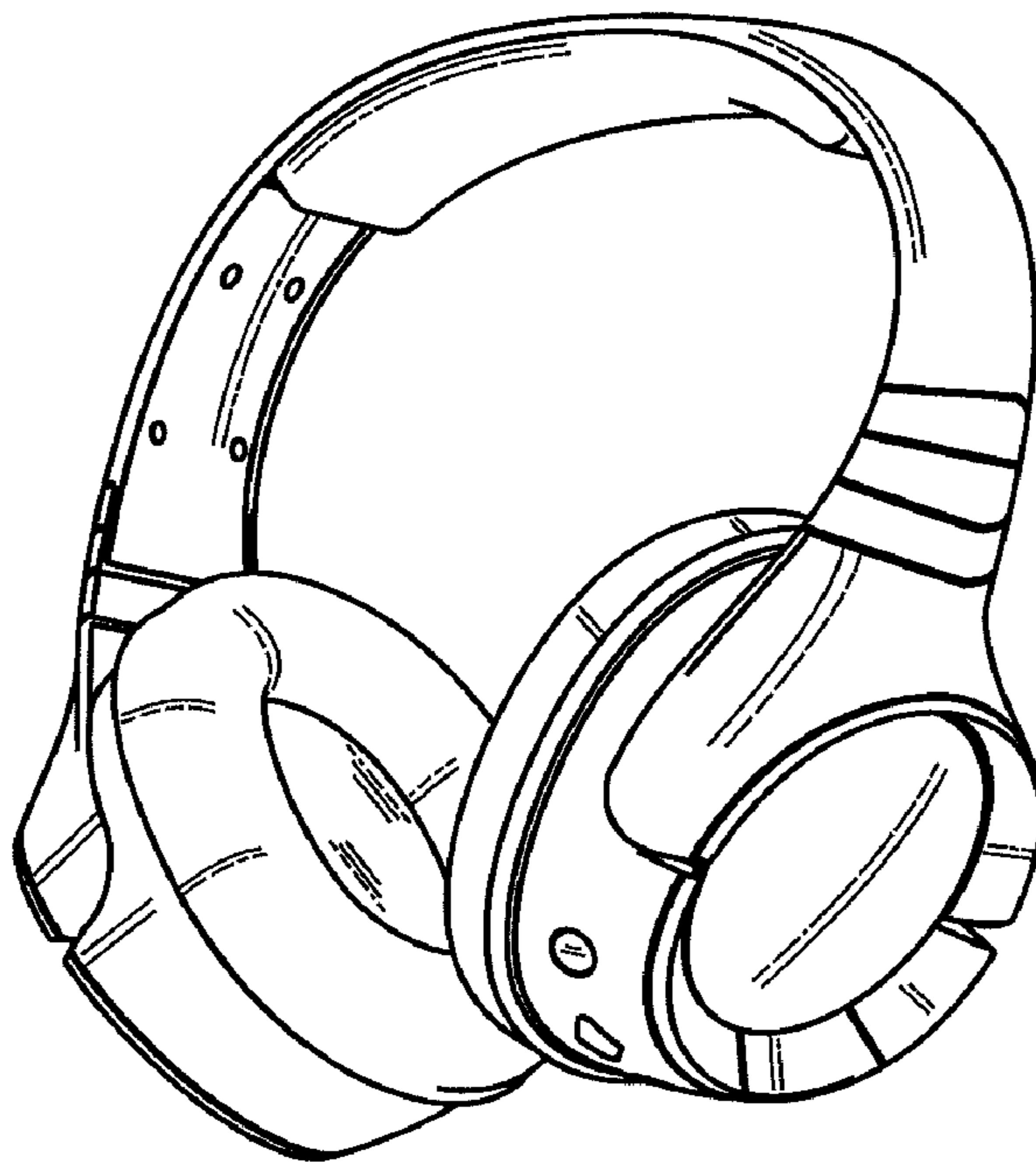

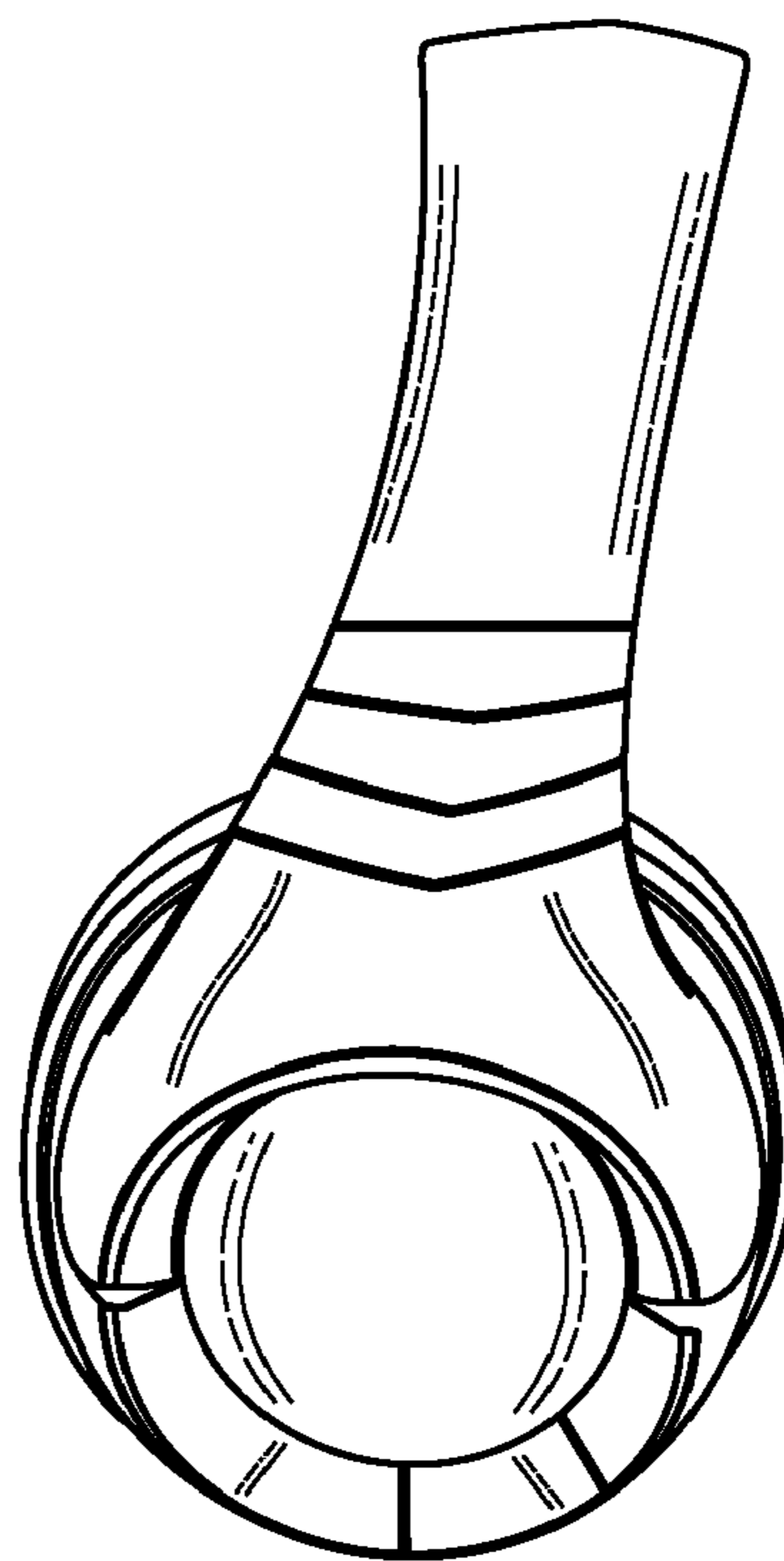

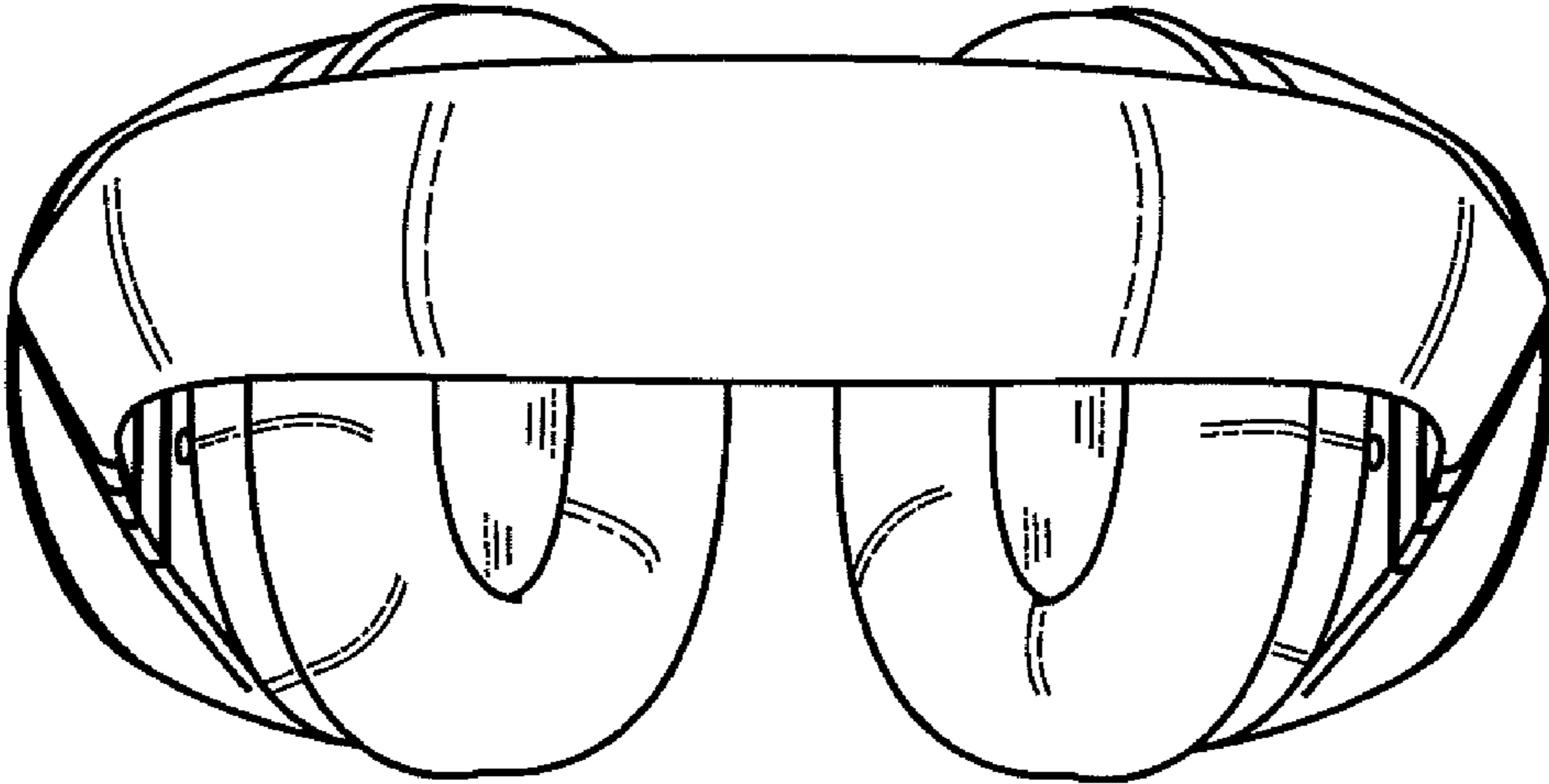

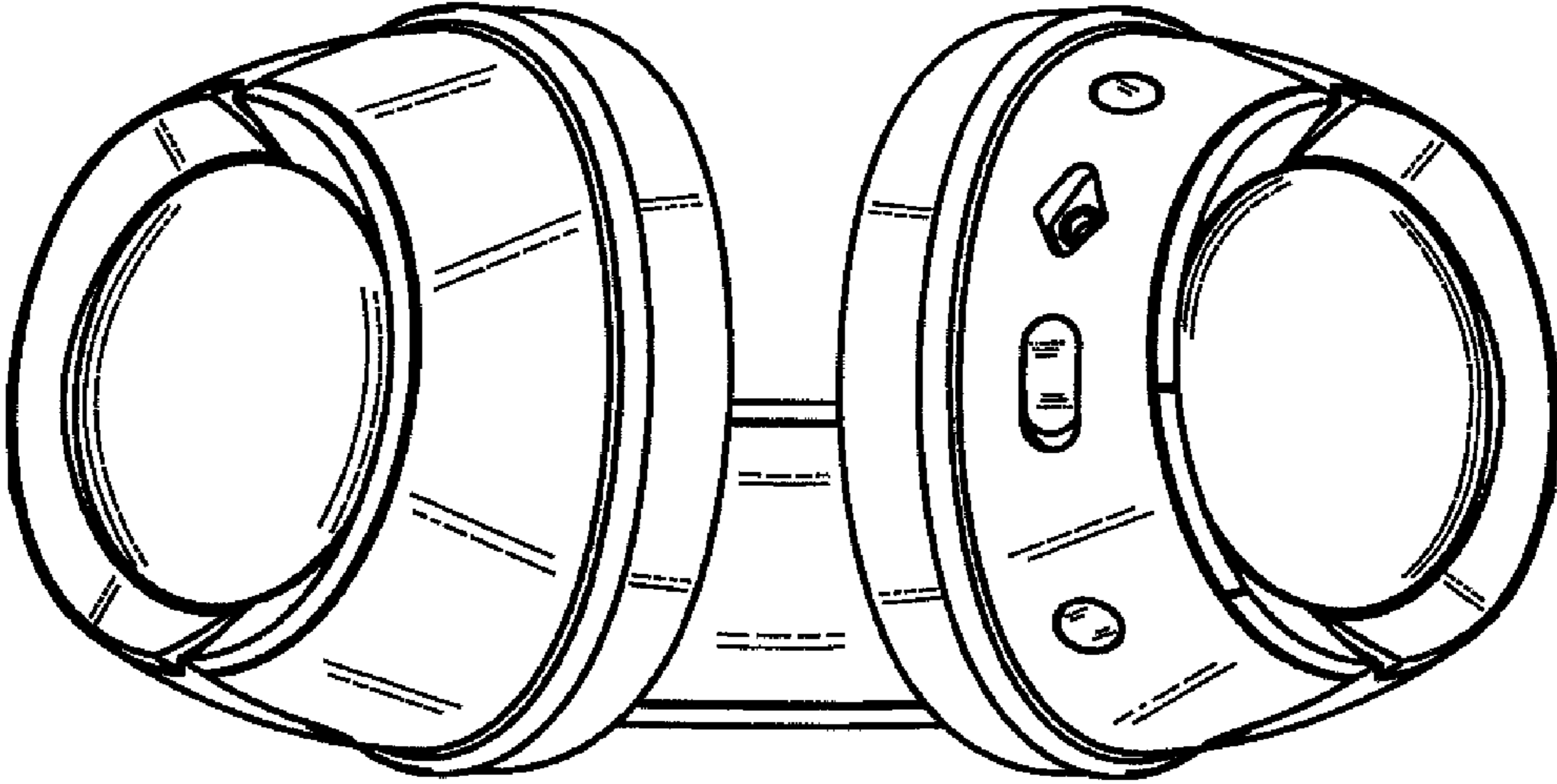
