(57) **CLAIM**

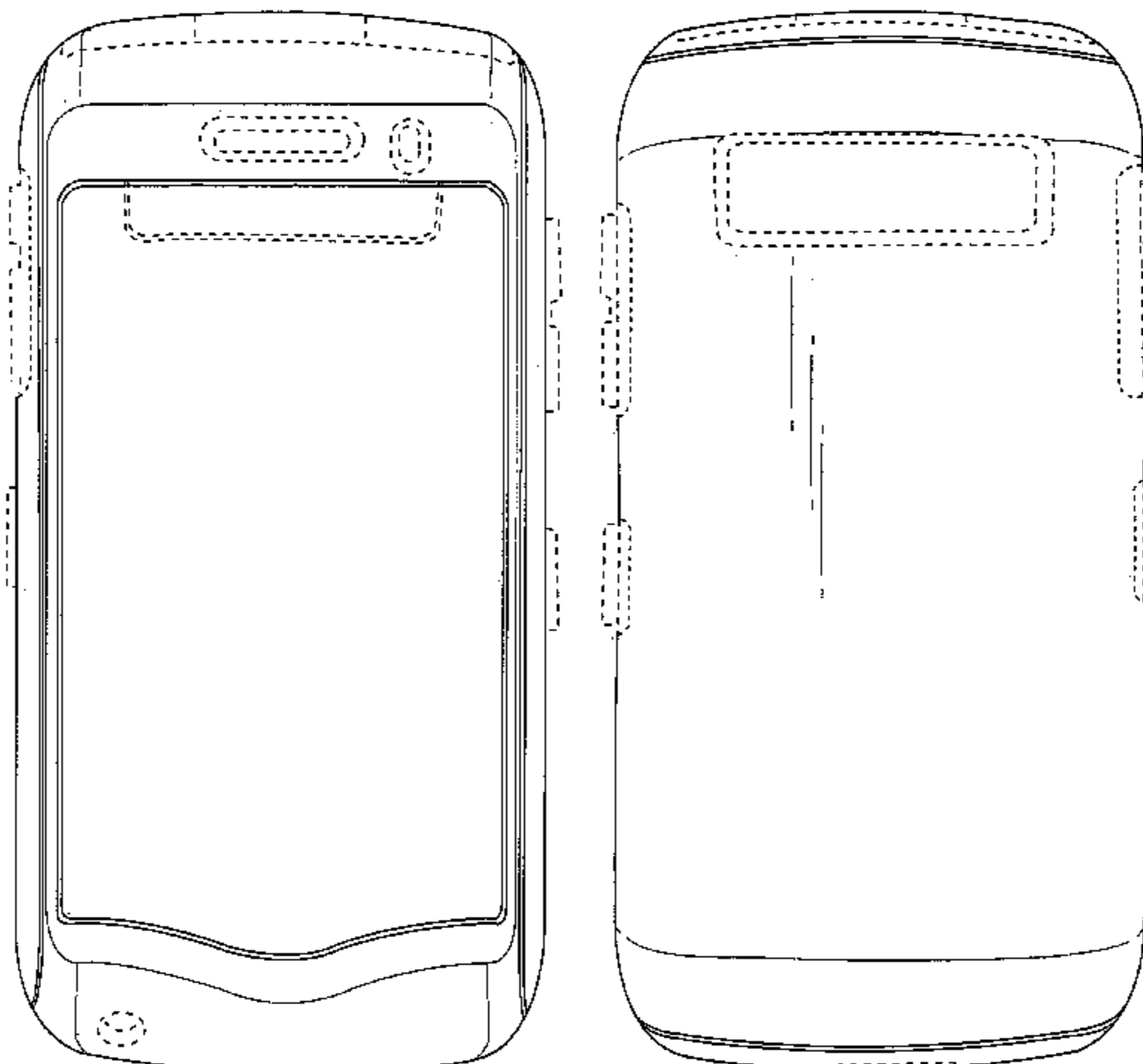
The ornamental design for a case, as shown and described.

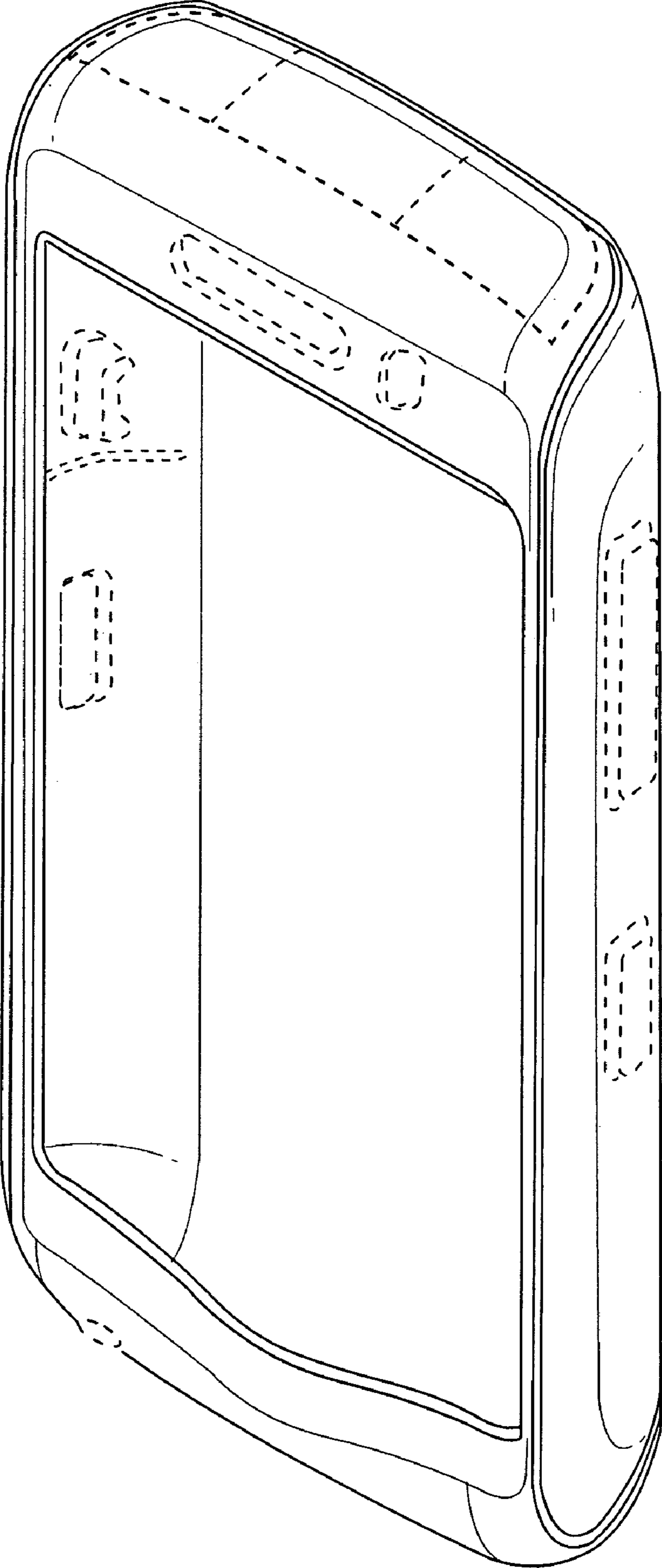

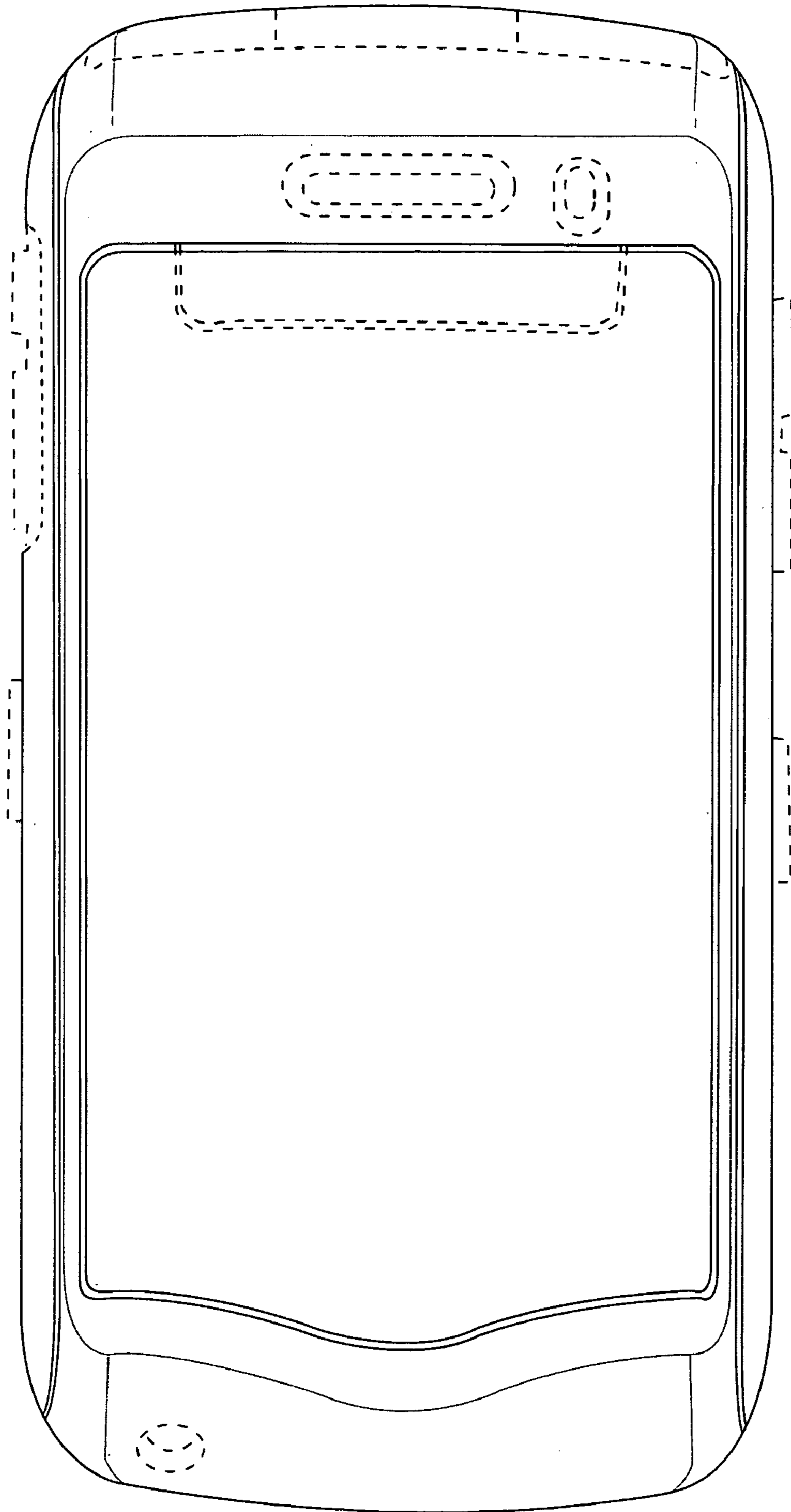

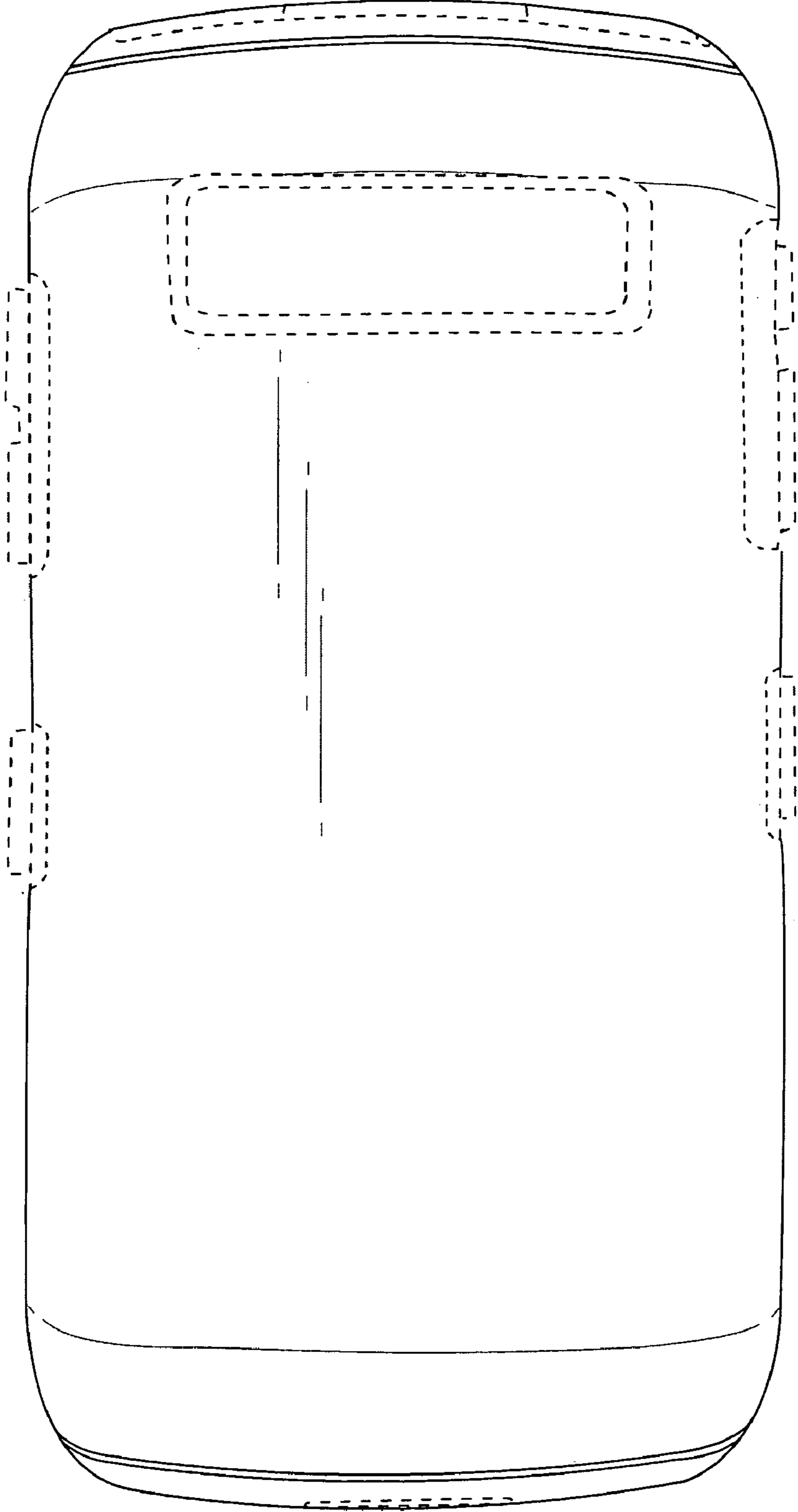

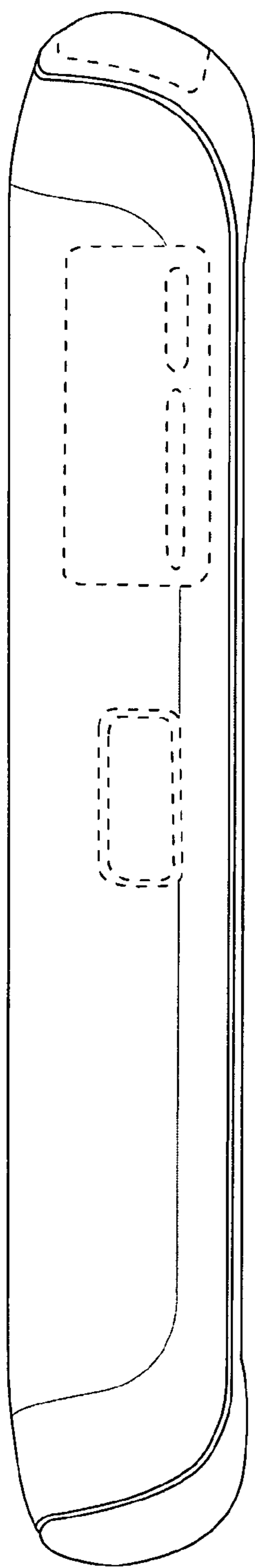

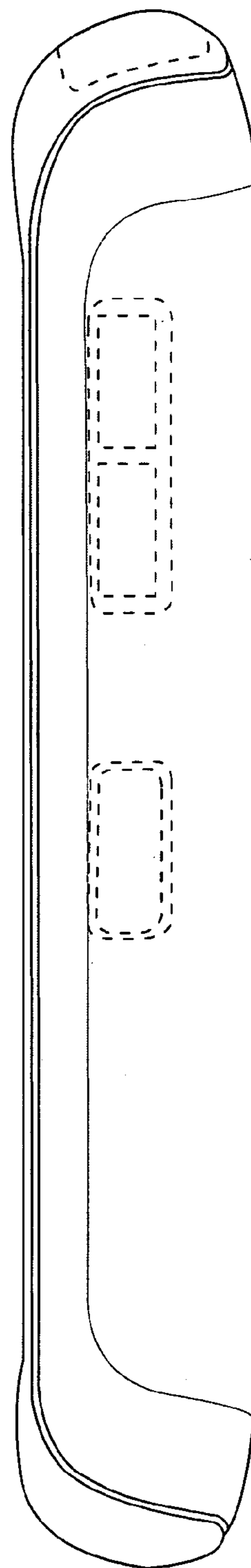
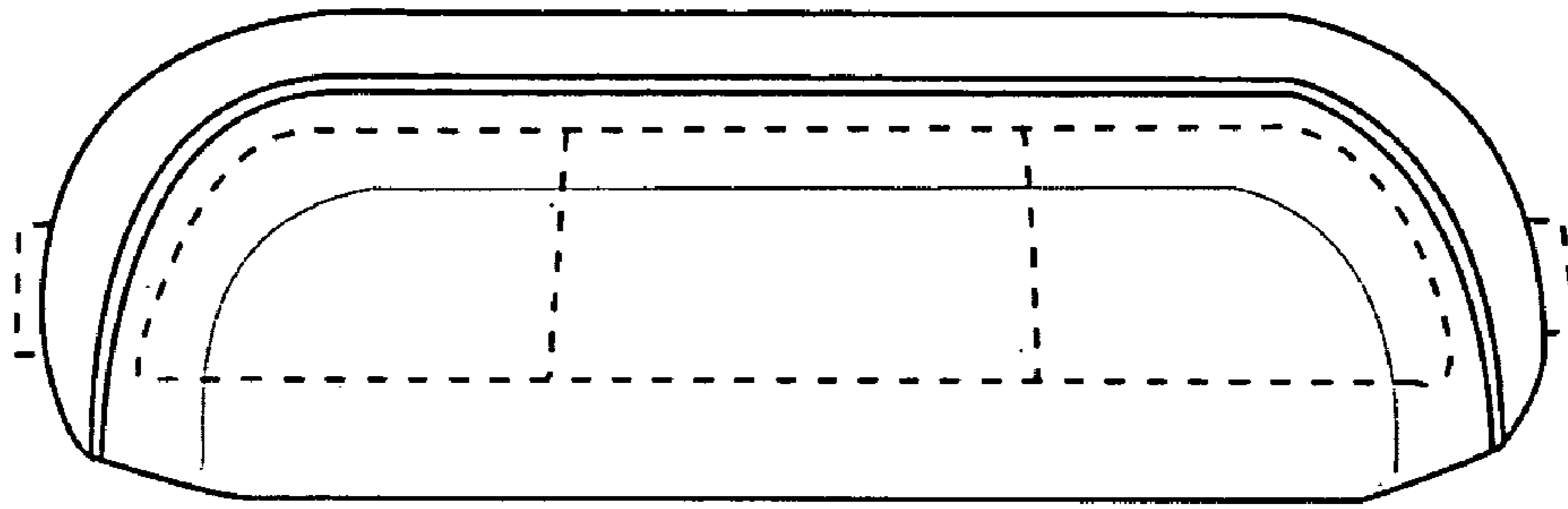
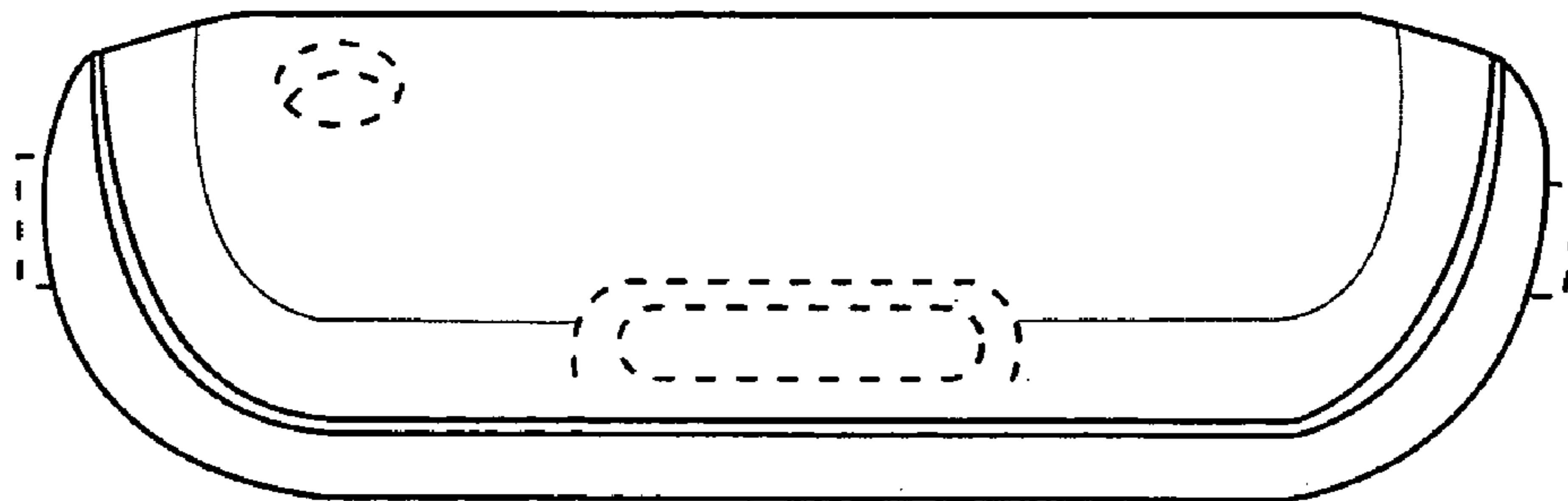
