(57) **CLAIM**

I claim the ornamental design for a baby bottle holder, as
shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a baby bottle holder showing
my new design;

FIG. 2 is a front view of the baby bottle holder;

FIG. 3 is a rear view of the baby bottle holder of FIG. 2;

FIG. 4 is a left side view of the baby bottle holder of FIG. 2;

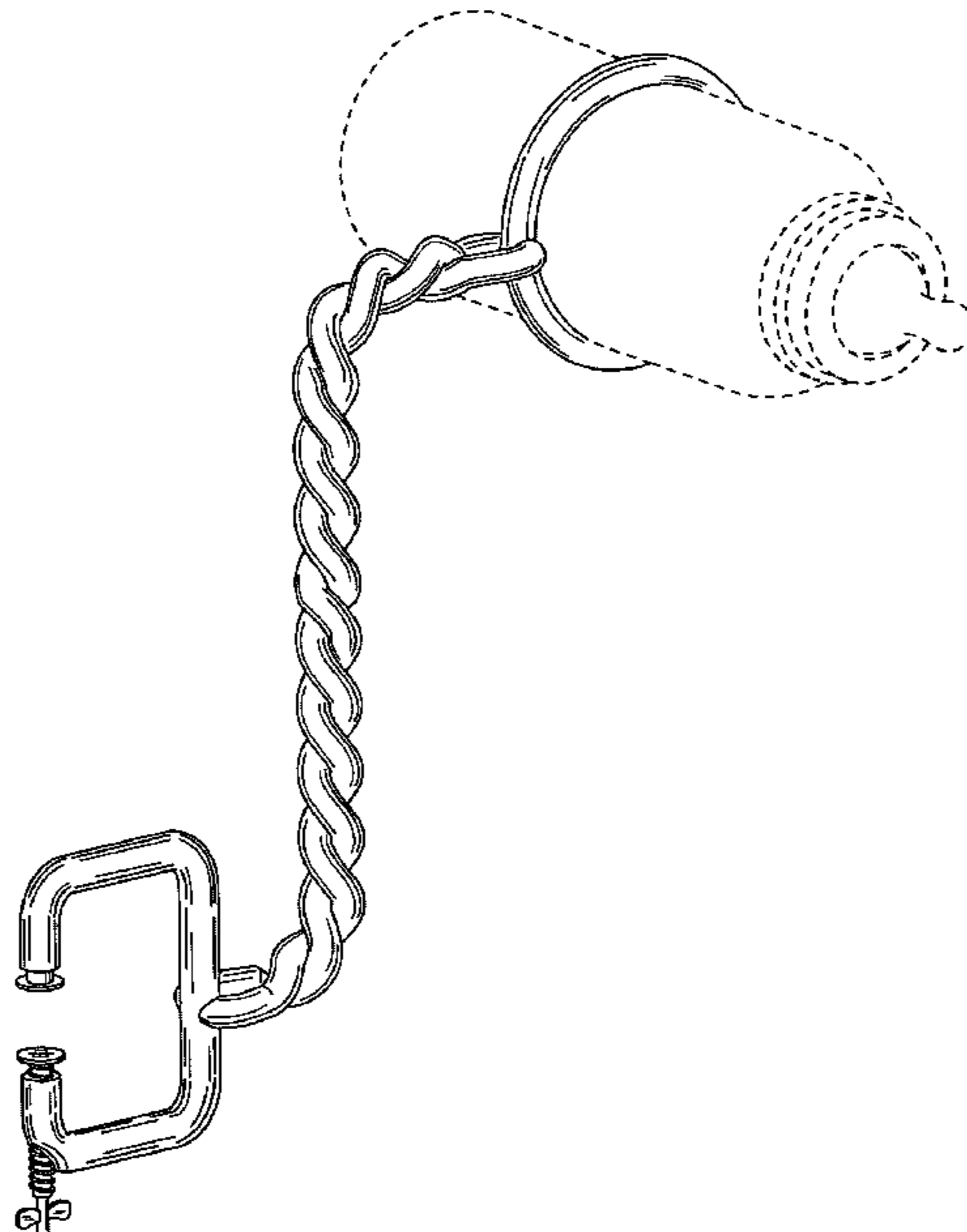
FIG. 5 is a right side view of the baby bottle holder of FIG. 2;

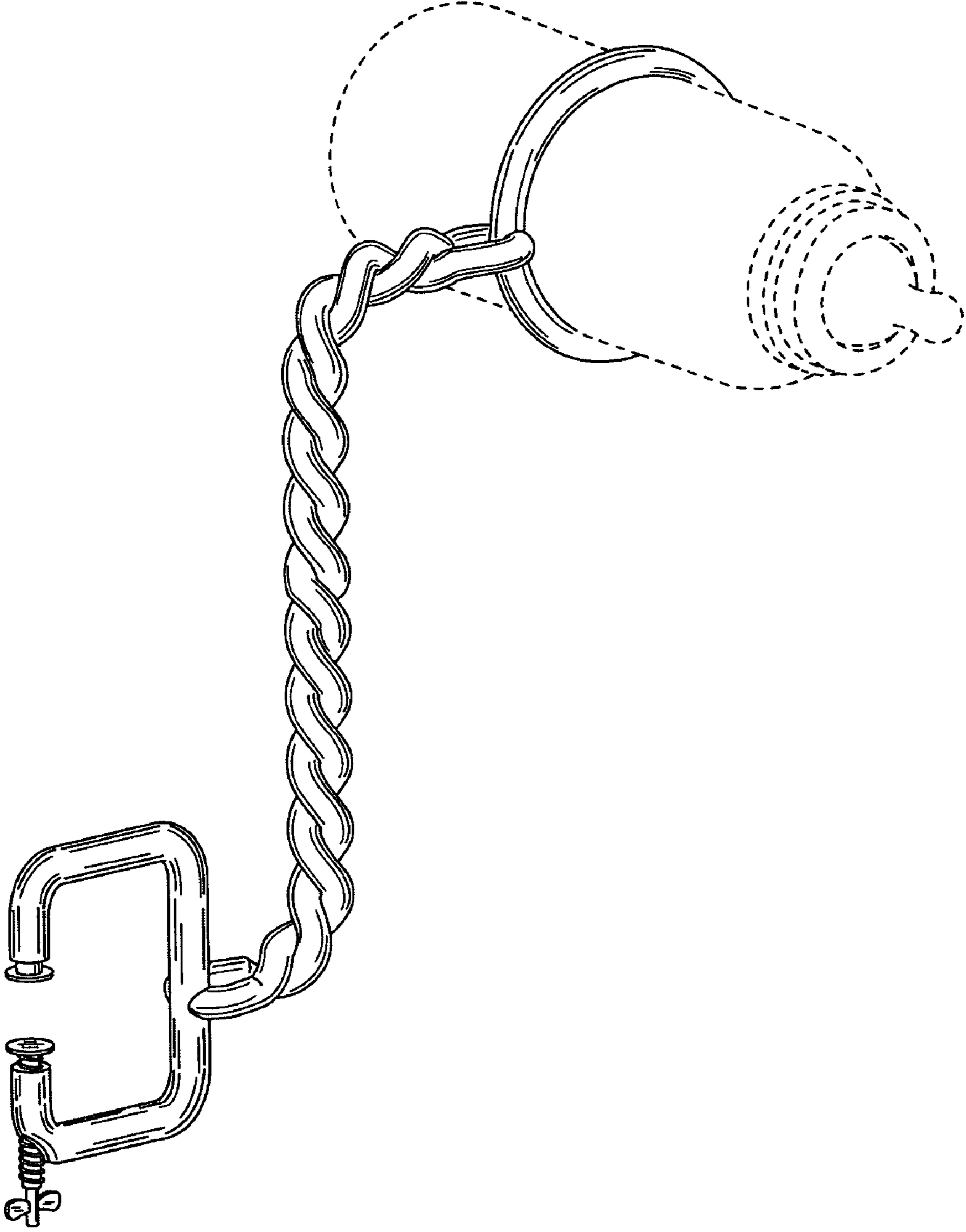

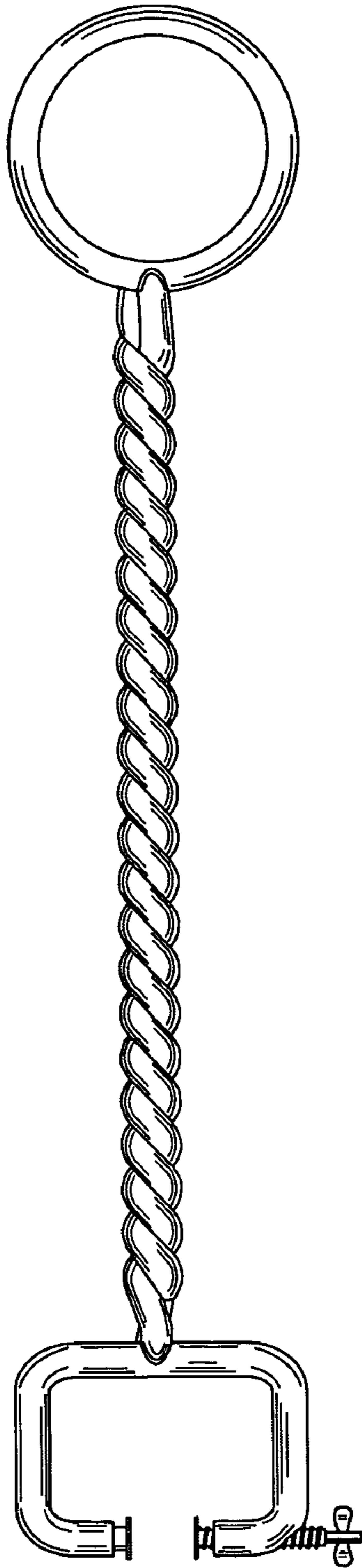

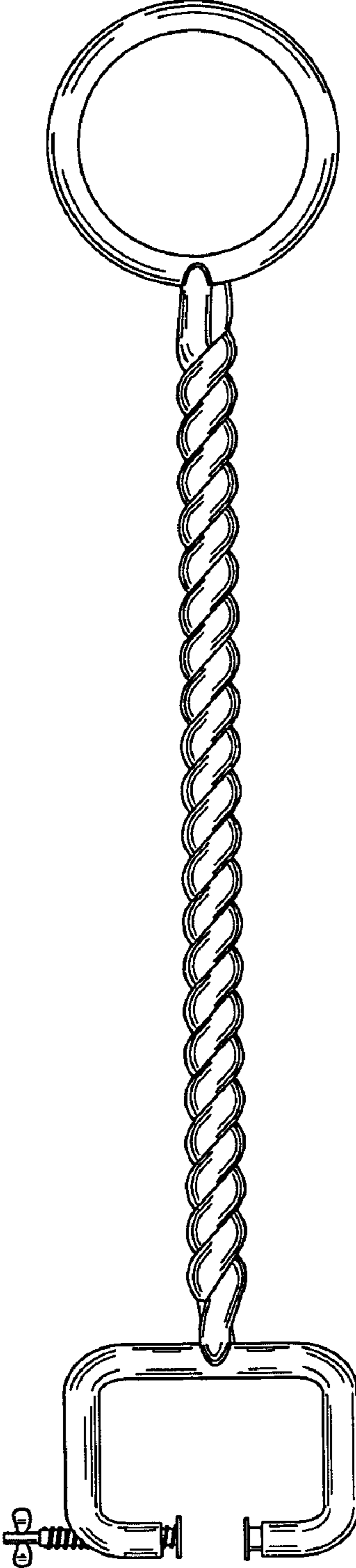

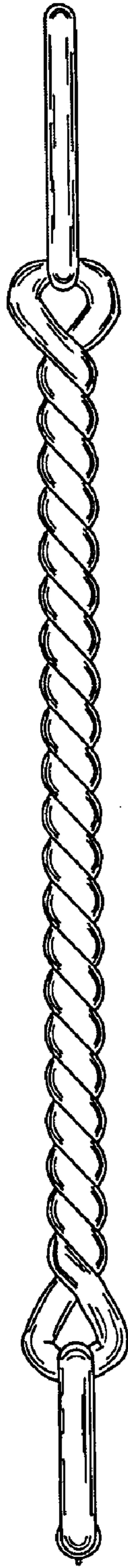

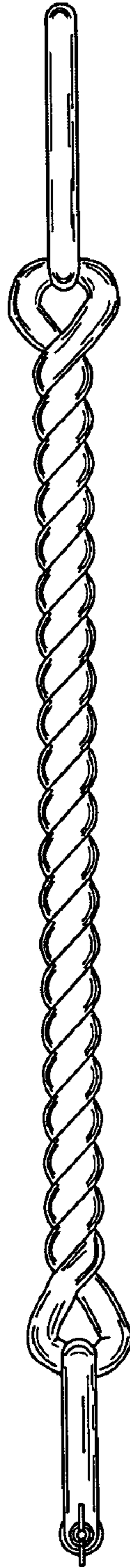

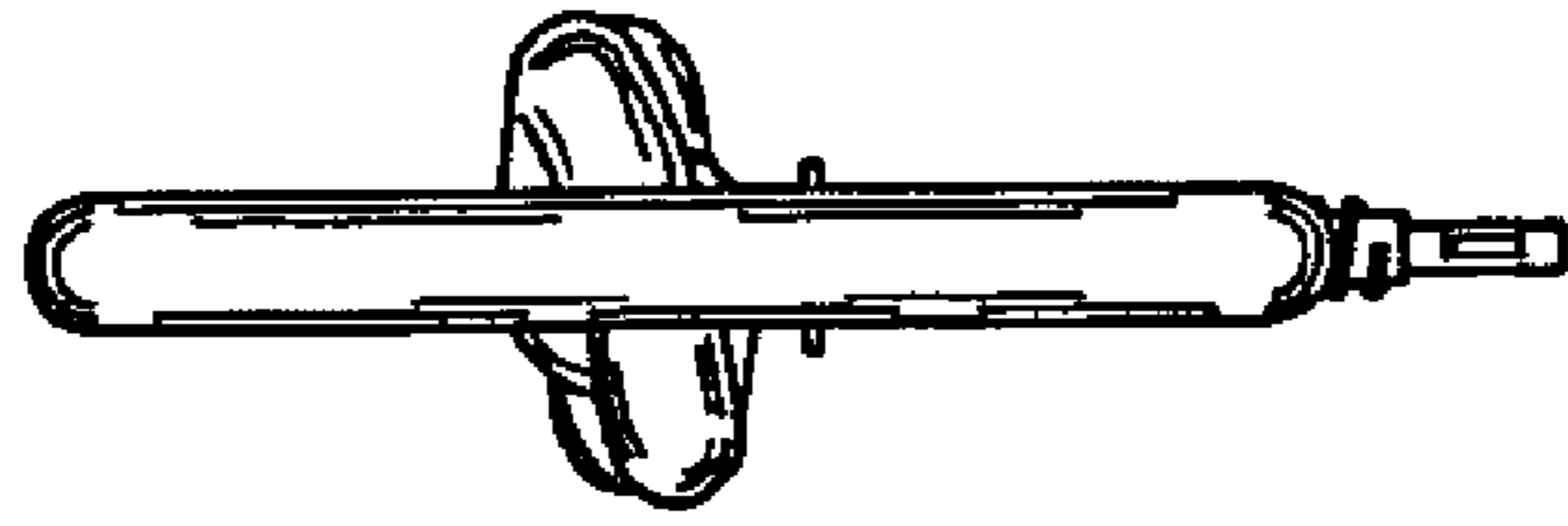

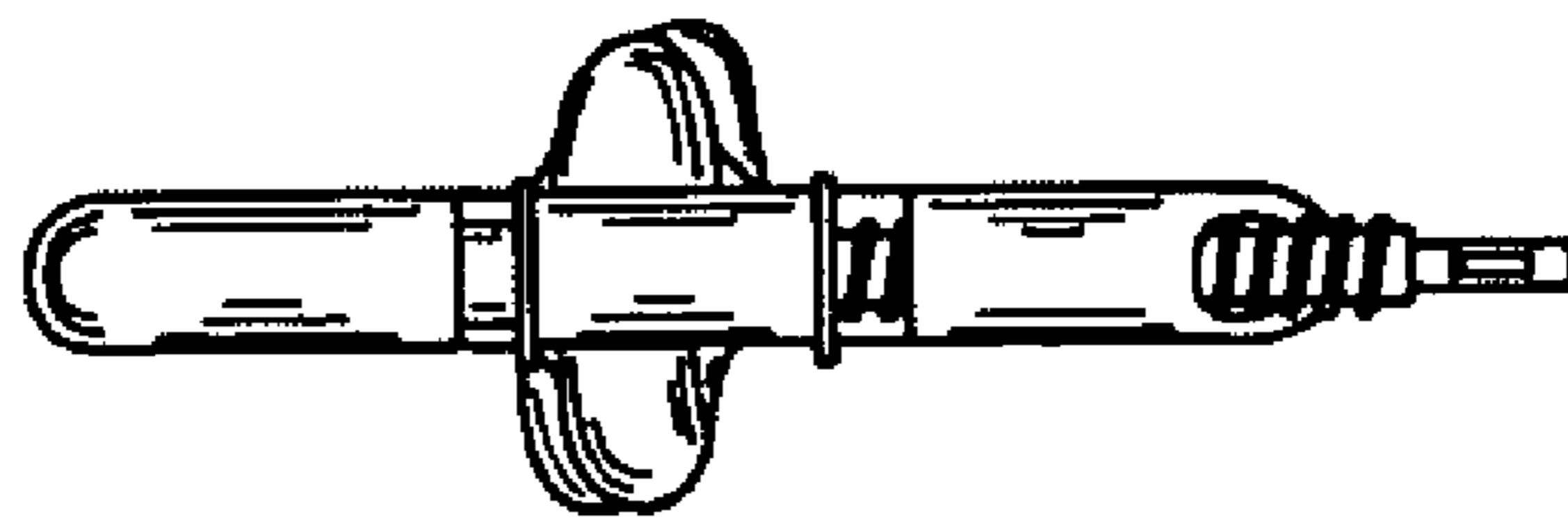
